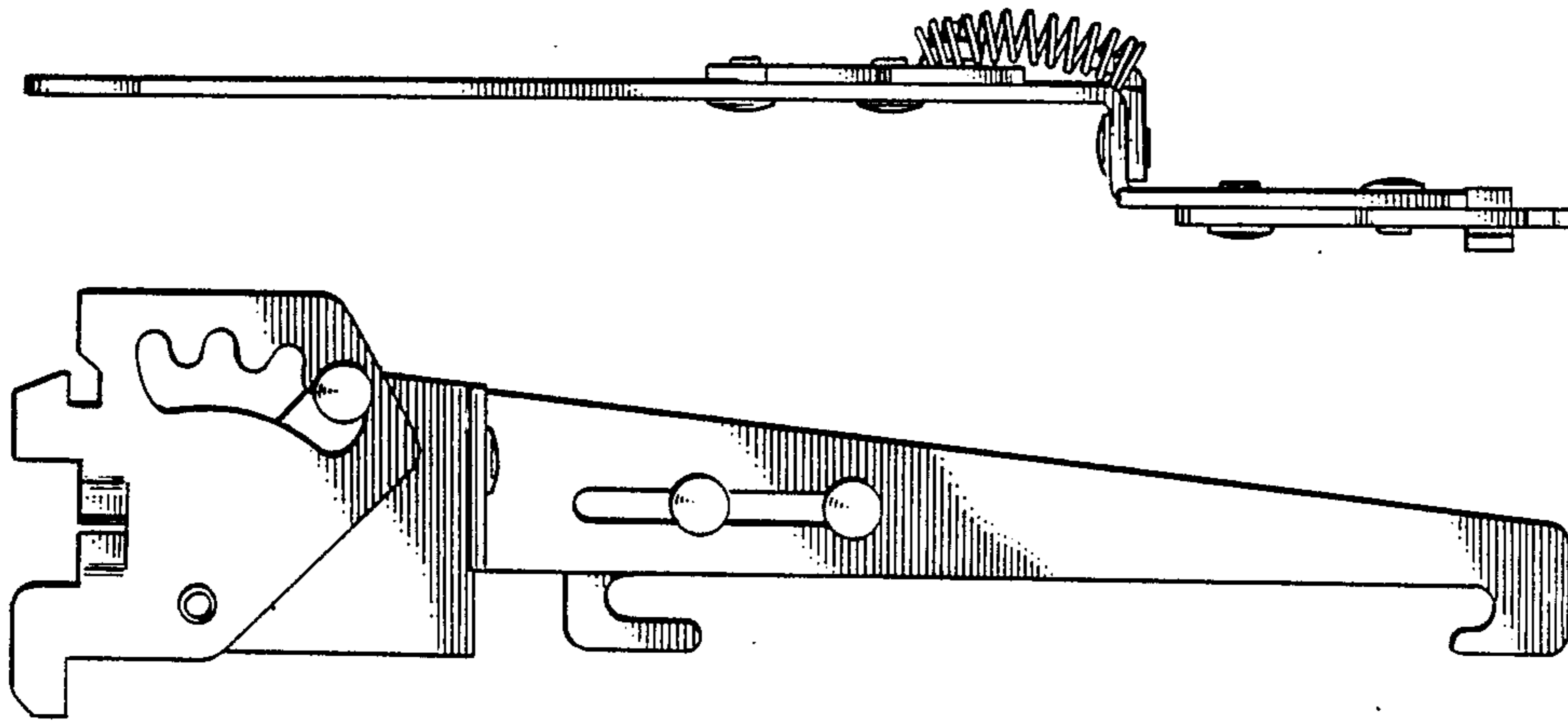

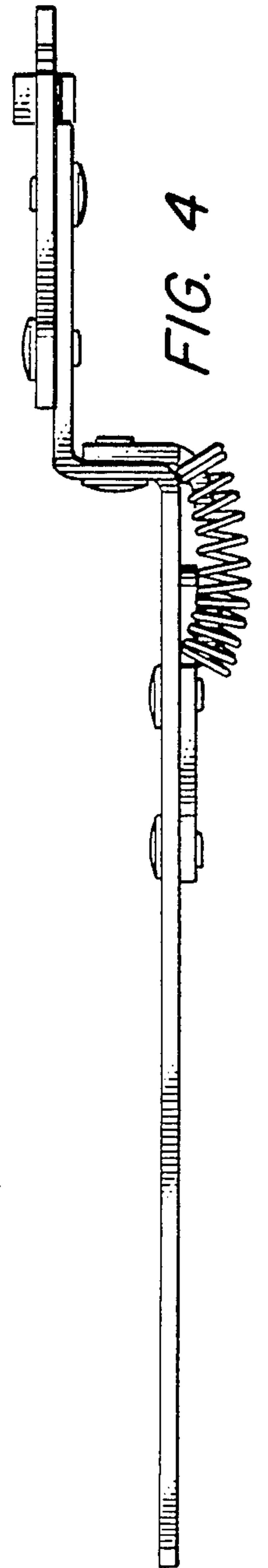
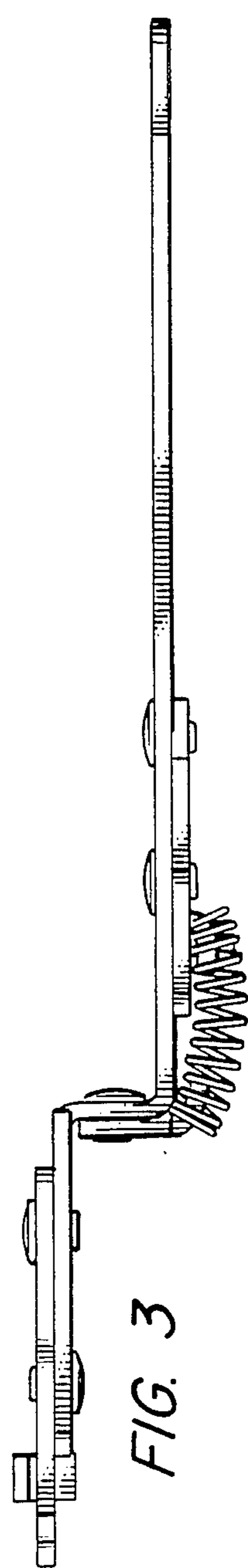
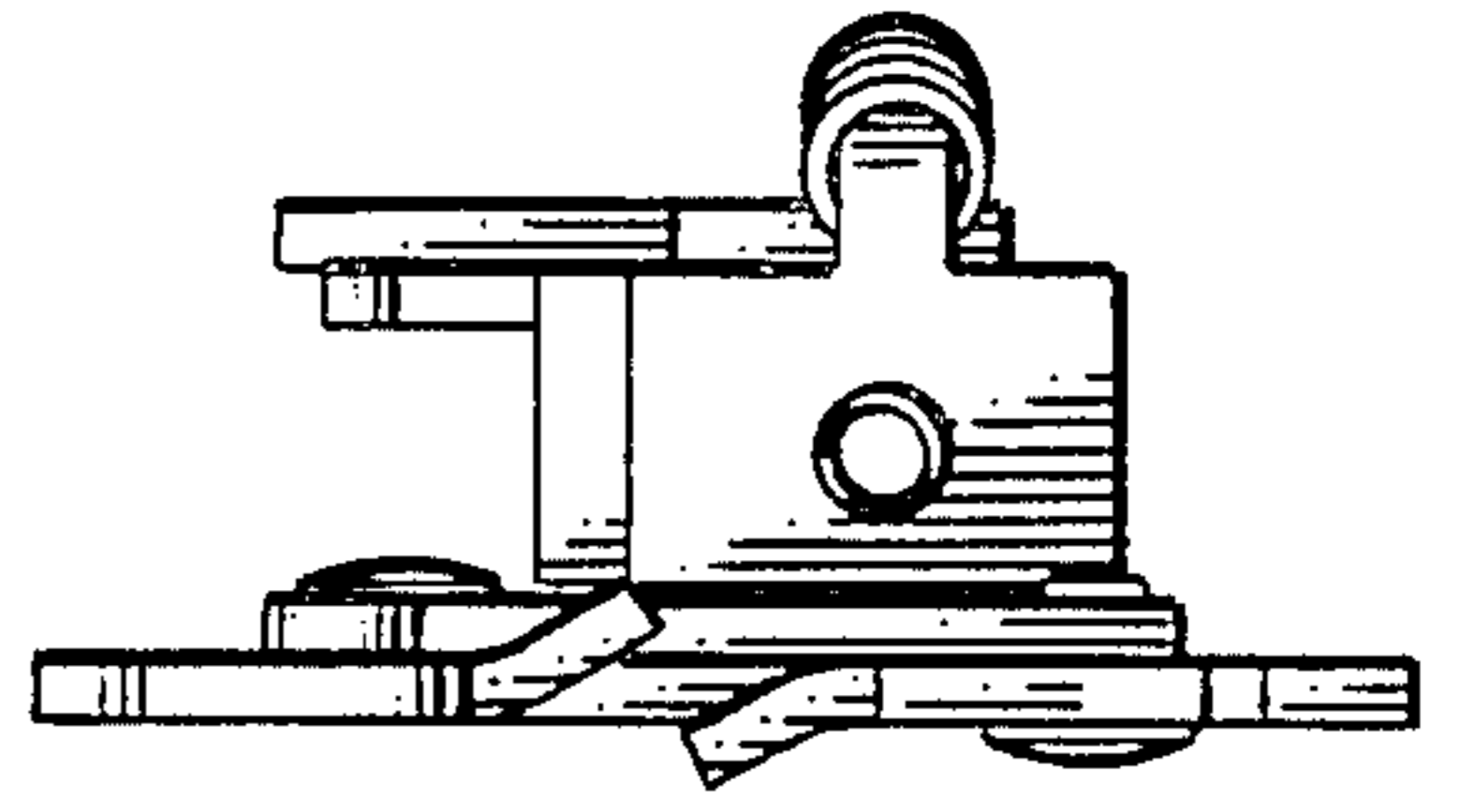
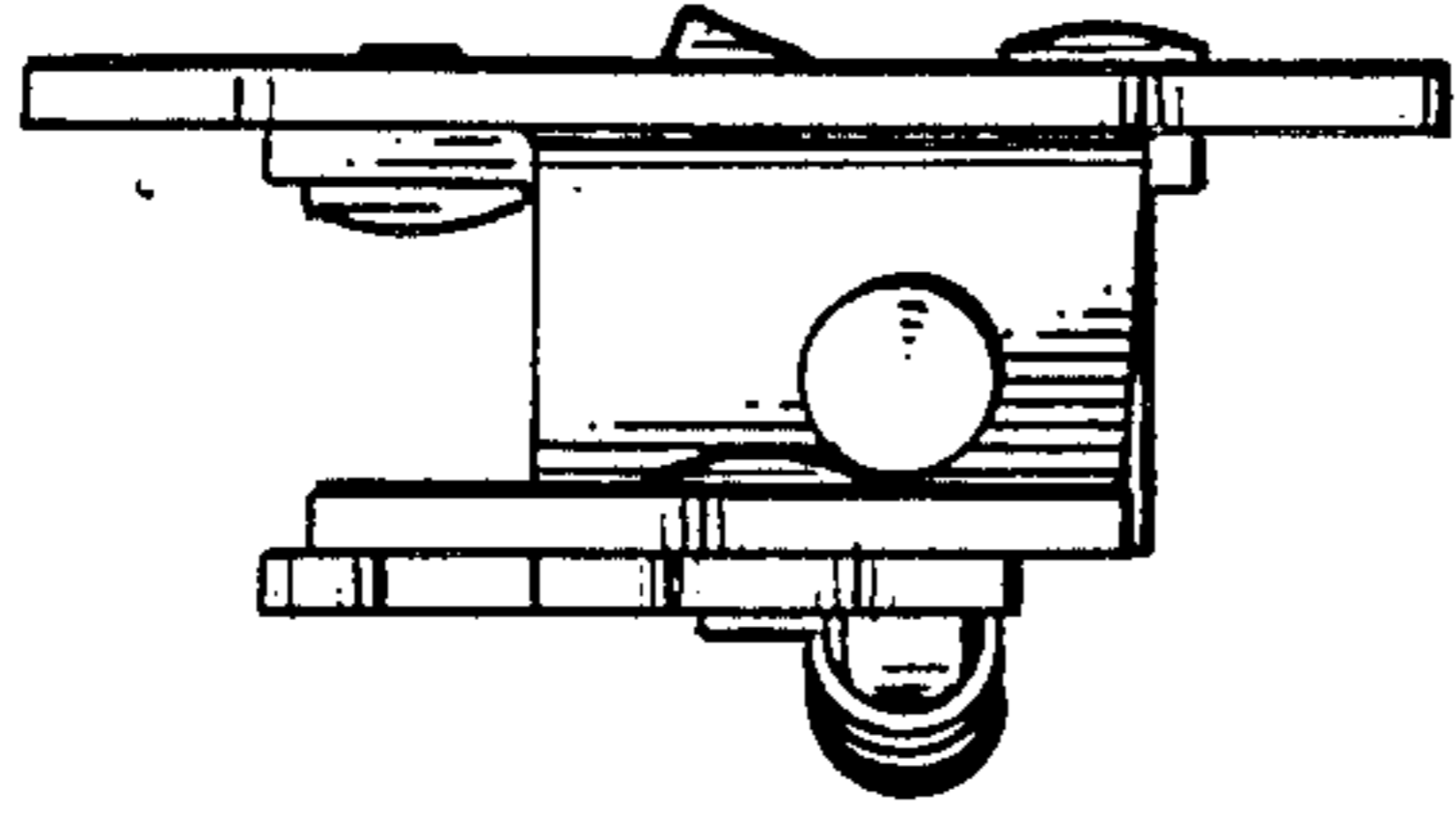
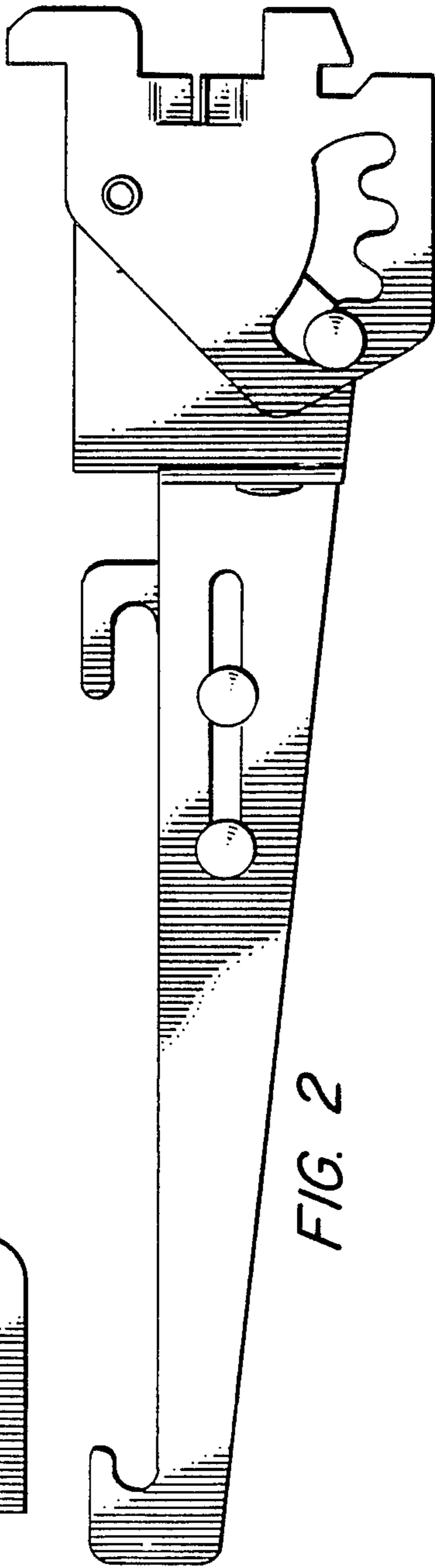
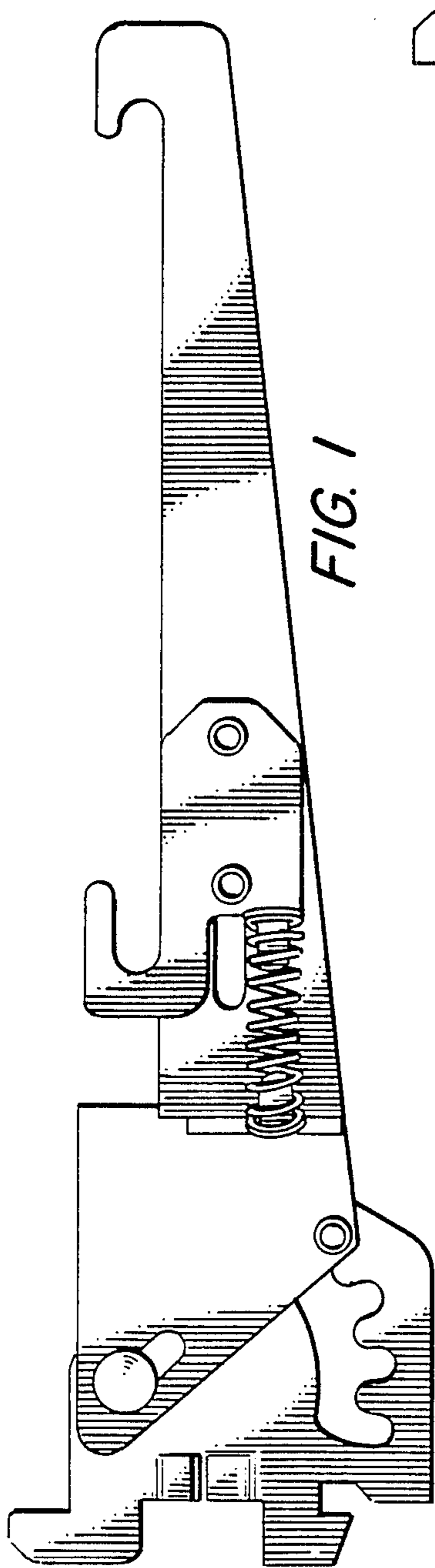
[57] **CLAIM**

DESCRIPTION

FIG. 1 is a right side elevational view of an adjustable shelf bracket showing my new design; FIG. 2 is an inverted left side elevational view thereof; FIGS. 3 and 4 are respectively top and bottom plan views thereof; and FIGS. 5 and 6 are respectively front and rear elevational views thereof.
