[57] CLAIM

The ornamental design for a cassette tape holder, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a cassette tape holder showing my new design, the mounting bracket shown in dotted lines being for illustrative purposes only and not part of the design claimed.

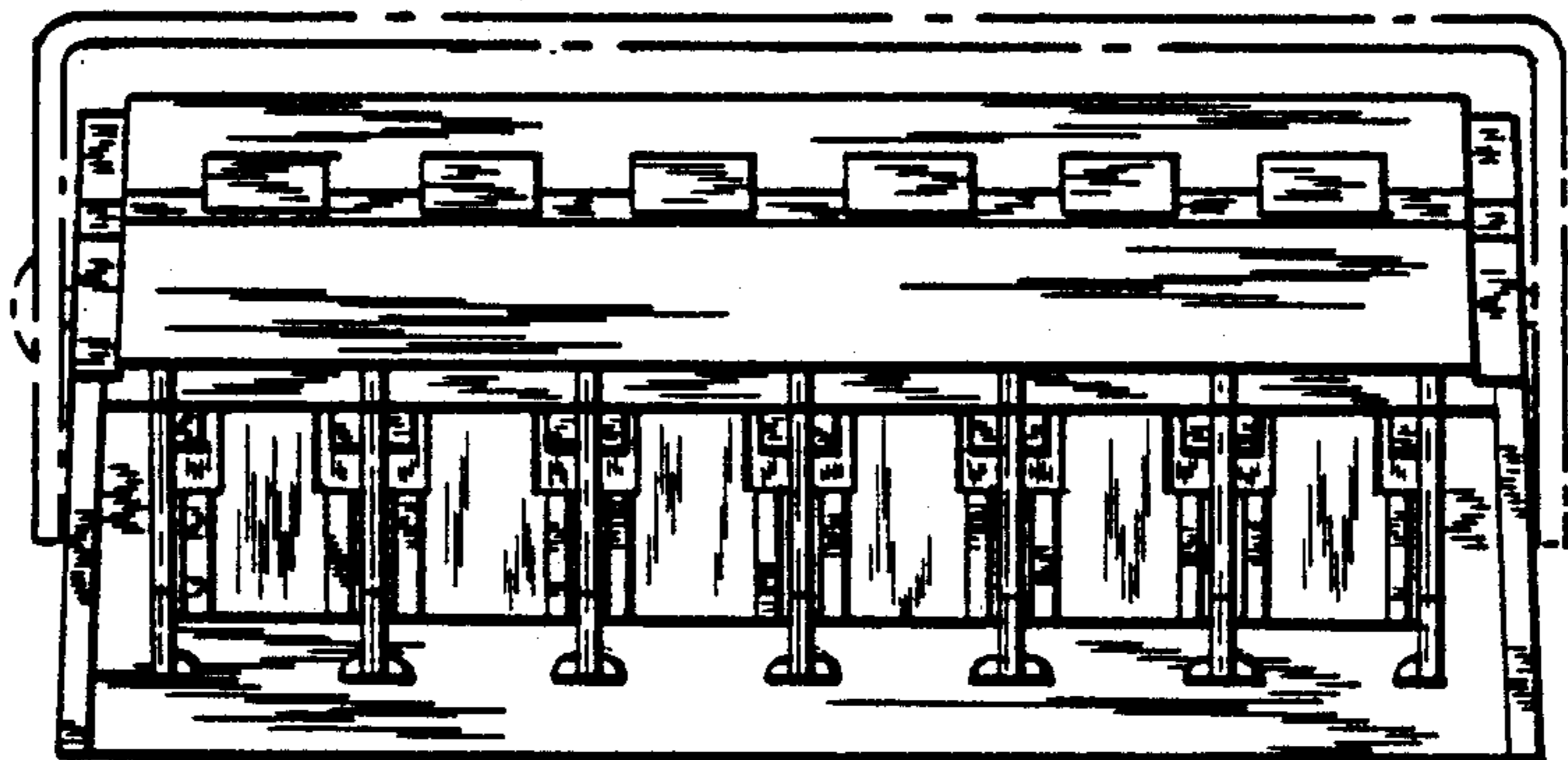
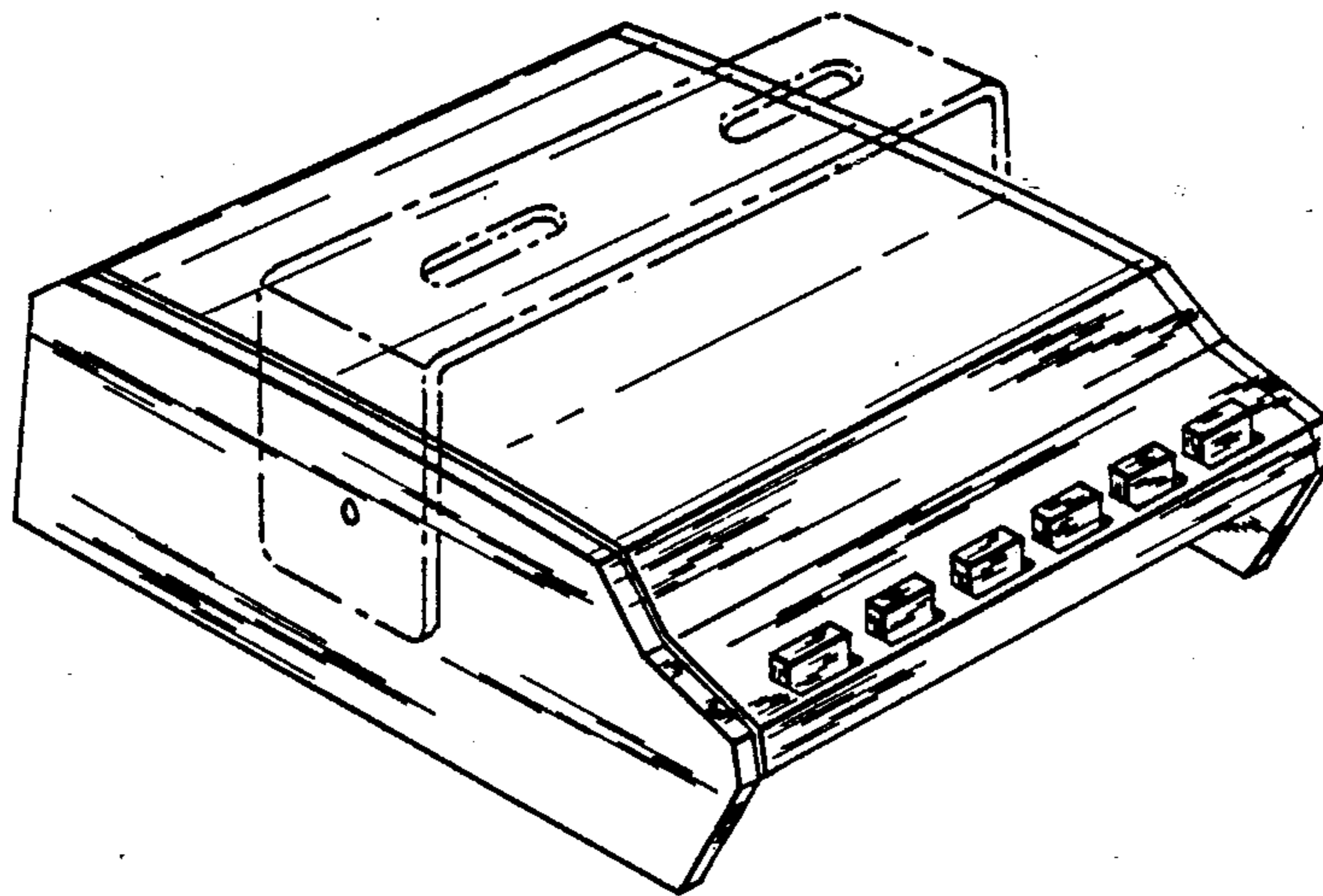
FIG. 2 is a top plan view of the cassette tape holder of FIG. 1;

FIG. 5 is a rear elevational view of the cassette tape holder of FIG. 1; and

FIG. 6 is a bottom plan view of the tape holder of FIG. 1.



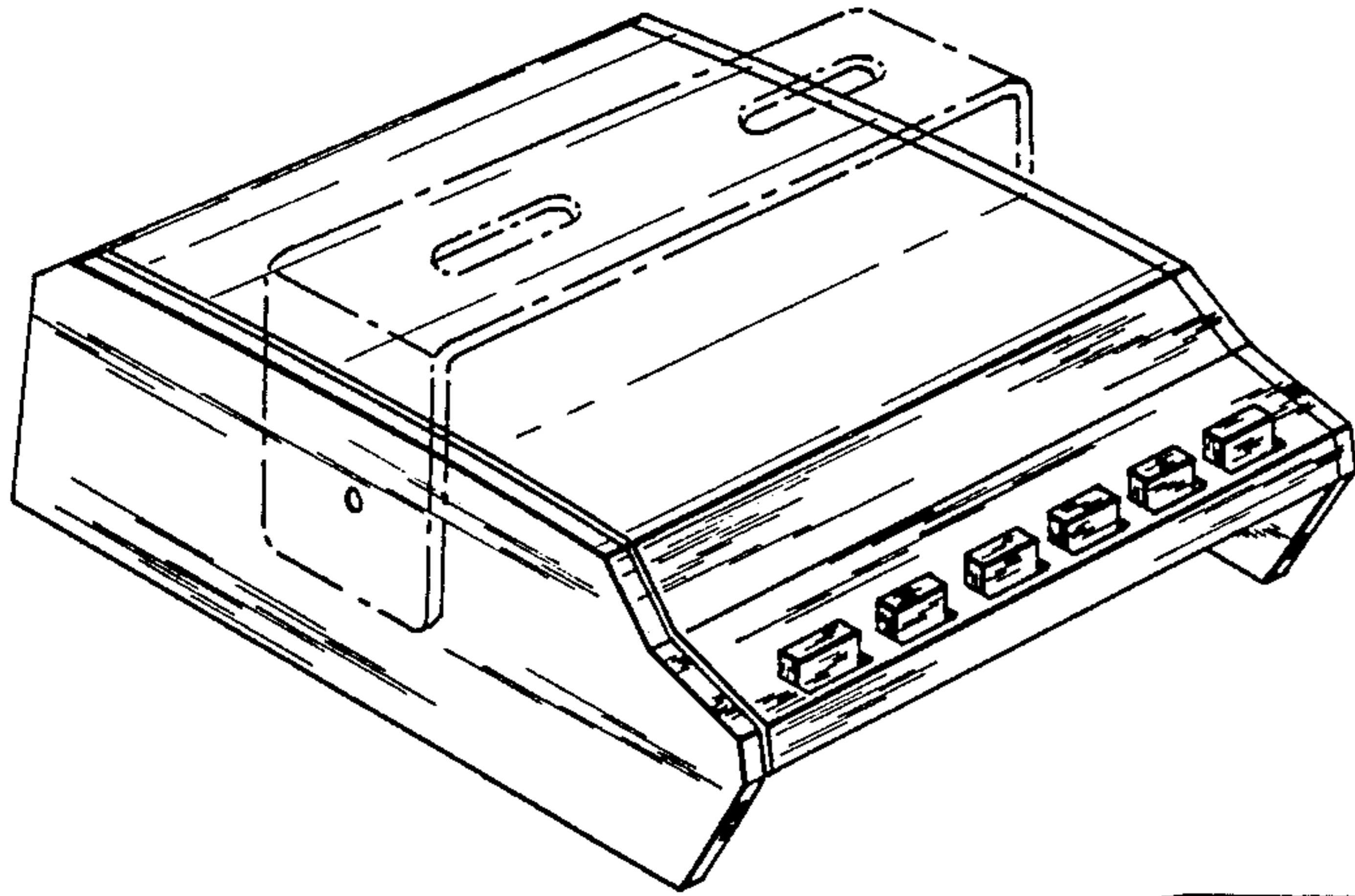

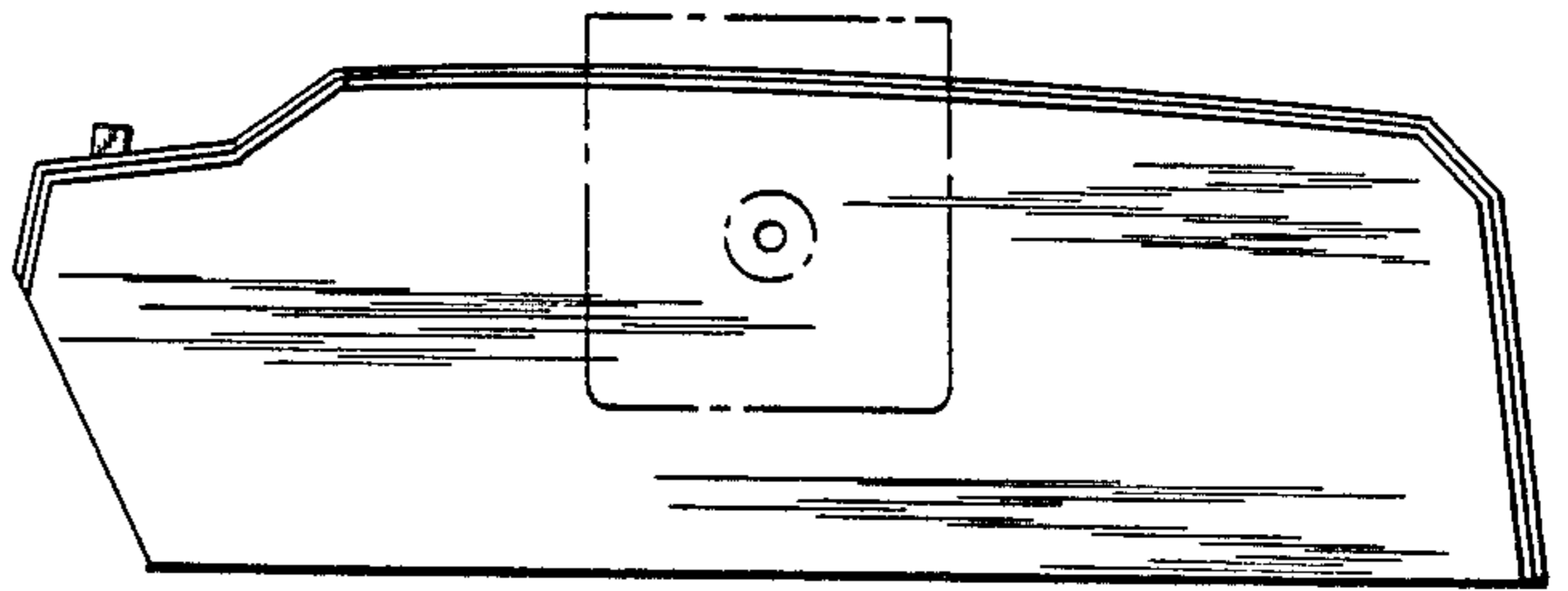
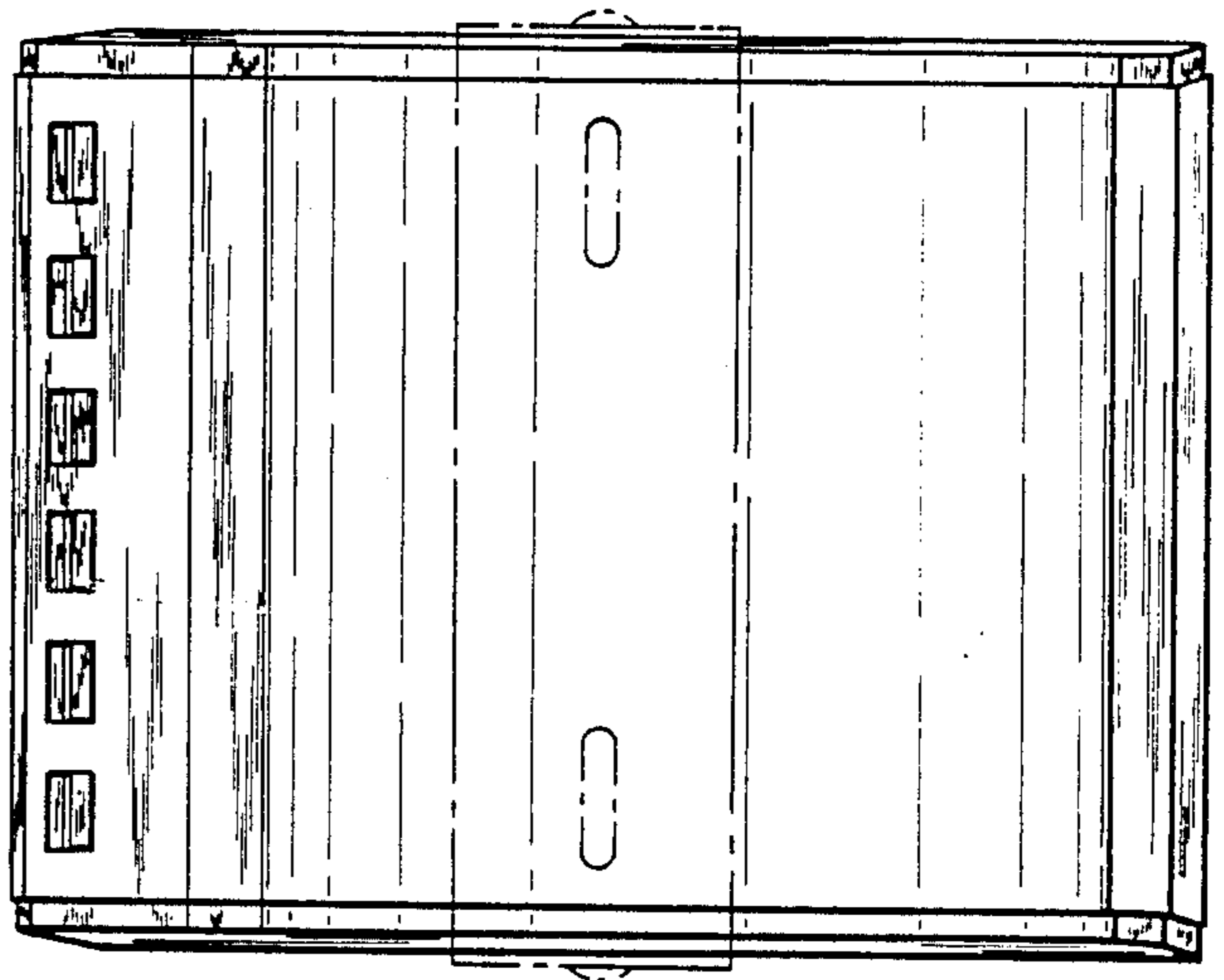

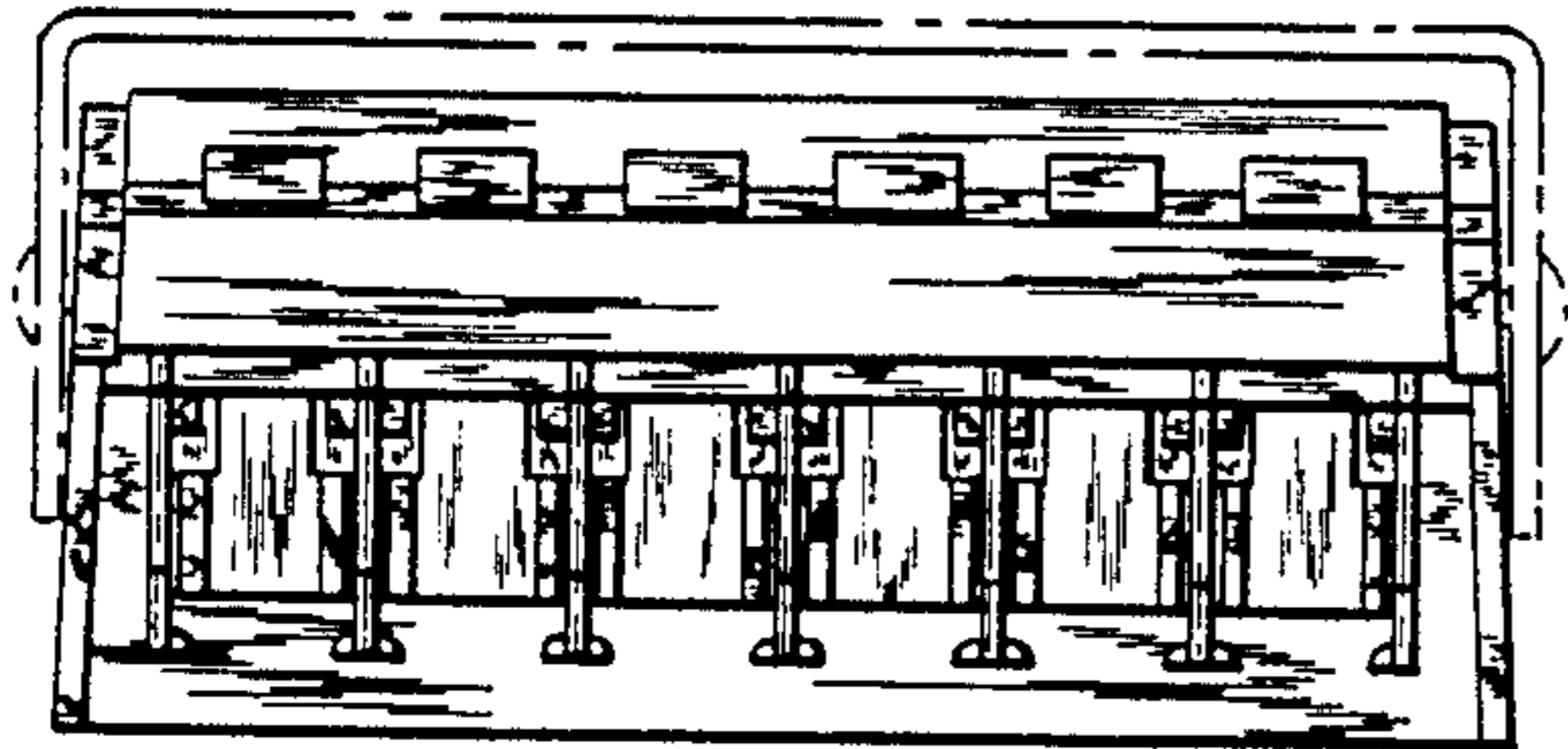

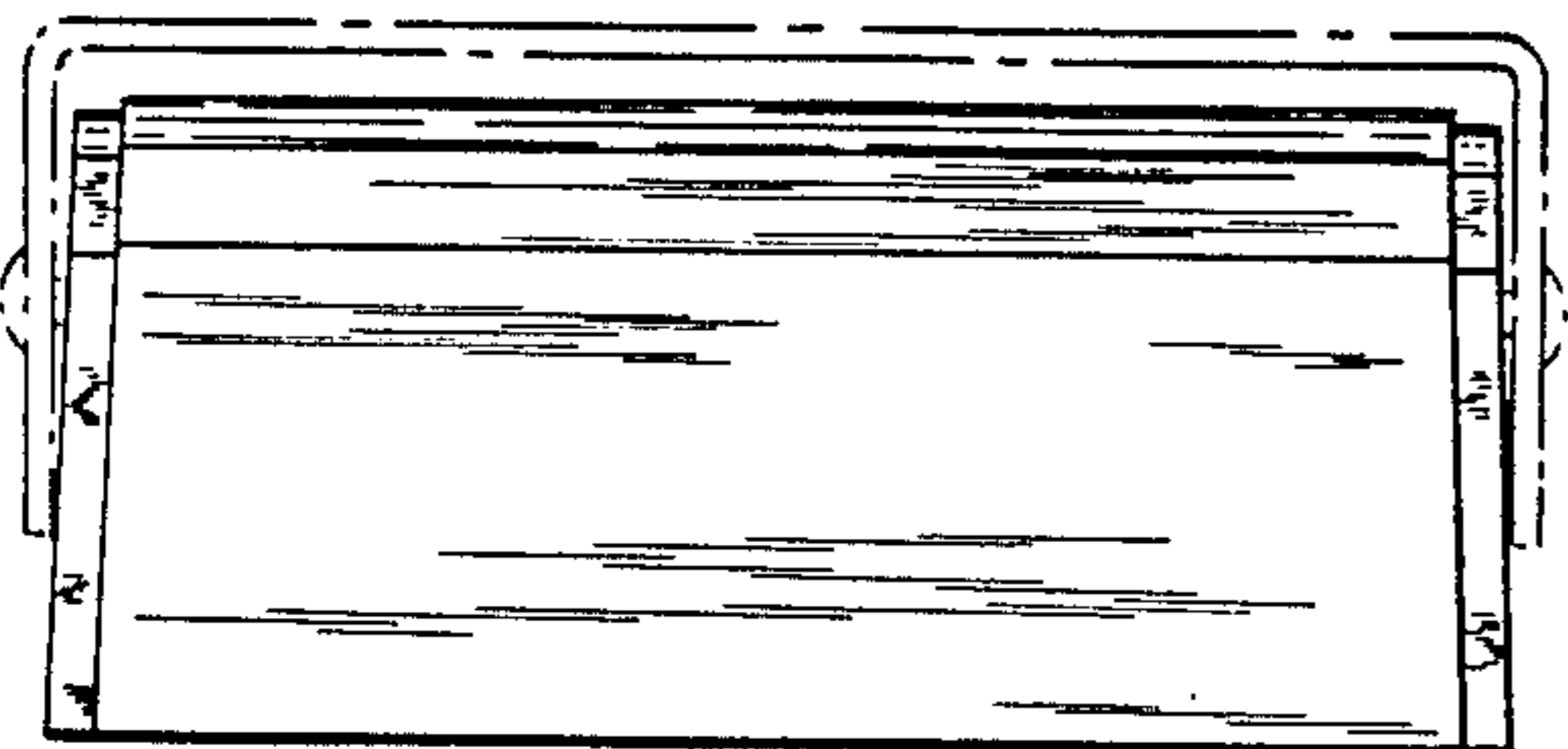

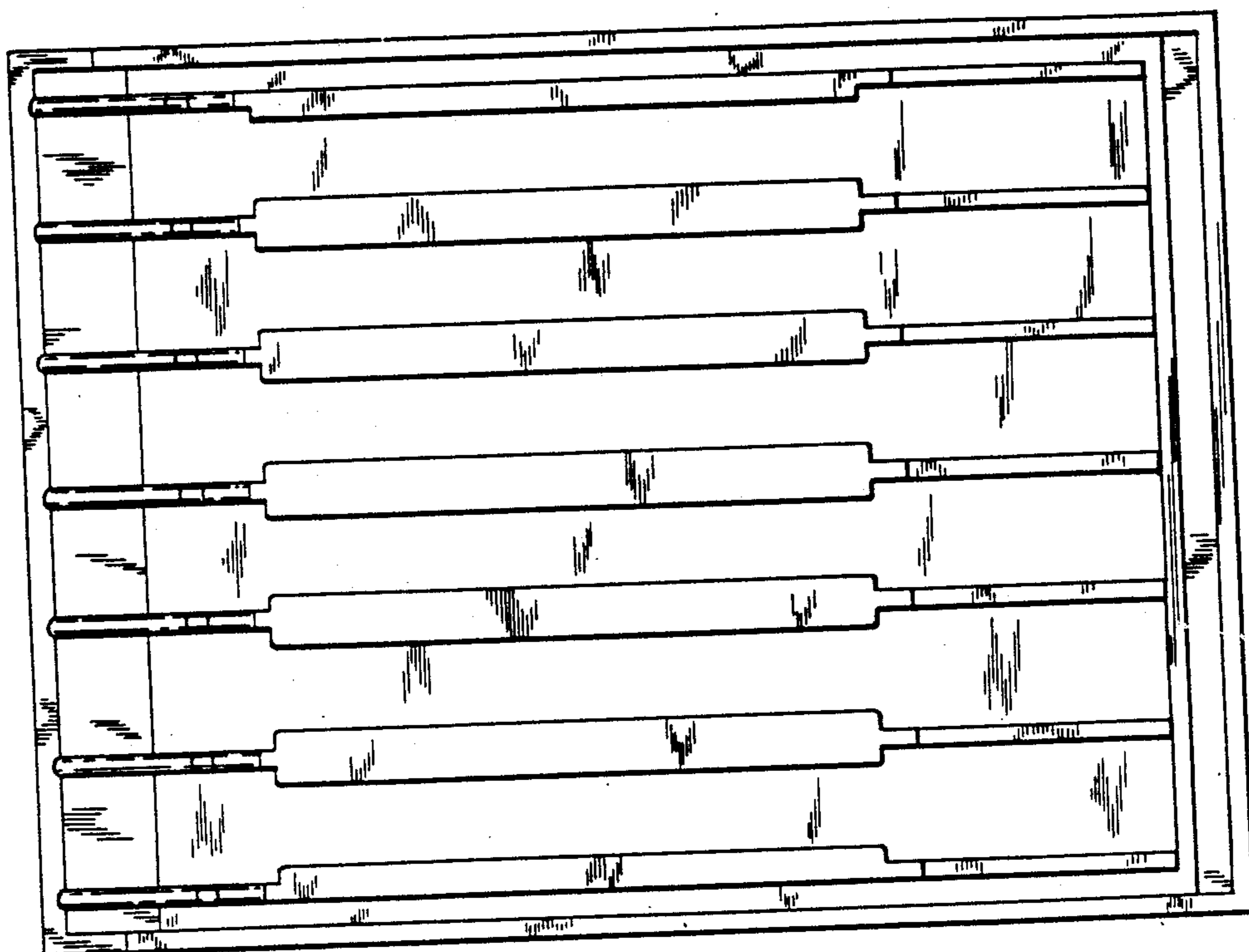
