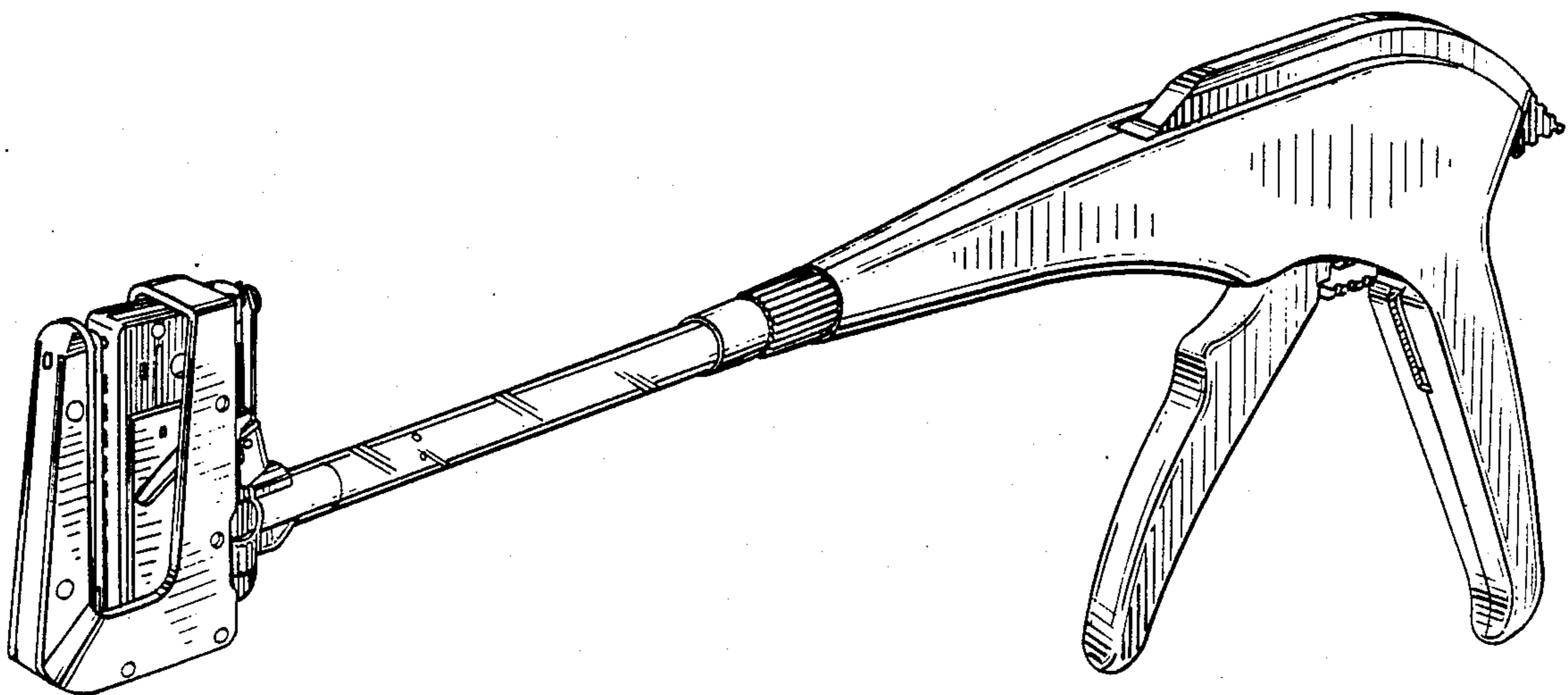

DESCRIPTION

FIG. 1 is a left front perspective view of a surgical stapler, showing our new design;
 FIG. 2 is a right side elevational view of the surgical stapler;
 FIG. 3 is a plan top view of the surgical stapler;
 FIG. 4 is a bottom view of the surgical stapler;
 FIG. 5 is a front elevational view of the surgical stapler;

 FIG. 6 is a rear elevational view of the surgical stapler.



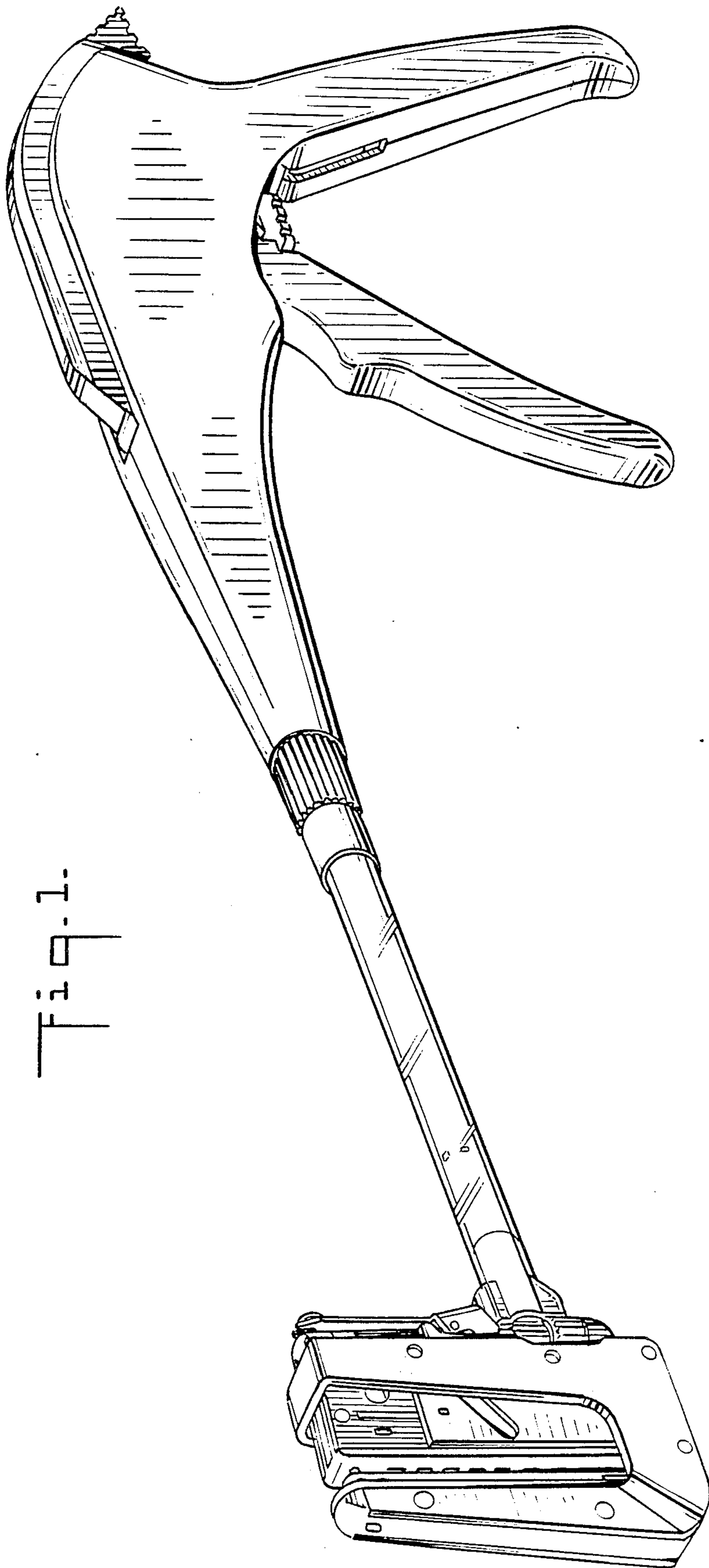

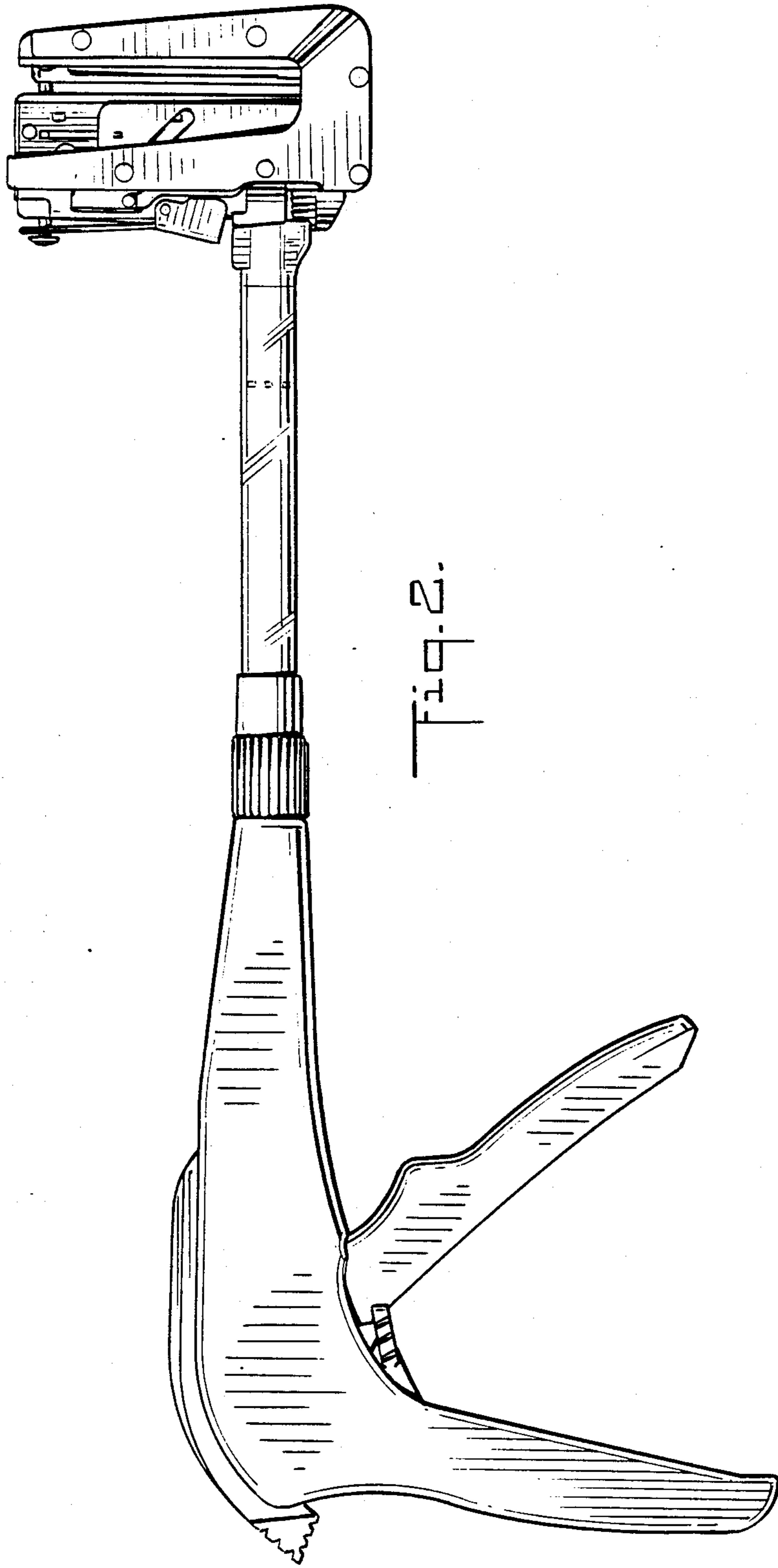
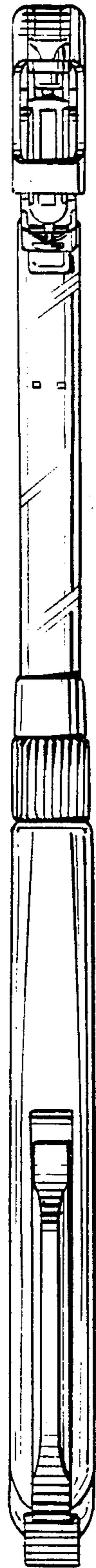

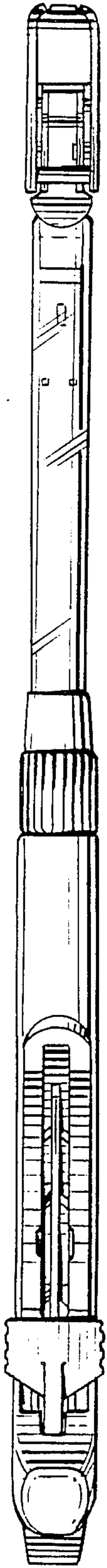

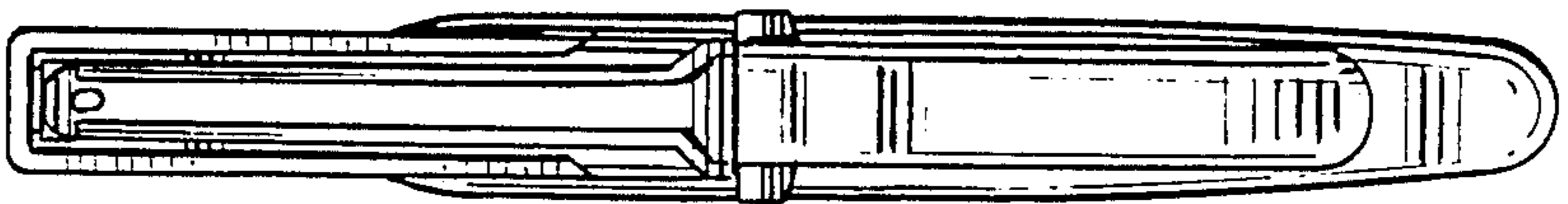
