[57] CLAIM

The ornamental design for combination telephone handset and console stand assembly, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view from above of a combined telephone handset and console stand assembly showing my new design;

FIG. 2 is a right side elevational view thereof;

FIG. 3 is a top plan view thereof with the handset spaced apart from the console stand;

FIG. 4 is a similar top plan view thereof with the handset on the console stand;

FIG. 5 is a front elevational view thereof;

FIG. 6 is a left side elevational view thereof;

FIG. 7 is a rear elevational view thereof; and

FIG. 8 is a bottom plan view thereof.



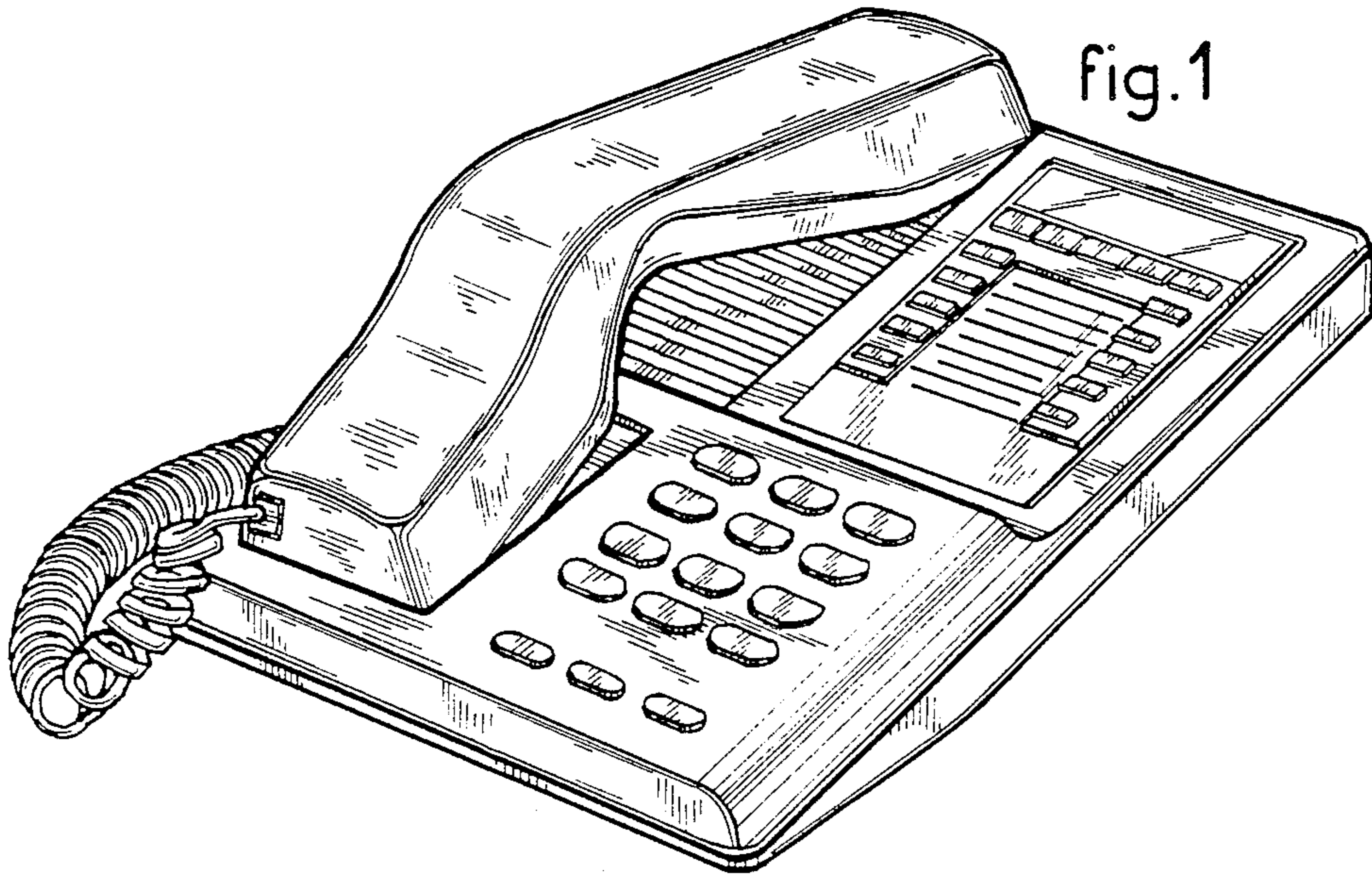

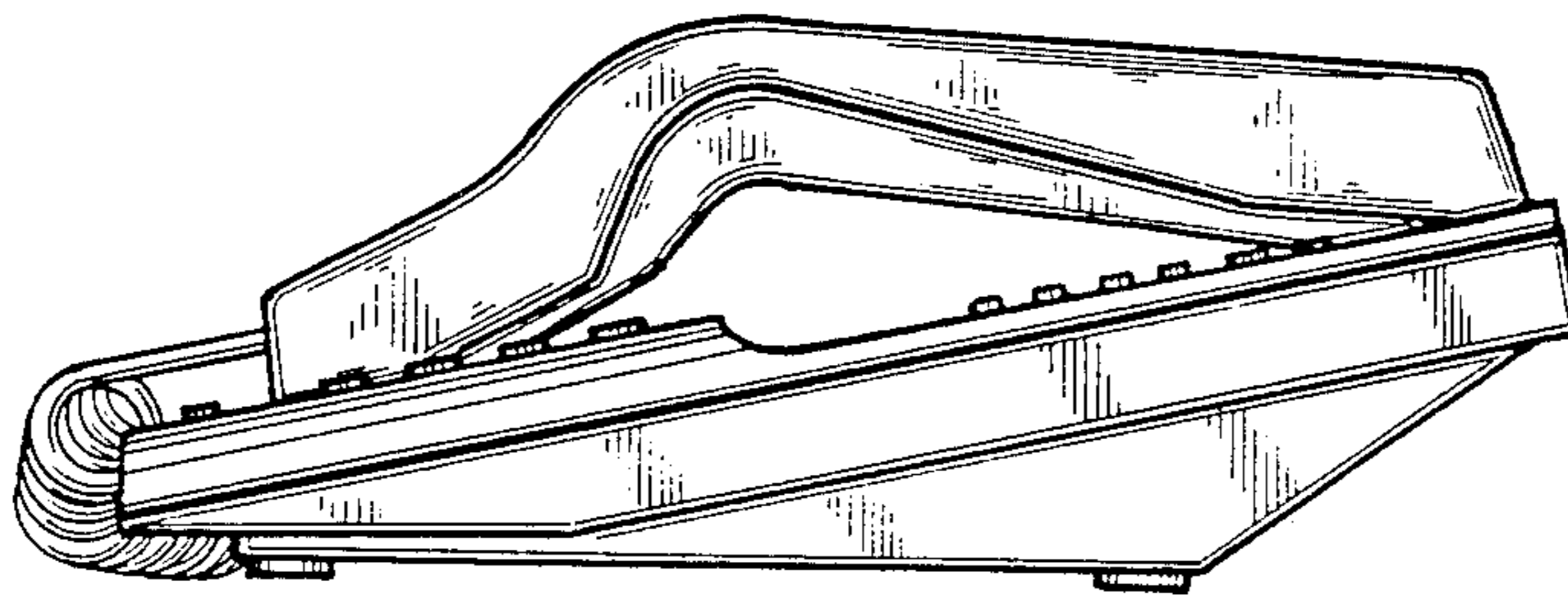

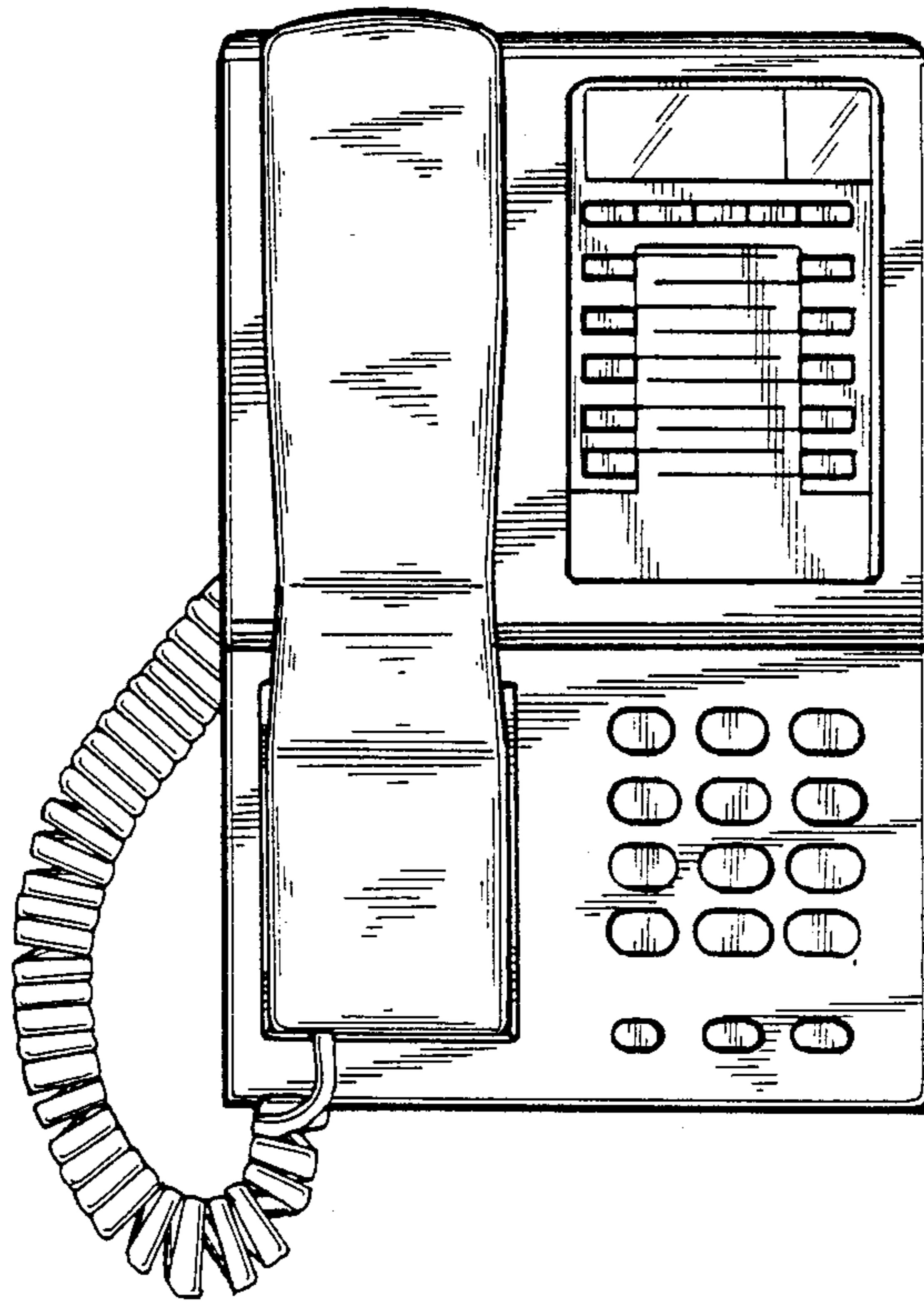

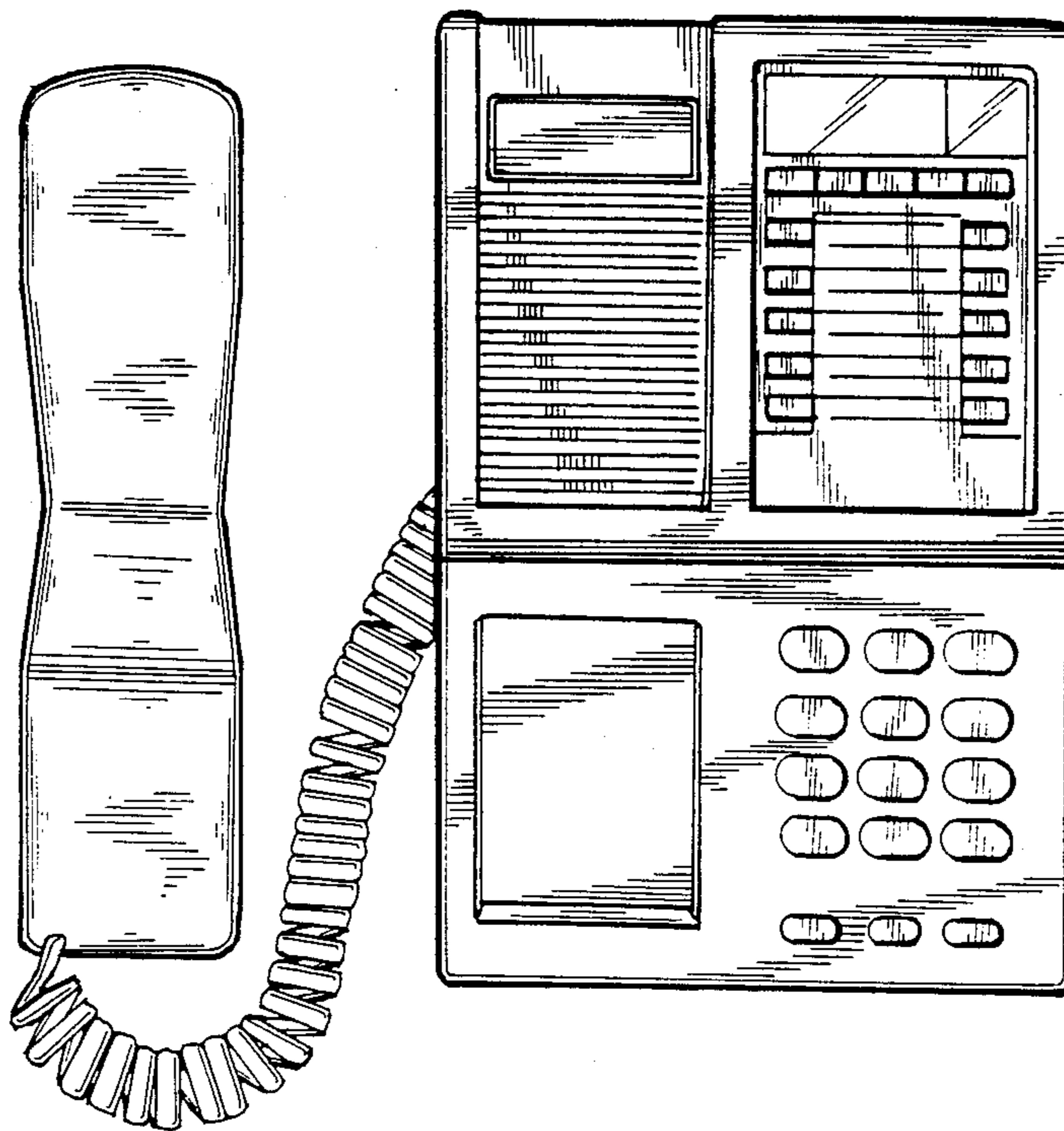

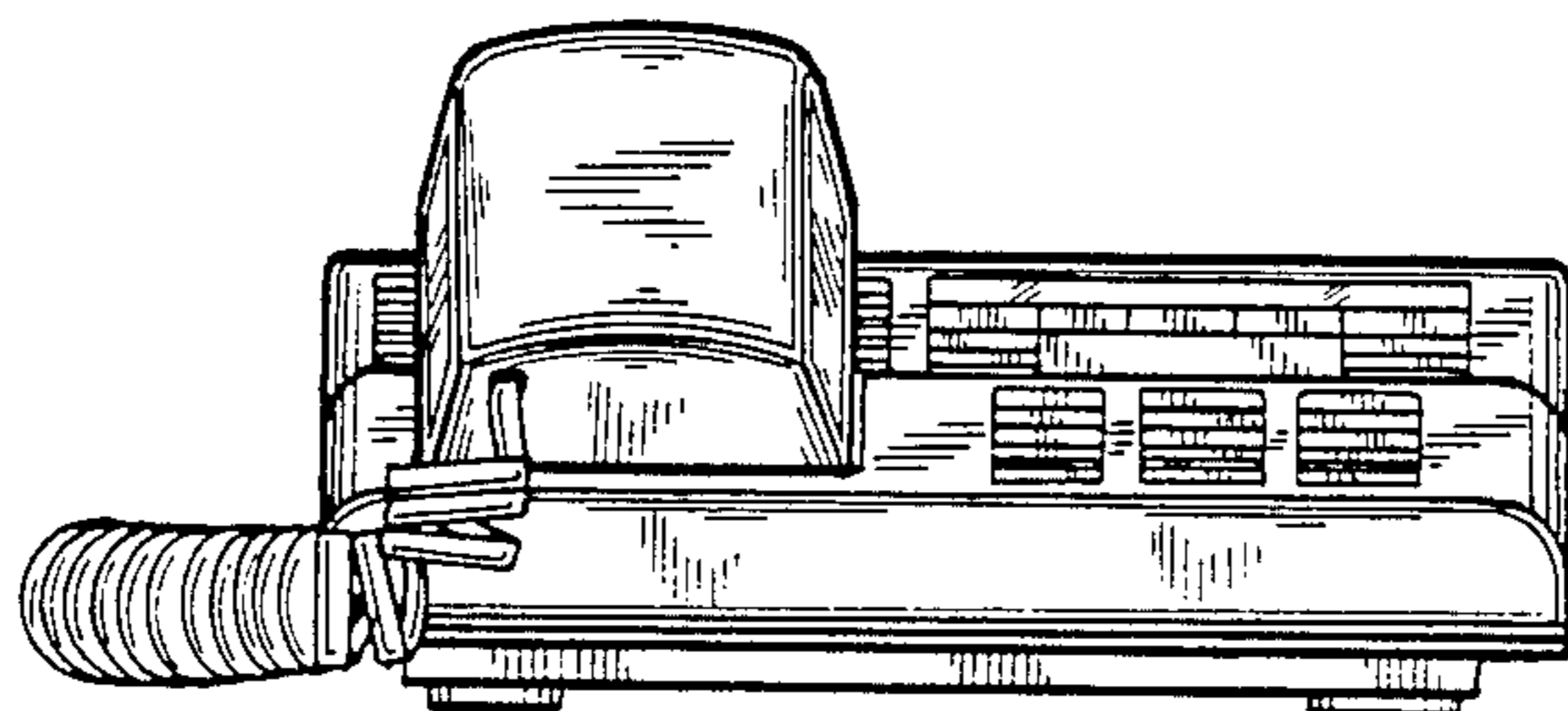

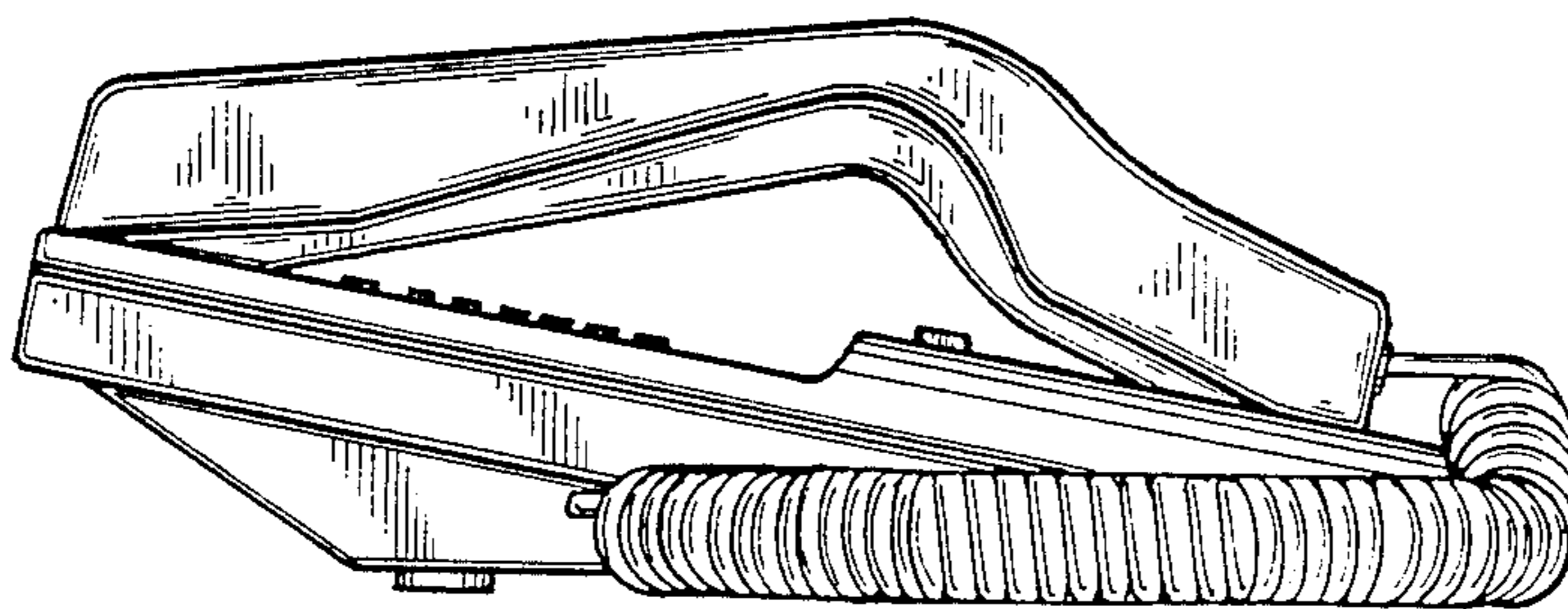

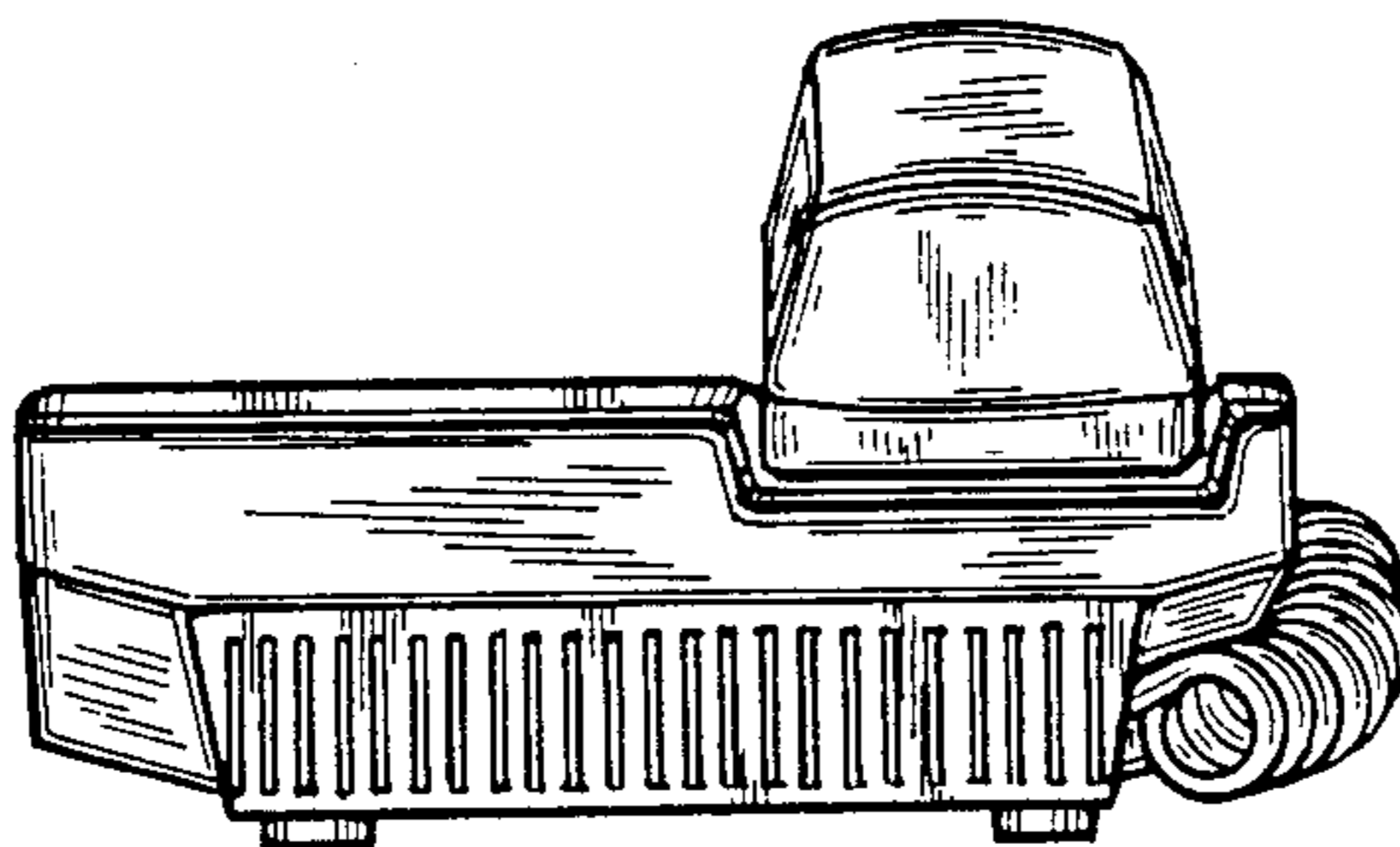
