DESCRIPTION

FIG. 1 is a top front perspective view of a shoe showing my new design;
FIG. 2 is a left side elevational view;
FIG. 3 is a right side elevational view;
FIG. 4 is a bottom plan view;
FIG. 5 is a front elevational view;
FIG. 6 is a top plan view;
FIG. 7 is a rear elevational view;
FIG. 8 is a top front perspective view of a shoe showing a modified form of my new design;
FIG. 9 is a left side elevational view of the second embodiment;
FIG. 10 is a right side elevational view thereof;
FIG. 11 is a top plan view thereof;
FIG. 12 is a front elevational view thereof; and
FIG. 13 is a rear elevational view thereof, the bottom being the same as shown in FIG. 4.

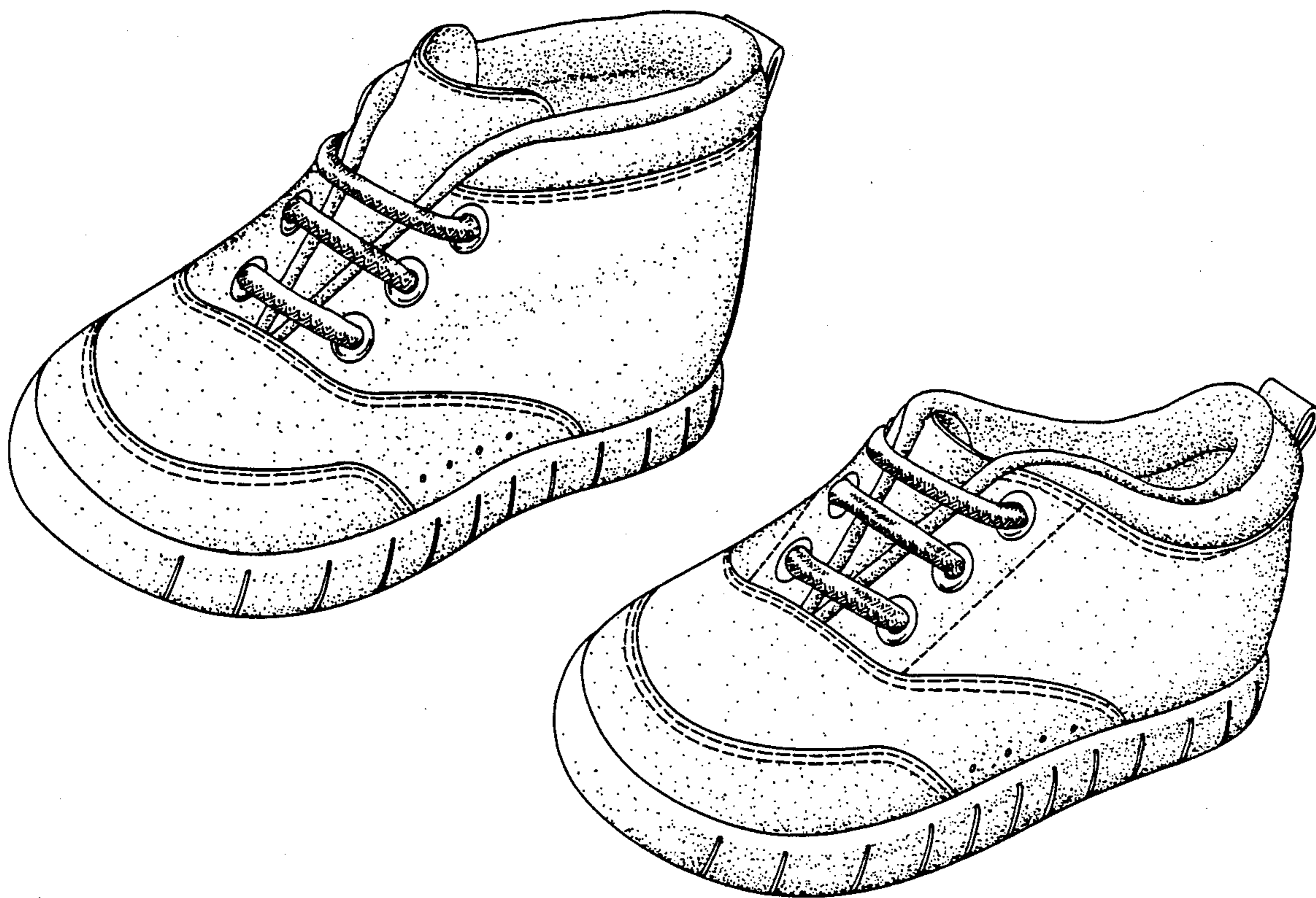

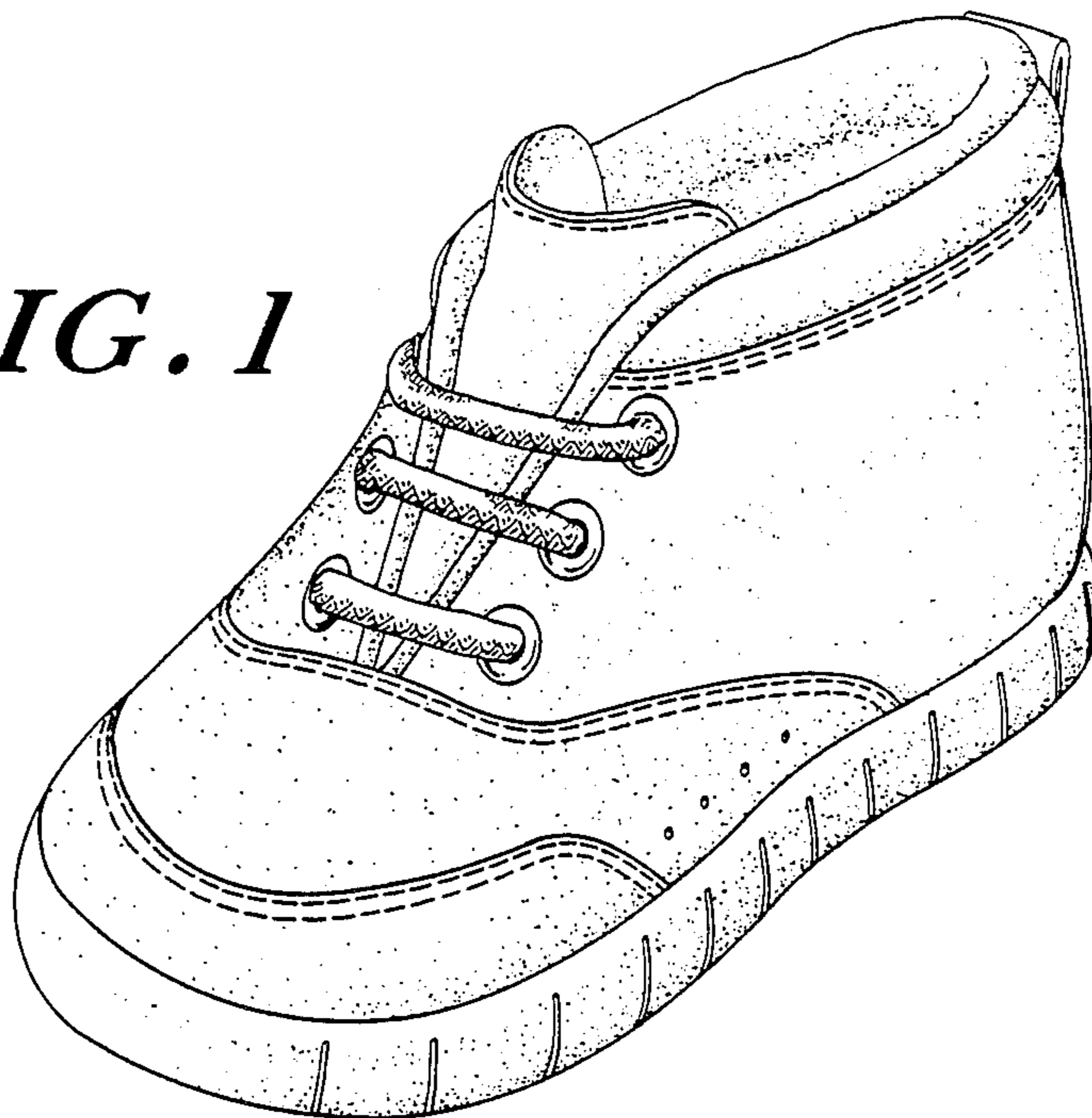

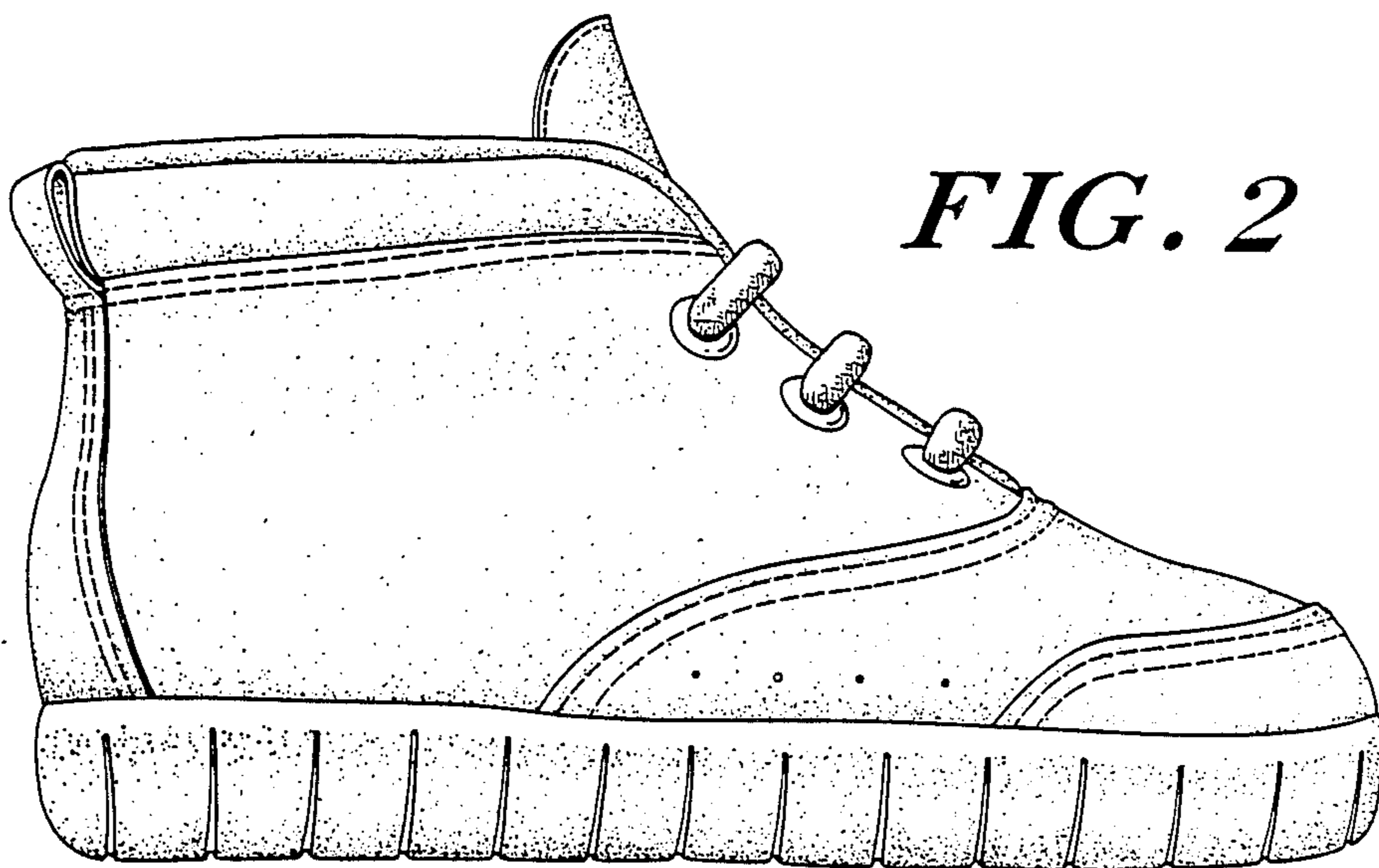

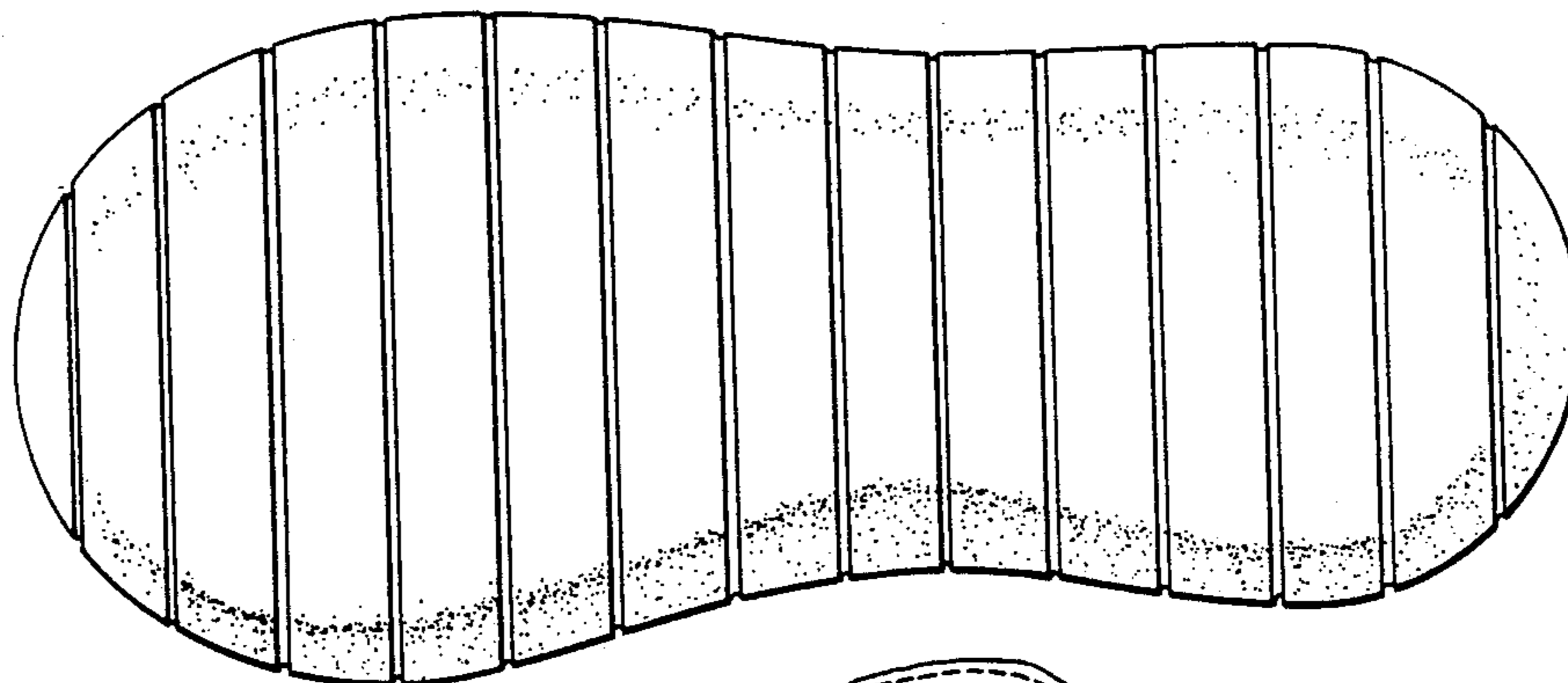
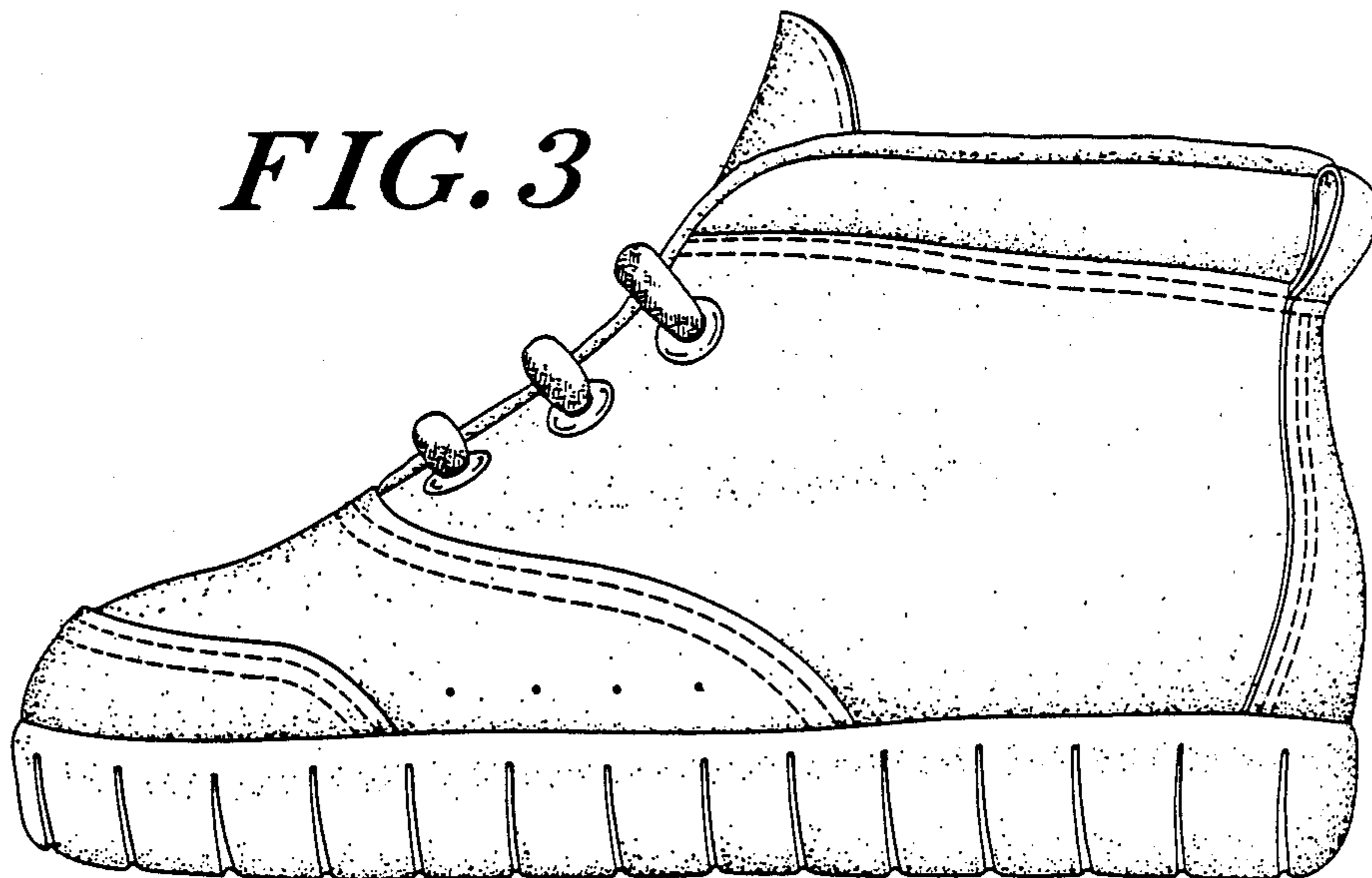
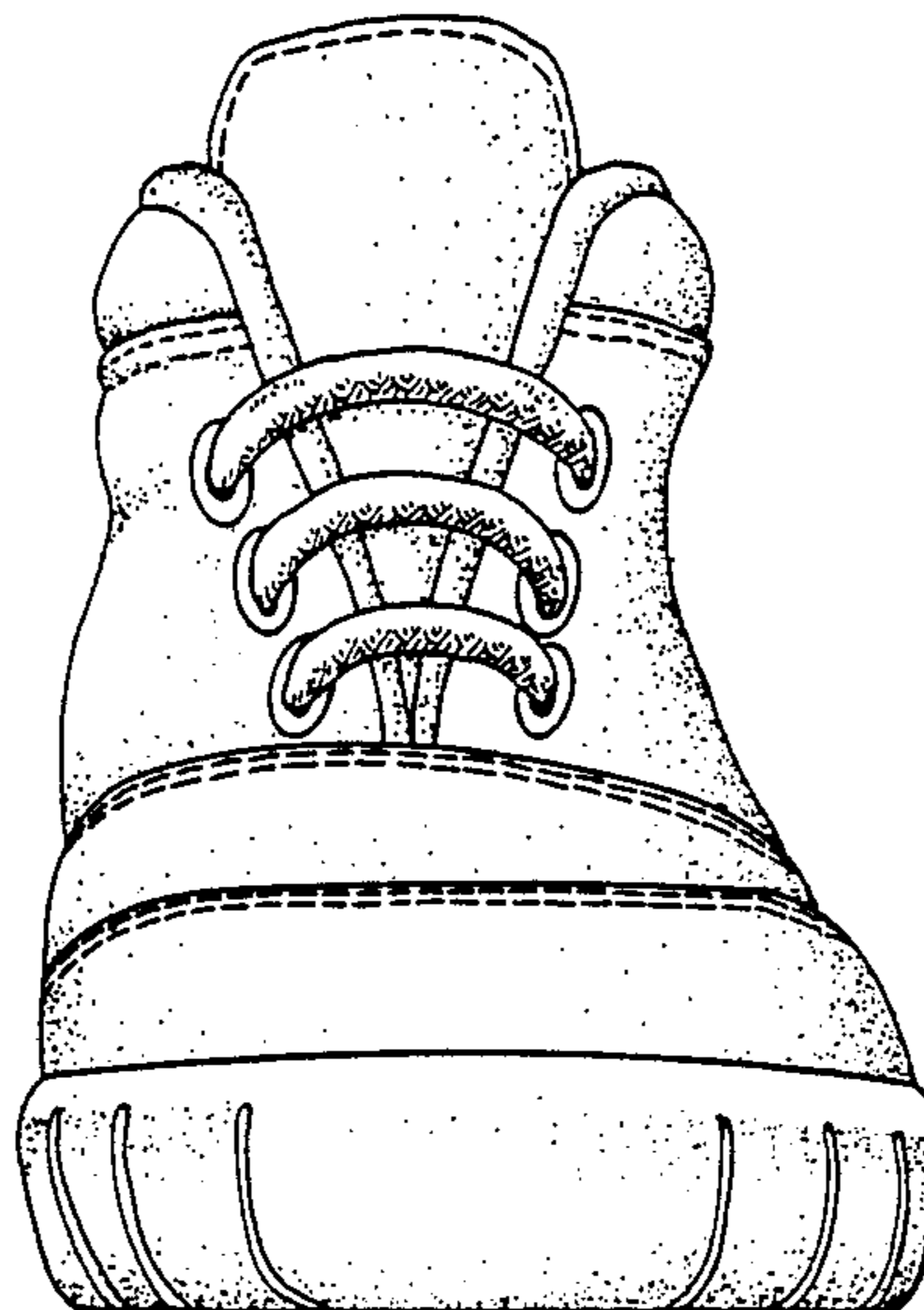

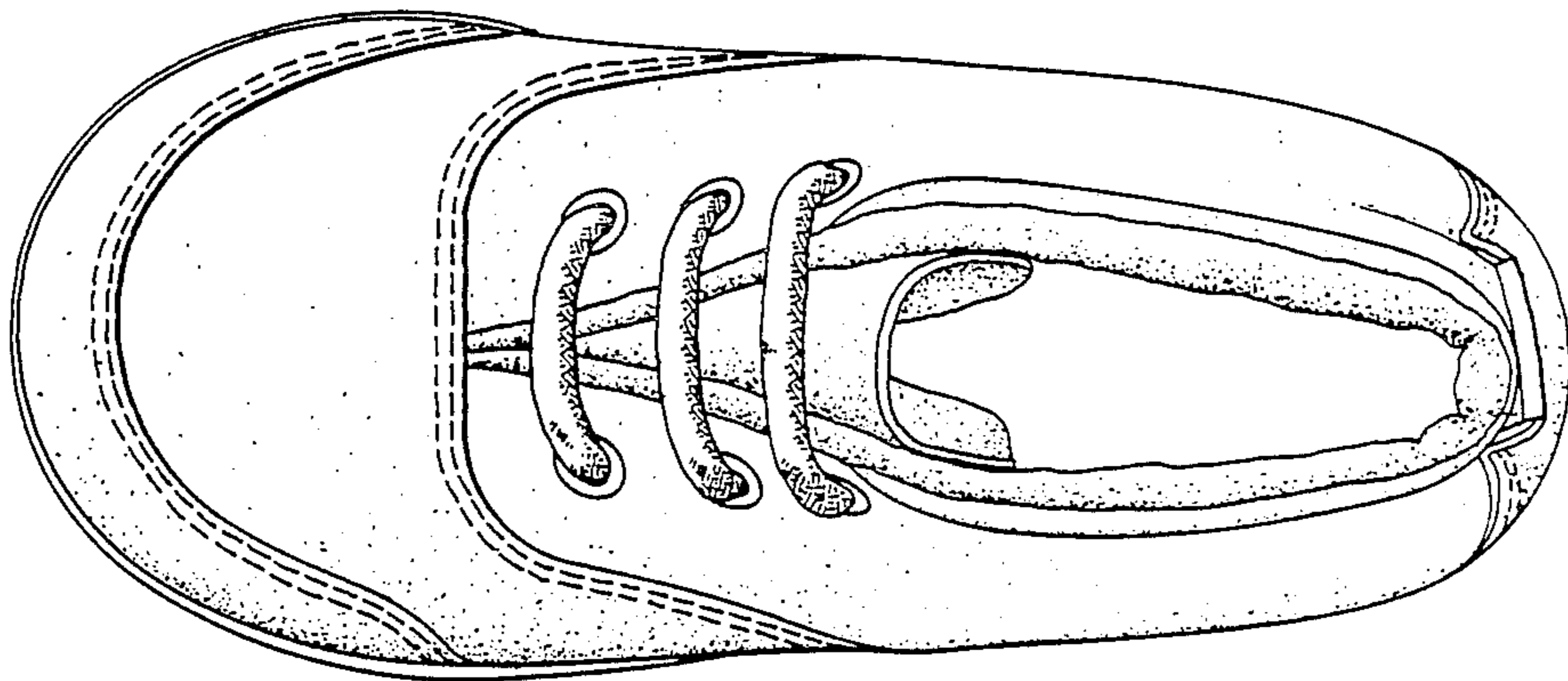

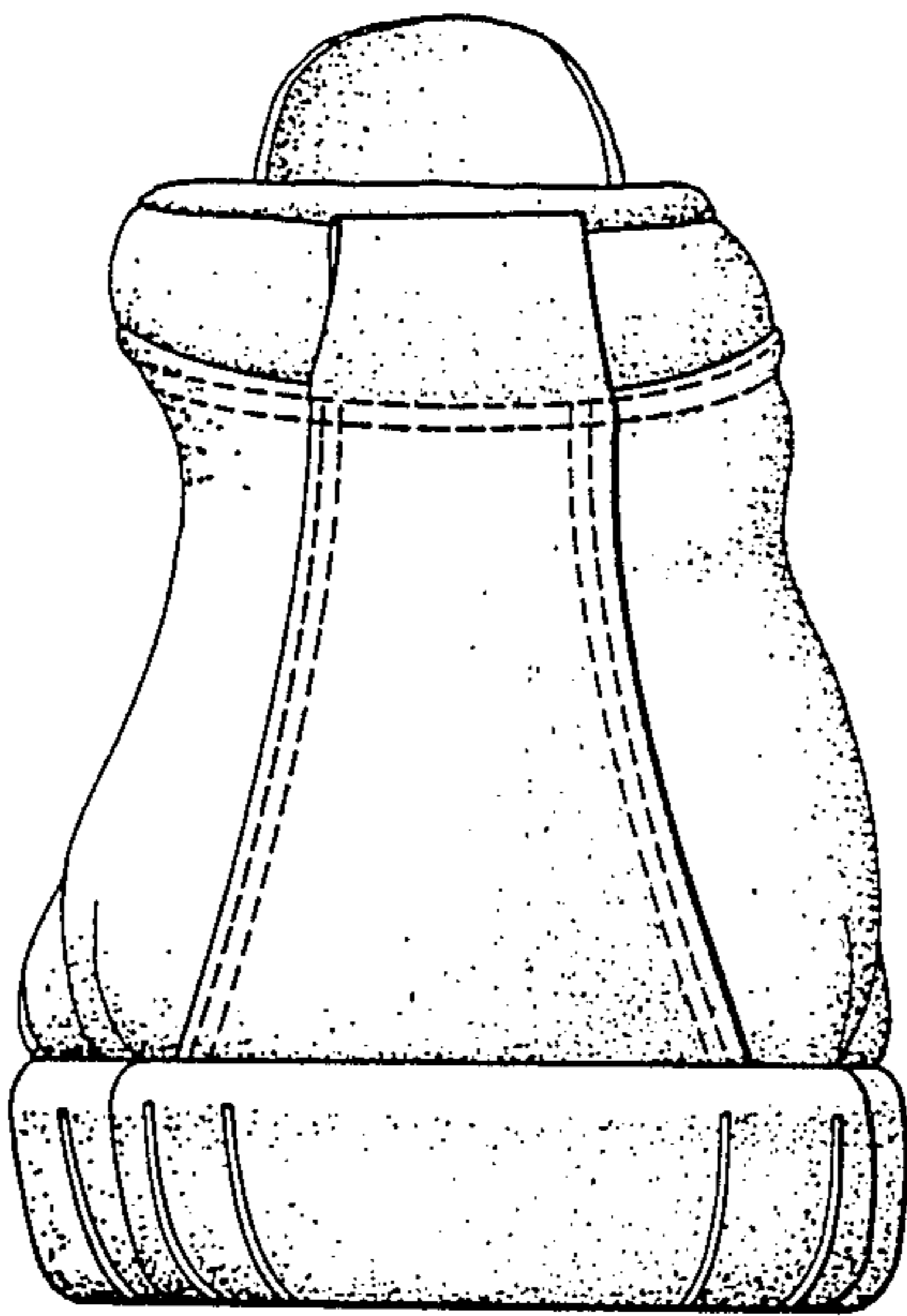

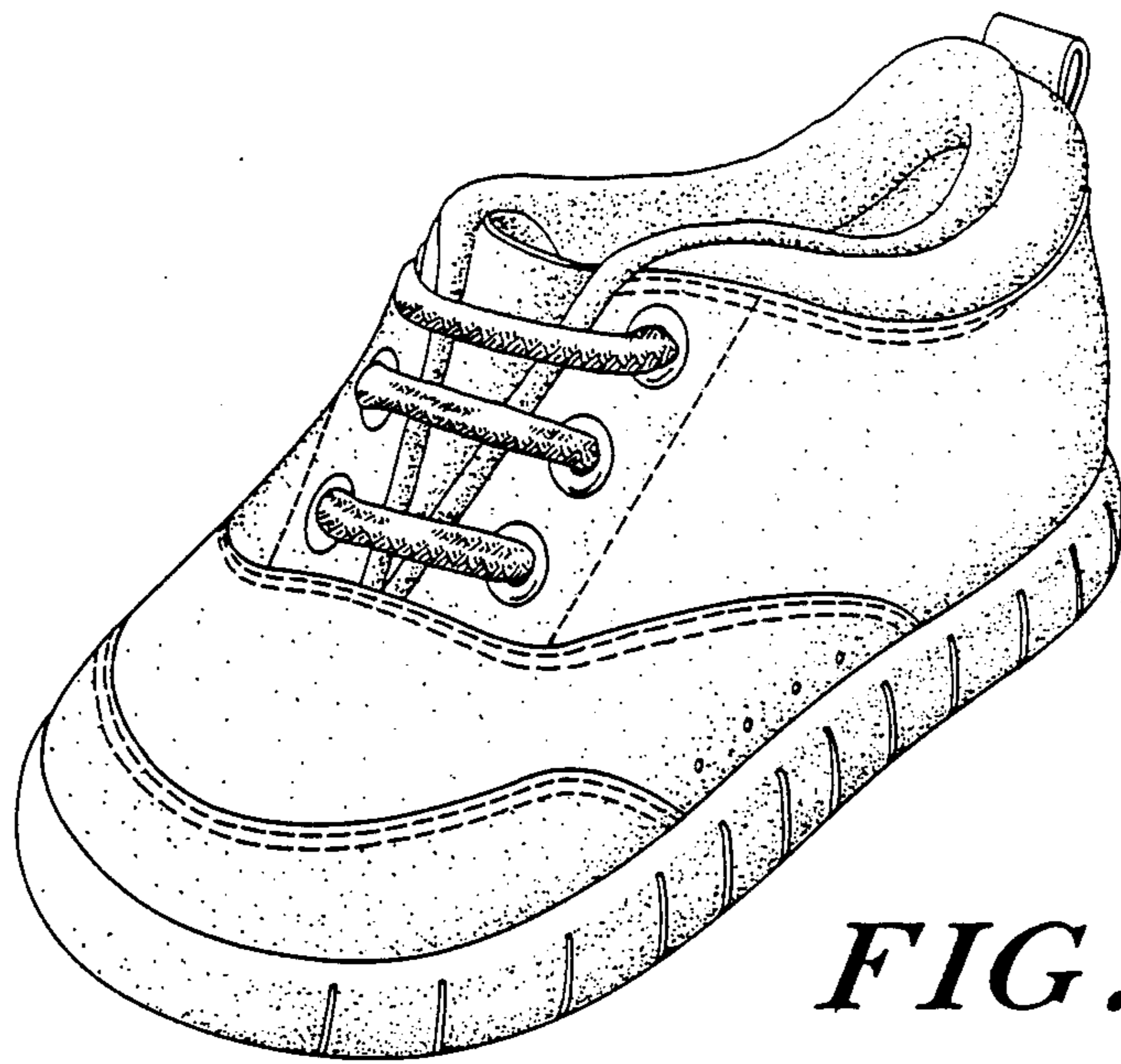

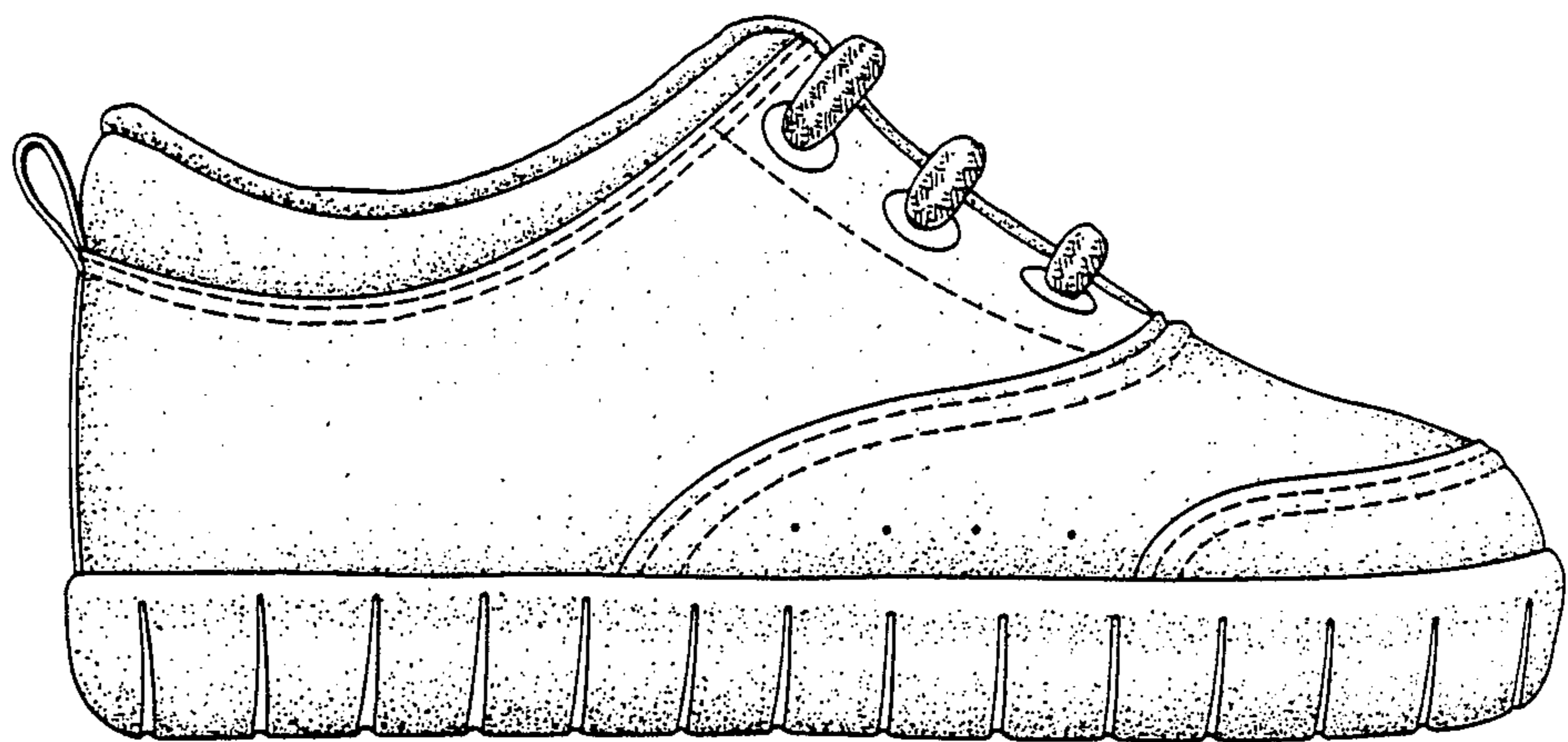

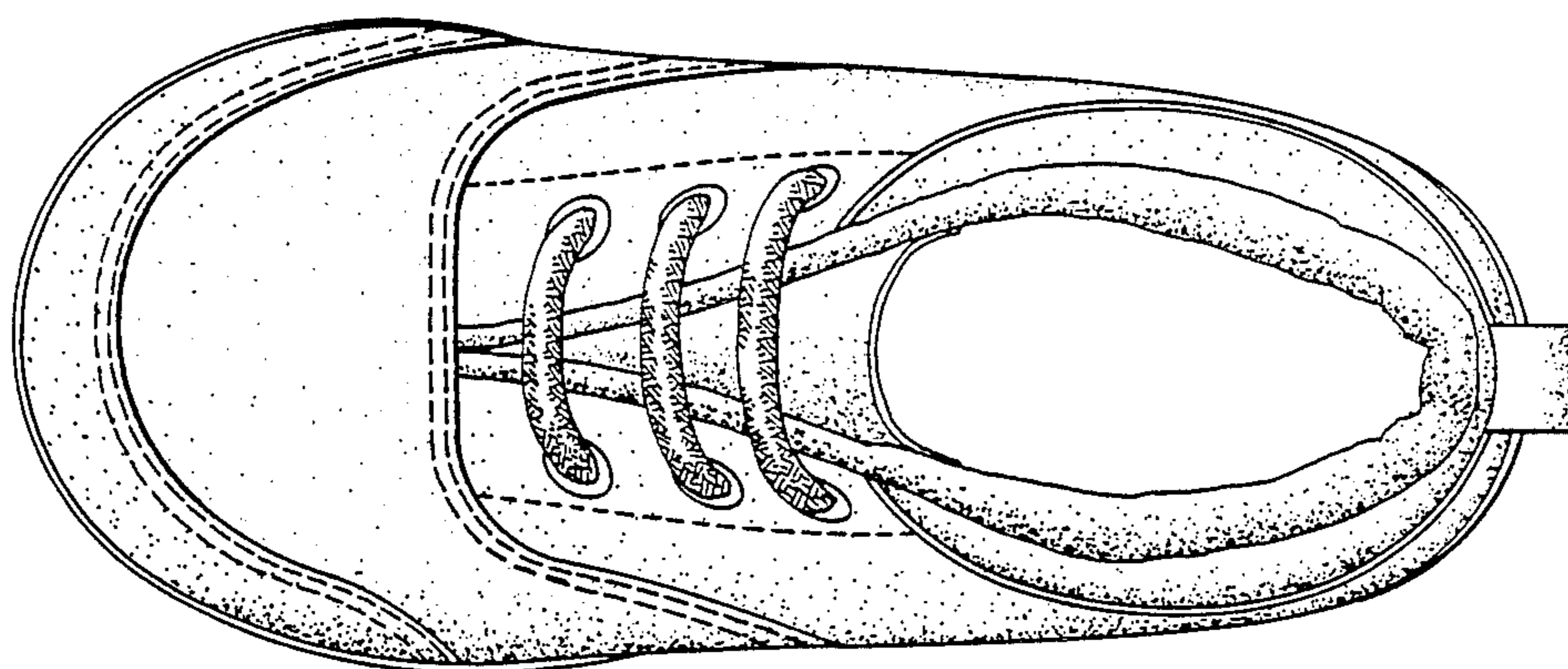
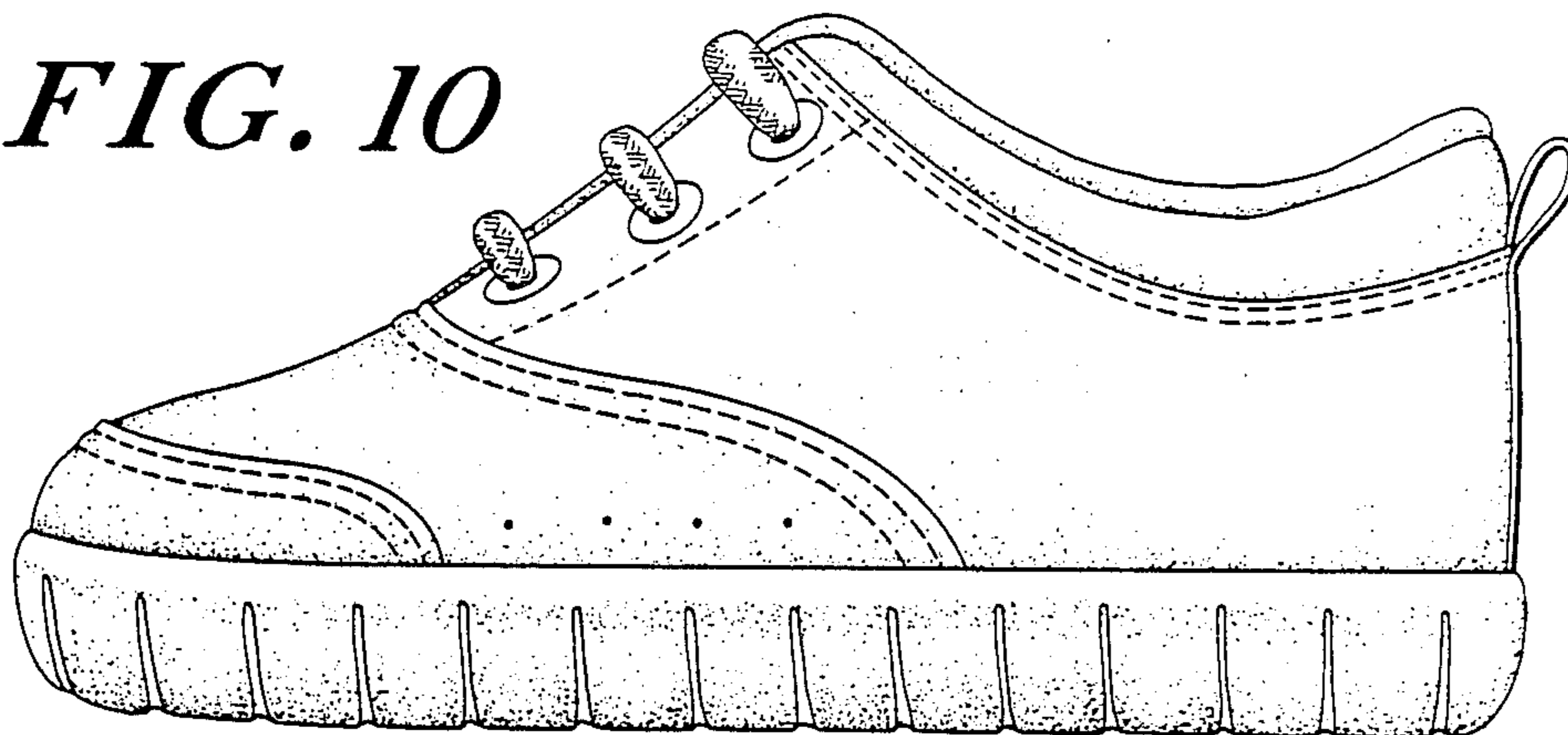

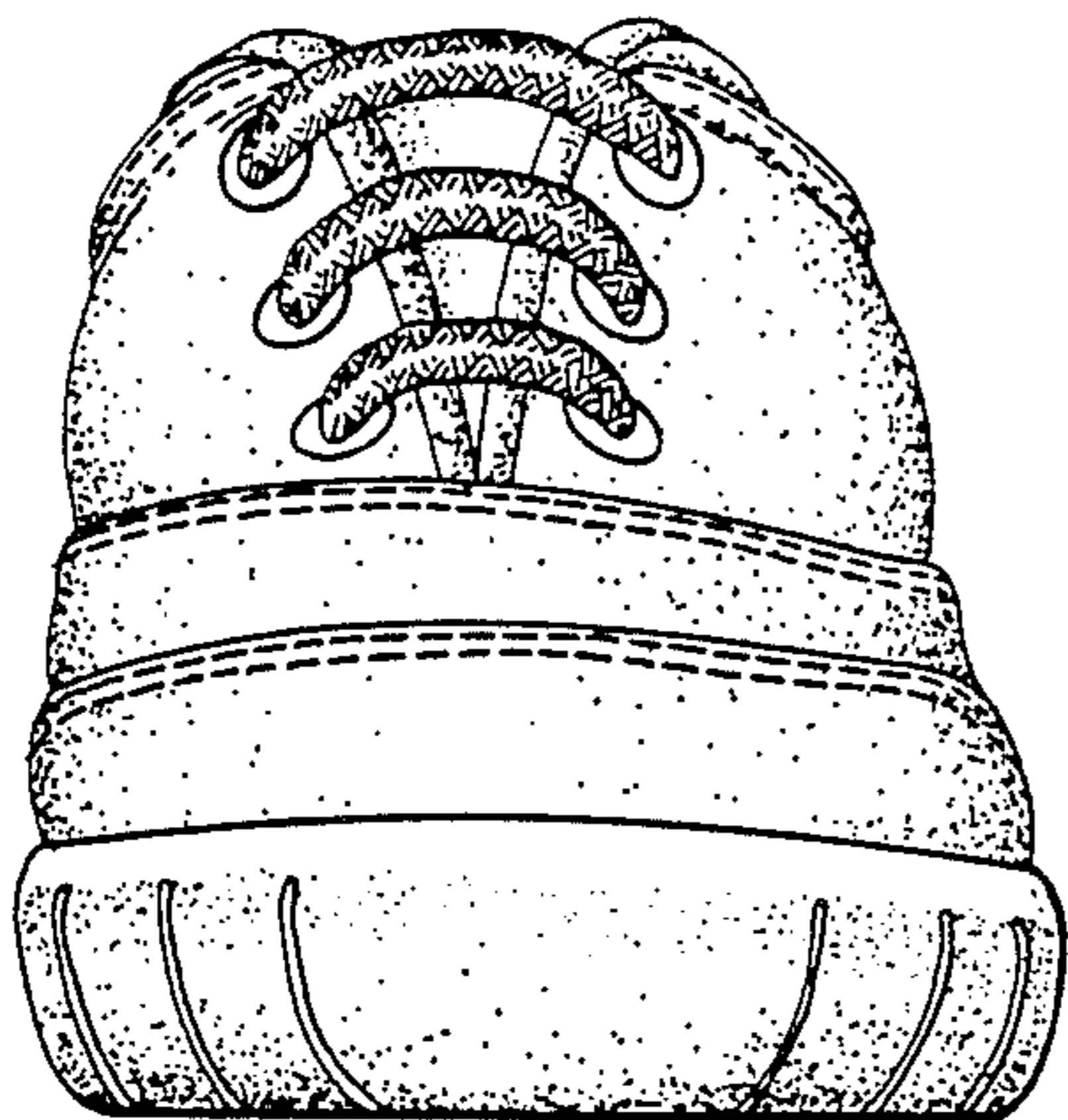

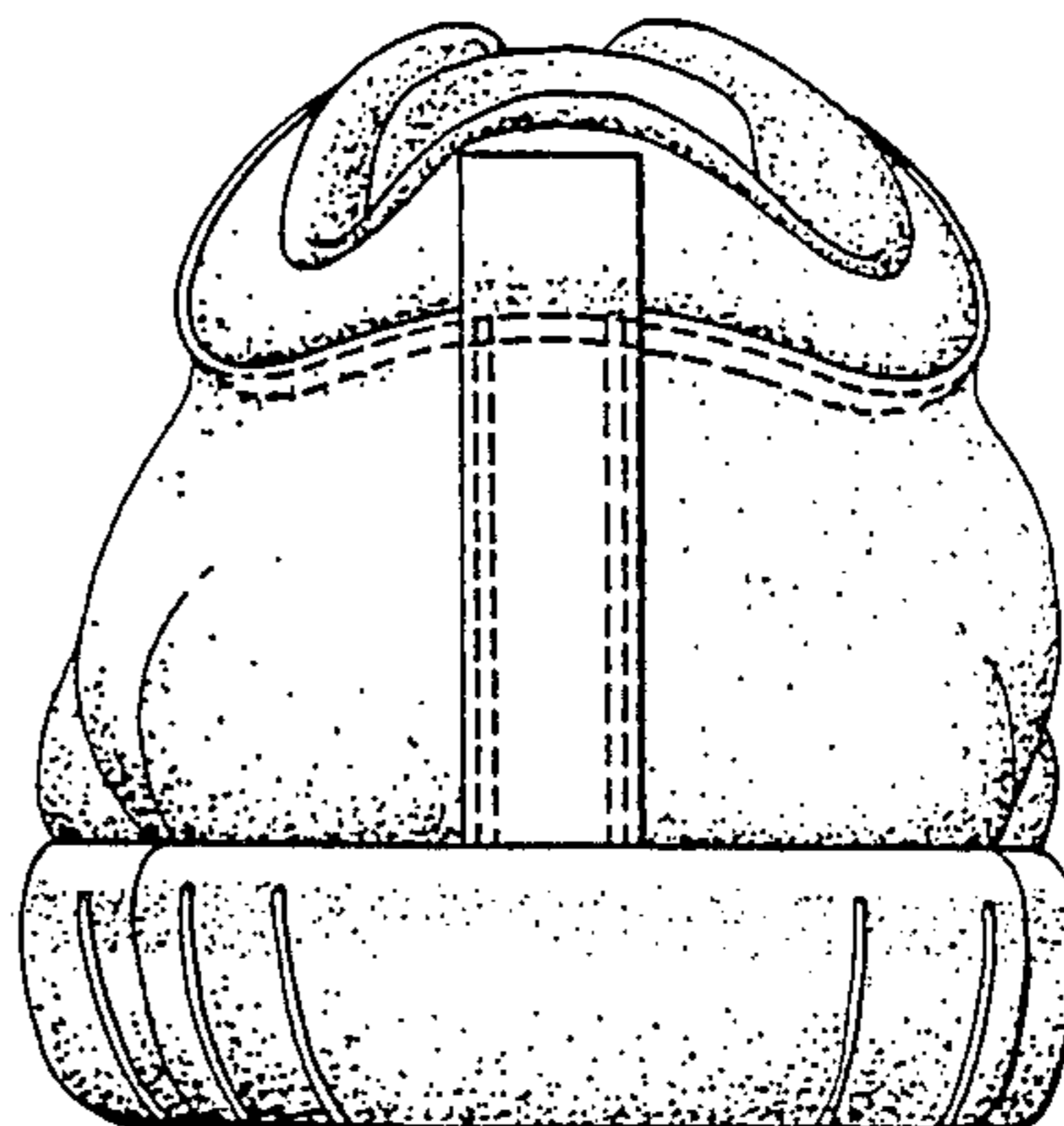
