[57] CLAIM

The ornamental design for a whirlpool bathing shell, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a whirlpool bathing shell embodying my new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a rear side elevational view thereof;
FIG. 7 is a bottom plan view thereof;
FIG. 8 is a cross sectional view thereof, taken on the line 8—8 of FIG. 2;
FIG. 9 is a cross sectional view thereof, taken on the line 9—9 of FIG. 2;
FIG. 10 is a cross sectional view thereof, taken on the line 10—10 of FIG. 2;
FIG. 11 is a cross sectional view thereof, taken on the line 11—11 of FIG. 2;
FIG. 12 is a fragmentary cross sectional view thereof, taken on the line 12—12 of FIG. 2; and
FIG. 13 is a fragmentary cross sectional view thereof, taken on the line 13—13 of FIG. 2.

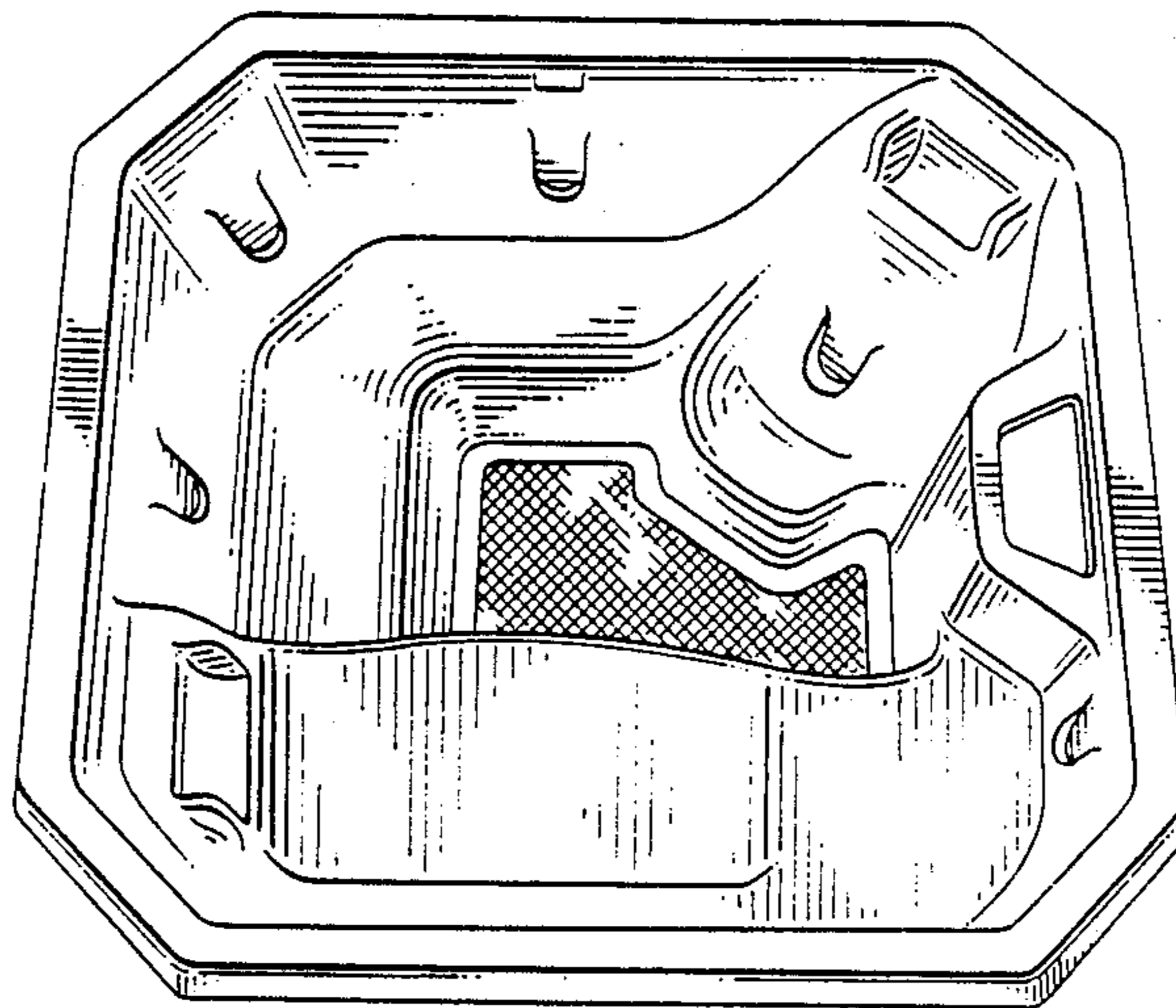

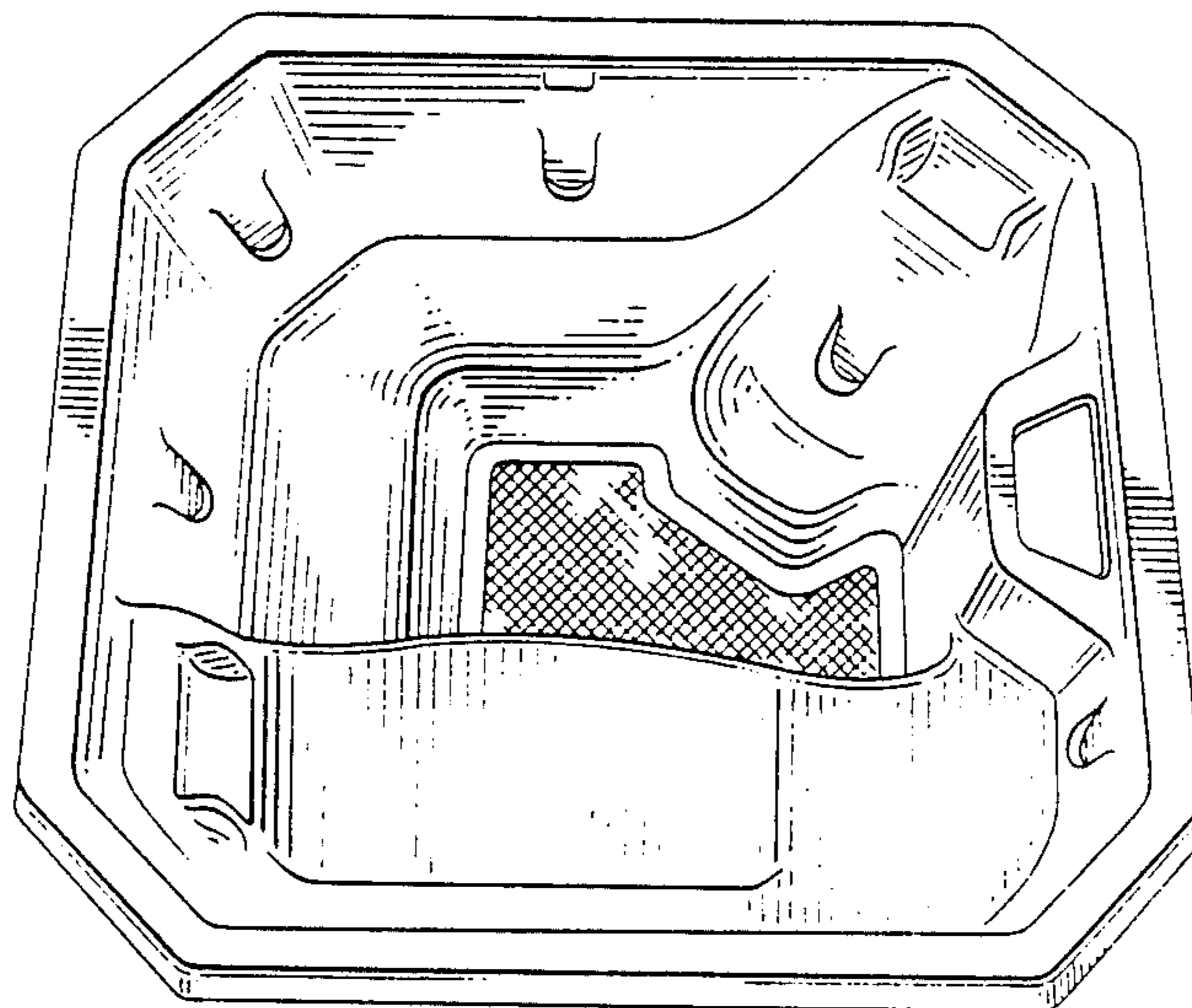

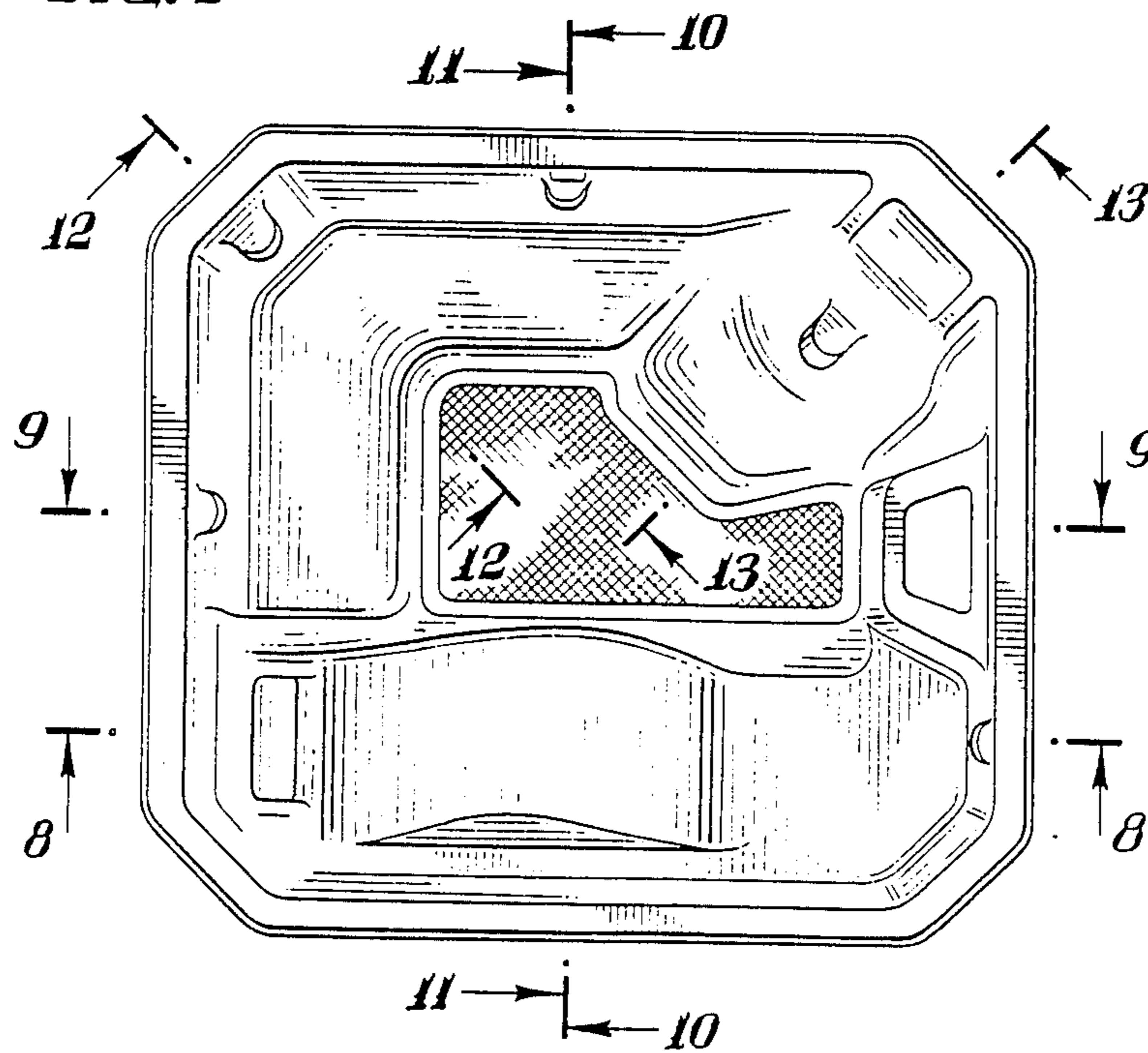

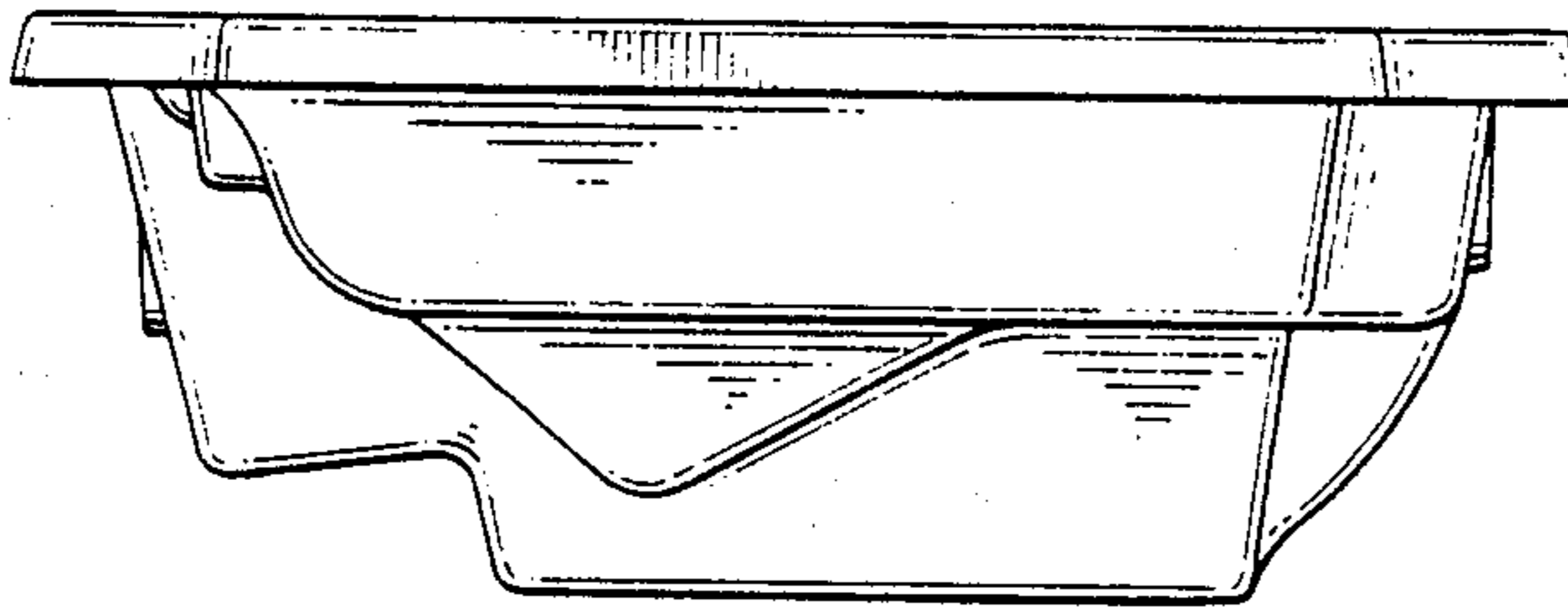

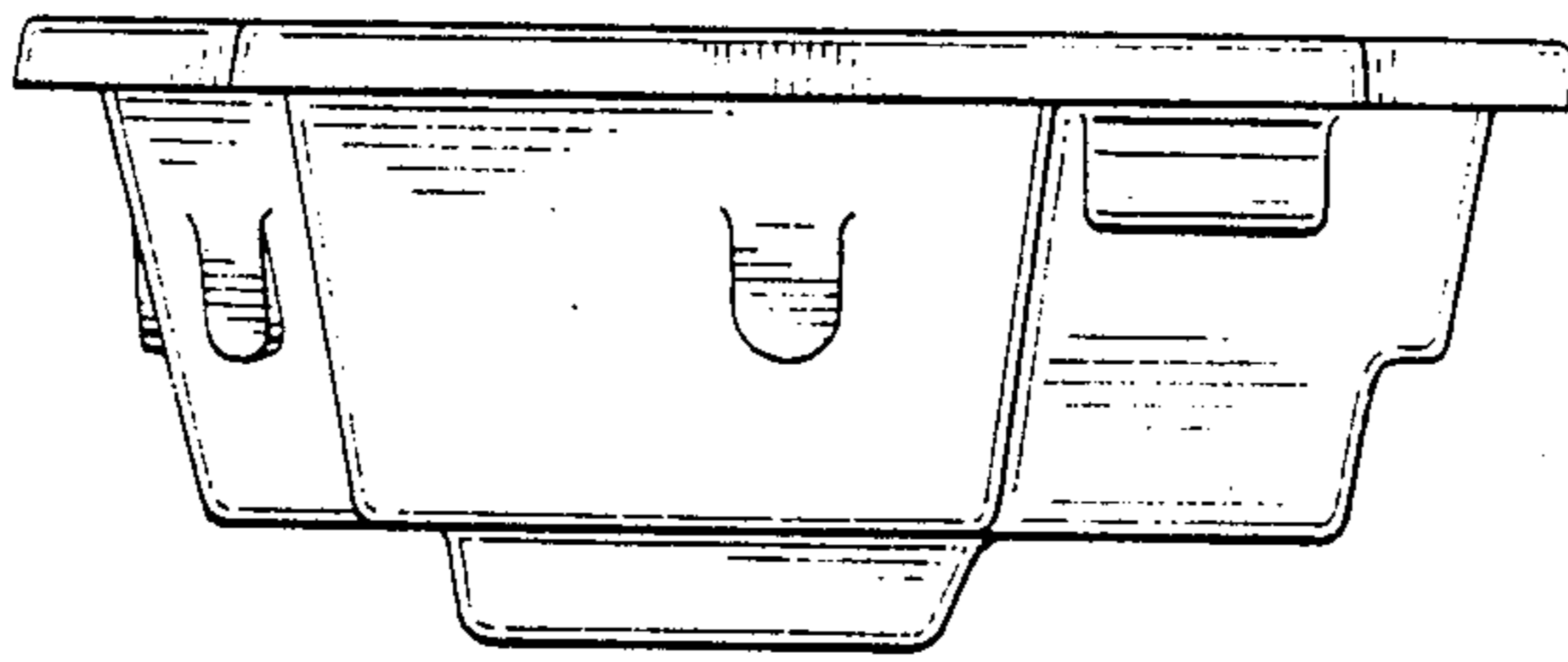

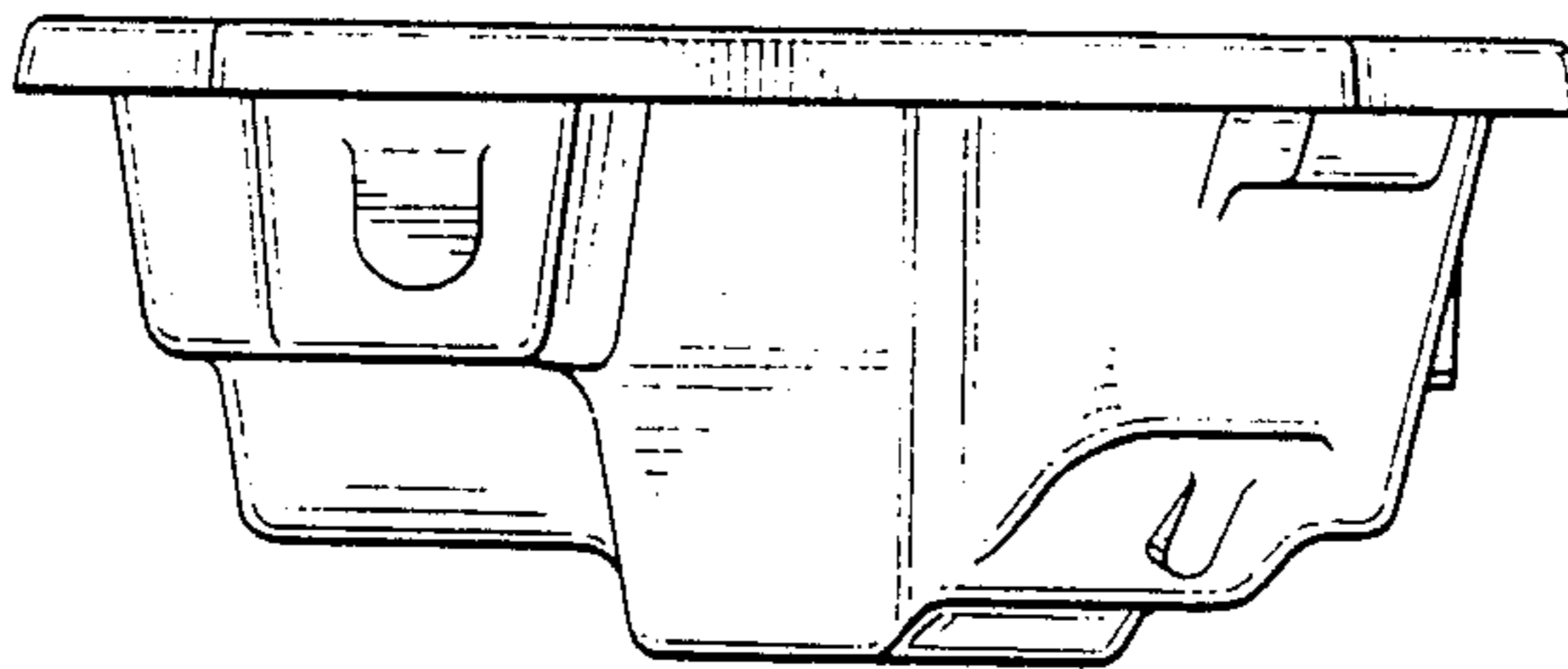

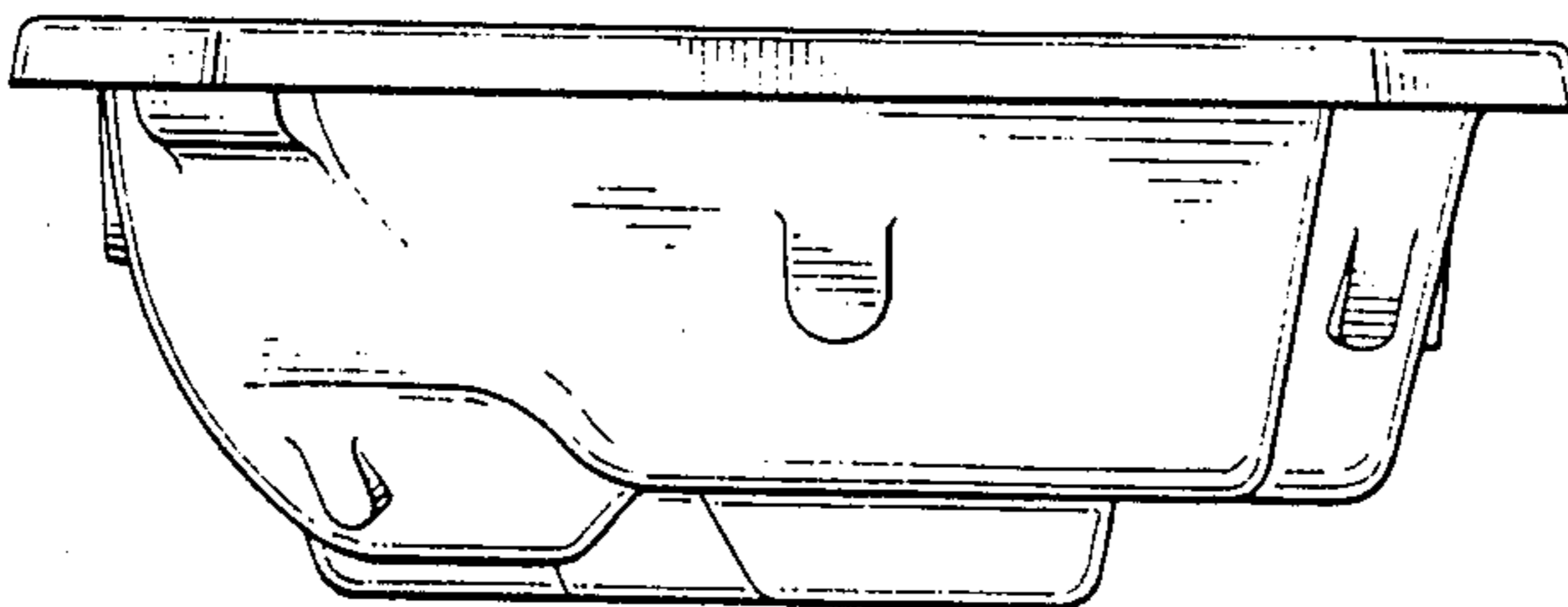

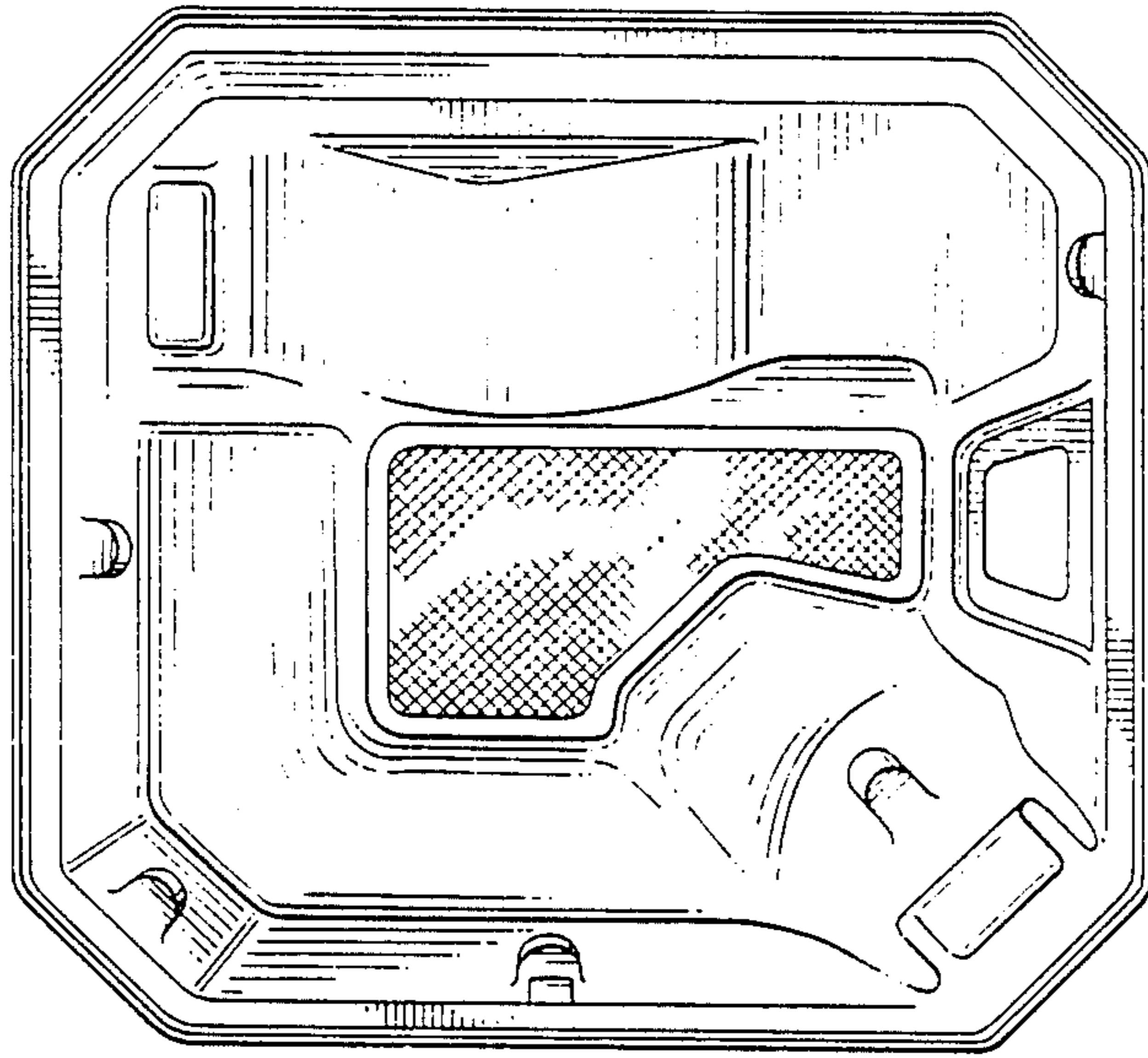

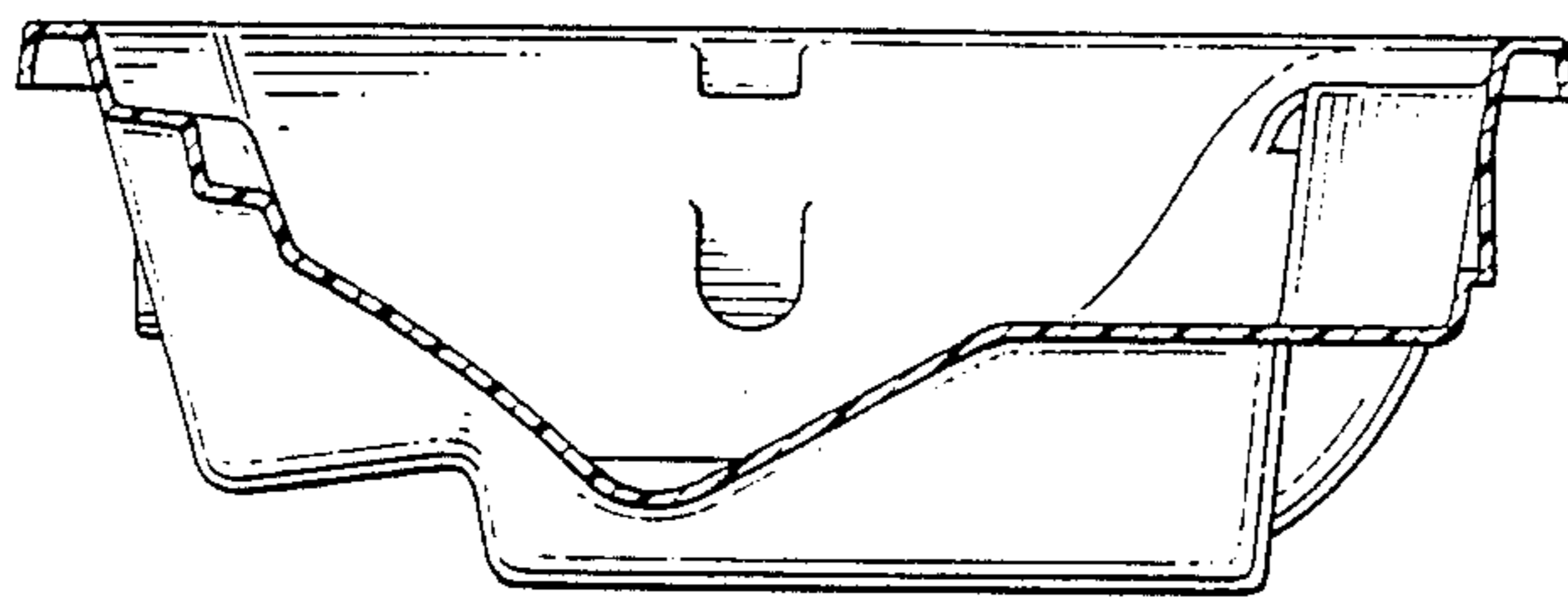

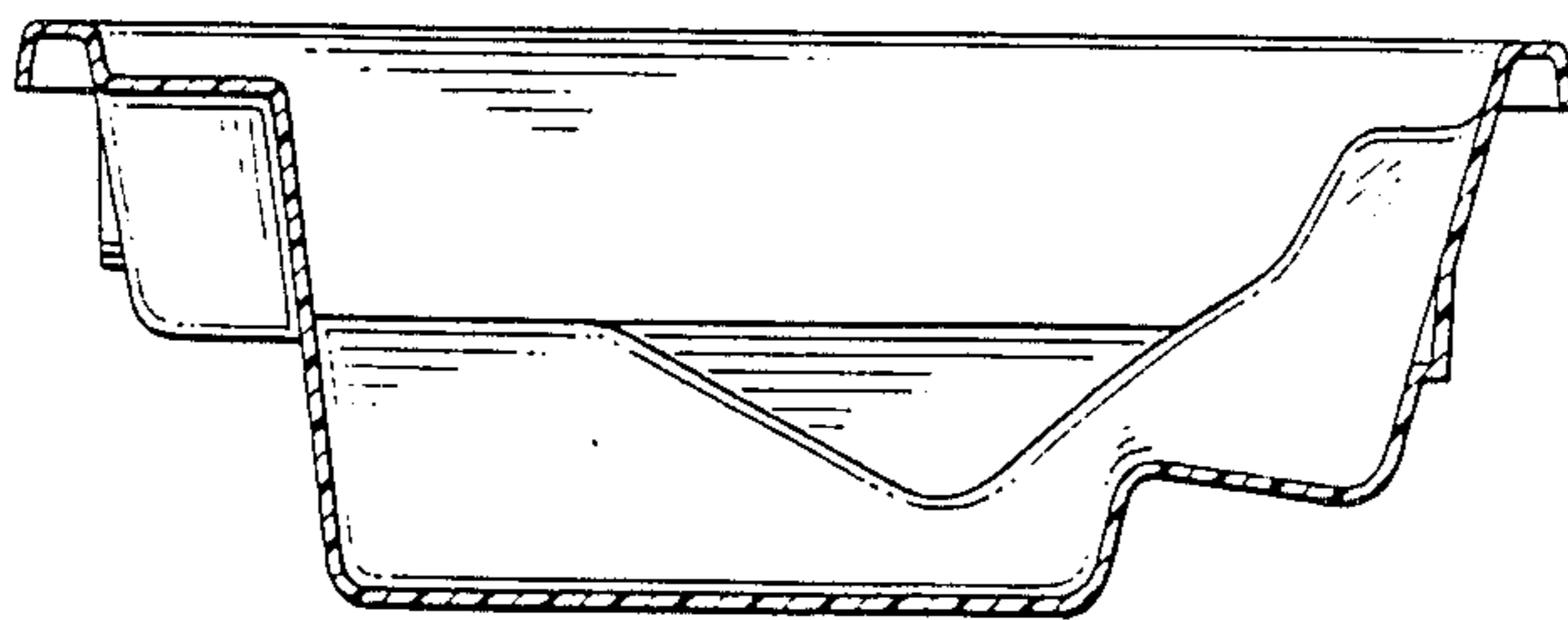

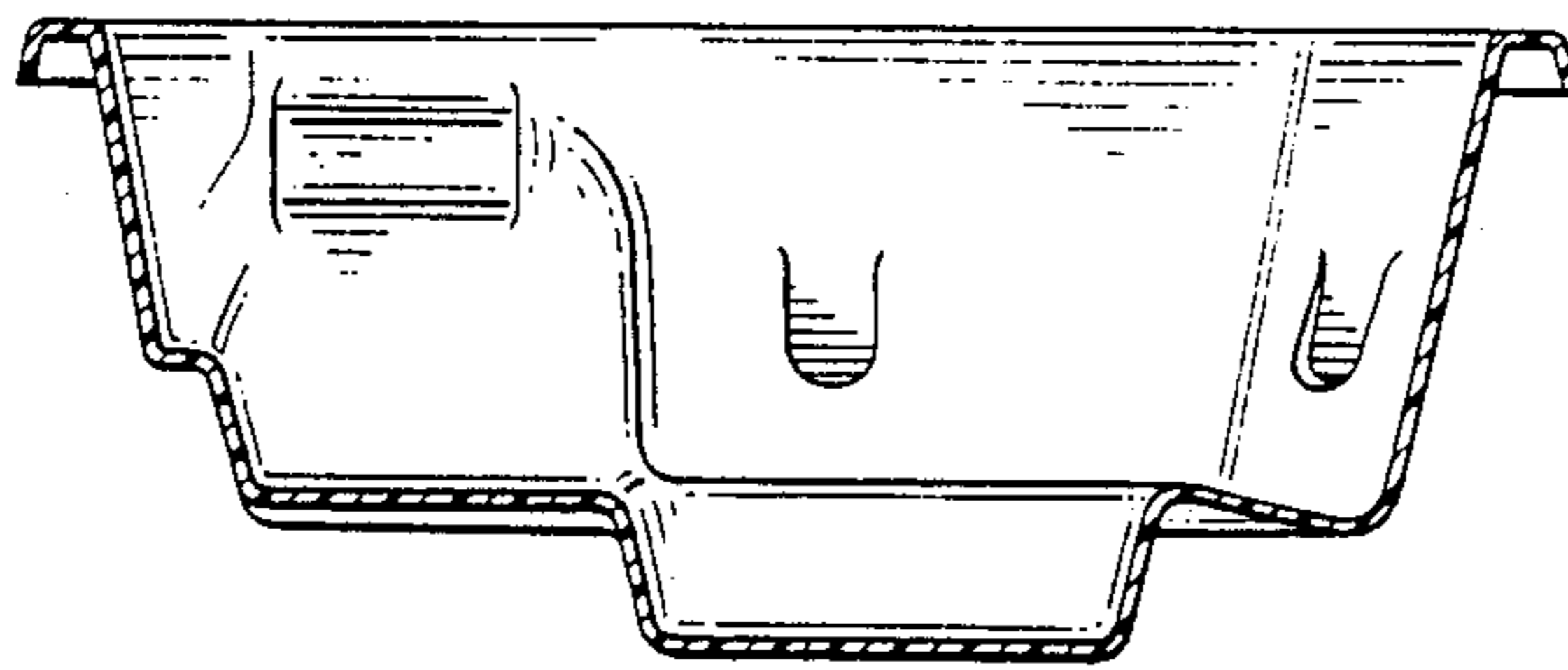

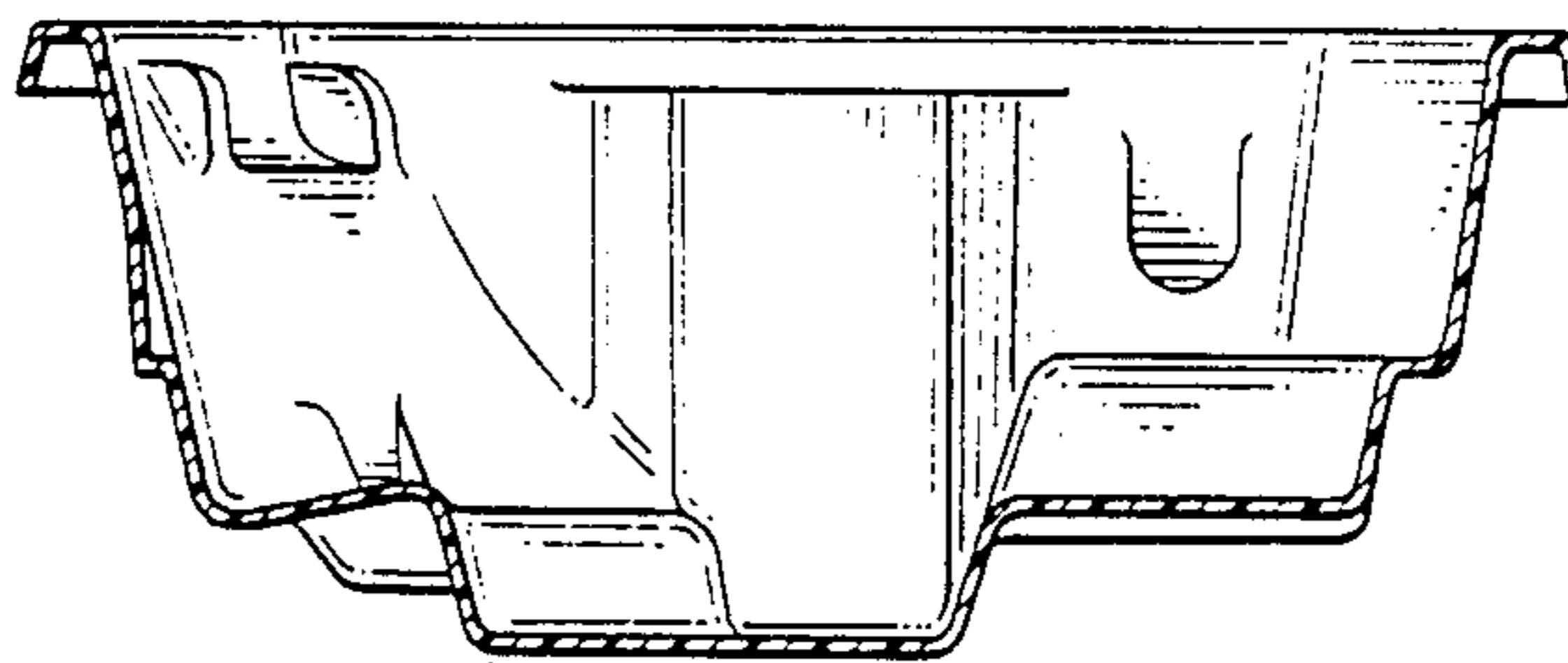

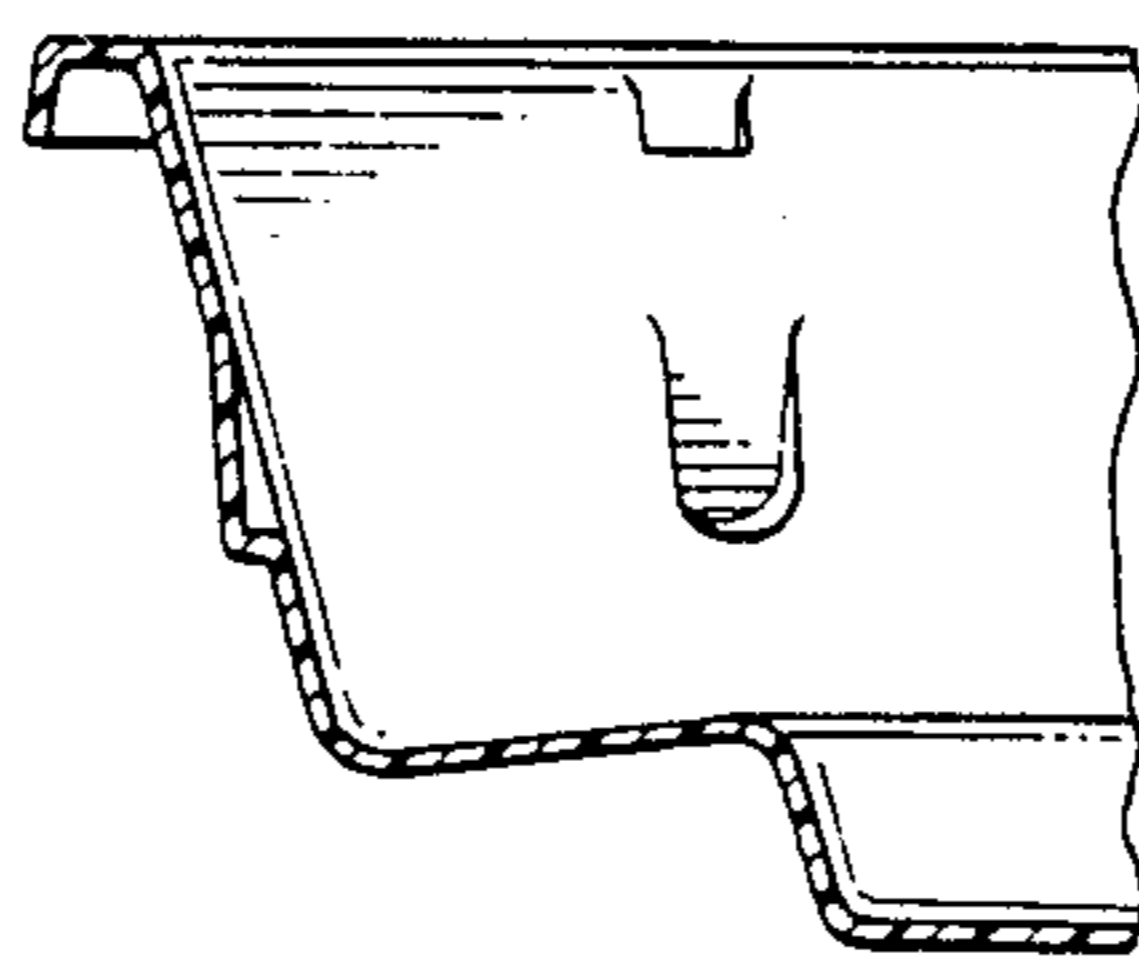
