FIG. 3 is a front elevational view thereof;

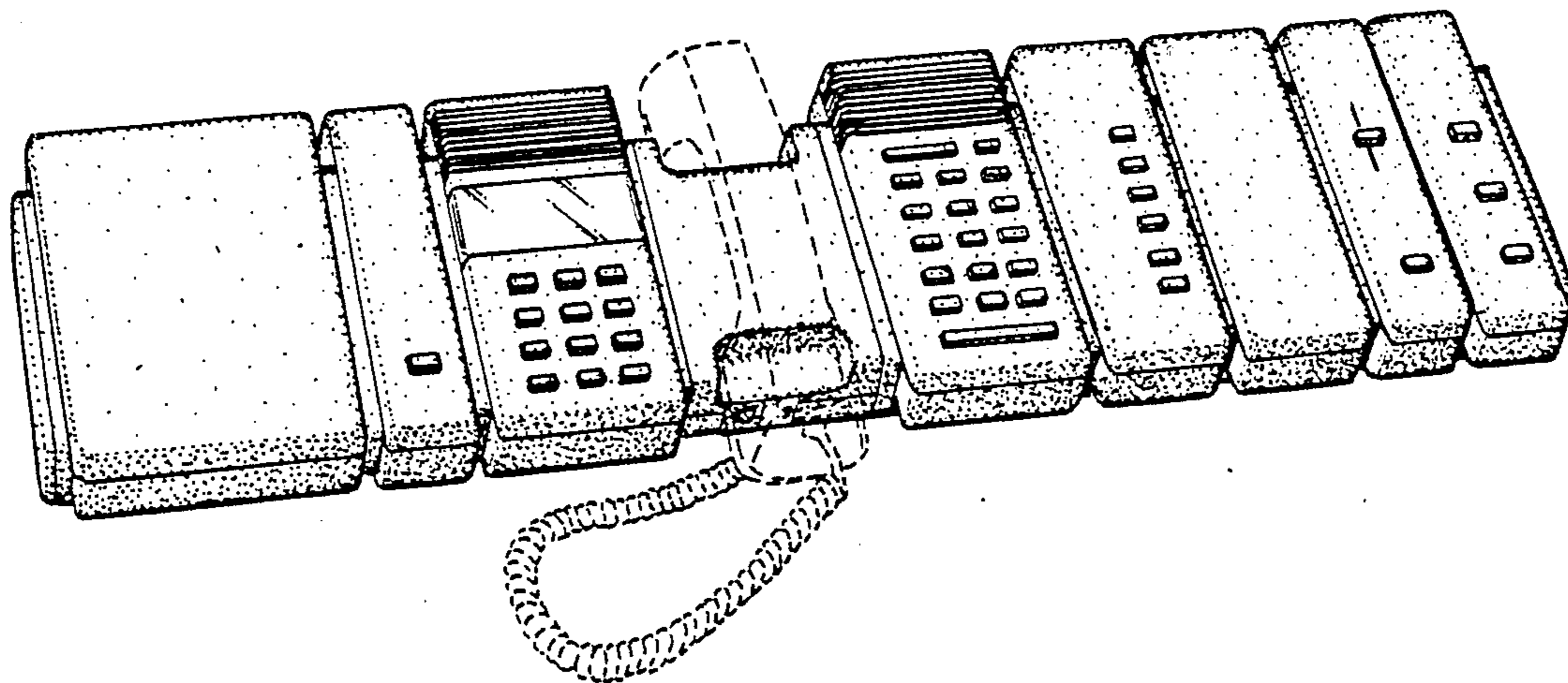
FIG. 4 is a right side elevational view thereof;

The broken line showing of a cord in FIG. 1 and a handset in FIGS. 1-7 is for illustrative purposes only and forms no part of the claimed design.



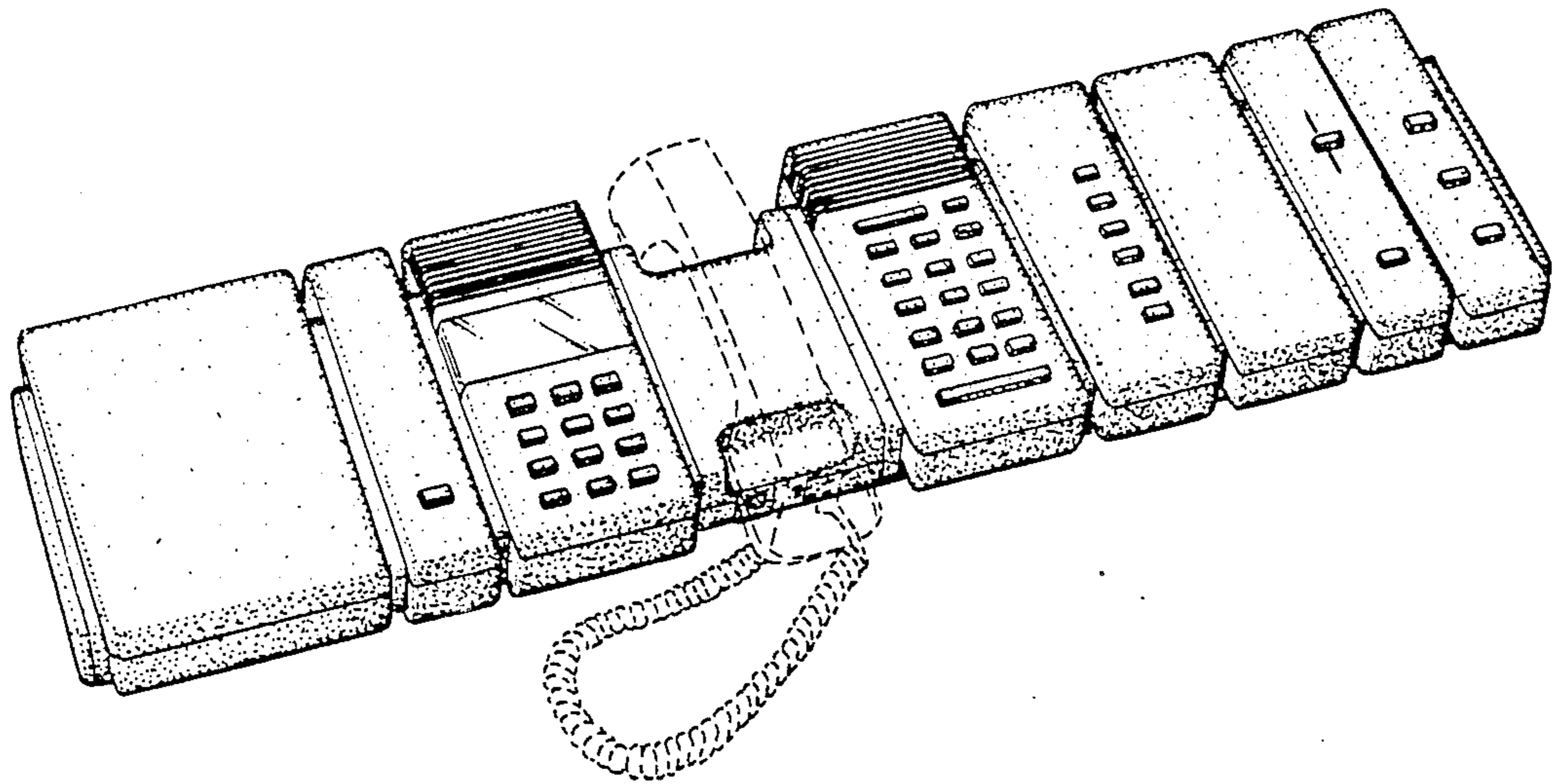

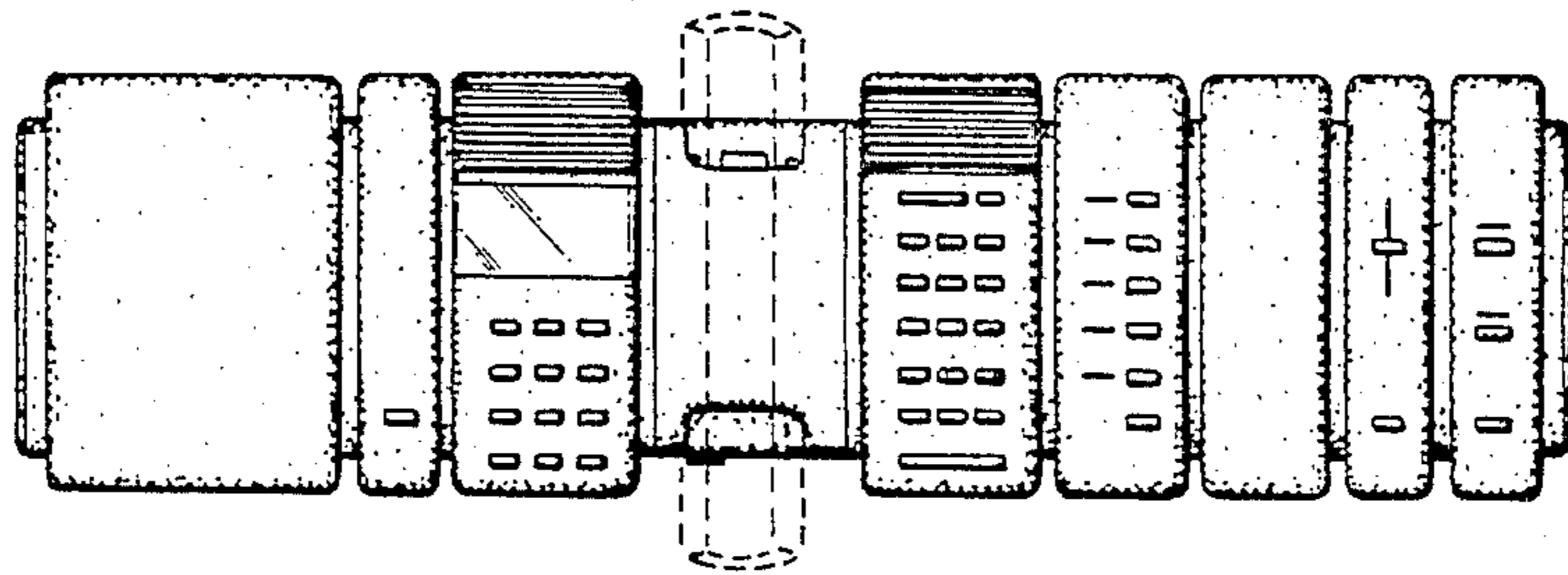

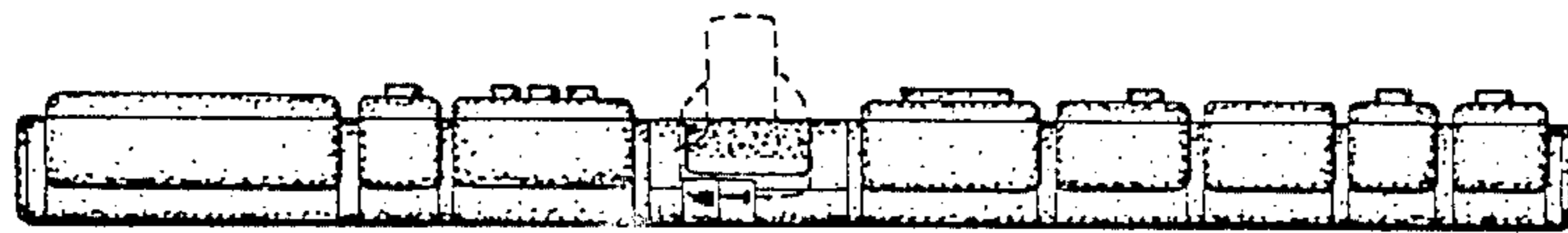

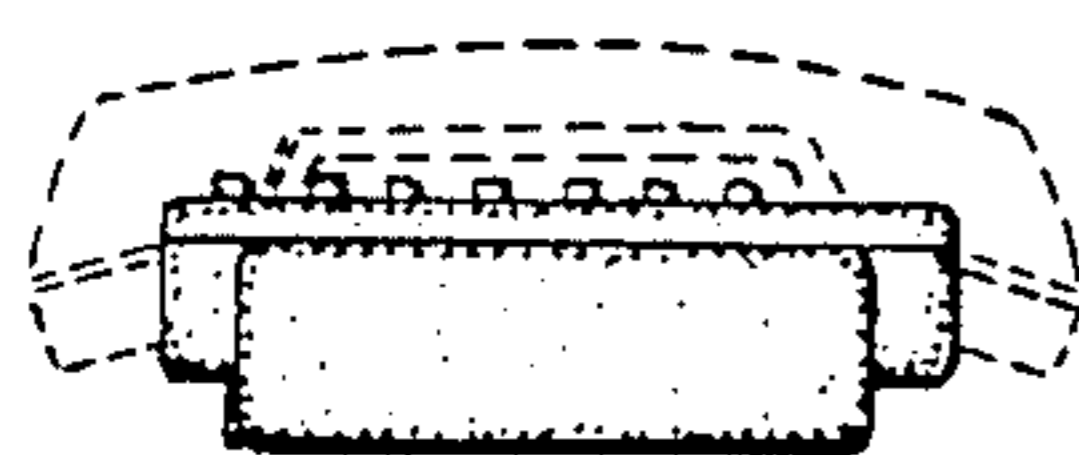

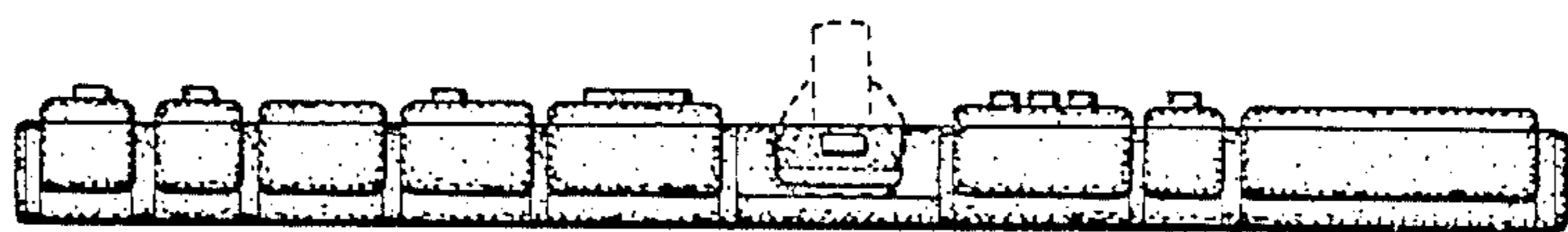

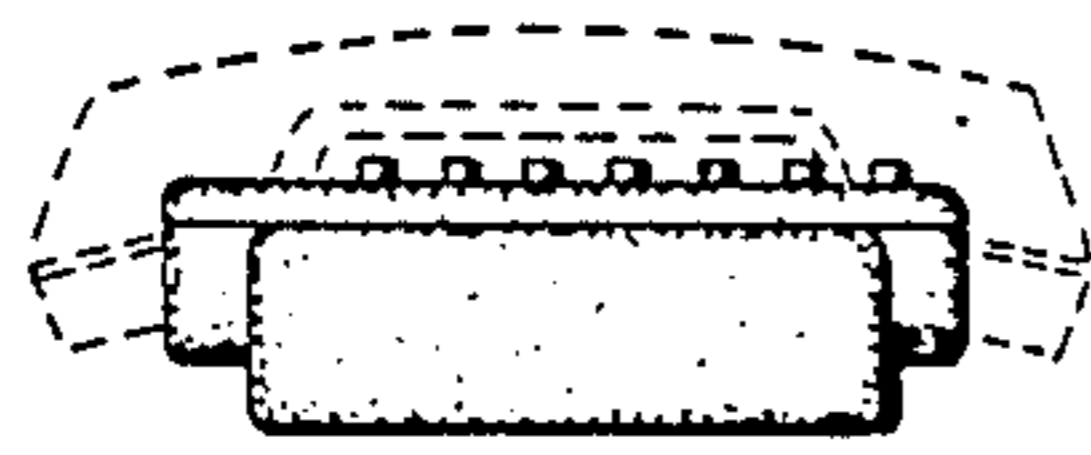

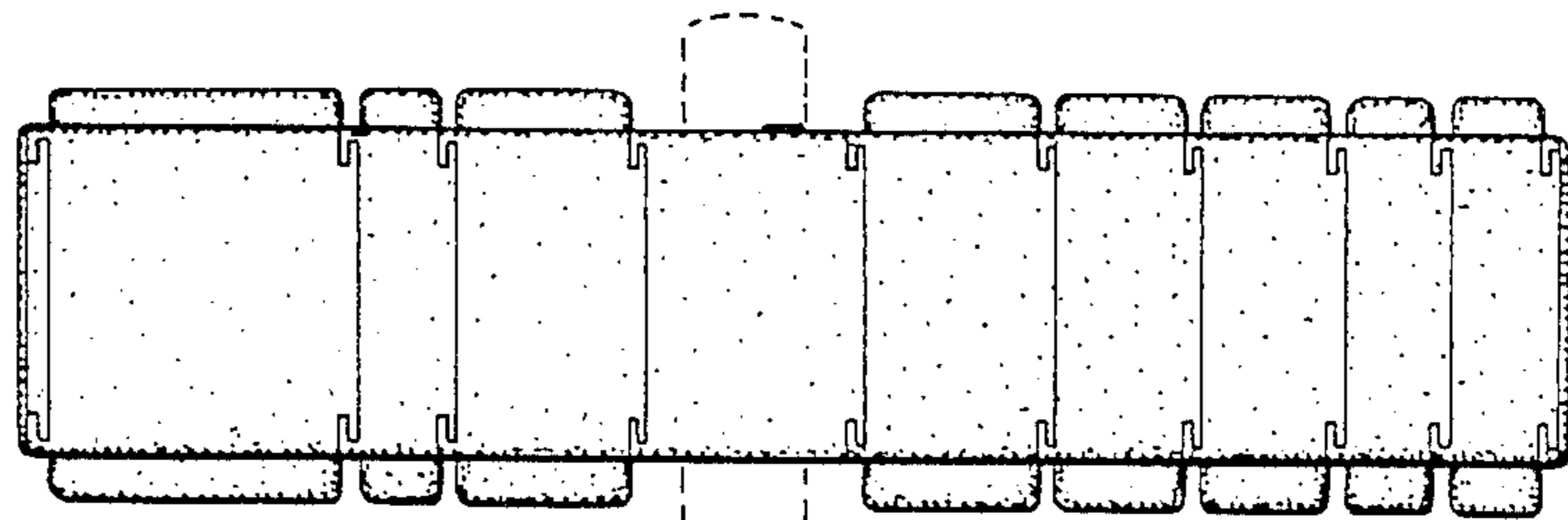
