The ornamental design for a reconfigurable toy vehicle, substantially as shown and described.

DESCRIPTION

FIG. 1 is a front side perspective view of a reconfigurable toy vehicle showing my new design;

 FIG. 21 is a bottom plan view thereof;

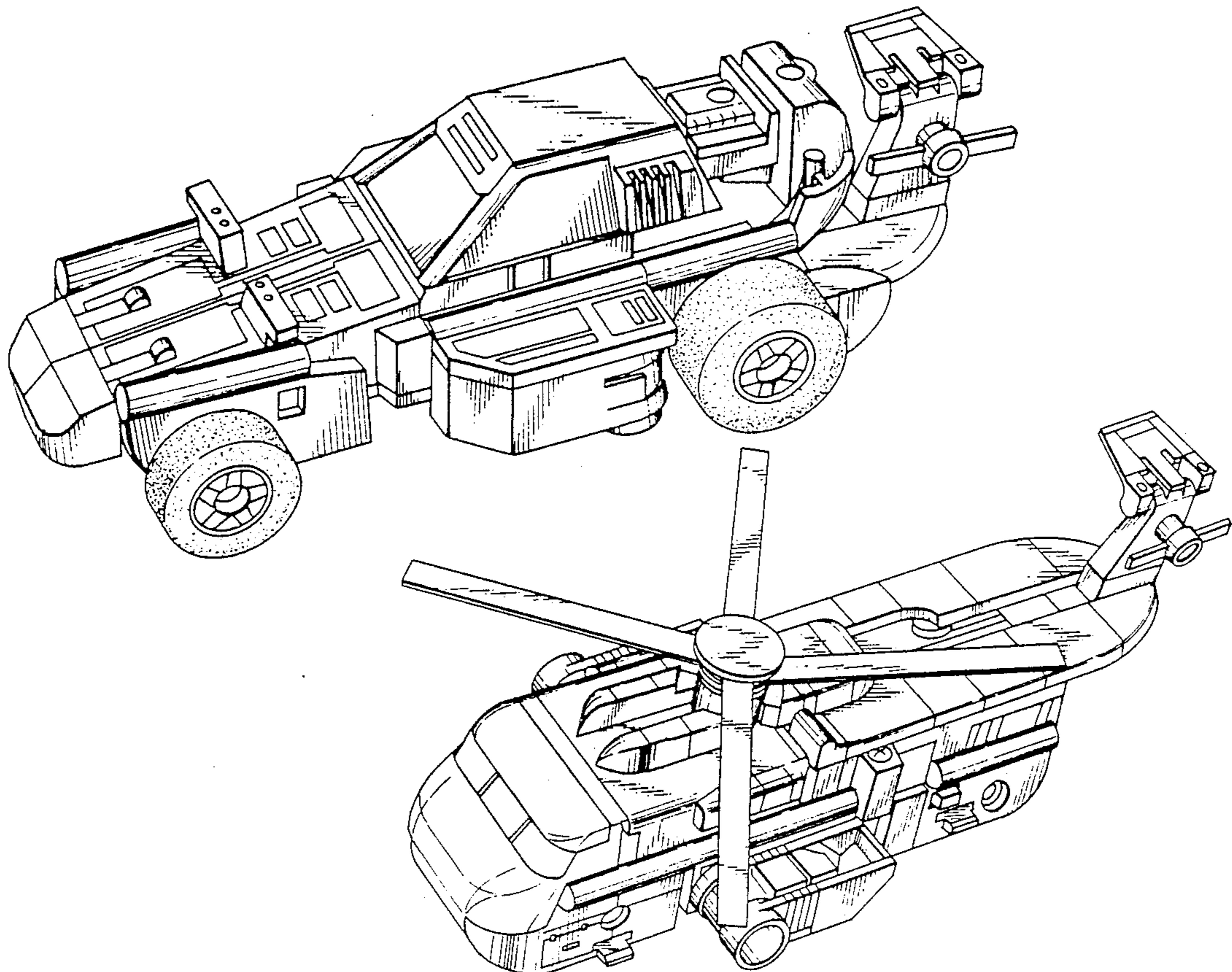

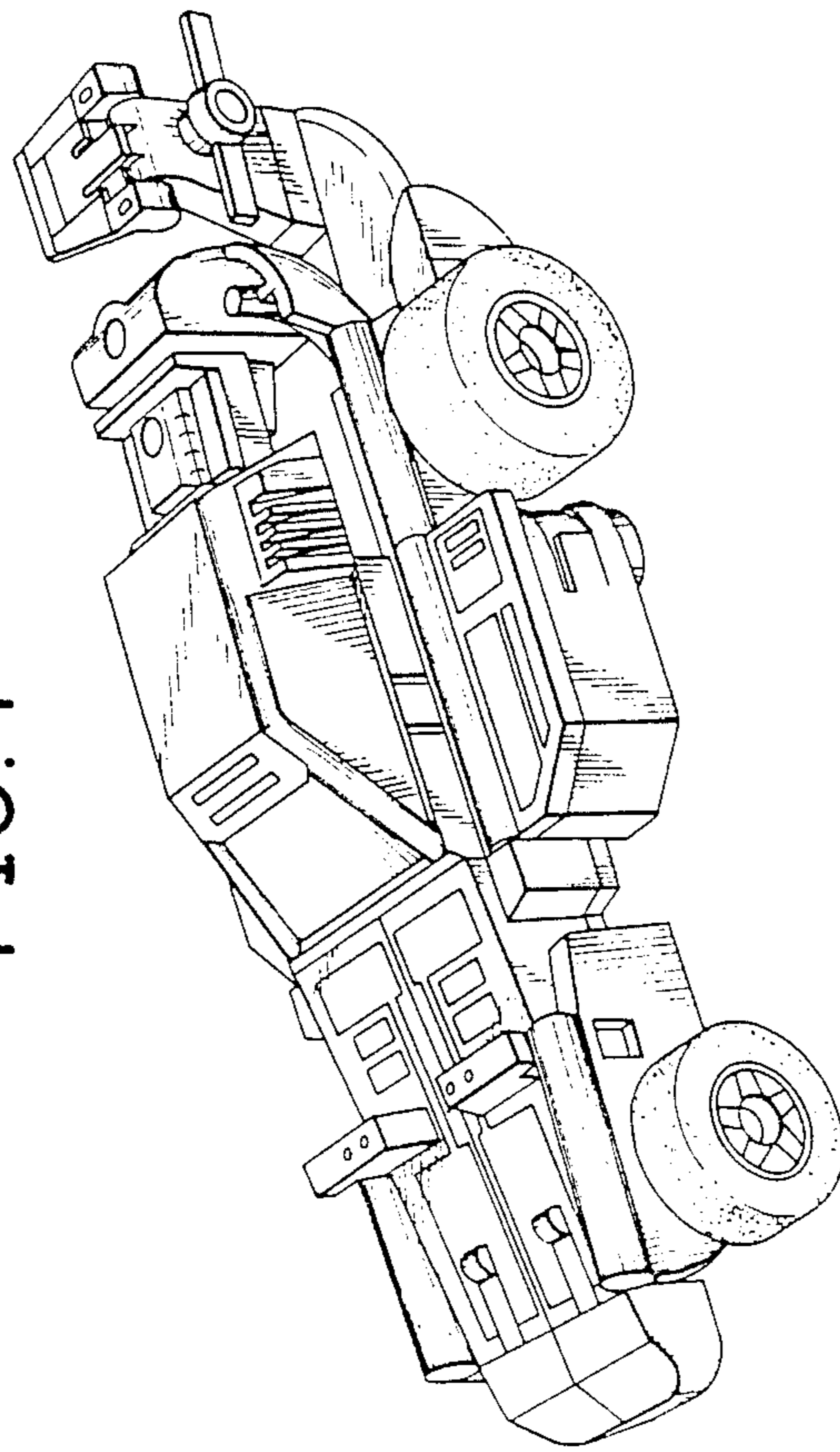

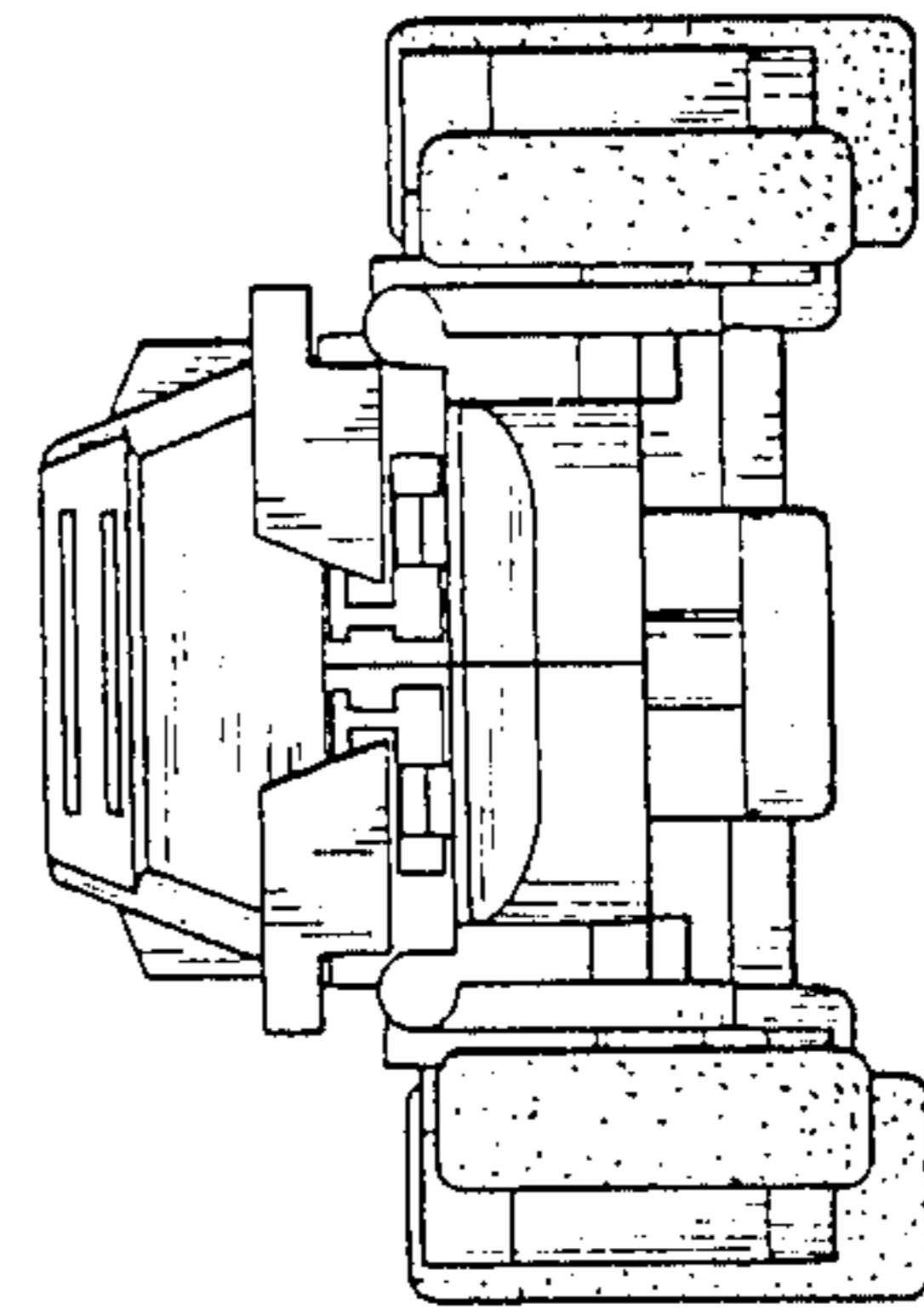

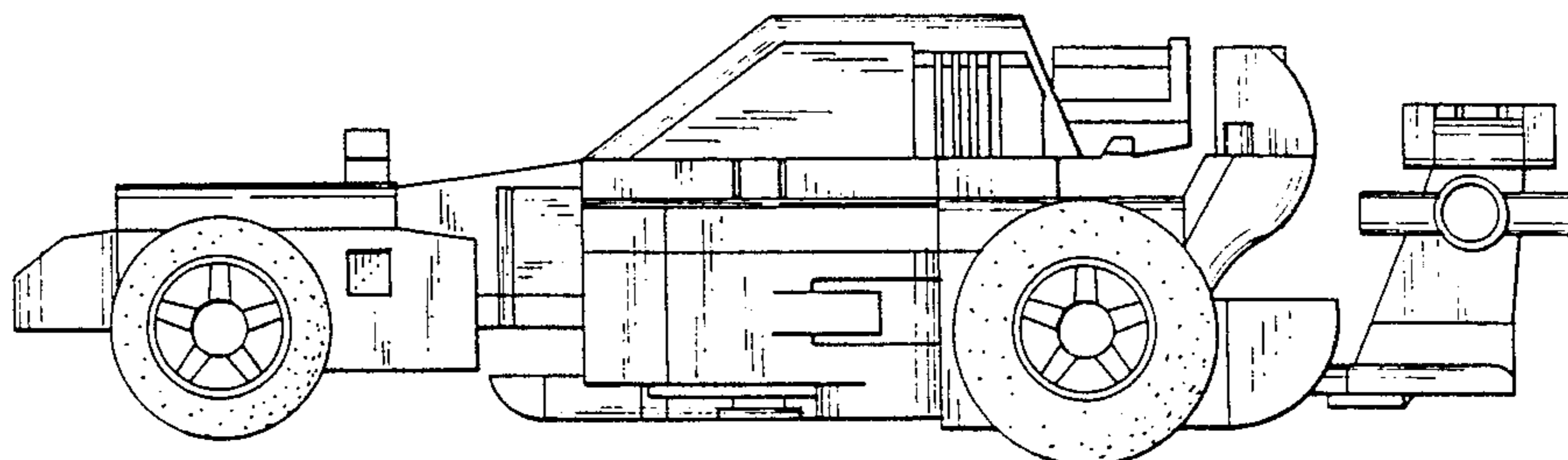

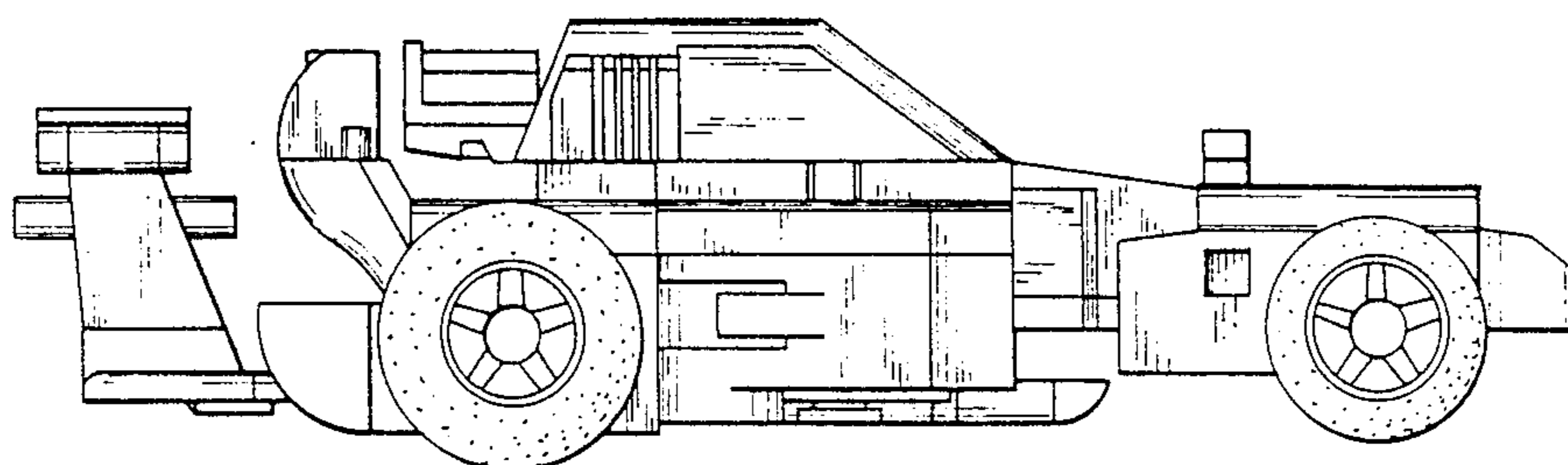
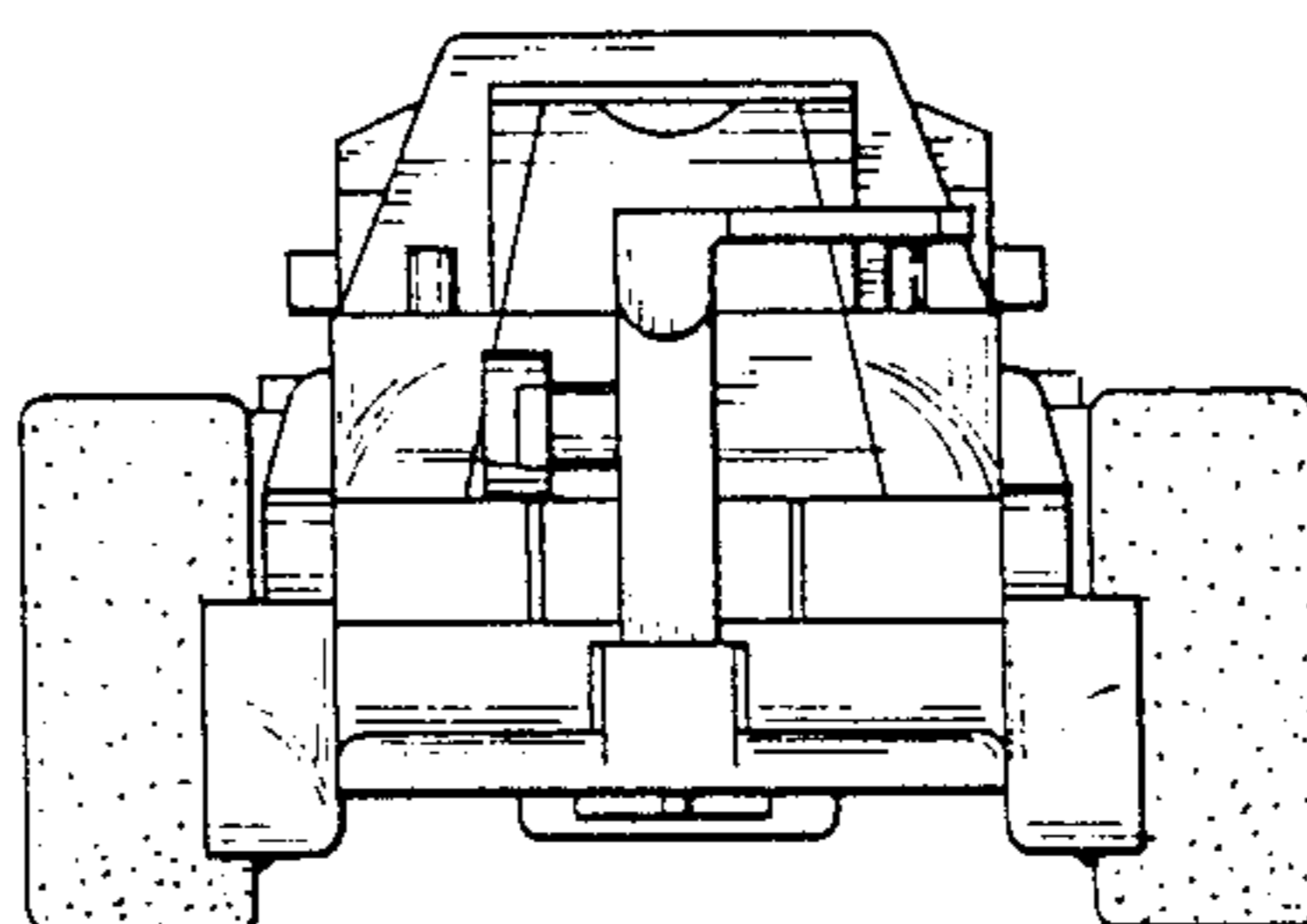

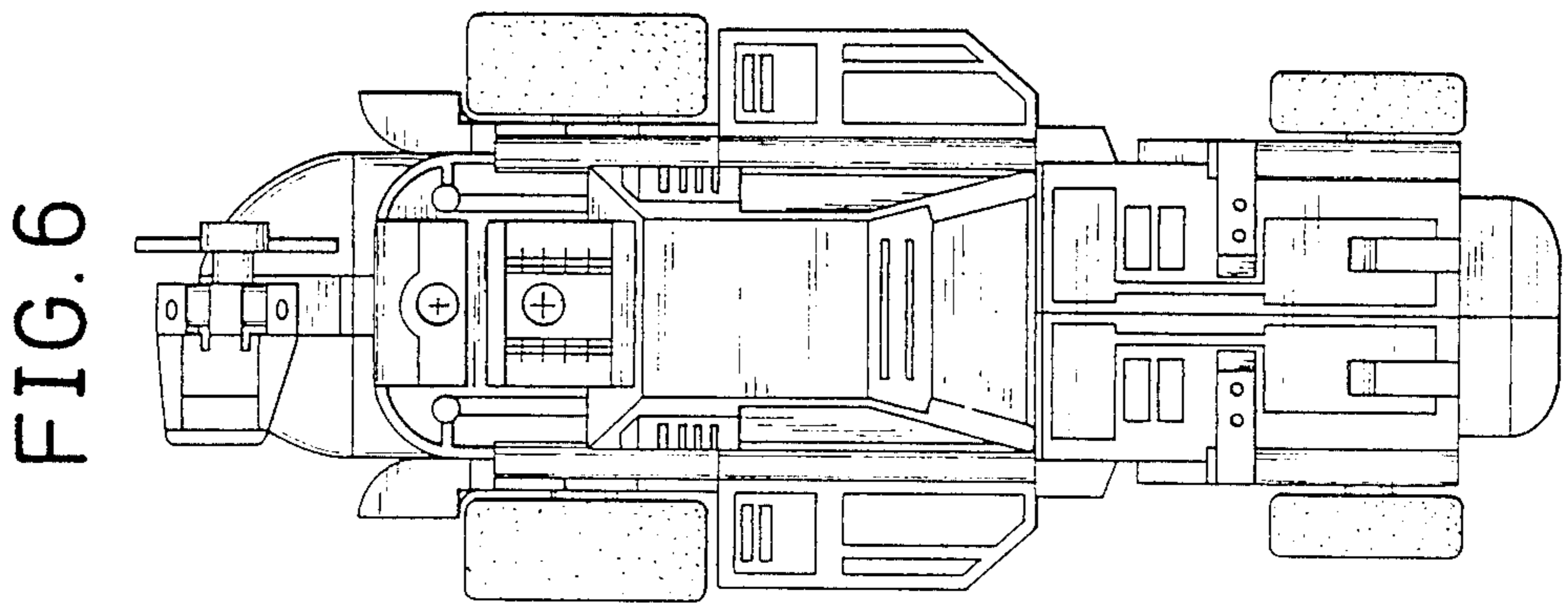
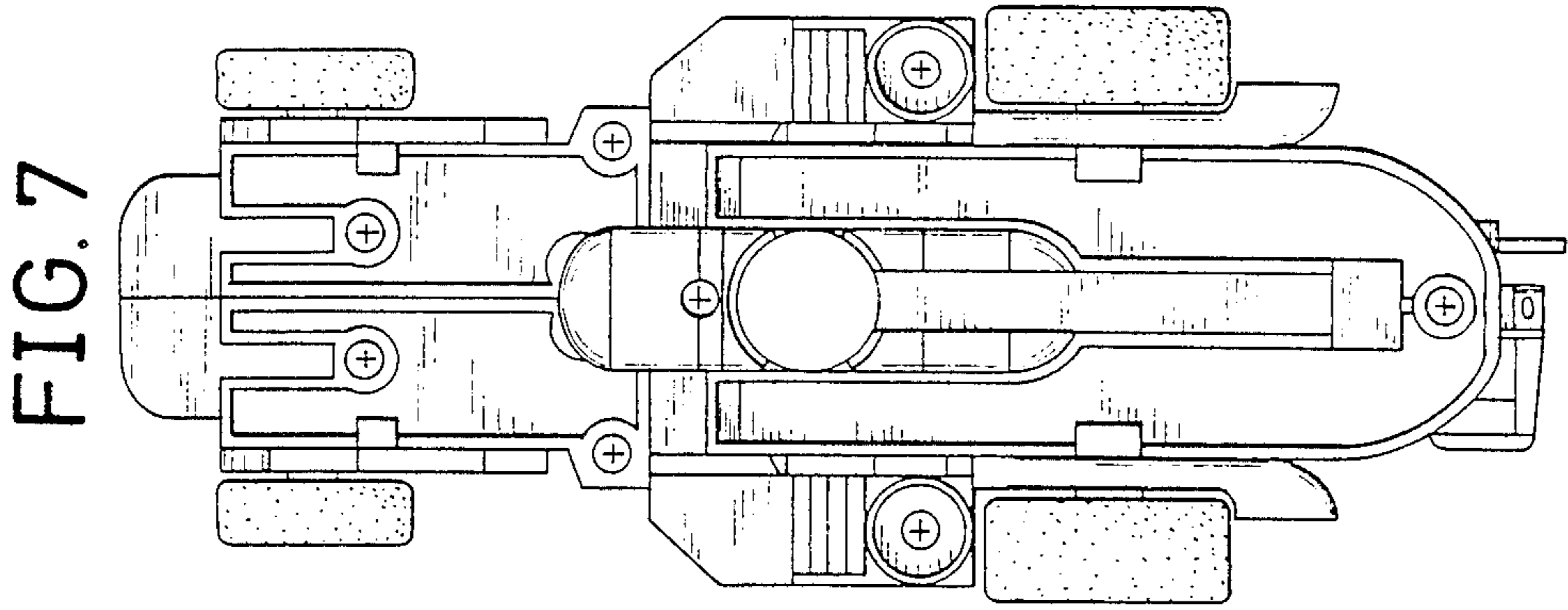

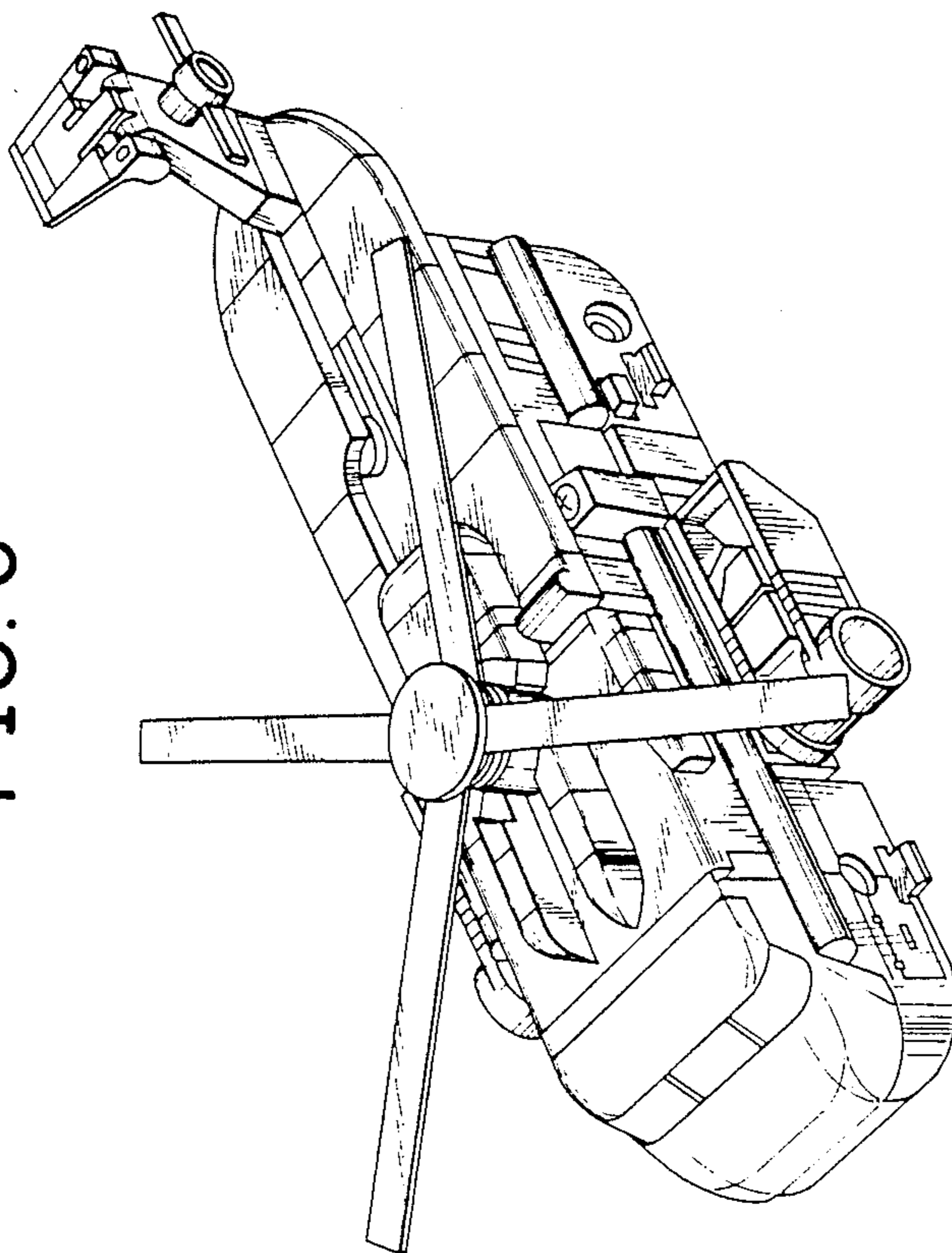

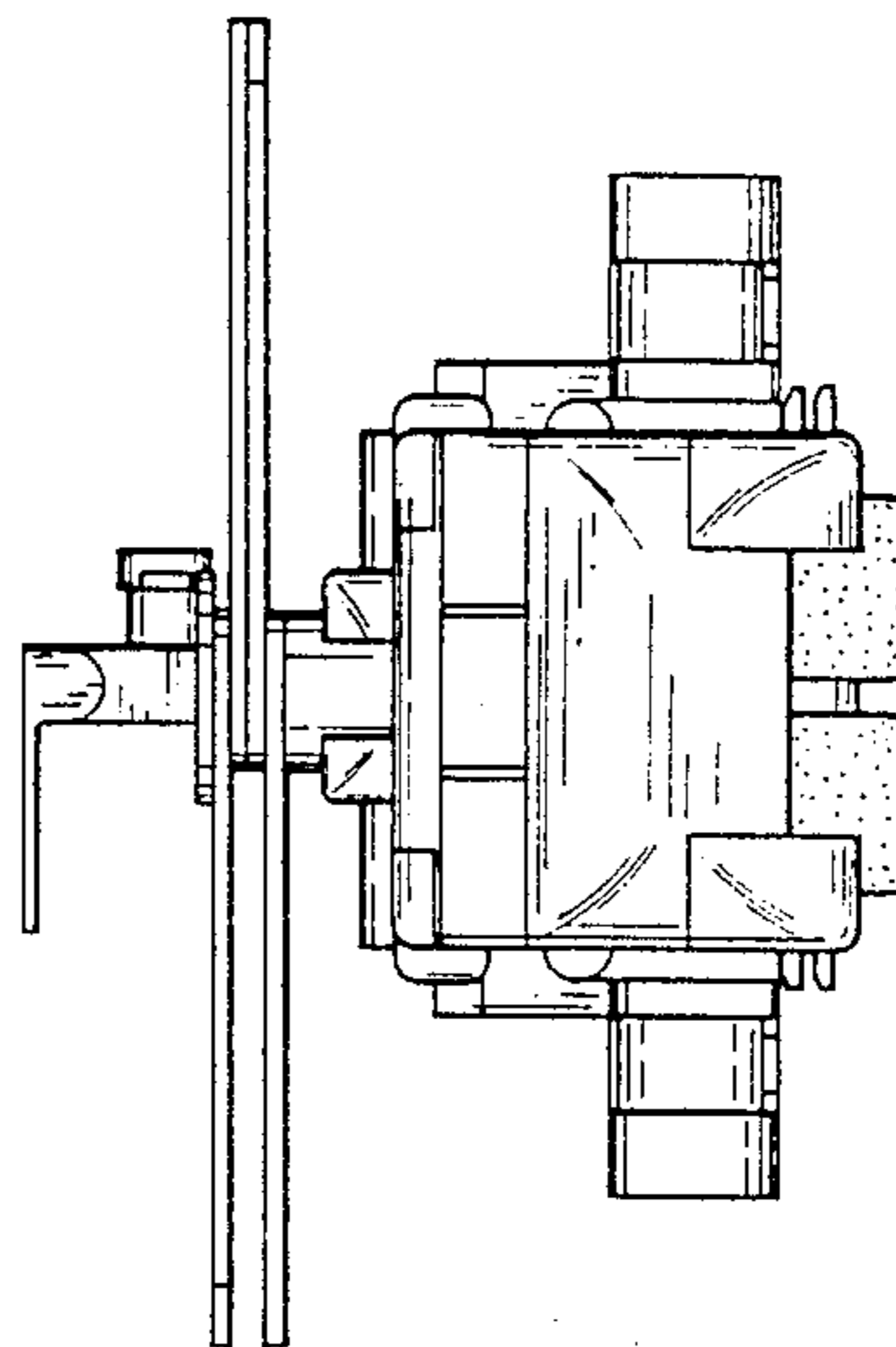

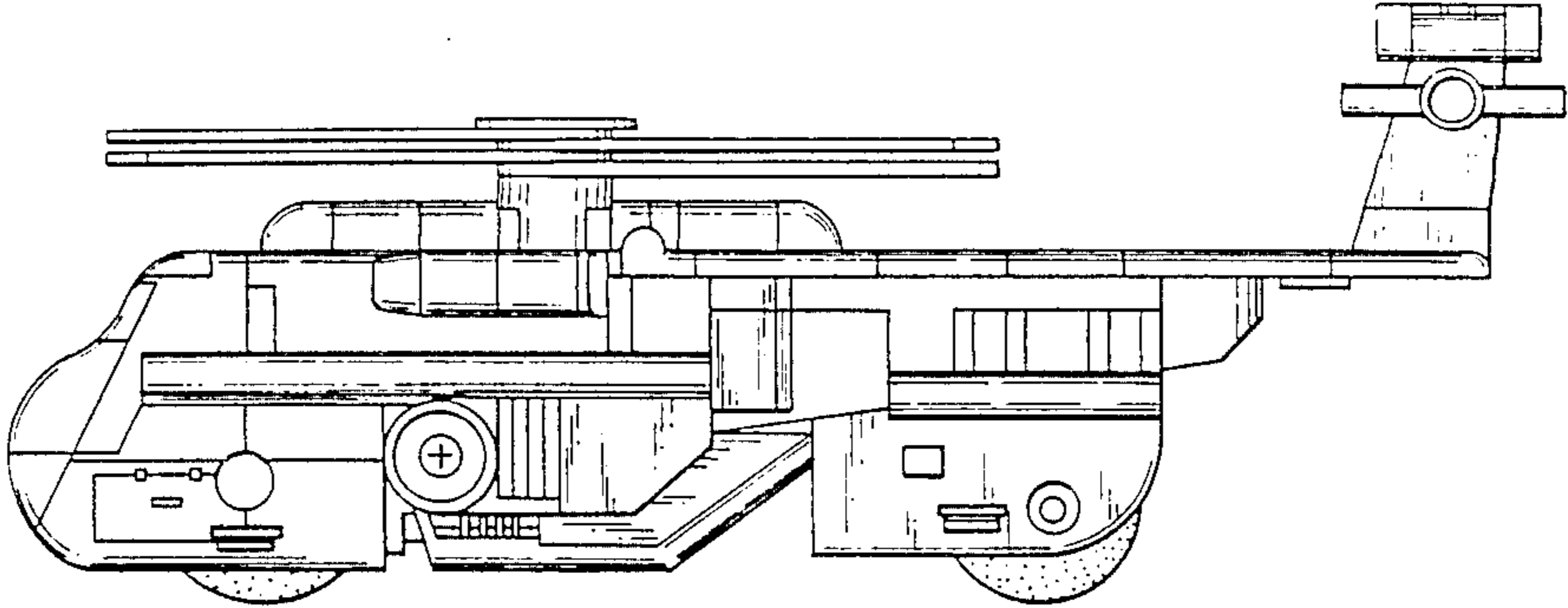

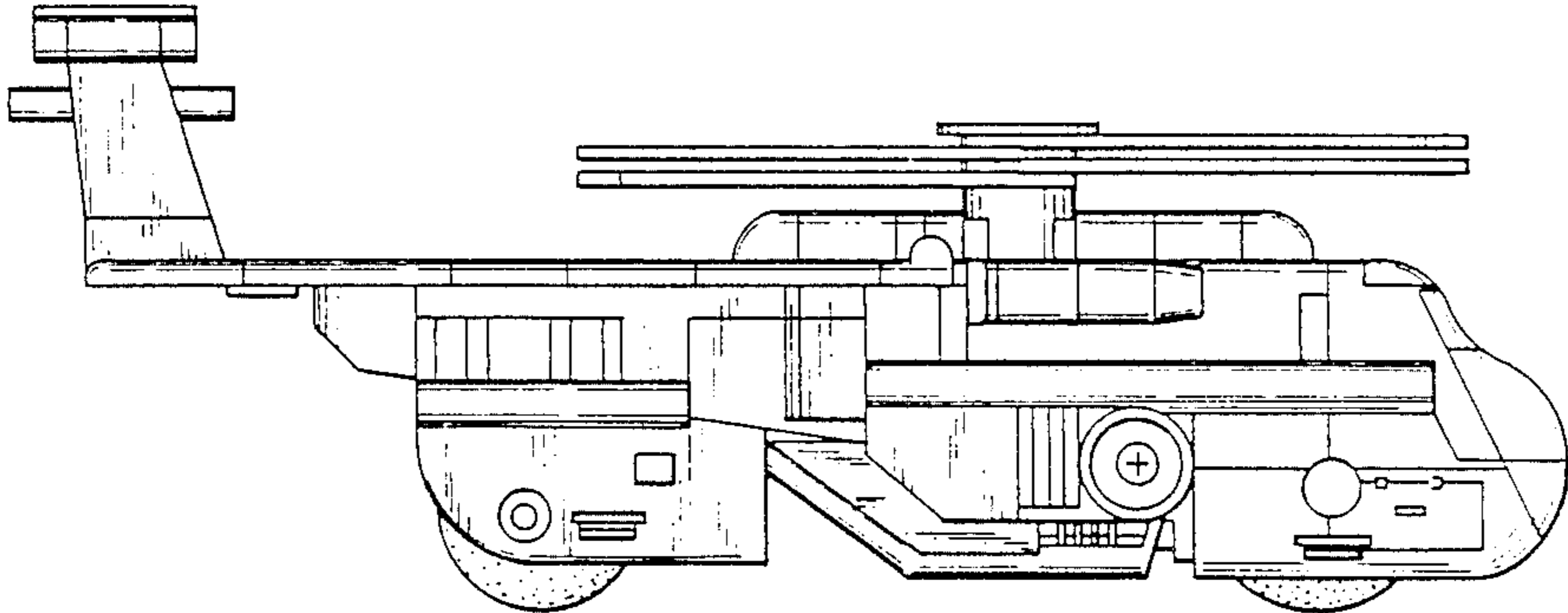

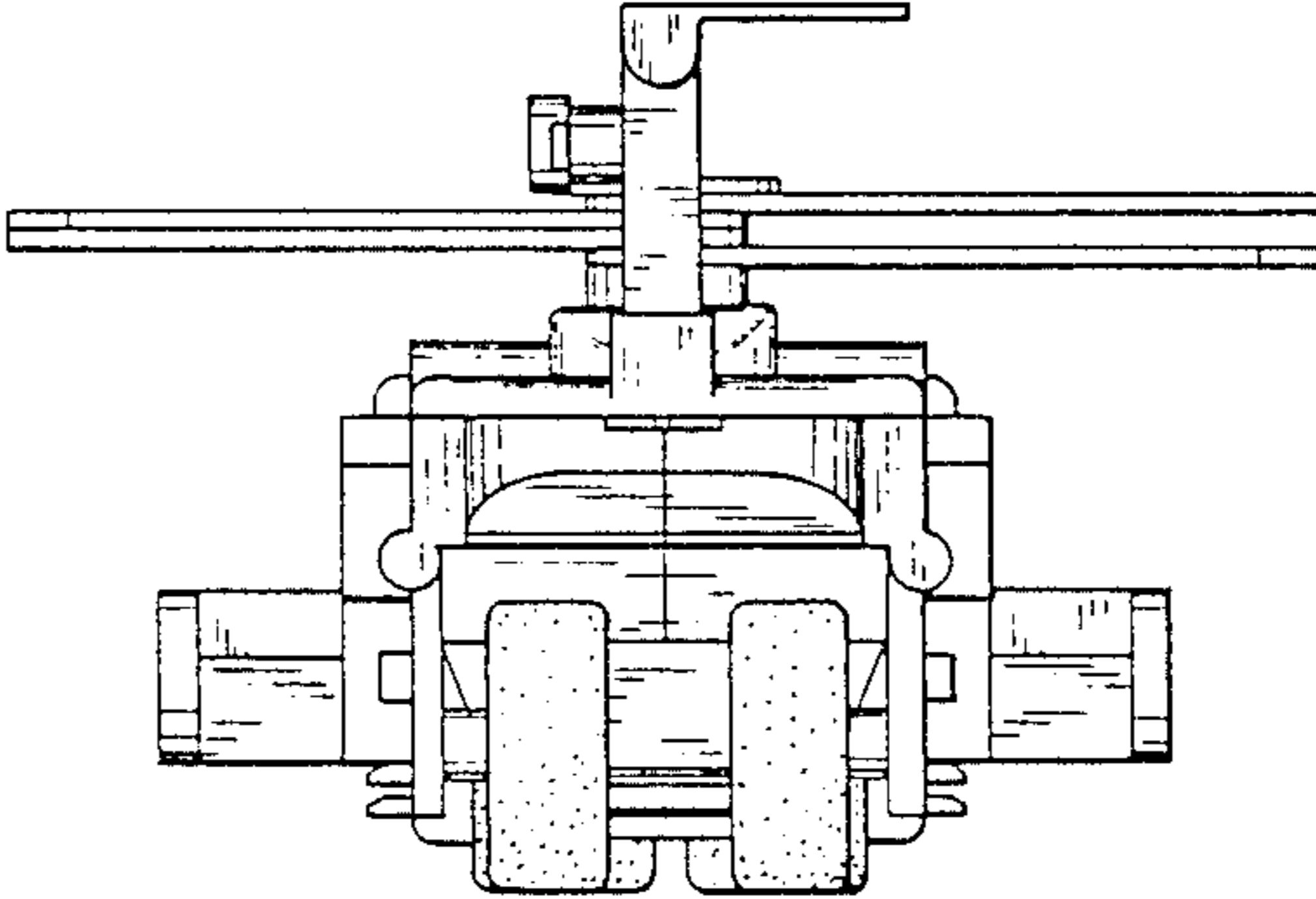

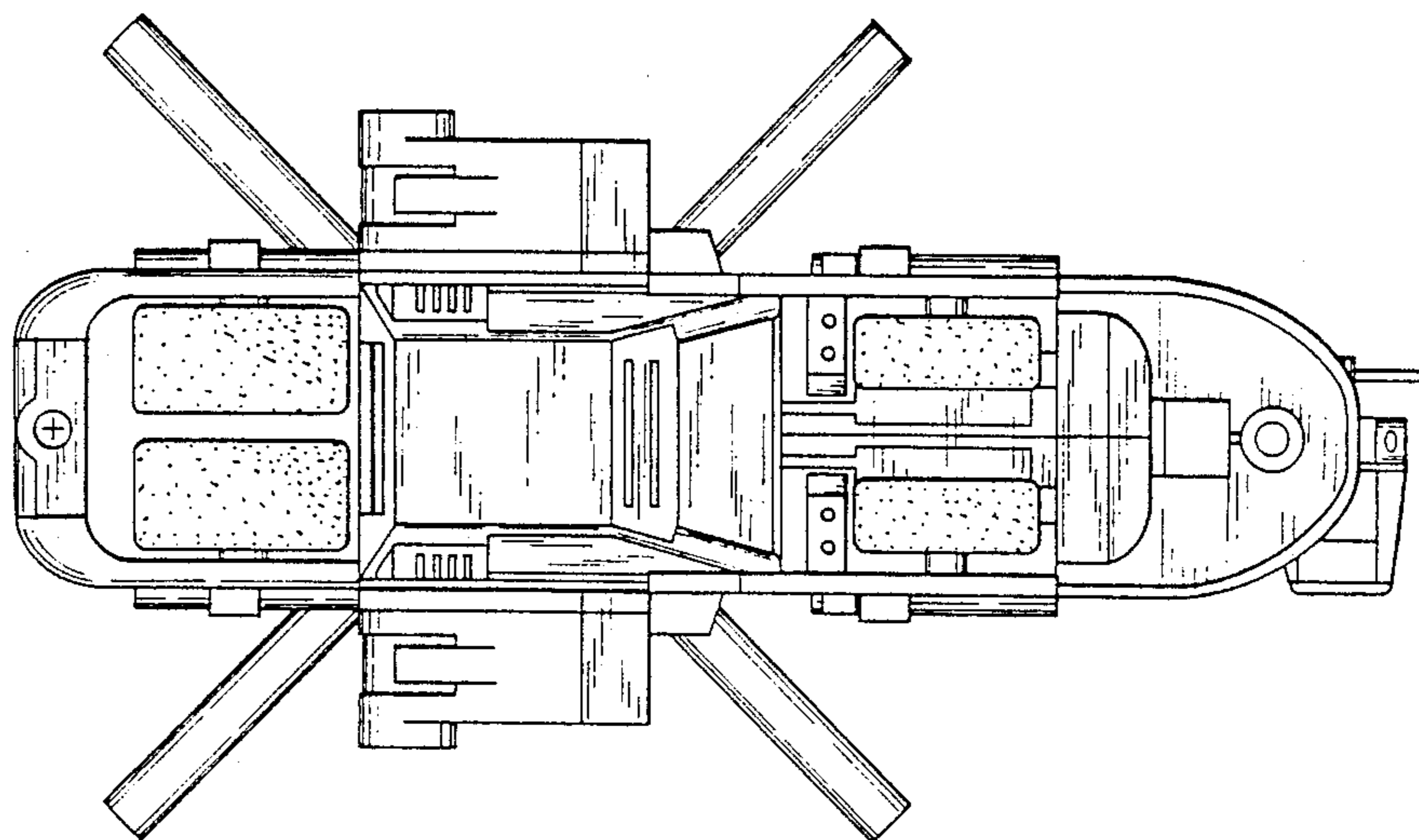

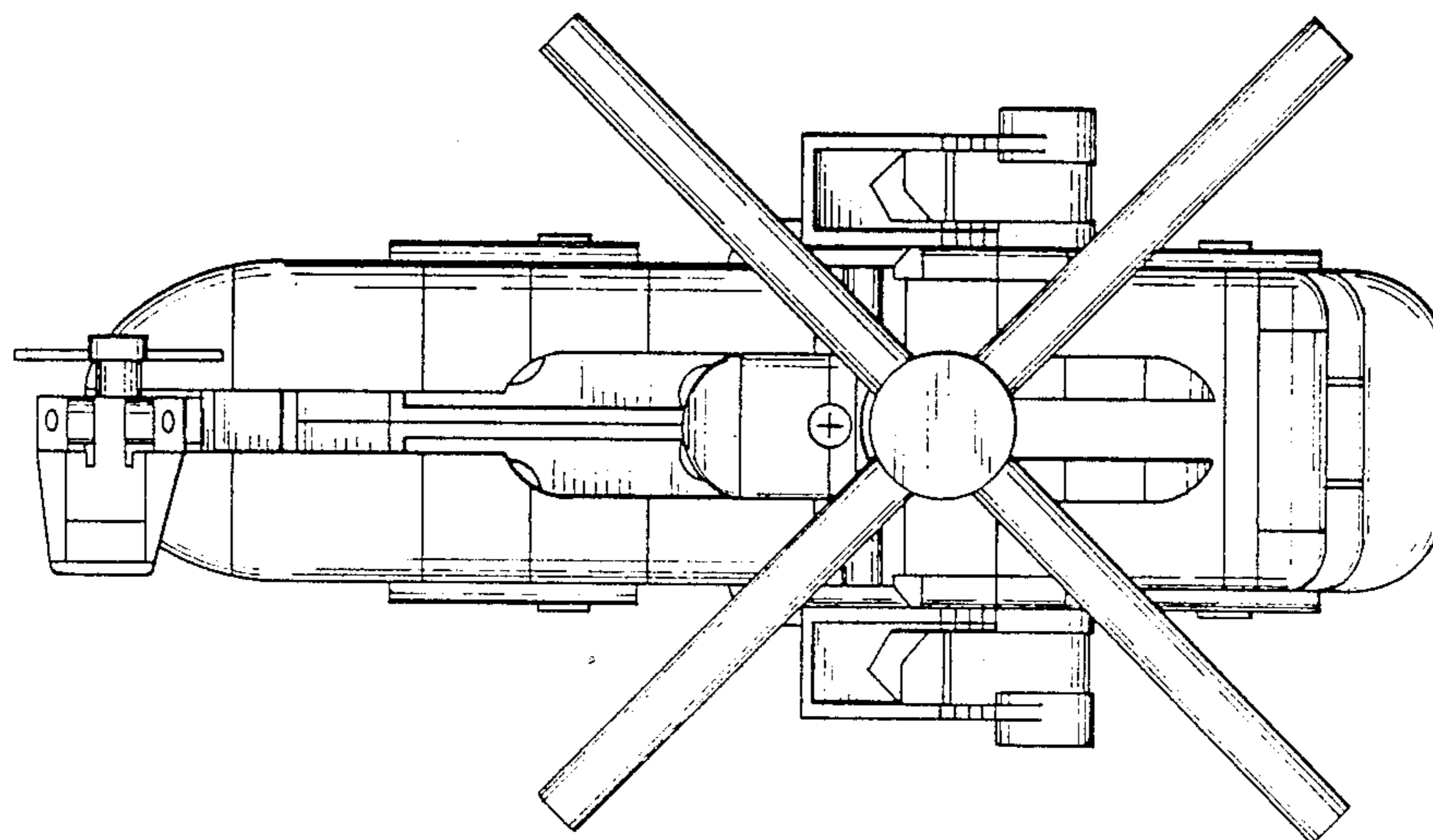

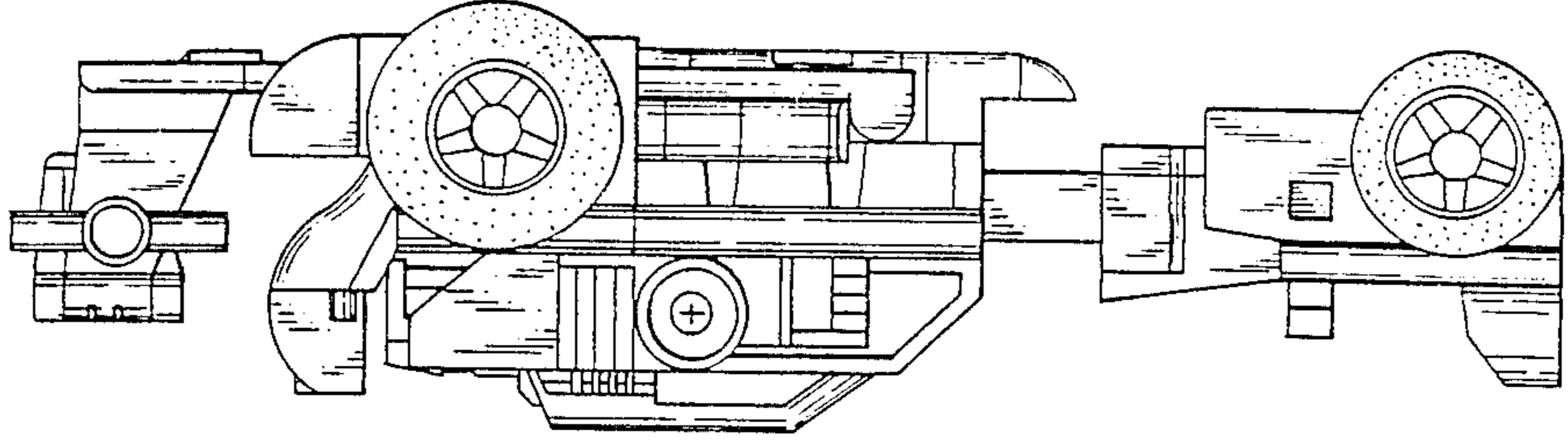

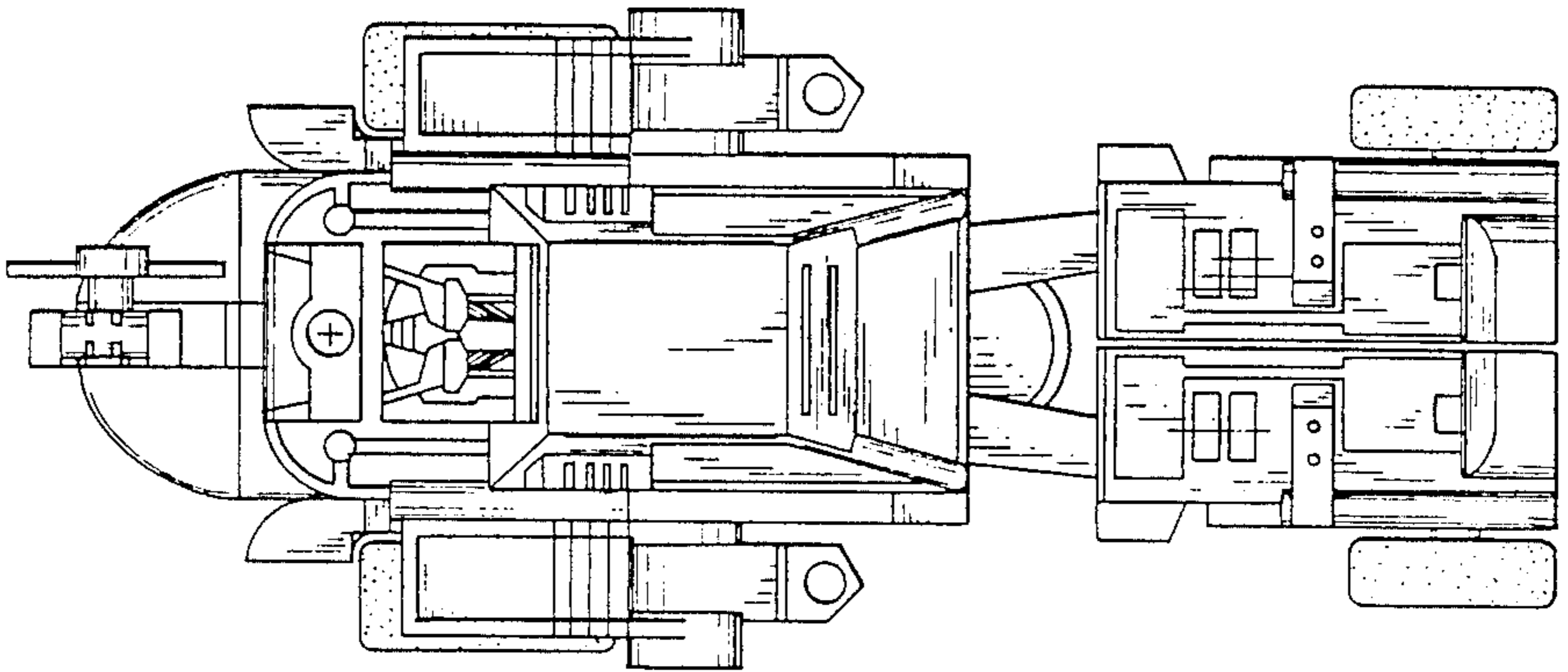

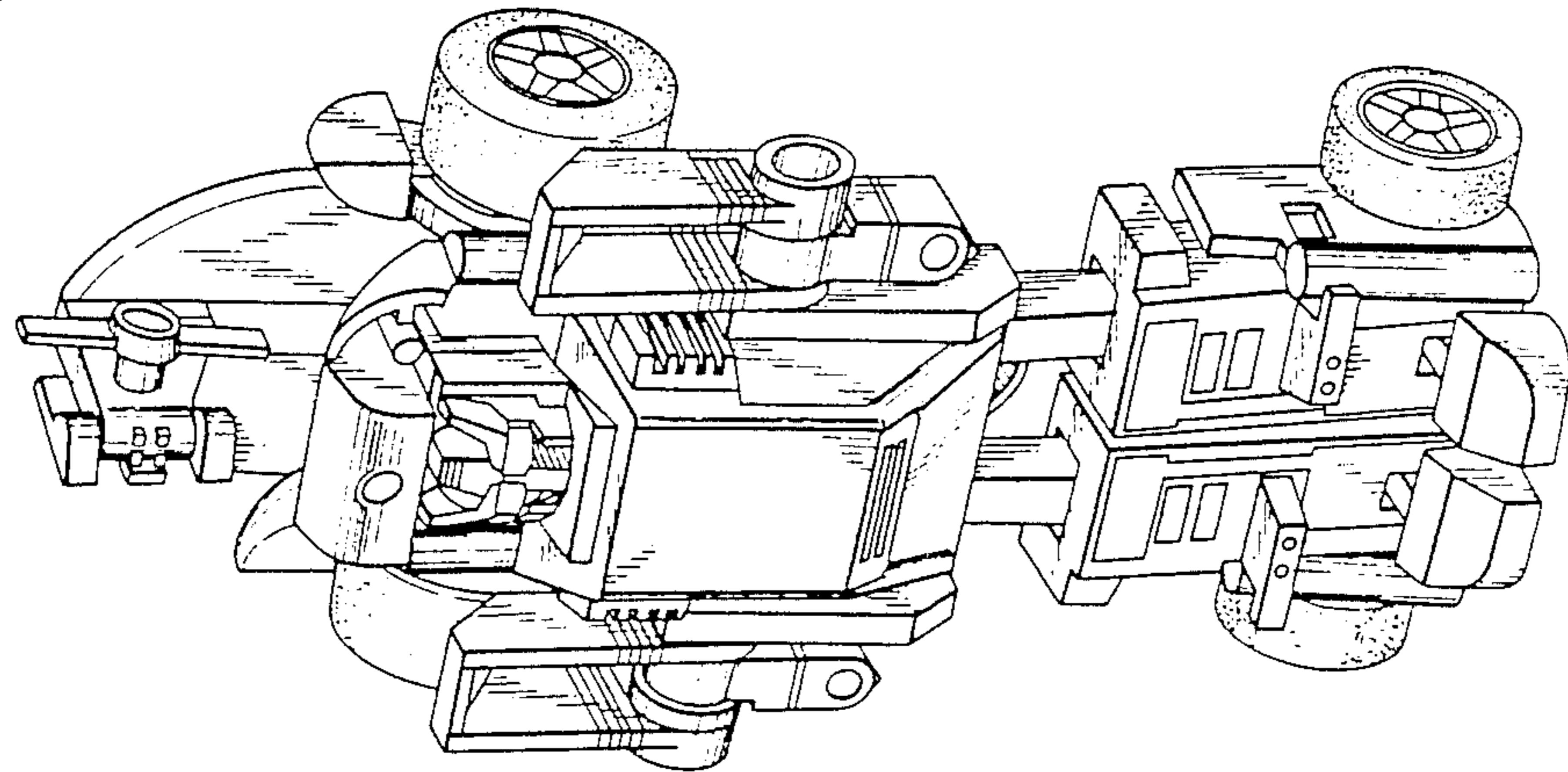

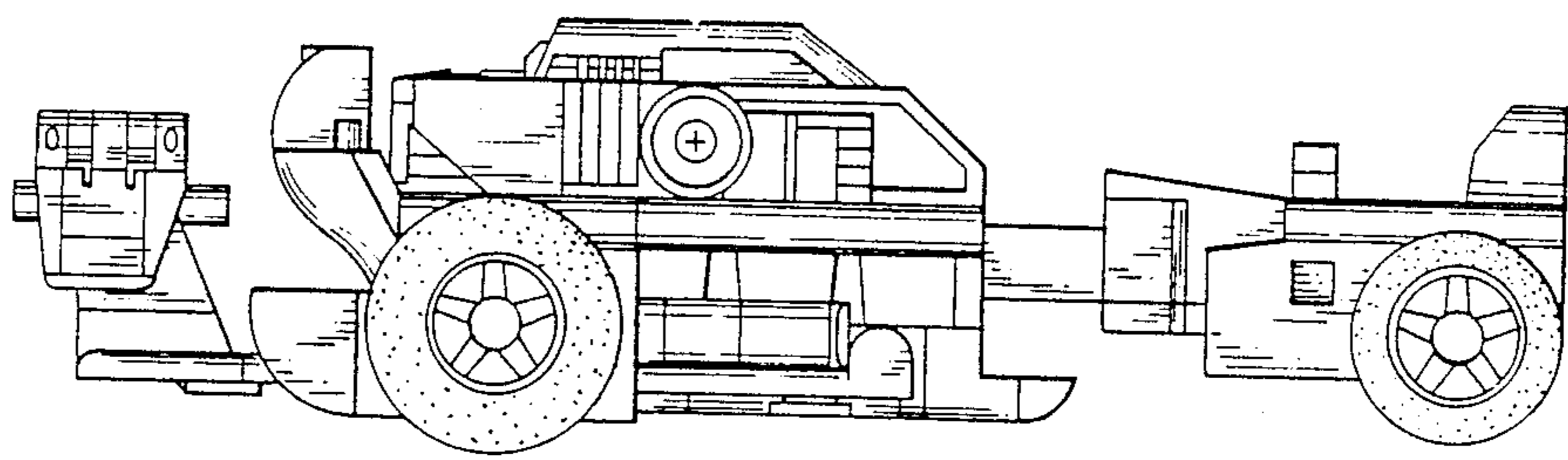

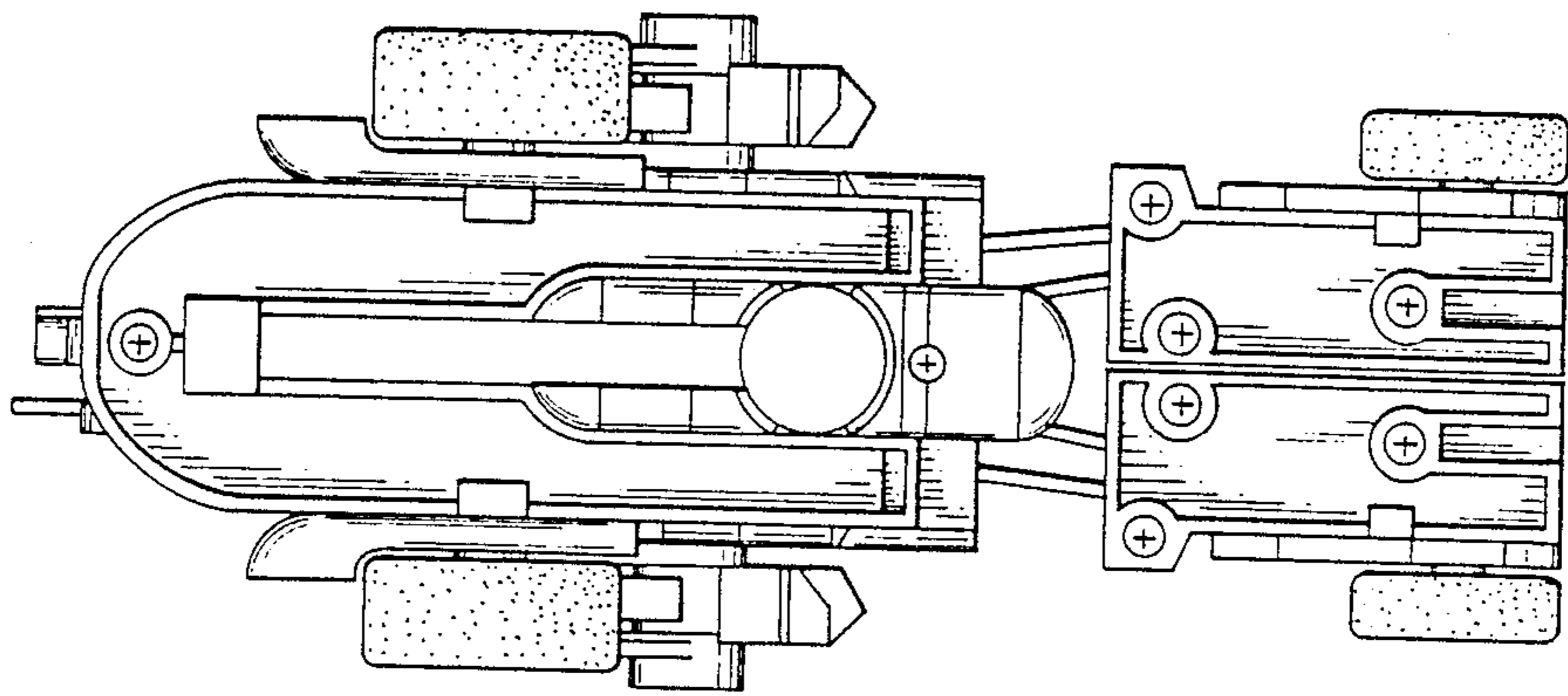

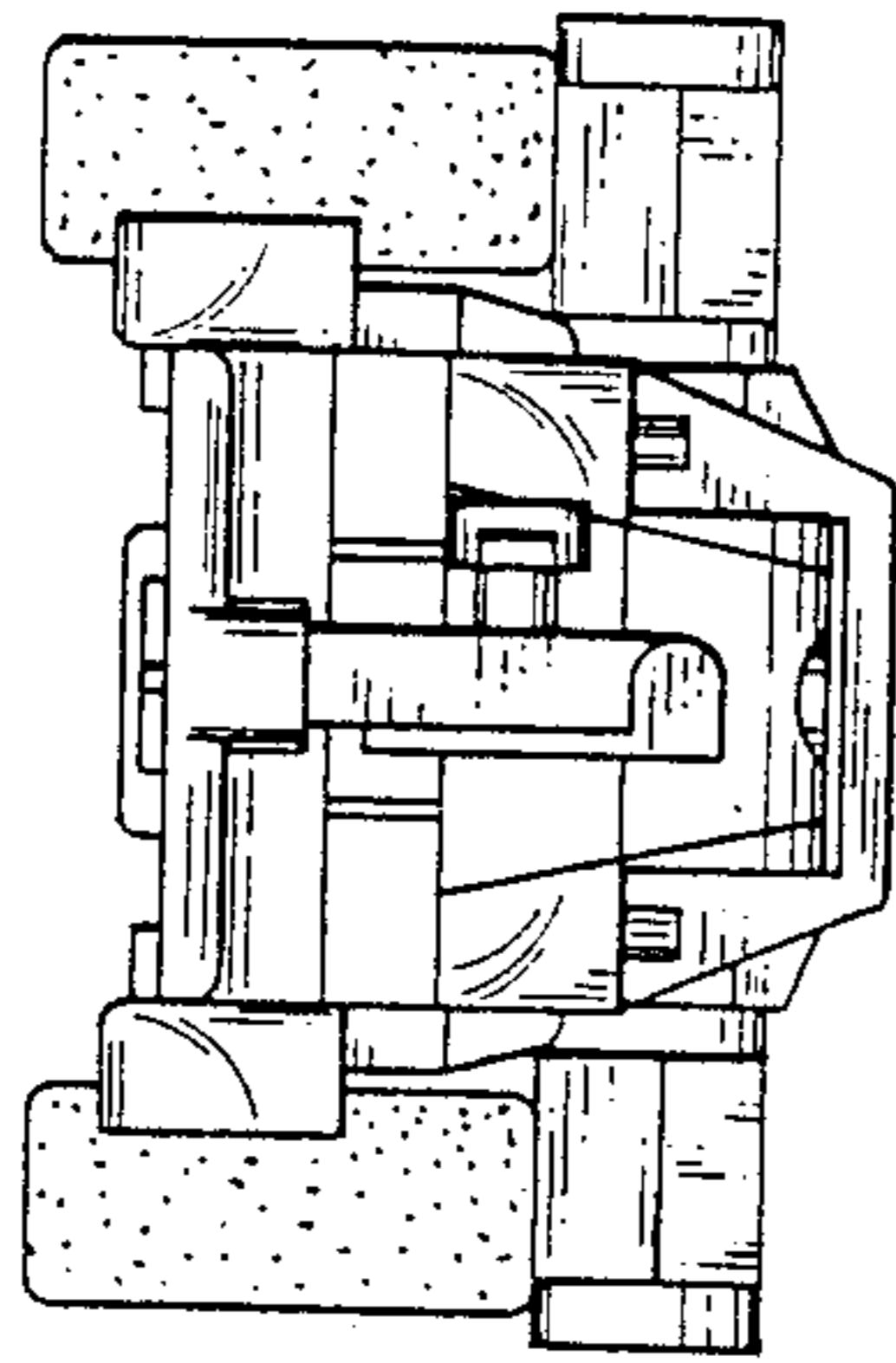
