The ornamental design for a tape measure with digital display, substantially as shown.

**DESCRIPTION**

FIG. 1 is a right side elevational view of a tape measure with digital display, showing our new design;  
FIG. 2 is a left side elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a front elevational view thereof;  
FIG. 5 is a top plan view thereof;  
FIG. 6 is a bottom plan view thereof;  
FIG. 7 is a top and right front perspective view thereof.

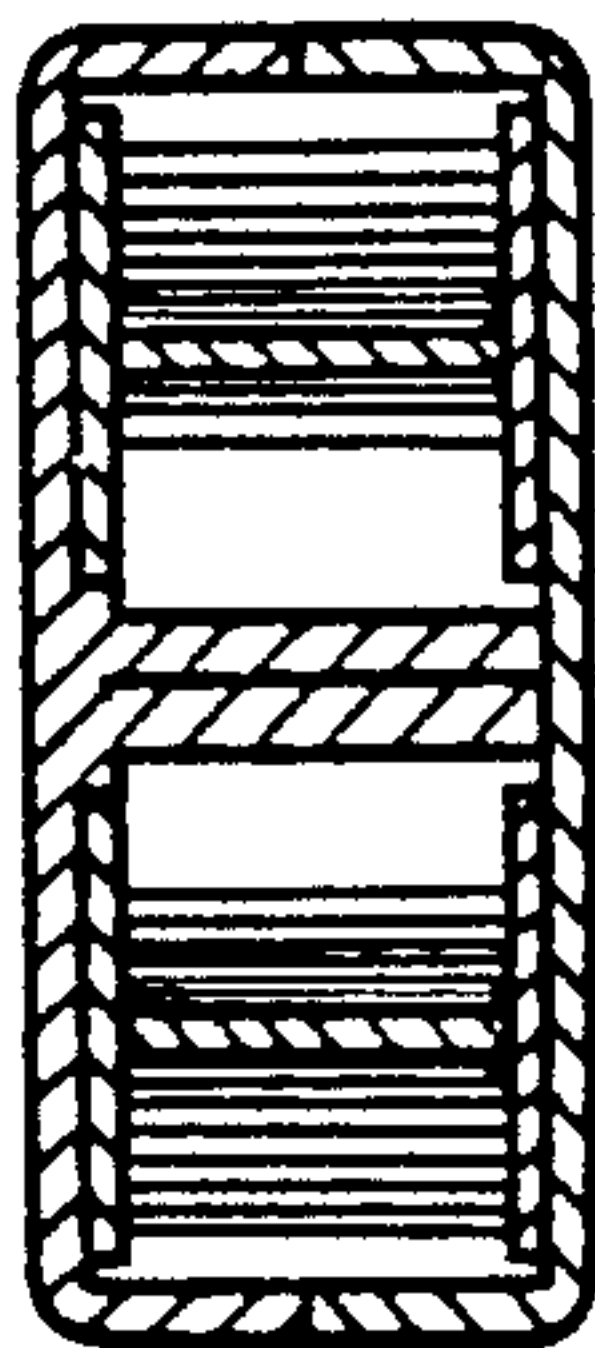

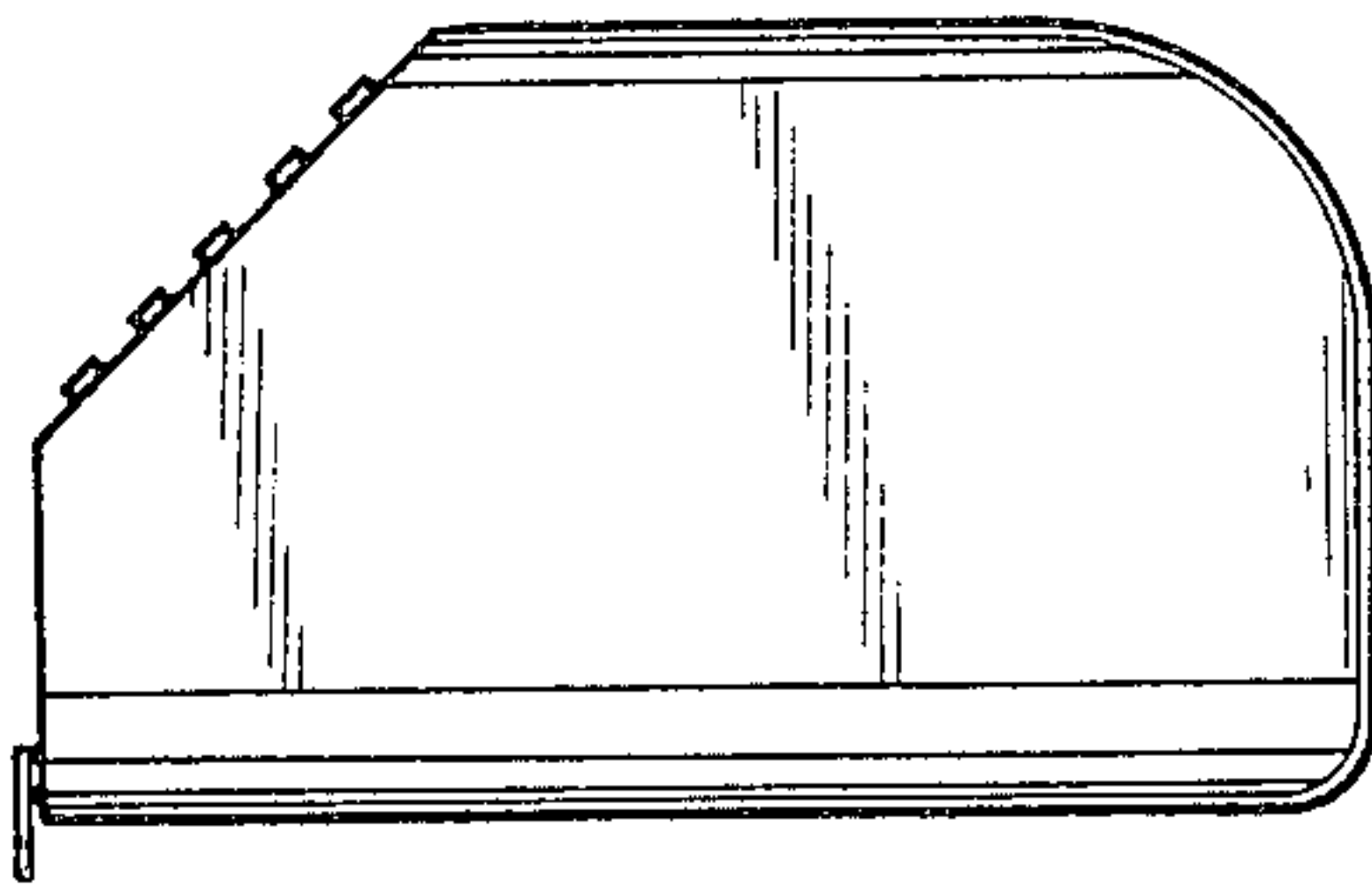

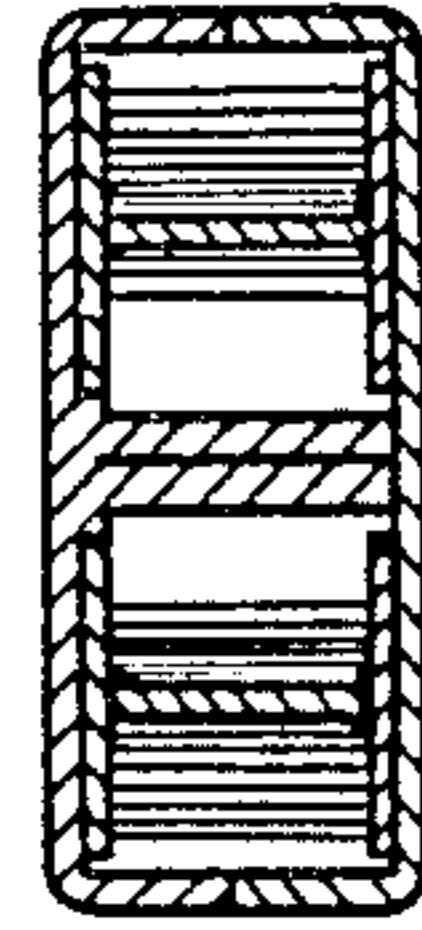

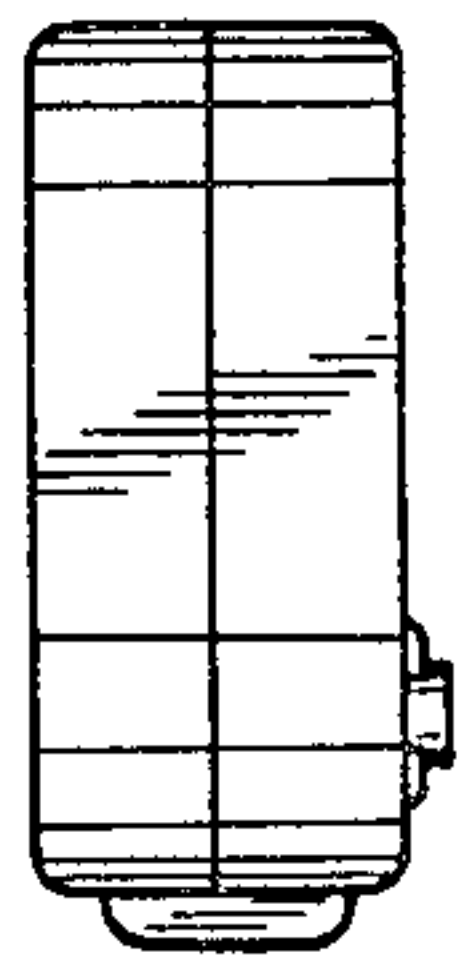

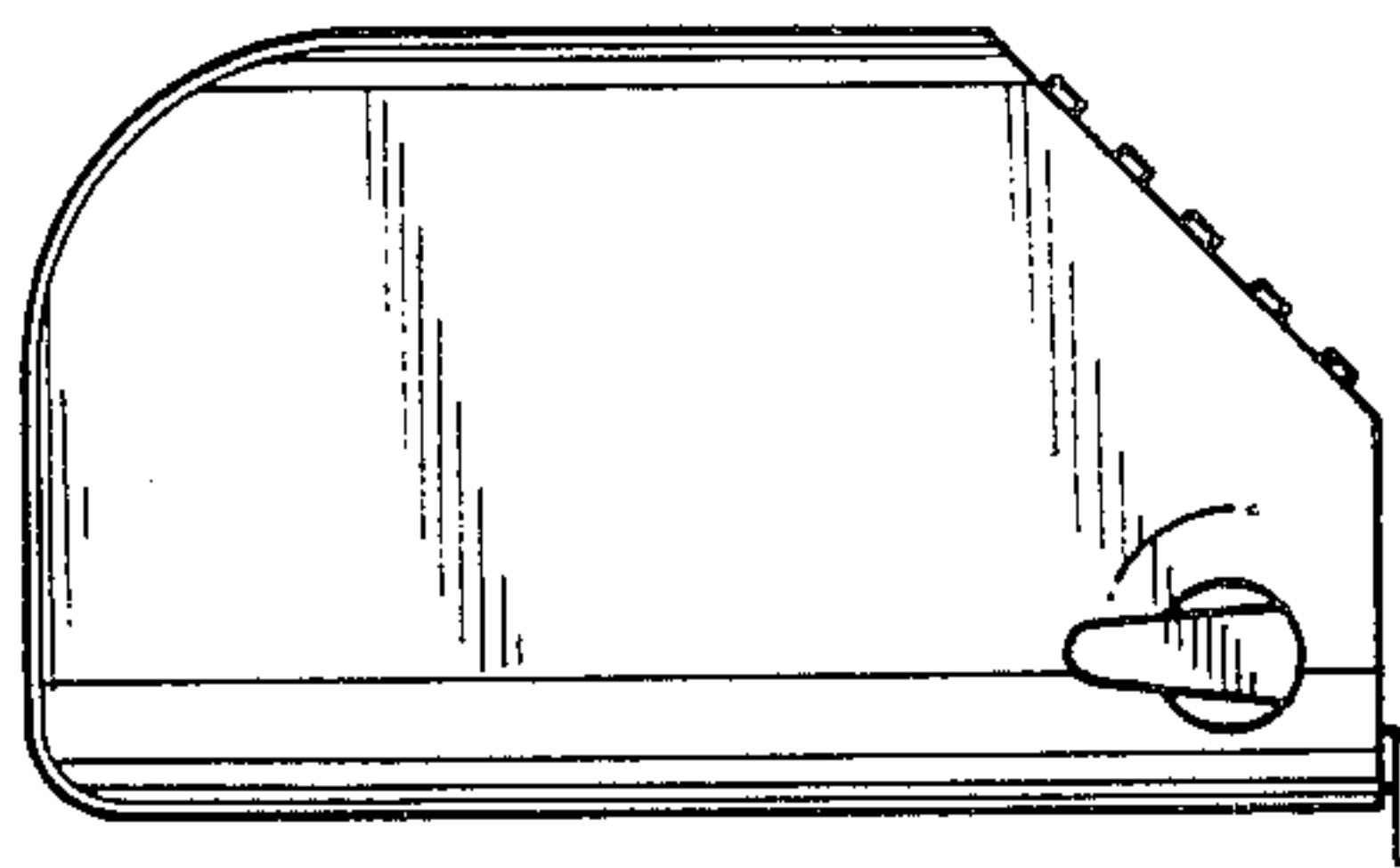

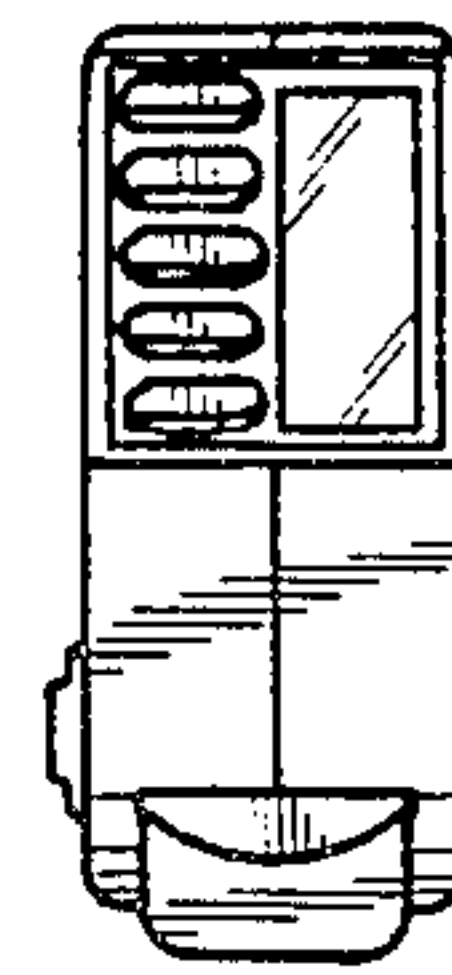

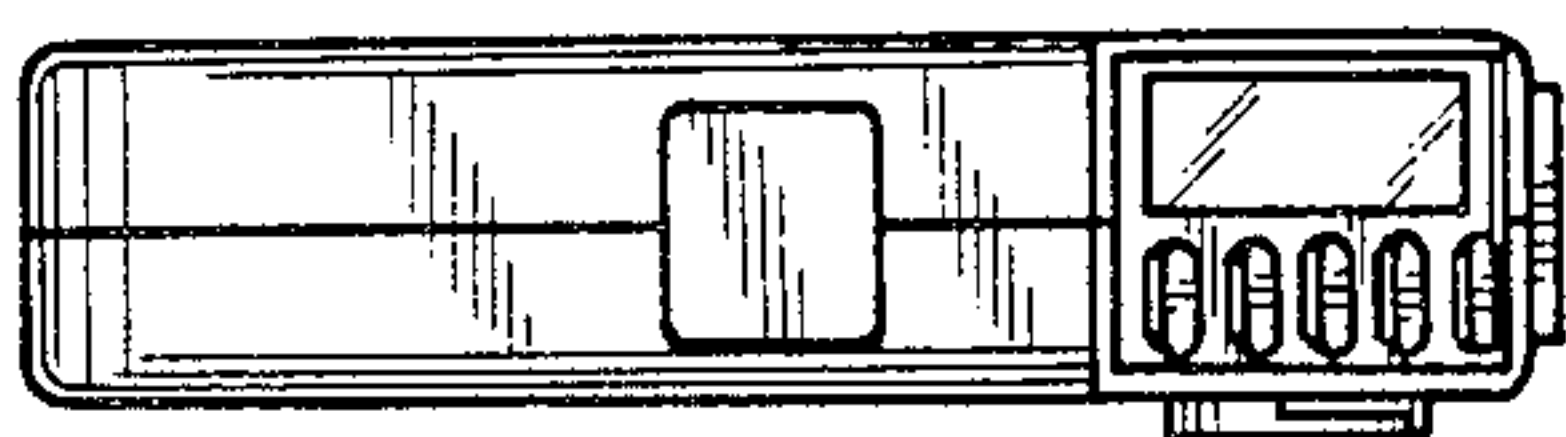

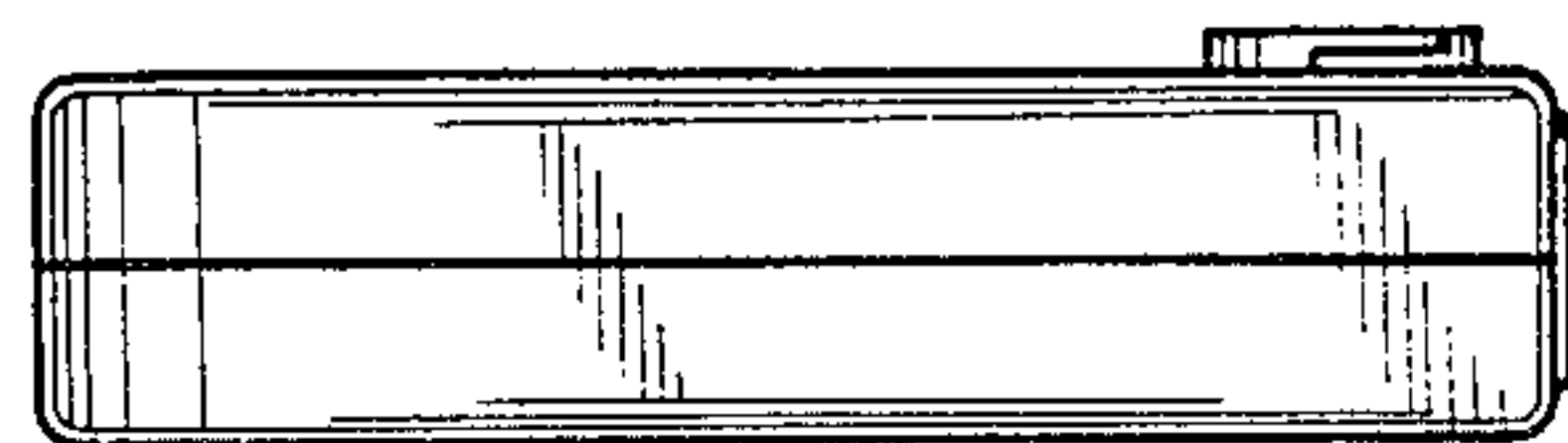

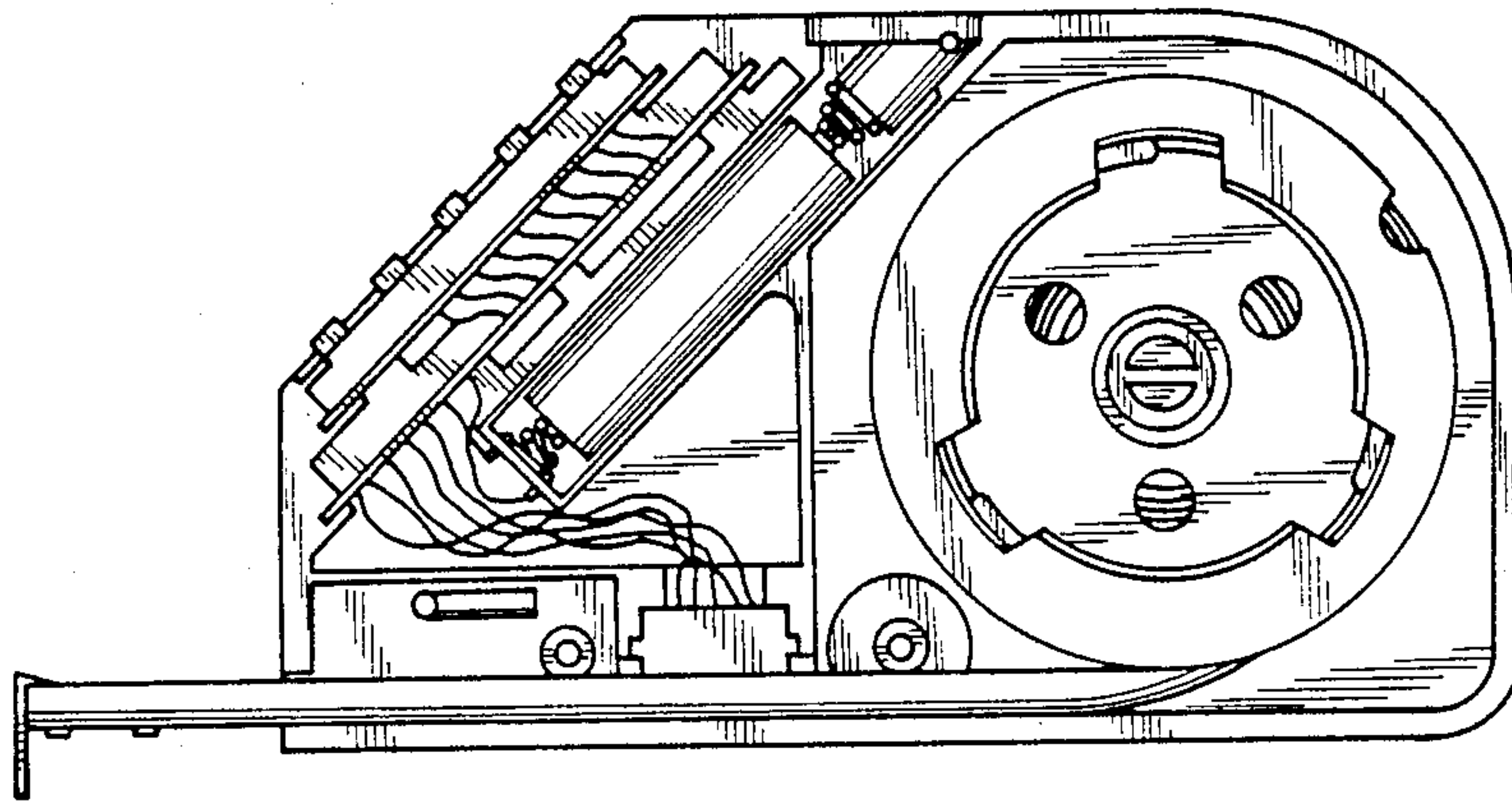
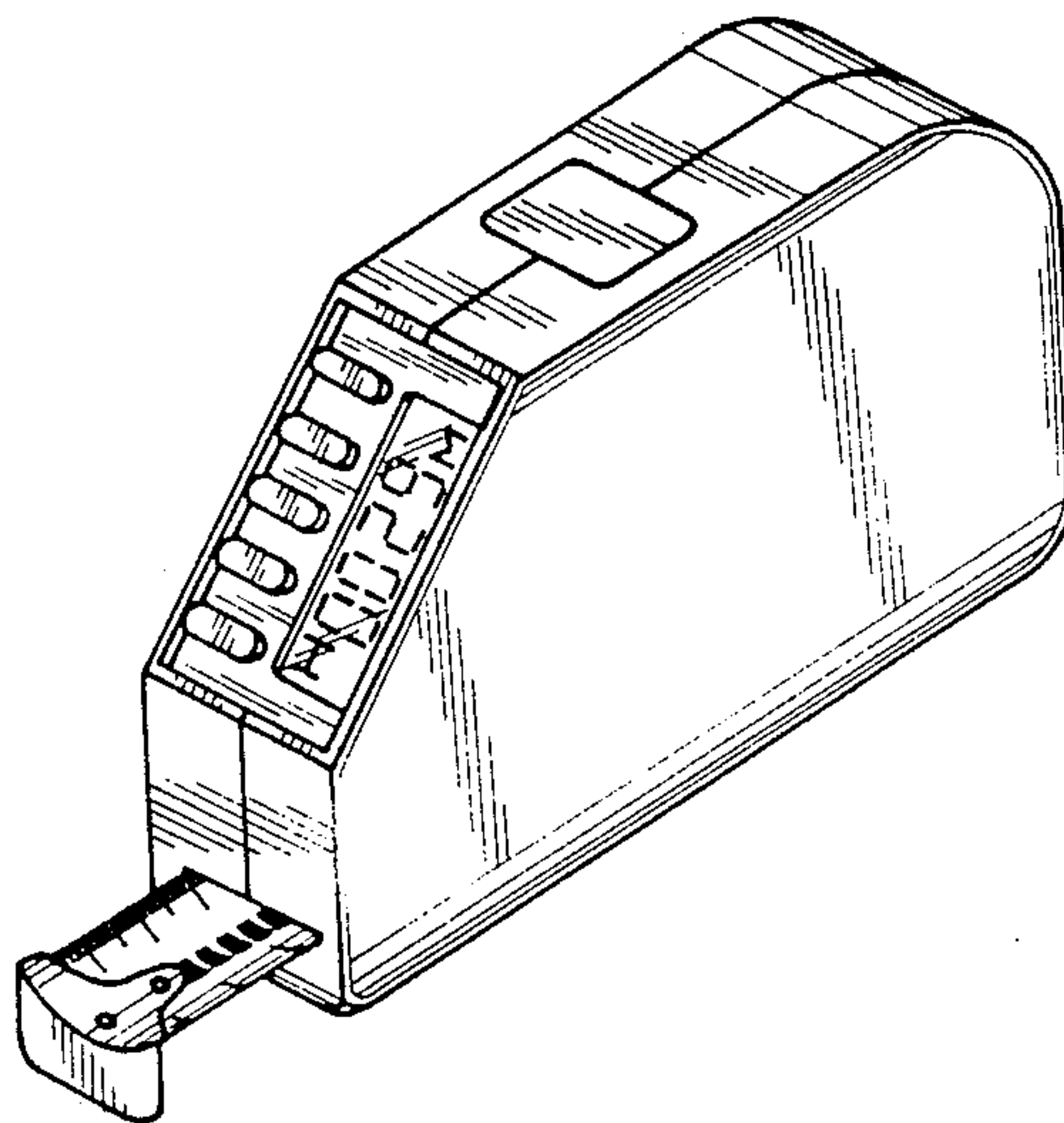
