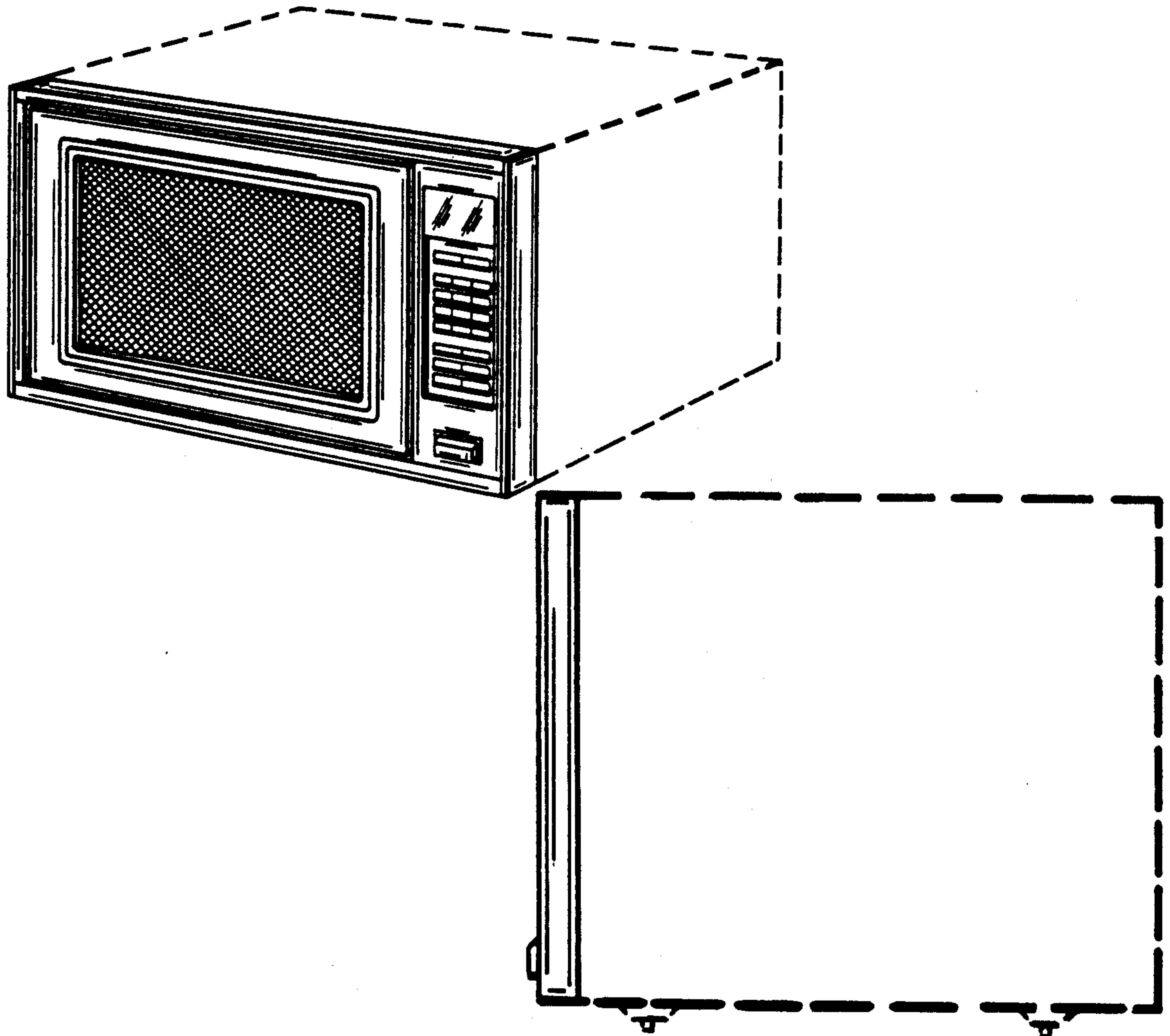

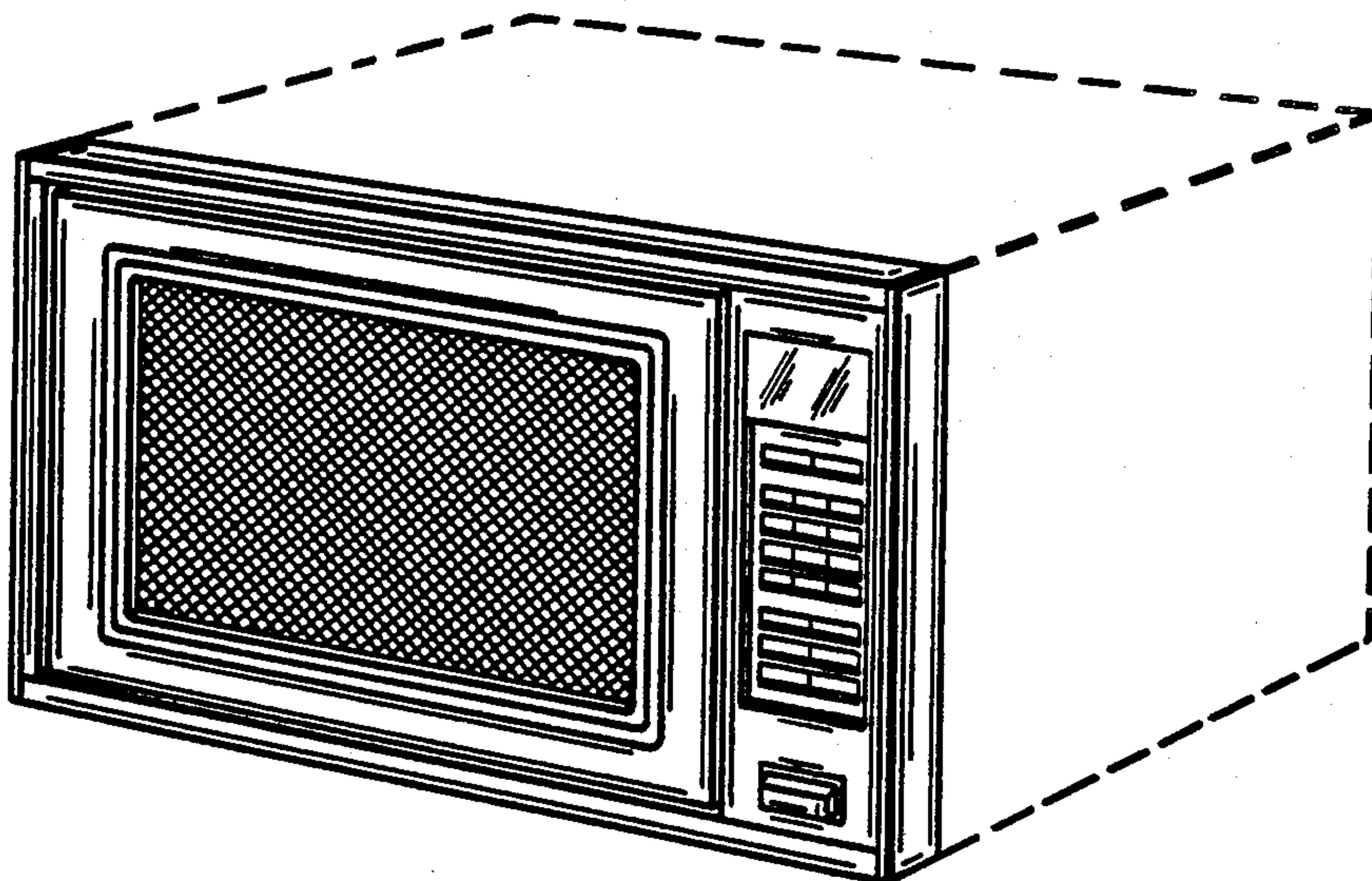
[57] CLAIM

The ornamental design for a front panel for a microwave oven, as shown and described.

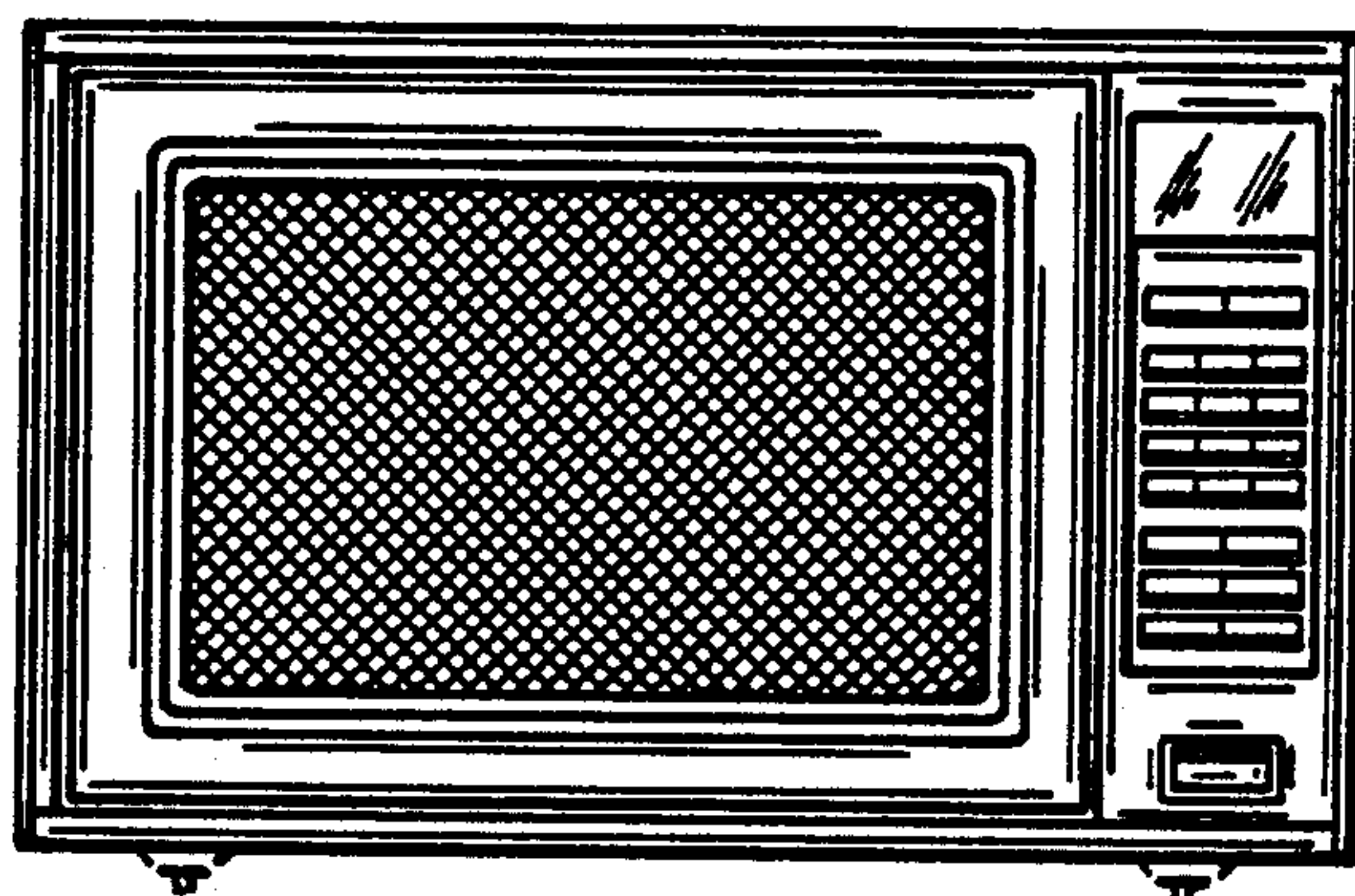
DESCRIPTION

FIG. 1 is an enlarged perspective view of front panel for a microwave oven showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a front elevational view thereof with the door open; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a right side elevational view thereof; and FIG. 7 is a left side elevational view thereof. The cabinet shown in broken lines in FIGS. 1-7 is shown for illustrative purposes only and forms no part of the claimed design.

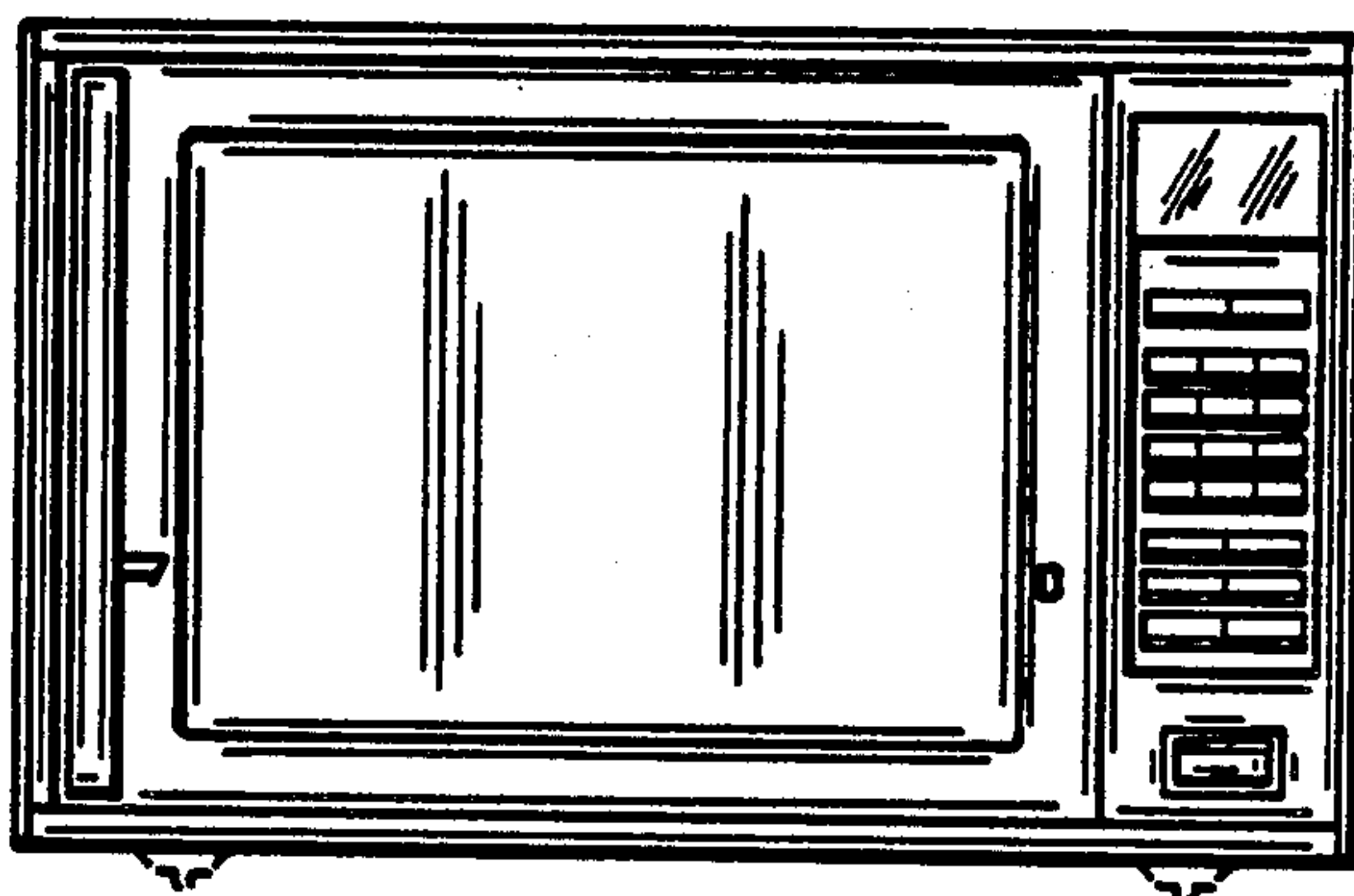




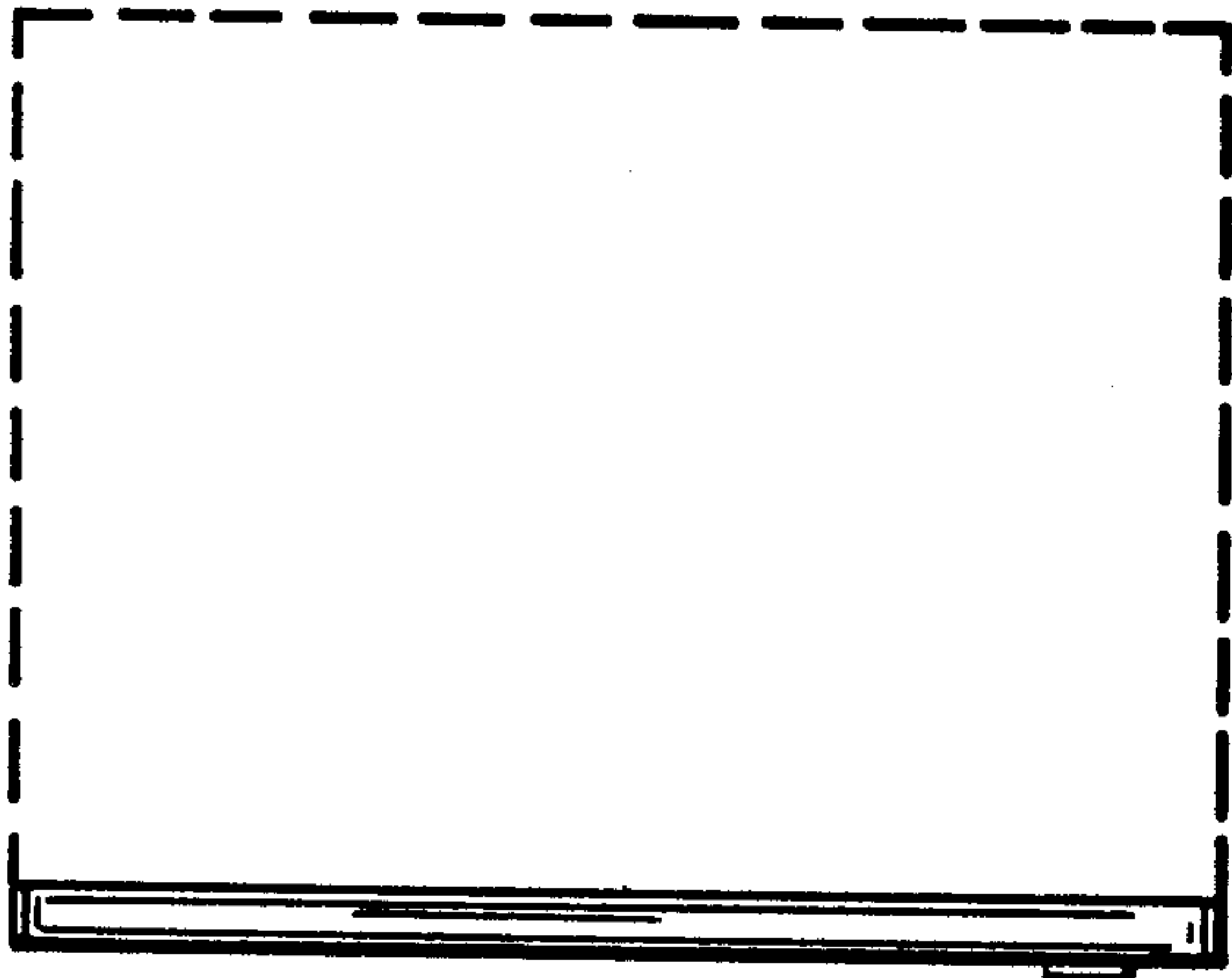

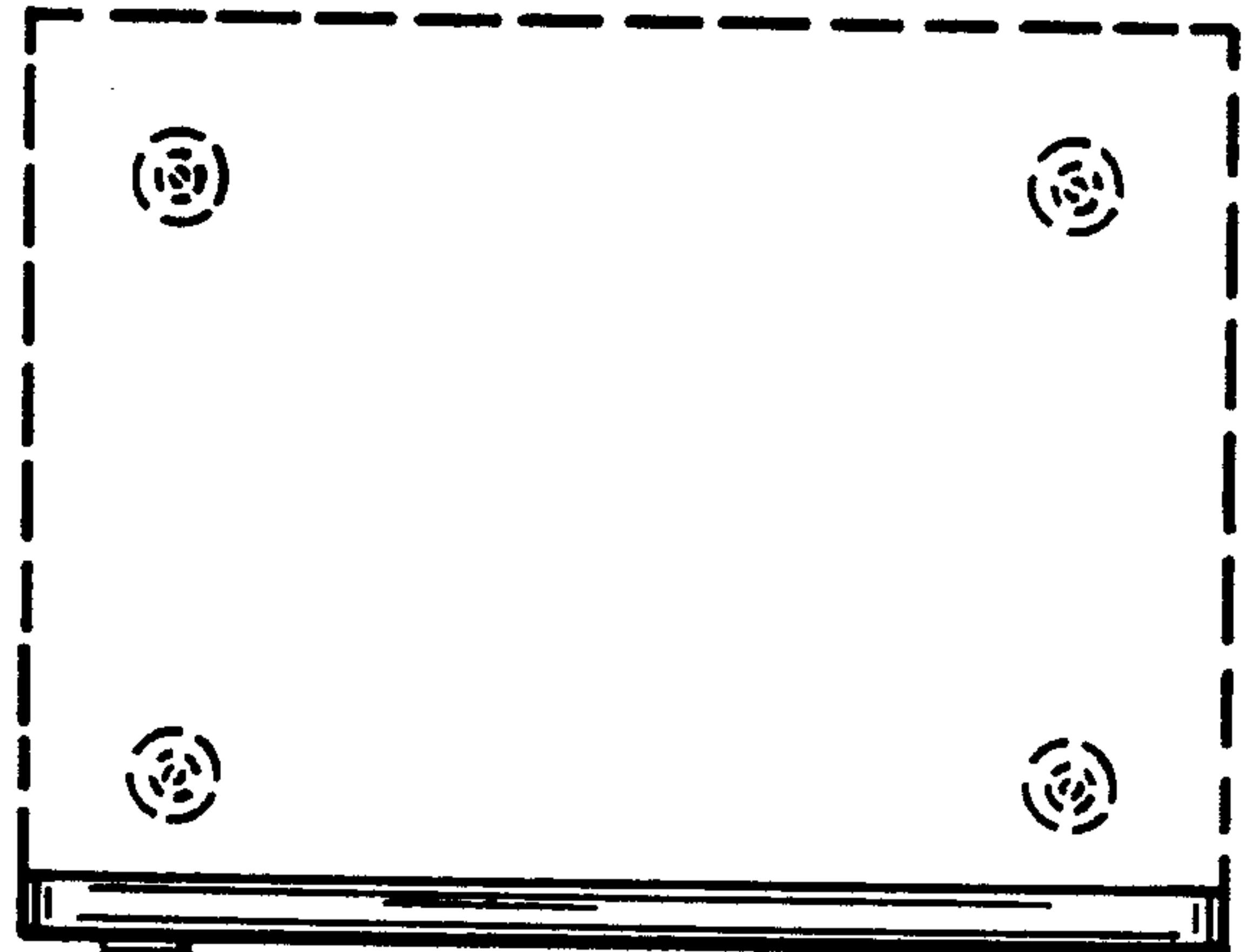

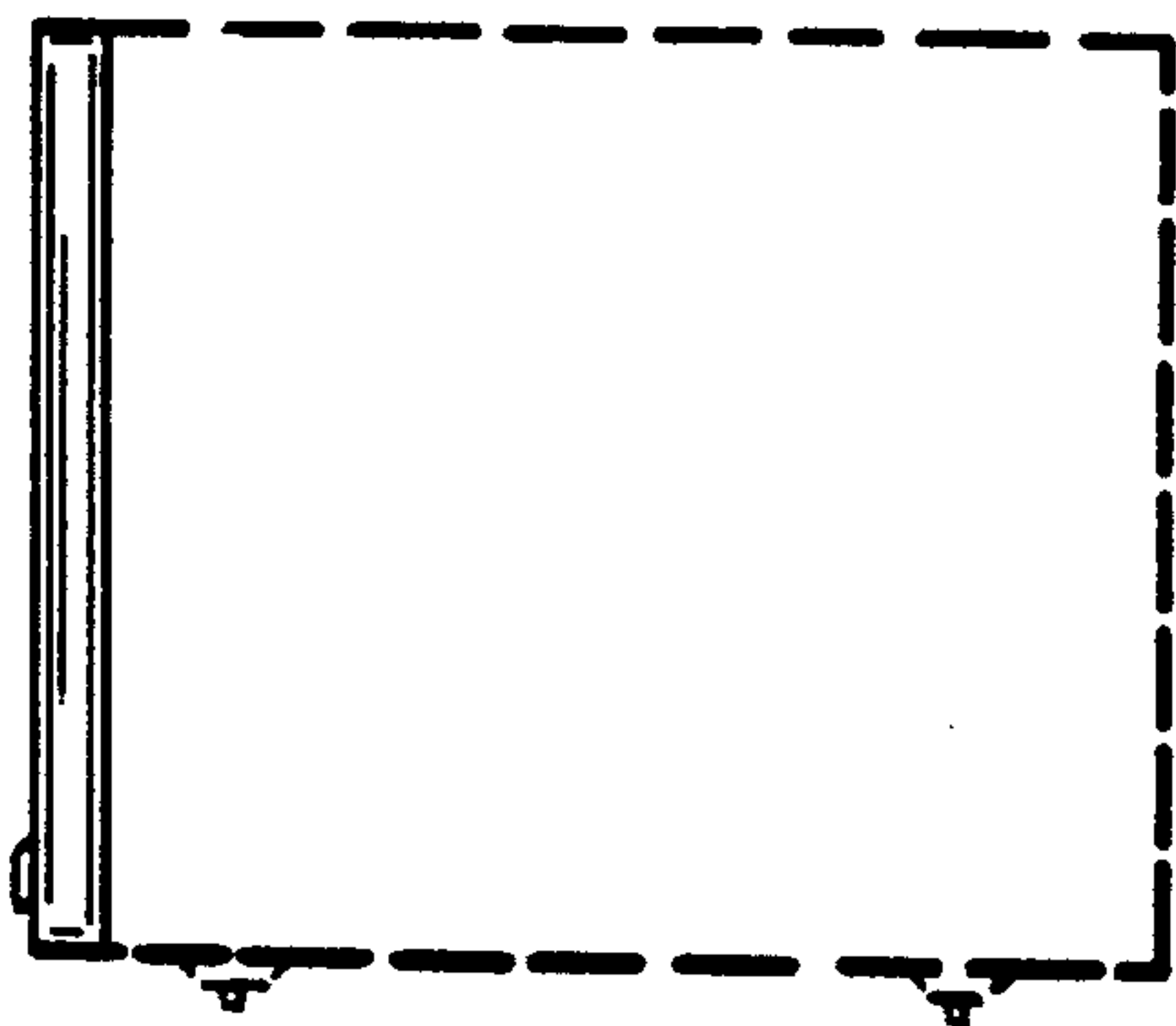

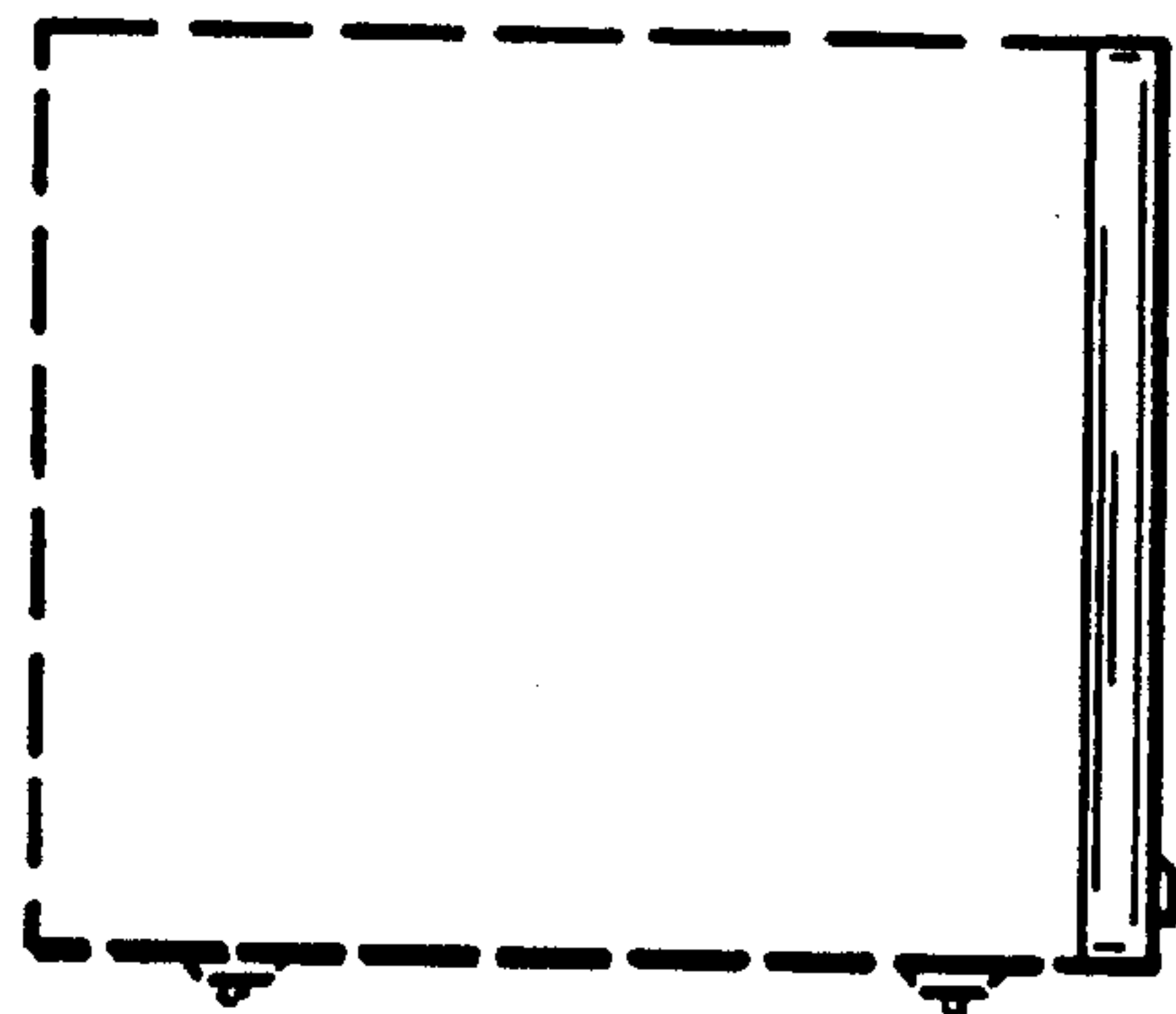
