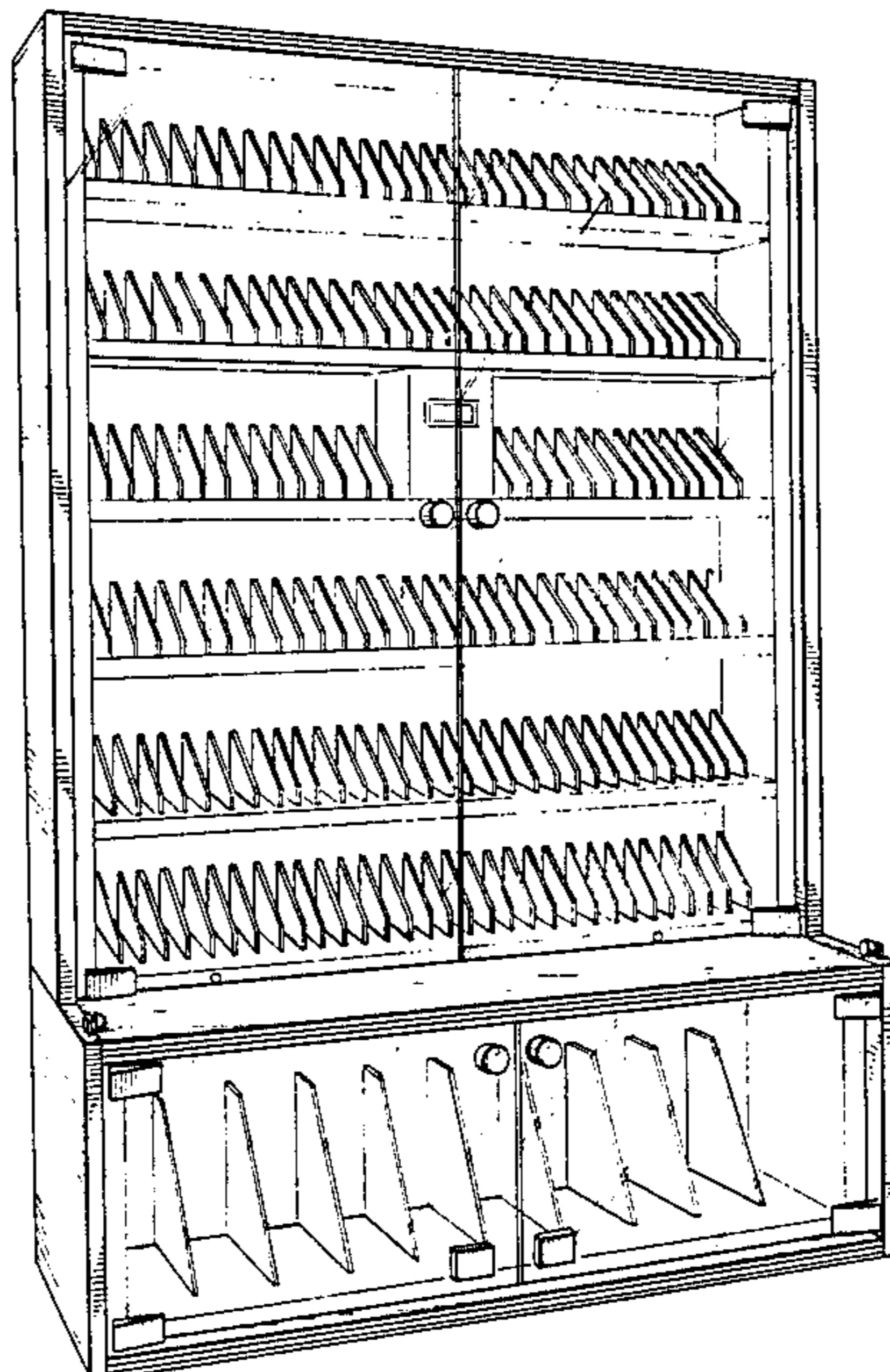

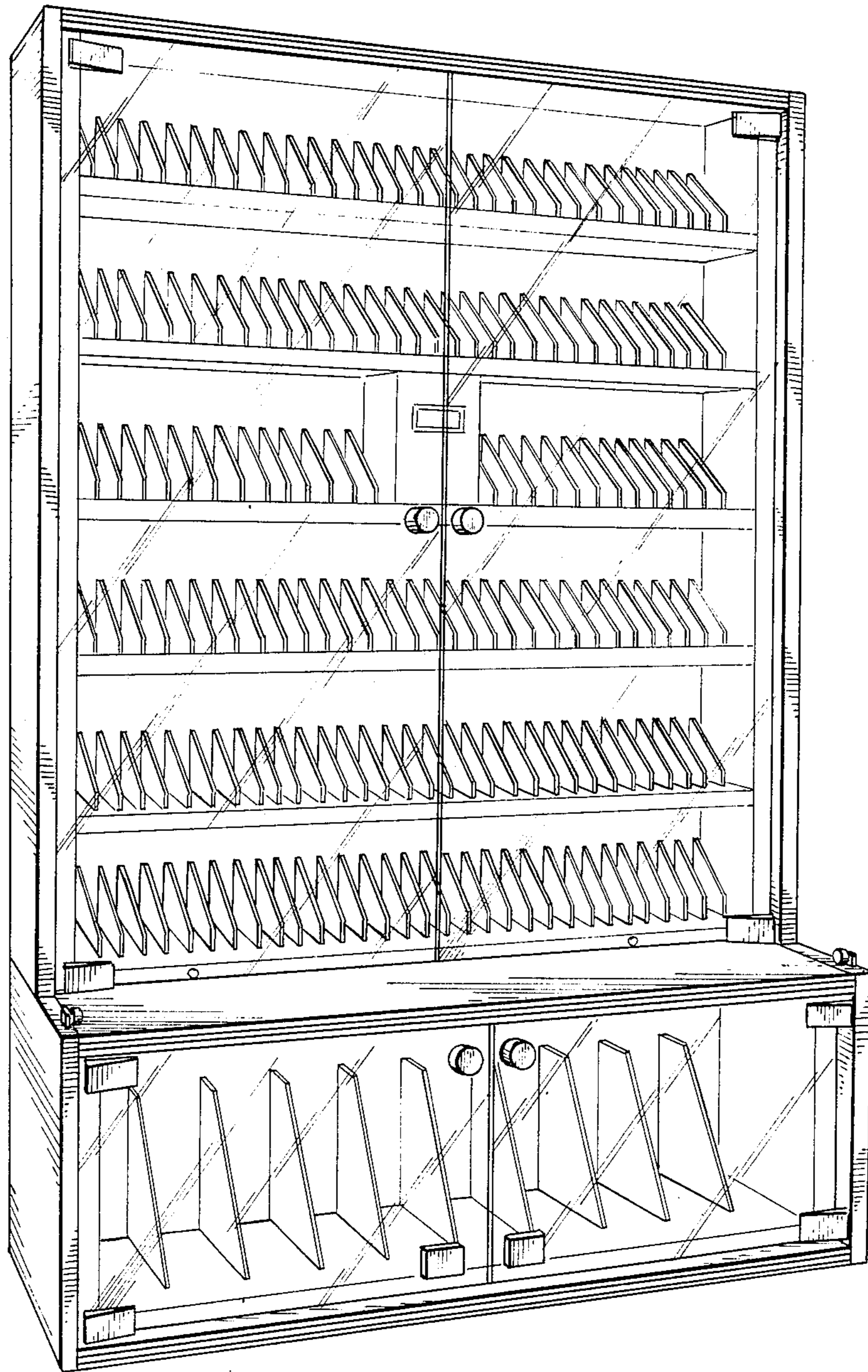
The ornamental design for a display cabinet, as shown and described.

**DESCRIPTION**

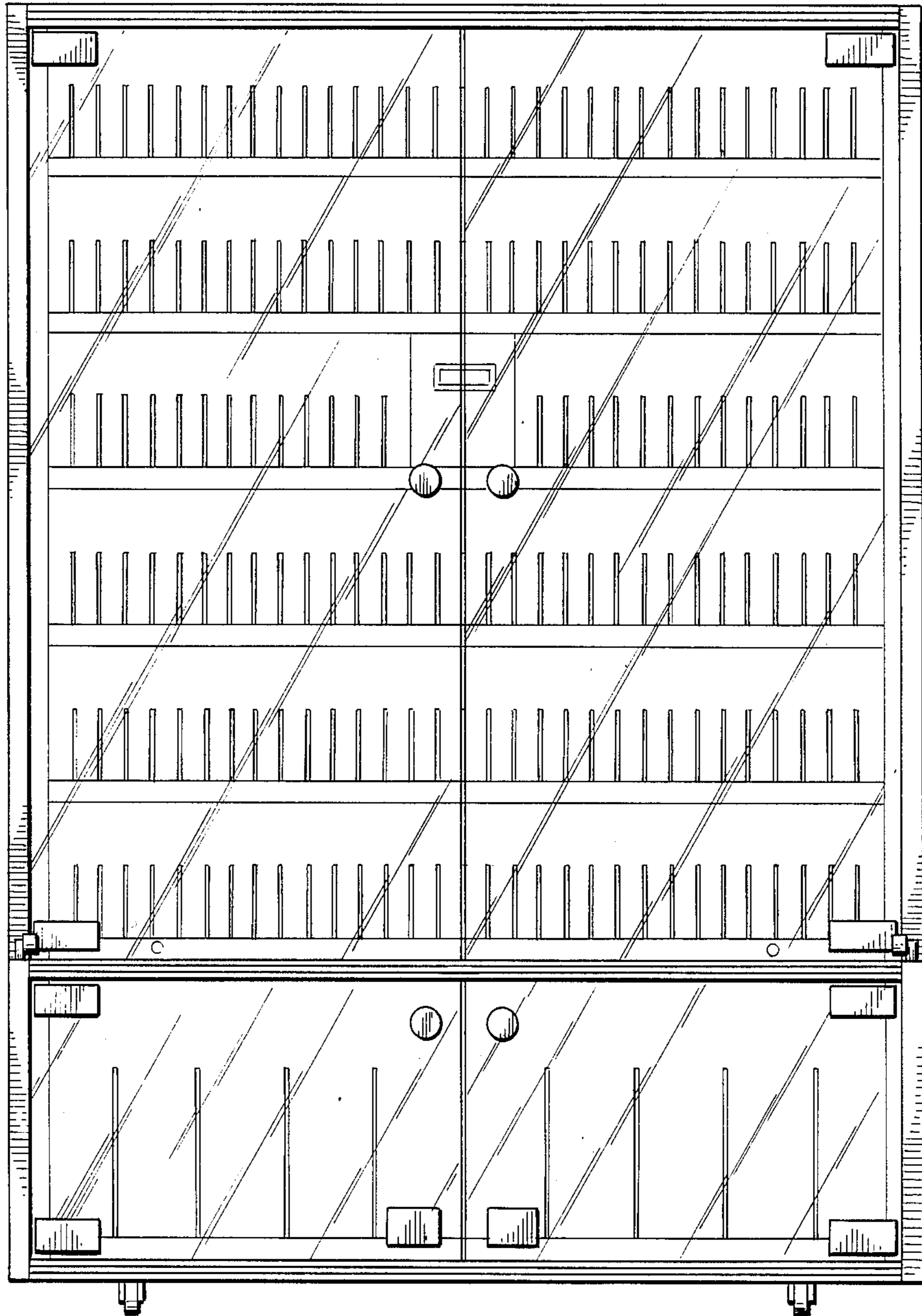
FIG. 1 is a front perspective view of a display cabinet showing my new design;

FIG. 4 is a top plan view thereof.



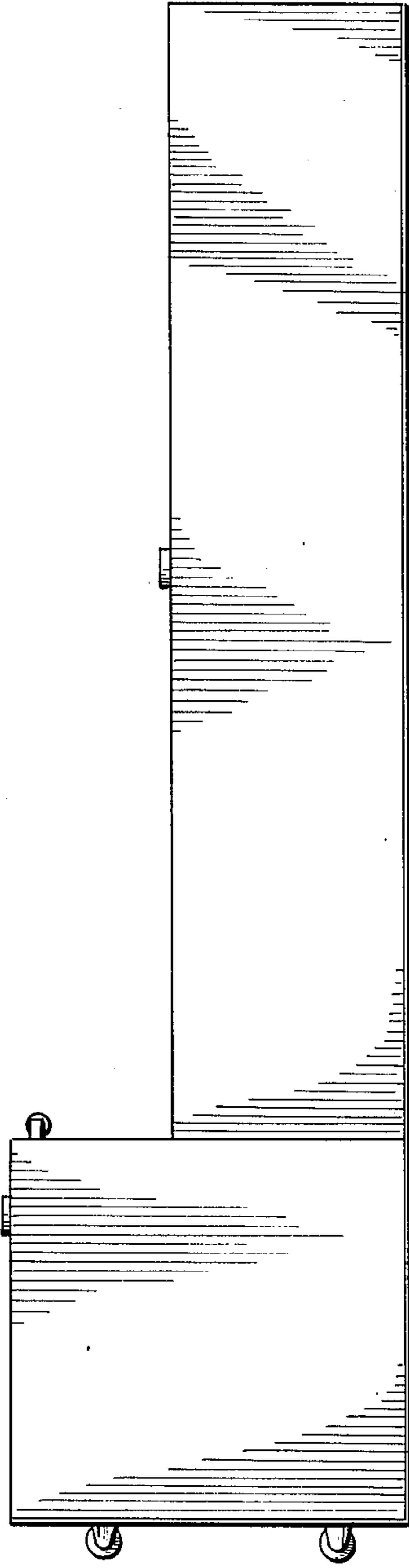
