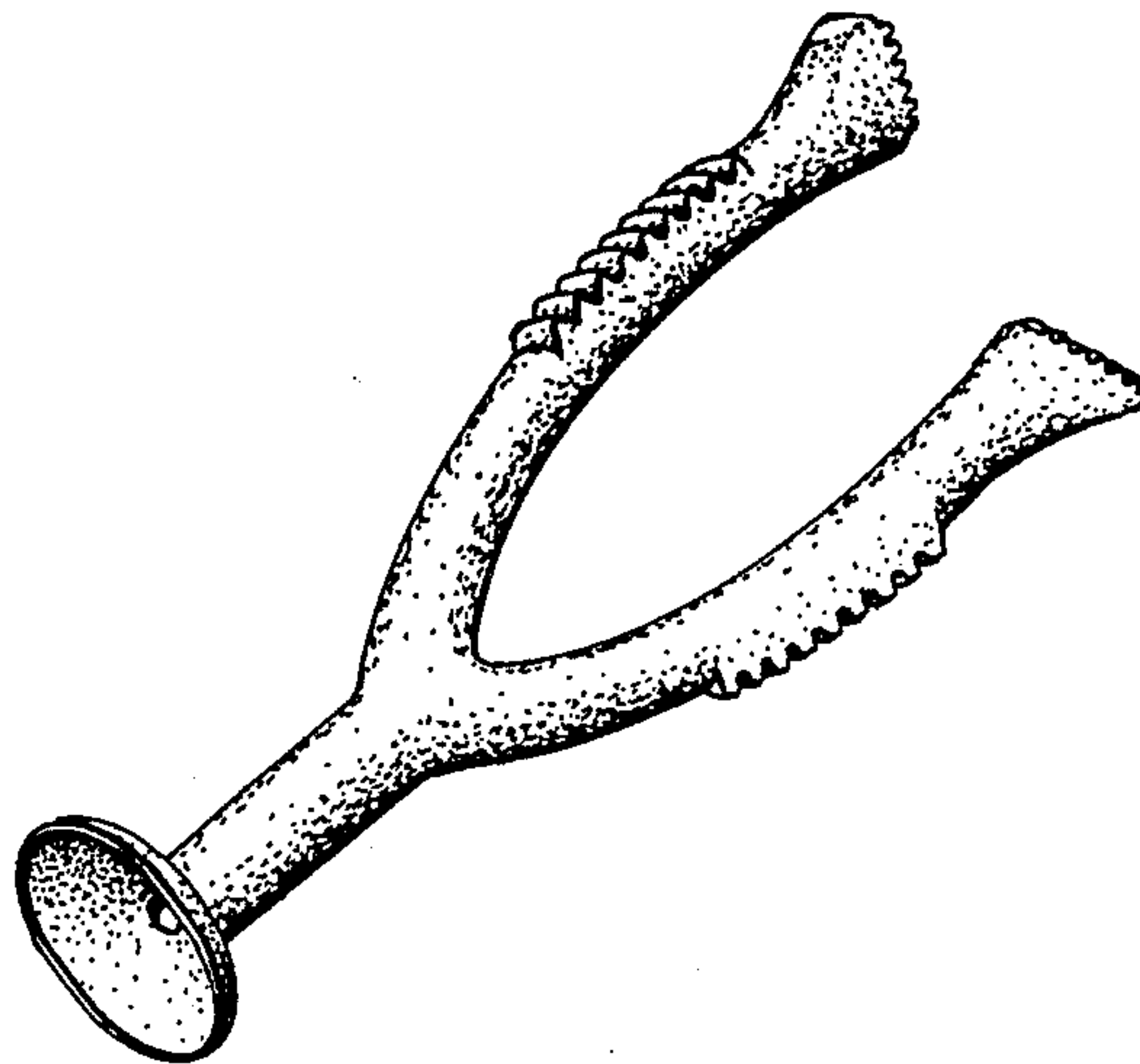

DESCRIPTION

FIG. 1 is a perspective view of the contact lens manipulator showing my new design;

 FIG. 6 is a bottom plan view thereof.



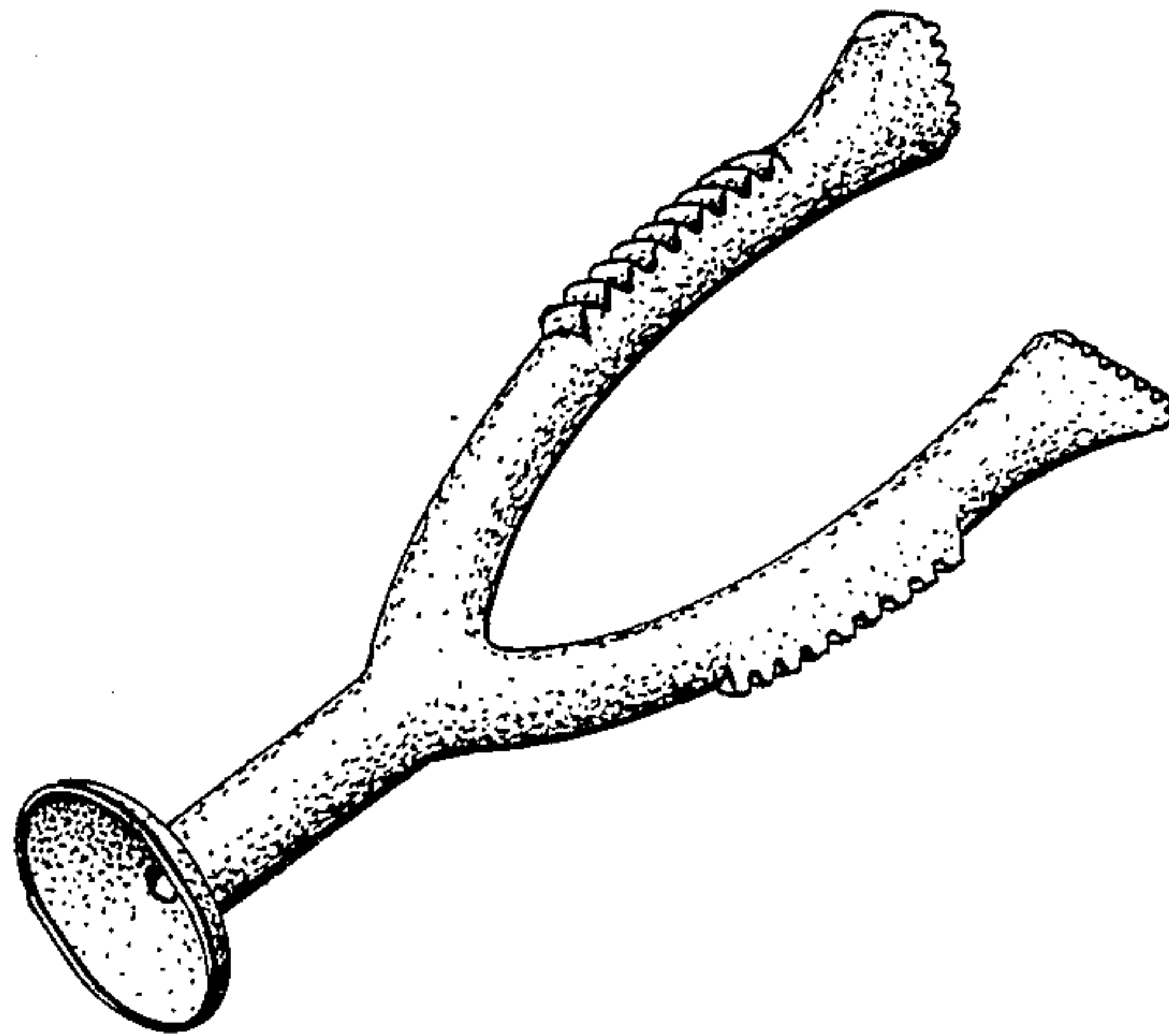

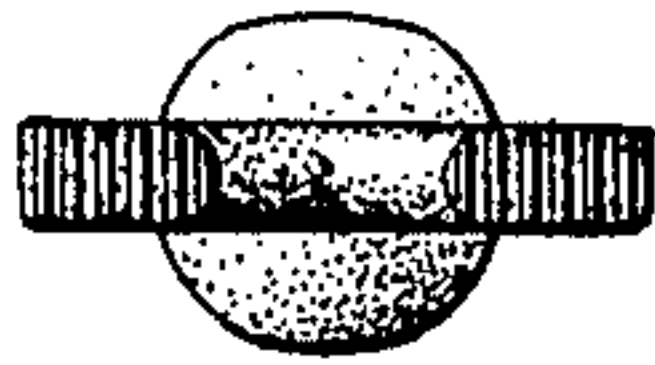

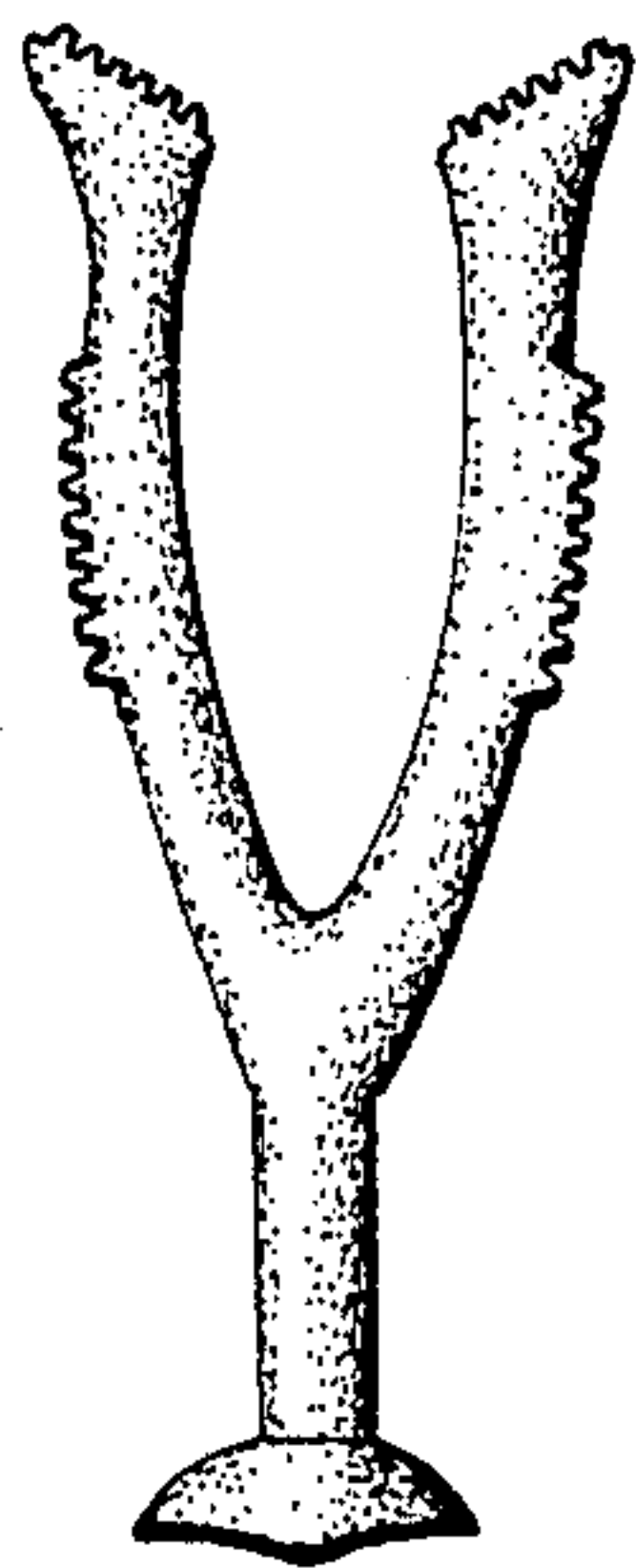

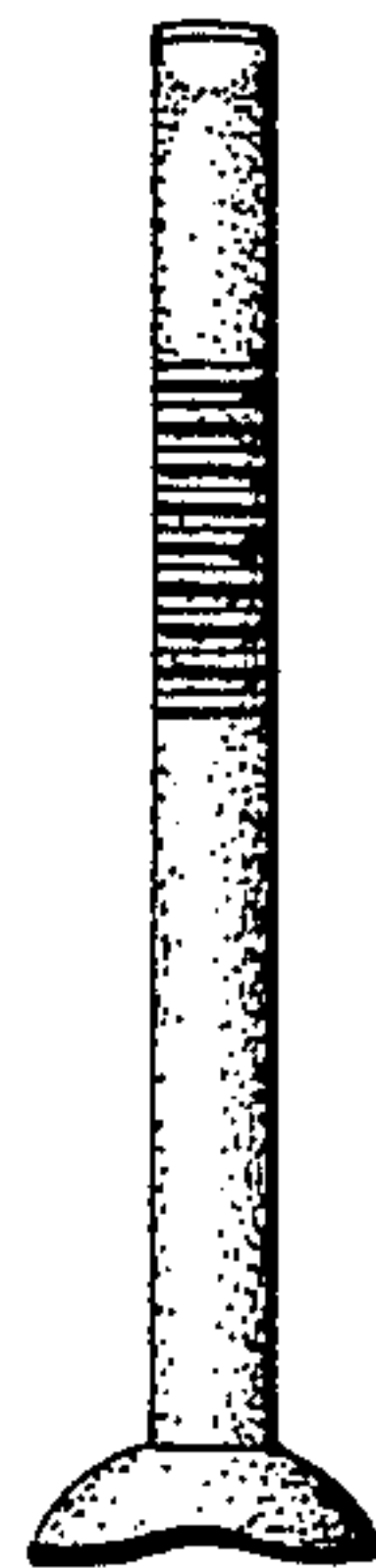

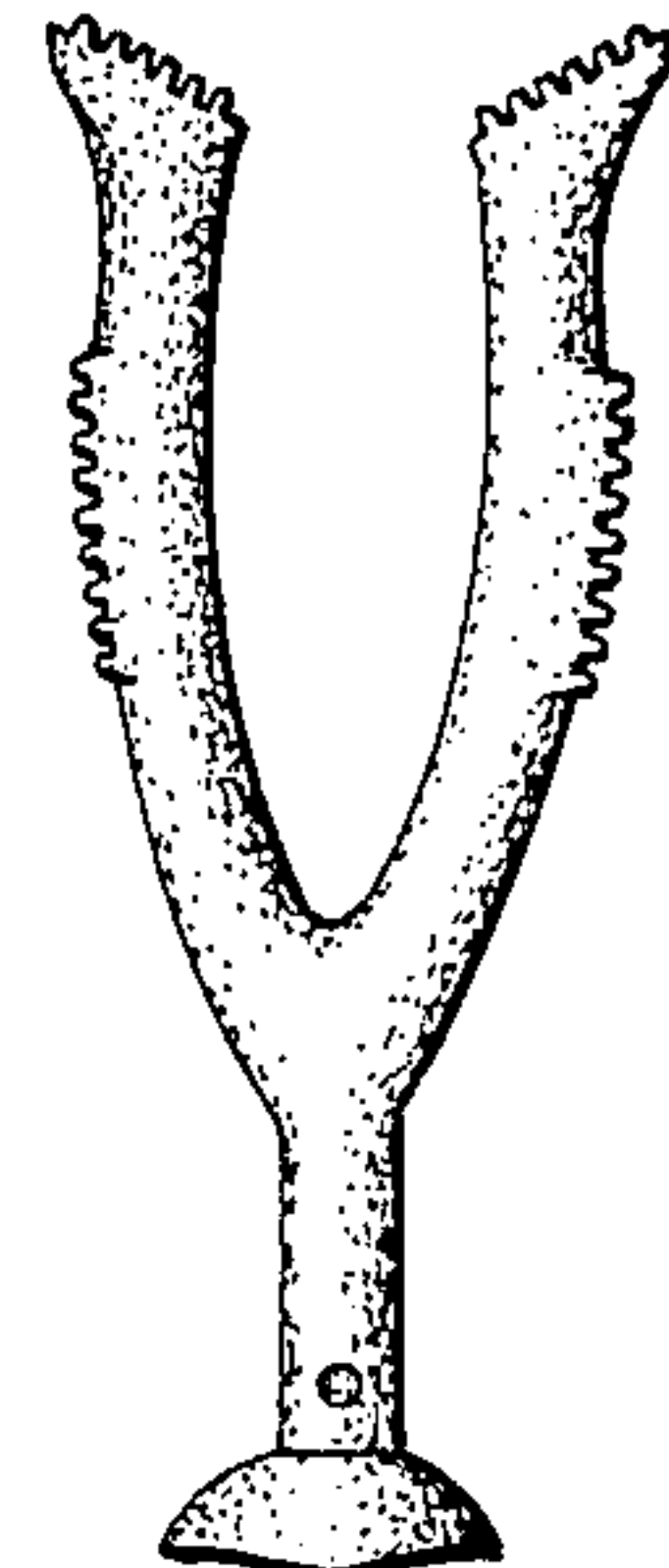

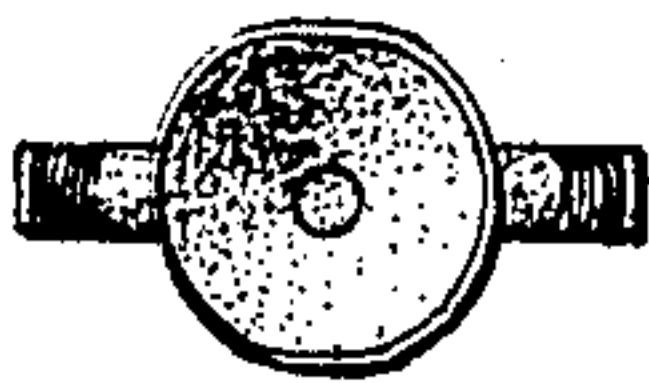
