The ornamental design for a shoe upper, as shown and described.

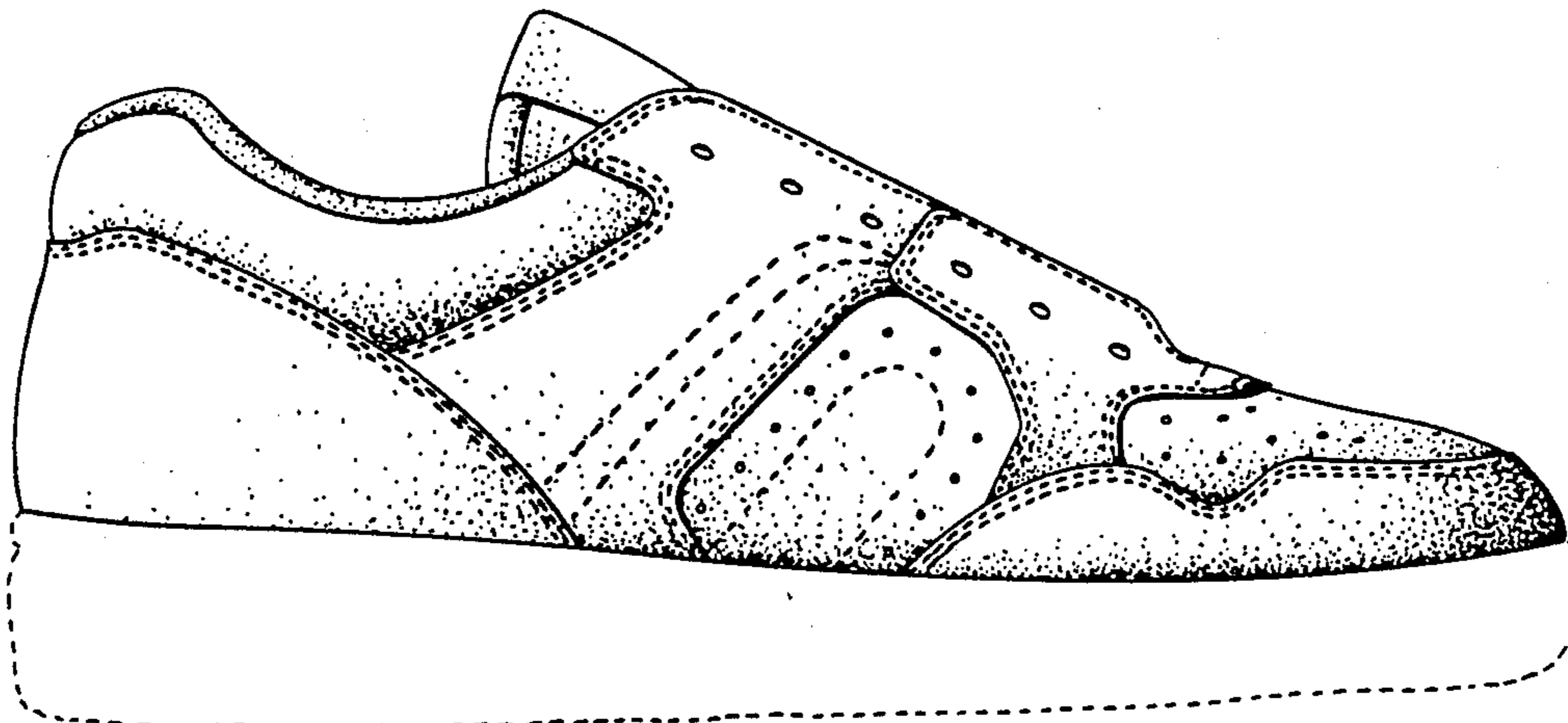
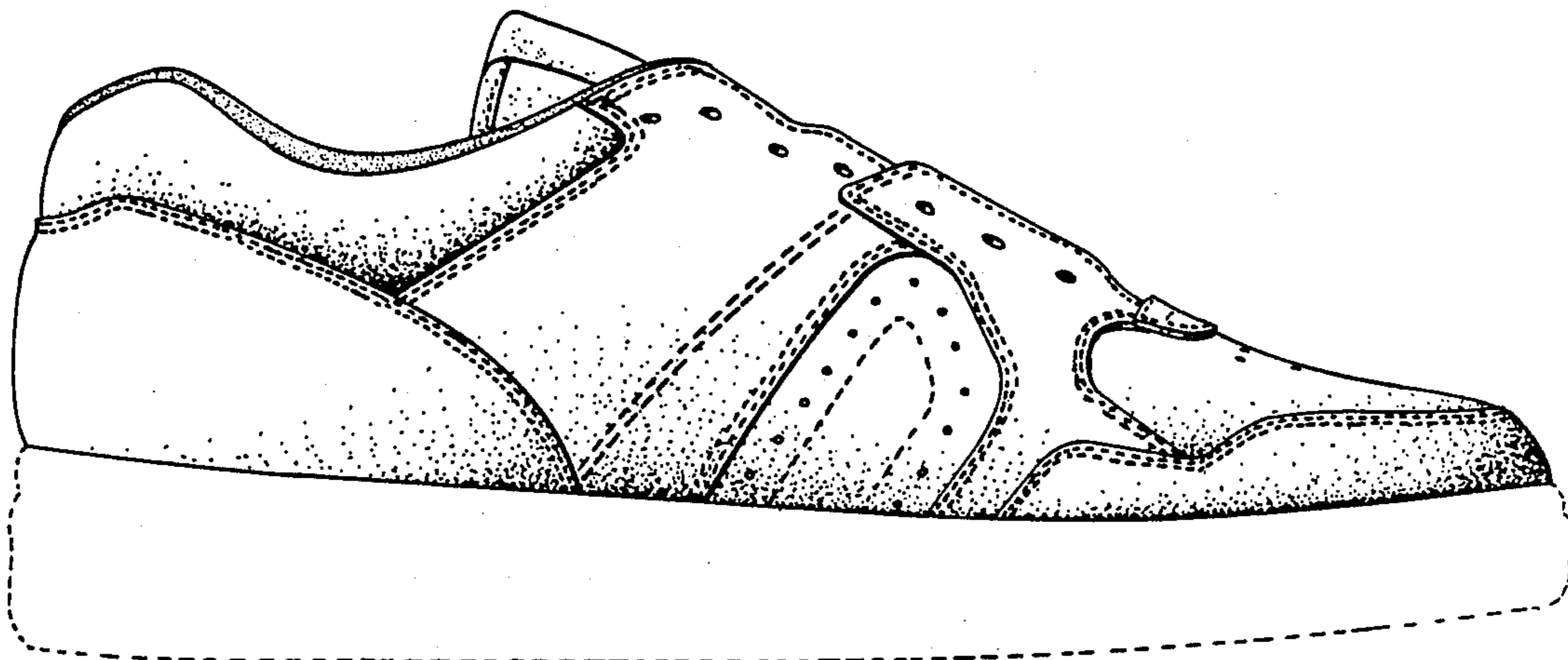
DESCRIPTION

FIG. 1 is a left side elevational view of a shoe upper showing our new design;

 FIG. 6 is a left side elevational view of a shoe upper showing a second embodiment of our new design;

 FIG. 10 is a rear elevational view thereof.  
 The broken line showing of a shoe sole in FIGS. 1-10 is environmental only and forms no part of the claimed design.

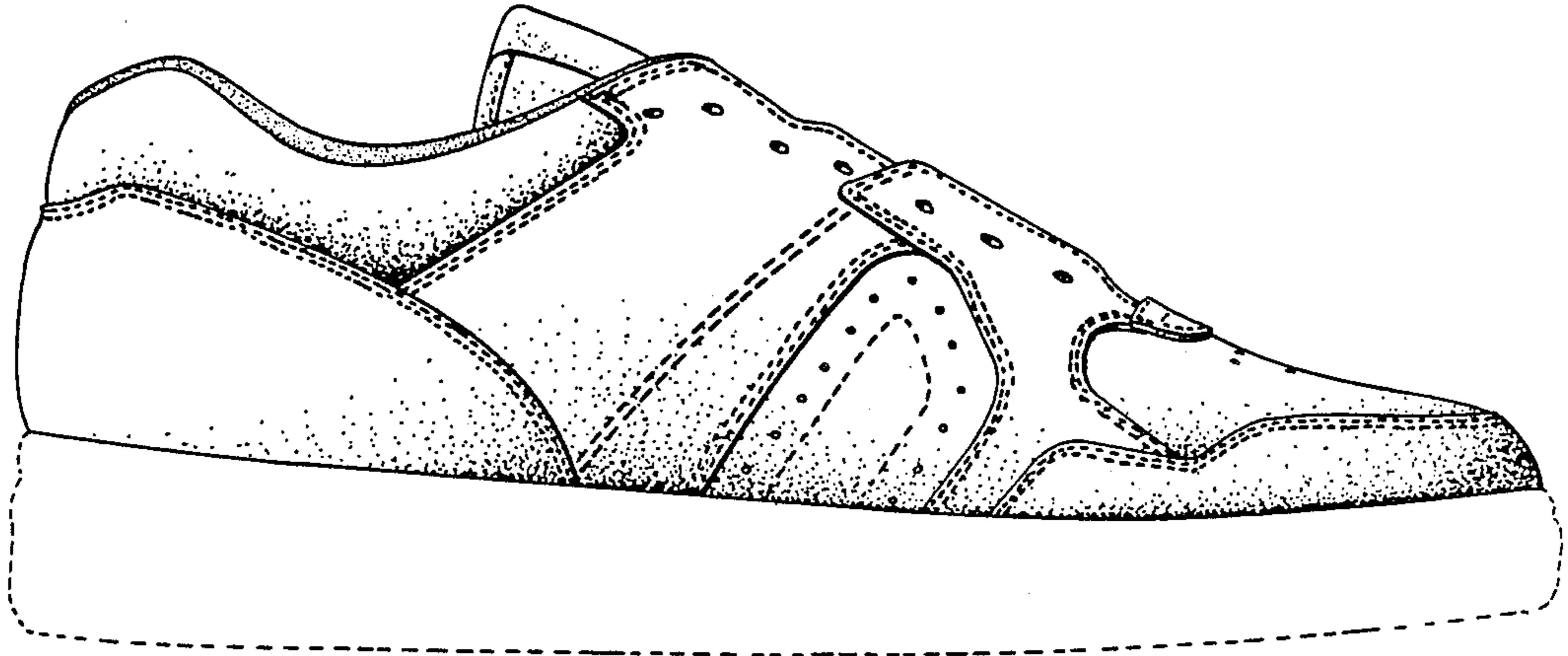

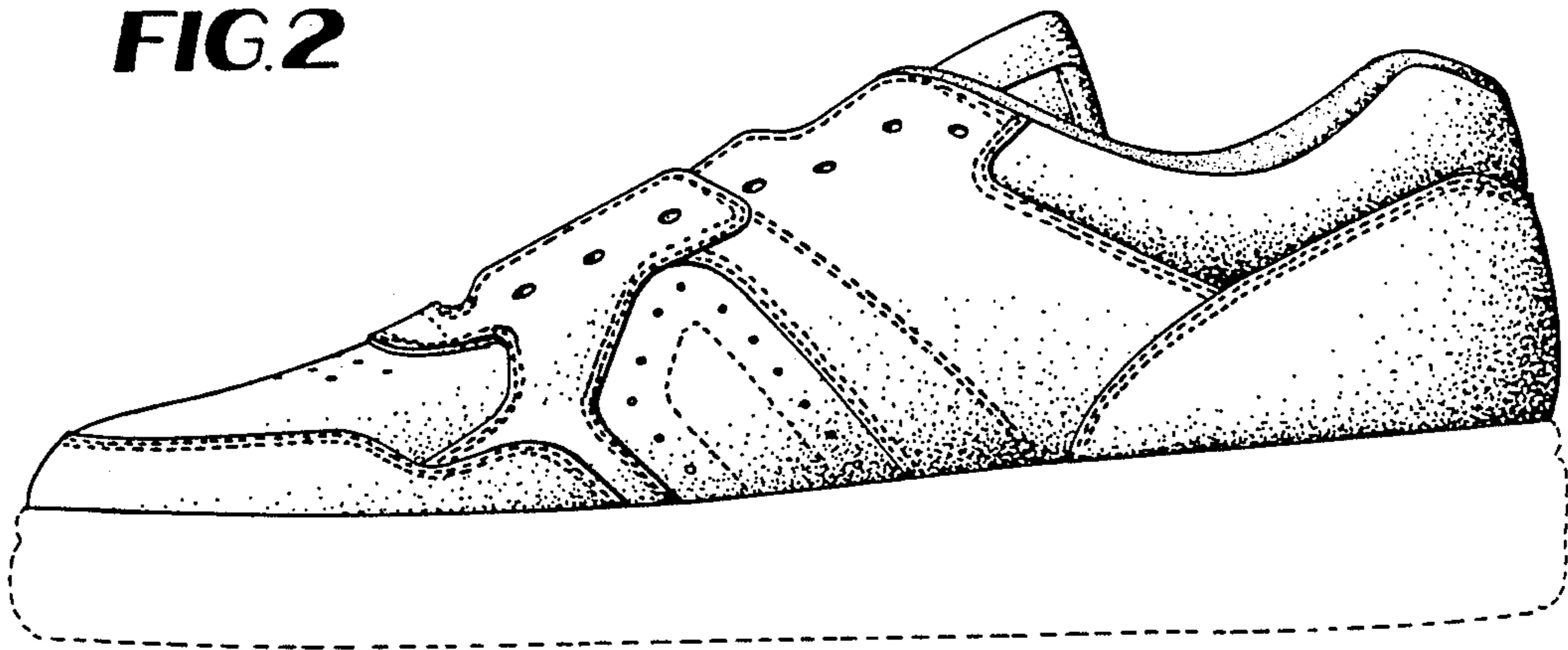

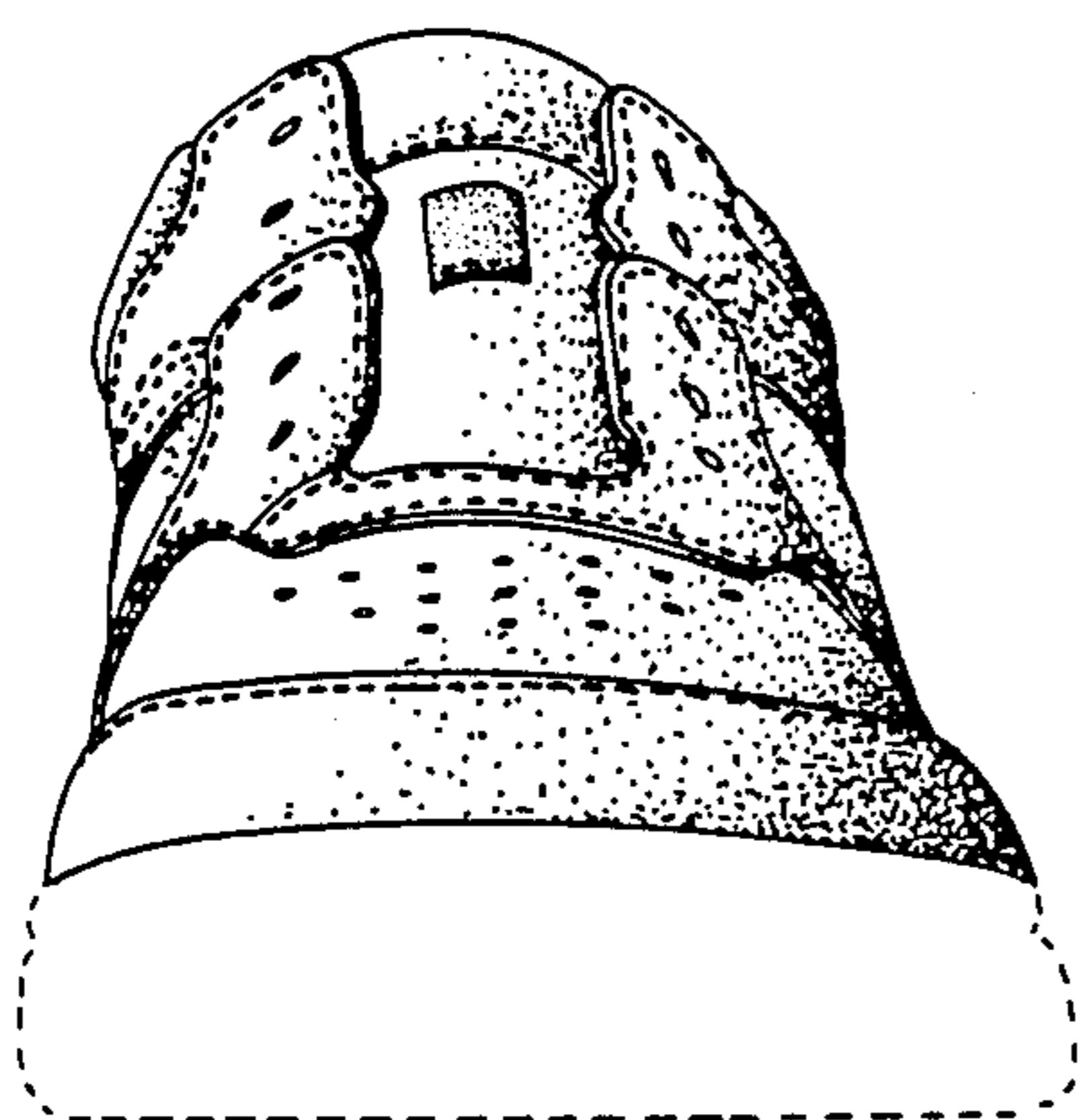
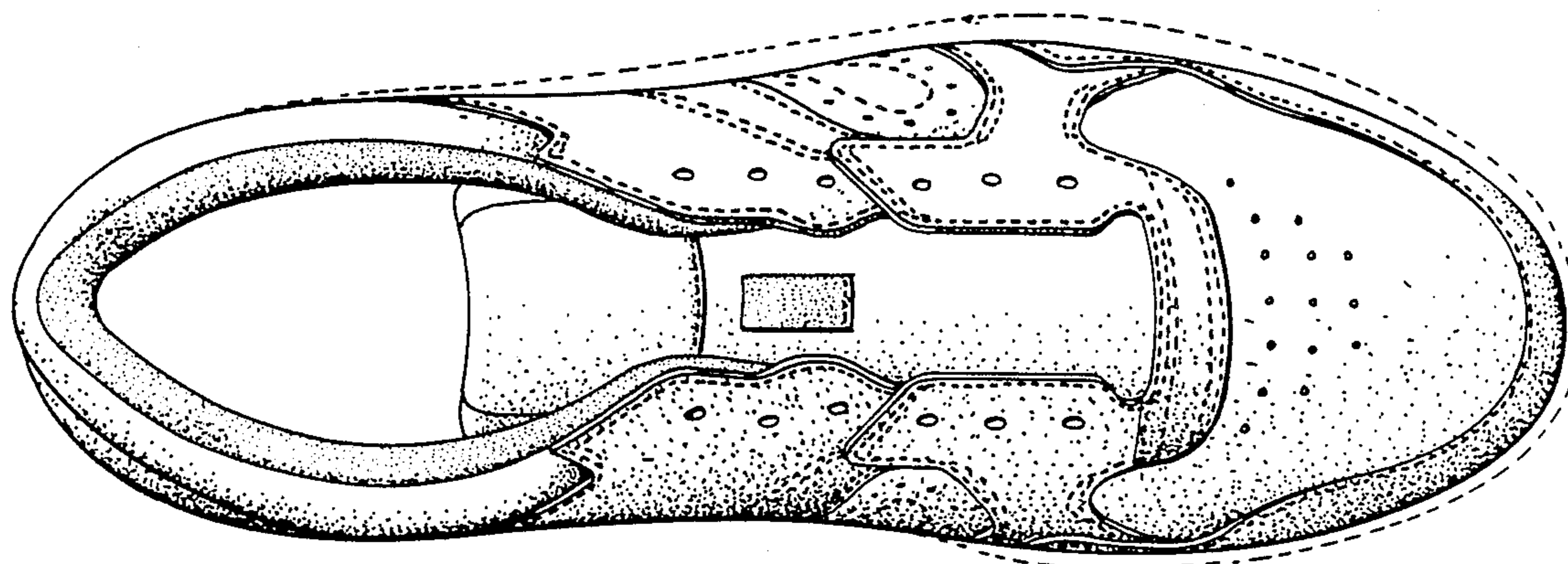

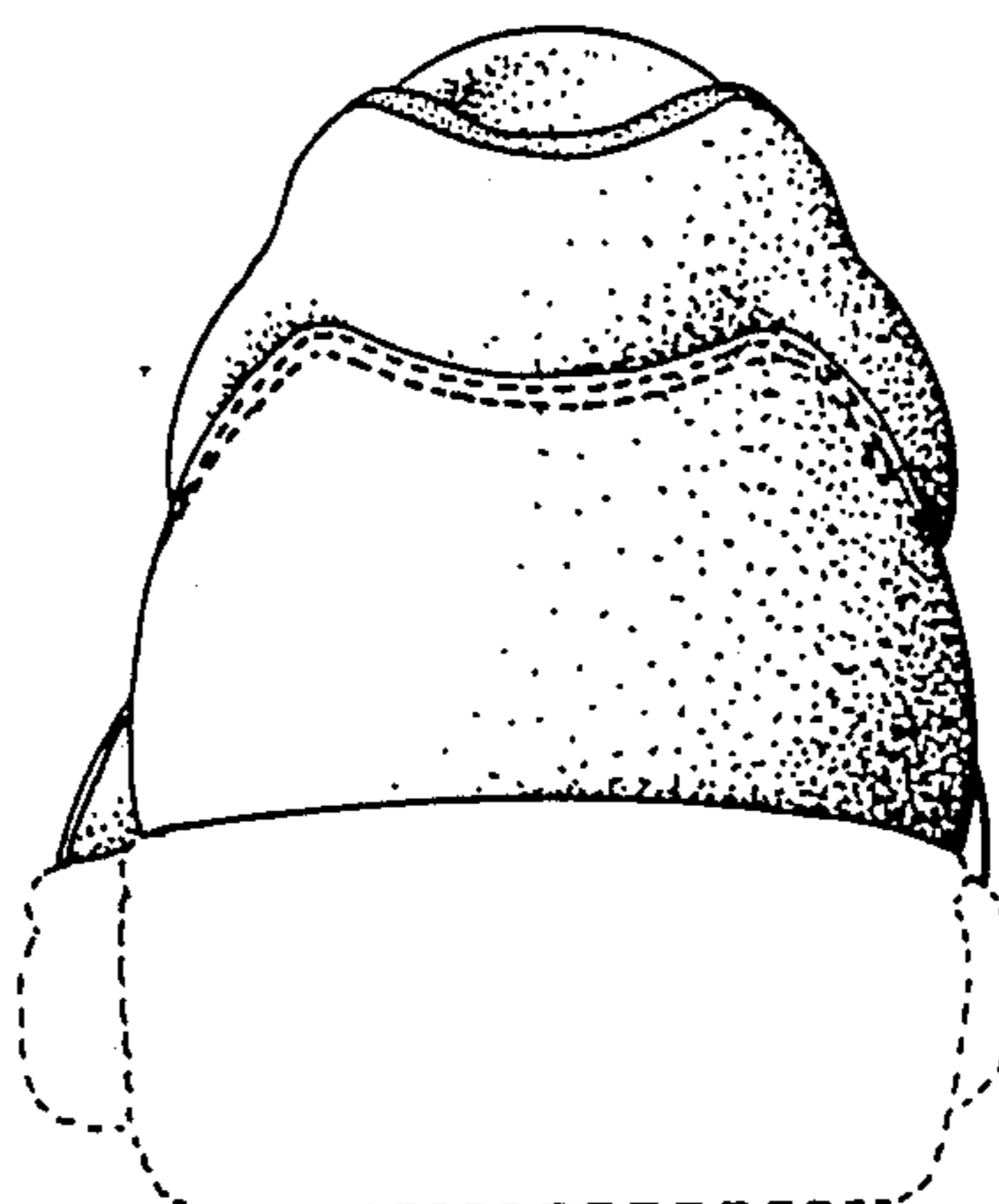

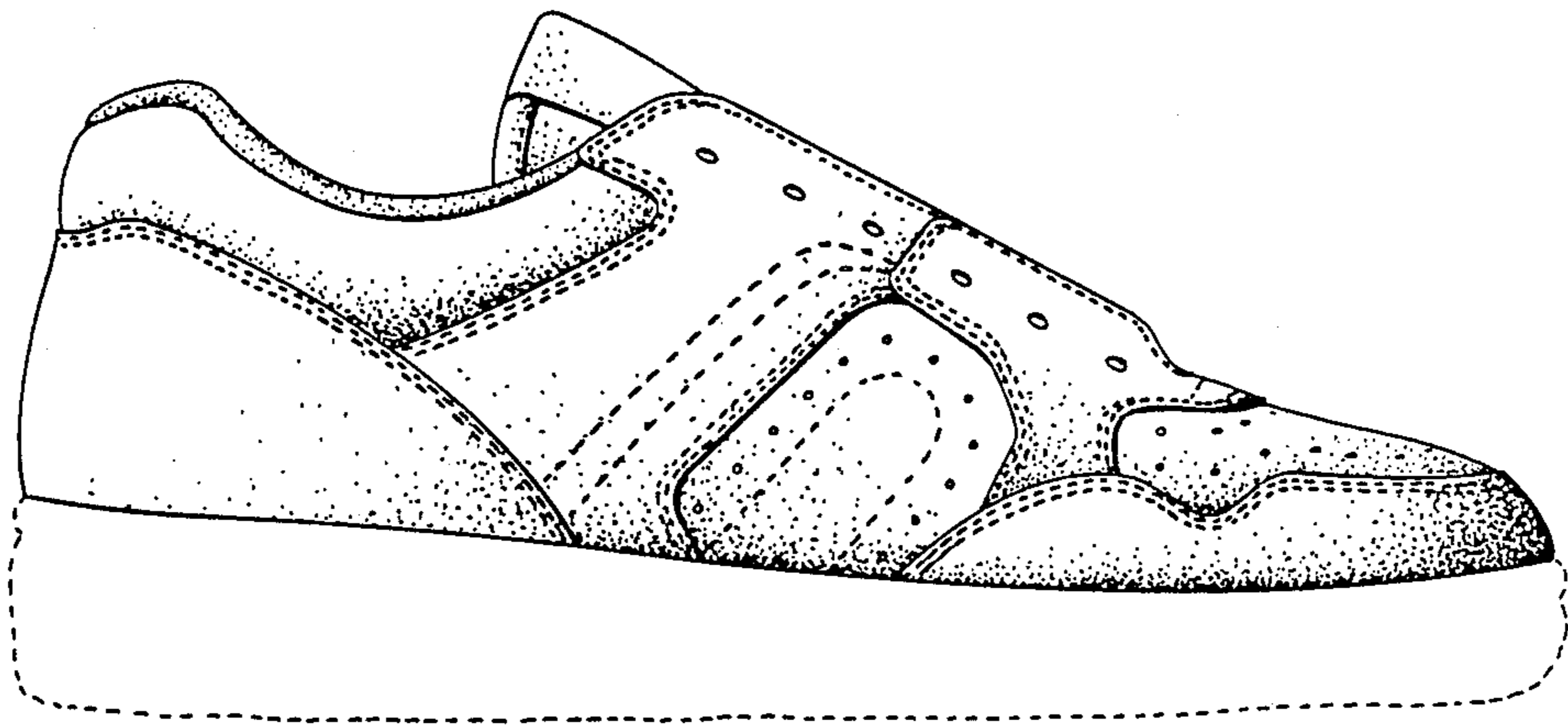

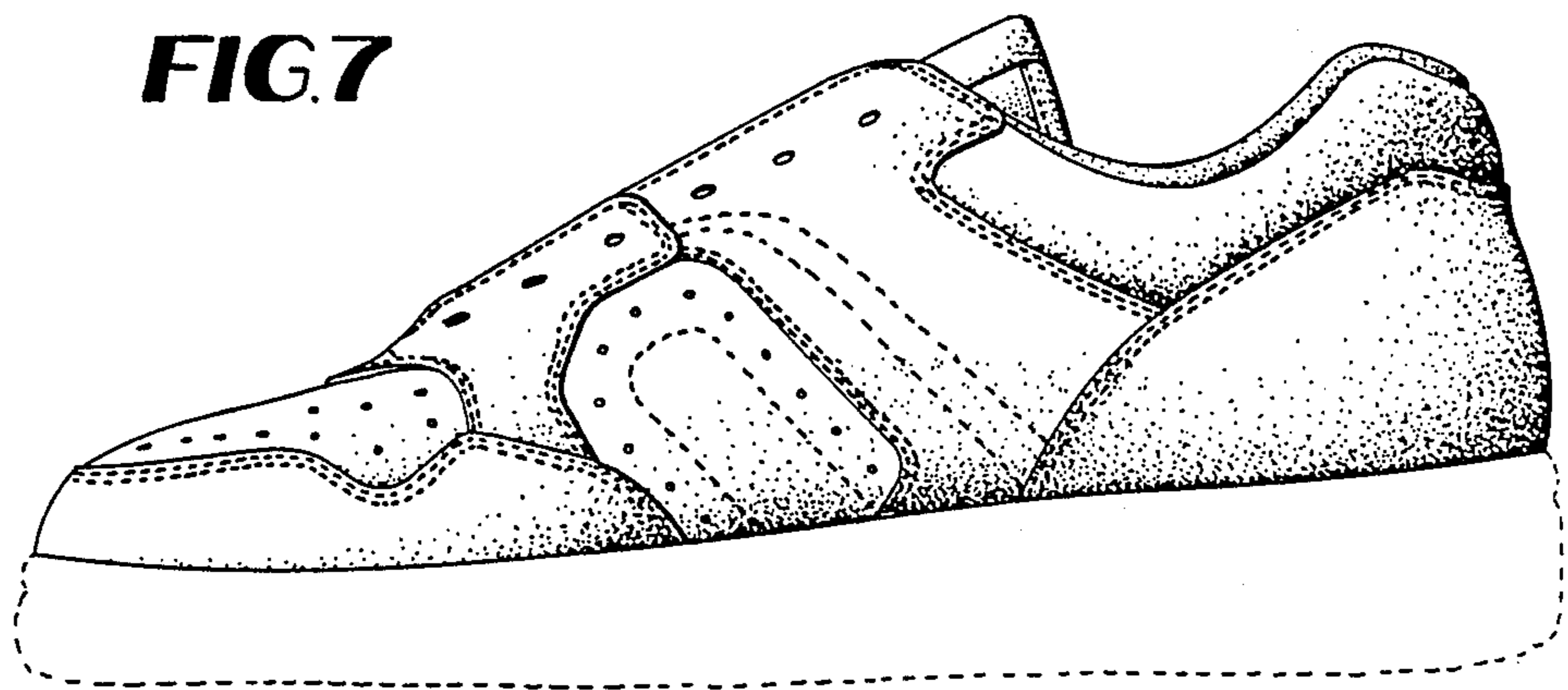

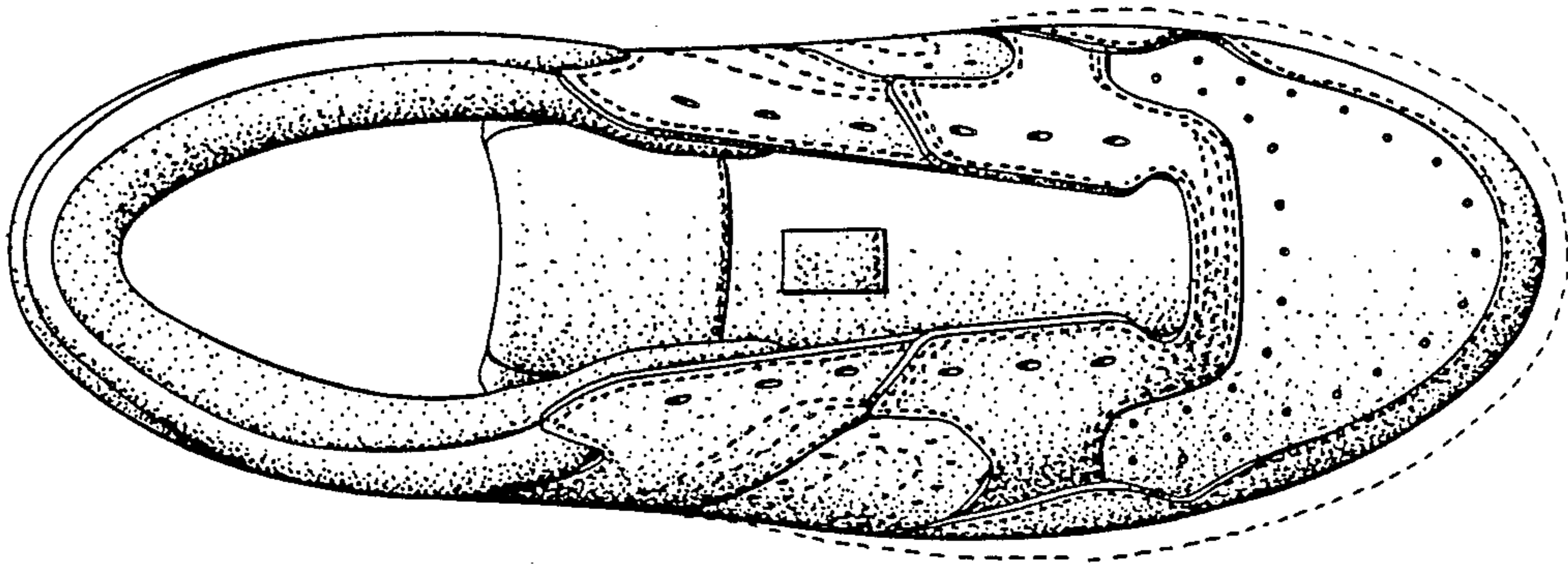

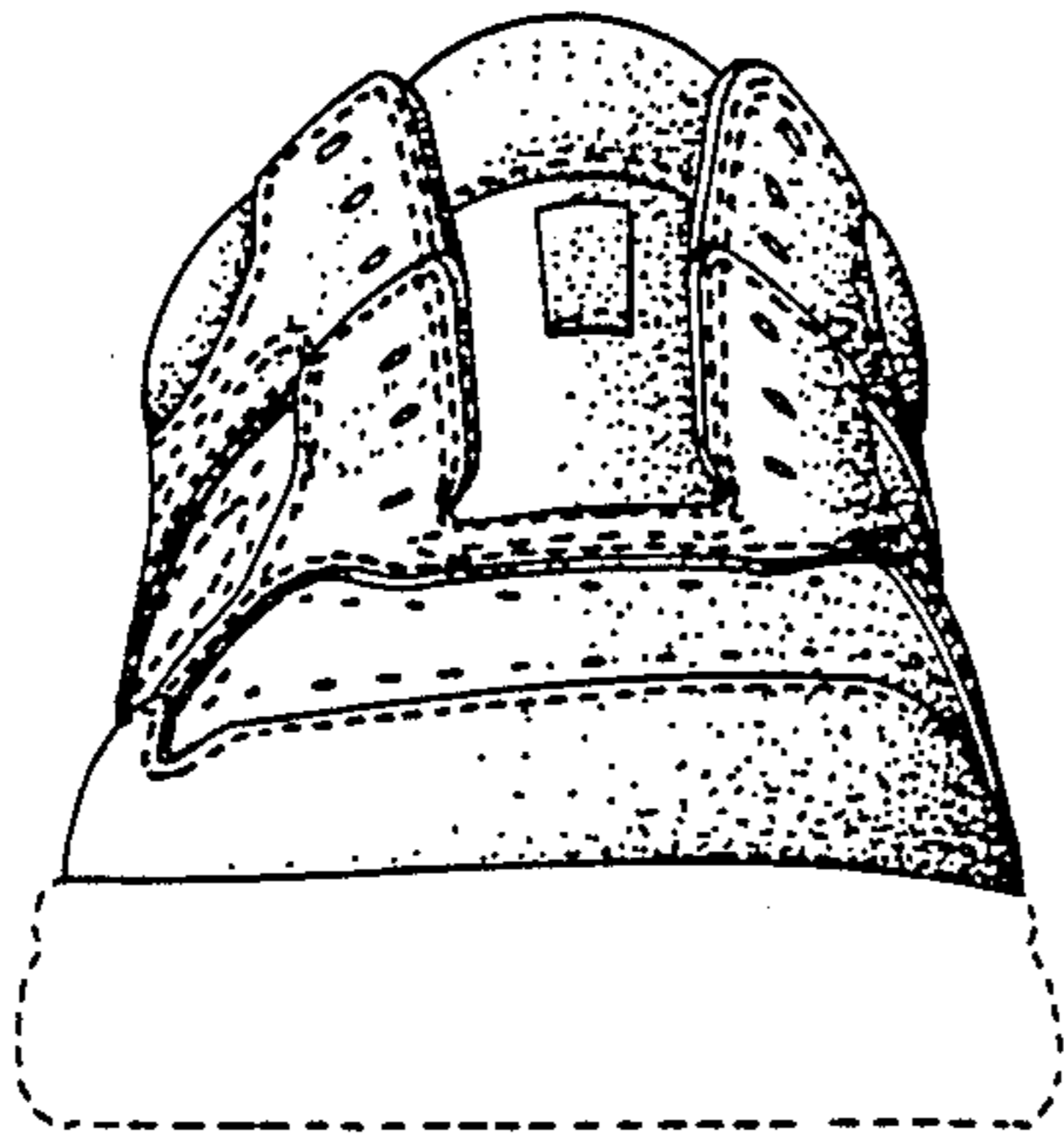
