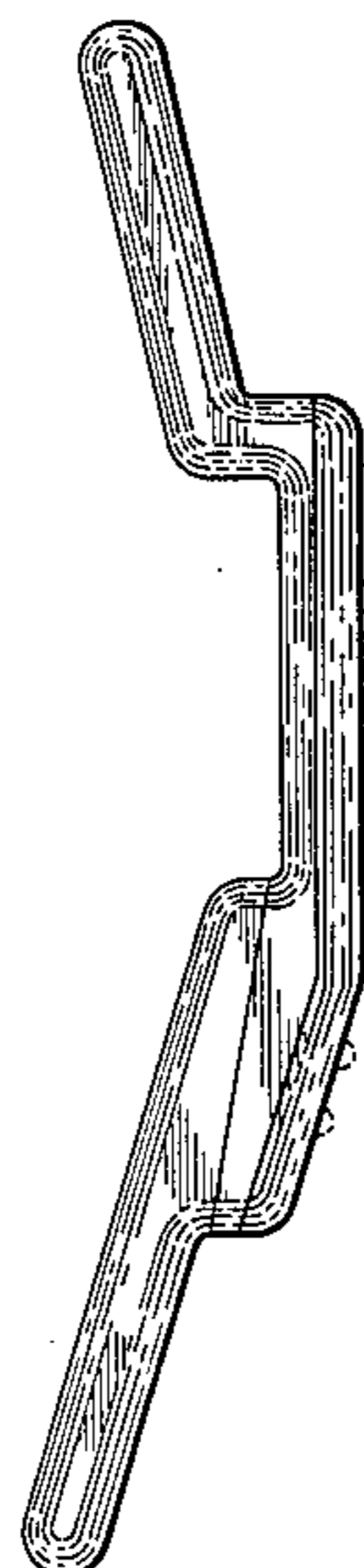
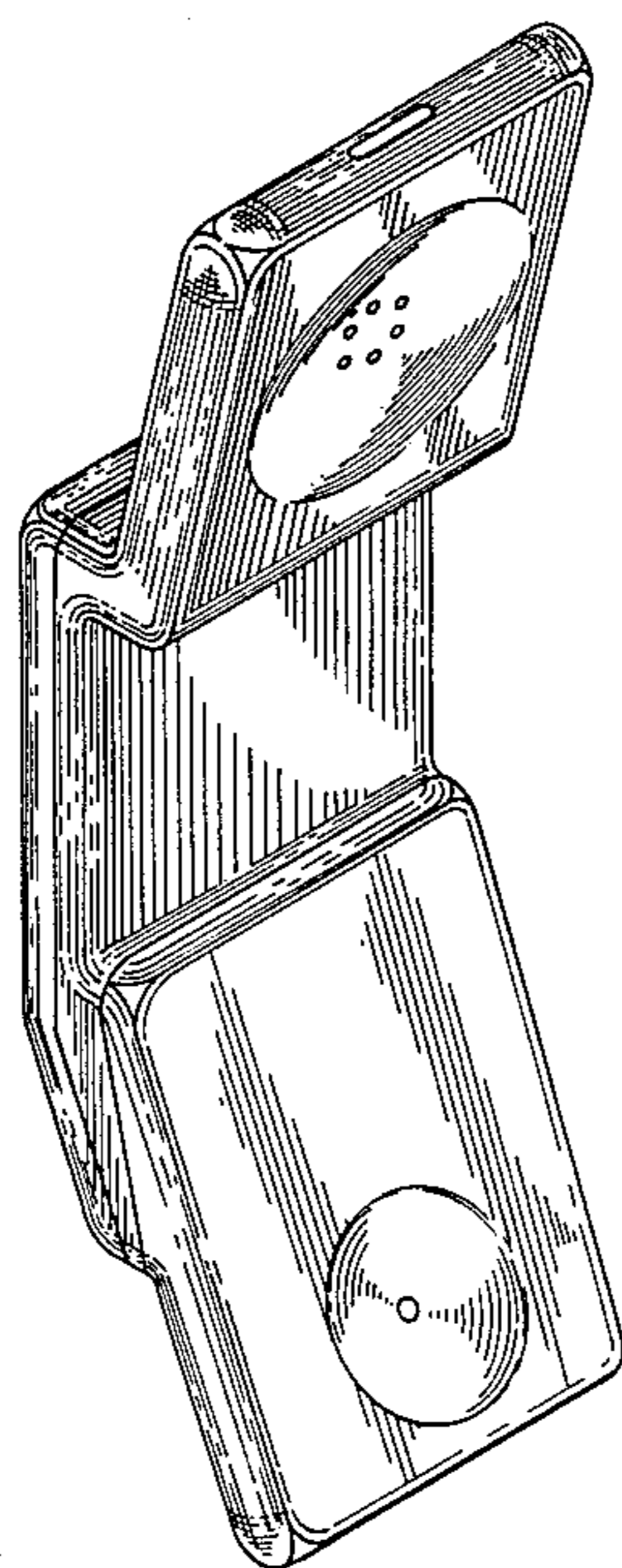

[57] **CLAIM**

The ornamental design for a housing for a portable handset telephone or similar article, as shown and described.

DESCRIPTION

FIG. 1 is a front, top and left side perspective view of housing for a portable handset telephone or similar article showing our new design; FIG. 2 is a right side elevational view thereof, the side opposite being a mirror image; FIG. 3 is rear elevational view thereof; and FIGS. 4 and 5 are respectively top and bottom plan views thereof. The broken line showing of environmental keyboard panel arrangements in FIGS. 3 and 2 is for illustrative purposes only and forms no part of the claimed design.



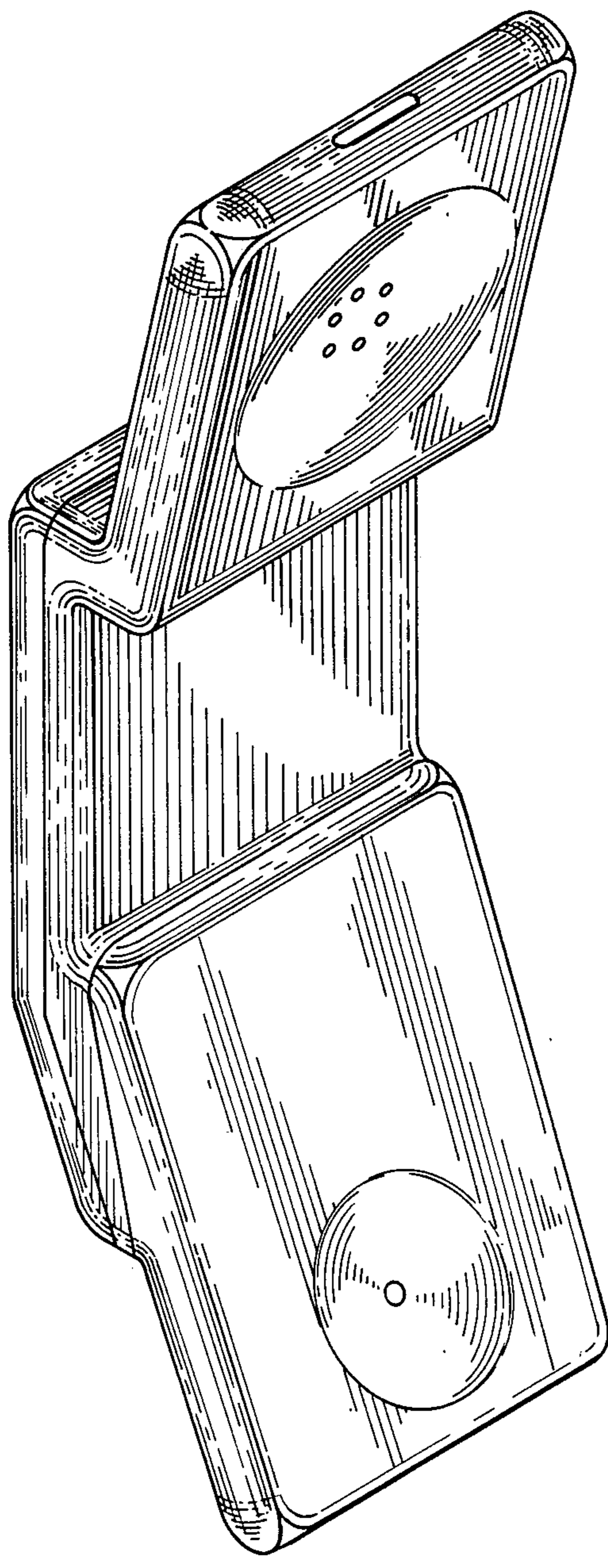

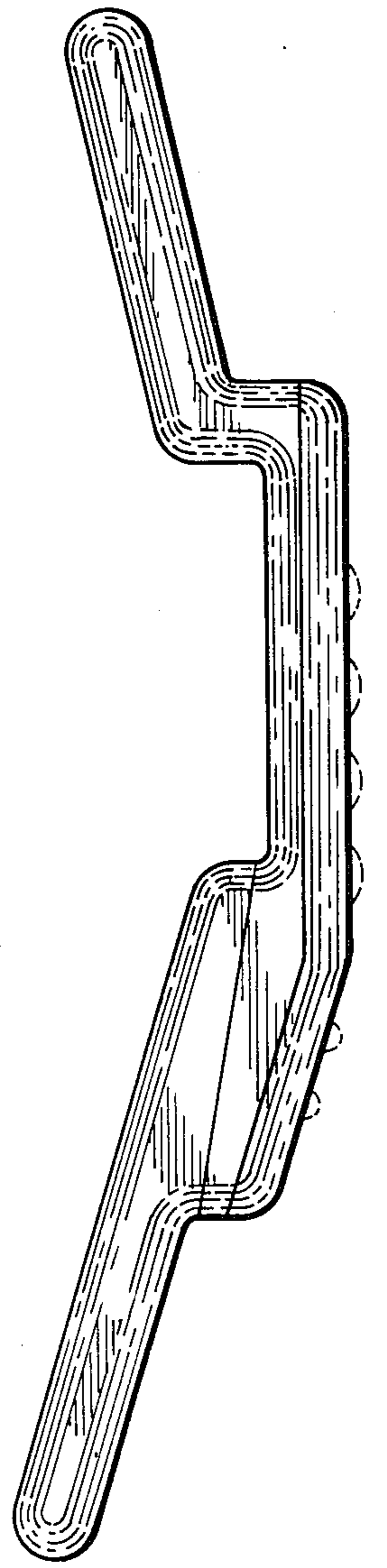

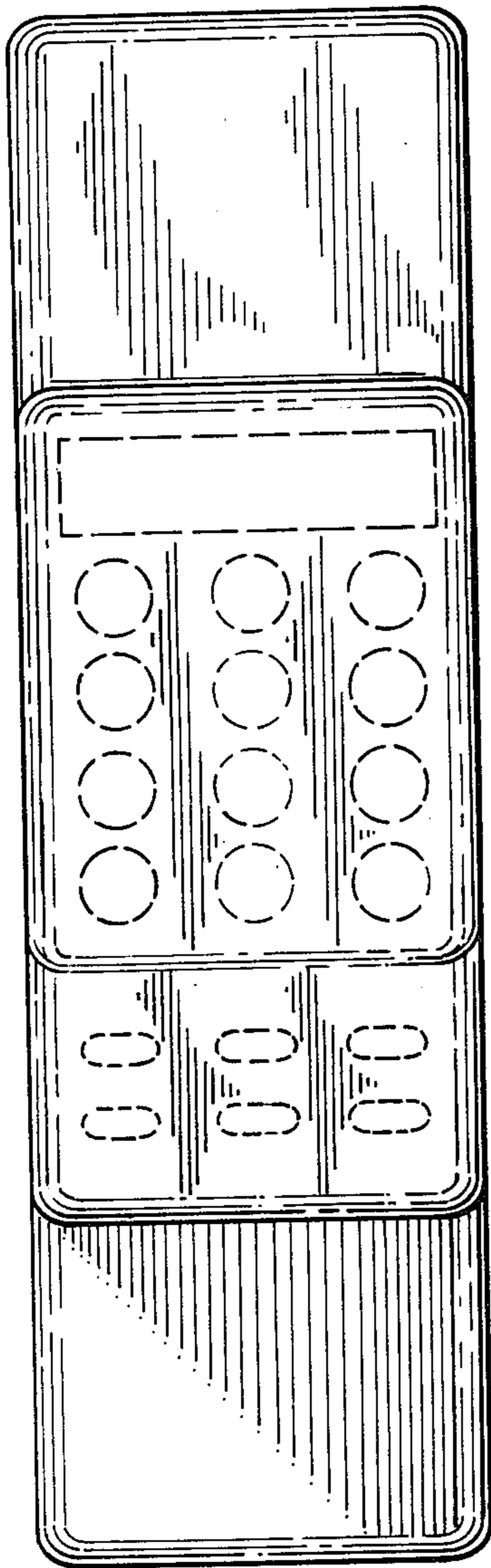

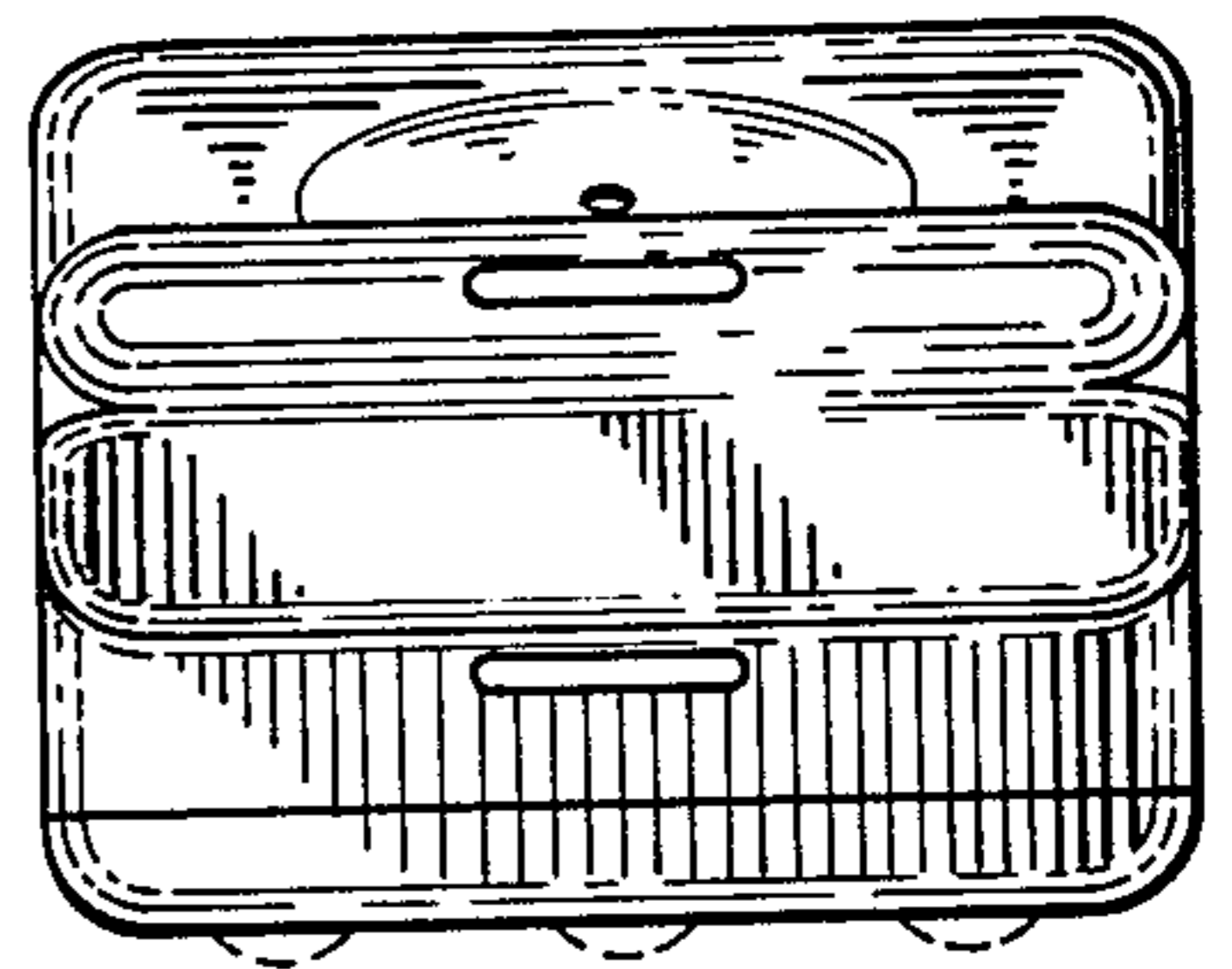
