FIG. 28 is a perspective view thereof.

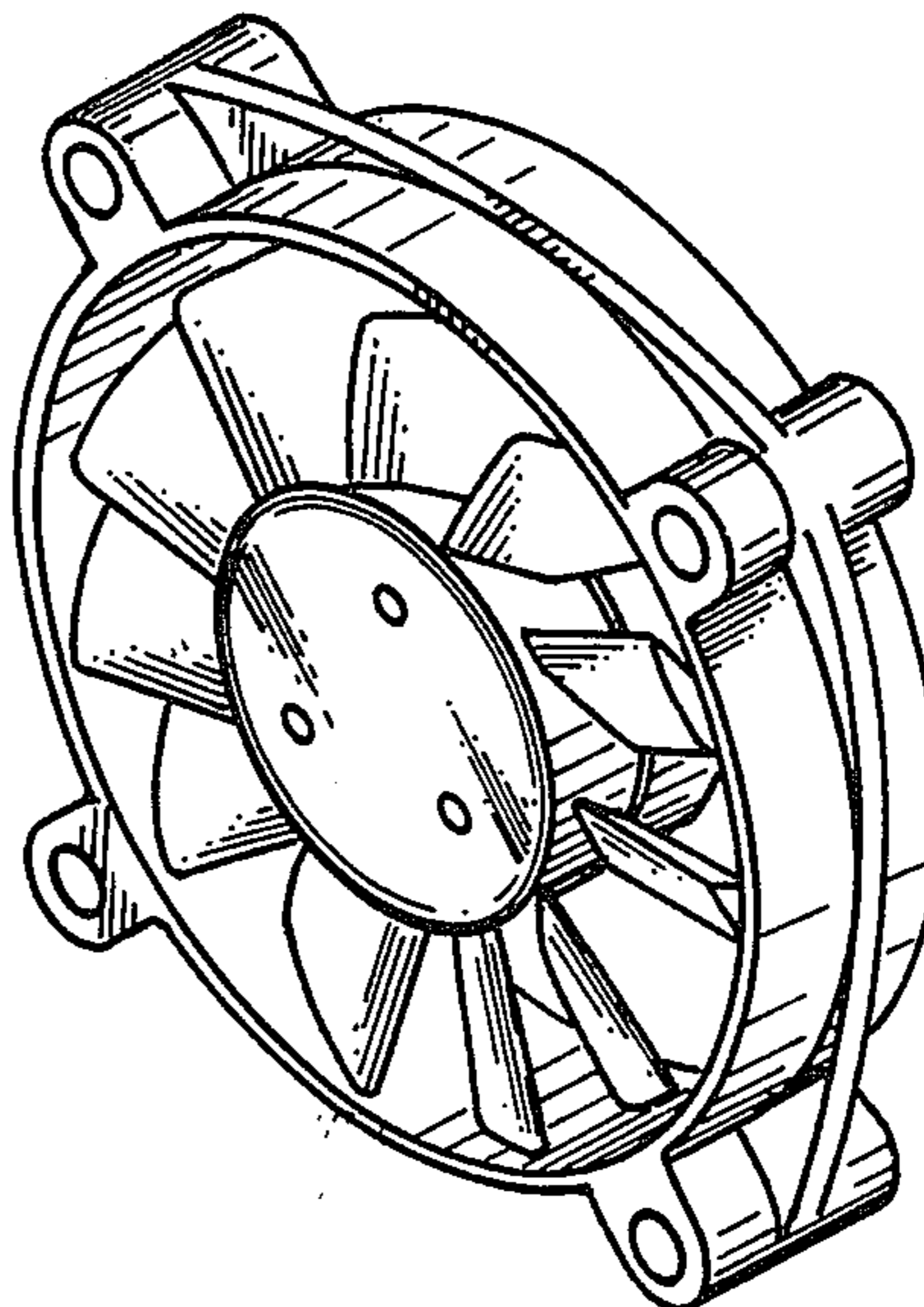
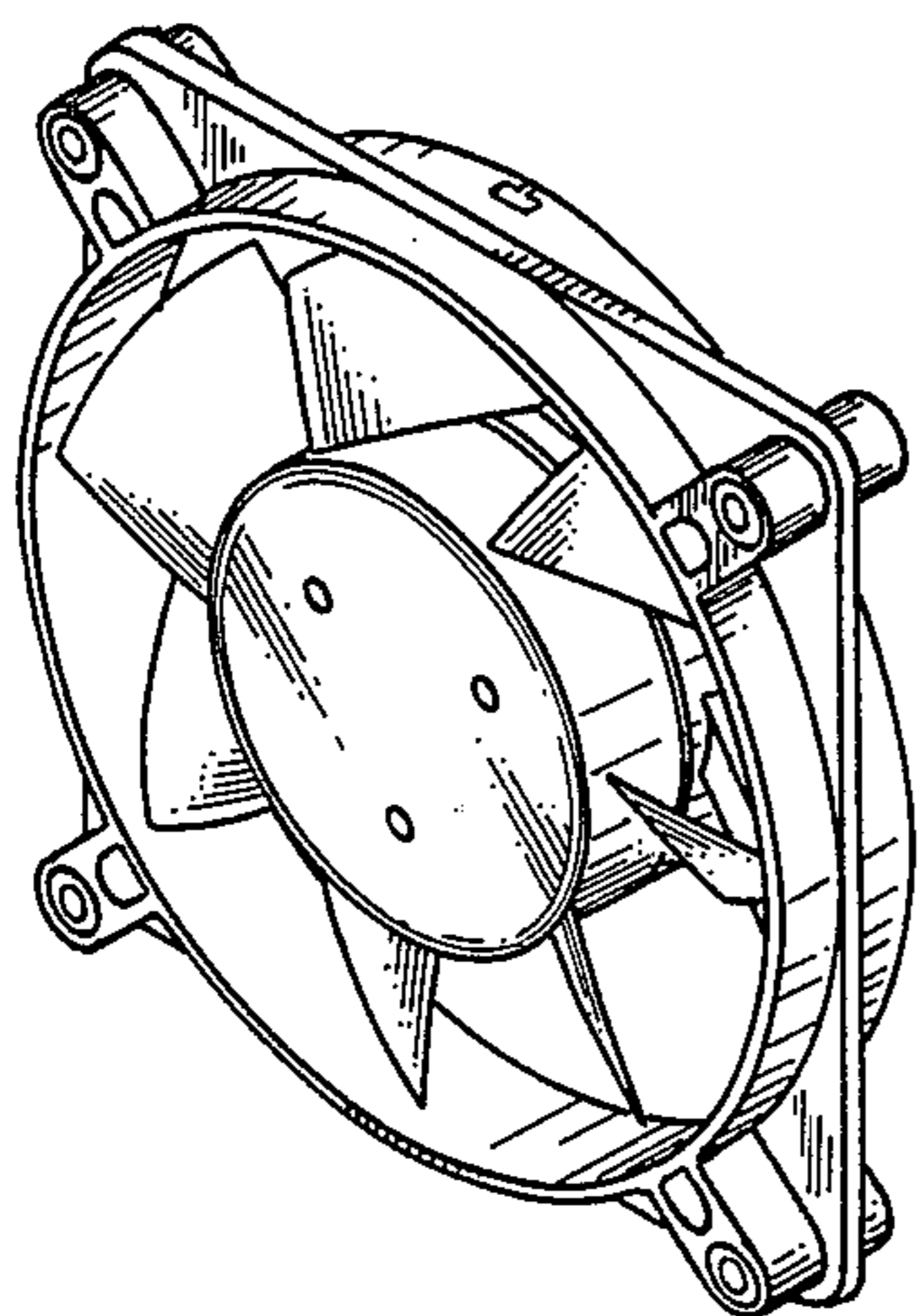

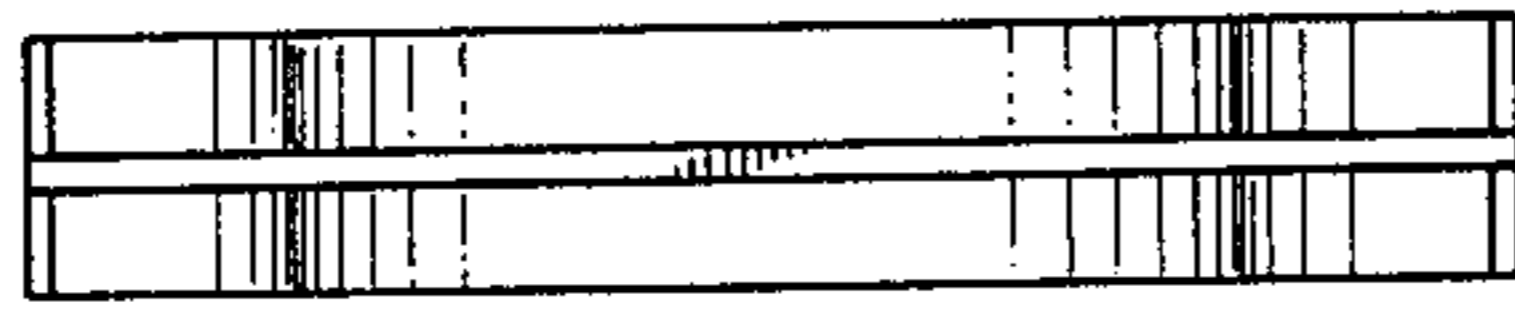

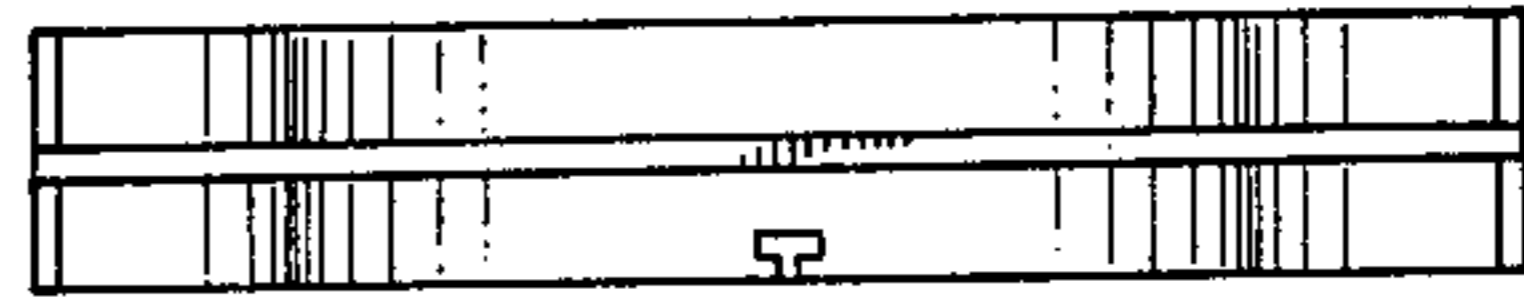

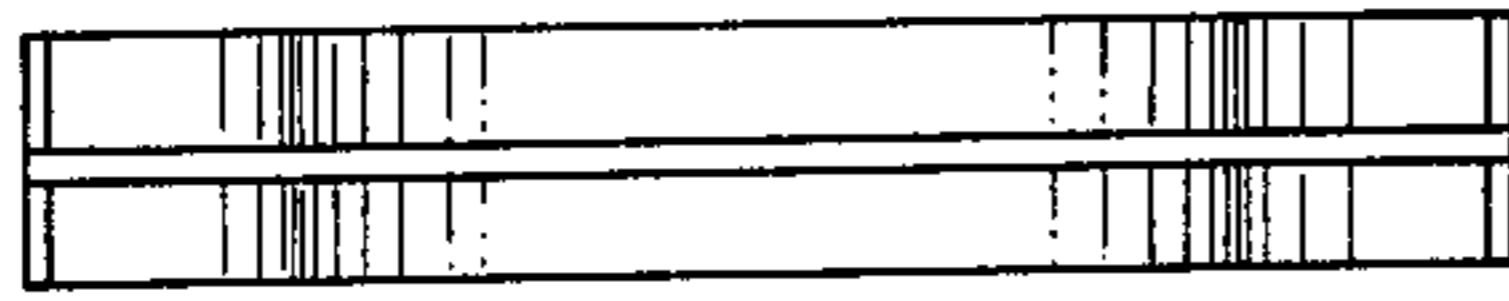

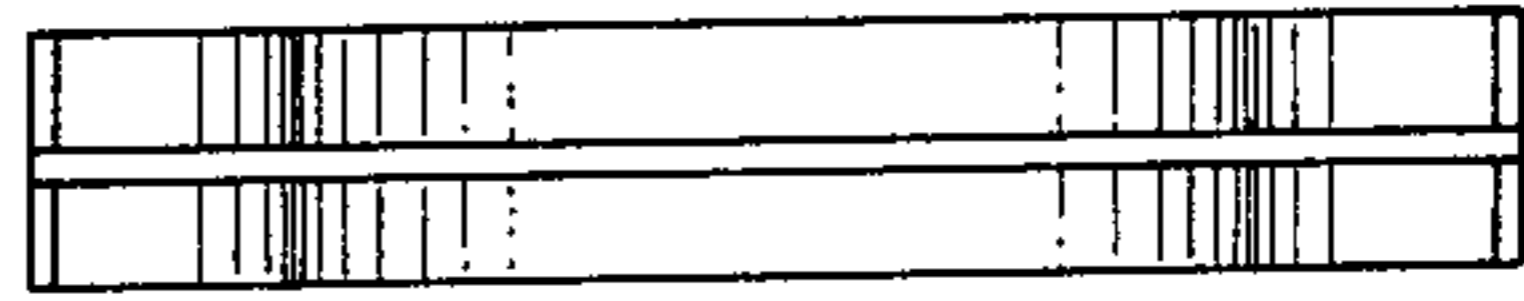

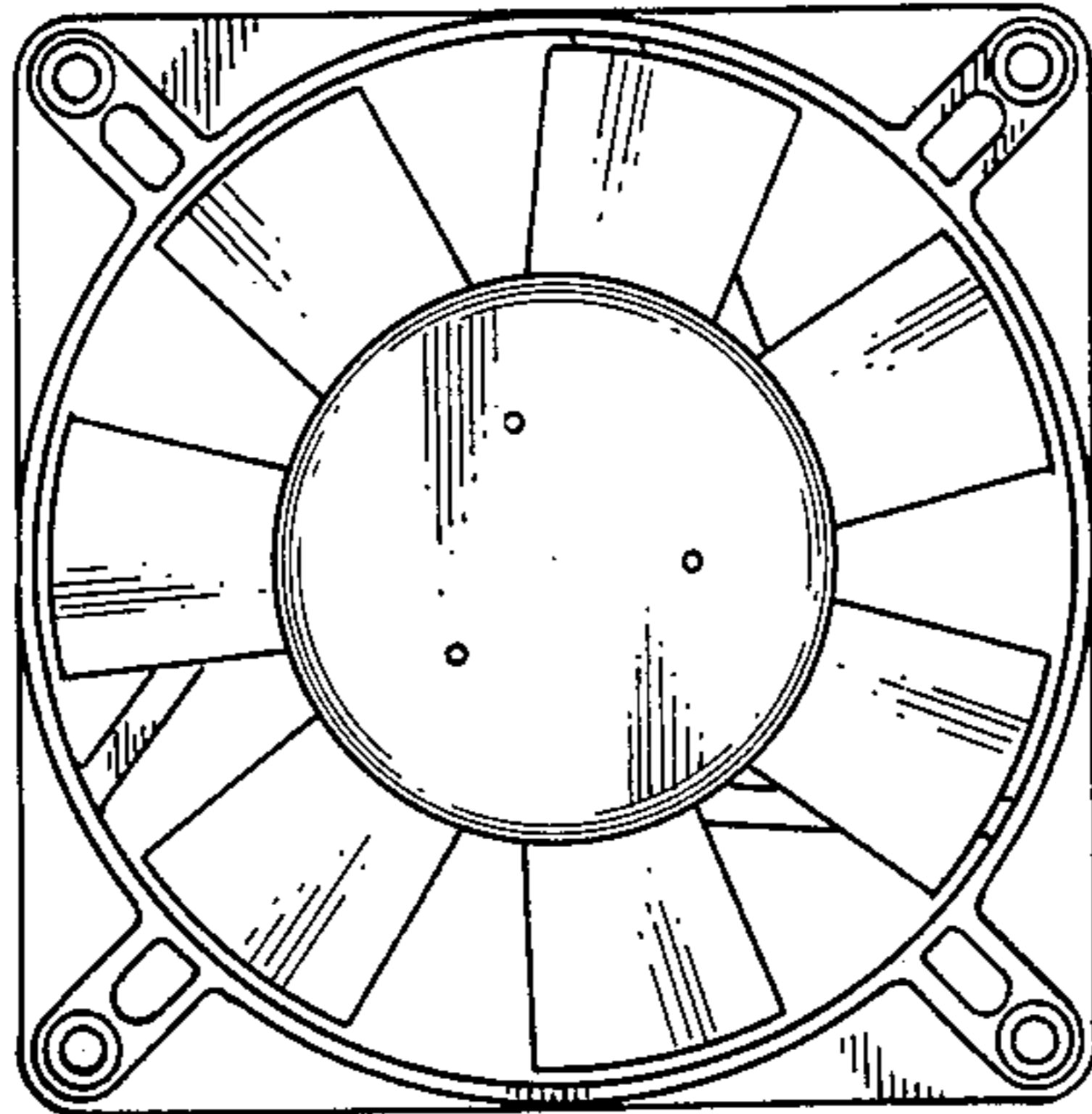

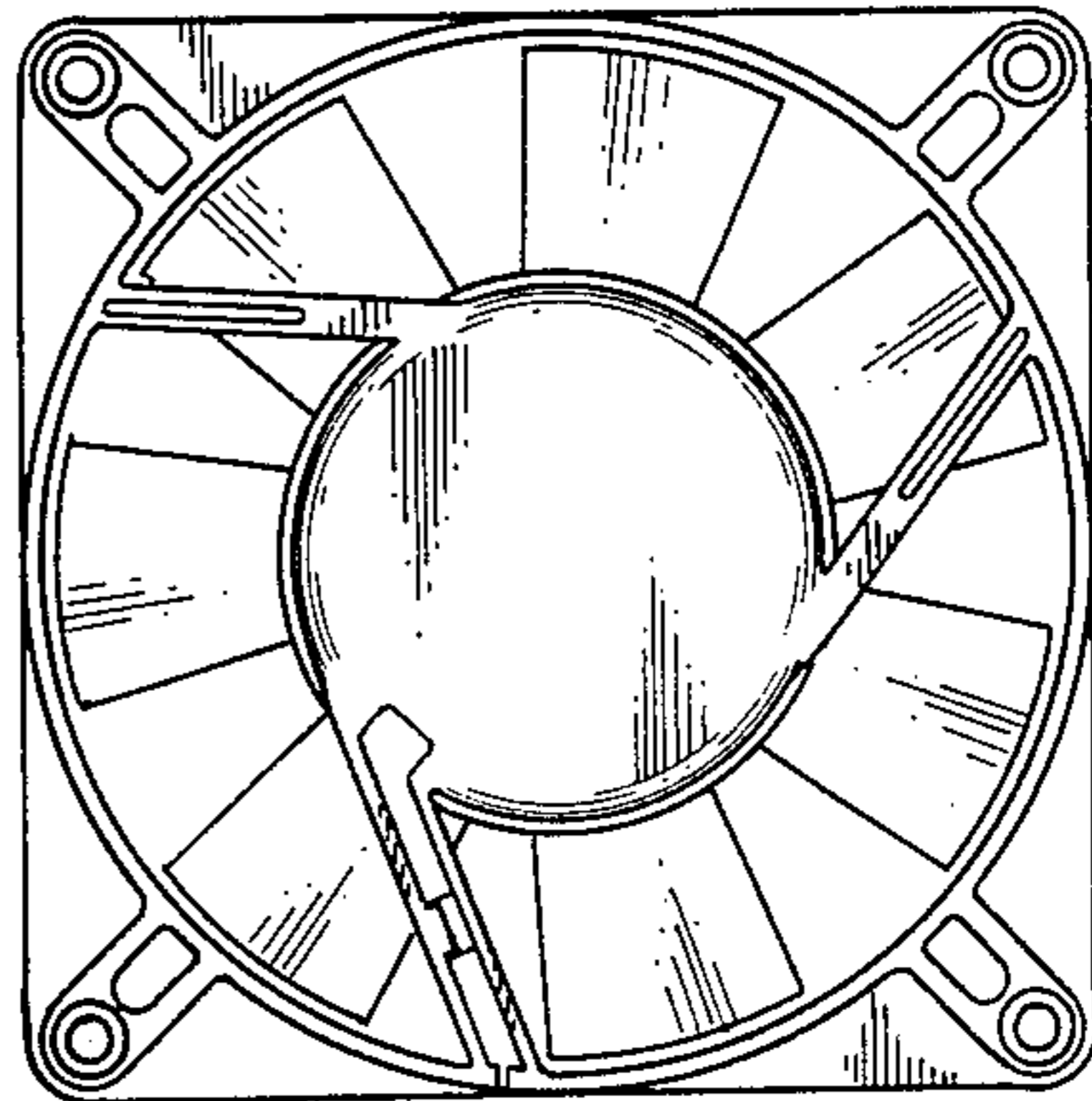

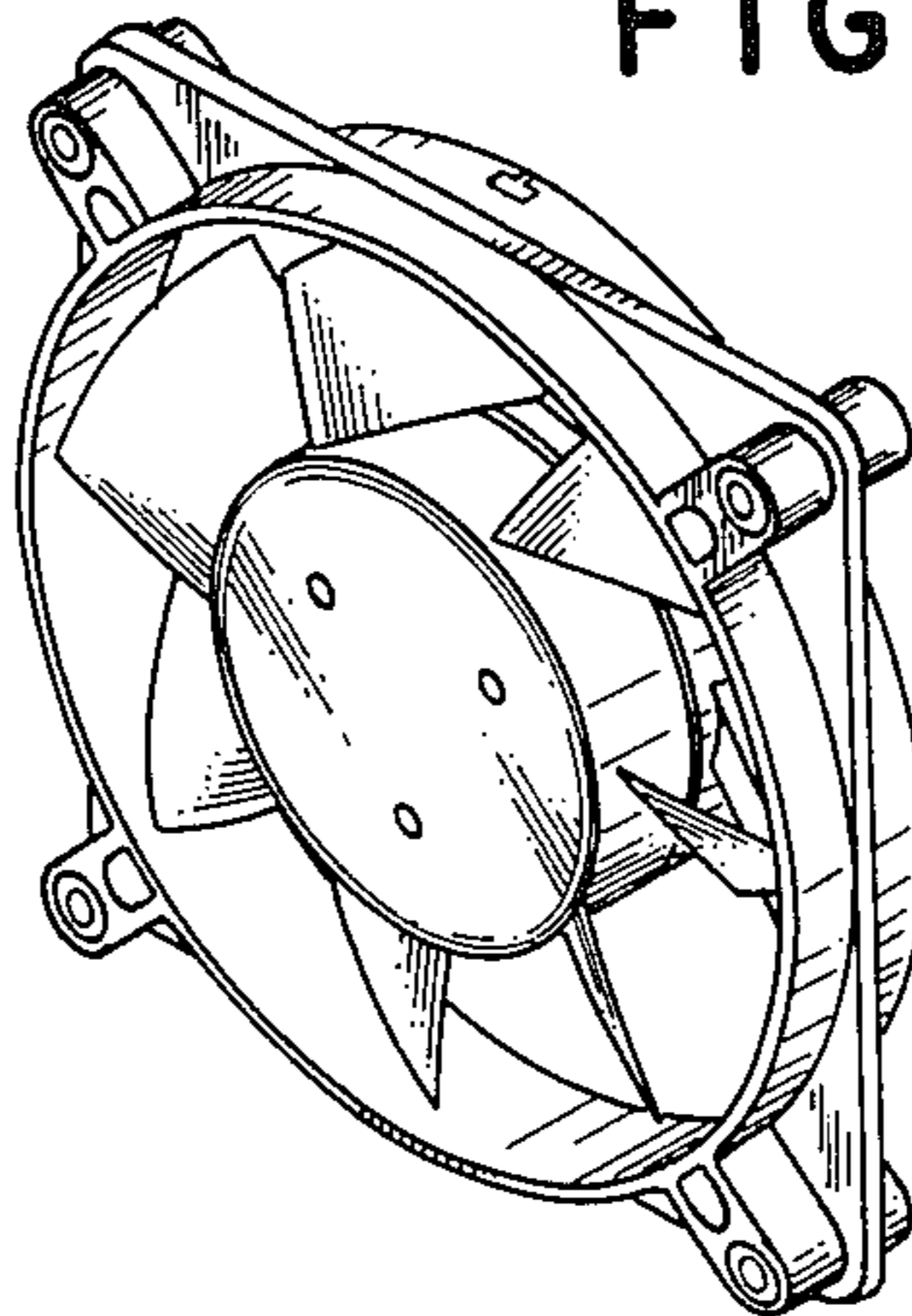

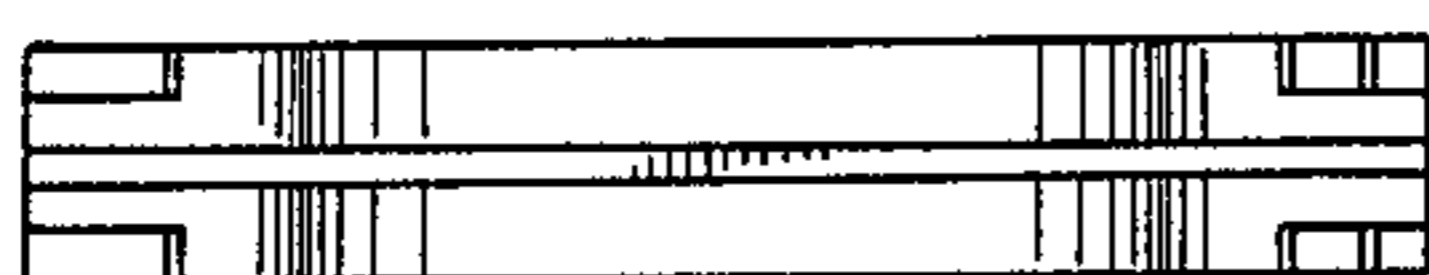

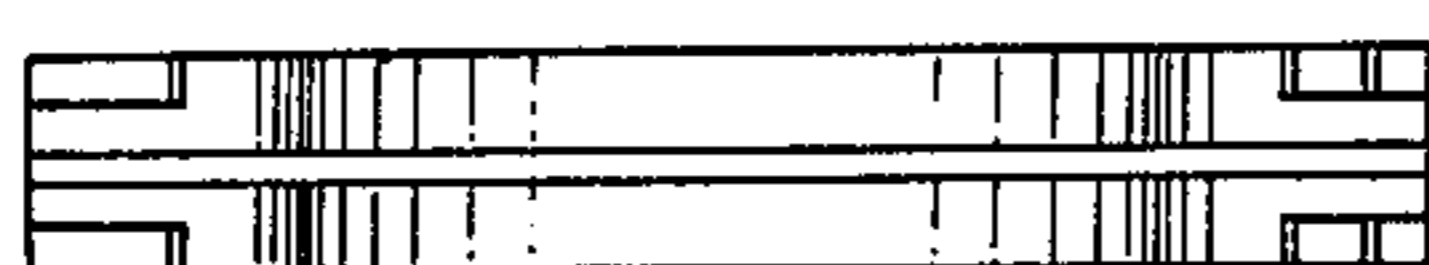

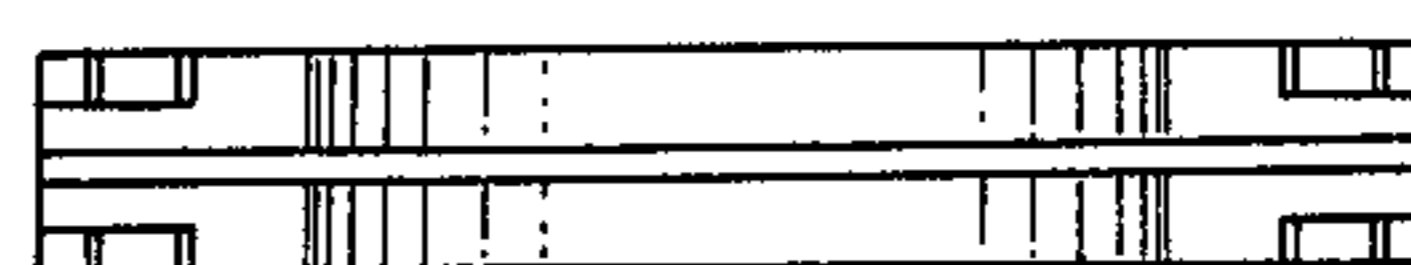

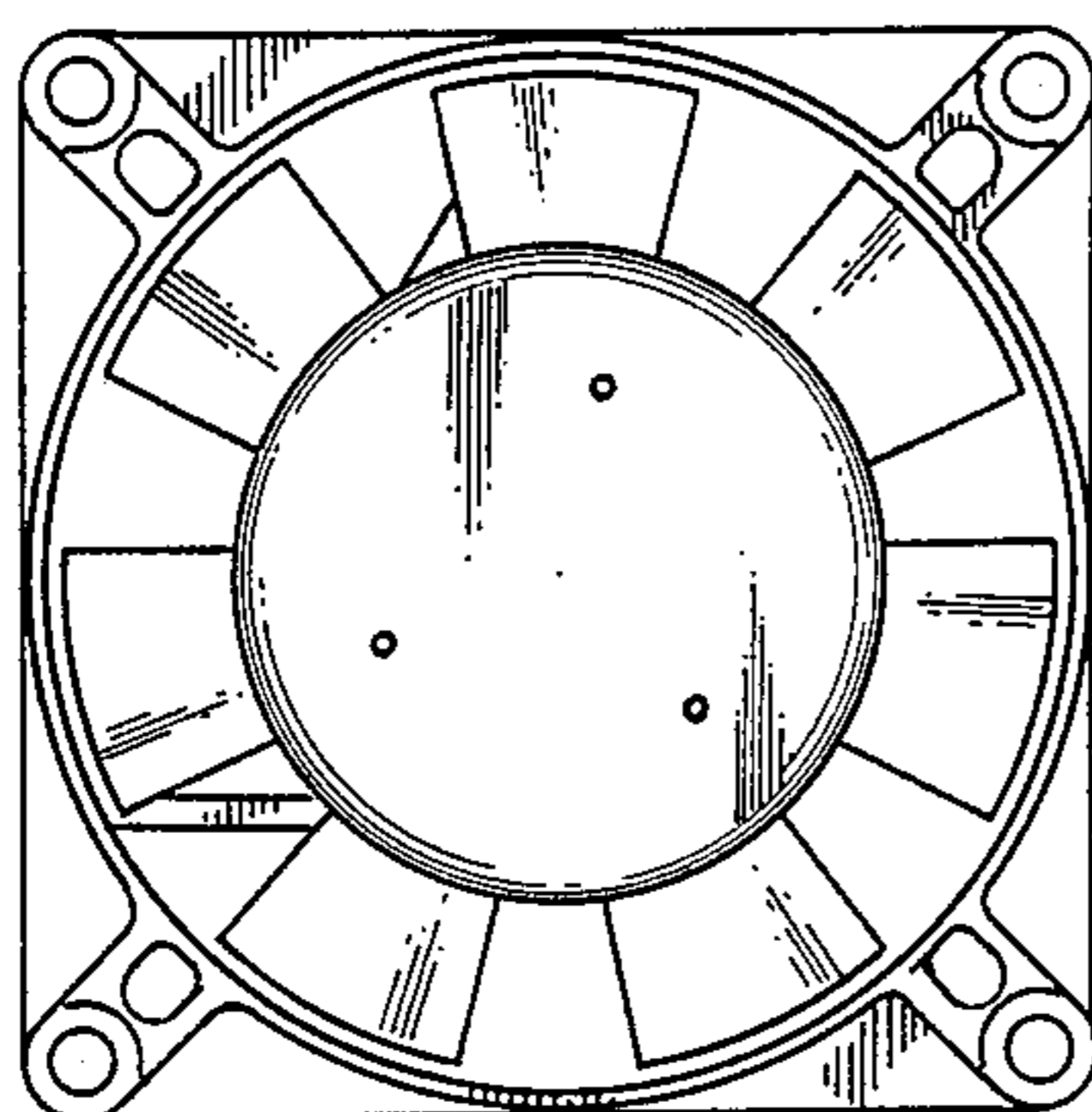

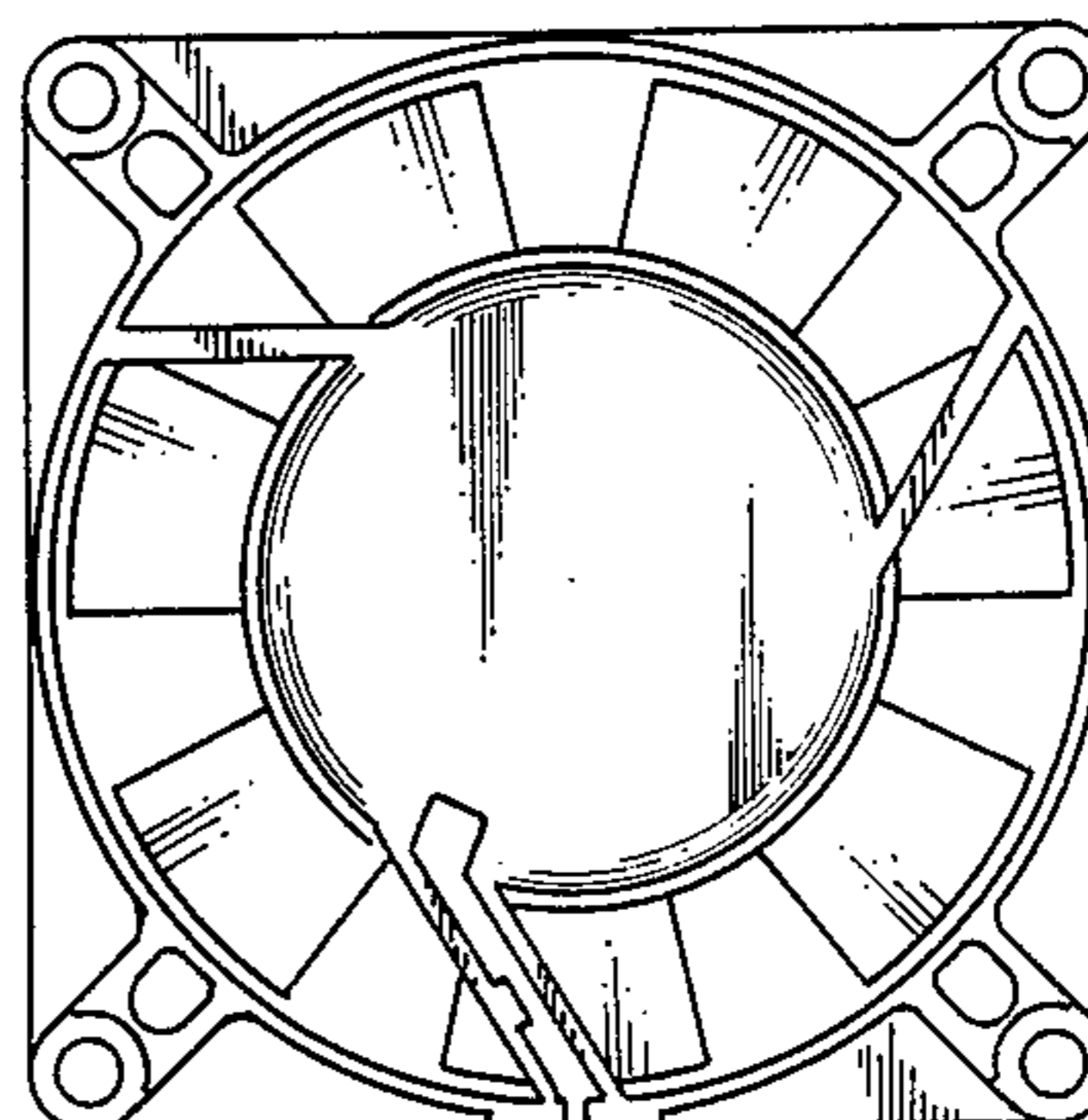

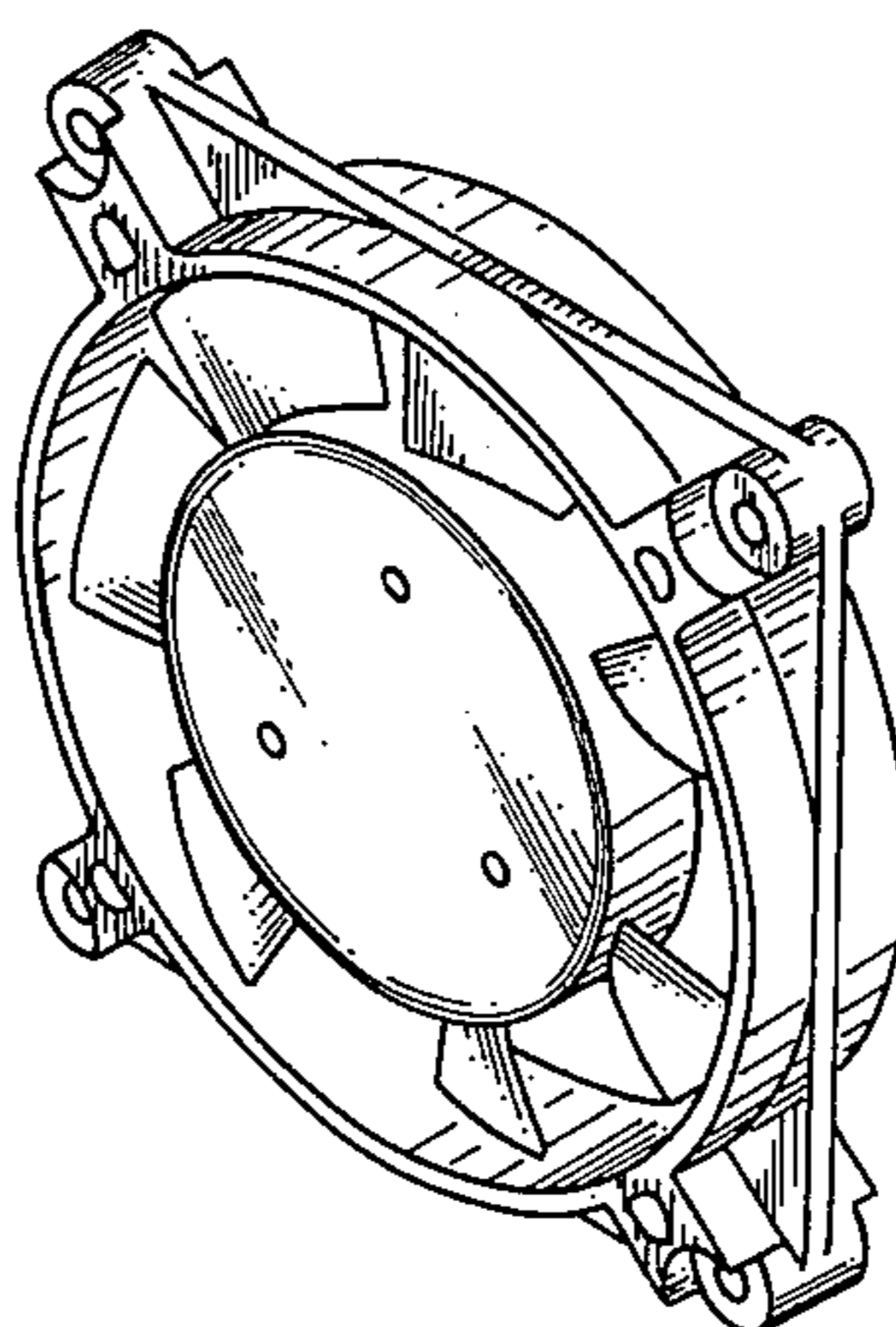

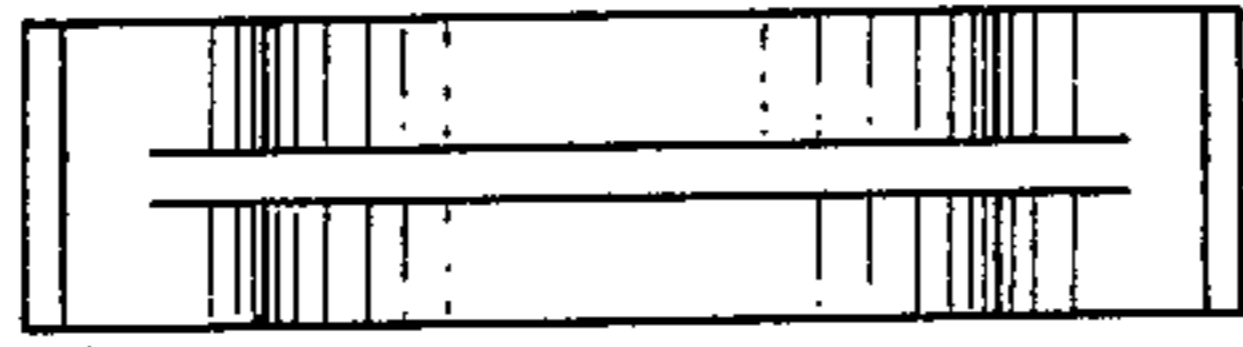

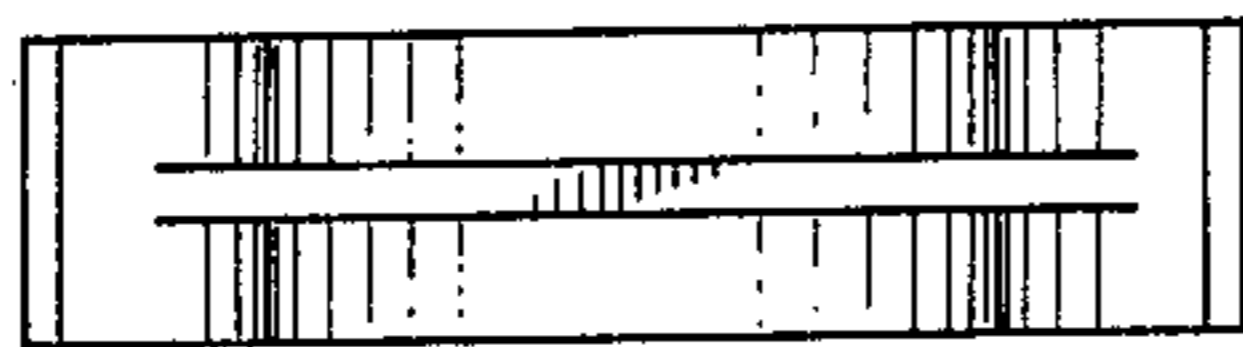

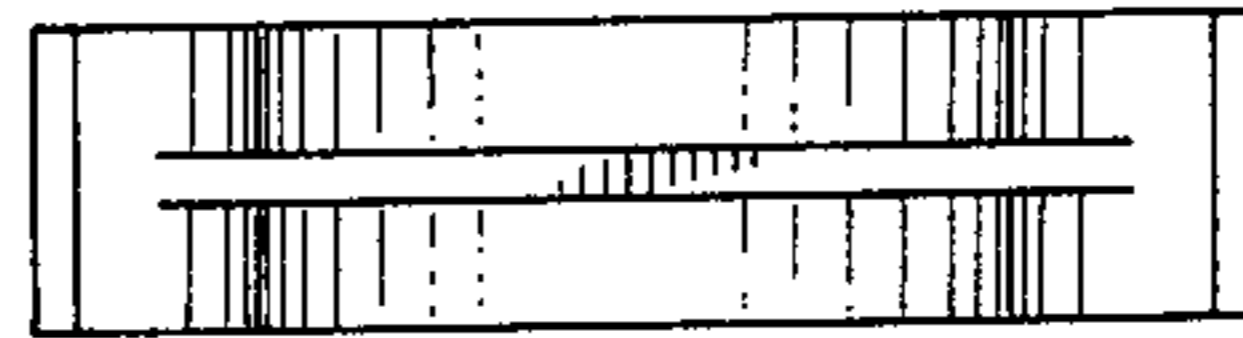

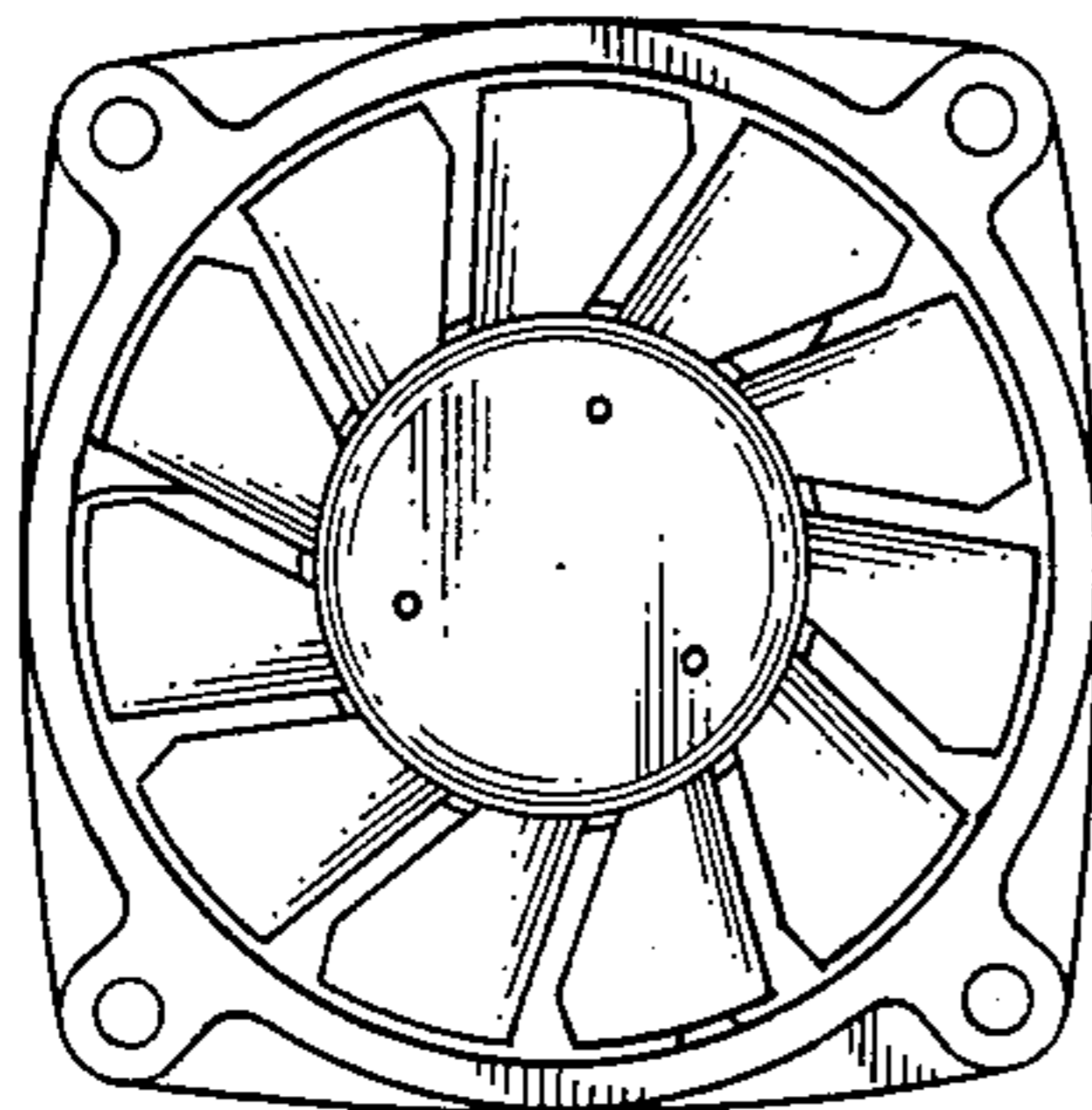

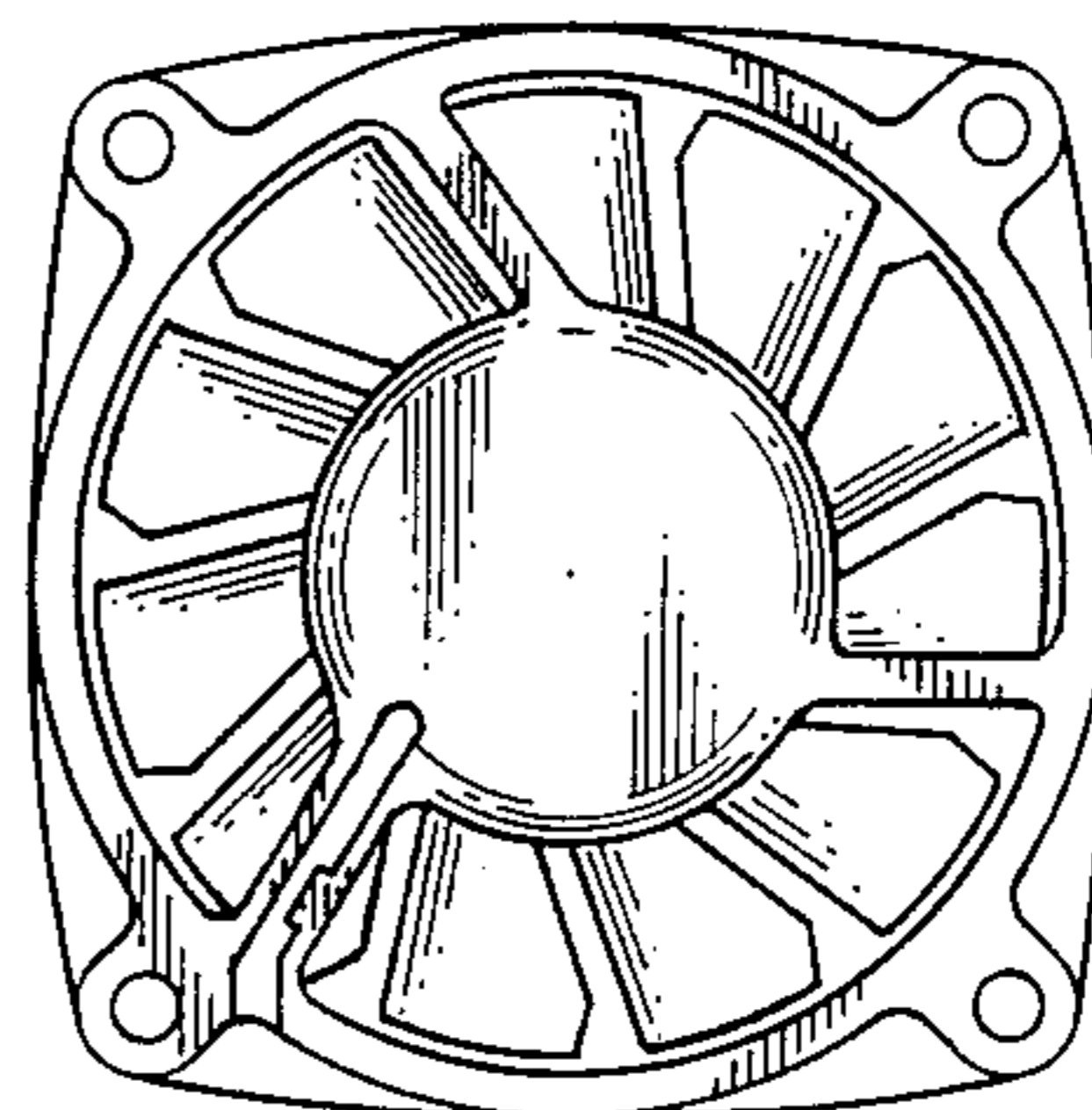

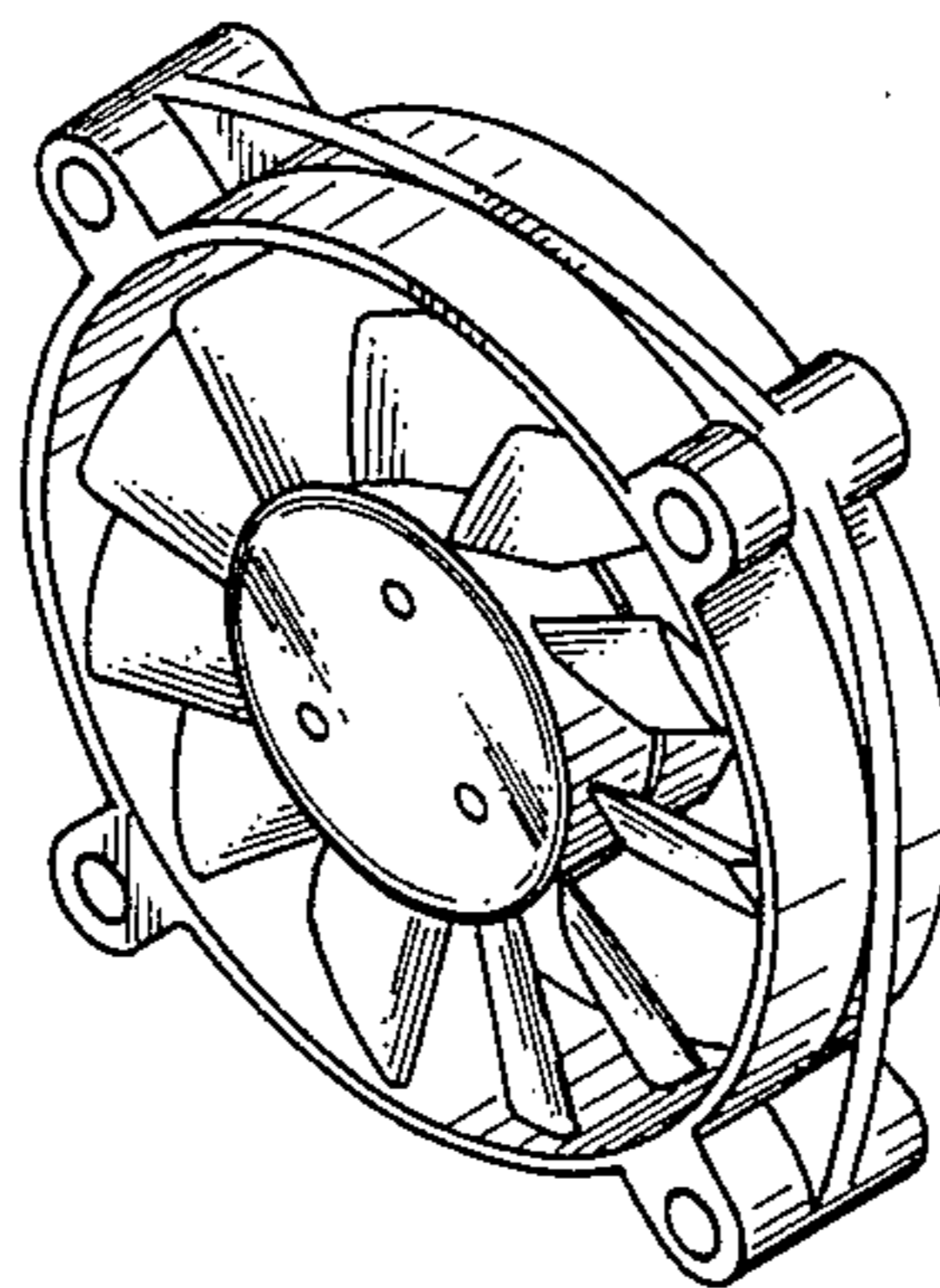

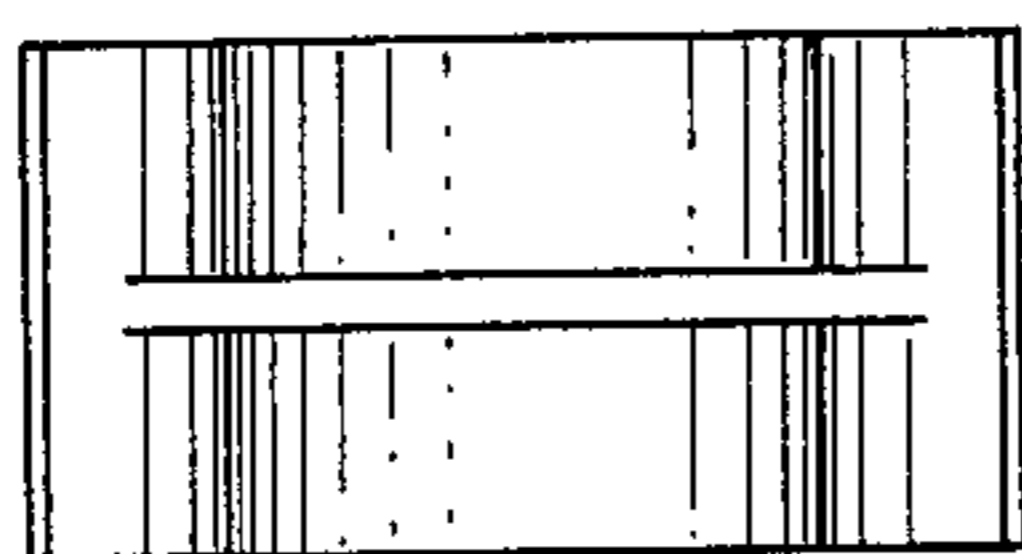

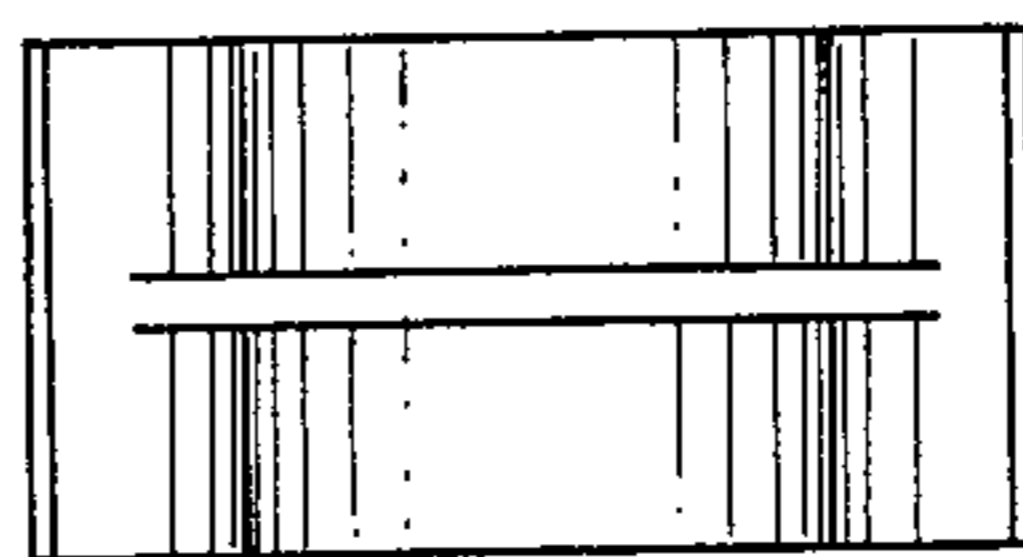

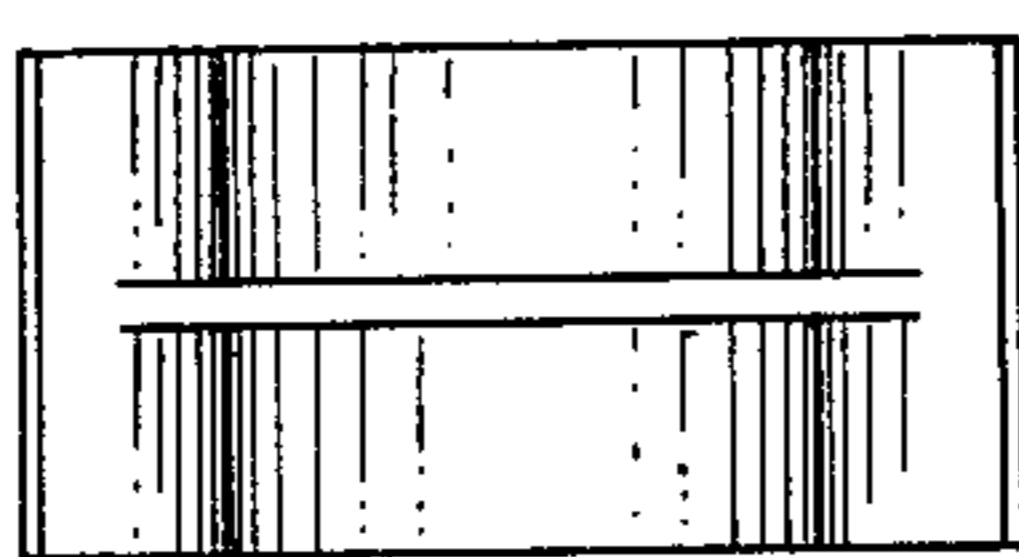

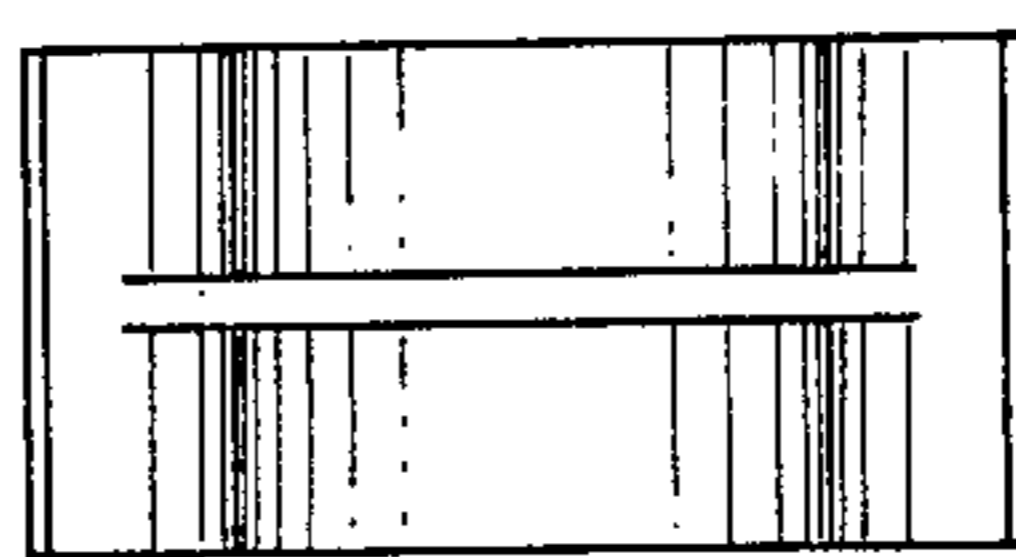

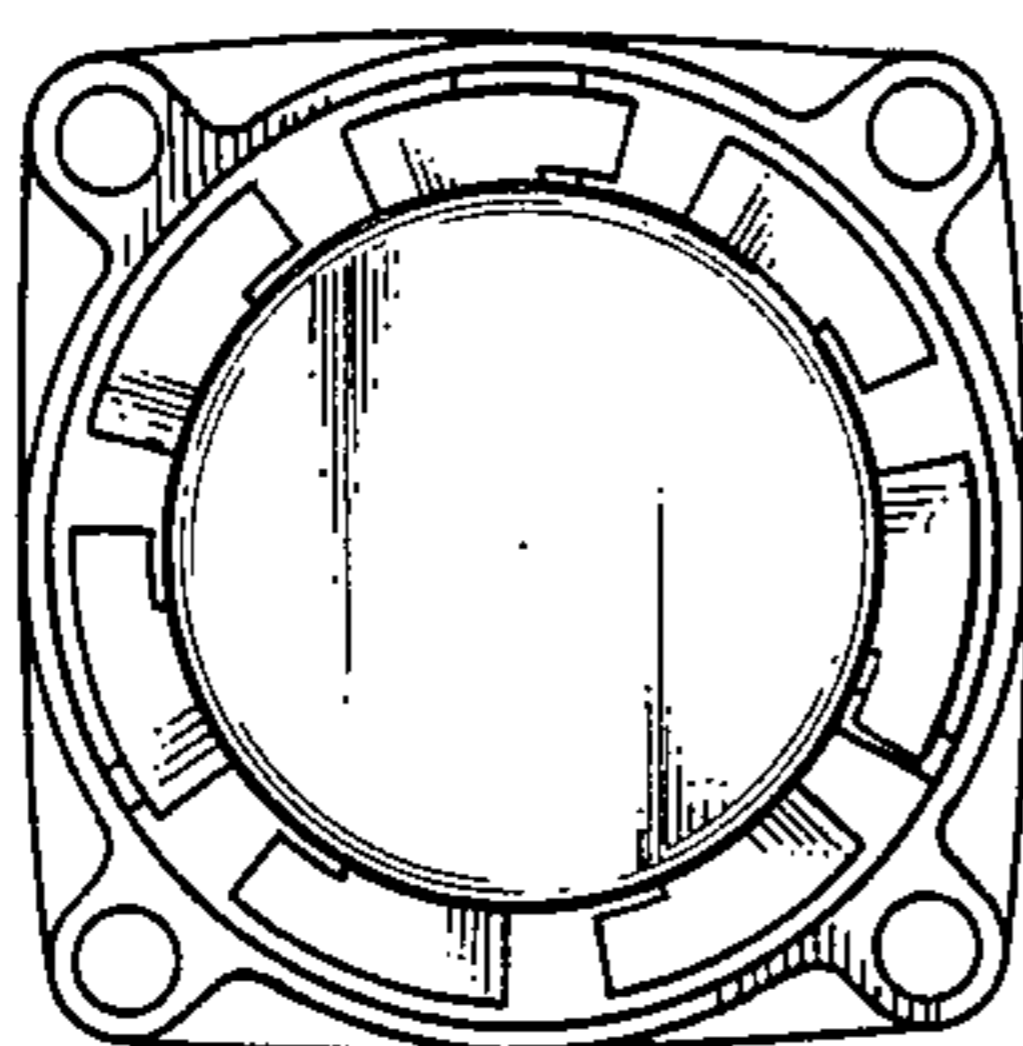

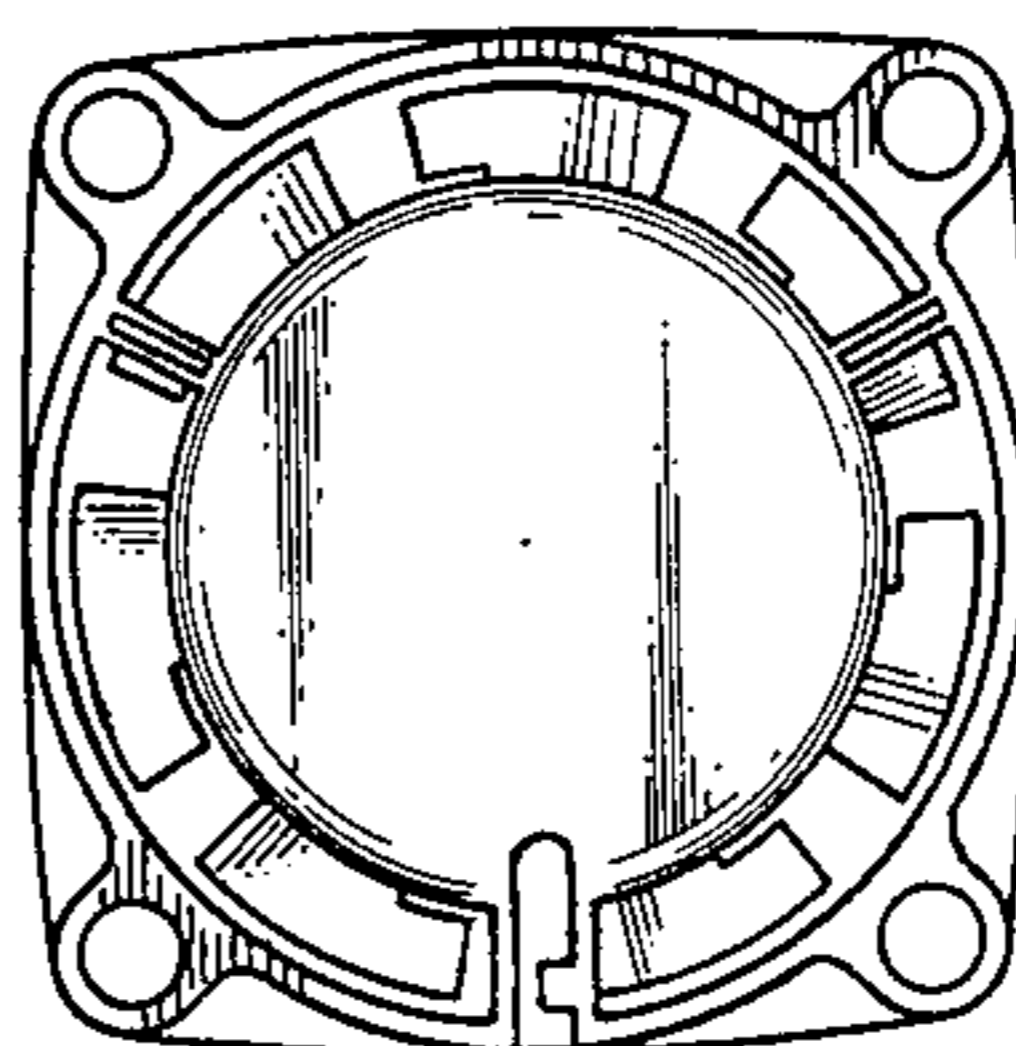
