**DESCRIPTION**

FIG. 1 is a top perspective view of a water closet tank showing our new design;

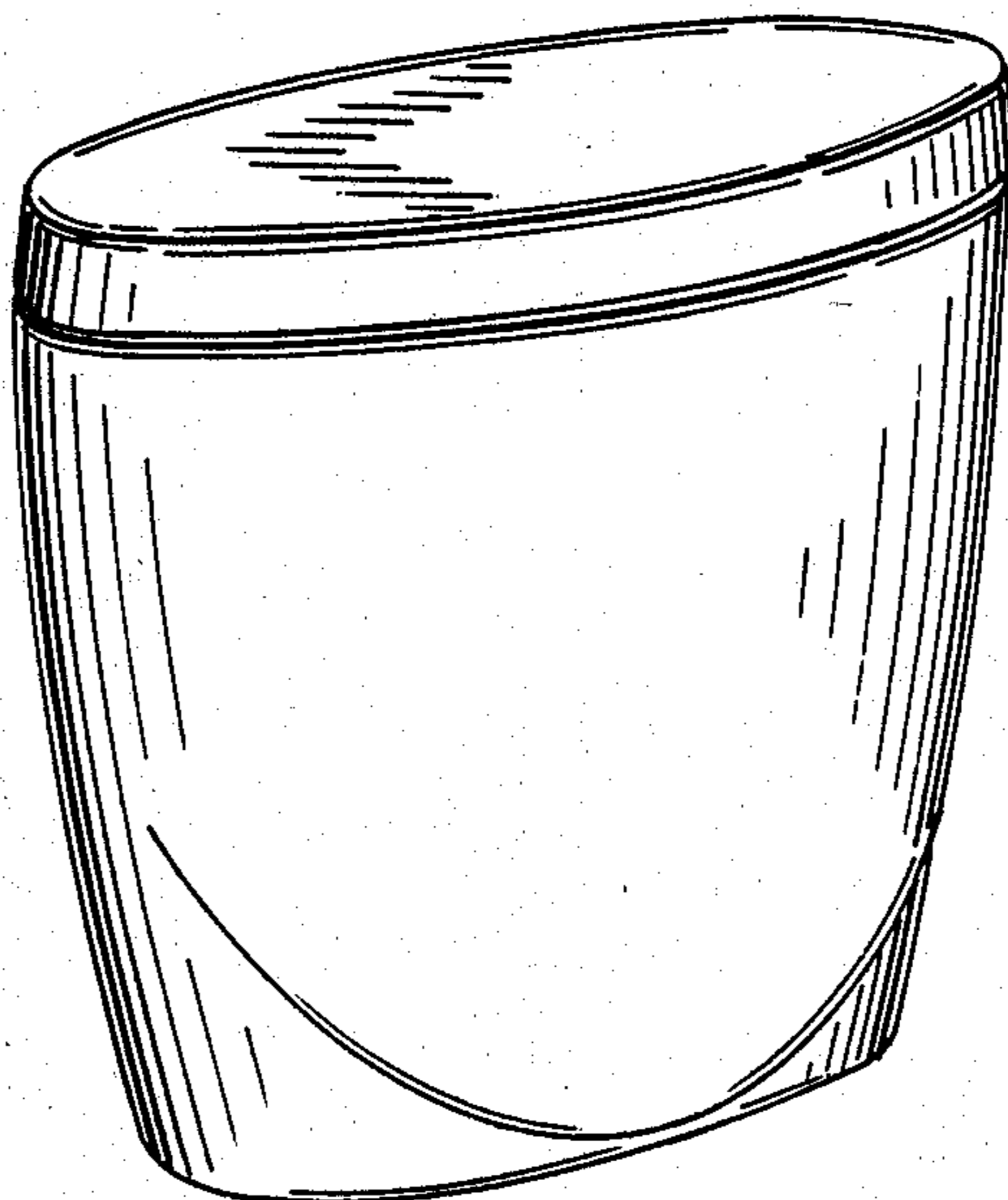
FIG. 2 is a front elevational view thereof, the rear elevational view being the mirror image thereof;

The broken line representations of fitting holes in FIG. 5 are for purposes of illustration only.



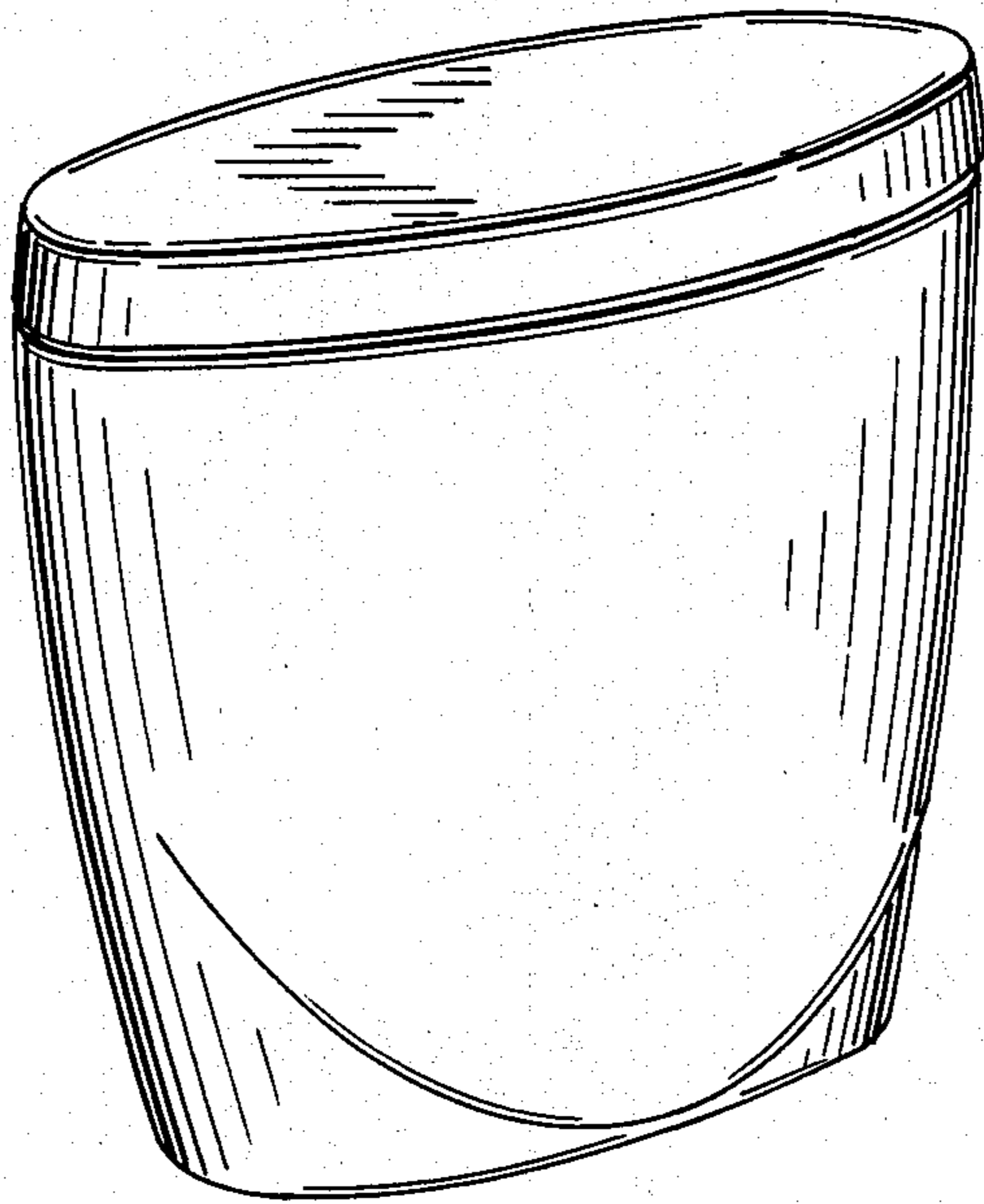

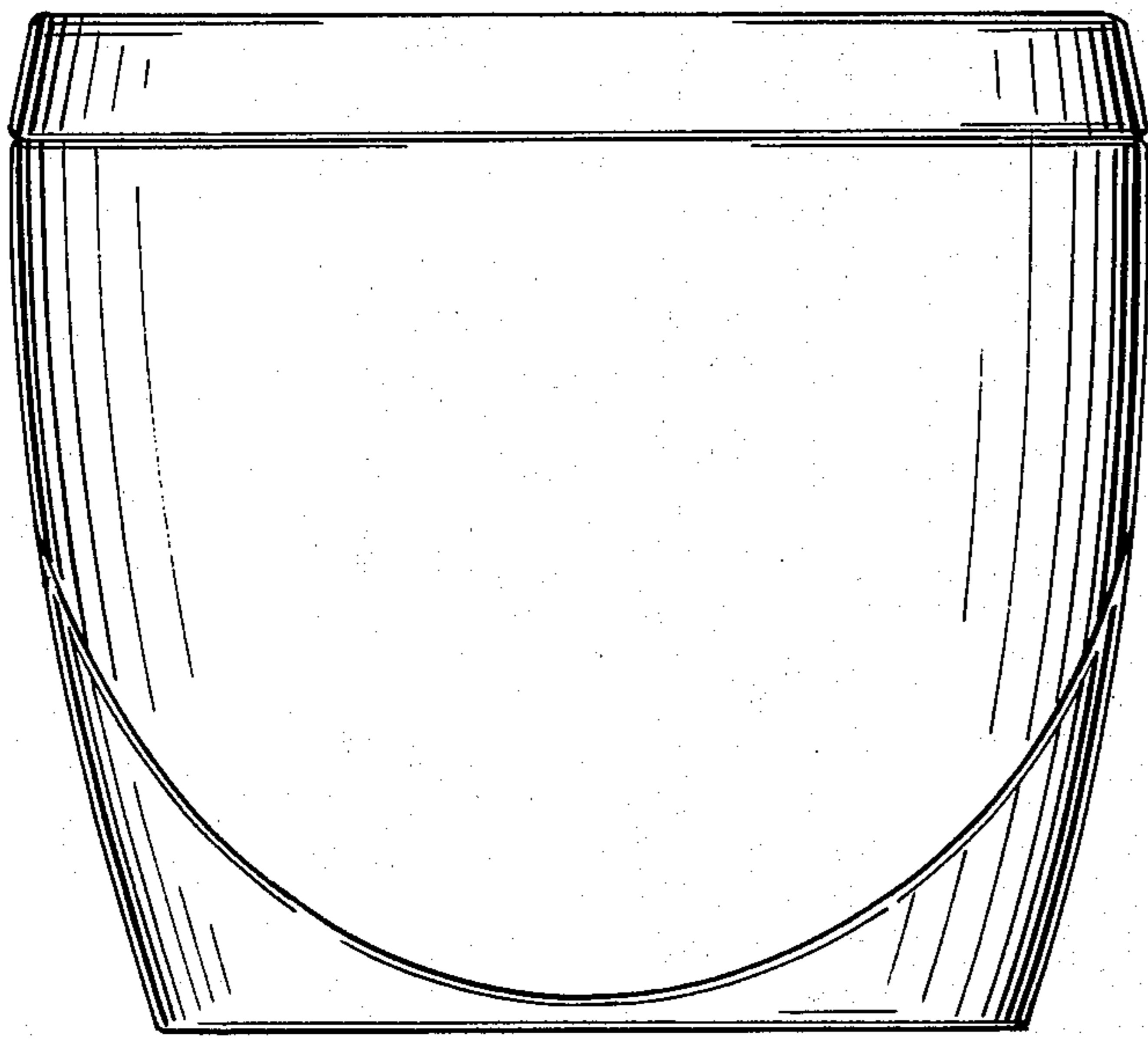

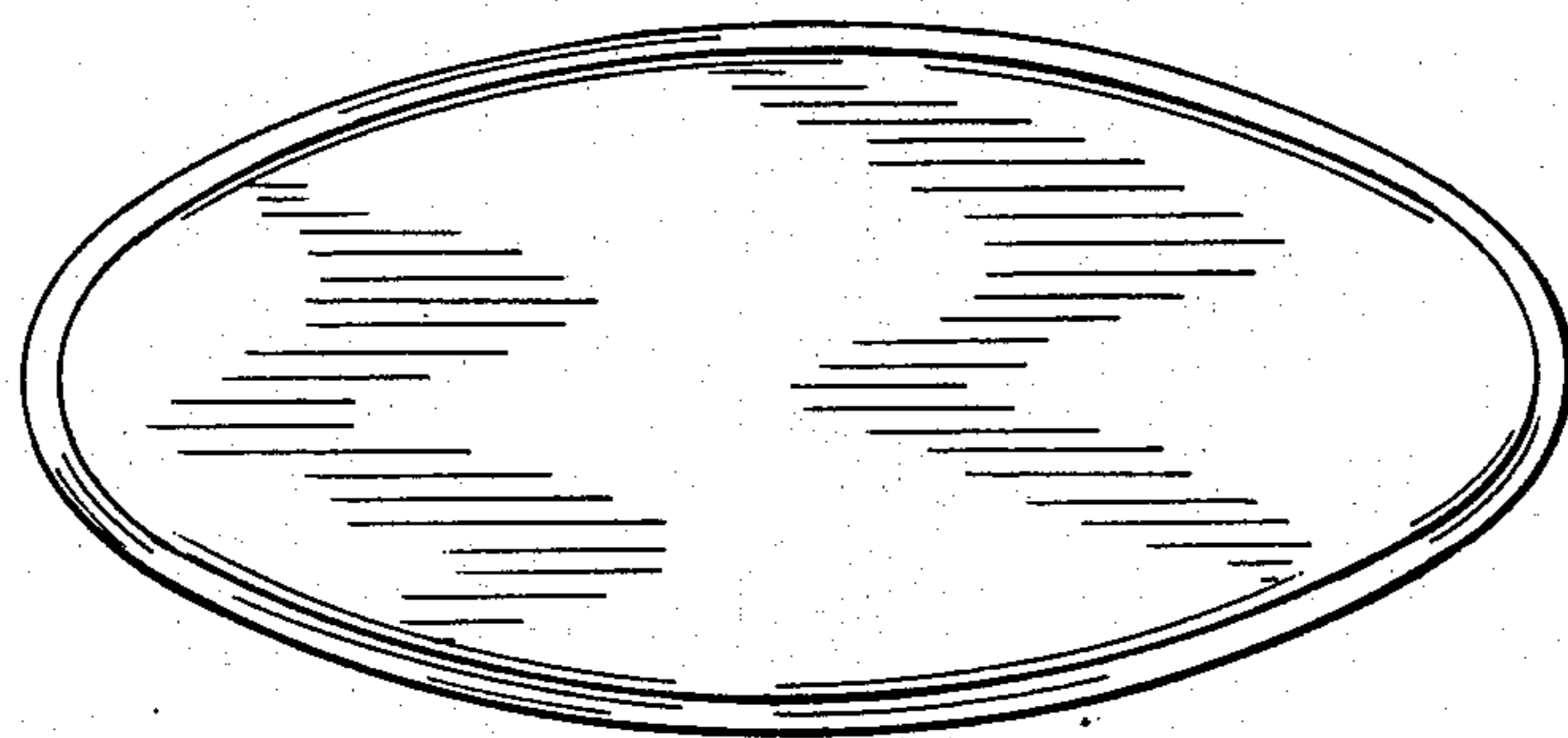
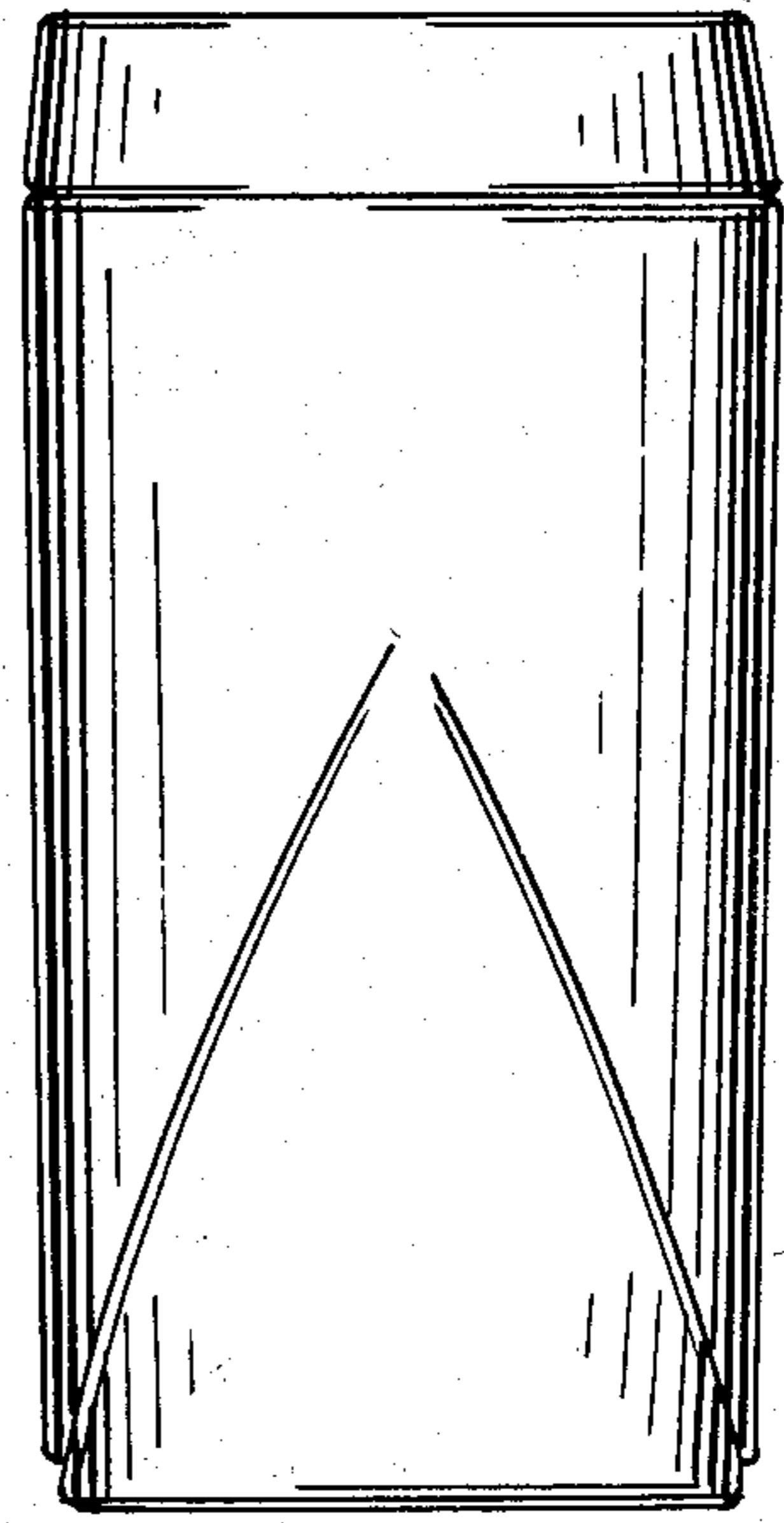

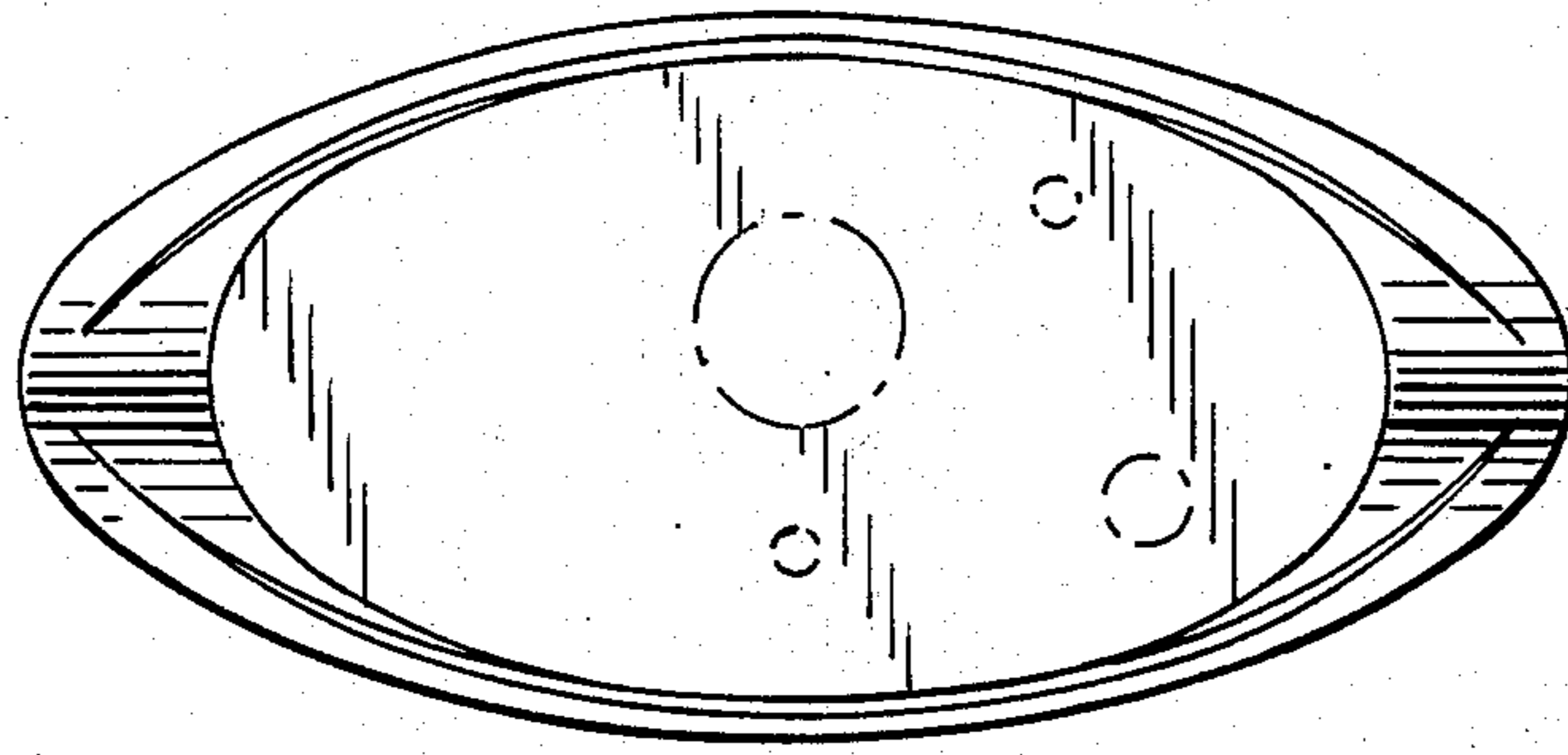
