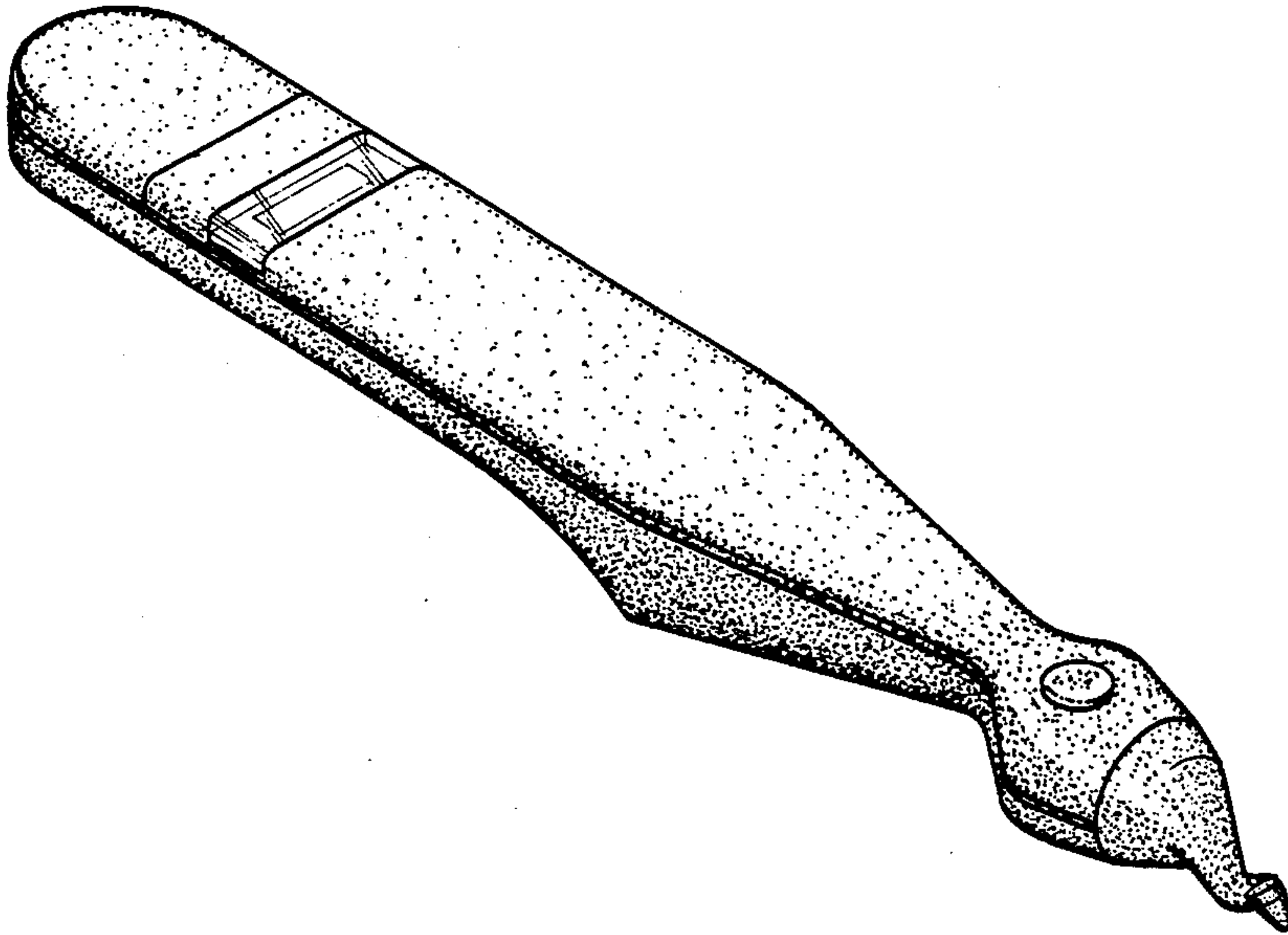

FIG. 8 is a perspective view of another alternate tip portion, all other portions being the same as FIG. 1;



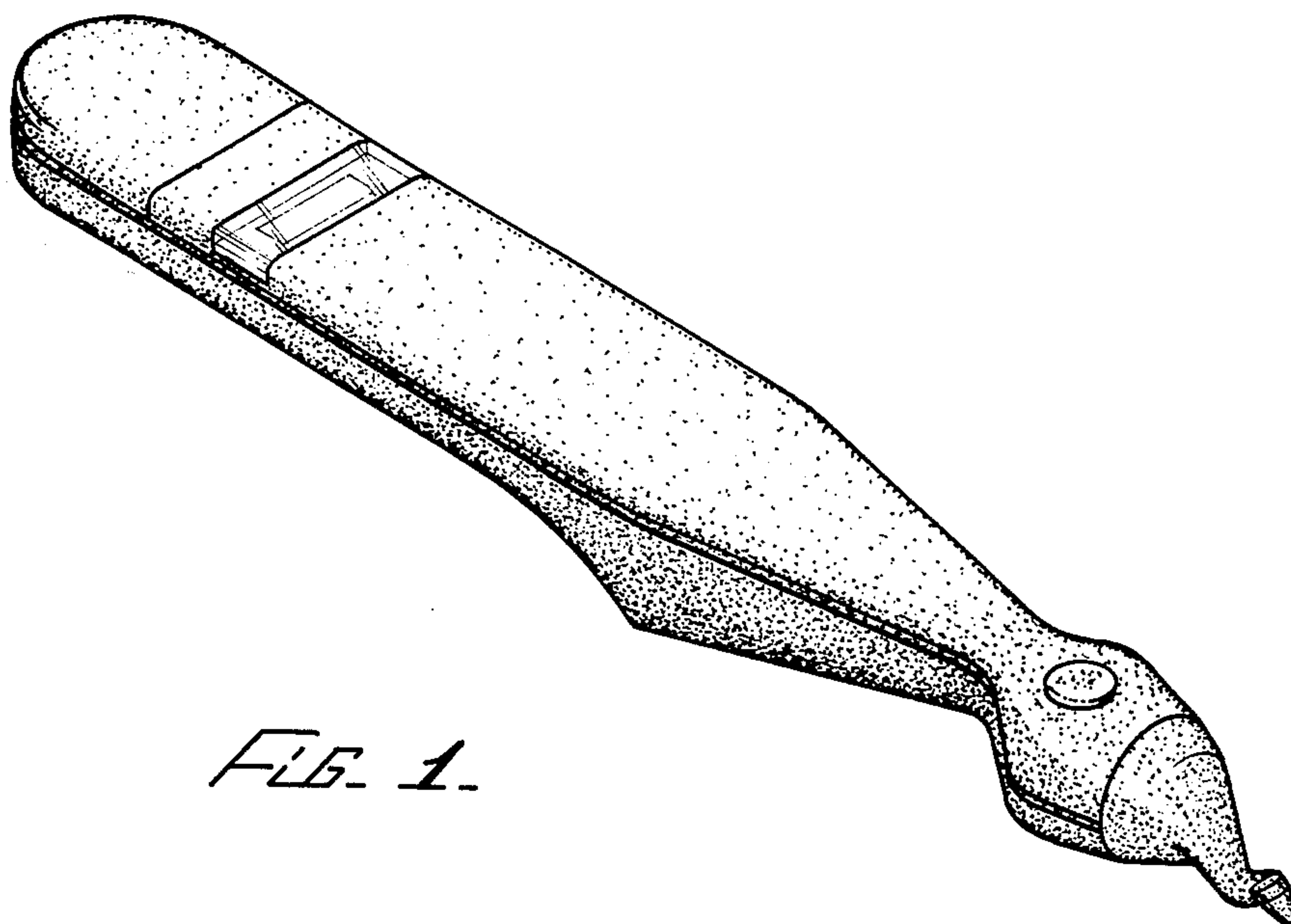

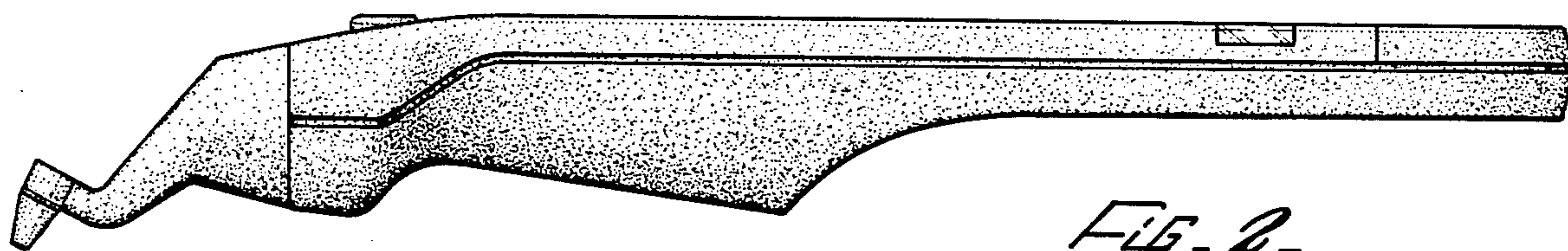

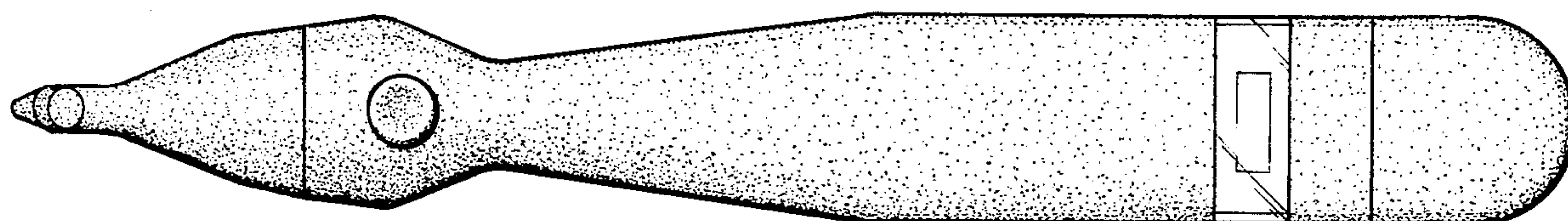

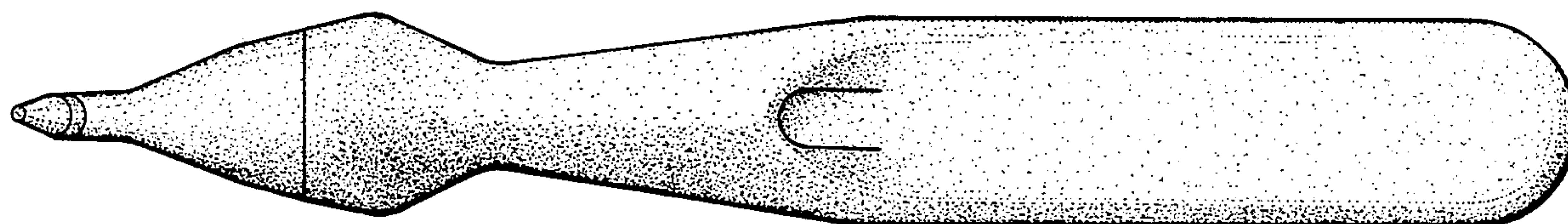

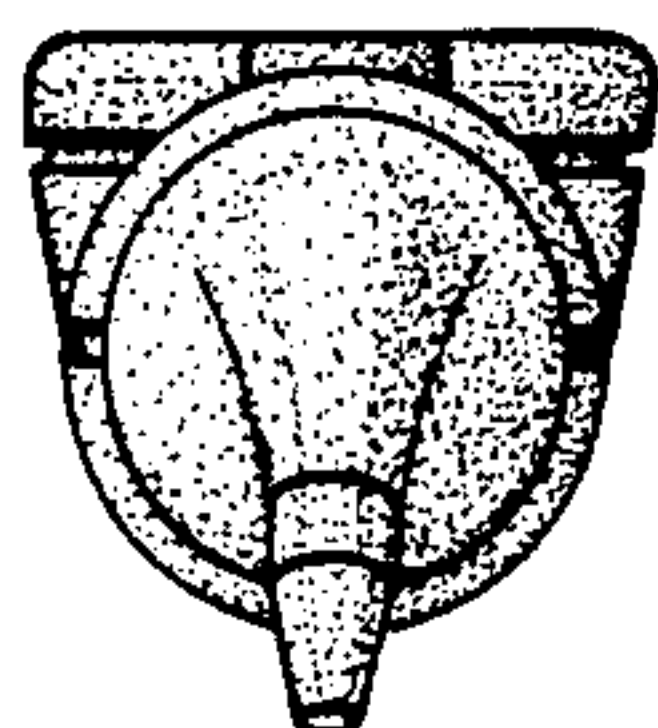

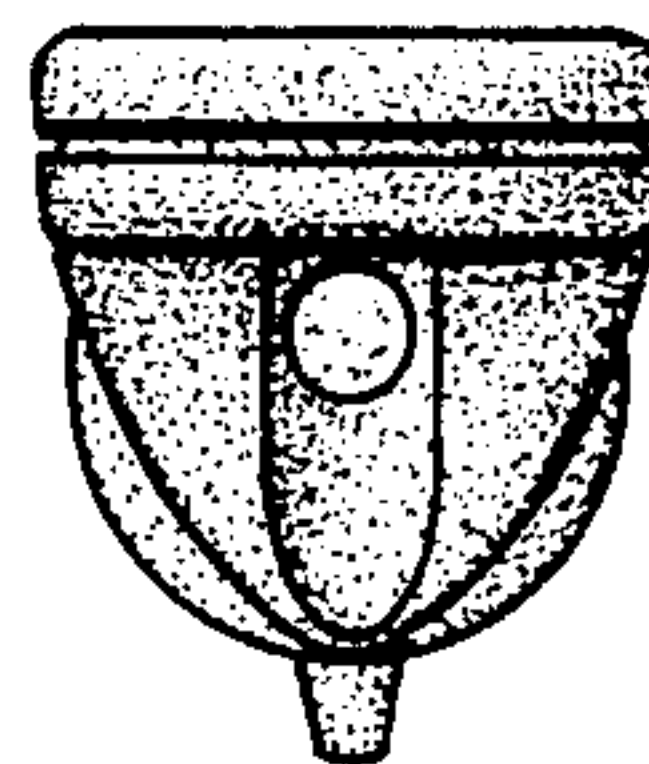

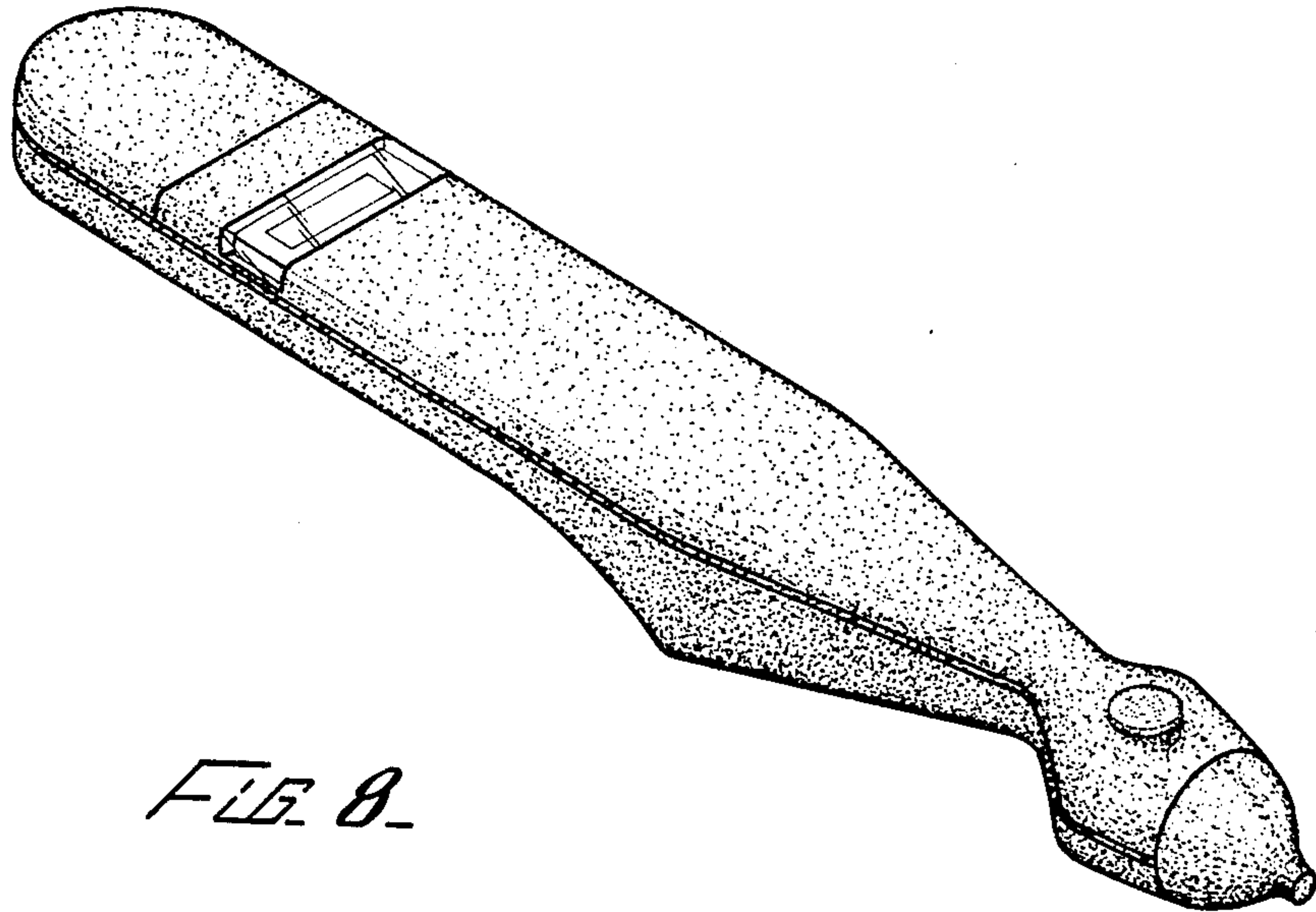

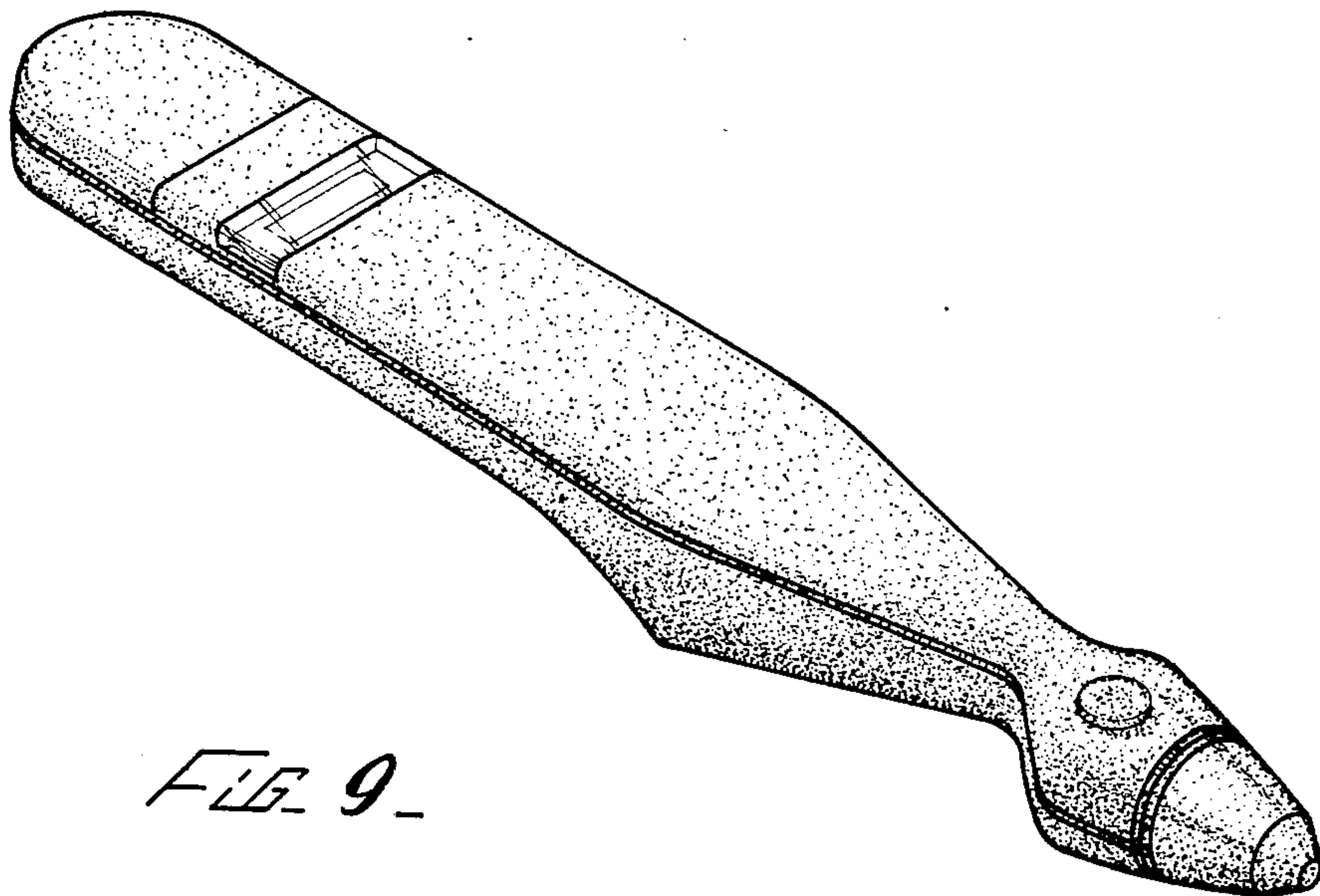
