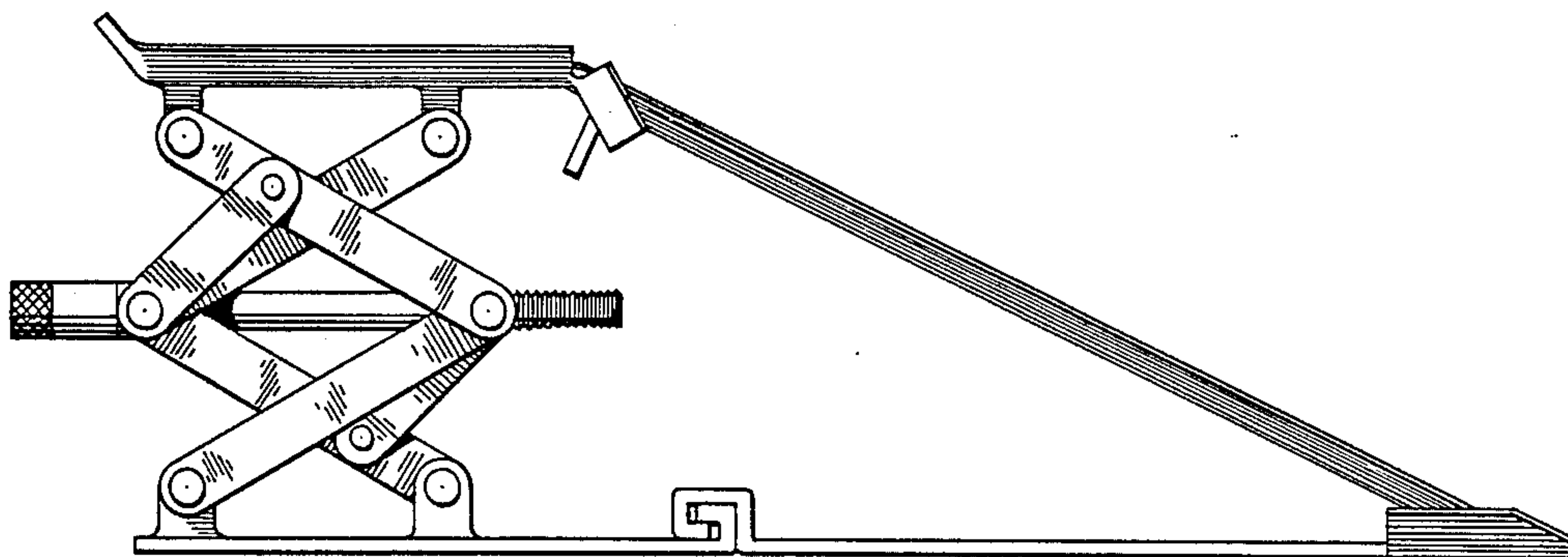

The ornamental design for a vehicle ramp, as shown
 and described.

DESCRIPTION

FIG. 1 is a left side elevational view of a vehicle ramp showing my new design;
 FIG. 2 is a left side elevational view thereof, shown in a collapsed condition;
 FIG. 3 is a rear elevational view thereof;
 FIG. 4 is a front elevational view thereof;
 FIG. 5 is a top plan view thereof;
 FIG. 6 is a bottom plan view thereof;
 FIG. 7 is a left side elevational view of a jack portion of the vehicle ramp, it being understood that the jack portion is shown separately for clarity of illustration;
 FIG. 8 is a front elevational view of FIG. 7;
 FIG. 9 is a top plan view of FIG. 7;
 FIG. 10 is a bottom plan view of FIG. 7;
 FIG. 11 is a top plan view of a ramp portion of the vehicle ramp, the ramp portion is shown separately for clarity of illustration;
 FIG. 12 is a front elevational view of FIG. 11;
 FIG. 13 is a bottom plan view of FIG. 11;
 FIG. 14 is a rear elevational view of FIG. 11;
 FIG. 15 is a left side elevational view of FIG. 11;
 FIG. 16 is a left side elevational view of a horizontal base platform section of the vehicle ramp, the horizontal base platform section is shown separately for clarity of illustration;
 FIG. 17 is a top plan view of FIG. 16;
 FIG. 18 is a bottom plan view of FIG. 16;
 FIG. 19 is a rear elevational view of FIG. 16; and
 FIG. 20 is a front elevational view of FIG. 16.
 The right side views of FIGS. 1, 2, 7, 15 and 16 are mirror images of those shown.



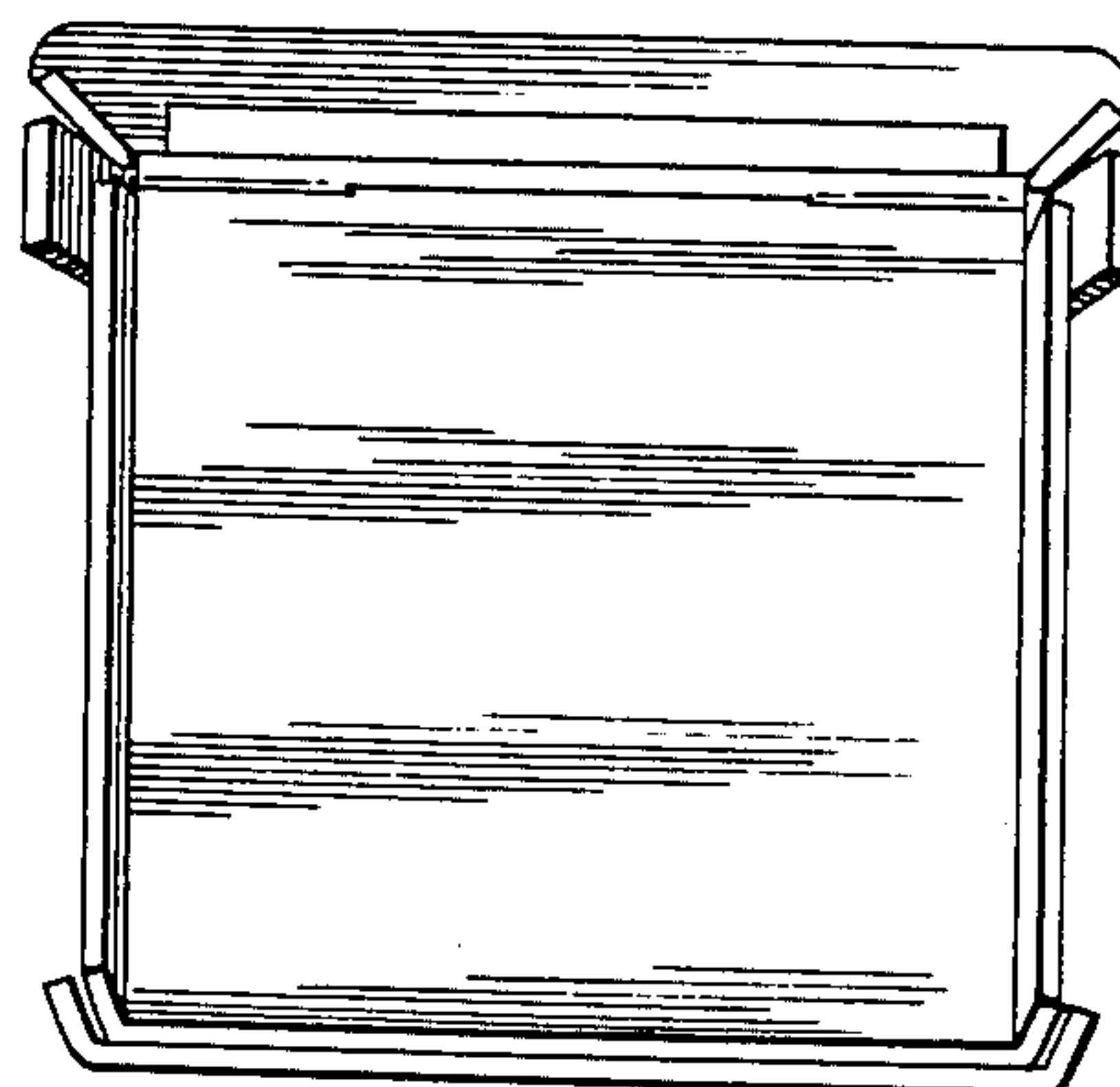
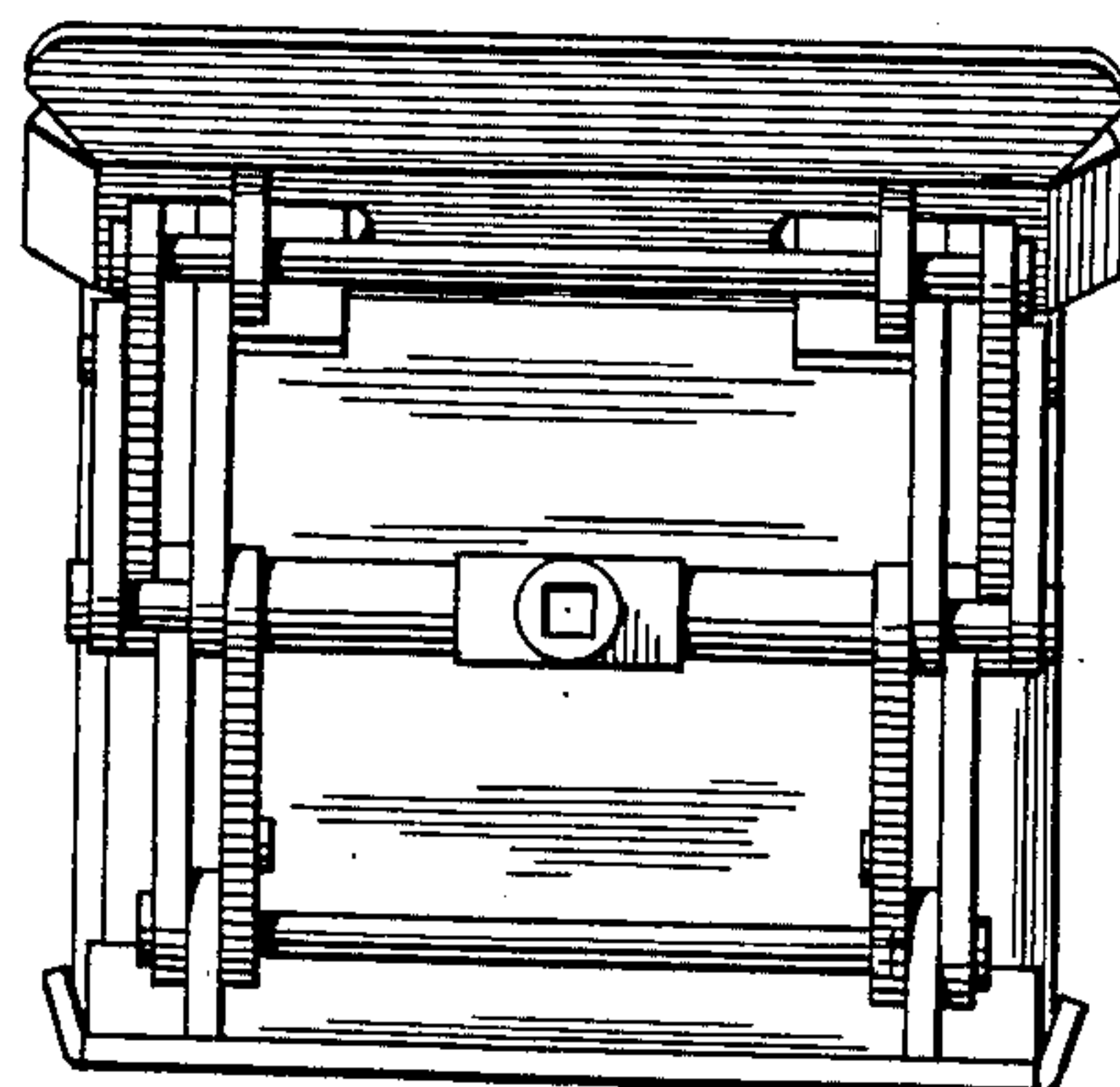
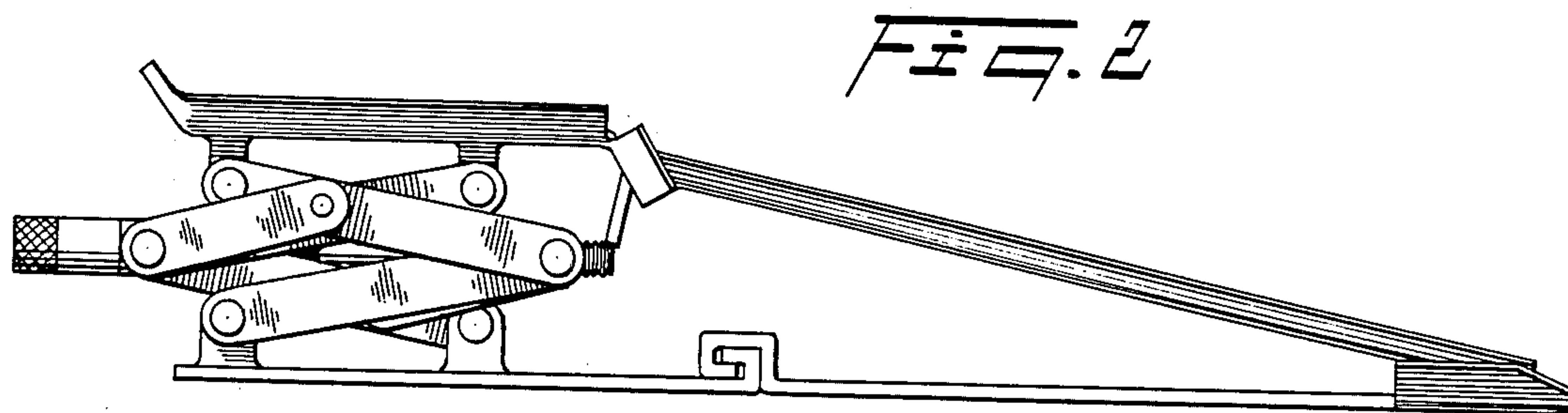
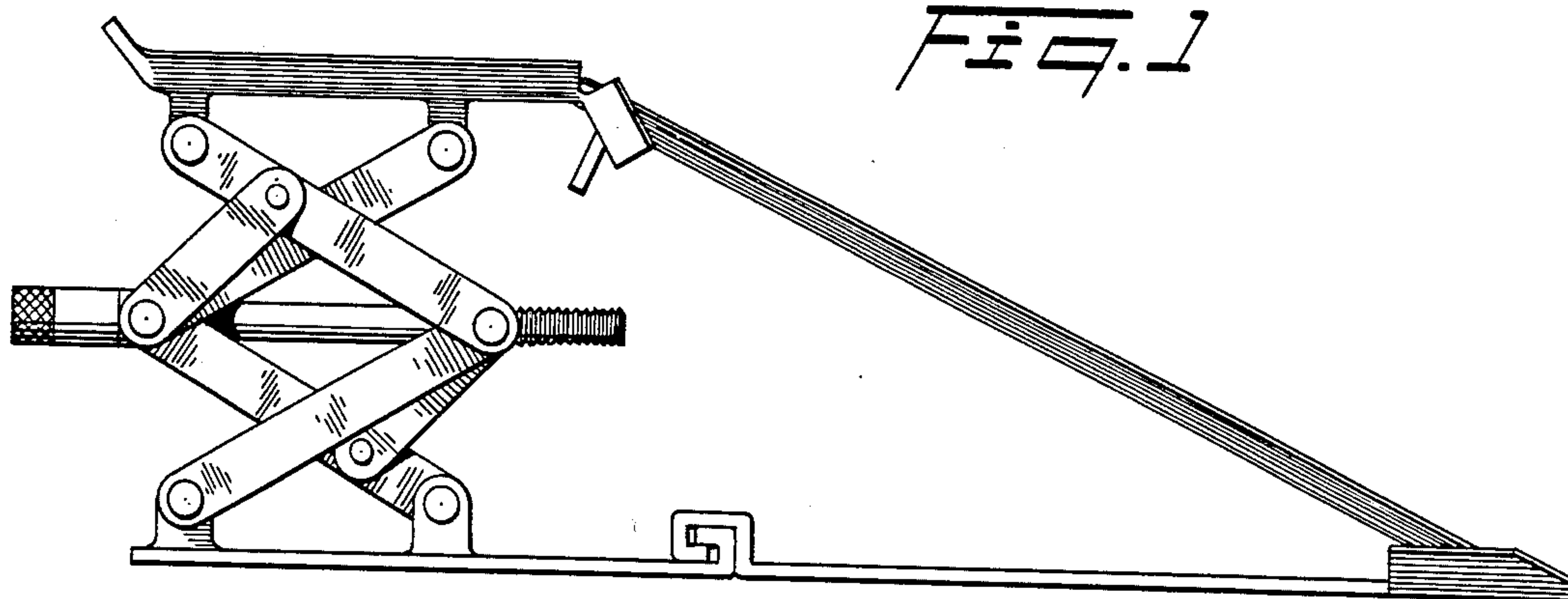

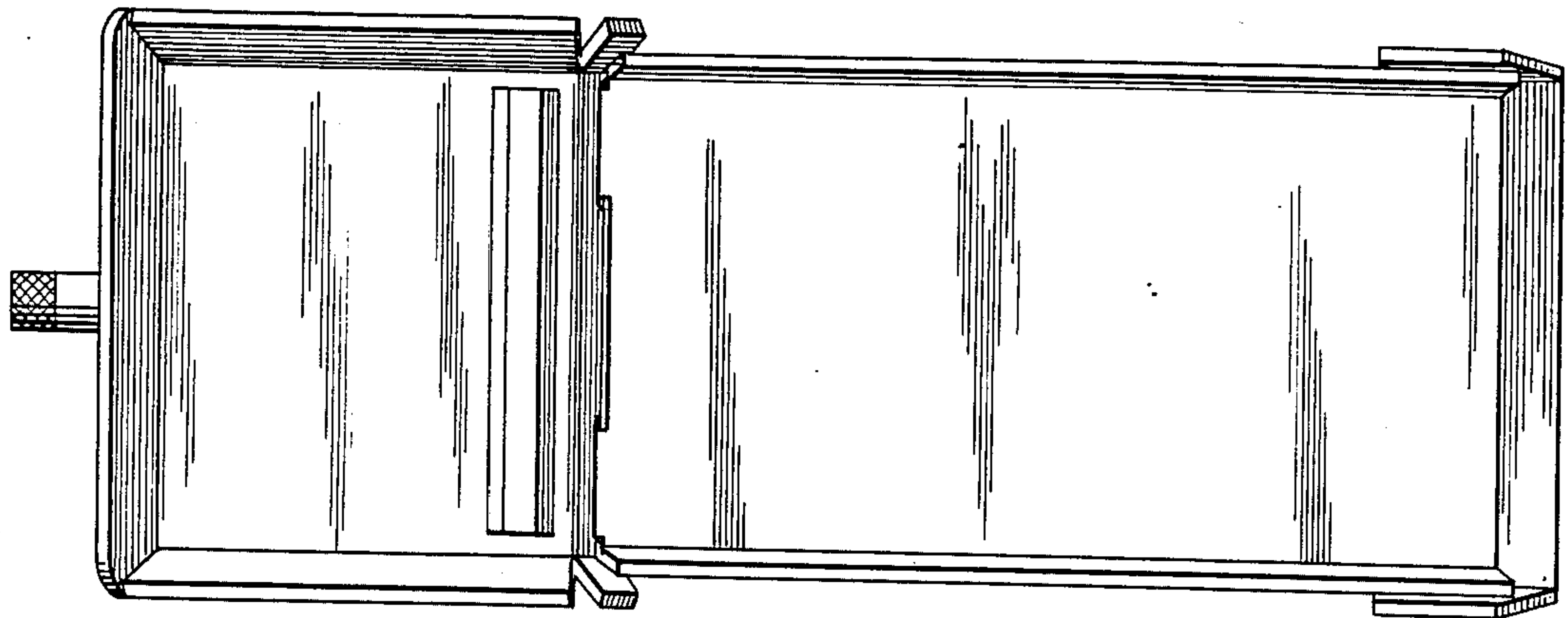

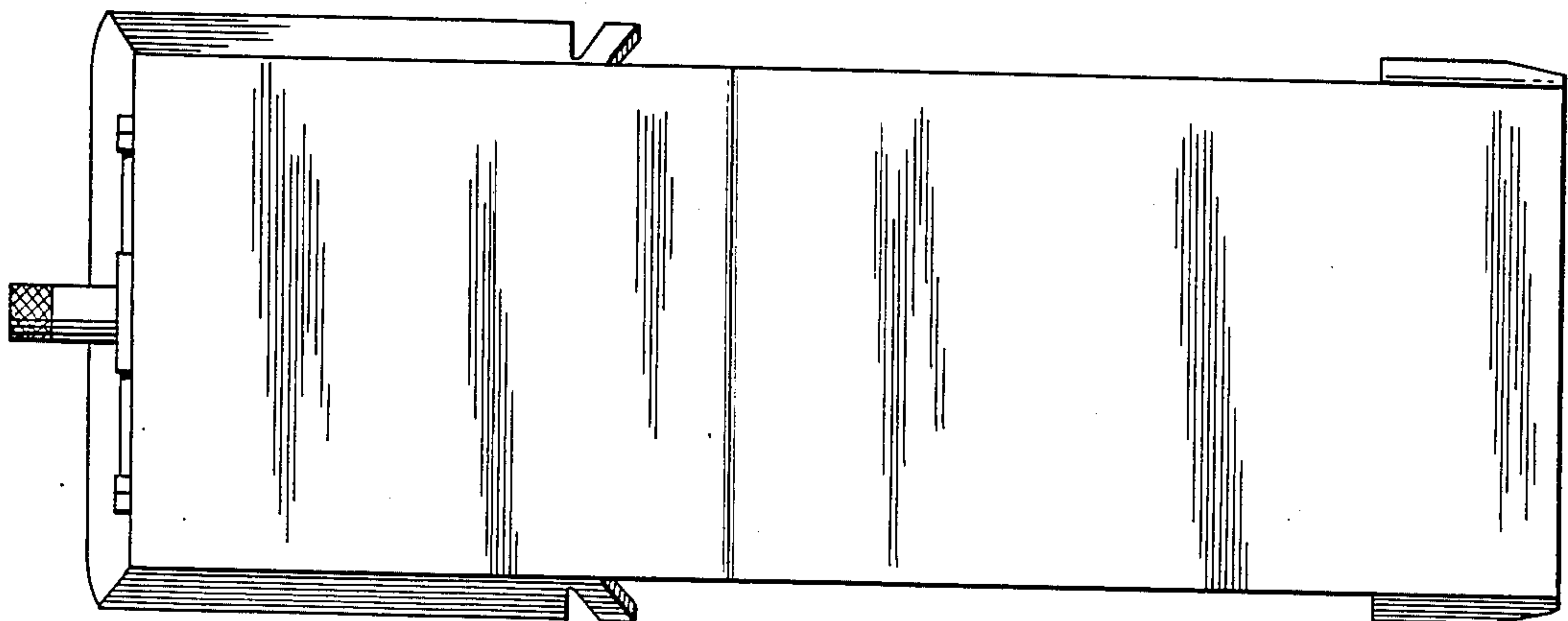

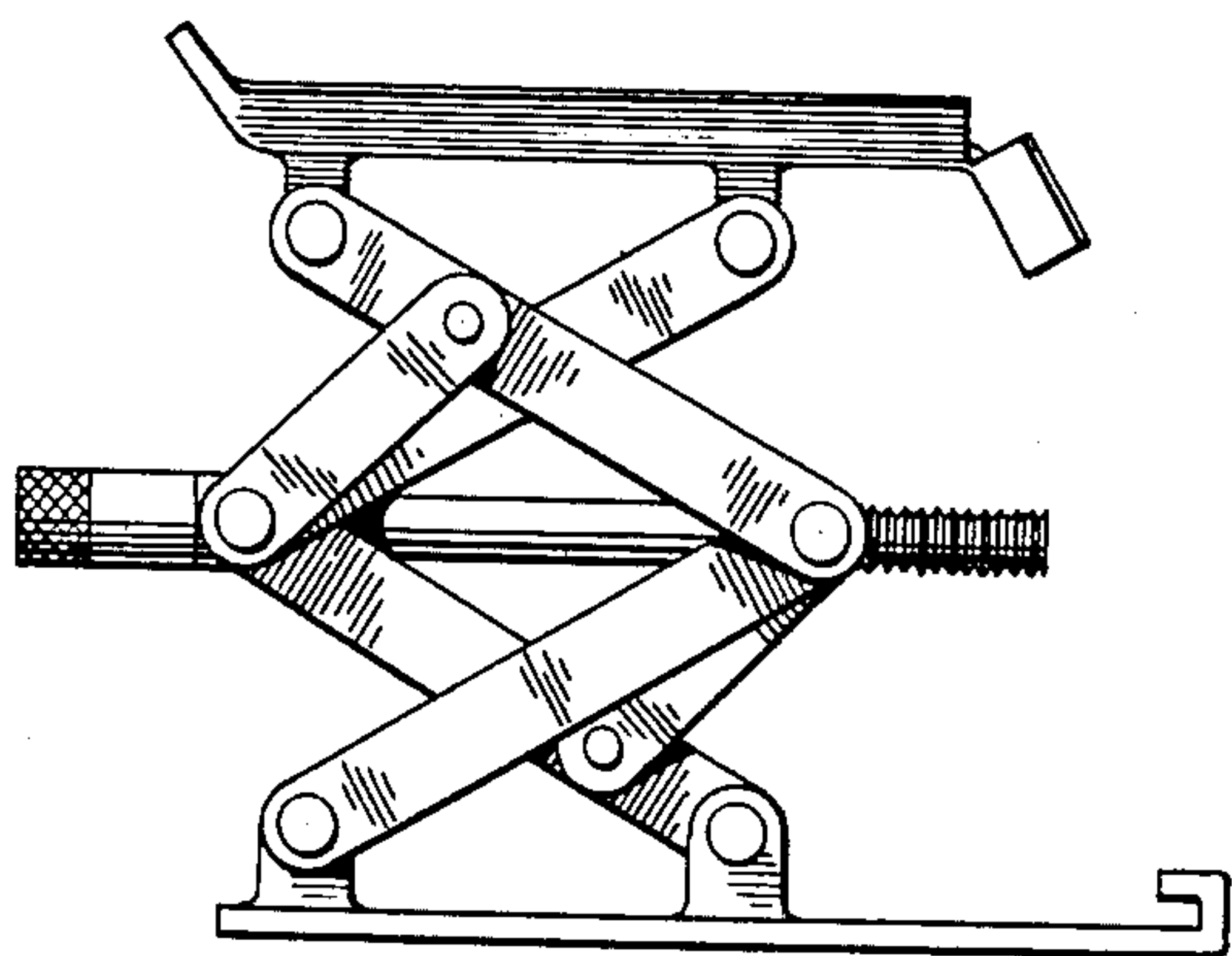

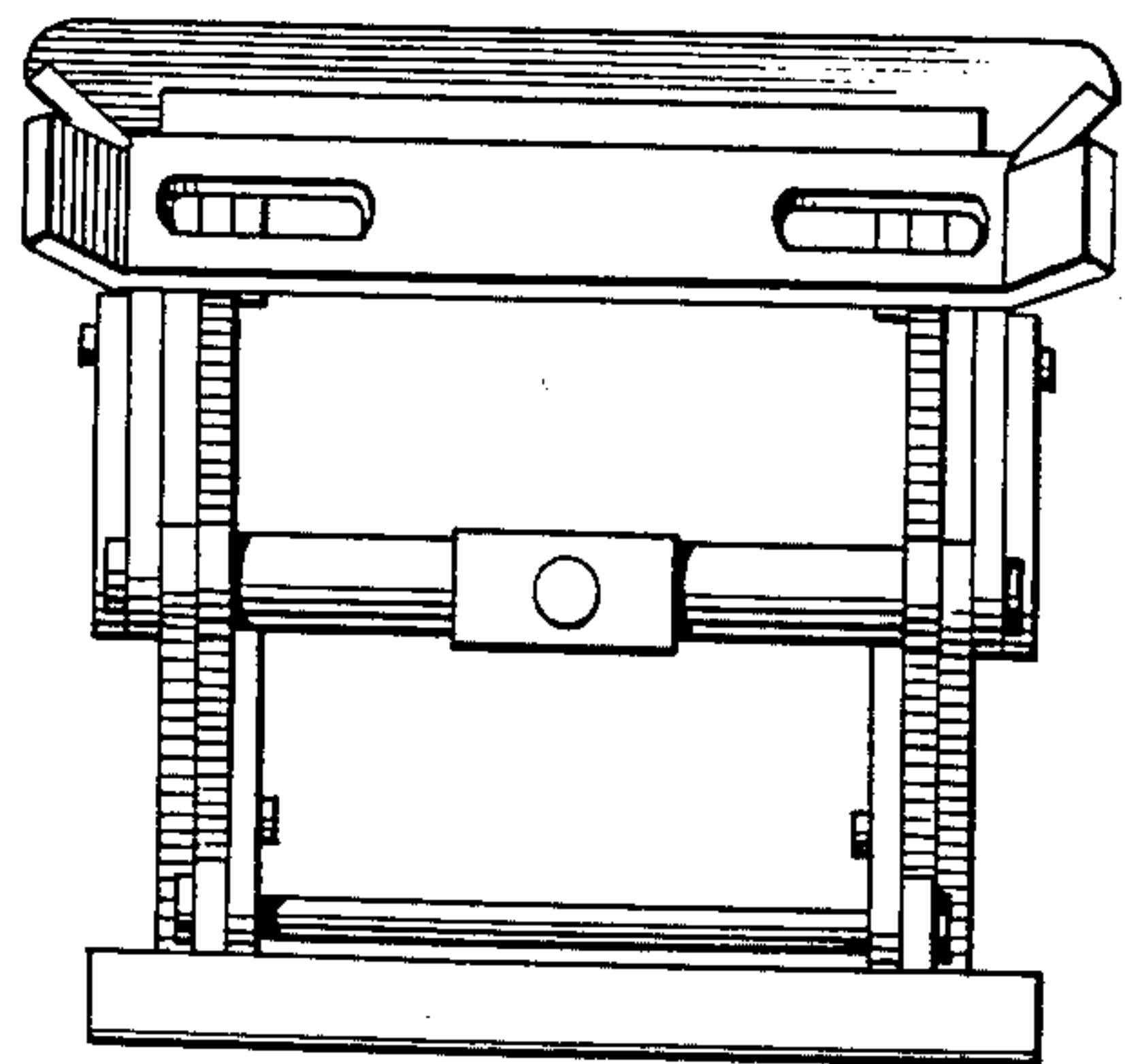

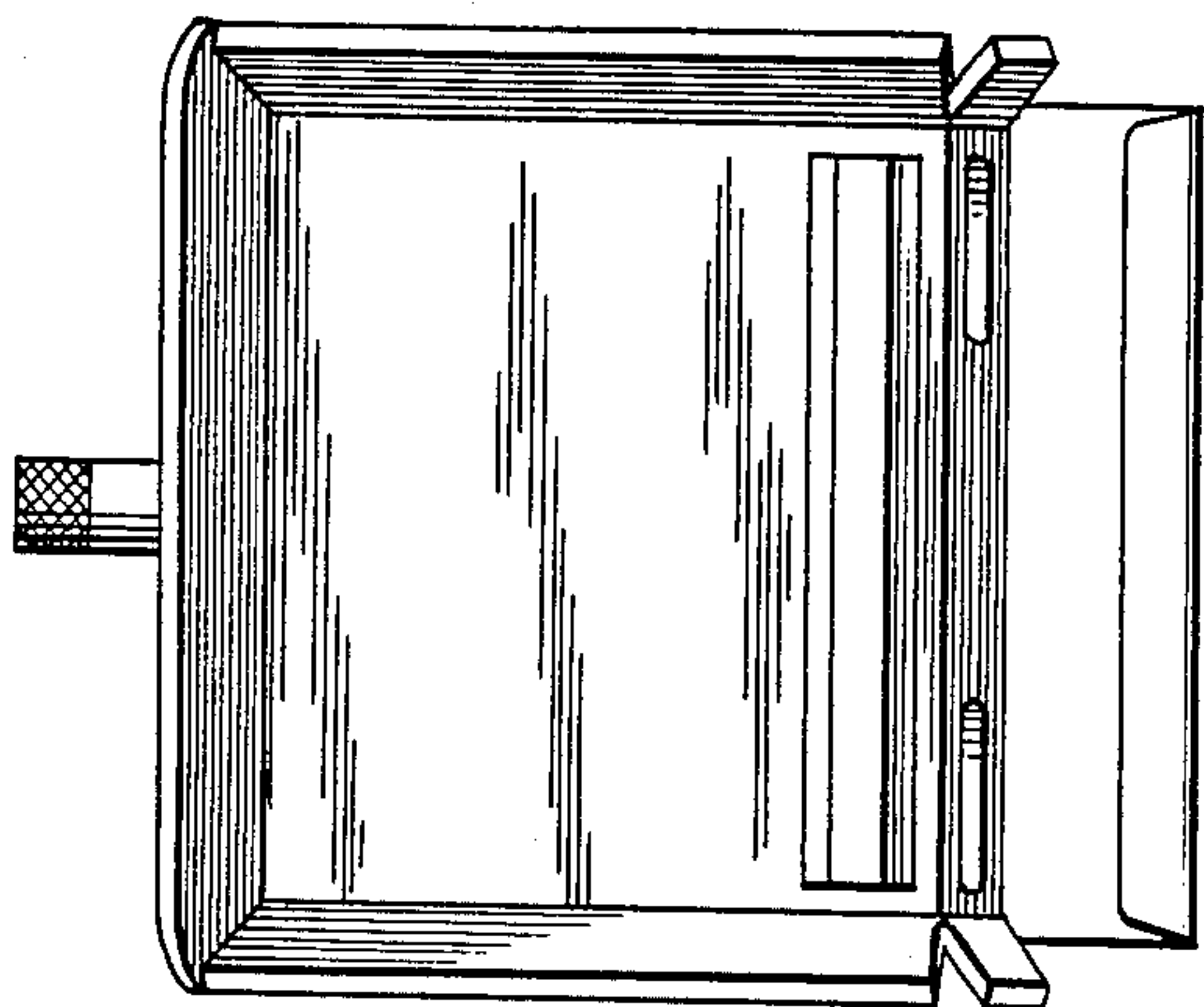

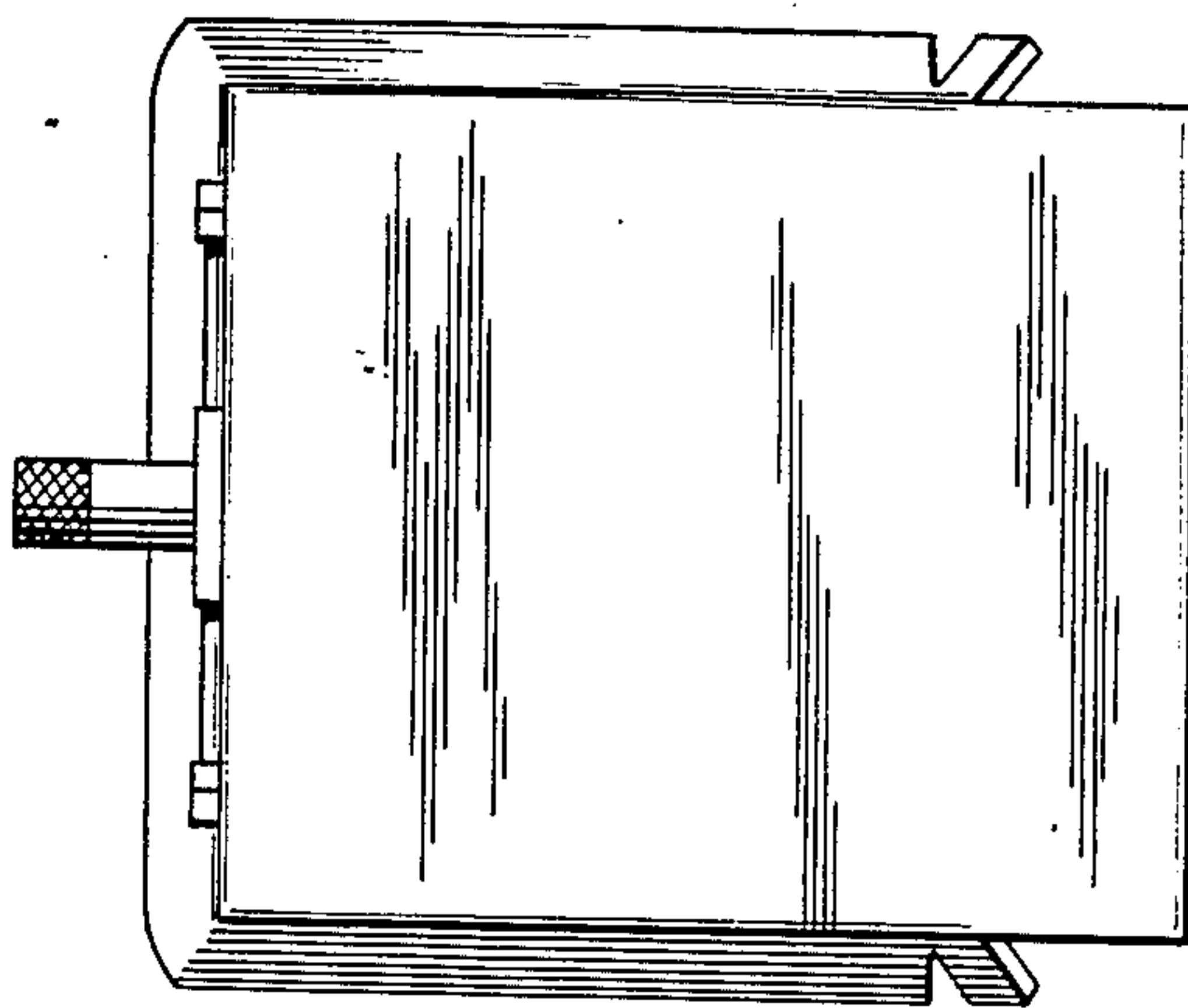

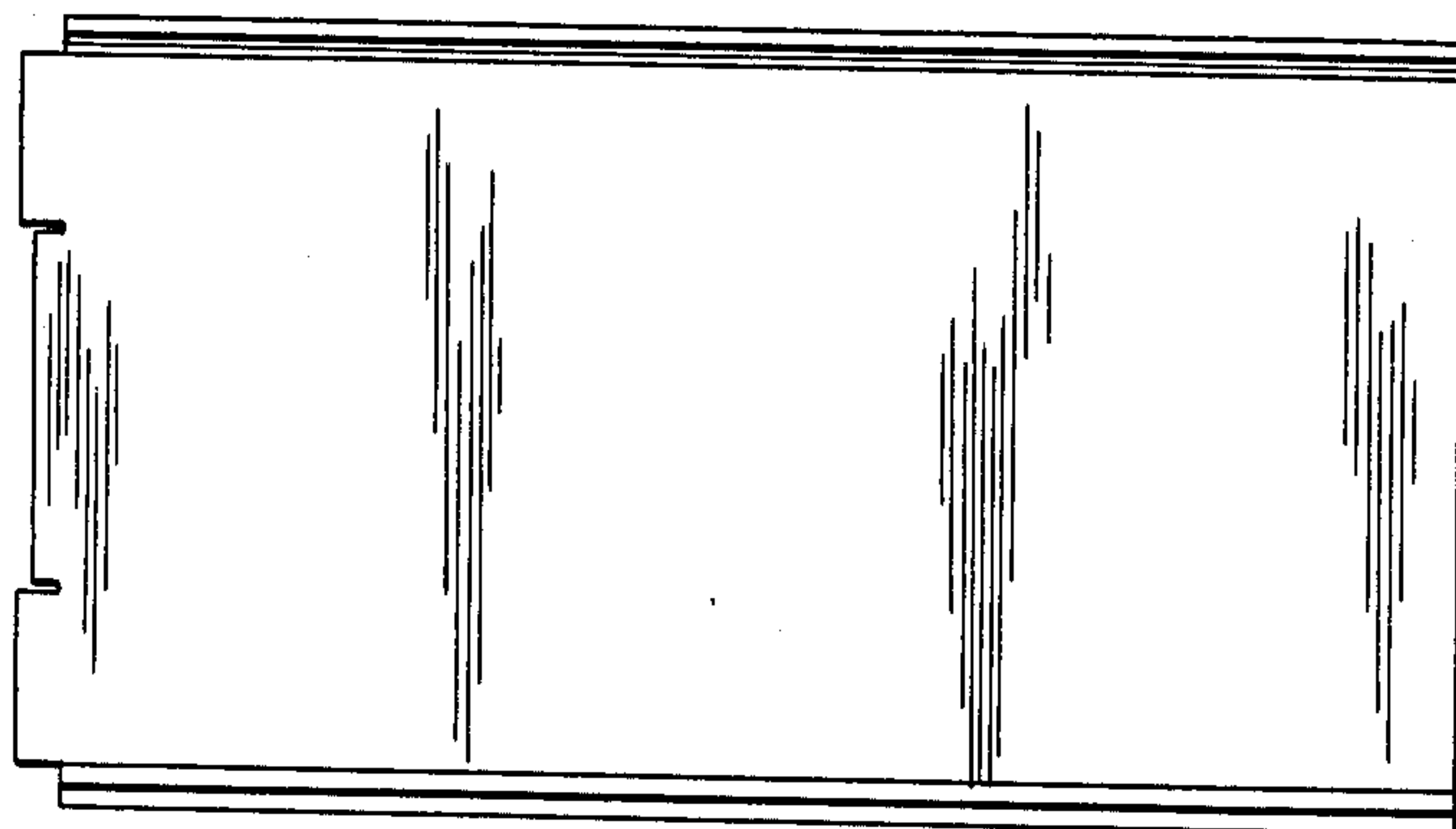

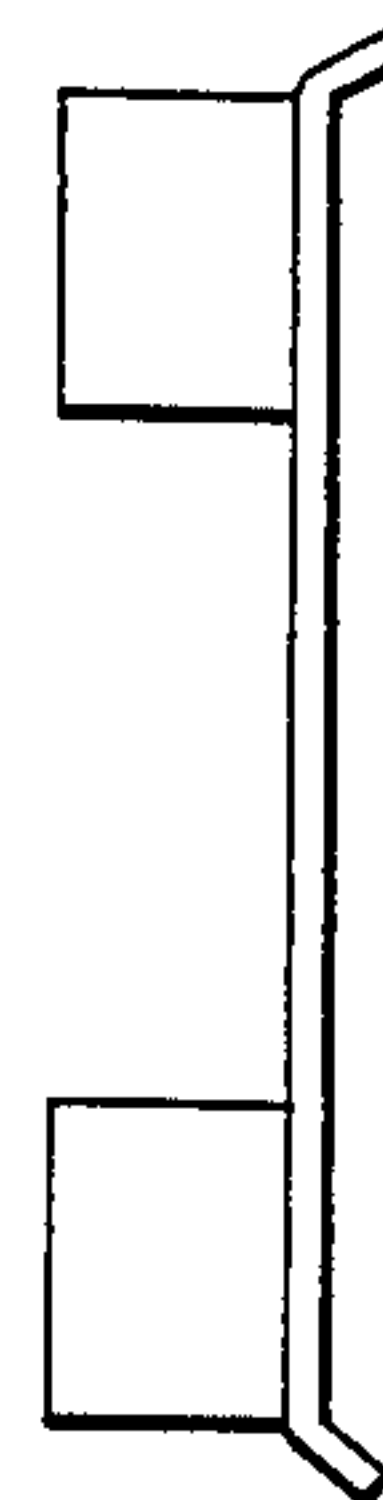
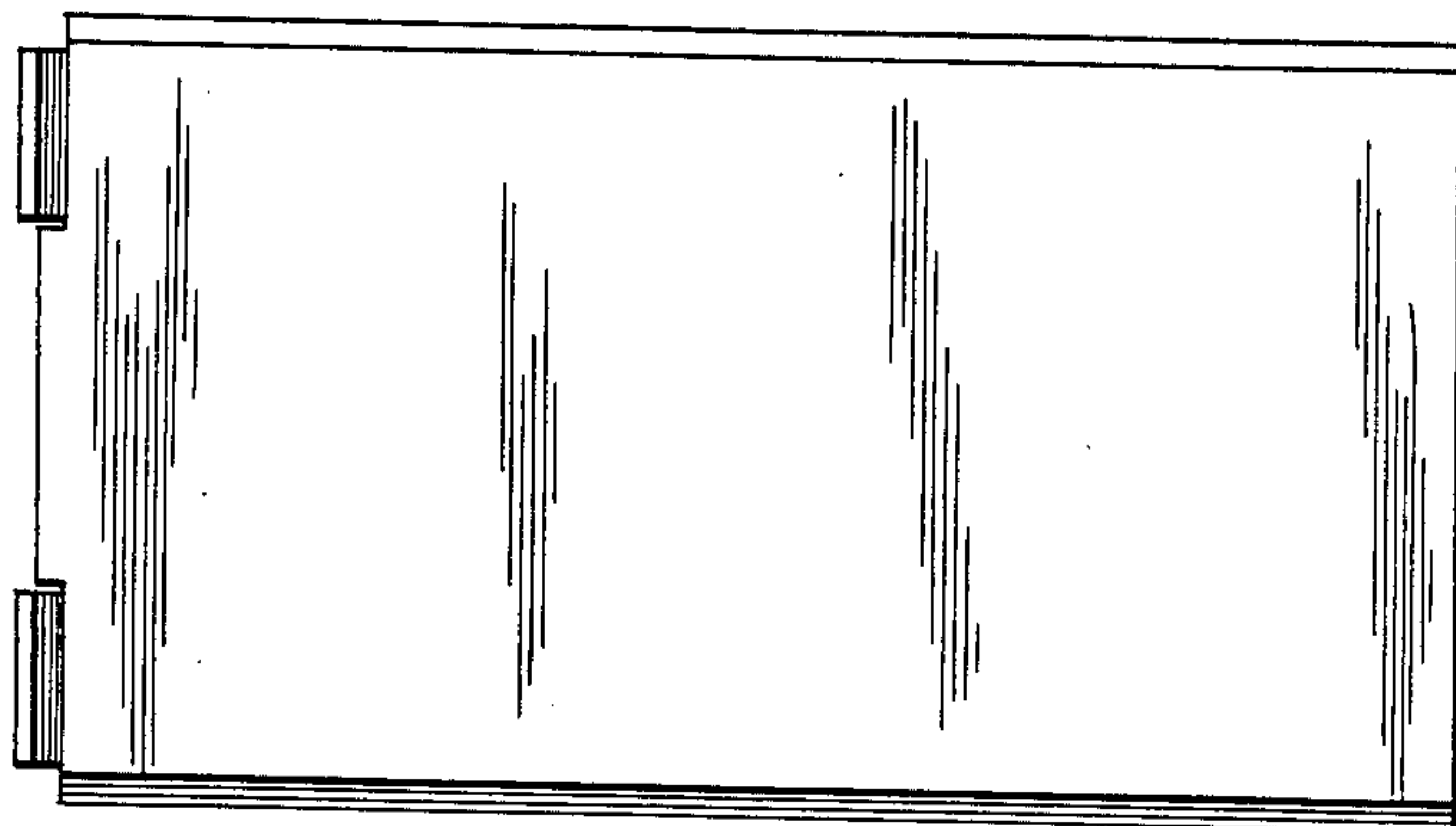
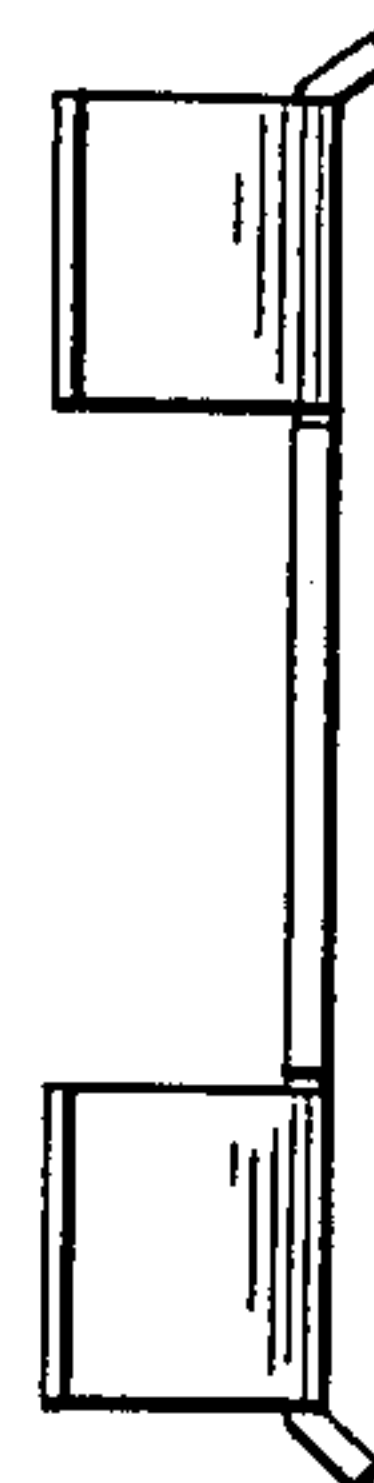

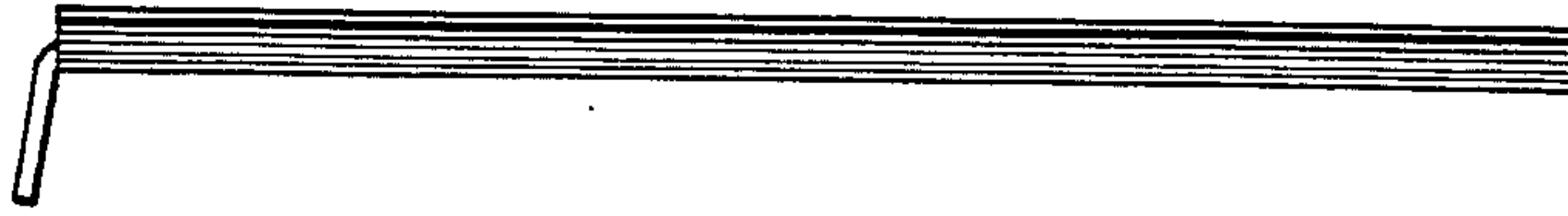

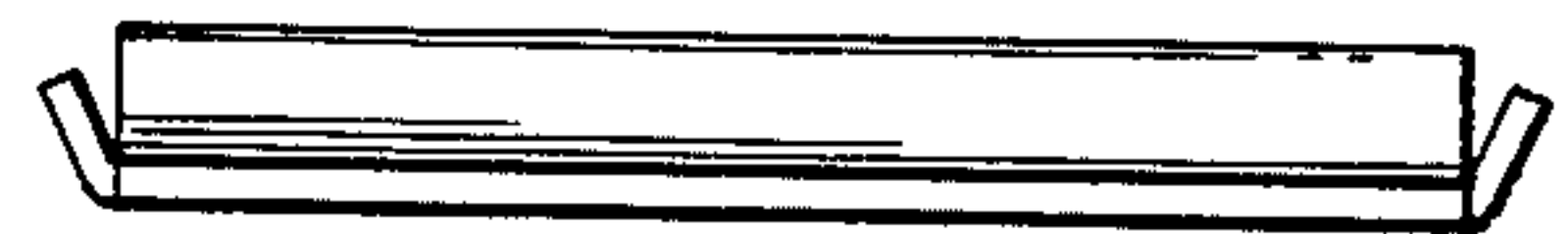
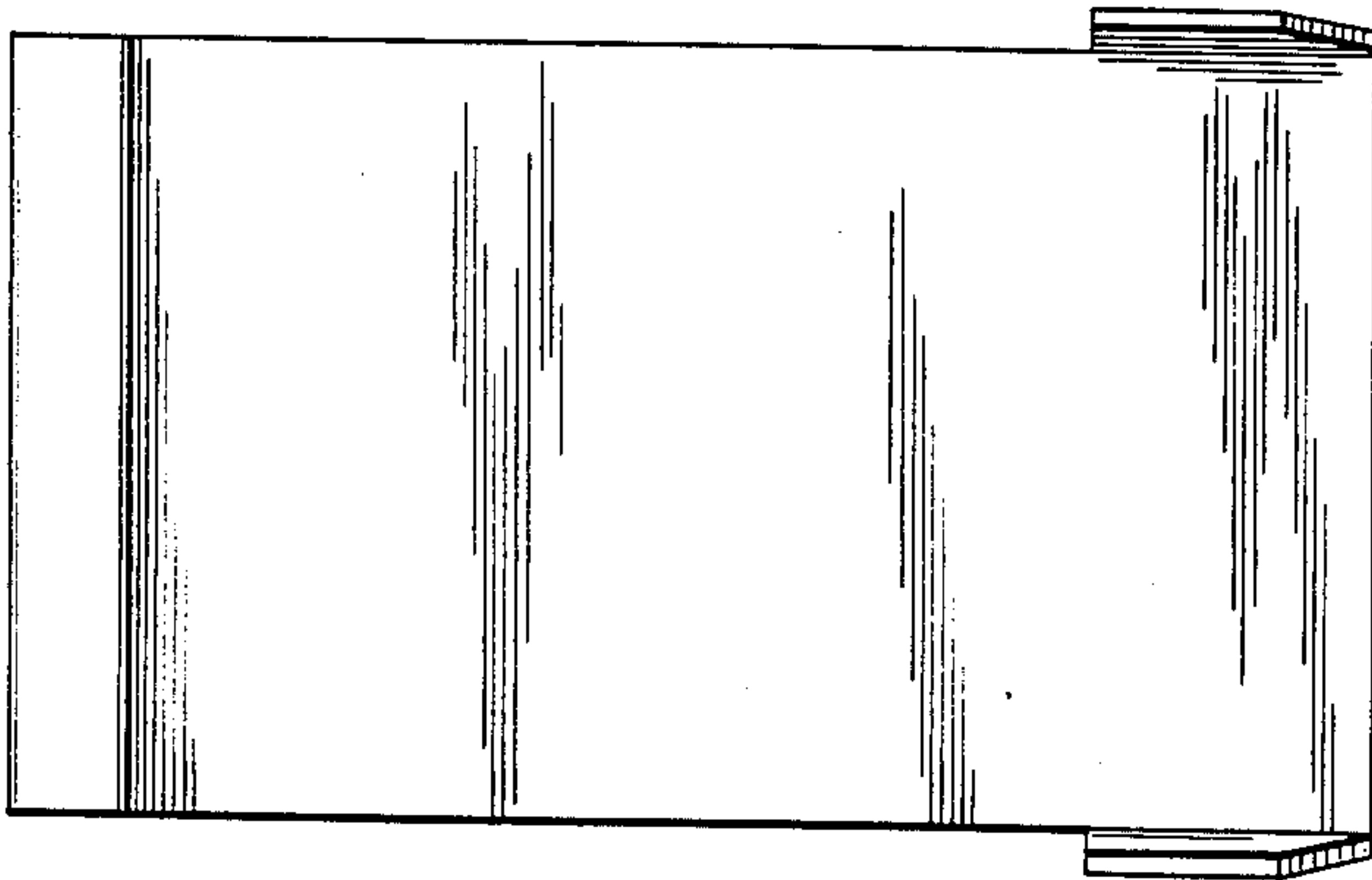

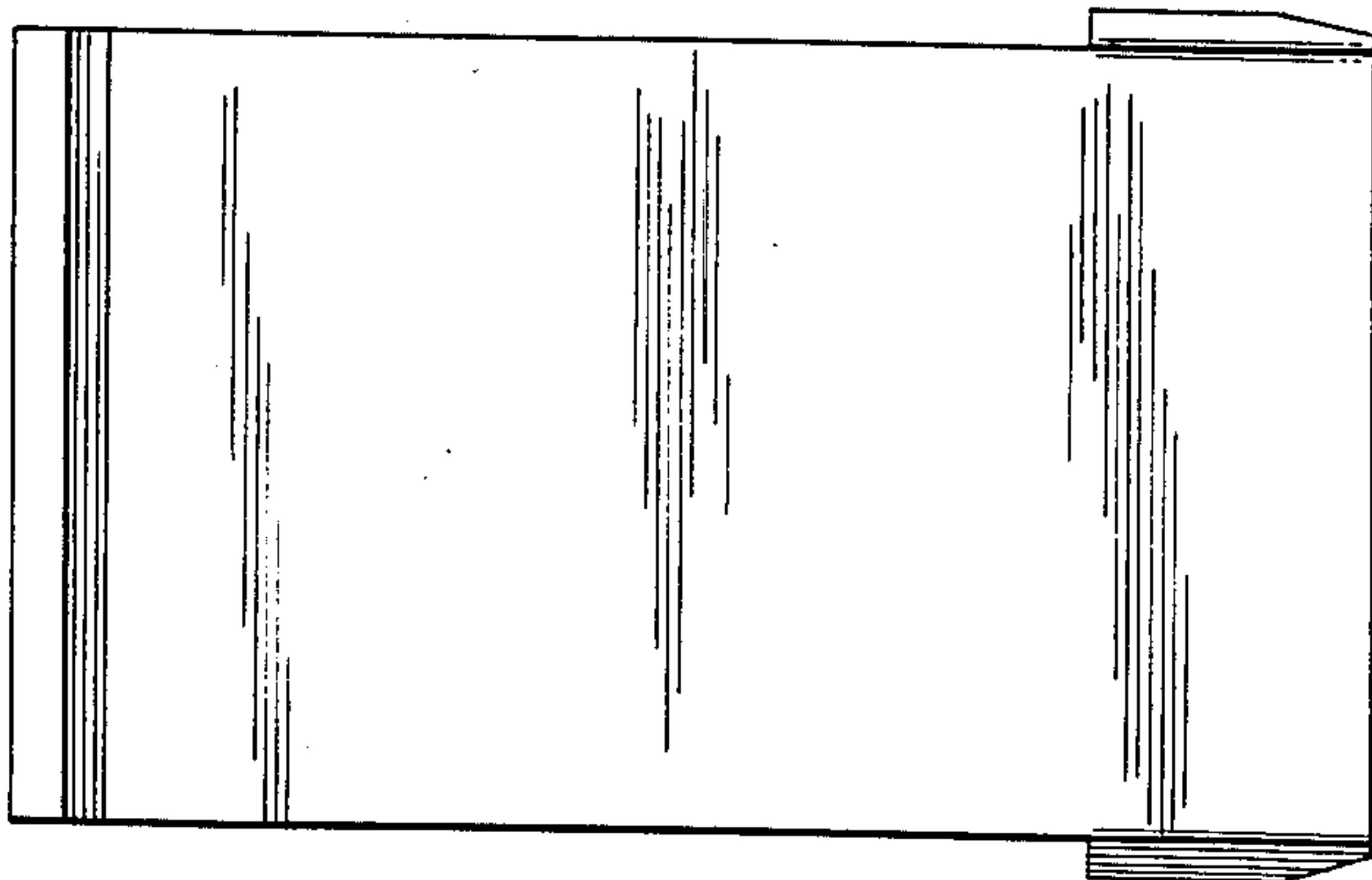
