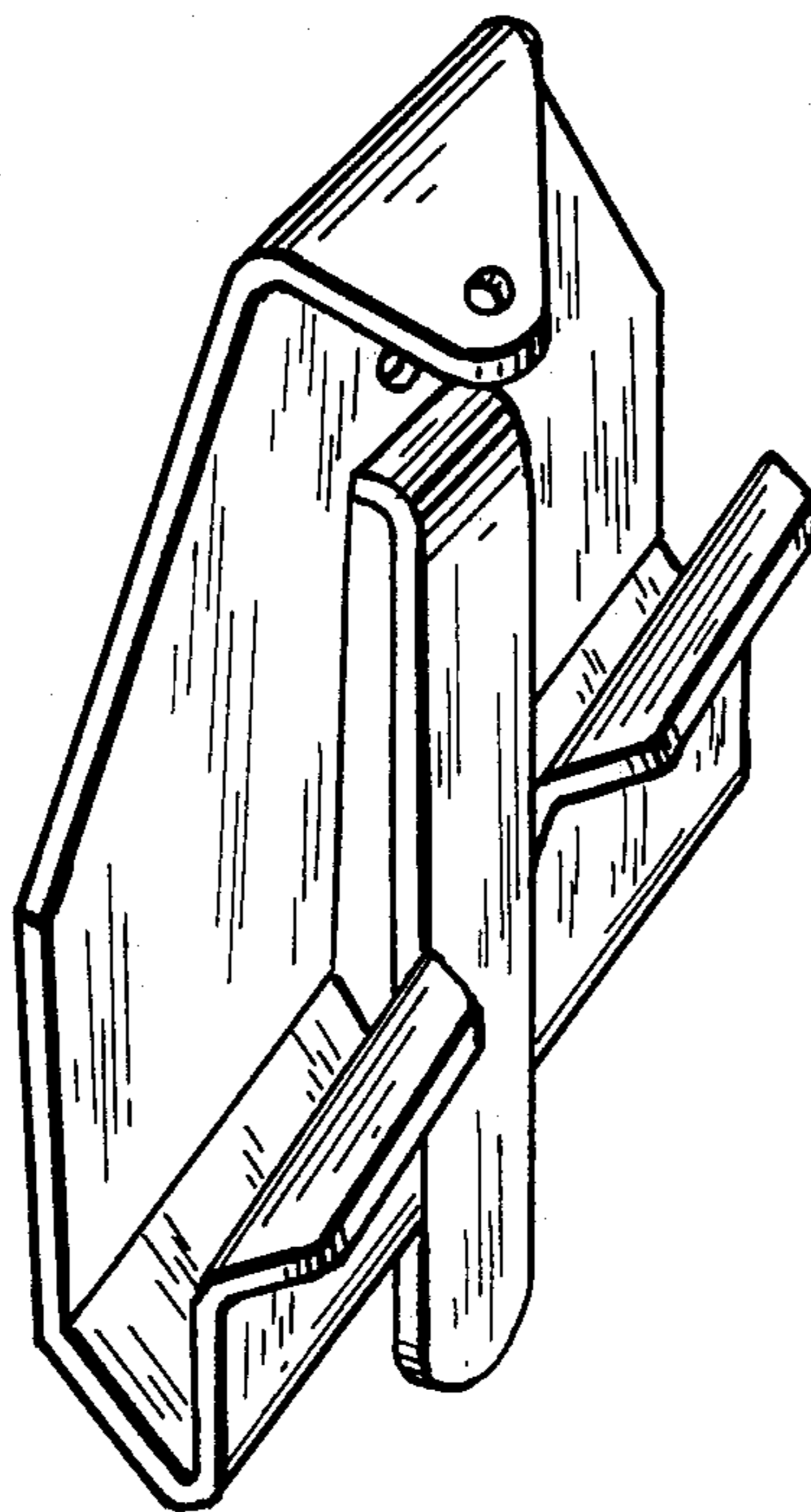

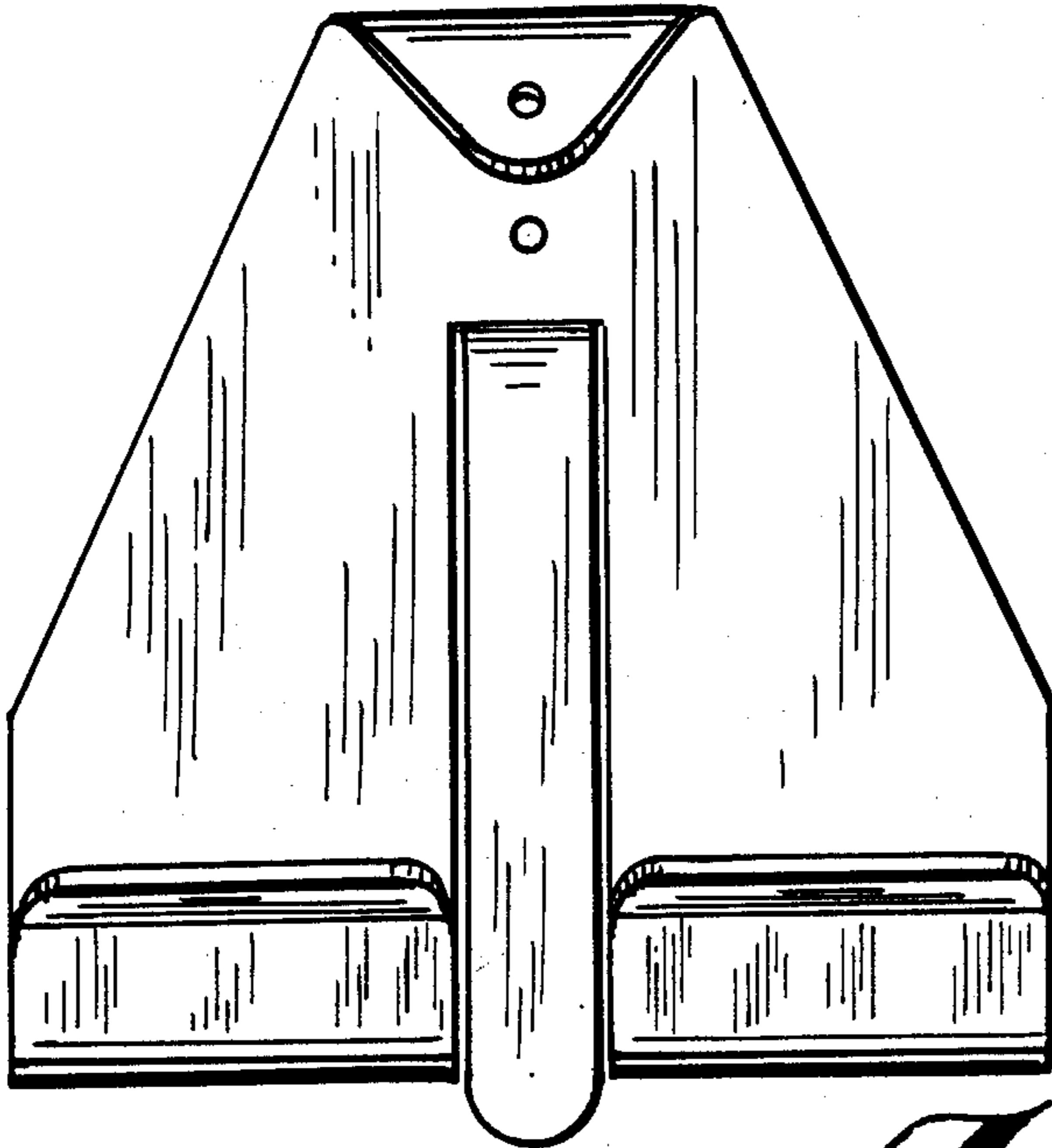

### DESCRIPTION

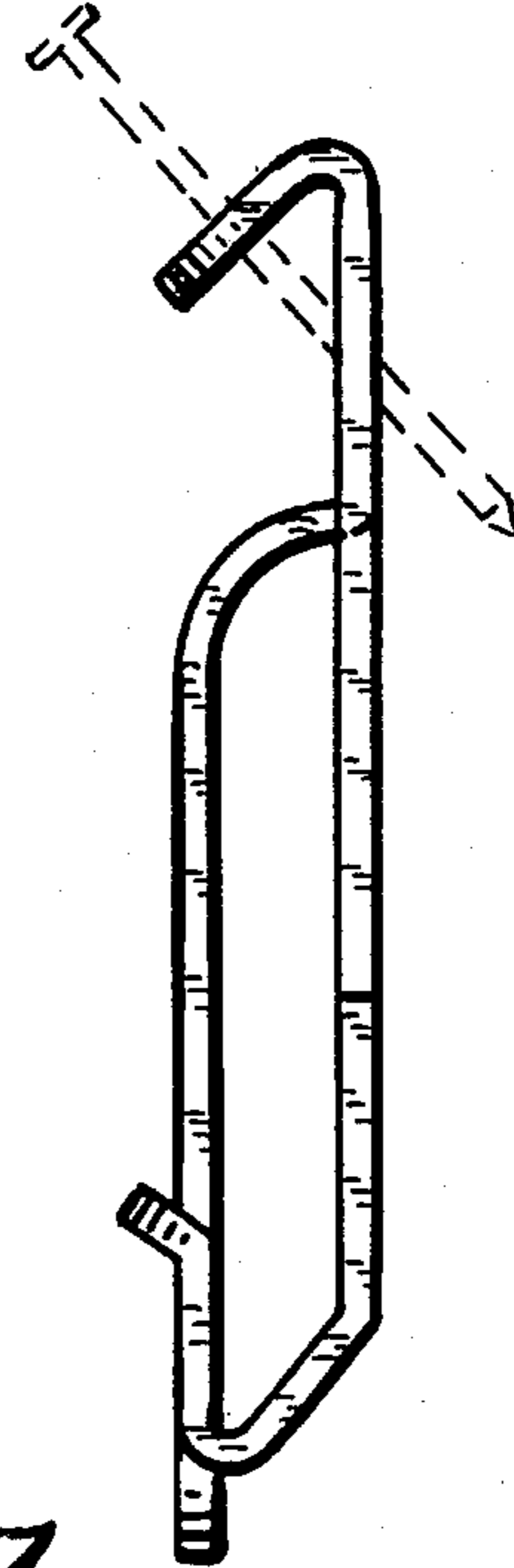
FIGS. 1 and 2 are respectively front and rear elevational views thereof;  
FIGS. 3 and 4 are respectively top and bottom plan views thereof;  
FIGS. 5 and 6 are respectively left side elevational views thereof, the side opposite being a mirror image;  
FIG. 7 is a front, top and right side perspective views thereof; and  
FIG. 8 is a left side, top and front perspective view thereof.  
The broken line showing of a nail in FIG. 5 and a picture wire in FIG. 6 is for illustrative purposes only and forms no part of the claimed design.



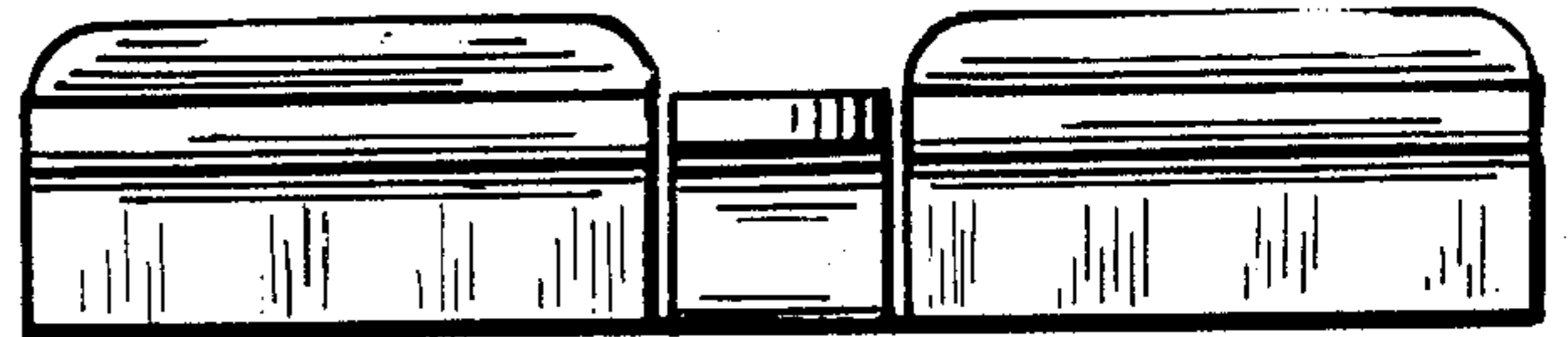

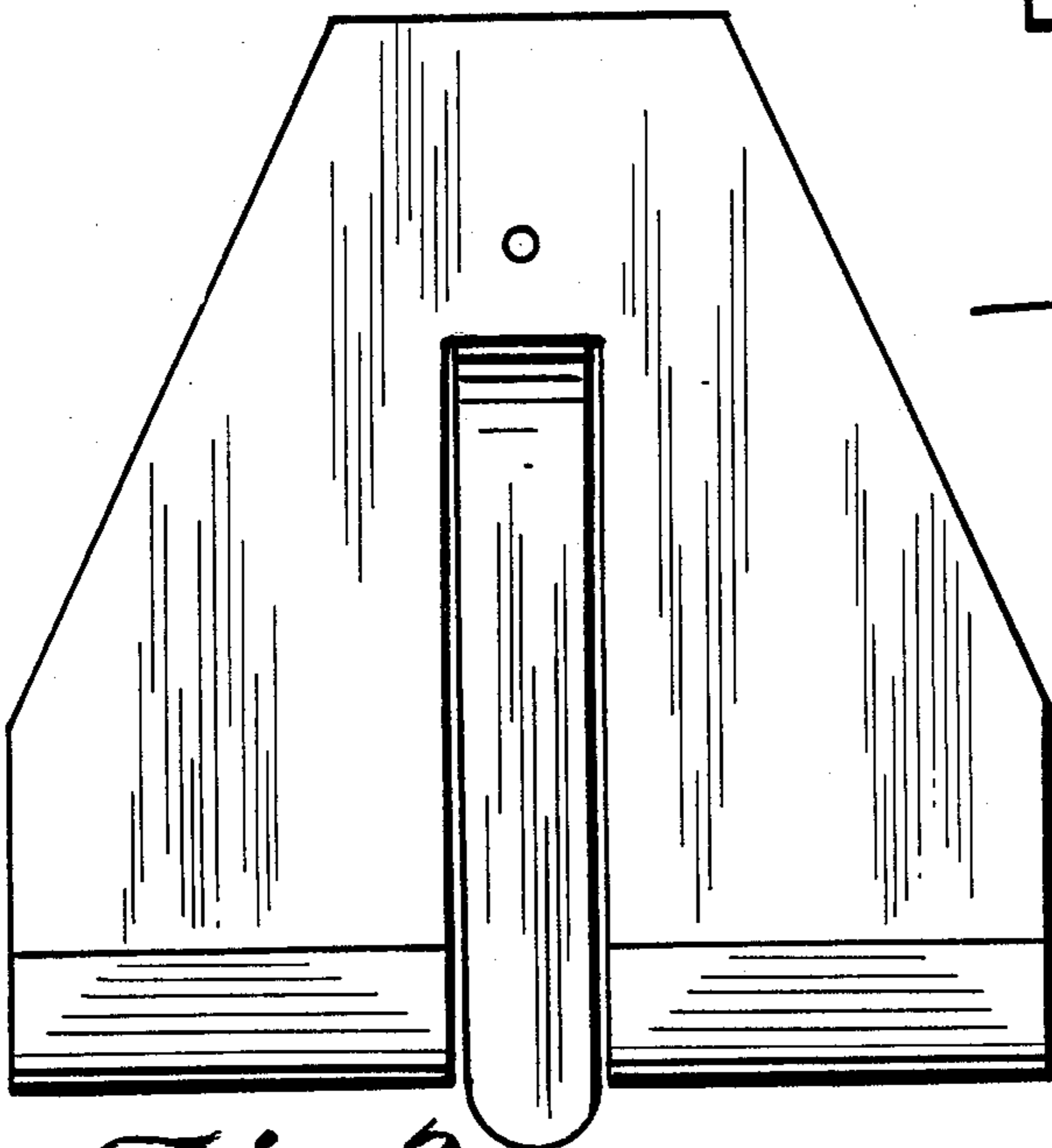

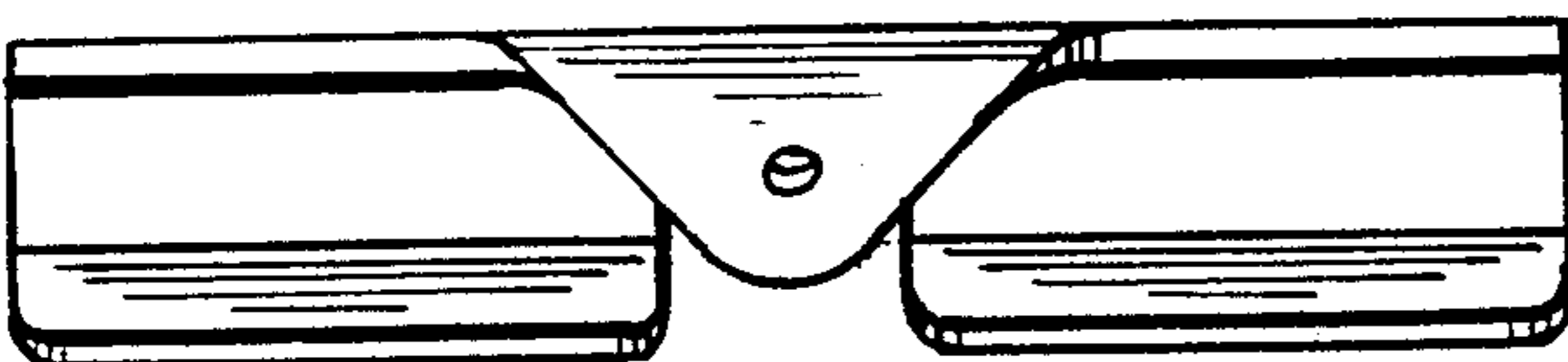

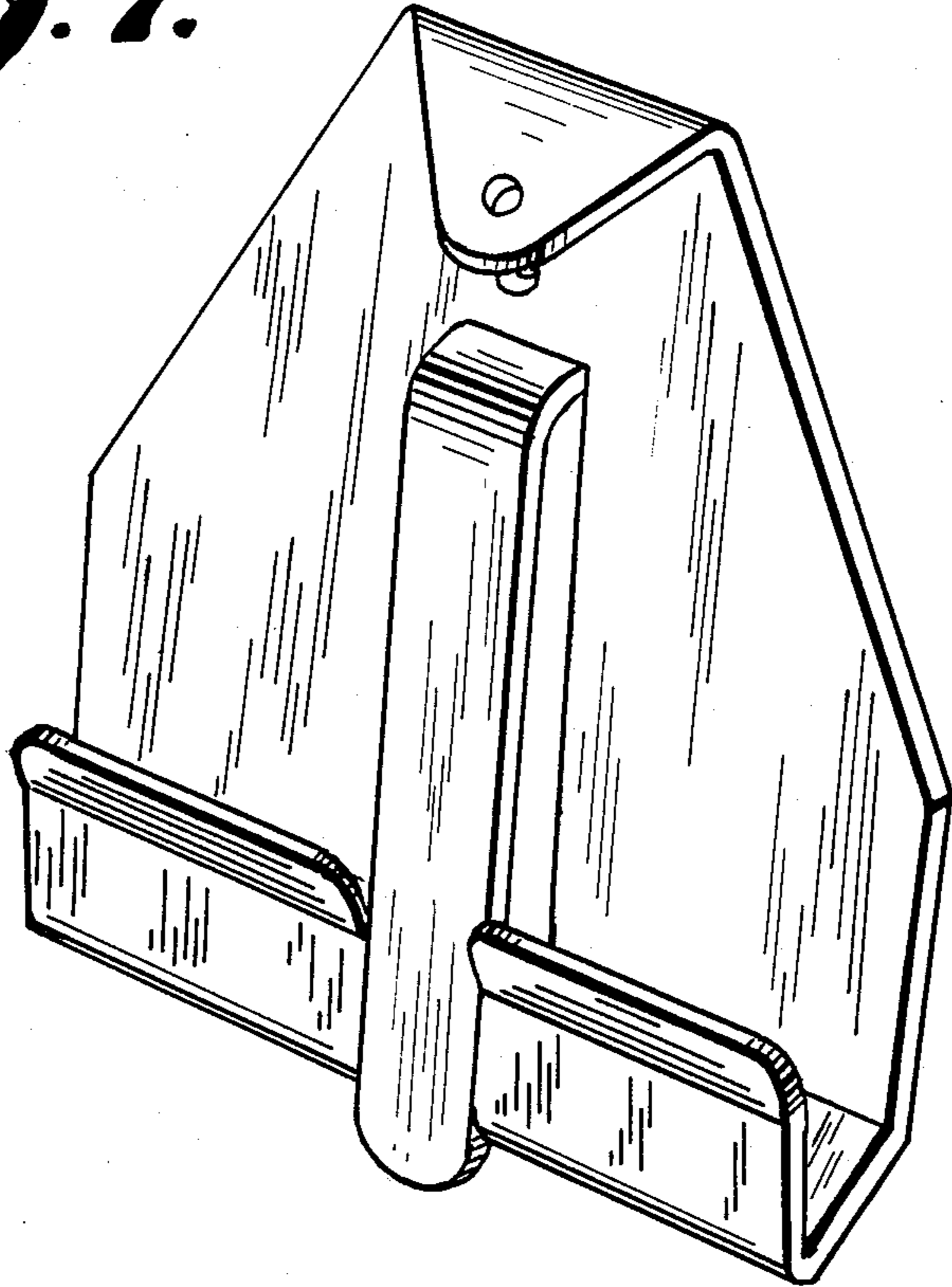
