[57] CLAIM

The ornamental design for a combined telephone handset and stand, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a combined telephone handset and stand, showing our new design in cradled relationship;

FIG. 2 is a top plan view of the stand alone;

FIG. 3 is a left side elevational view of the stand alone;

FIG. 4 is a left side elevational view of the handset and stand in cradled relationship;

FIG. 5 is a right side elevational view of stand alone;

FIG. 6 is a right side elevational view of the handset and stand in cradled relationship;

FIG. 7 is a rear elevational view of the handset and stand together;

FIG. 8 is a rear elevational view of stand alone;

FIG. 9 is a front elevational view of the handset and stand together;

FIG. 10 is a front elevational view of stand alone;

FIG. 11 is a bottom plan view of the handset alone;

FIG. 12 is a top plan view of the handset alone;

FIG. 13 is a right side elevational view of the handset alone;

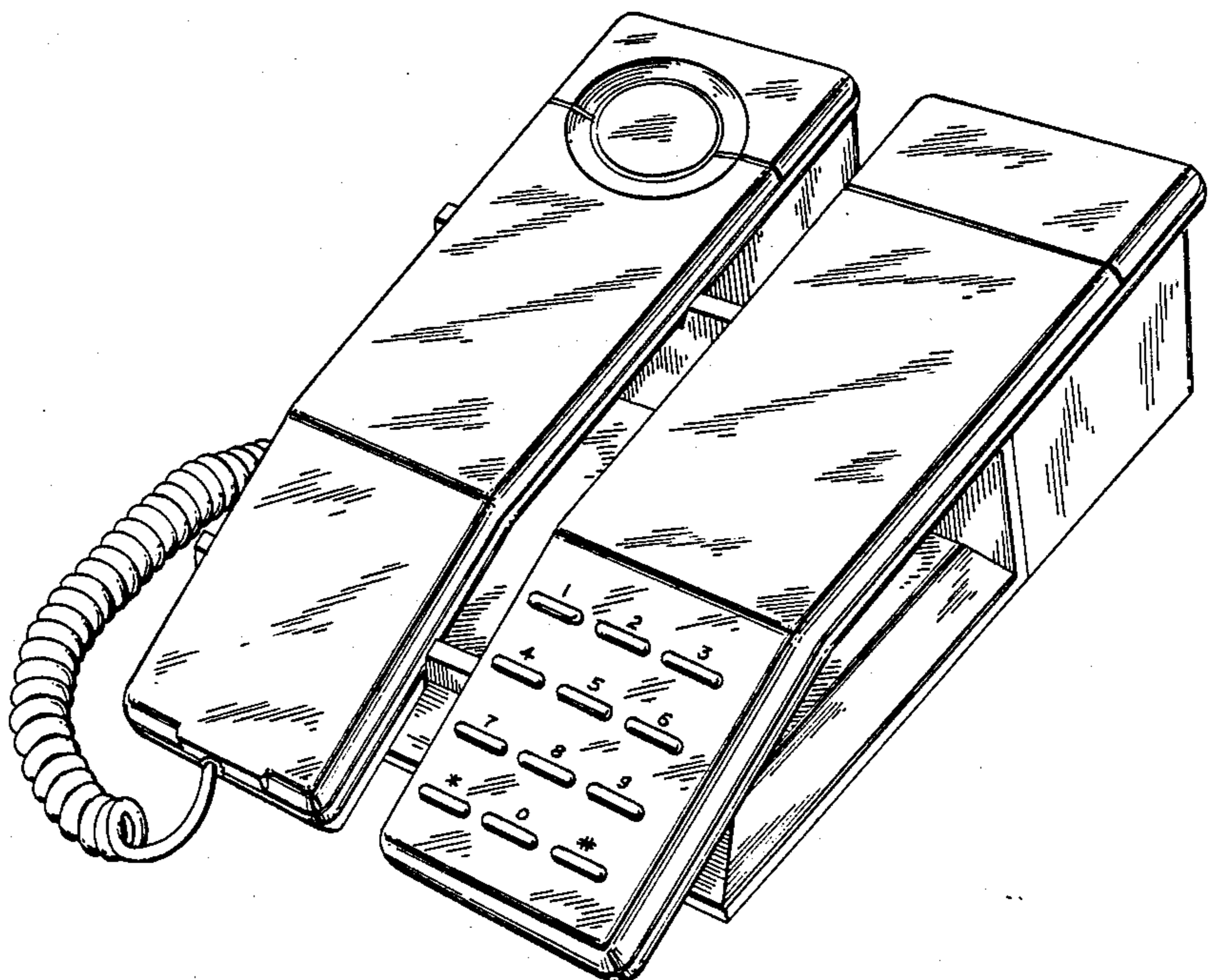
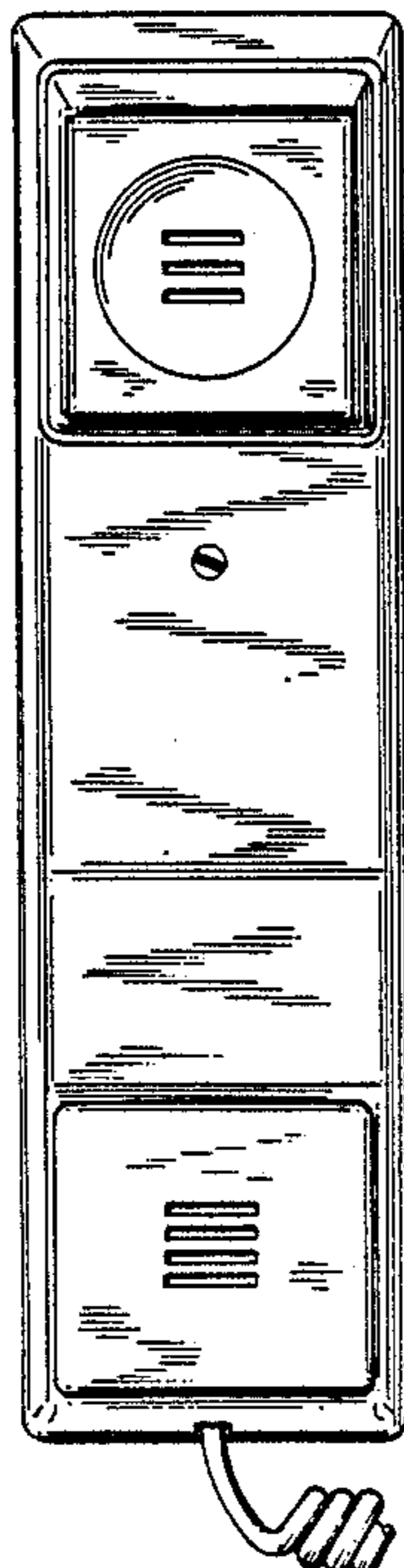
FIG. 14 is a left side elevational view of the handset alone;

FIG. 15 is a rear elevational view of the handset alone;

FIG. 16 is a front elevational view thereof; and

FIG. 17 is an isometric view of the handset and stand in cradled relationship.

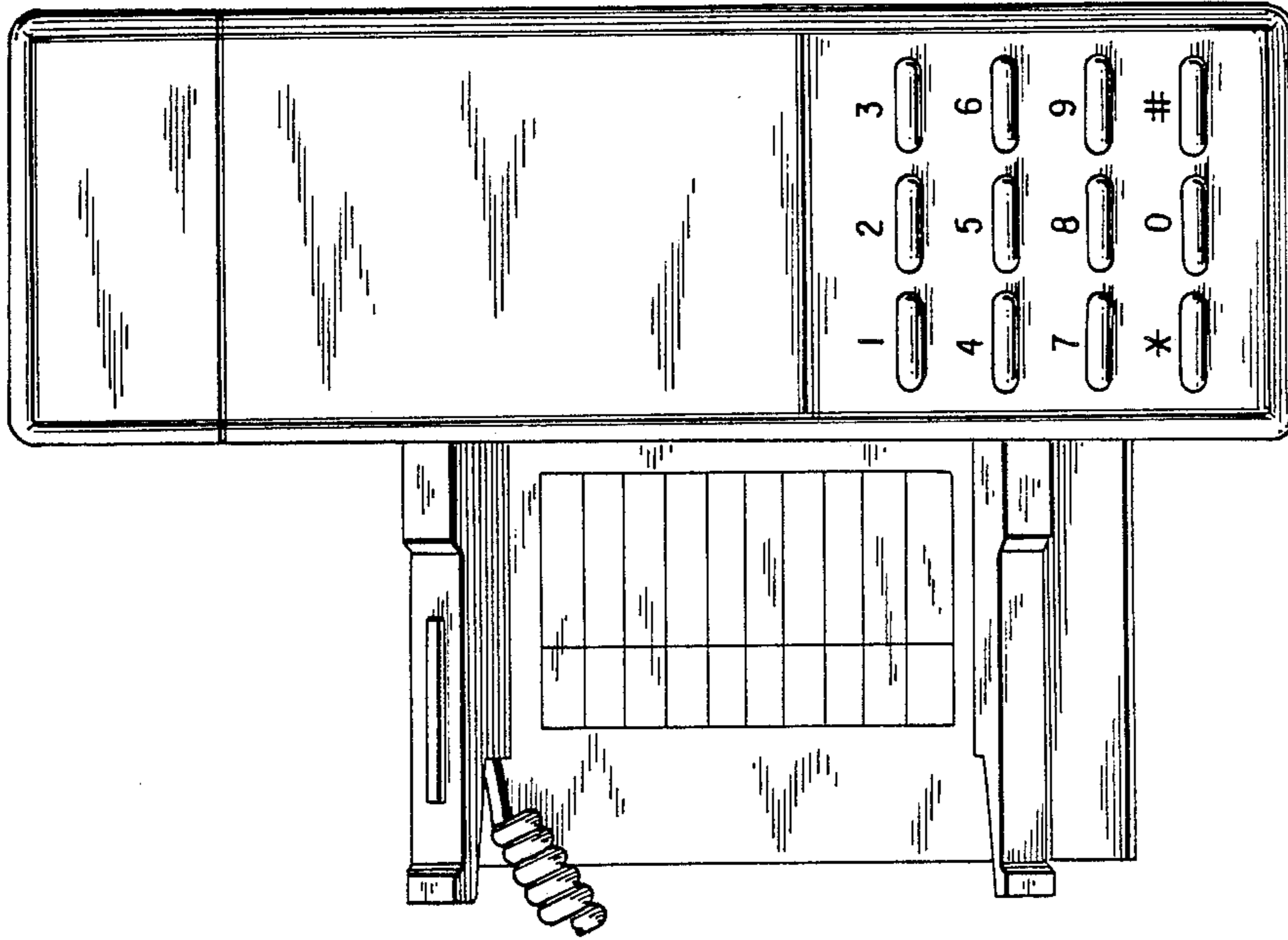

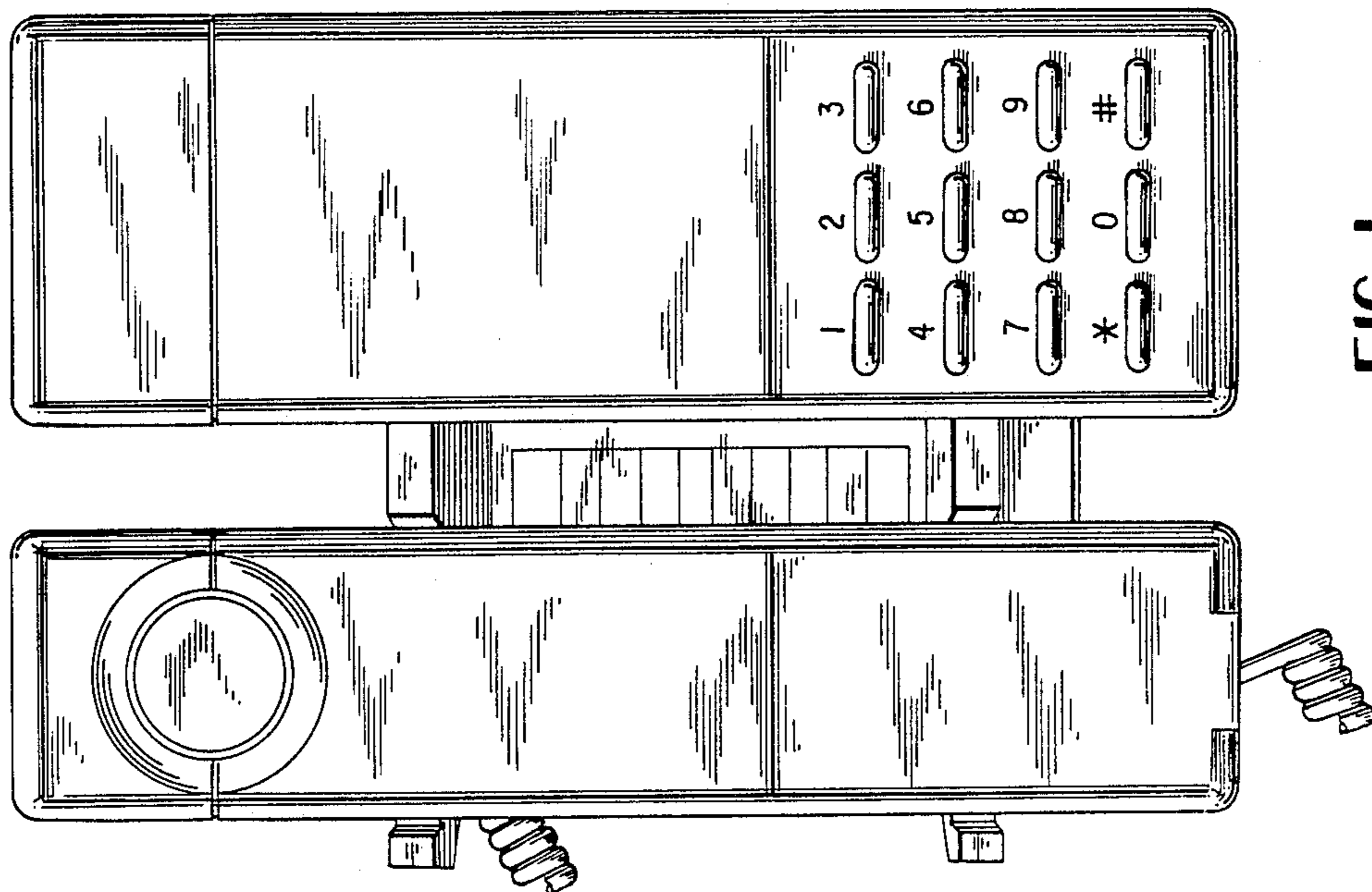

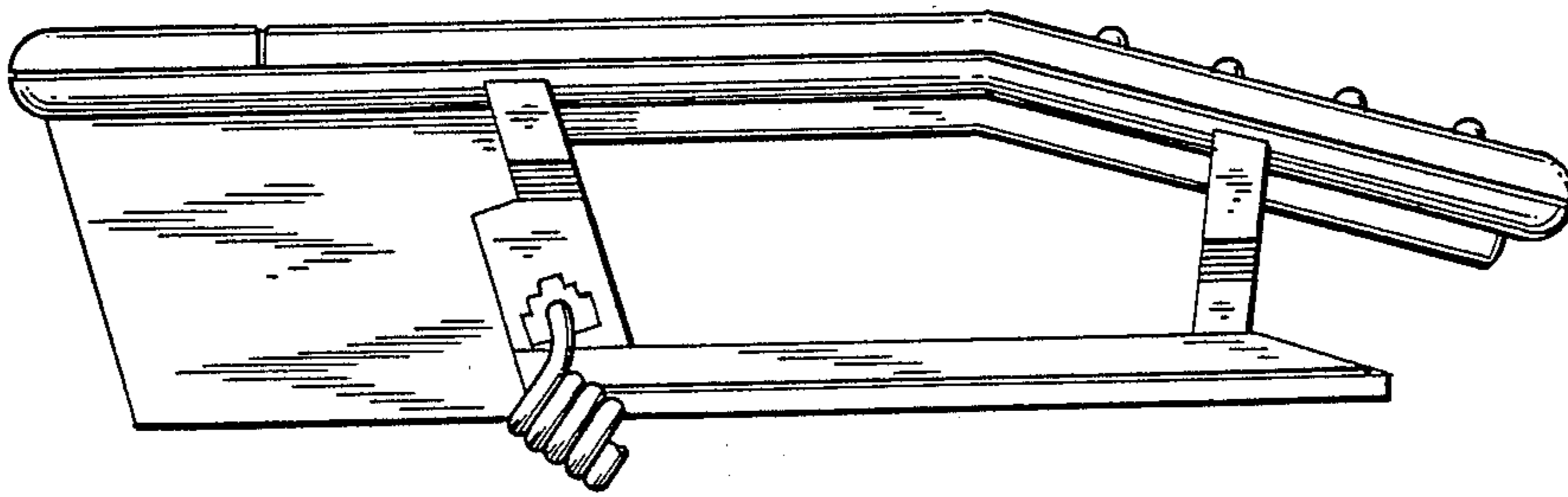

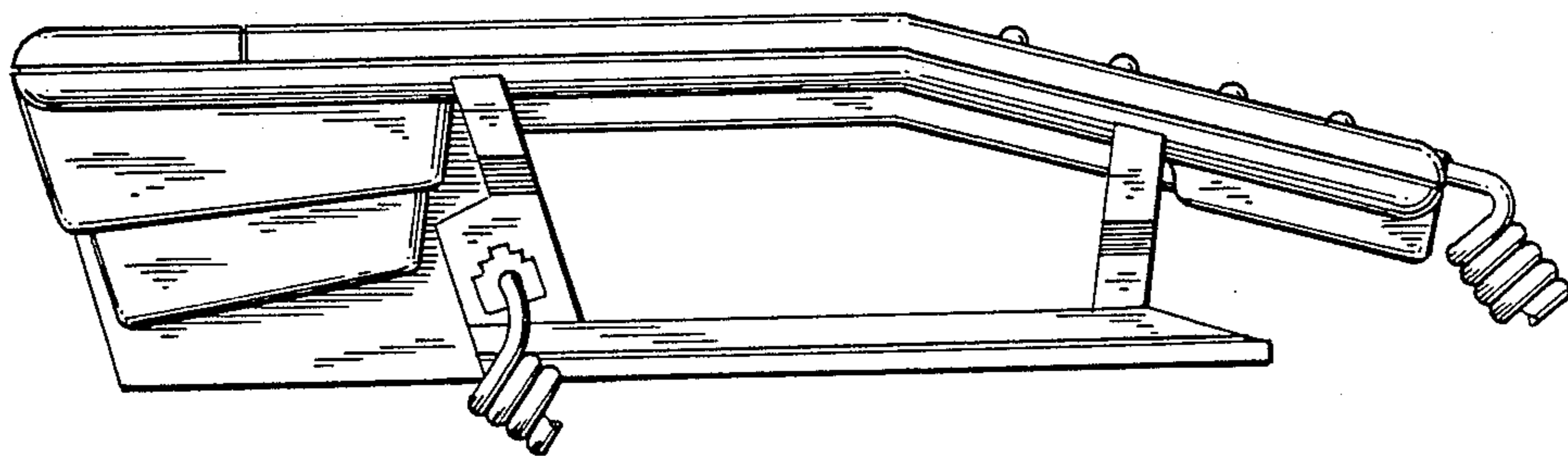

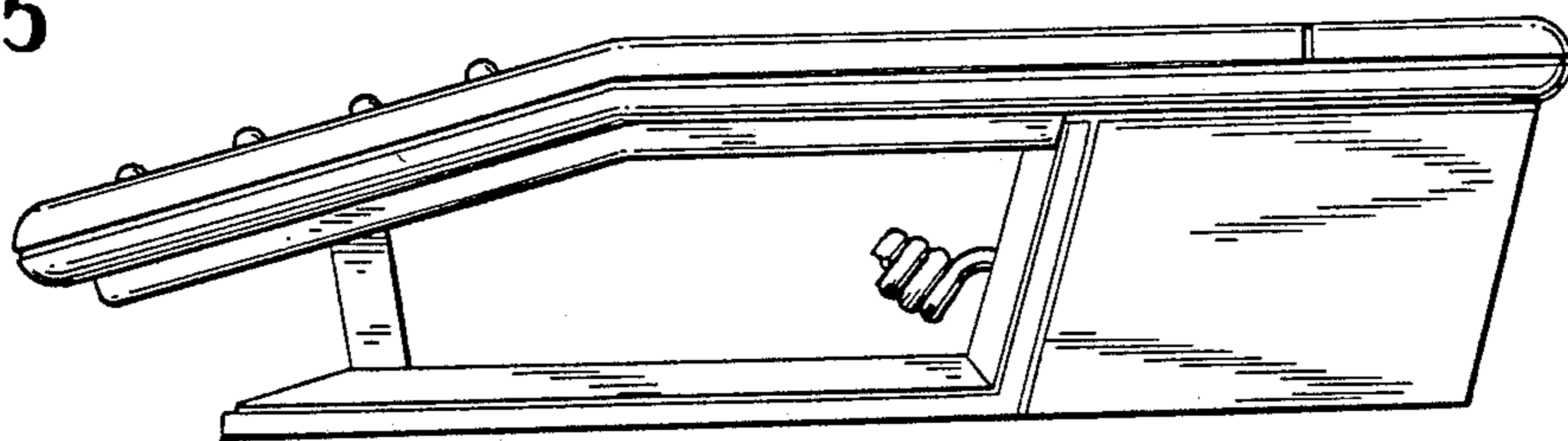

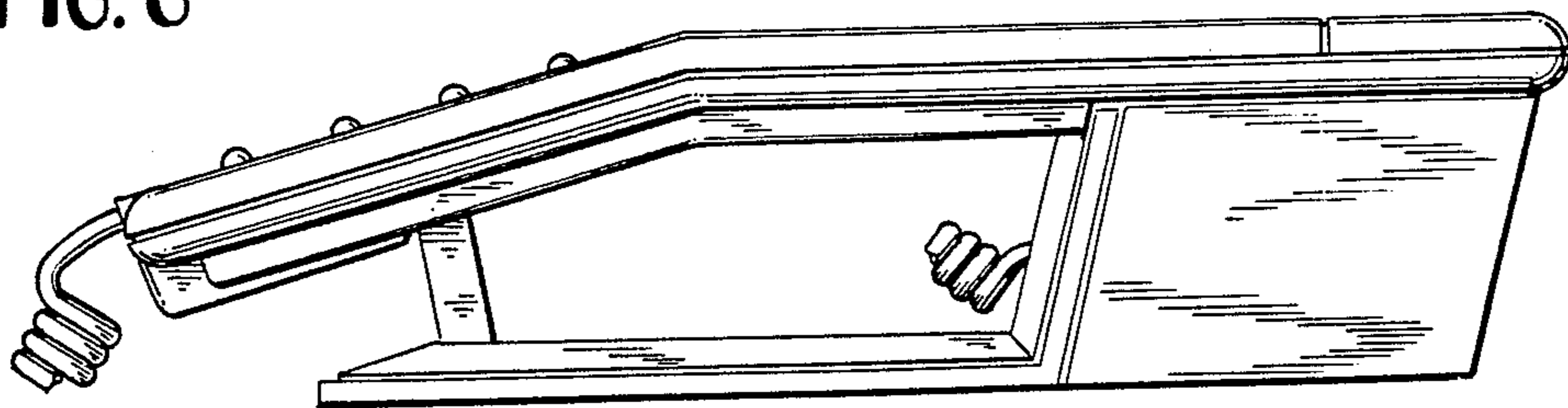

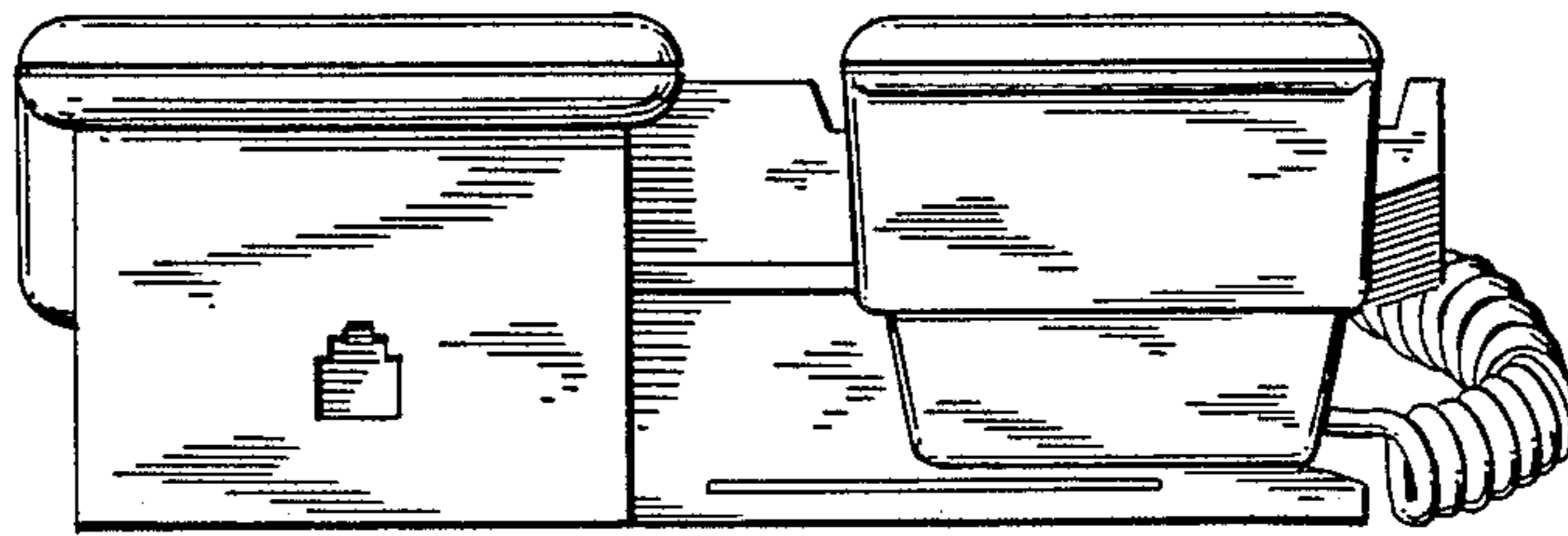

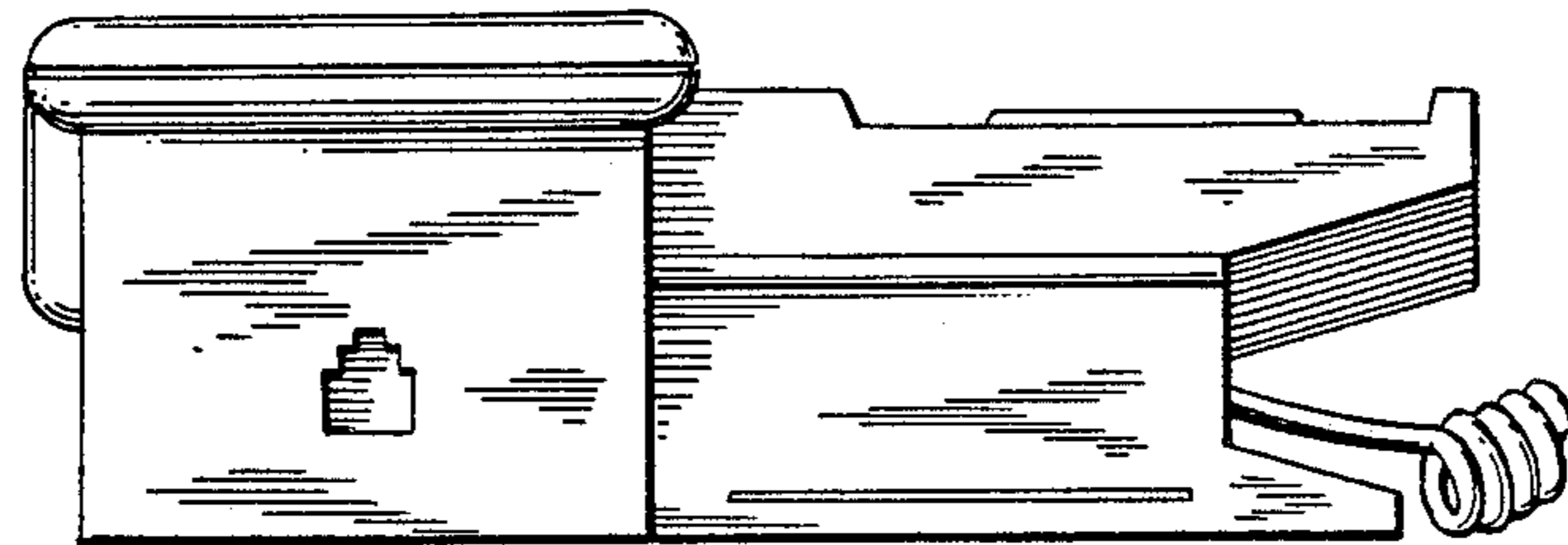

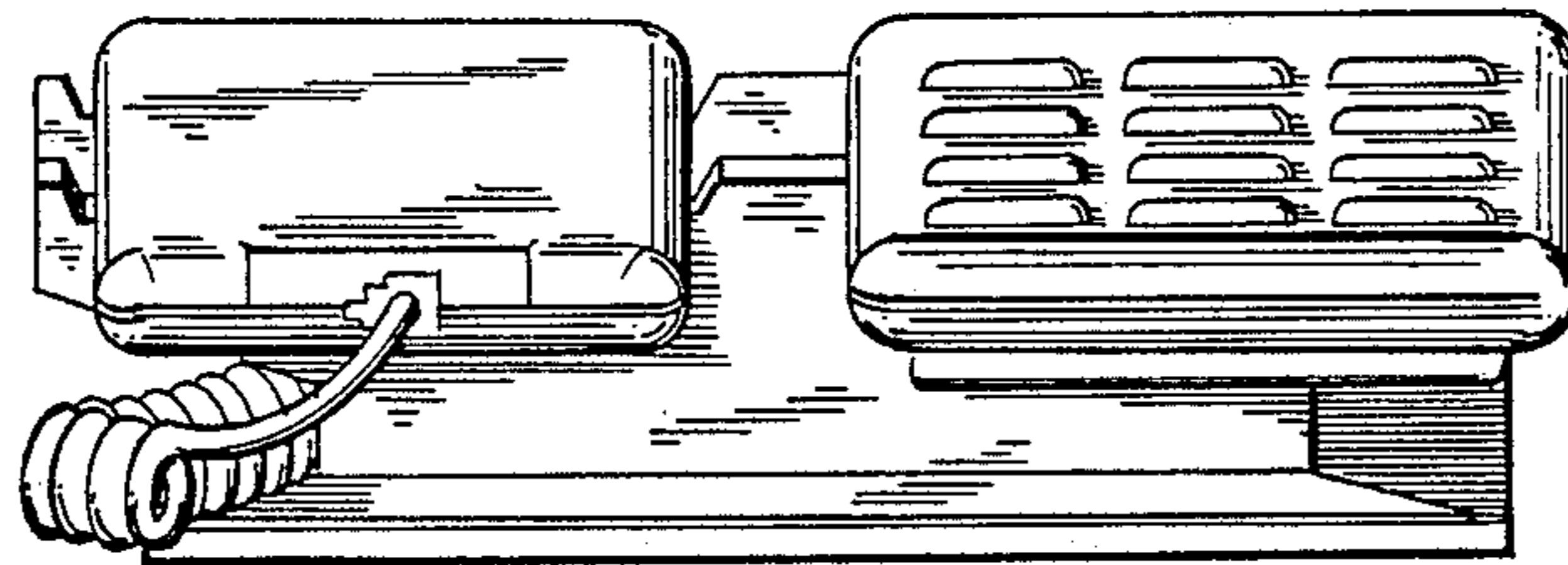
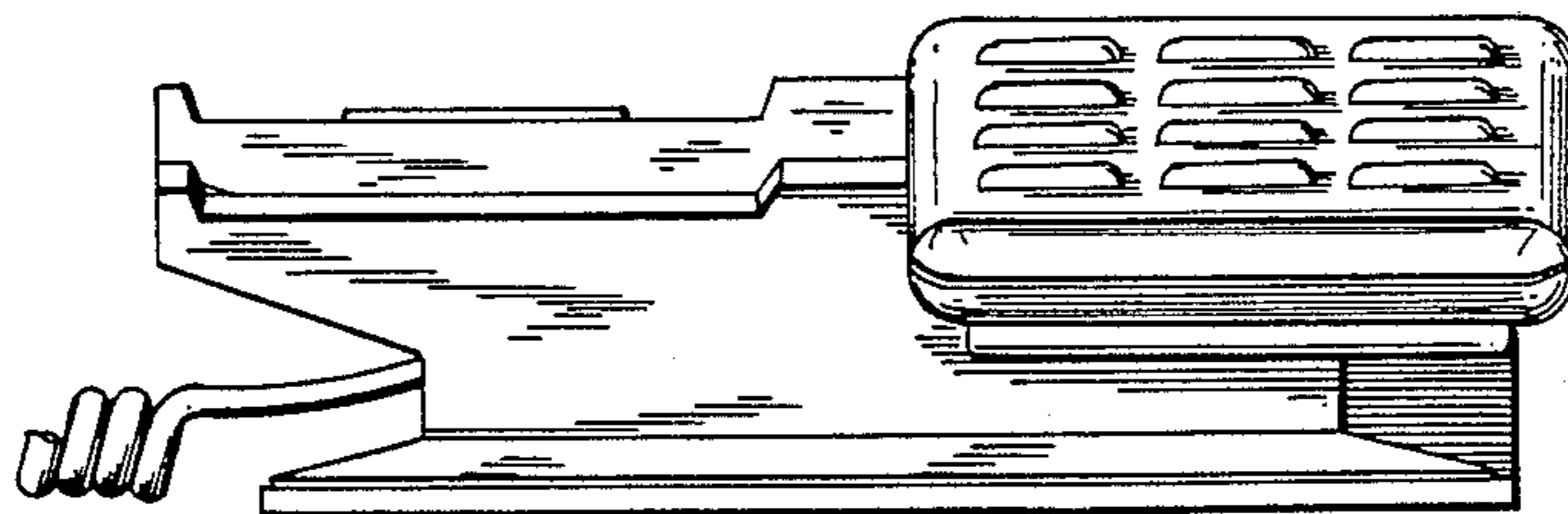

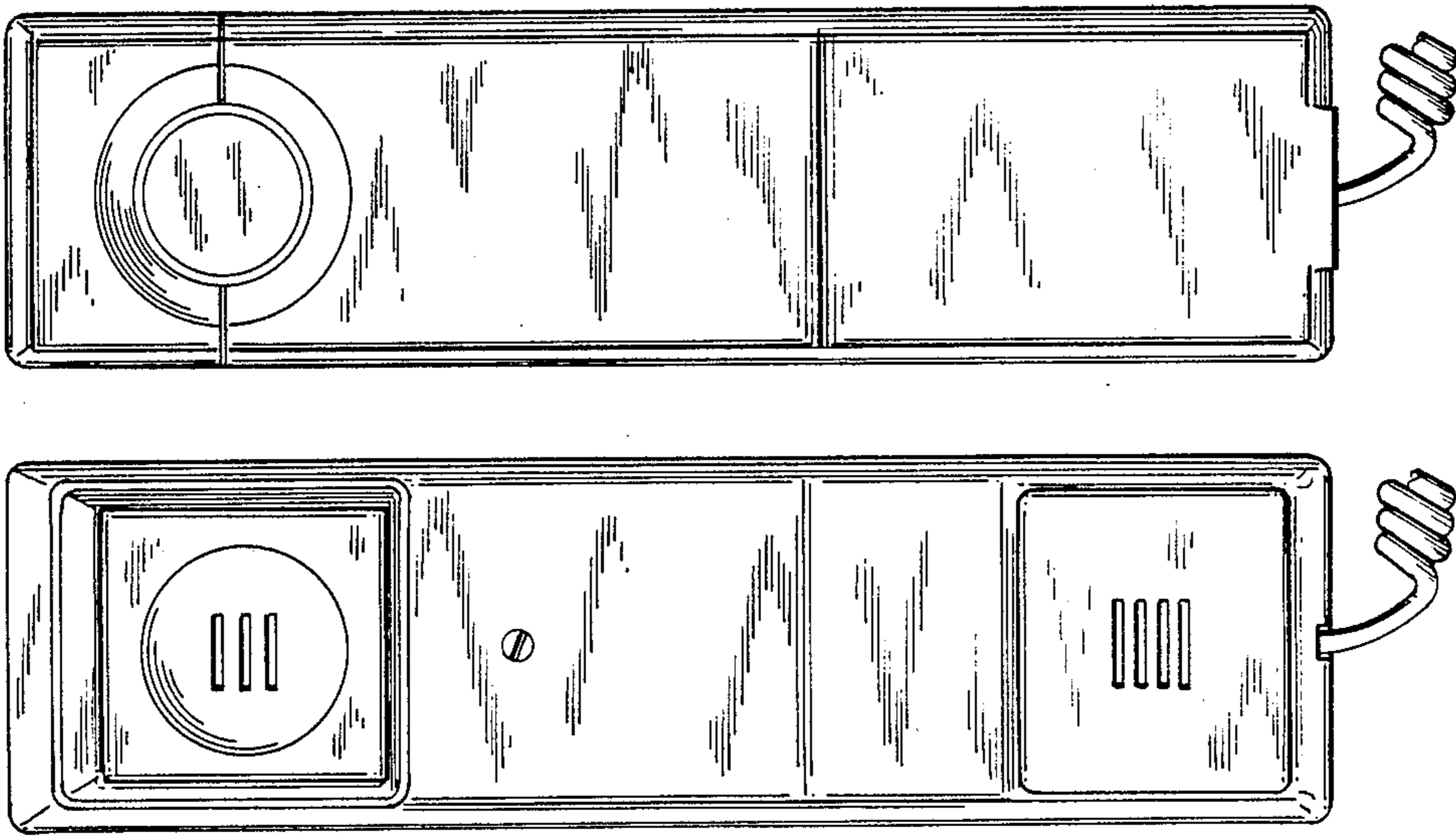

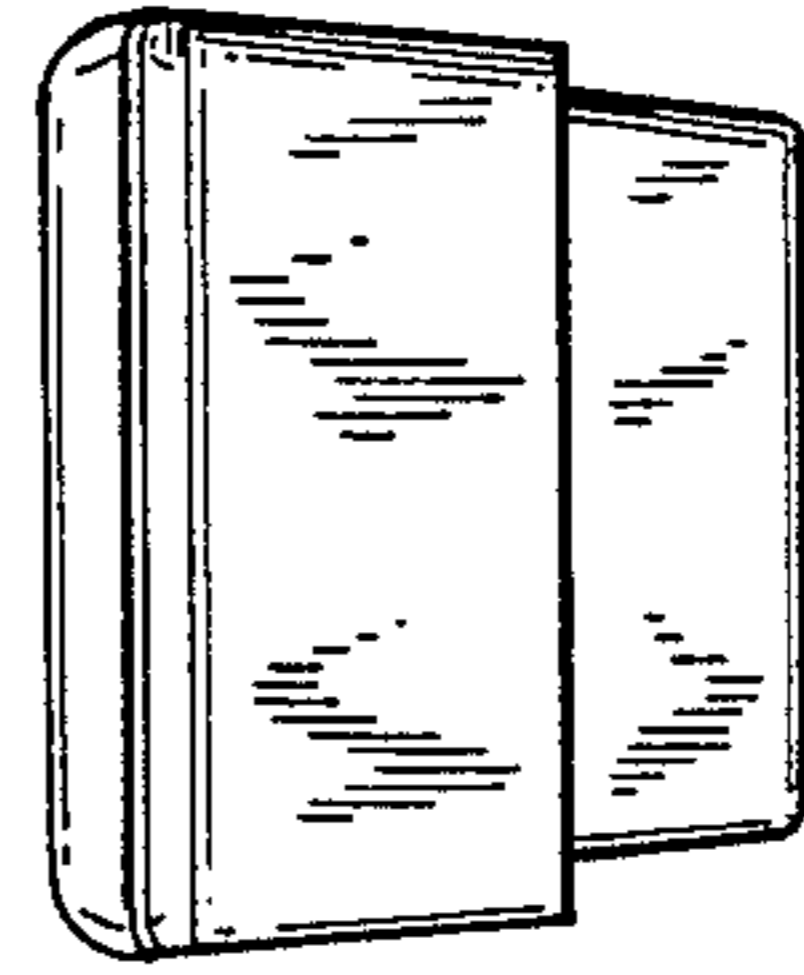

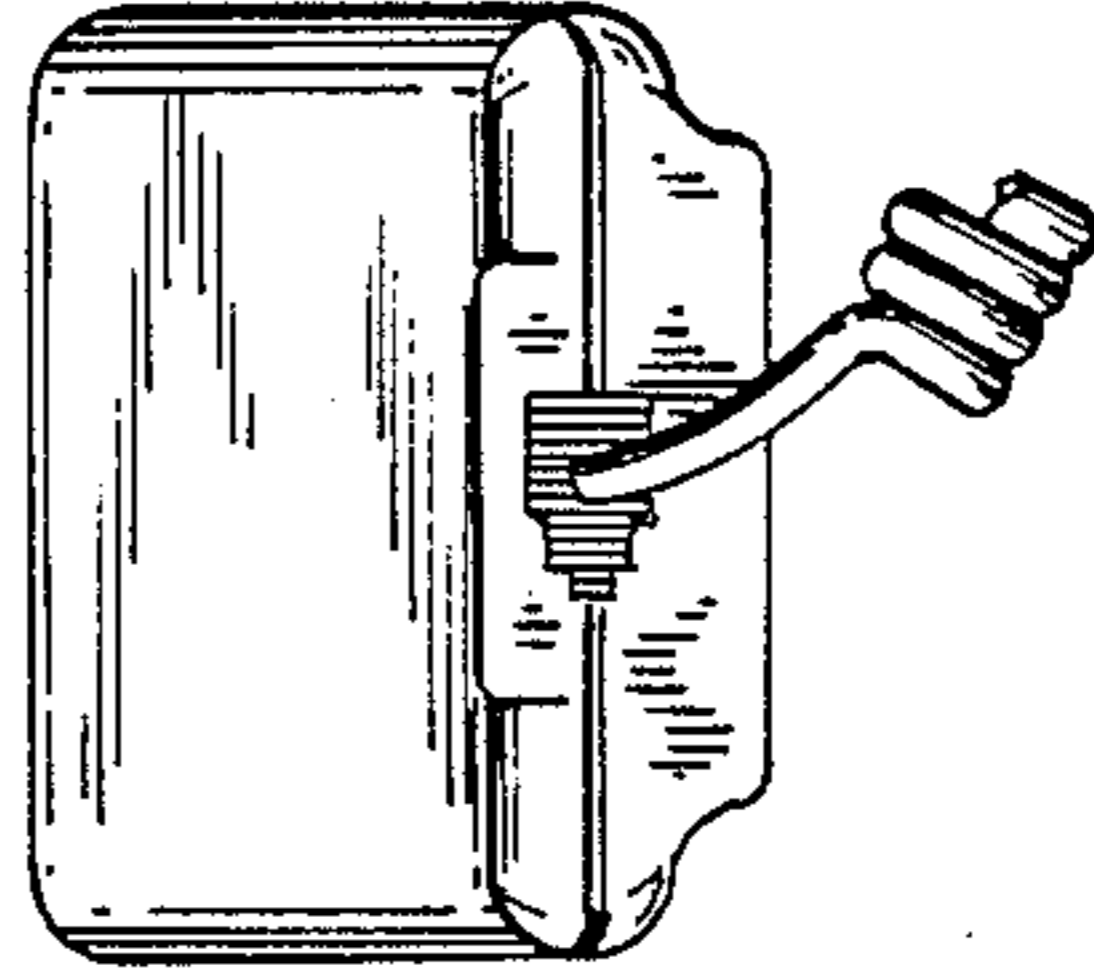

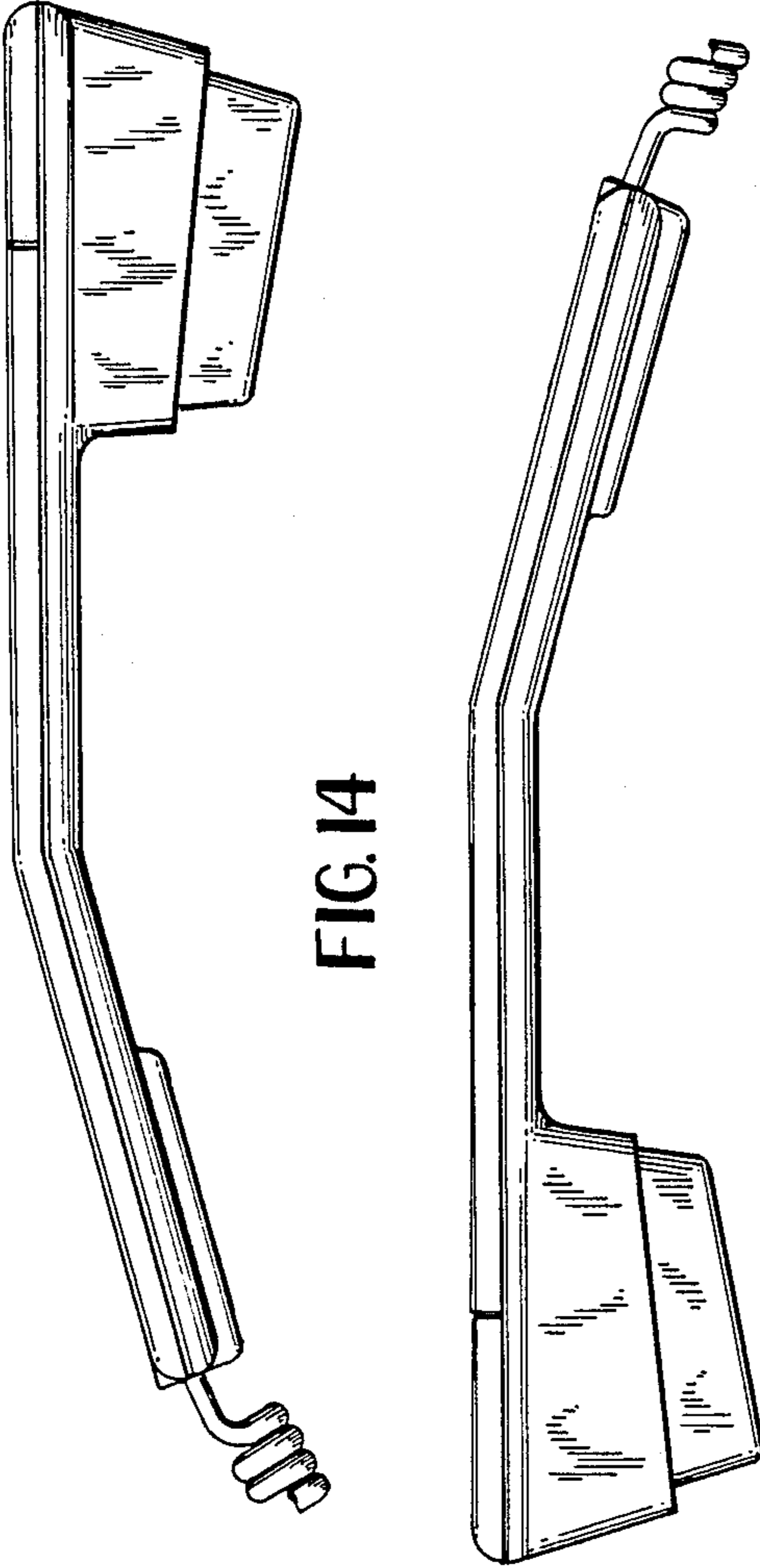

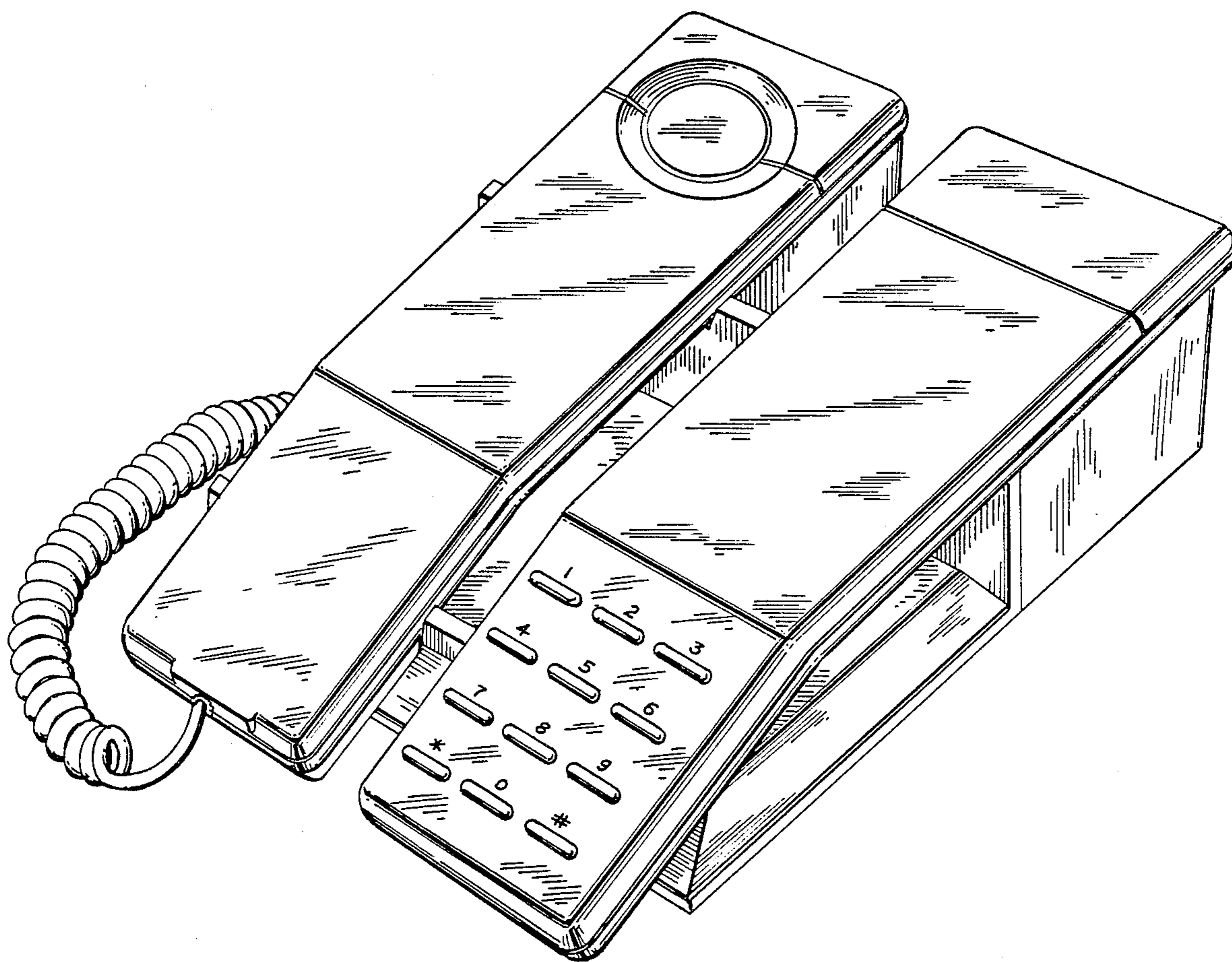
