[57] CLAIM

The ornamental design for a combination crow bar/-shovel tool, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the combination crow bar and shovel showing my new design;

FIG. 2 is a side elevational view of the foot engaging portion thereof;

FIG. 3 is an opposite side elevational view of the foot engaging portion thereof;

FIG. 4 is a front elevational view of the foot engaging portion thereof;

FIG. 5 is a top plan view of the foot engaging portion thereof;

FIG. 6 is a bottom plan view of the foot engaging portion thereof;

FIG. 7 is a perspective view of the blade portion thereof;

FIG. 8 is a front elevational view of the blade portion thereof;

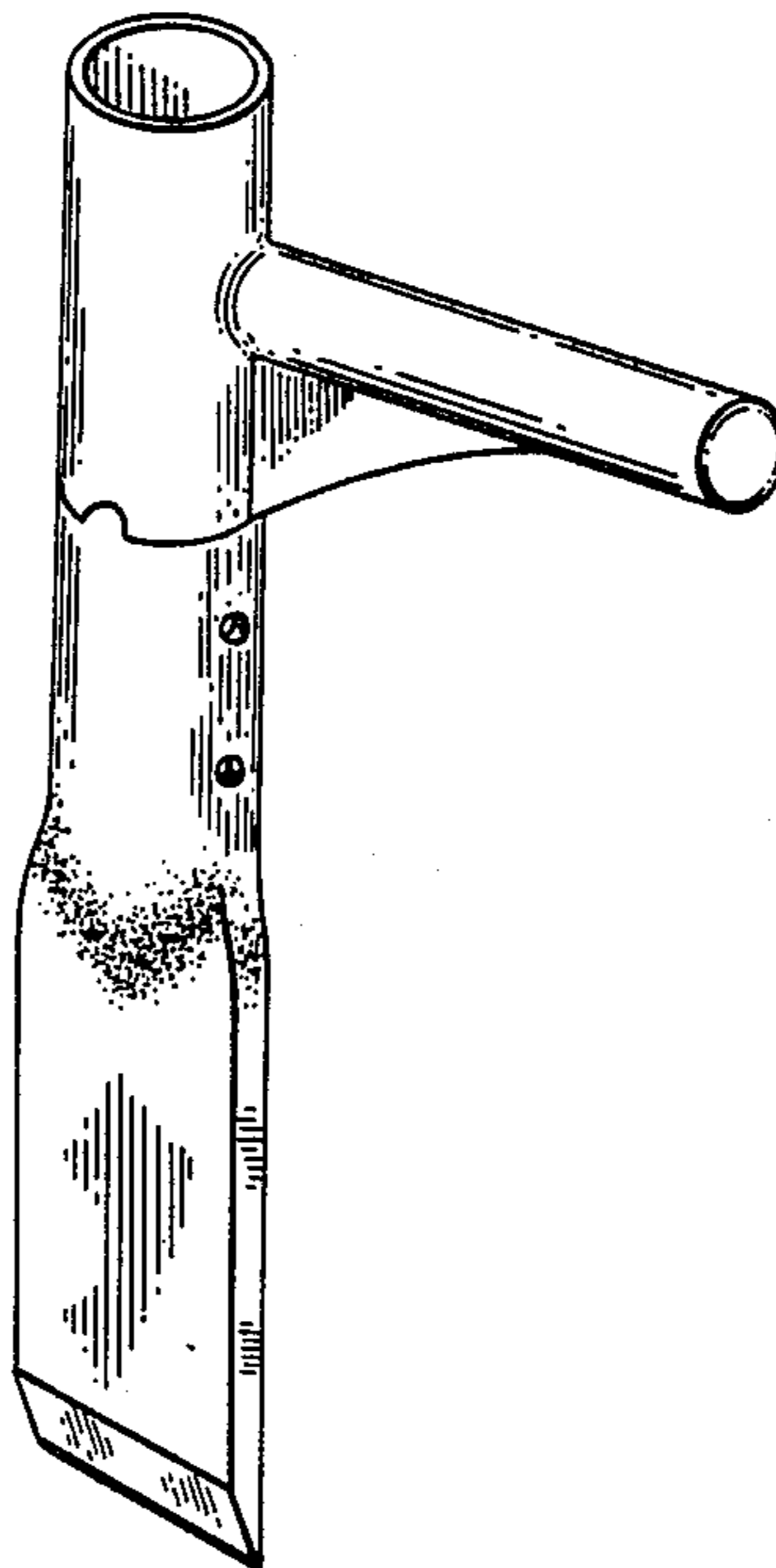
FIG. 9 is a side elevational view of the blade portion thereof;

FIG. 10 is a top plan view of the blade portion thereof;

FIG. 11 is a bottom plan view of the blade portion thereof;

FIG. 12 is a reduced rear elevational view of the blade portion thereof.

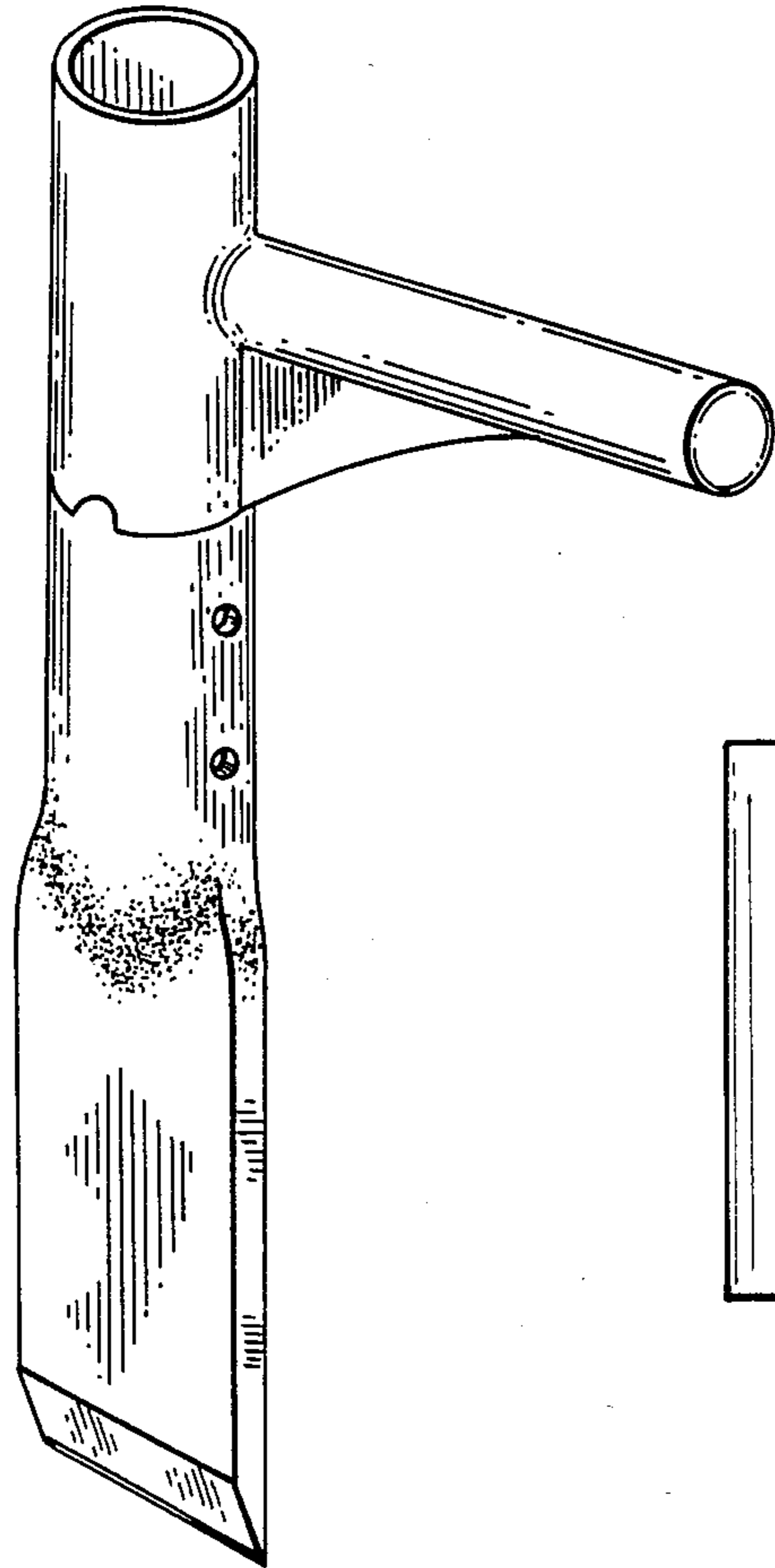

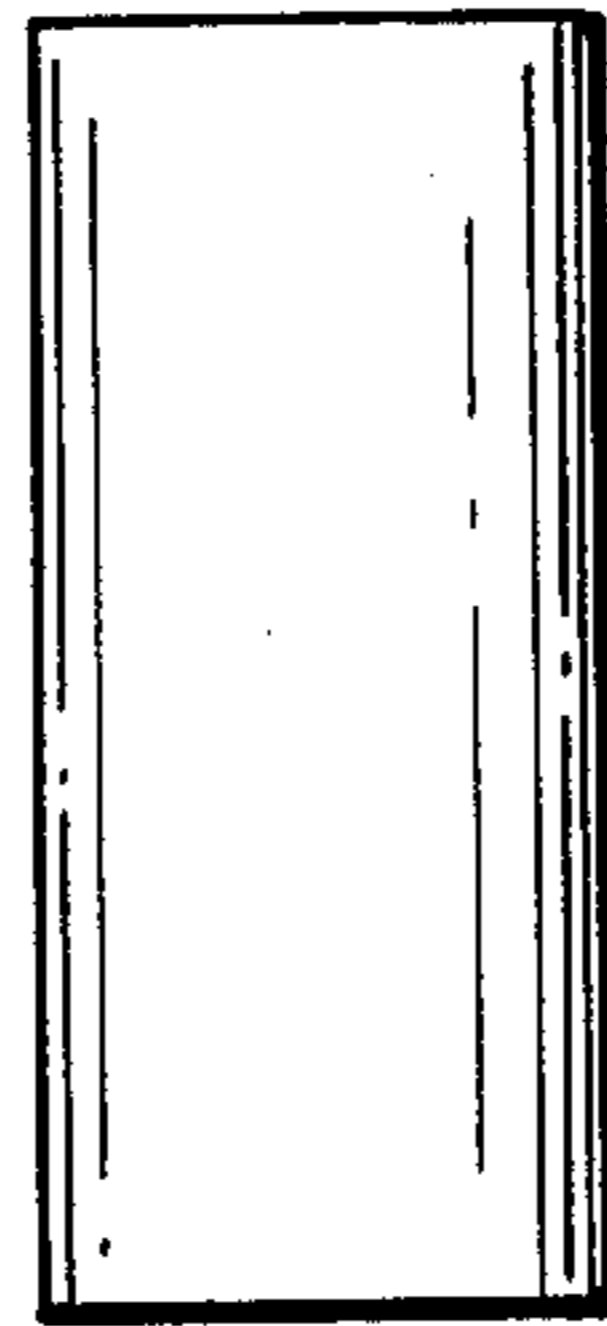

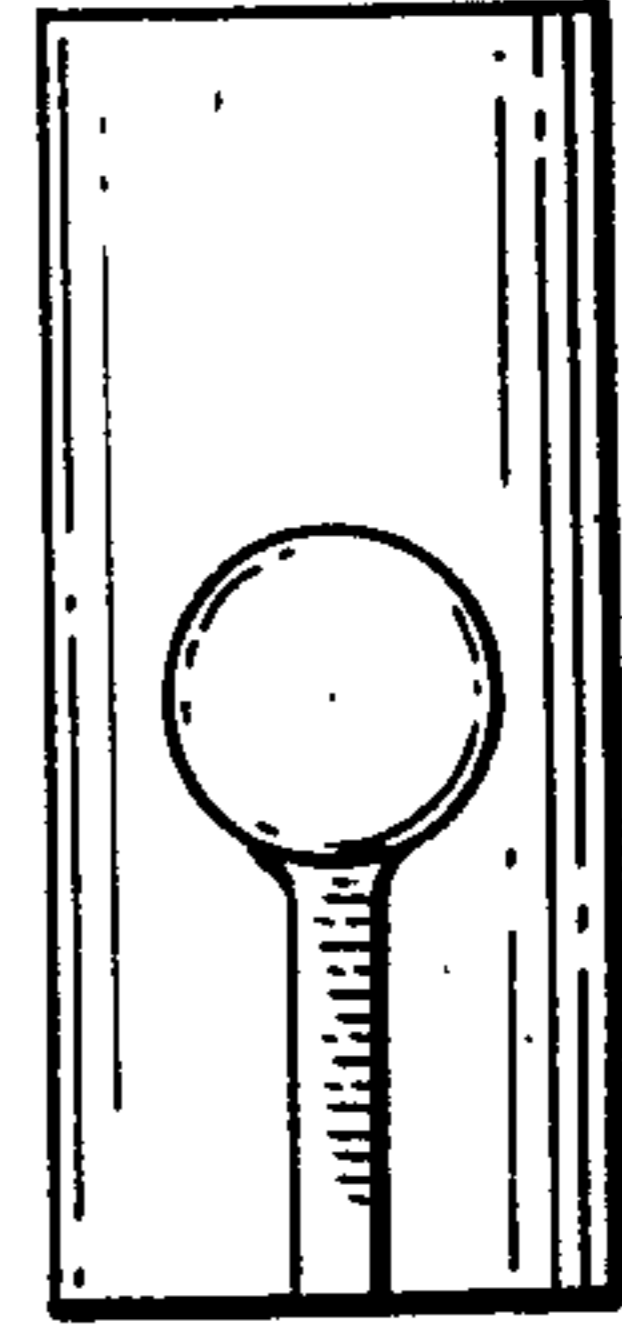

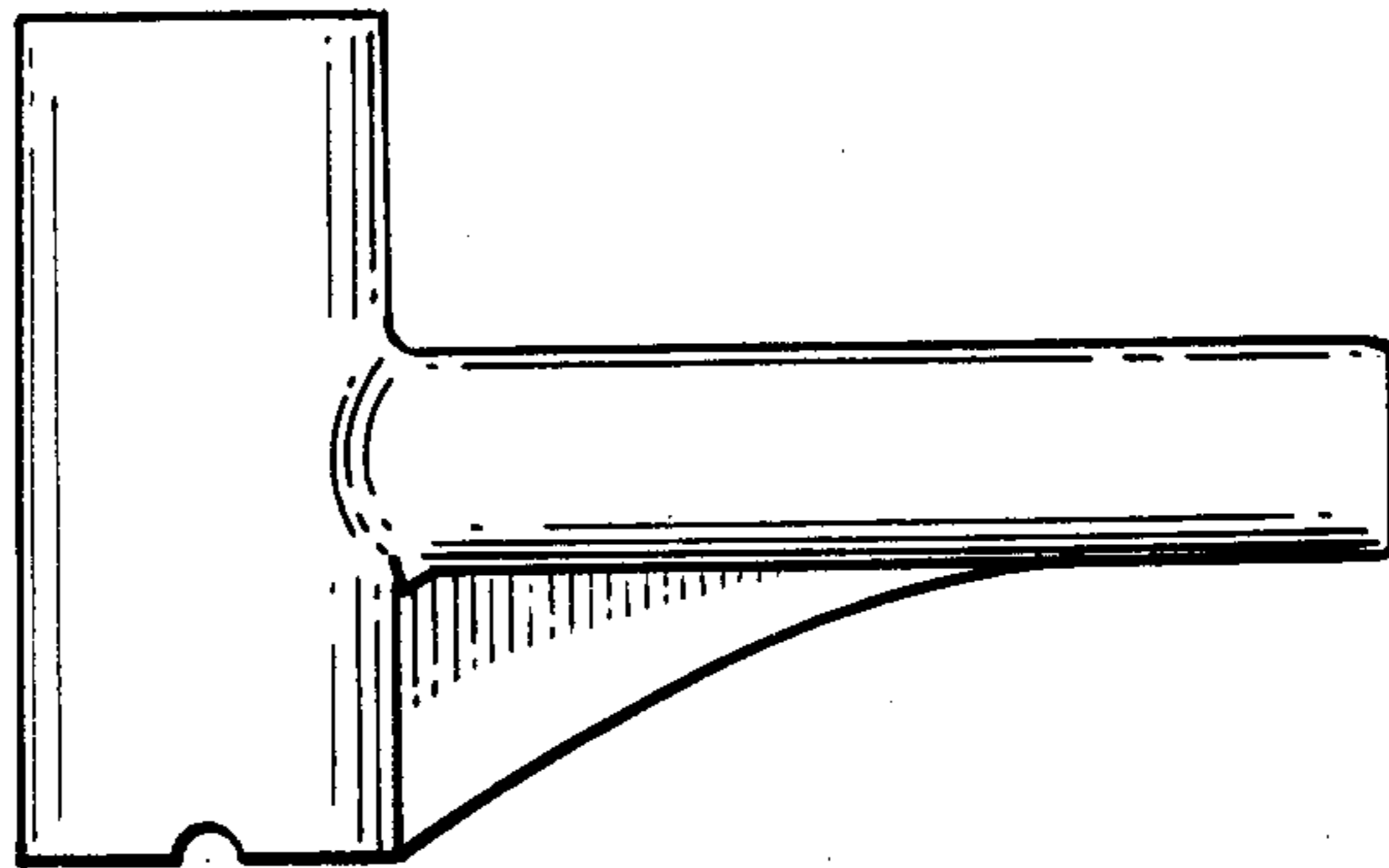

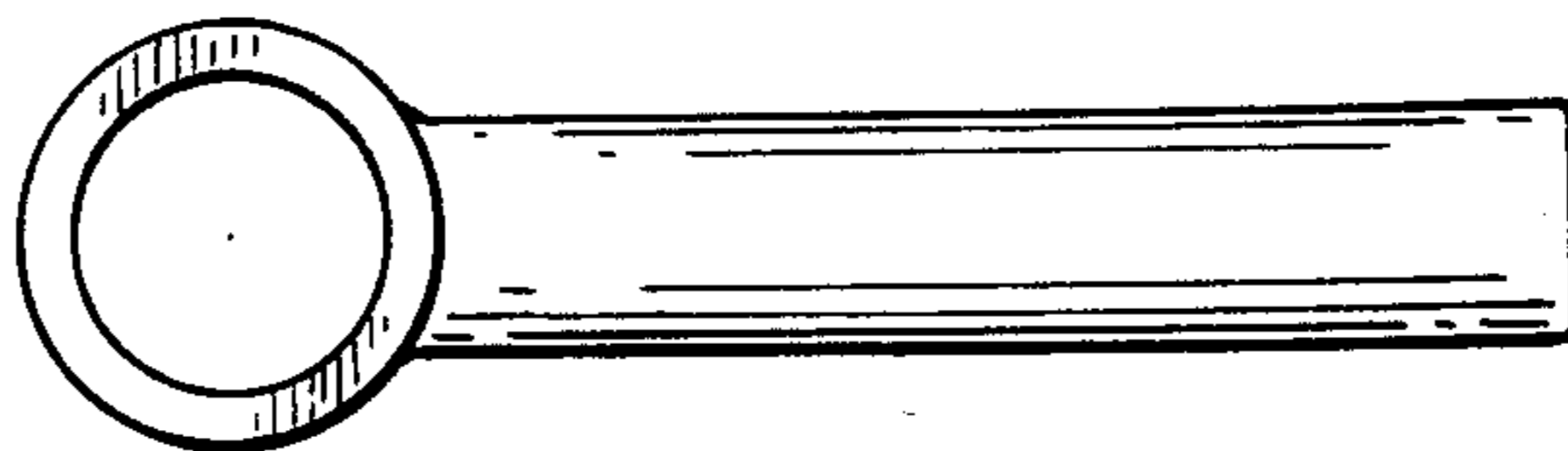

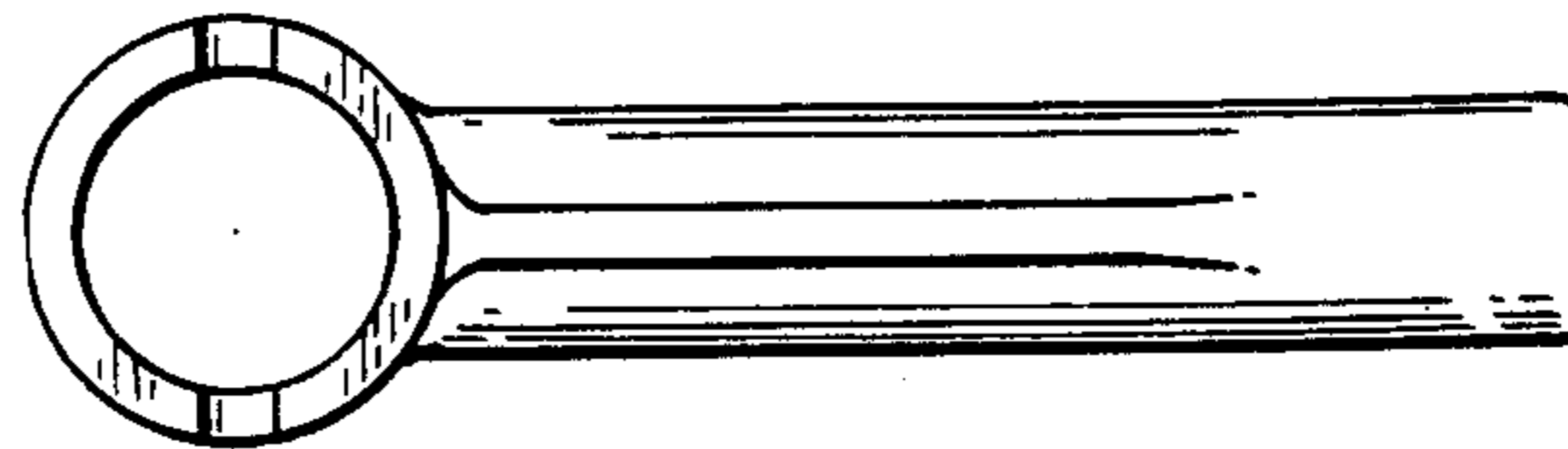

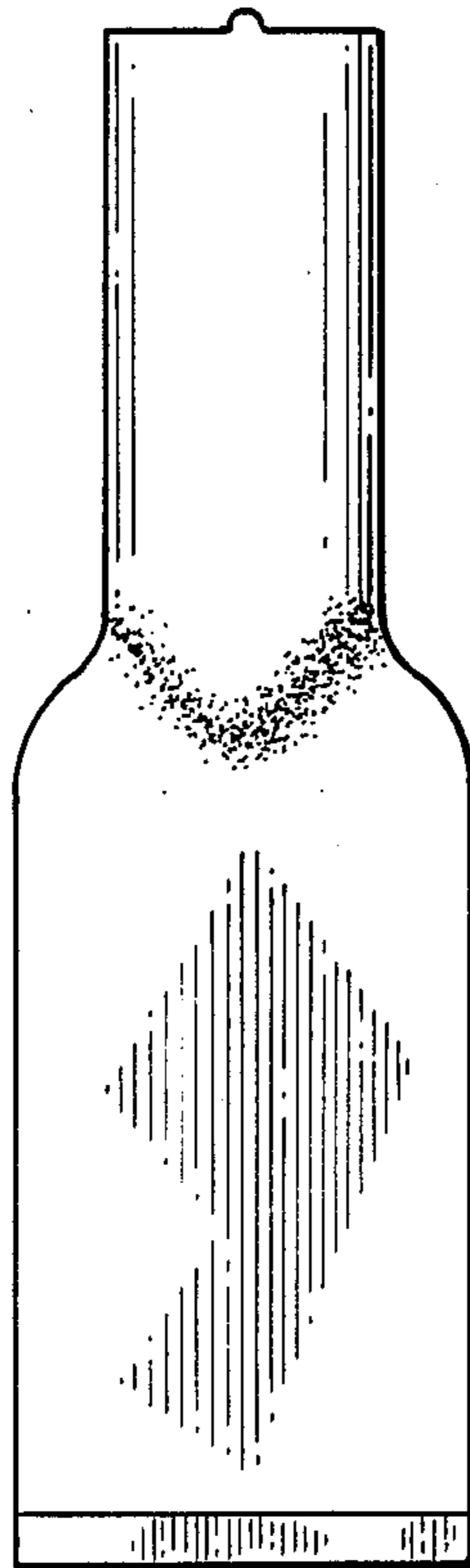

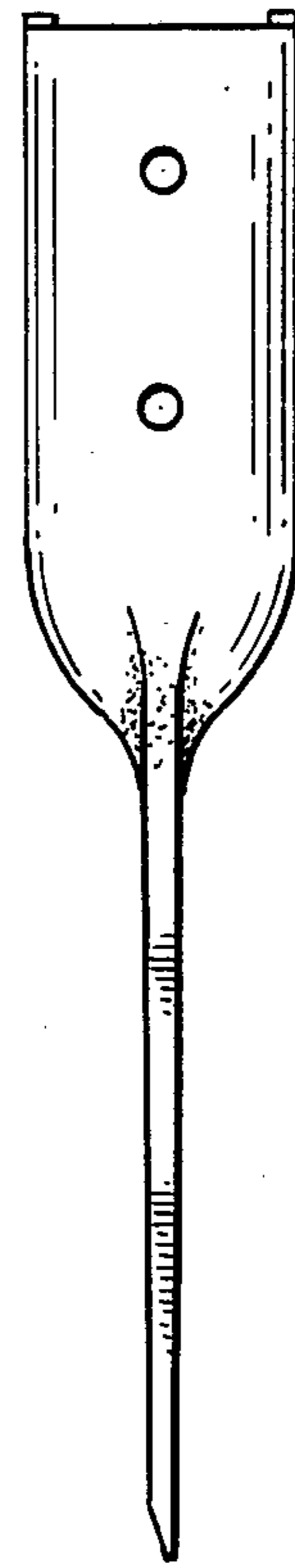

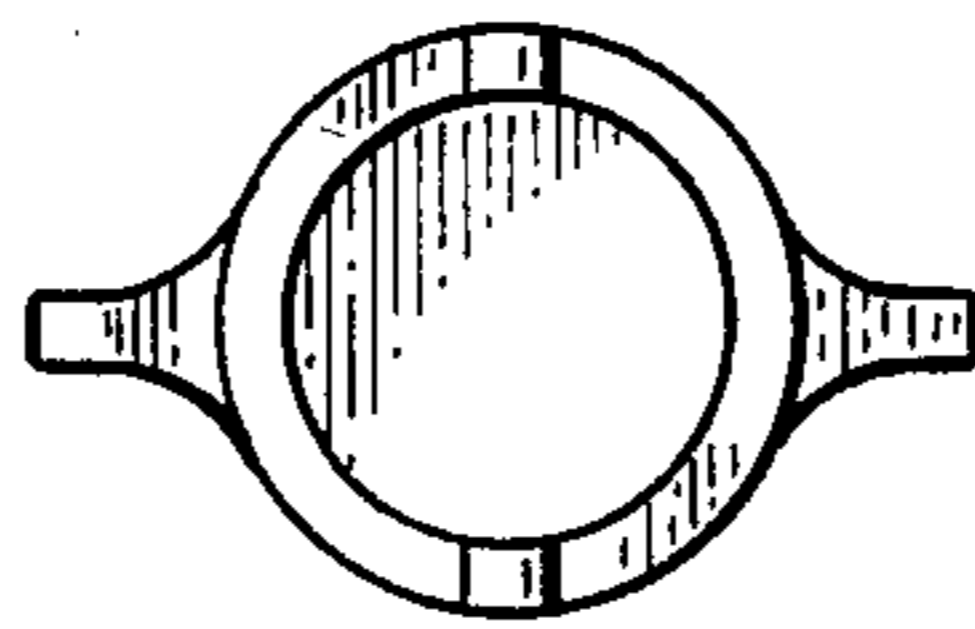

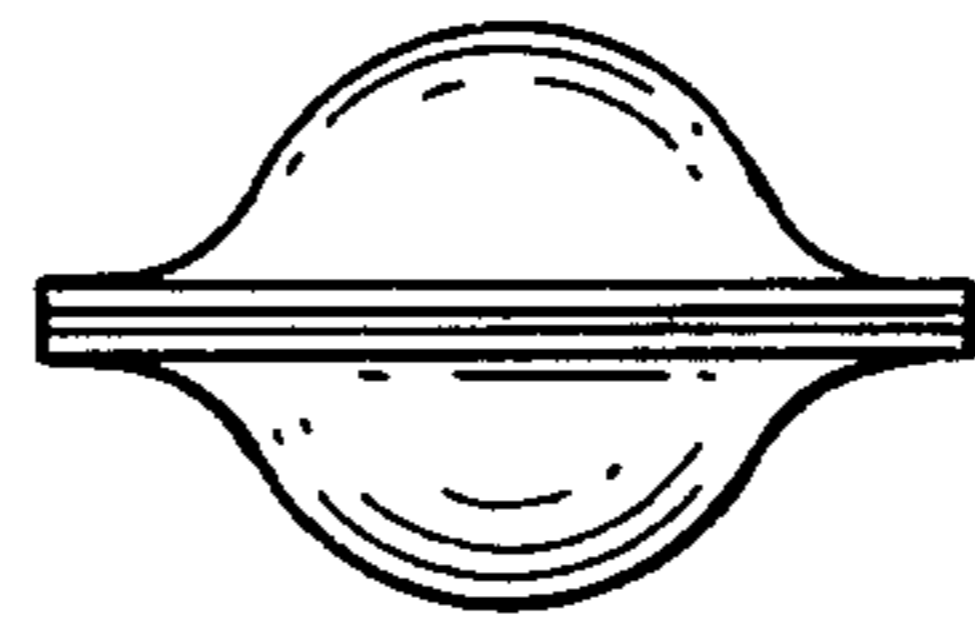
