DESCRIPTION

FIG. 1 is a top front perspective view of an inflatable swimming glove, showing our new design;
 FIG. 2 is a bottom rear perspective view thereof;

 FIG. 8 is a bottom plan view thereof.

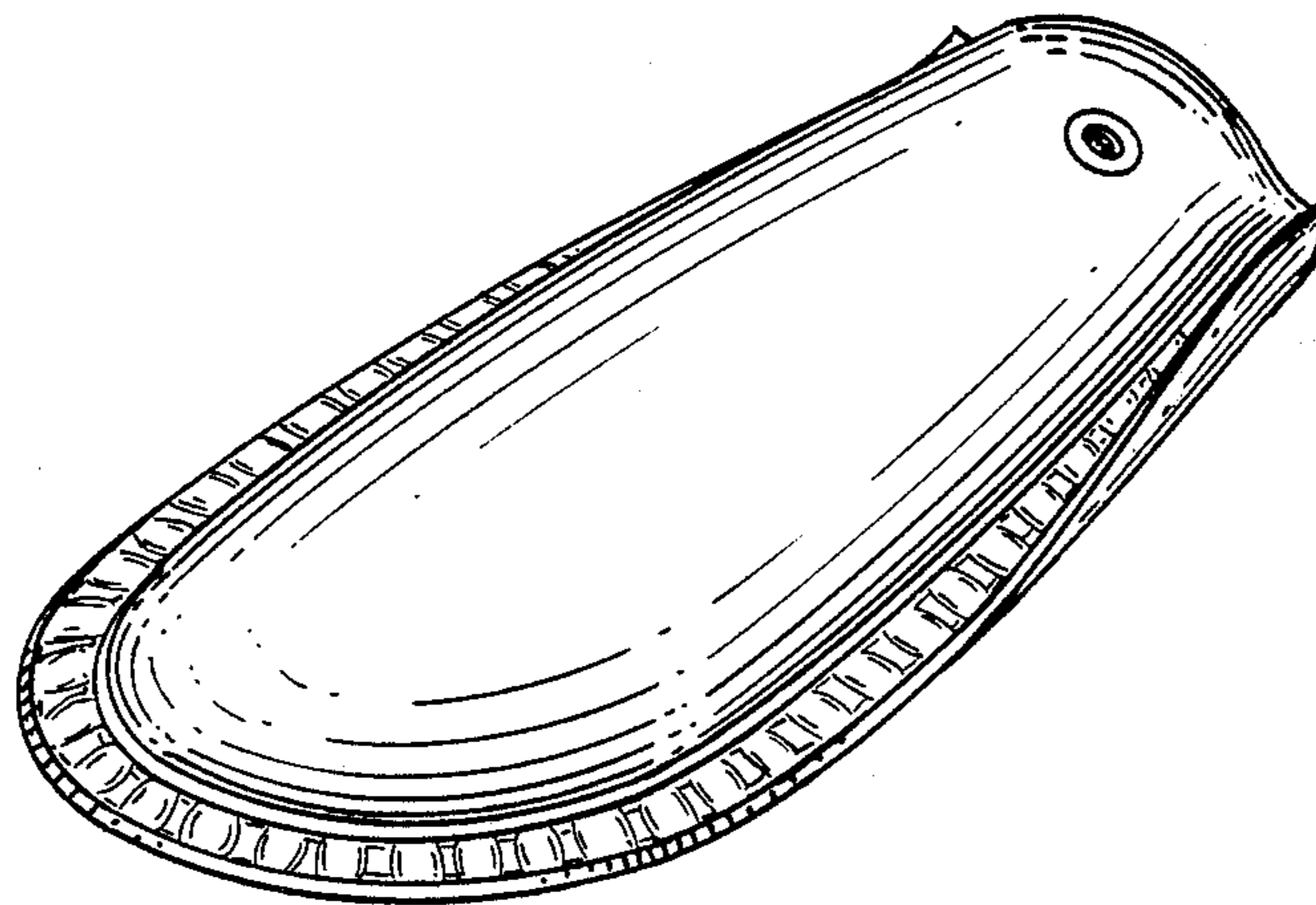

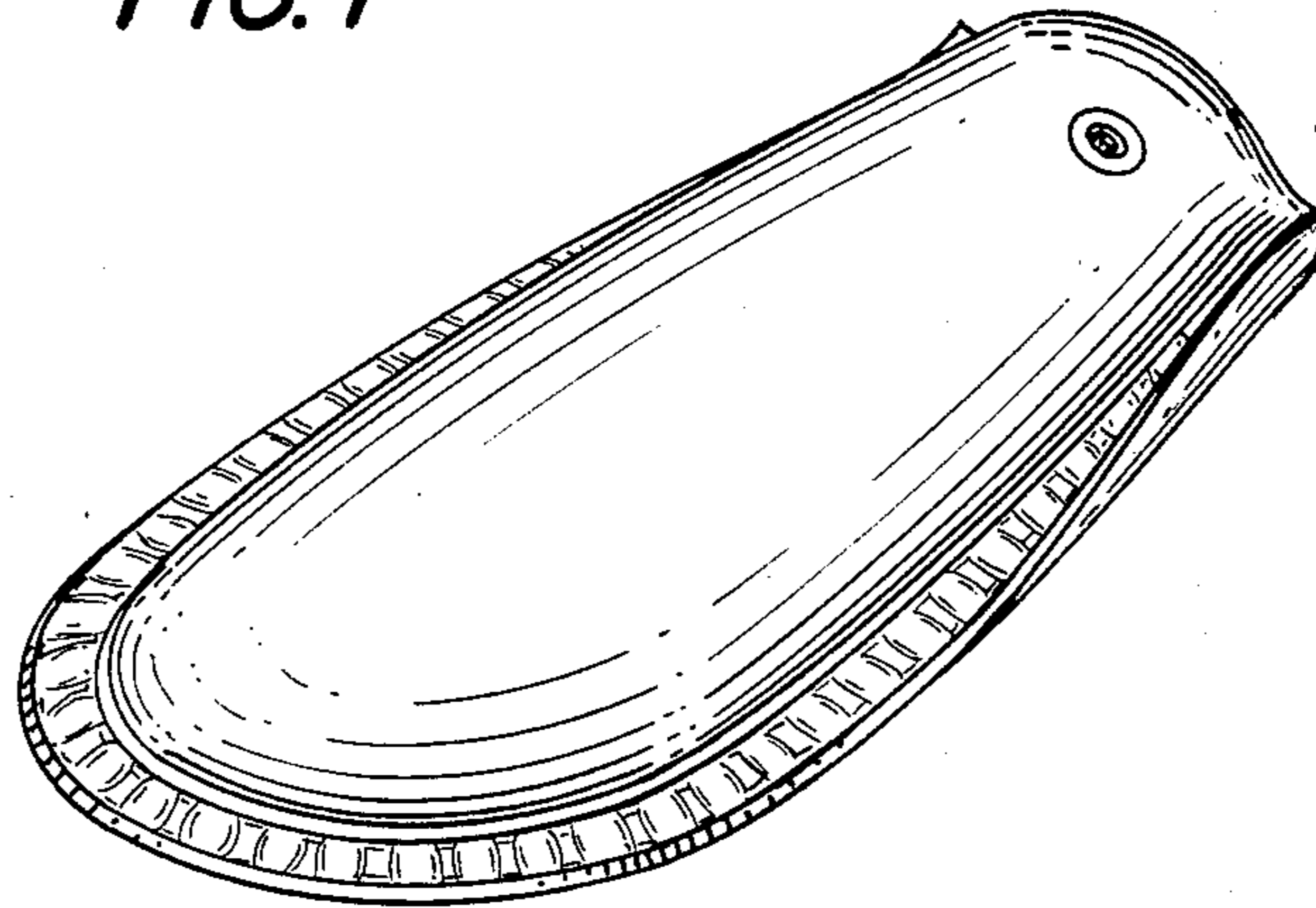

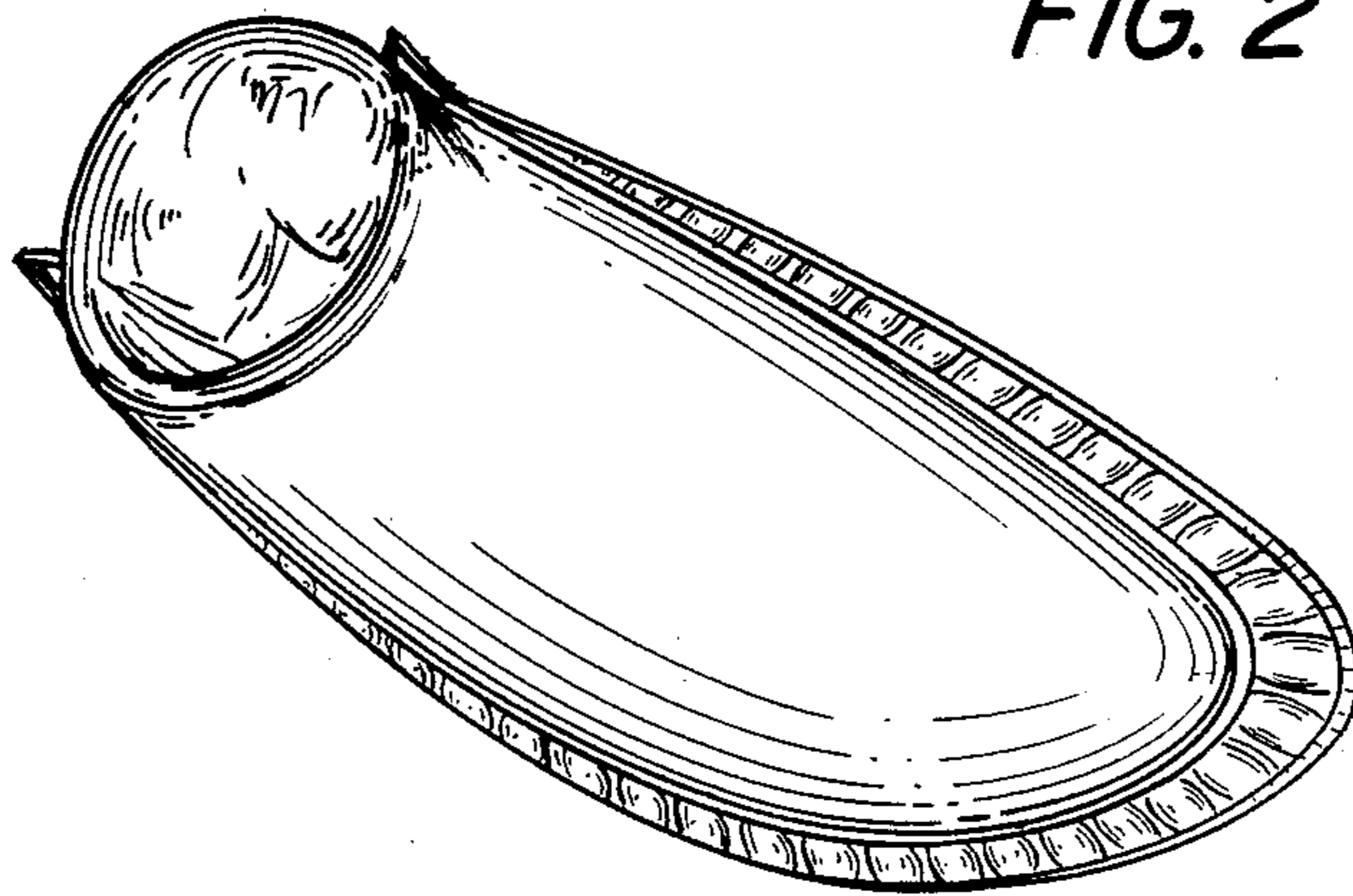

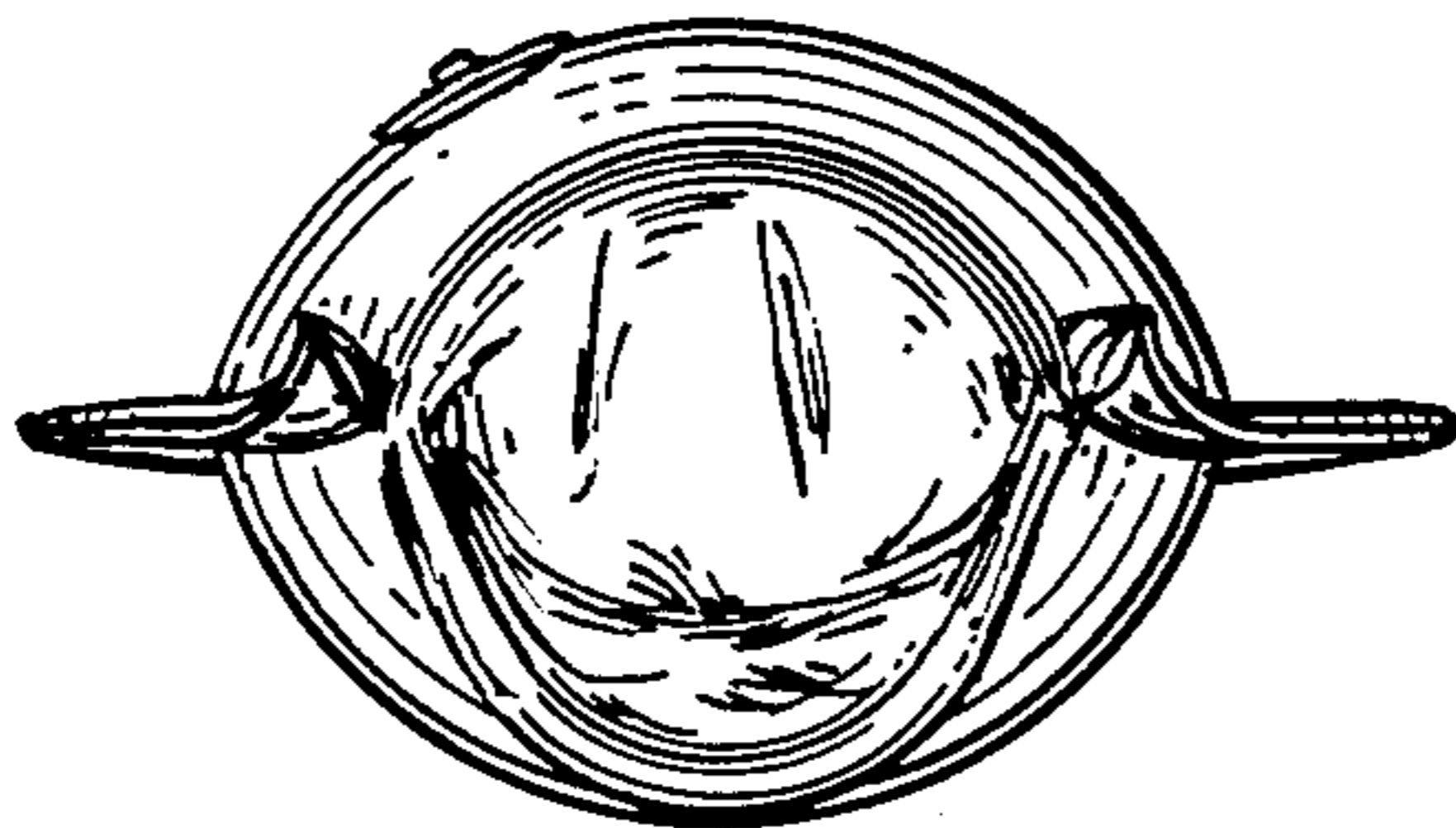
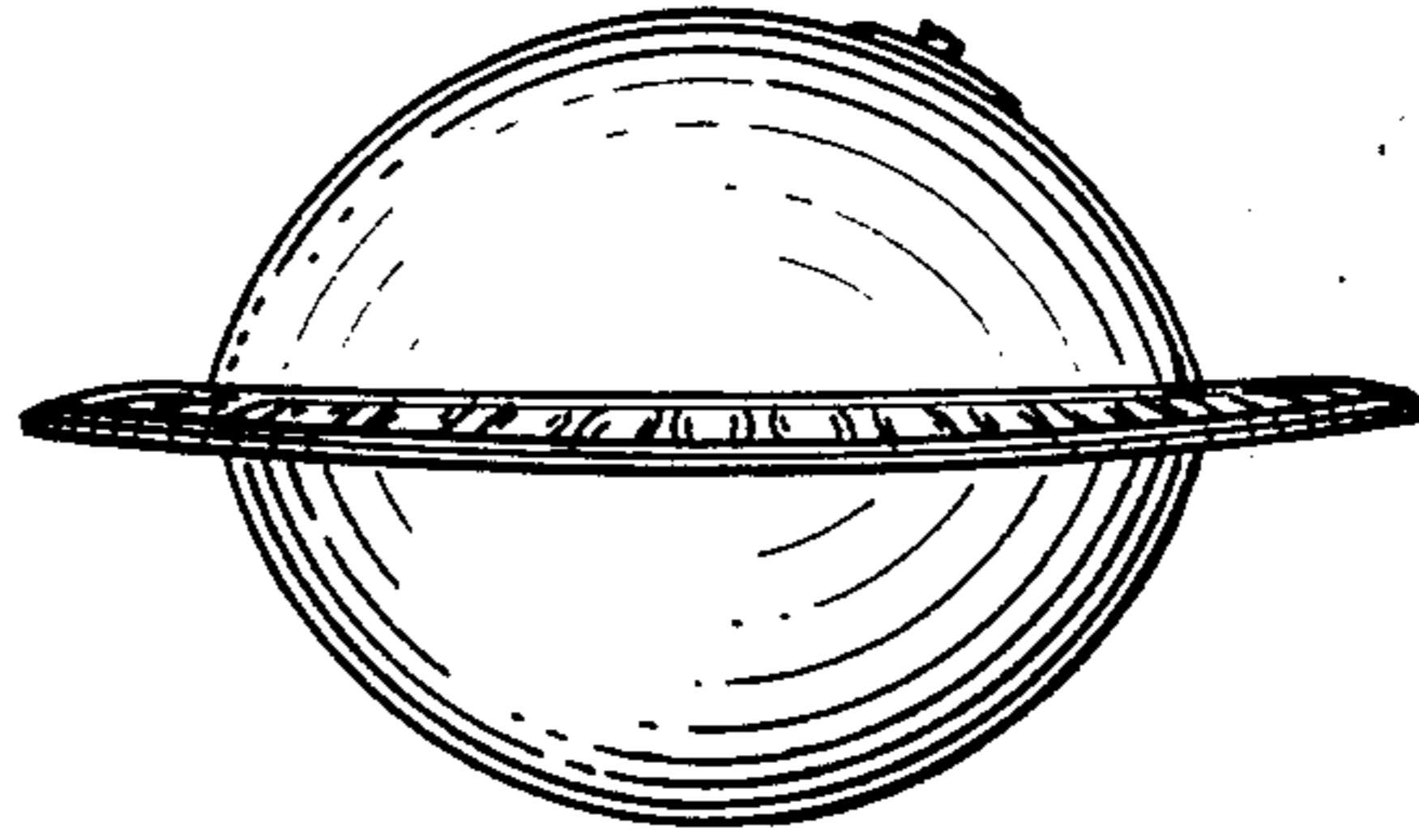

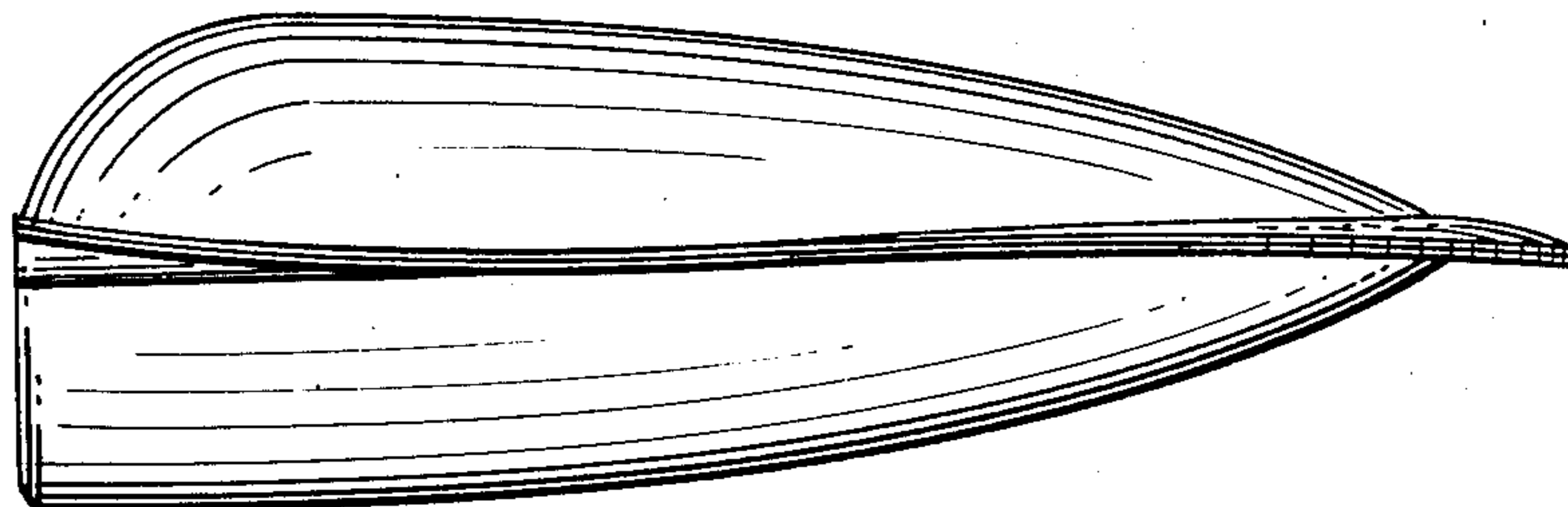

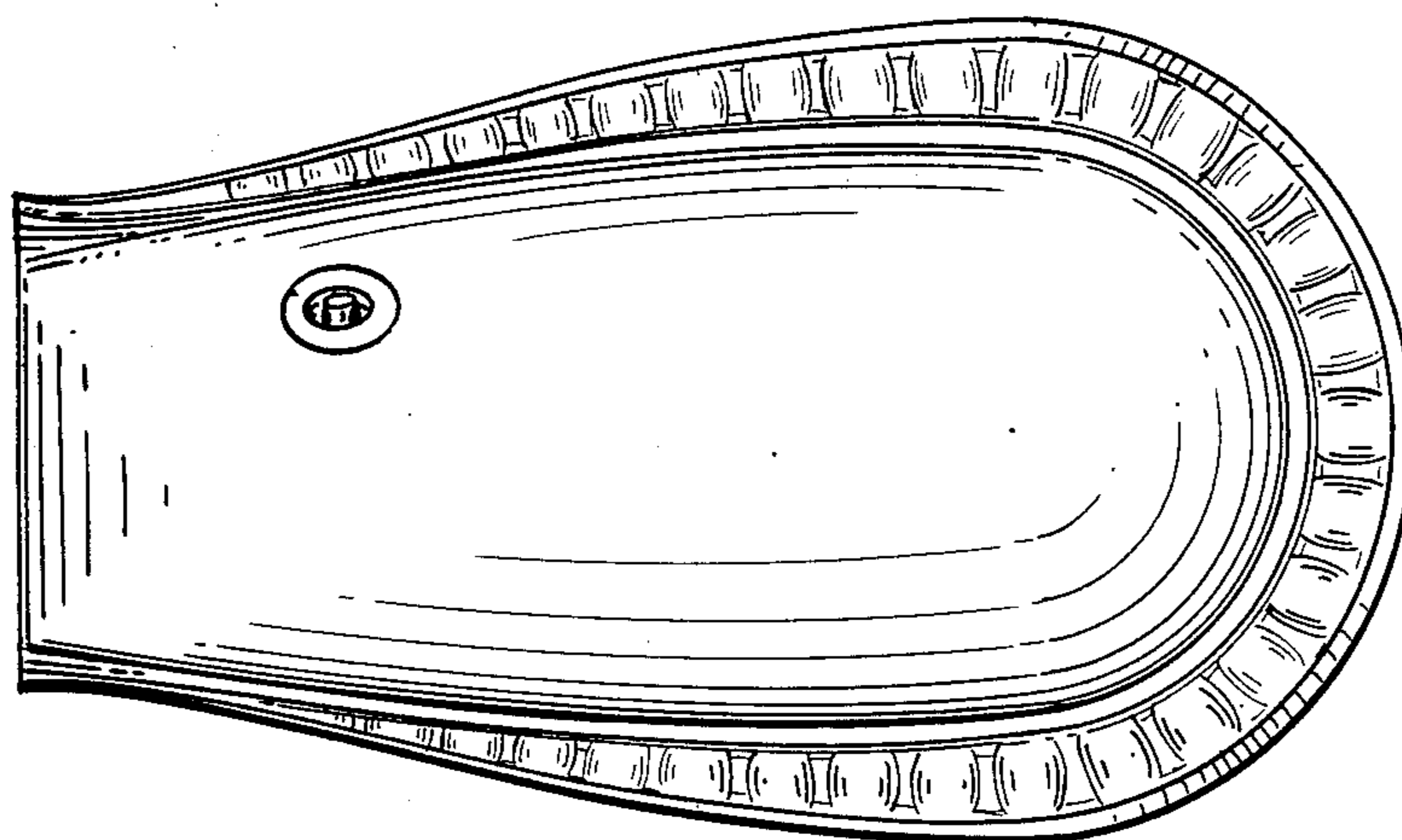
