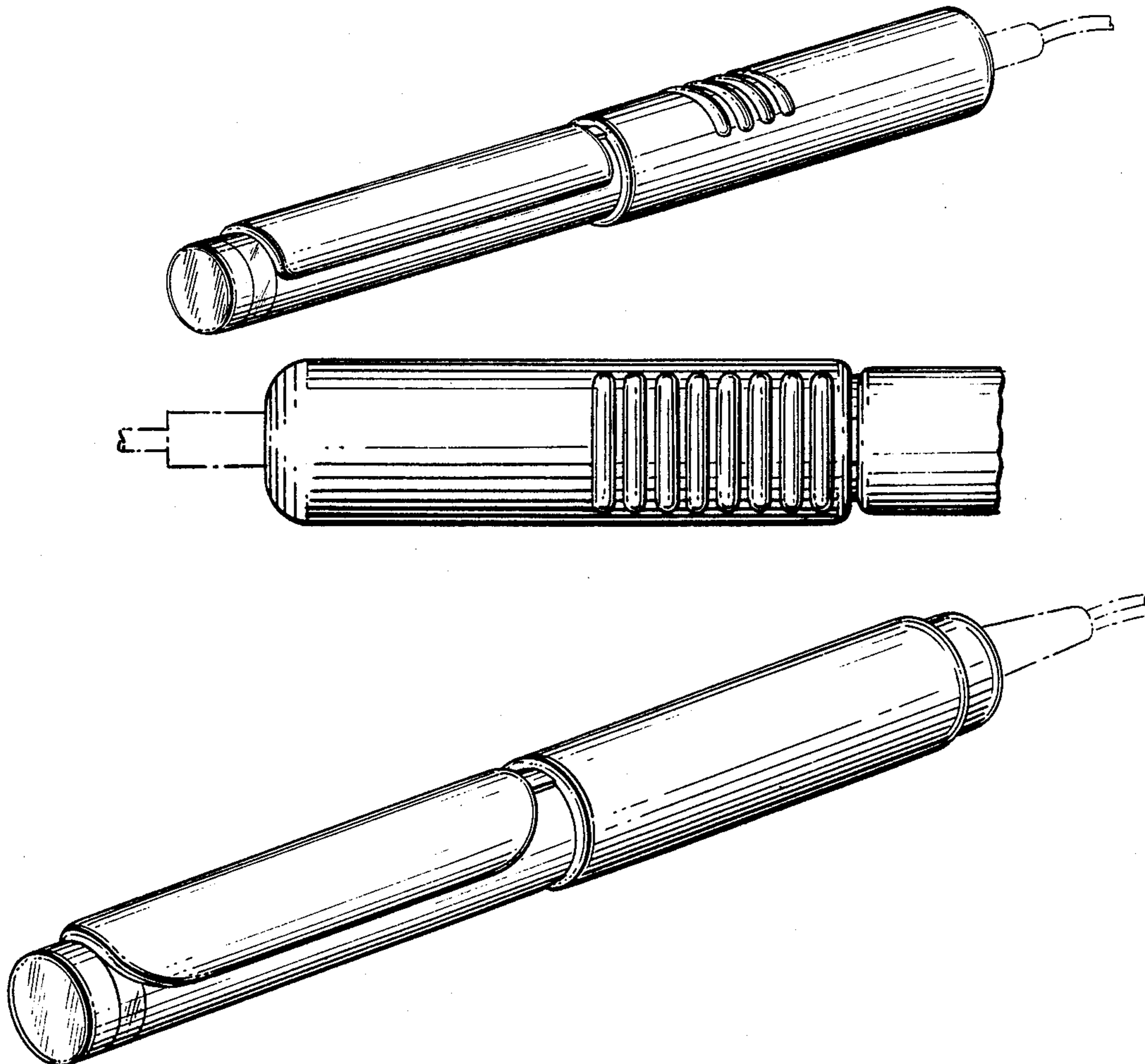

[57] CLAIM

The ornamental design for a soft handle curling iron, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a soft handle curling iron showing our new design;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is a right end view of FIG. 2;
 FIG. 4 is a side elevational view thereof;
 FIG. 5 is a left end view of FIG. 4;
 FIG. 6 is a bottom plan view thereof;
 FIG. 7 is a partial top plan view of a soft handle curling iron showing a modified form of our new design wherein only the top is modified;
 FIG. 8 is a partial perspective view of a soft handle curling iron showing another modified form of our new design wherein only the tip is modified;
 FIG. 9 is a perspective view of a soft handle curling iron showing a fourth embodiment of our new design;
 FIG. 10 is a top plan view thereof;
 FIG. 11 is a right end view thereof;
 FIG. 12 is a side elevational view thereof;
 FIG. 13 is a left end view thereof;
 FIG. 14 is a bottom plan view thereof;
 FIG. 15 is a partial perspective view of a soft handle curling iron showing a fifth embodiment of our new design wherein only the tip is modified.
 The broken line showing of a power cord in FIGS. 1, 2 4-7, 9, 10, and 12-14 is for illustrative purposes only and forms no part of the claimed design.



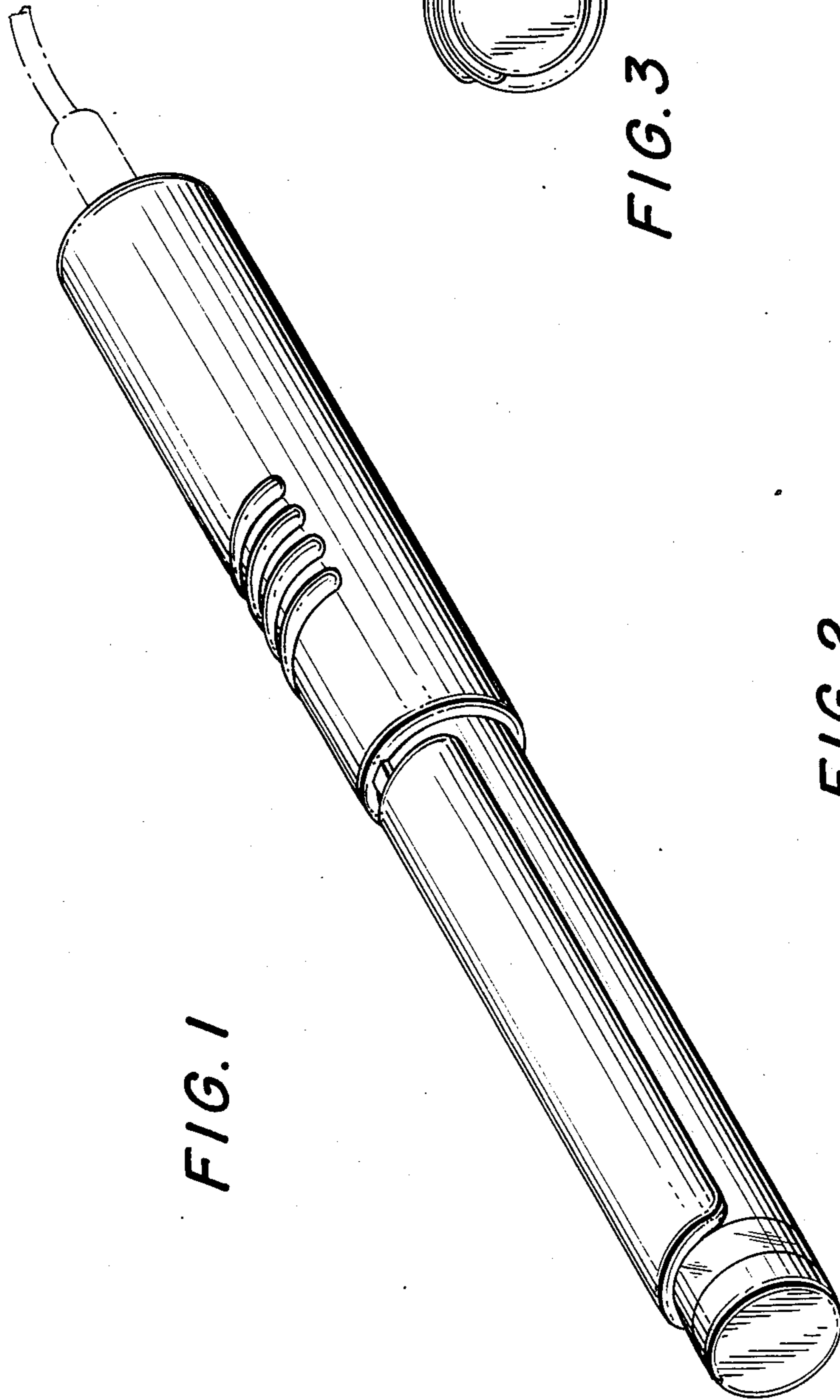

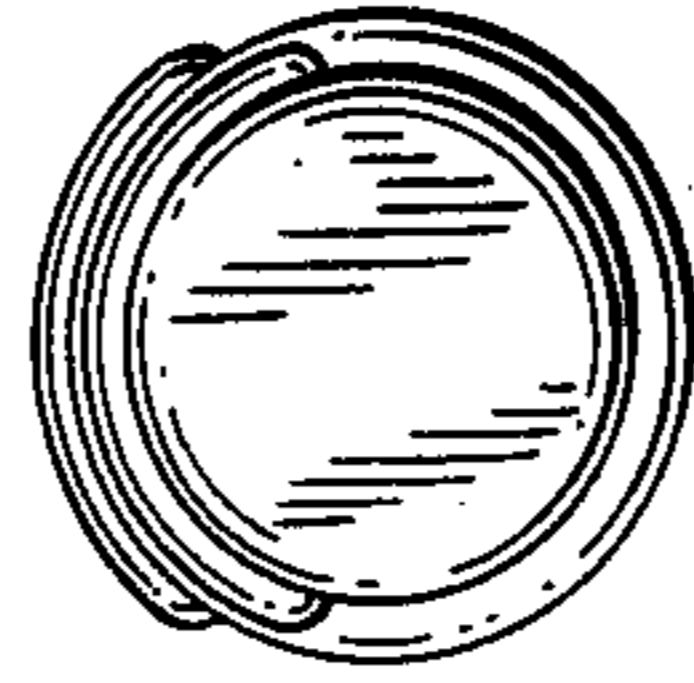

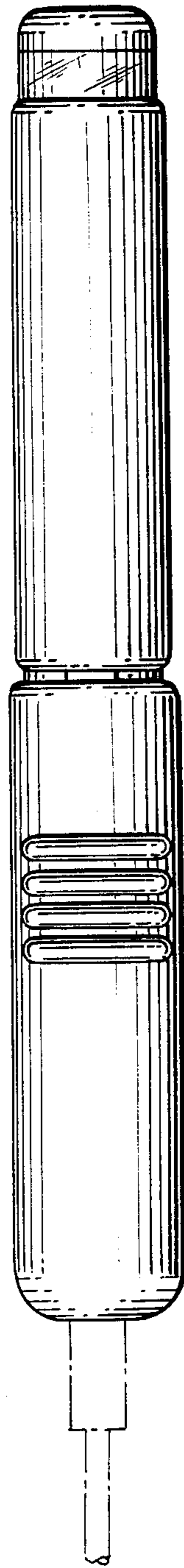

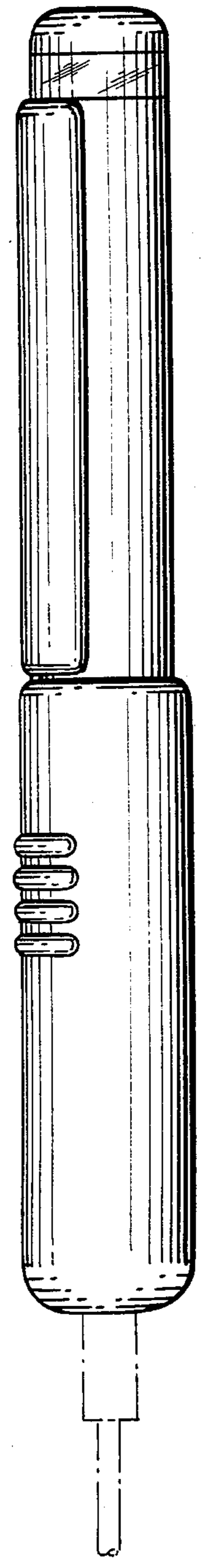

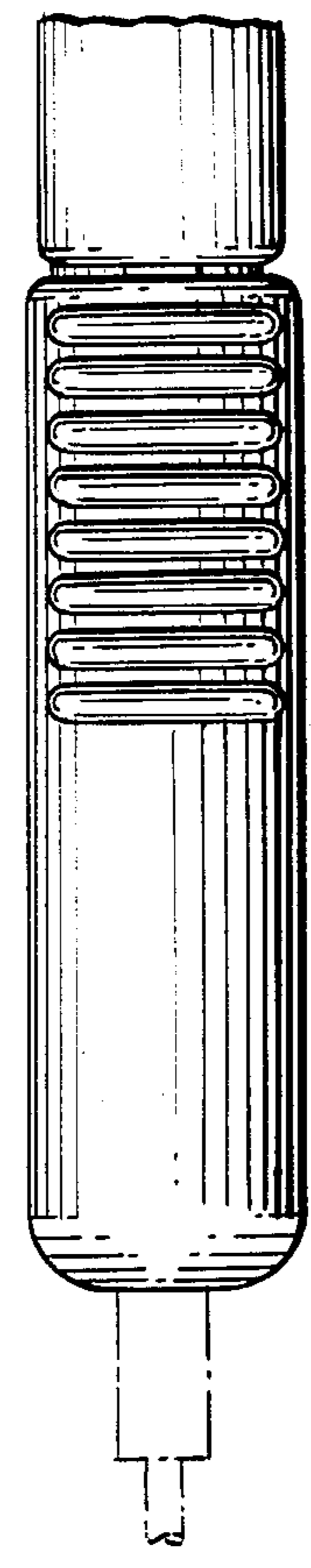

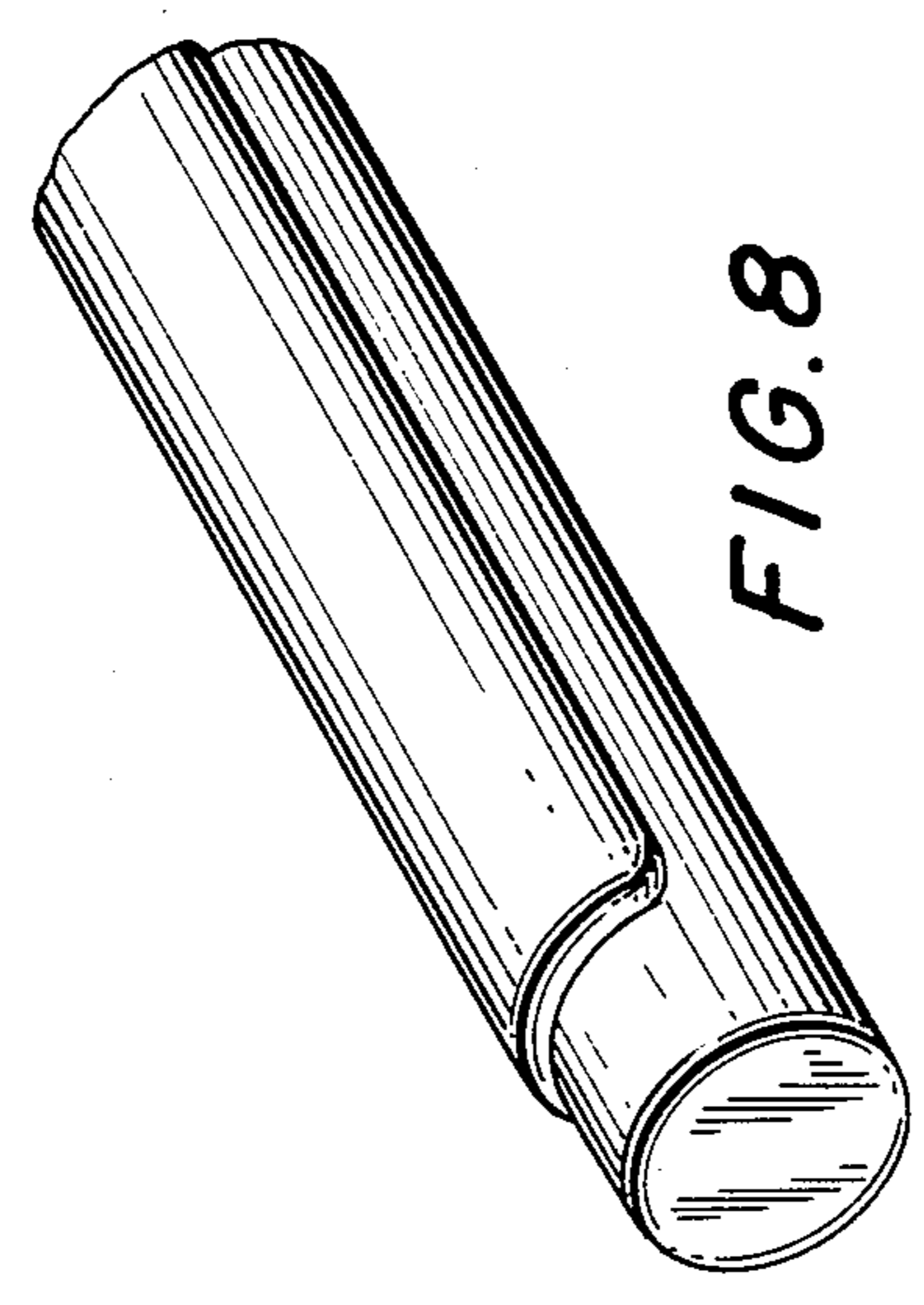

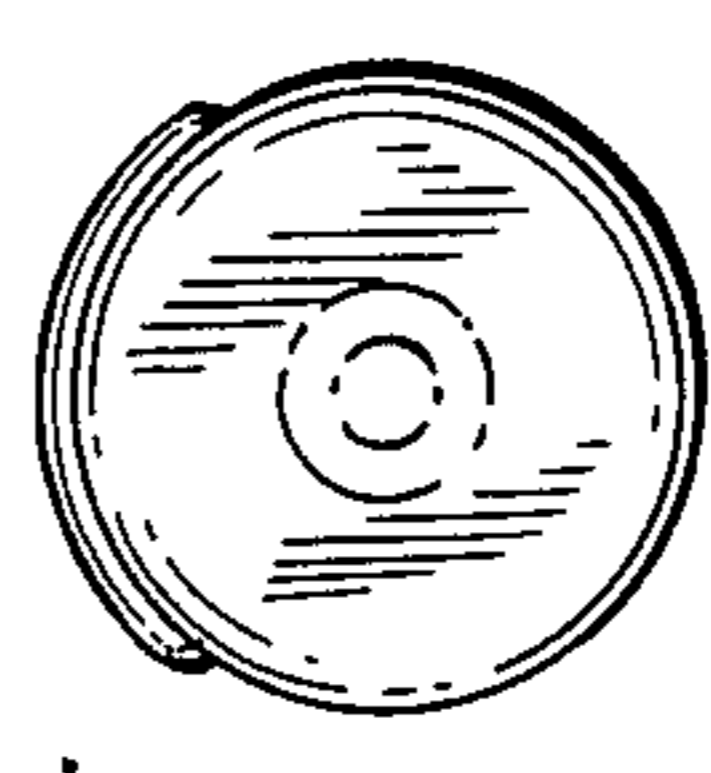
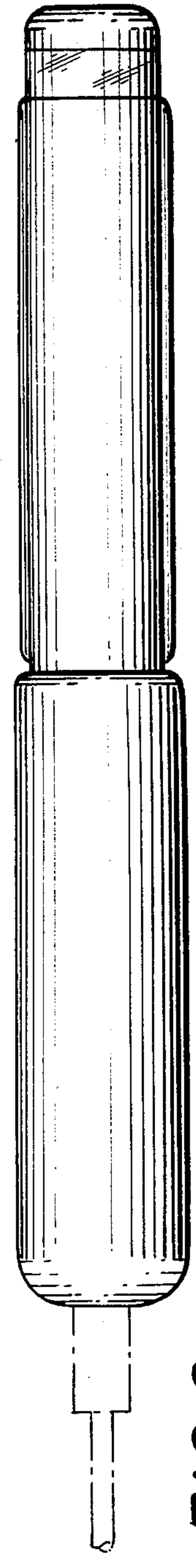

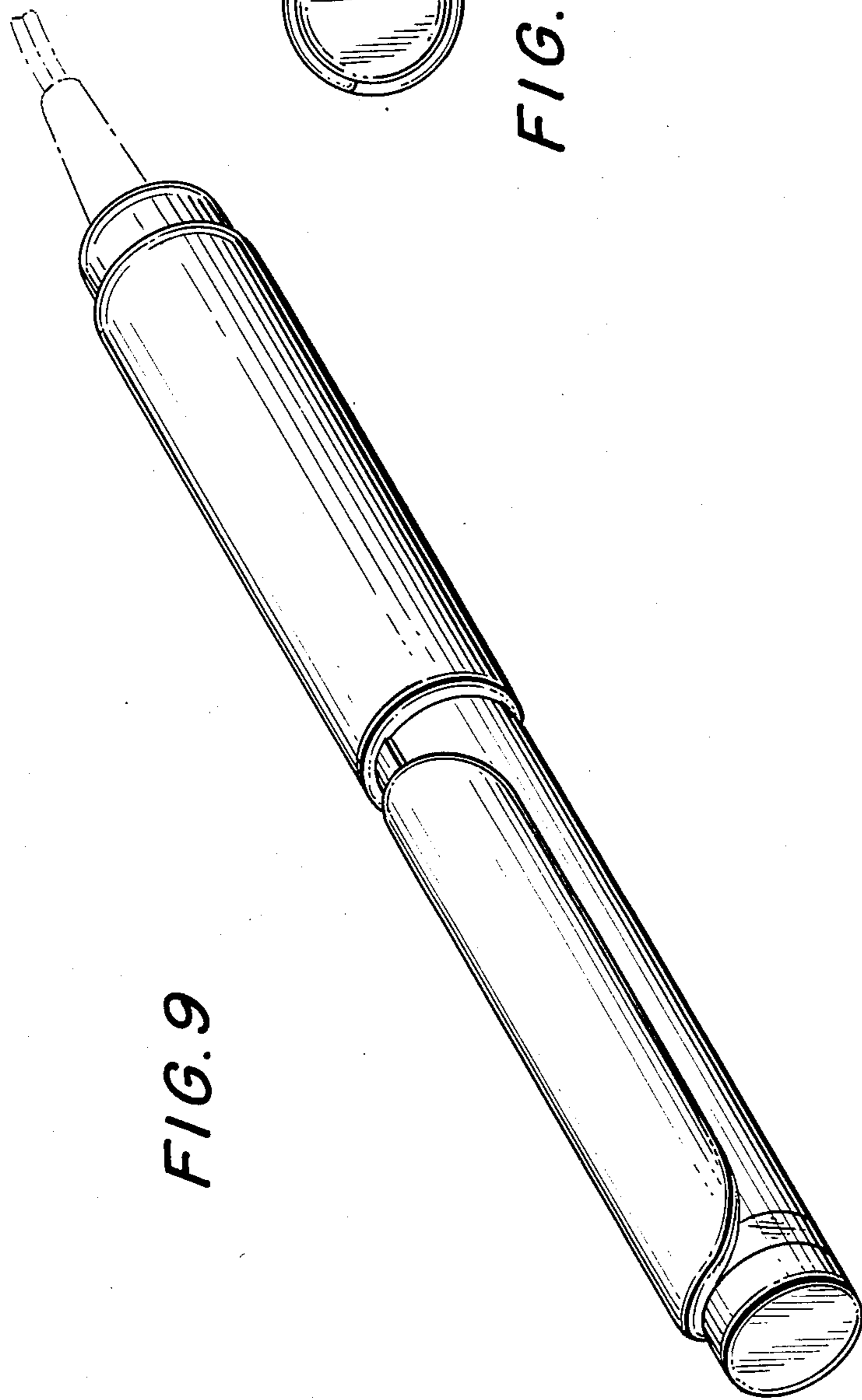

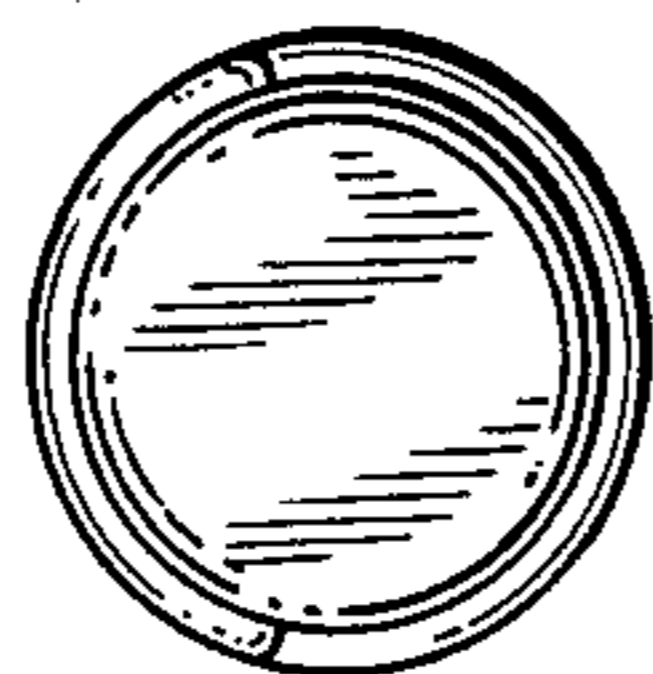

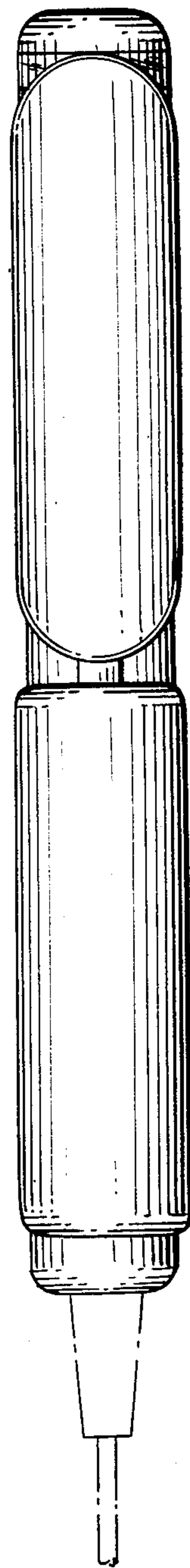

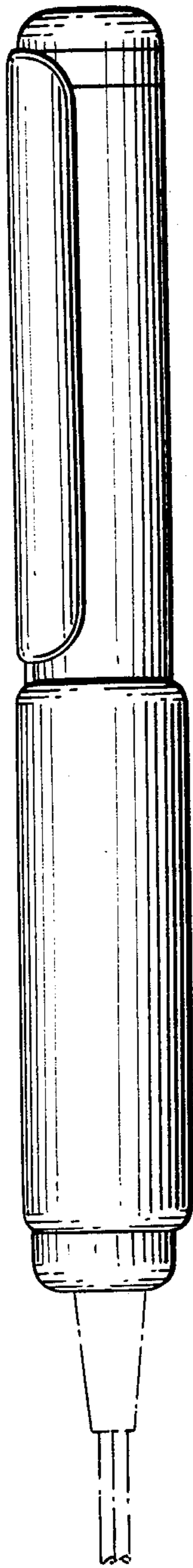

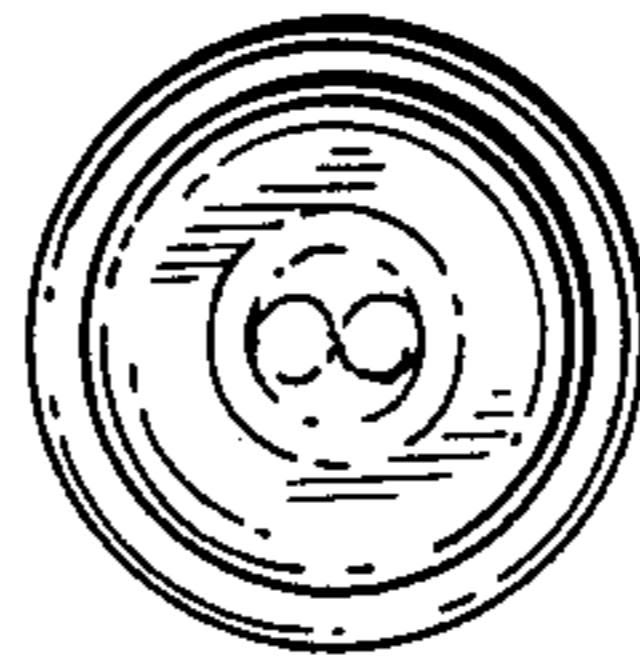

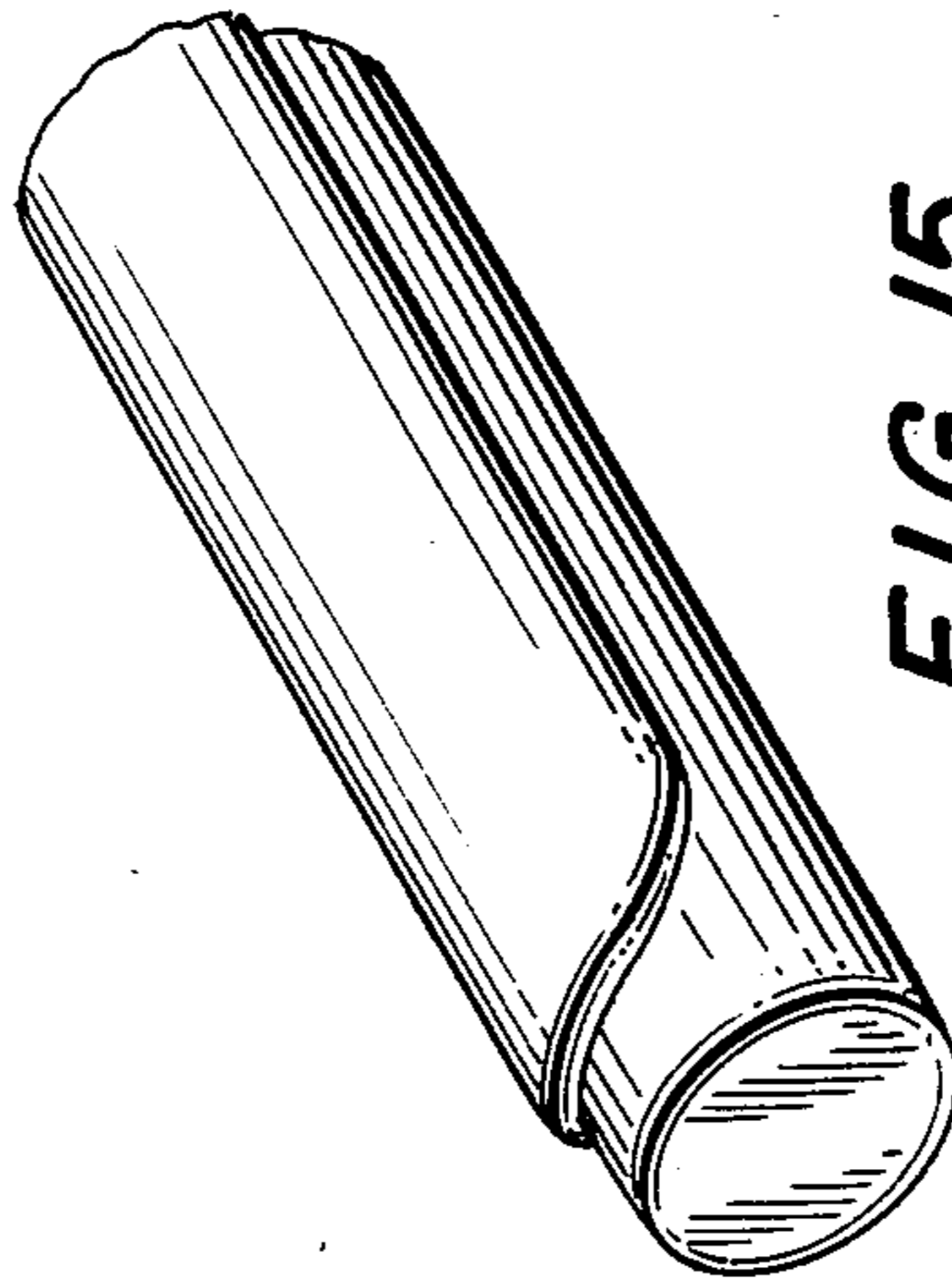
