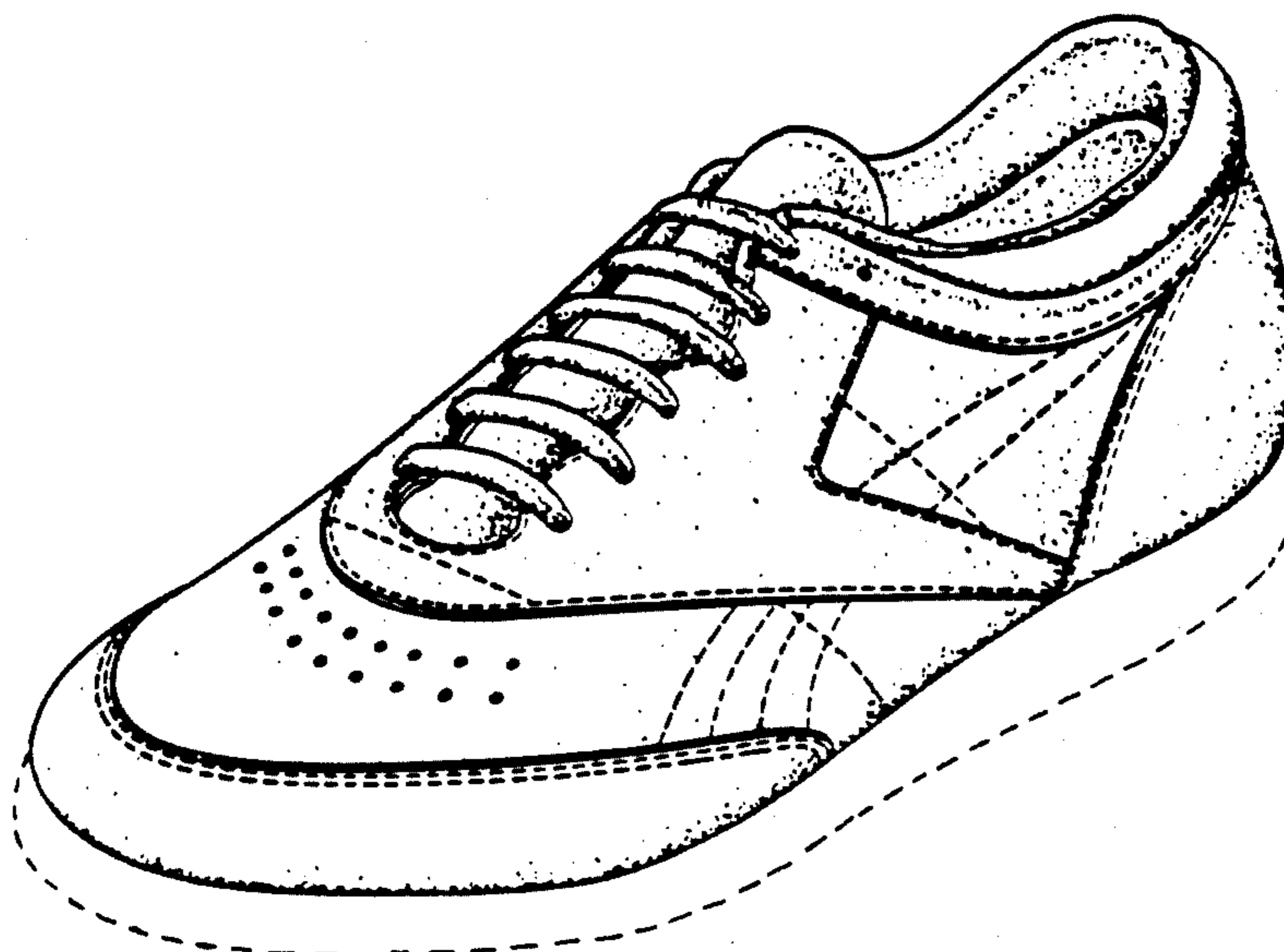

[57] CLAIM

The ornamental design for an athletic shoe upper, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an athletic shoe upper showing our new design; FIG. 2 is a right side elevational view; FIG. 3 is a left side elevational view; FIG. 4 is a top plan view; FIG. 5 is a rear elevational view; and FIG. 6 is a front elevational view. The broken line showing of a shoe sole in FIGS. 1-6 and the area within are environmental only and form no part of the claimed design.



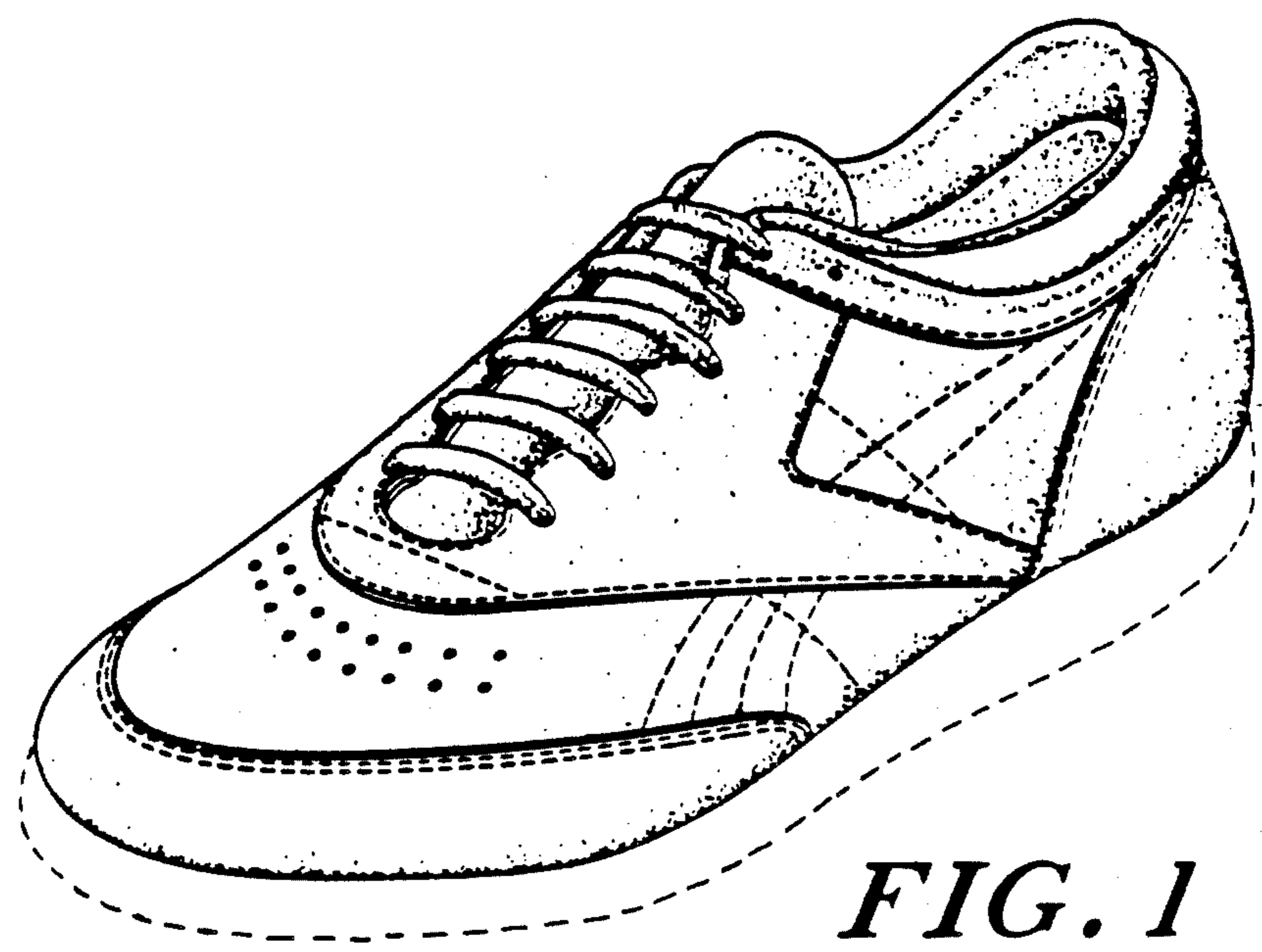

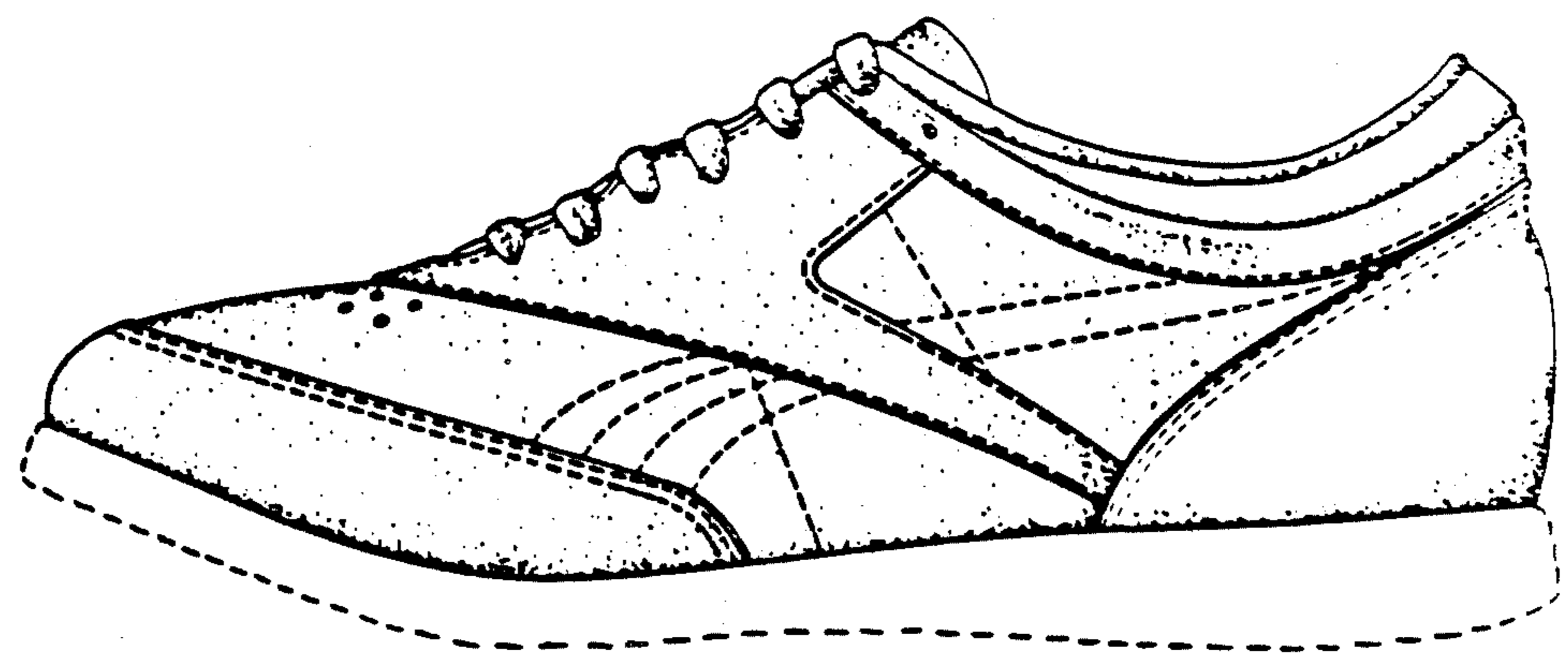

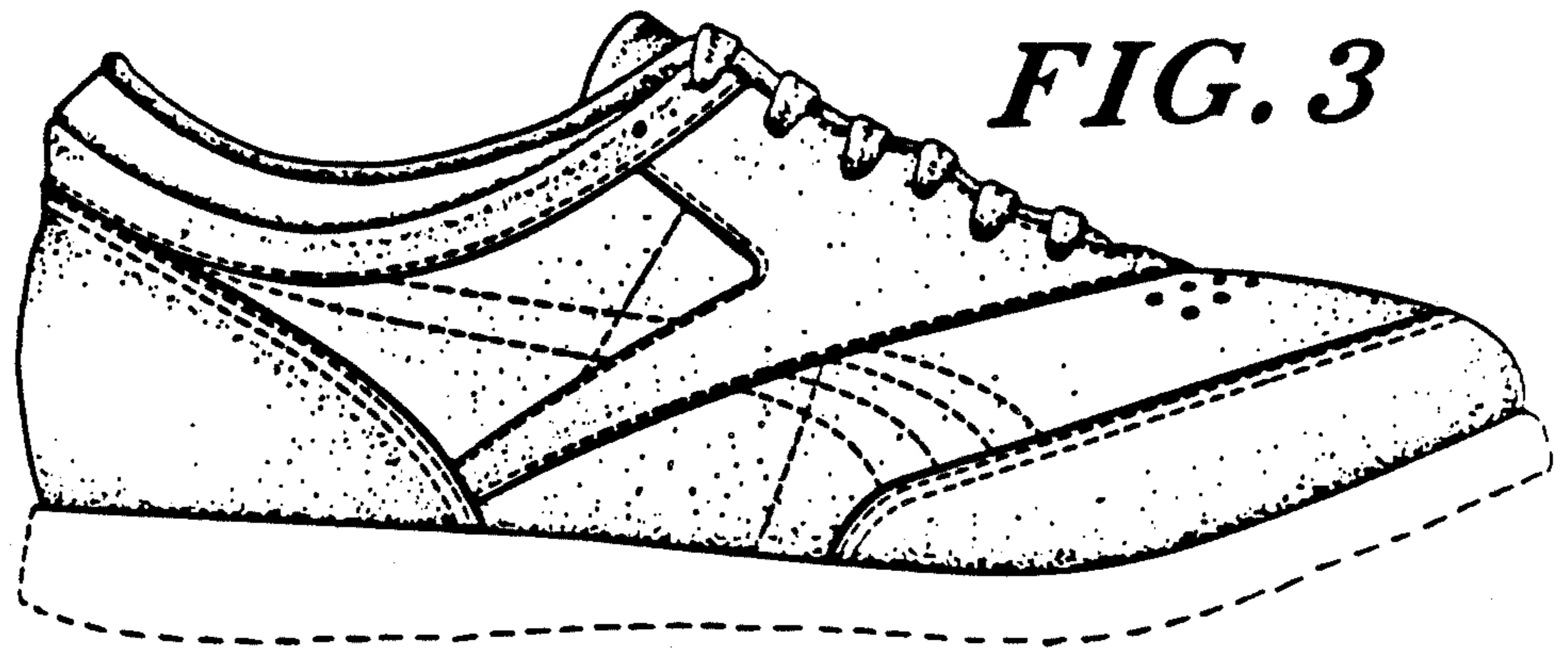

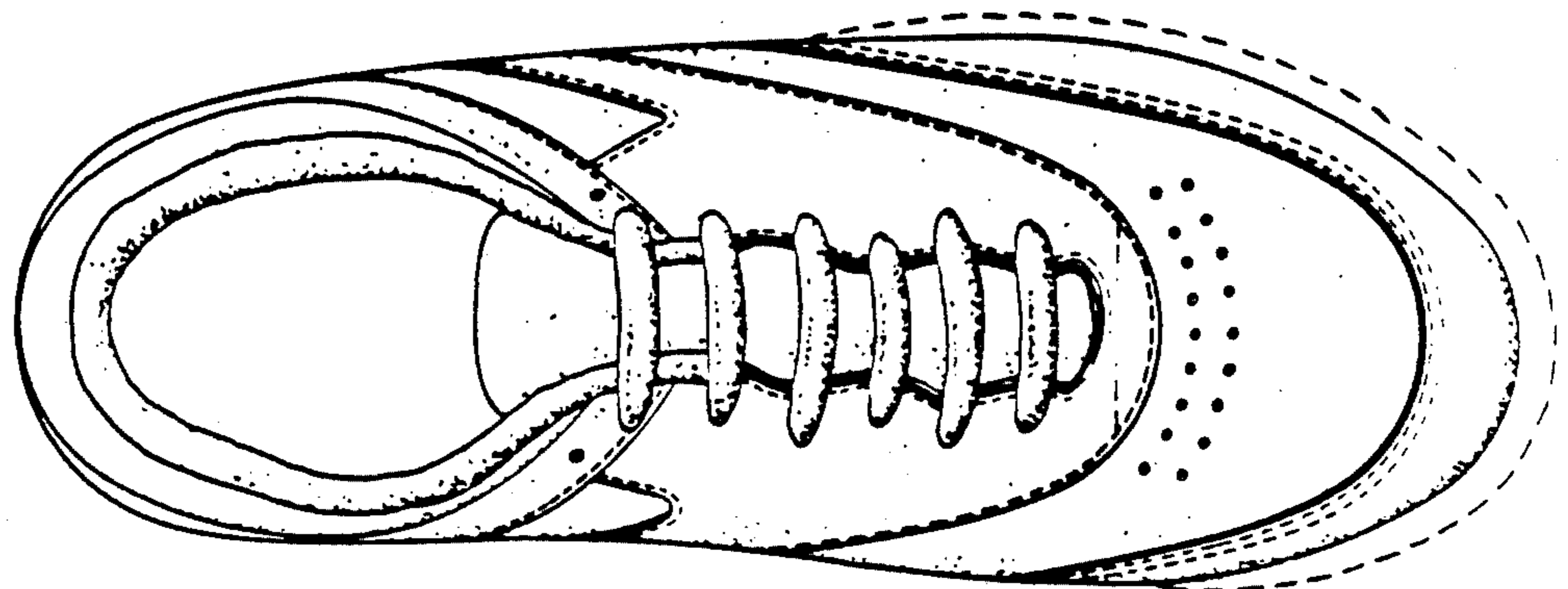

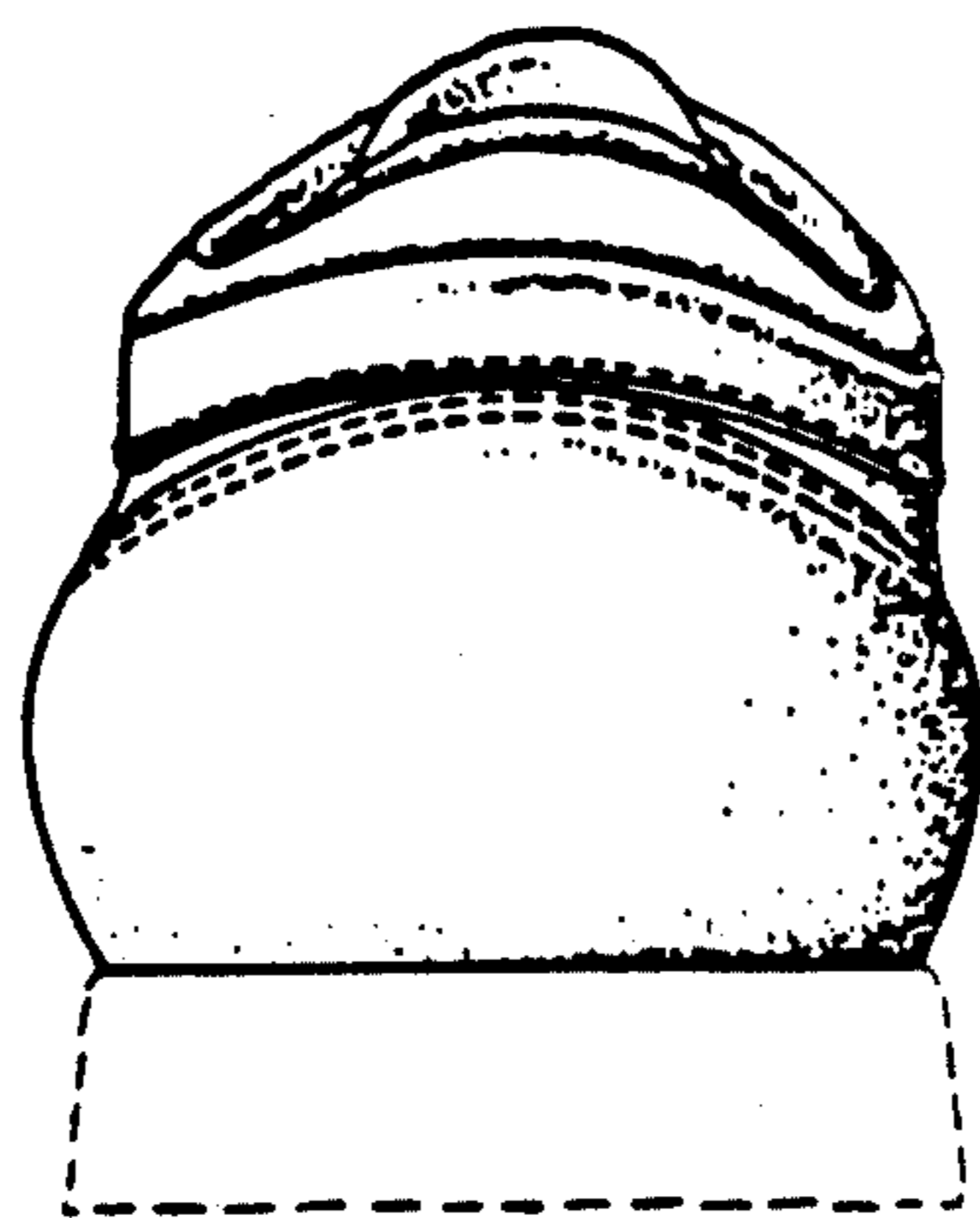

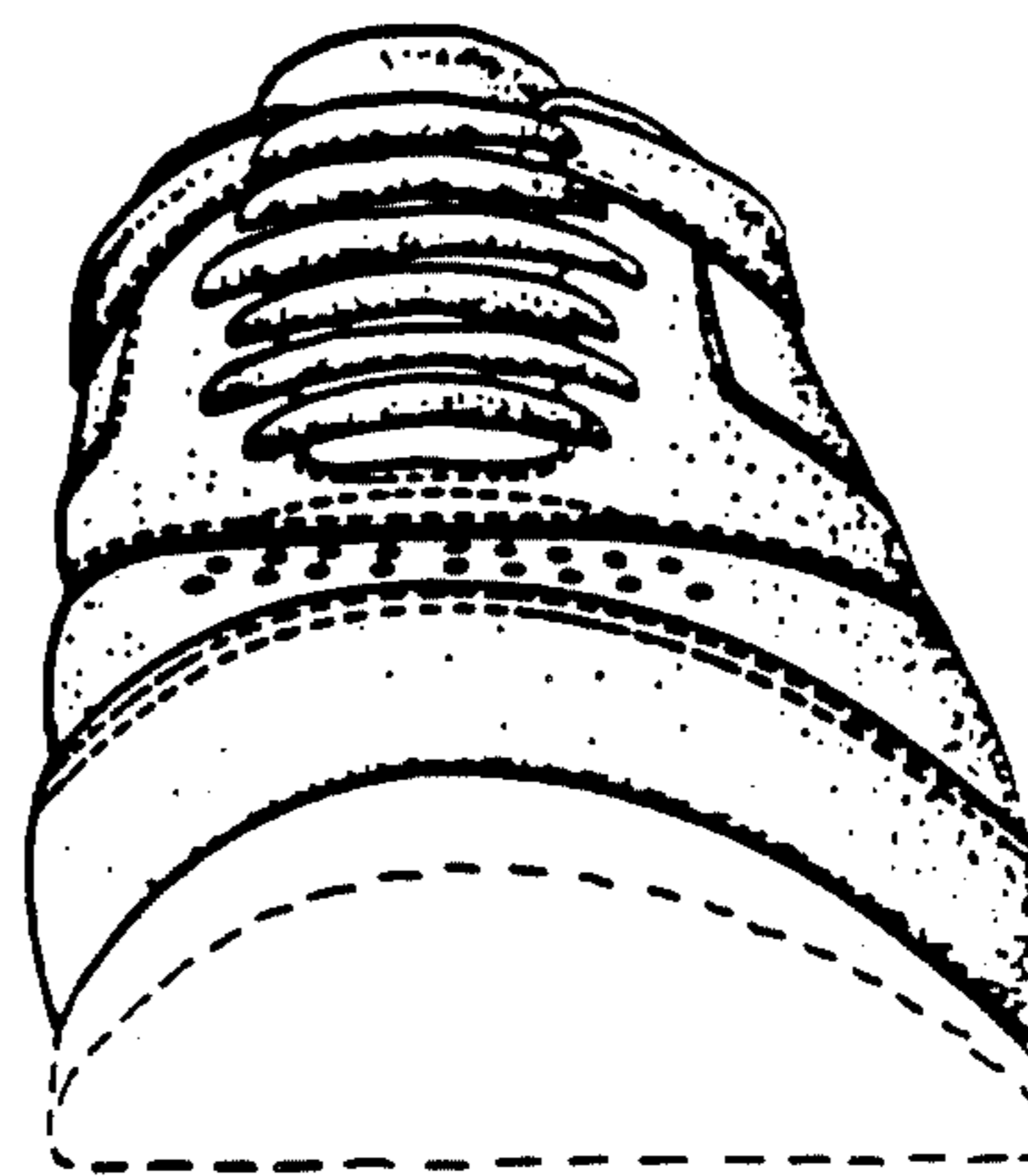
