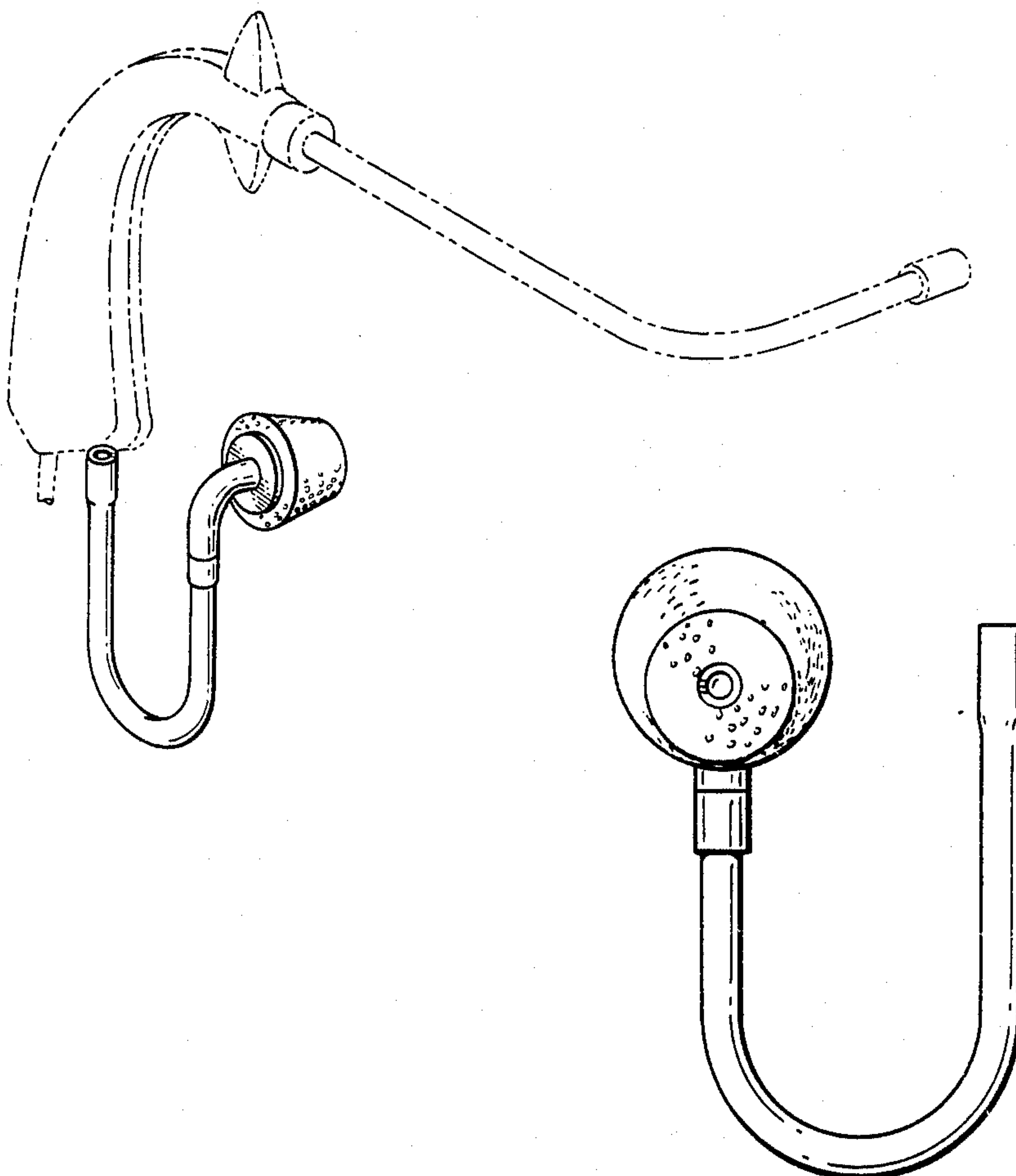

[57] CLAIM

The ornamental design for a foam ear cushion for telephone headset or similar article, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a foam ear cushion for telephone headset or similar article;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a side elevational view thereof, taken from the left side of FIG. 2;  
FIG. 4 is a rear elevational view thereof;  
FIG. 5 is a side elevational view thereof taken from the right side of FIG. 2;  
FIG. 6 is a front elevational view thereof; and,  
FIG. 7 is a bottom plan view thereof.  
The broken line showing of a telephone headset in FIG. 1 is for illustrative purposes only and forms no part of the claimed design.



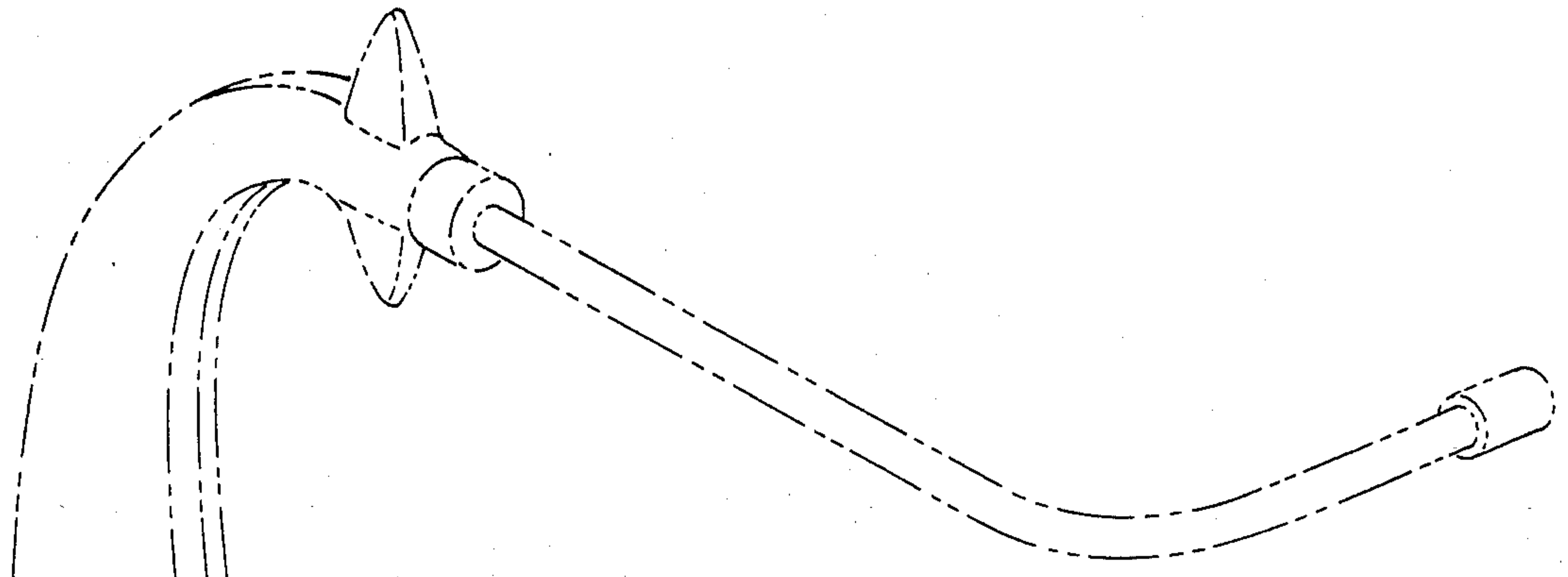

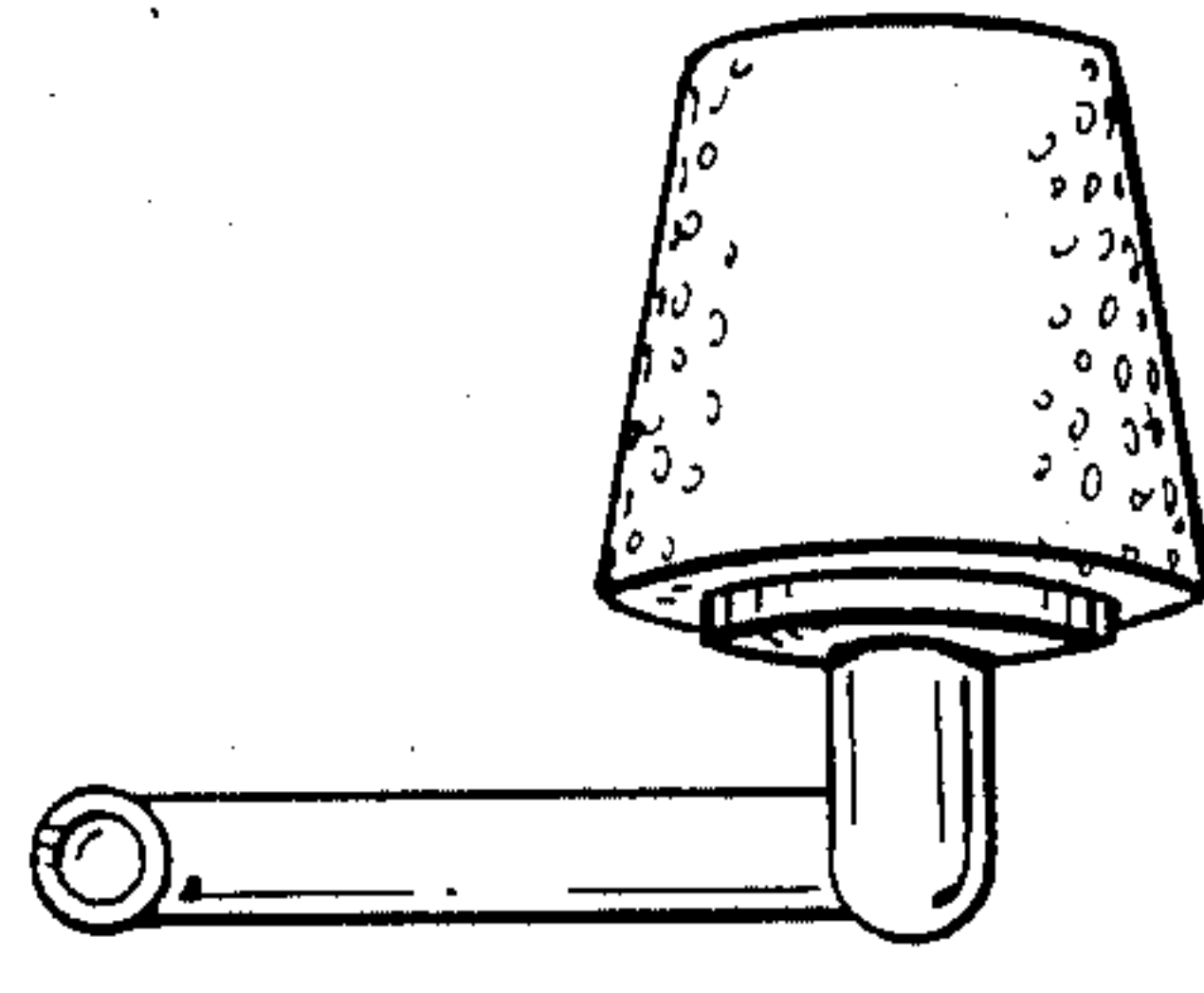
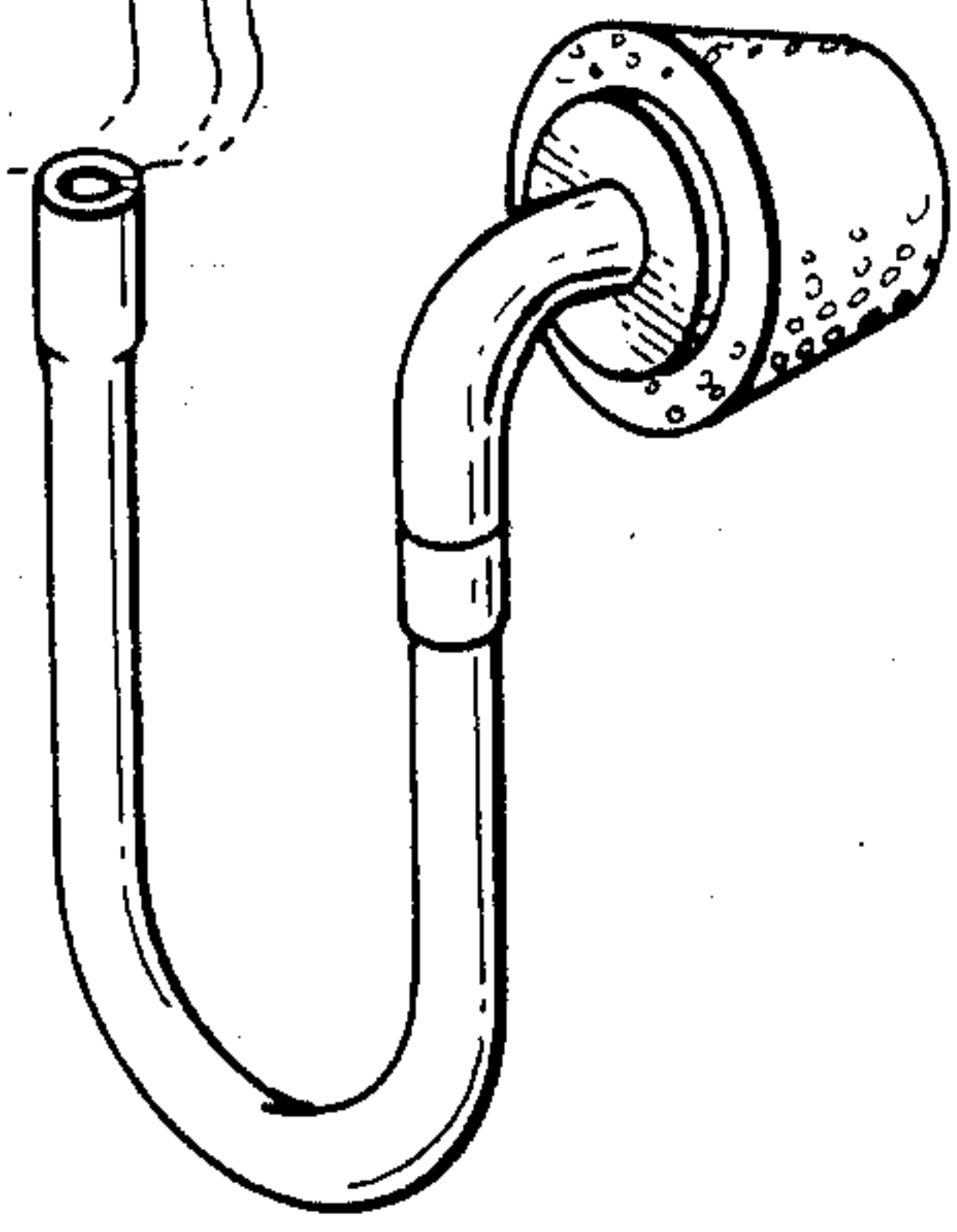

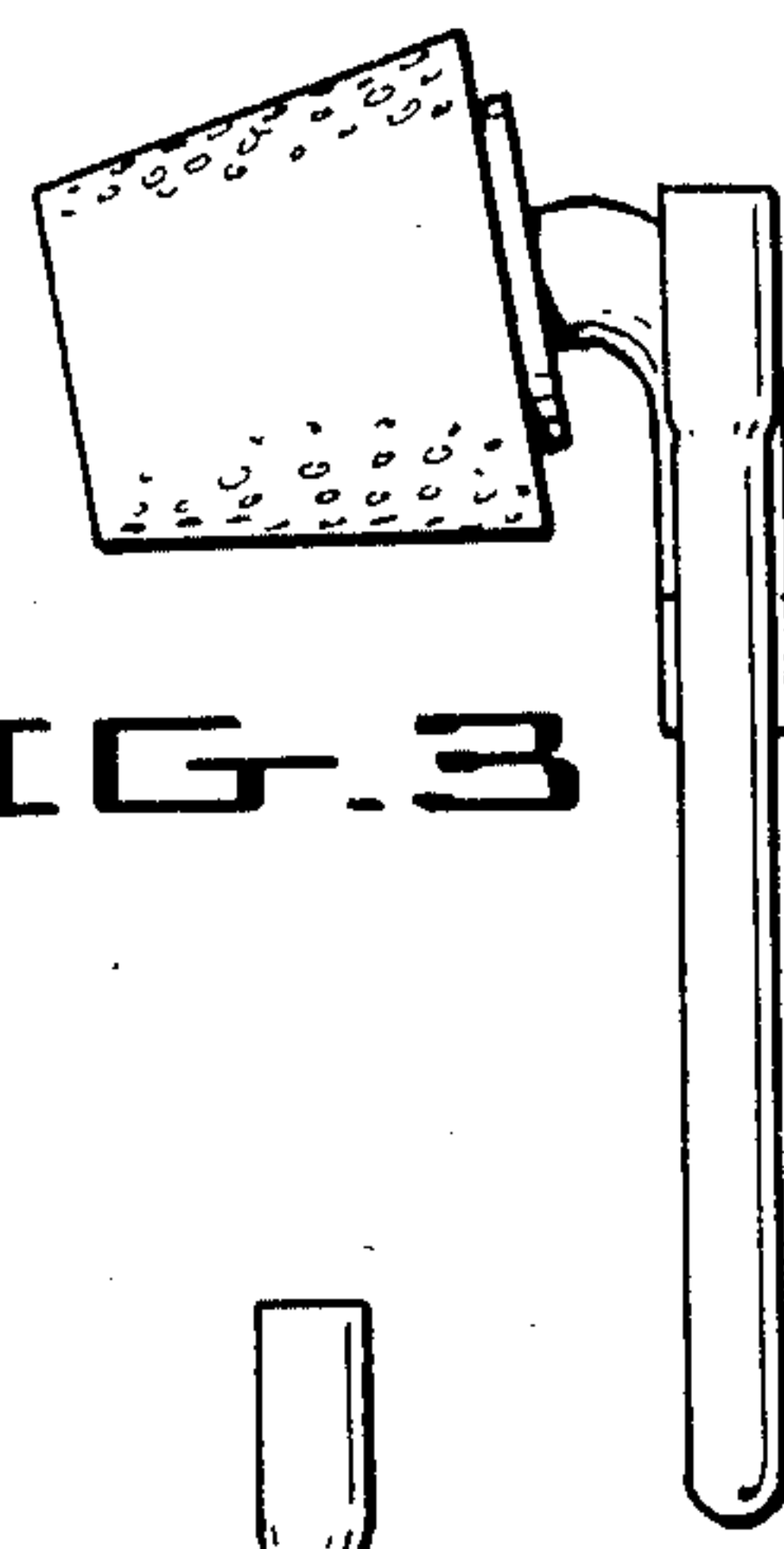

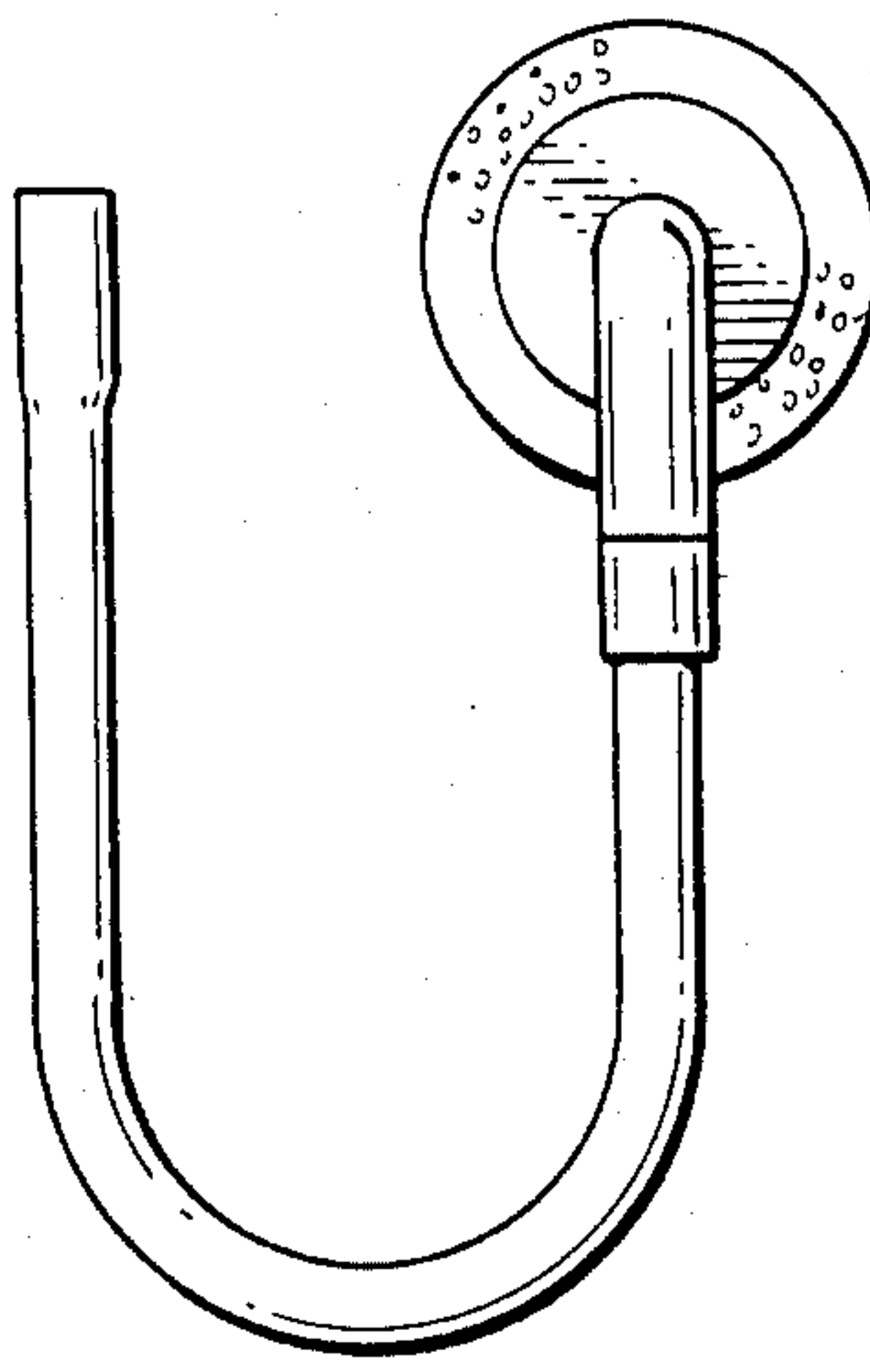

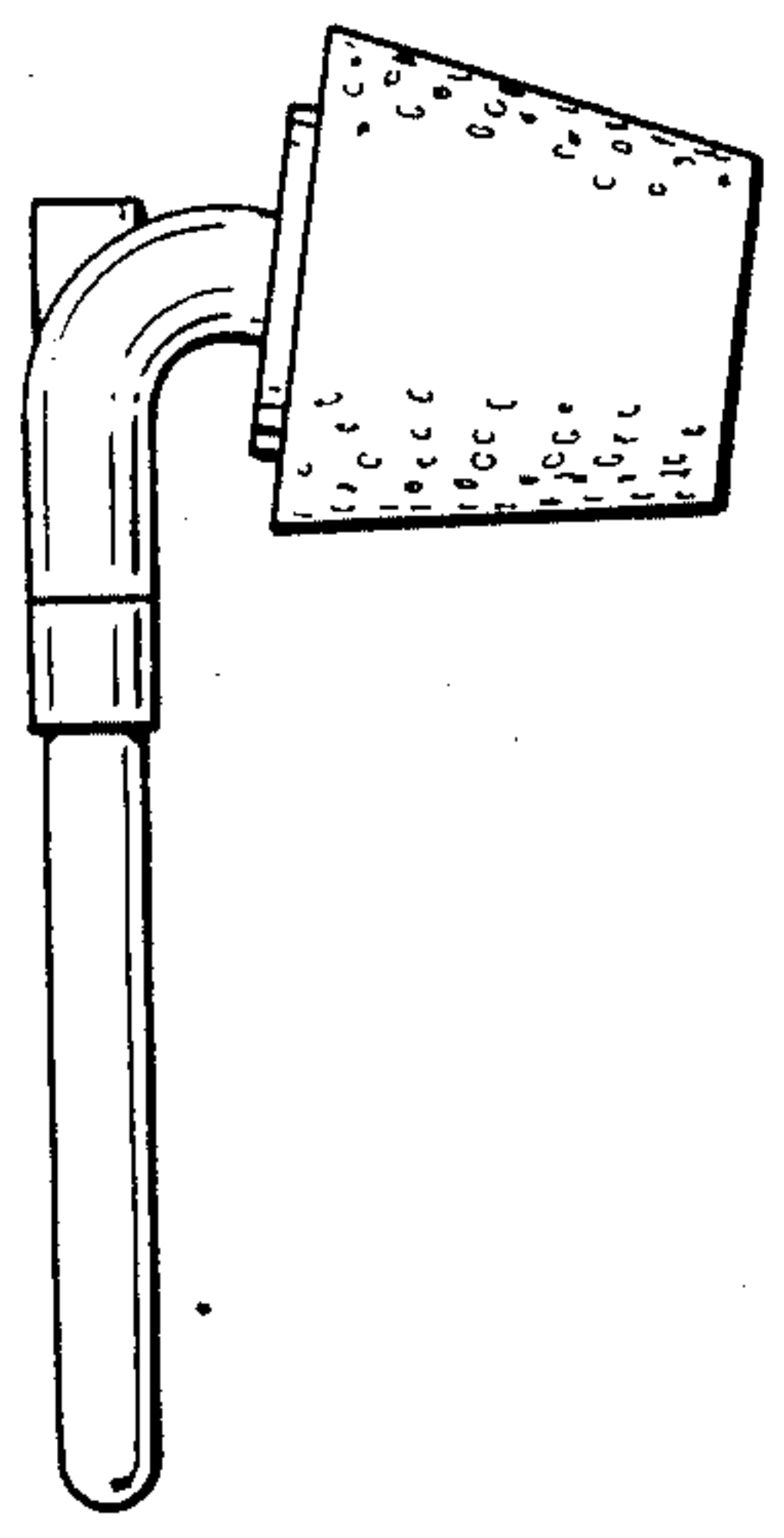

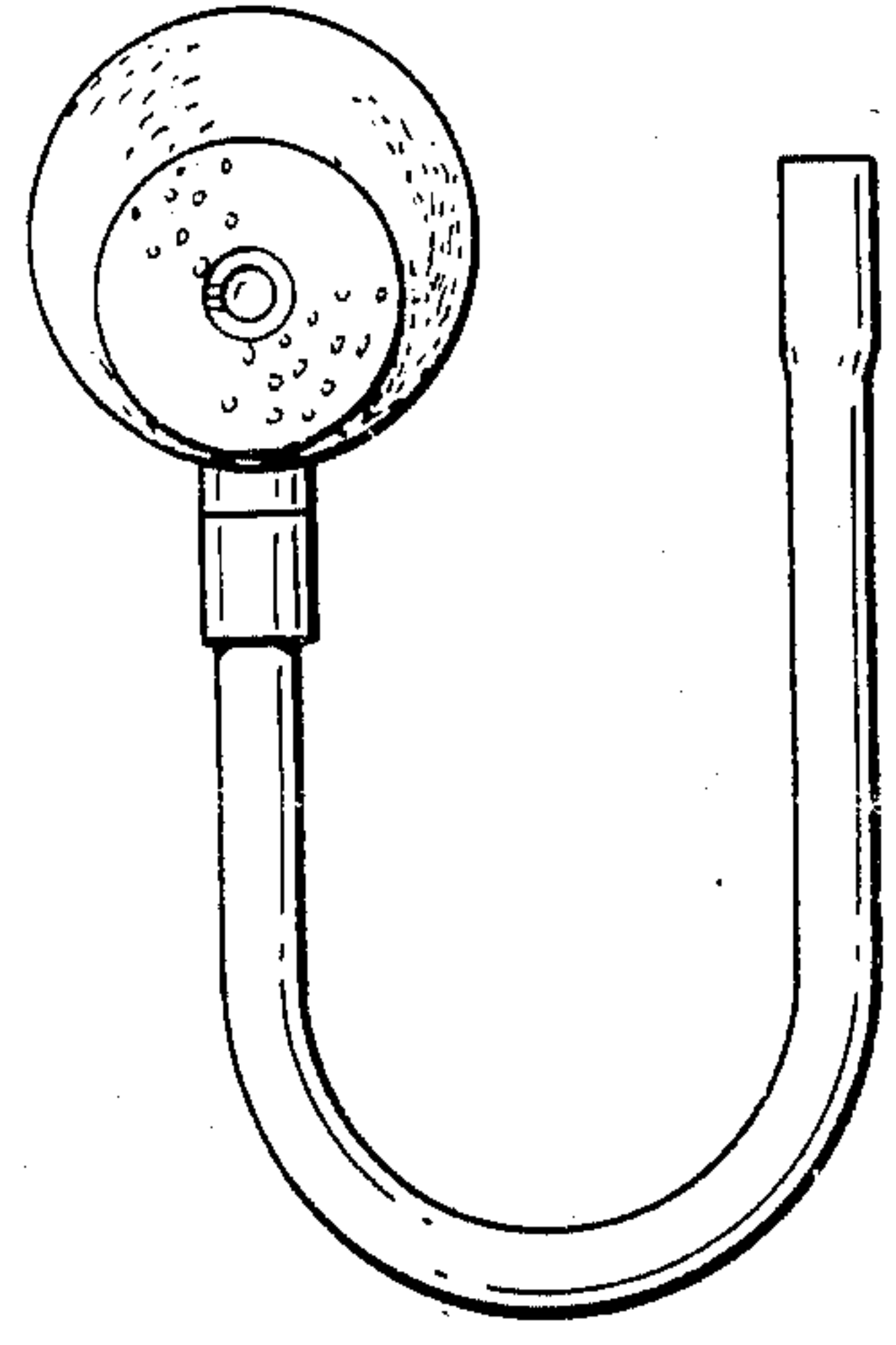

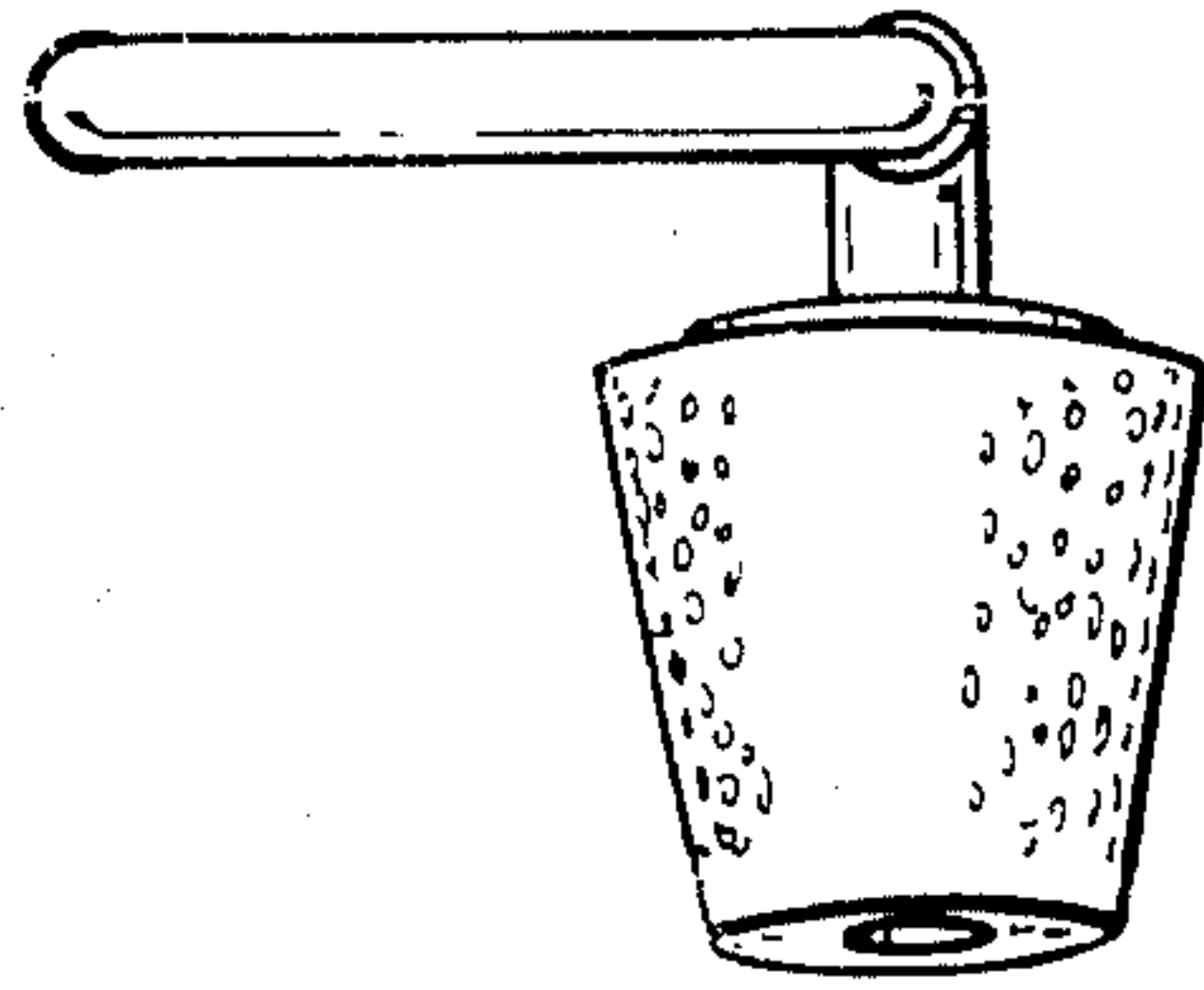
