DESCRIPTION

FIG. 1 is a front right side perspective view of a telephone set showing my new design;

FIGS. 6 and 7 are respectively left side elevational and rear elevational views thereof.

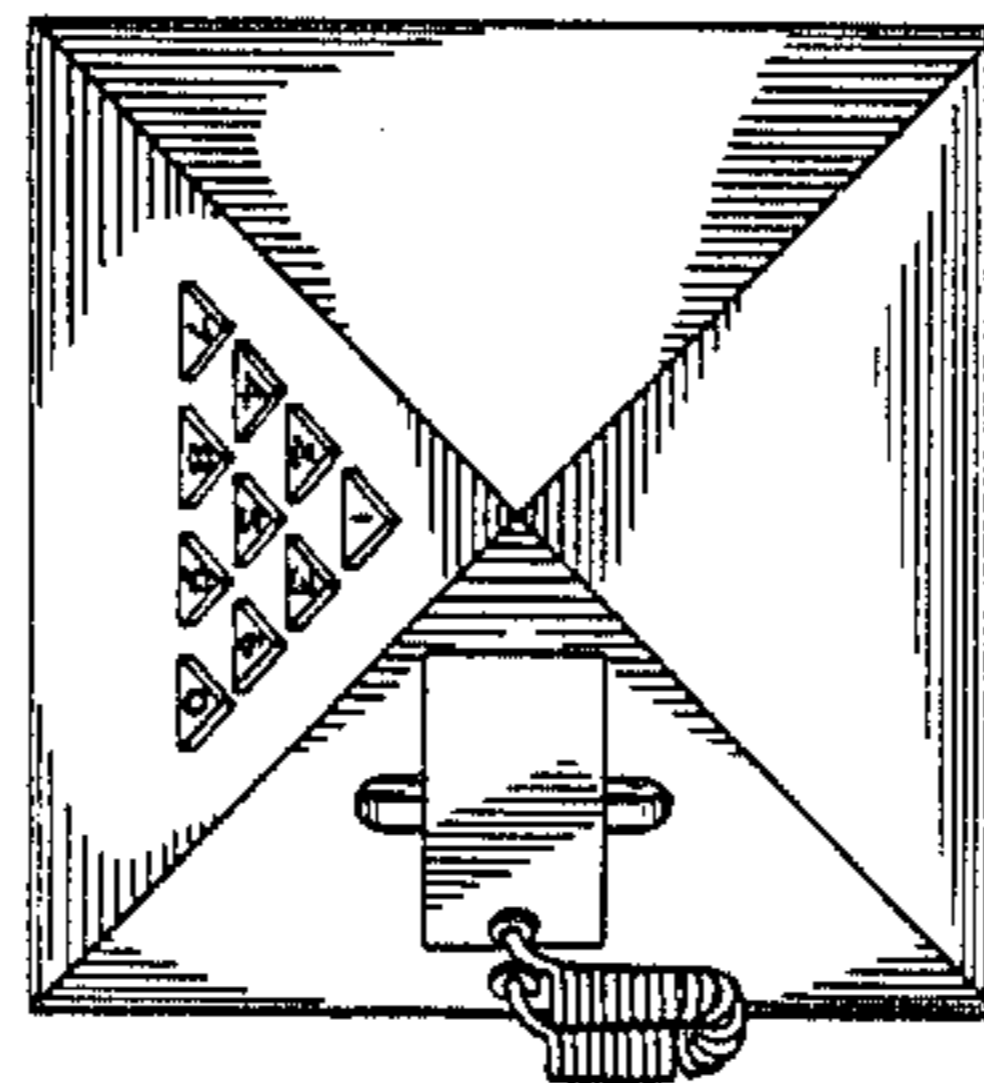
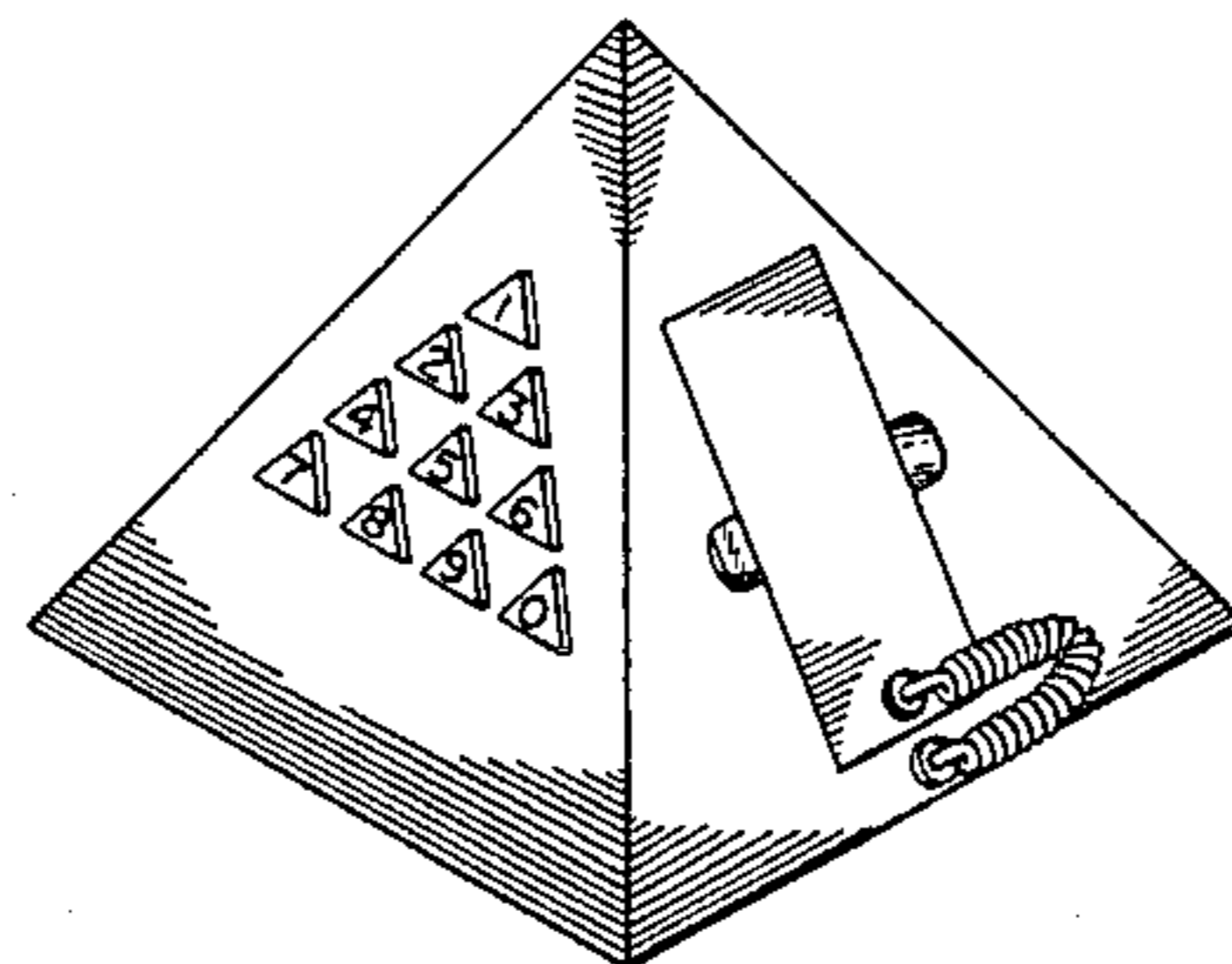

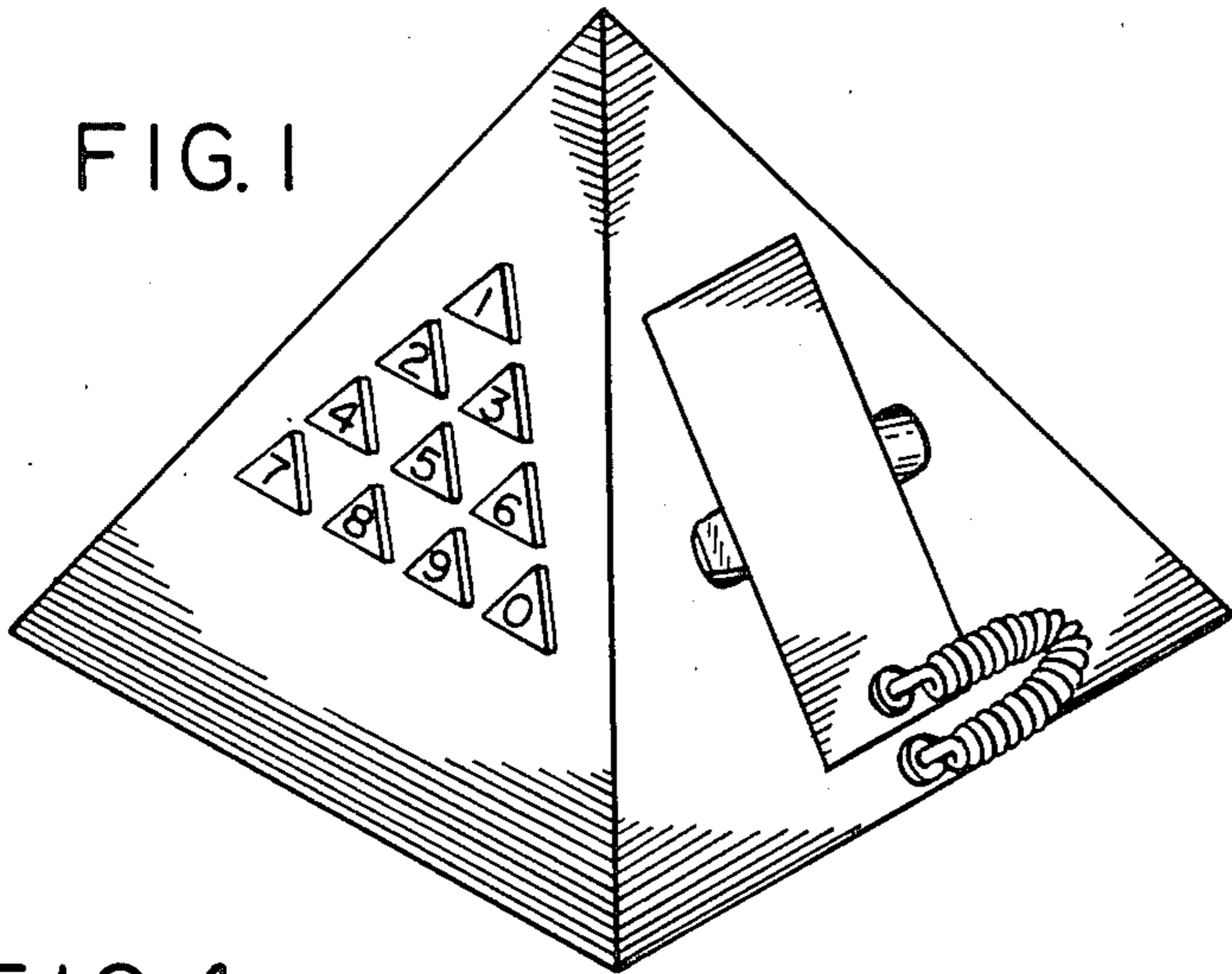

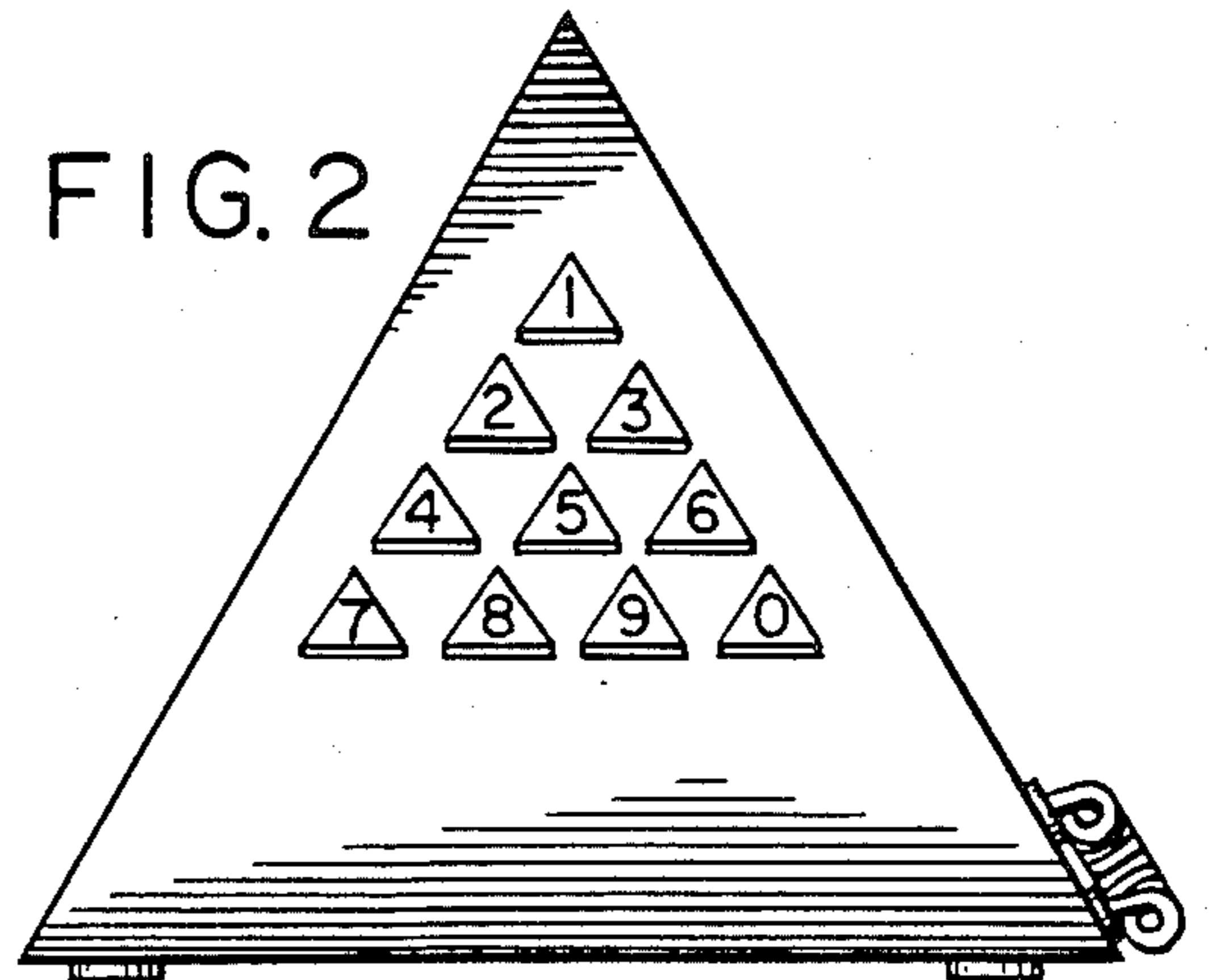

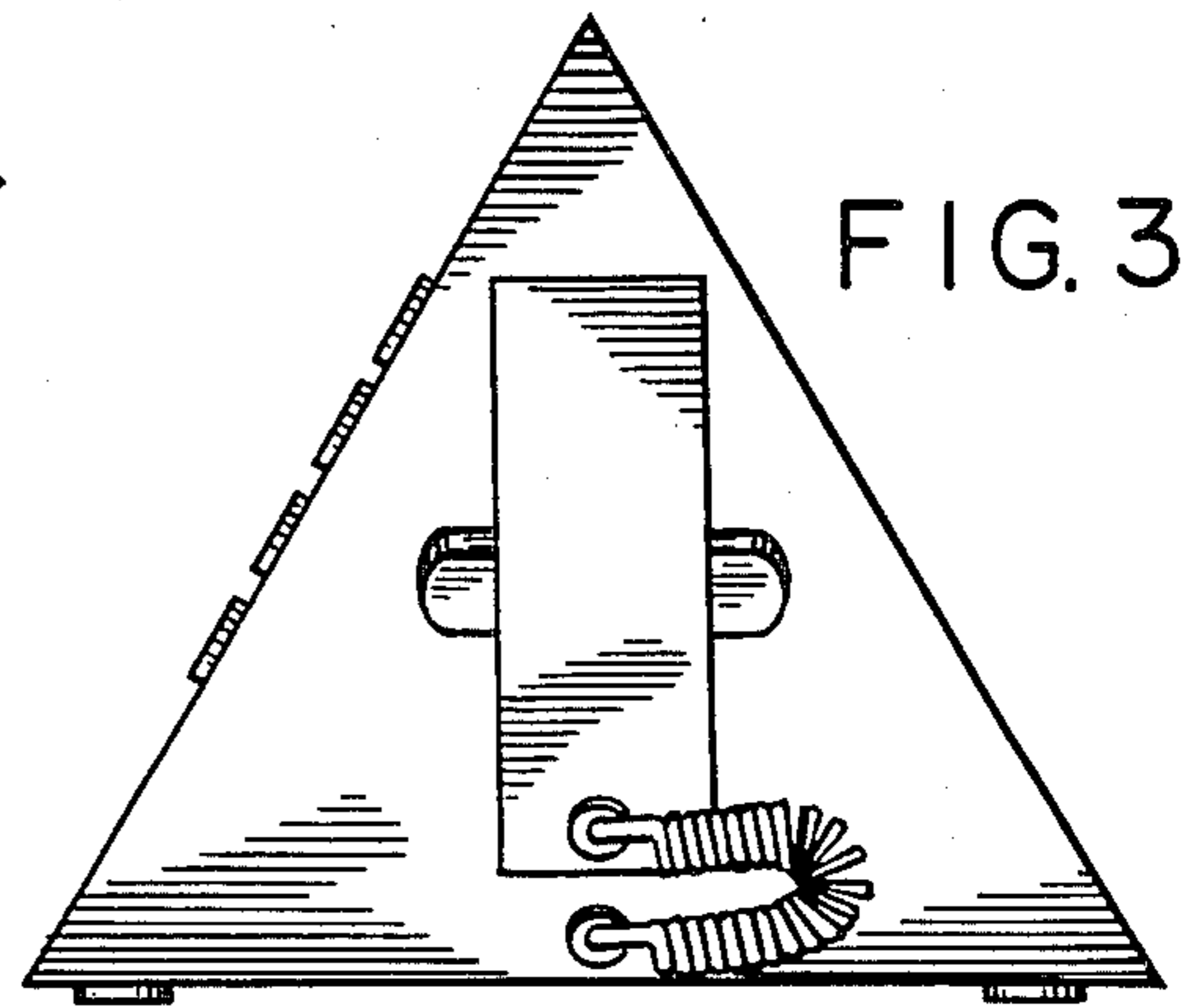

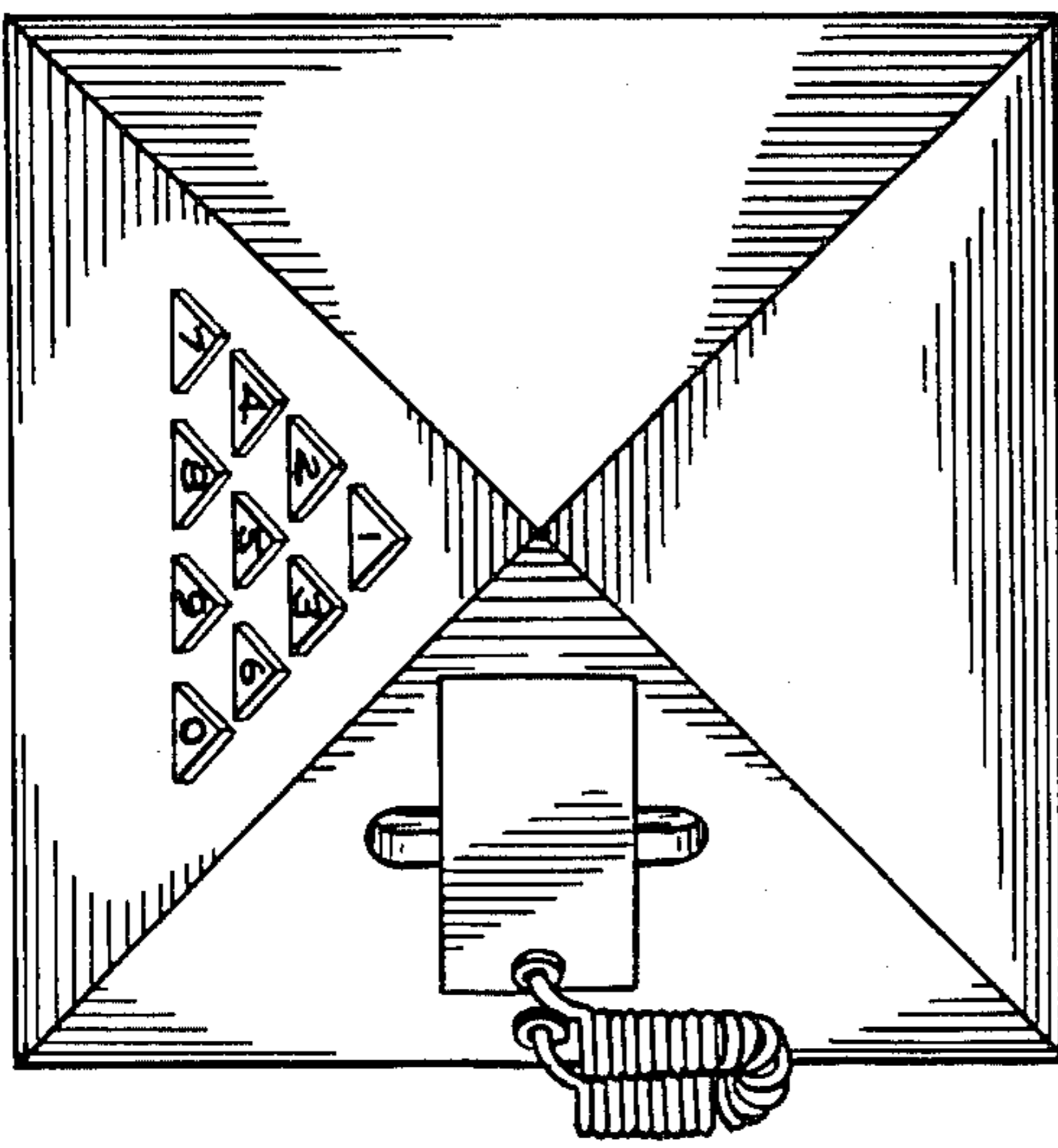

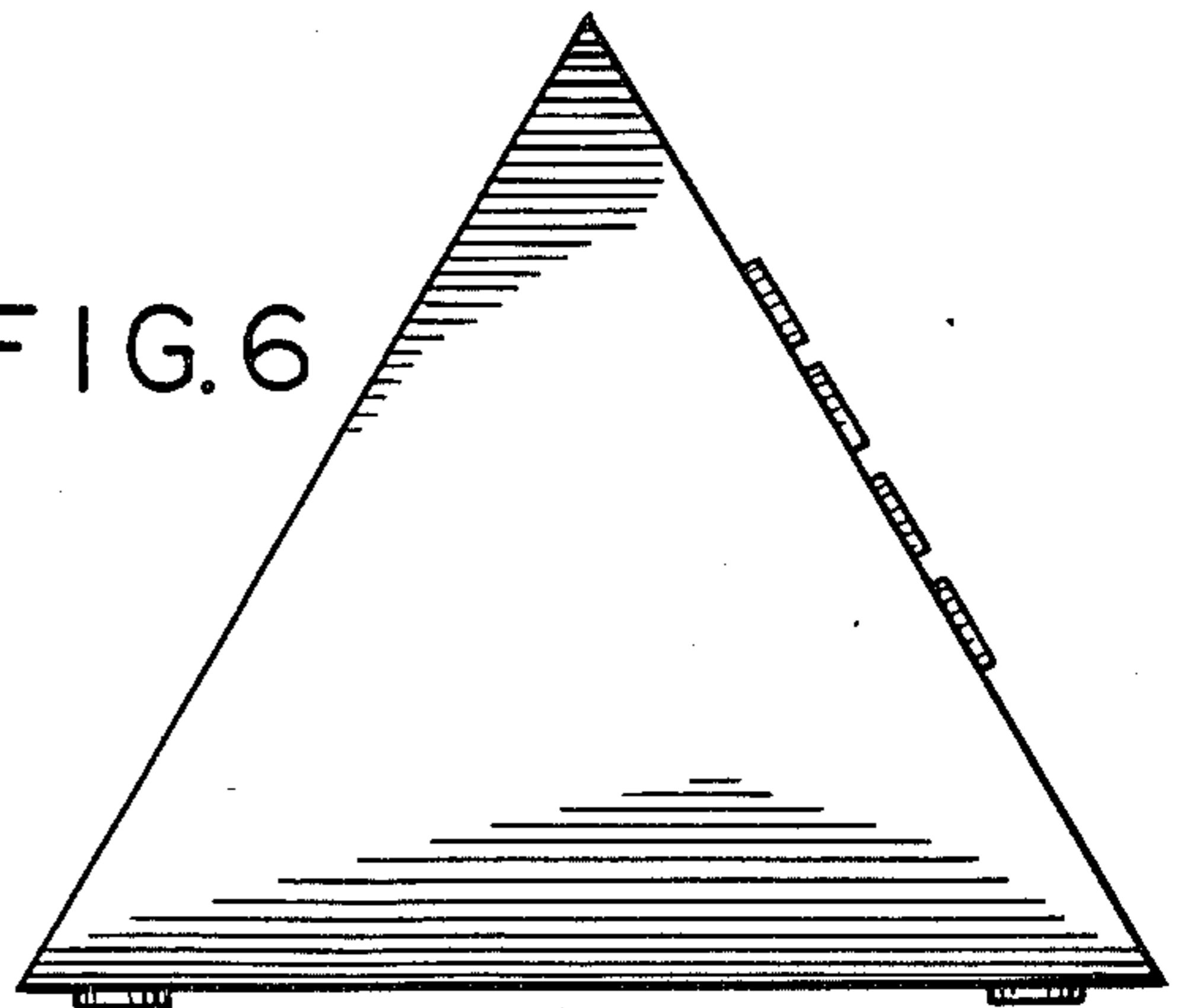

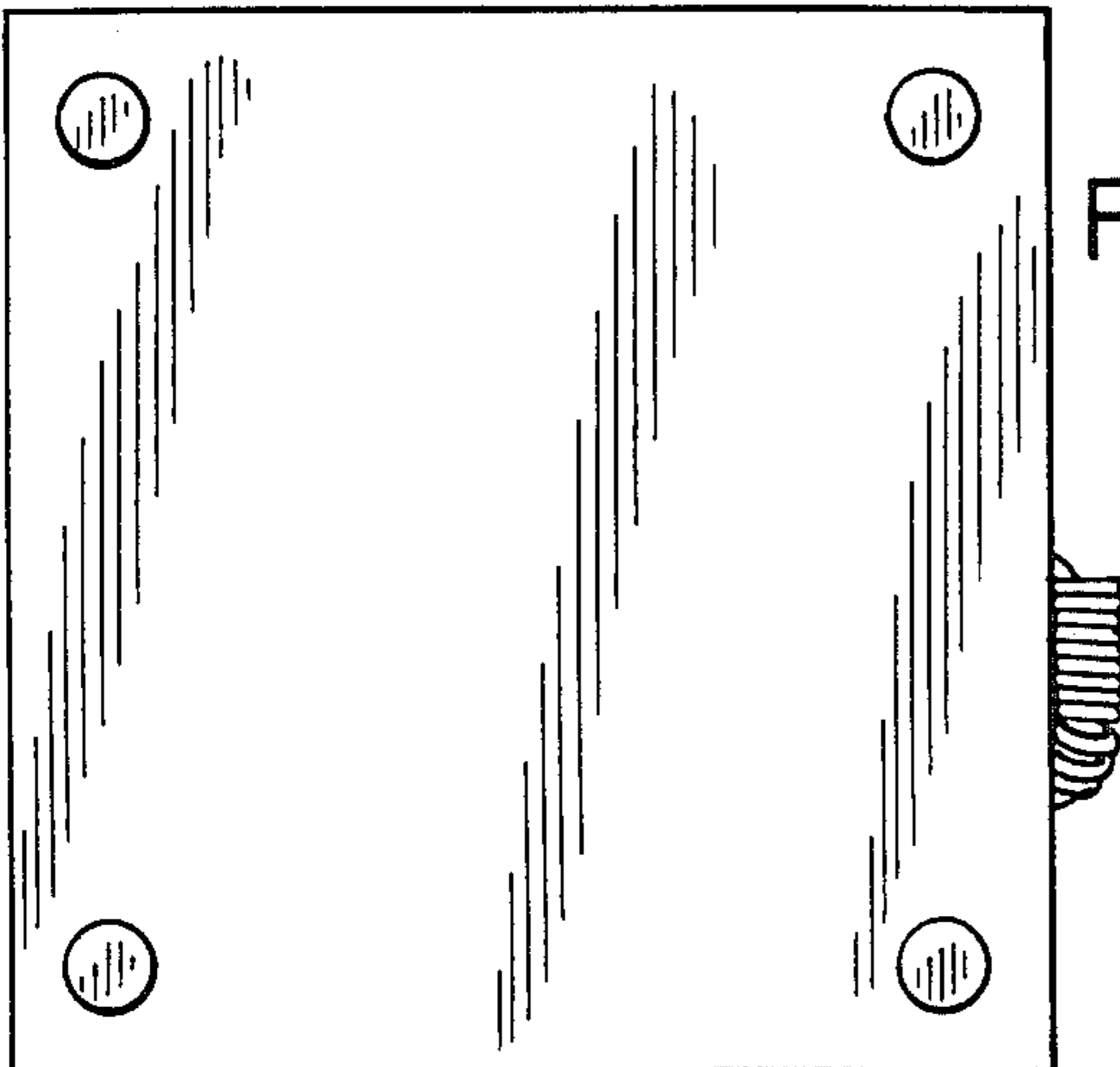
