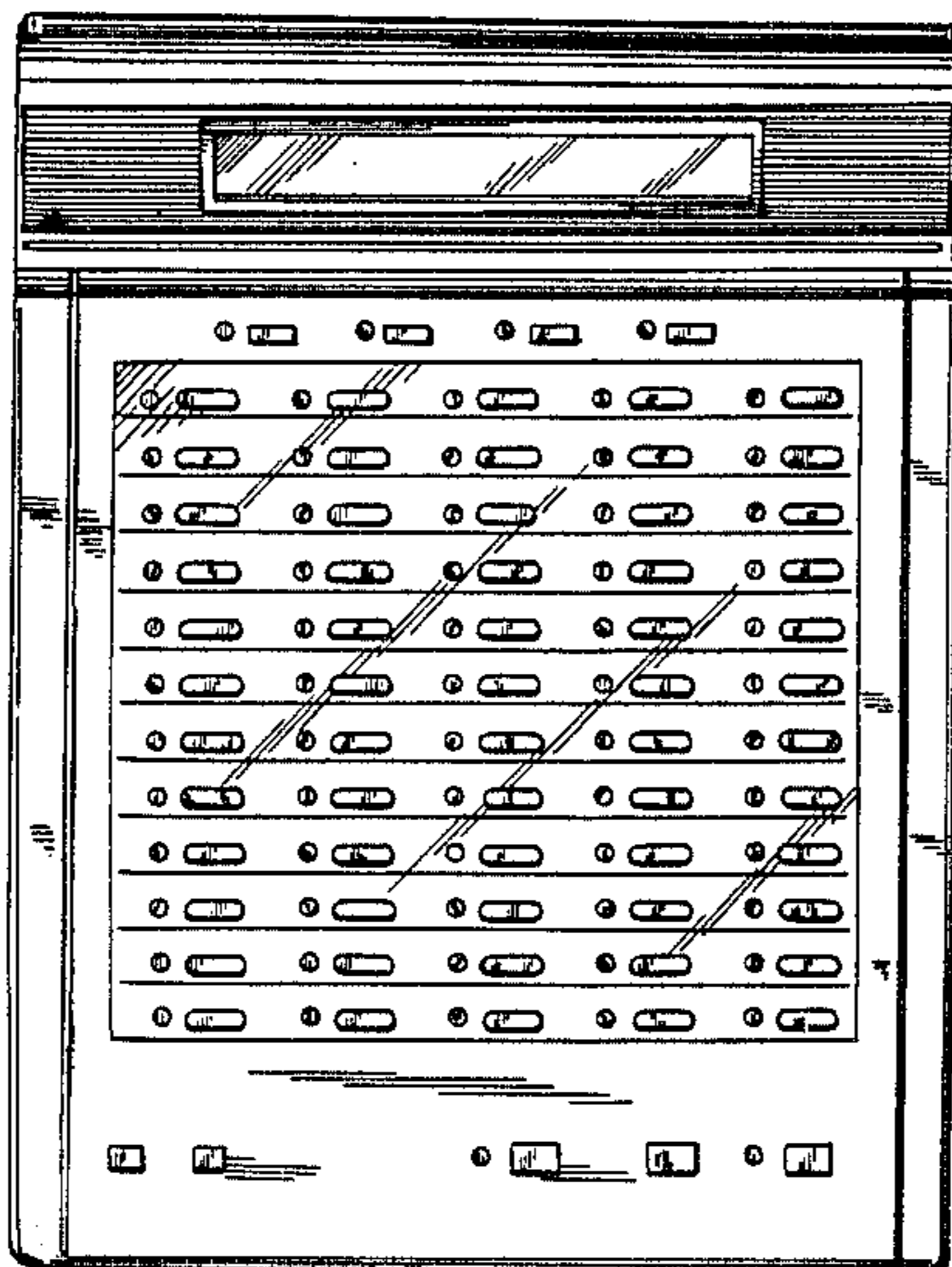
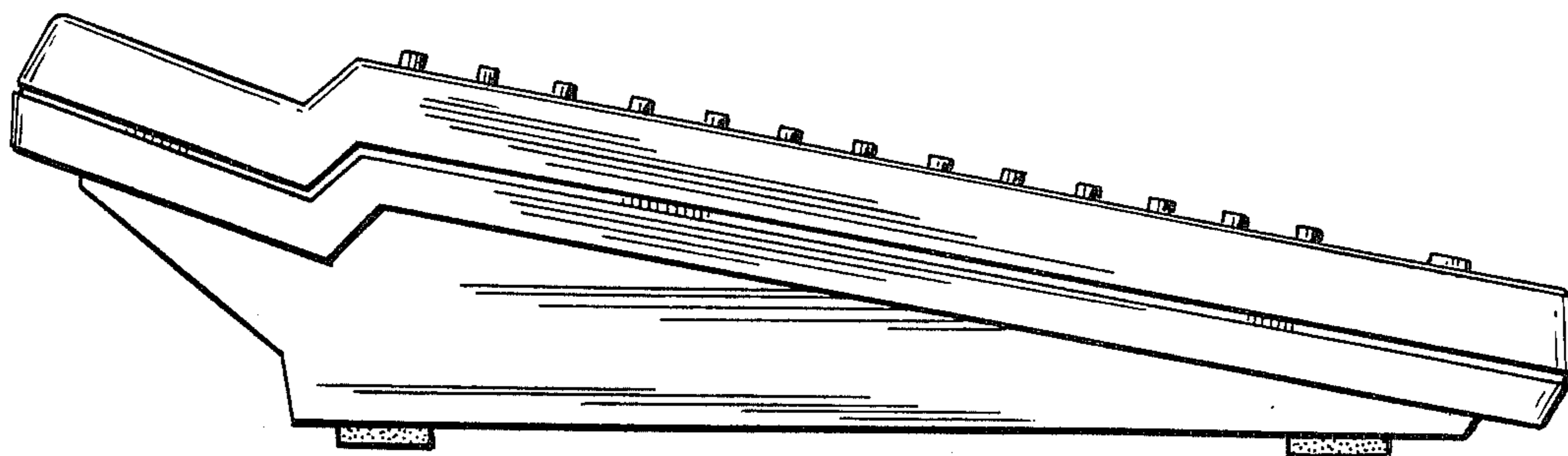

[57] **CLAIM**

The ornamental design for a direct station telephone selector stand, as shown and described.

DESCRIPTION

FIG. 1 is an enlarged perspective front elevational-like view of a direct station telephone selector stand showing our new design;
 FIG. 2 is a rear elevational view thereof;
 FIG. 3 is a left side elevational view thereof, the side opposite being a mirror image;
 FIG. 4 is a top plan view thereof;
 FIG. 5 is a bottom plan view thereof; and
 FIG. 6 is a front, top and right side perspective view thereof.



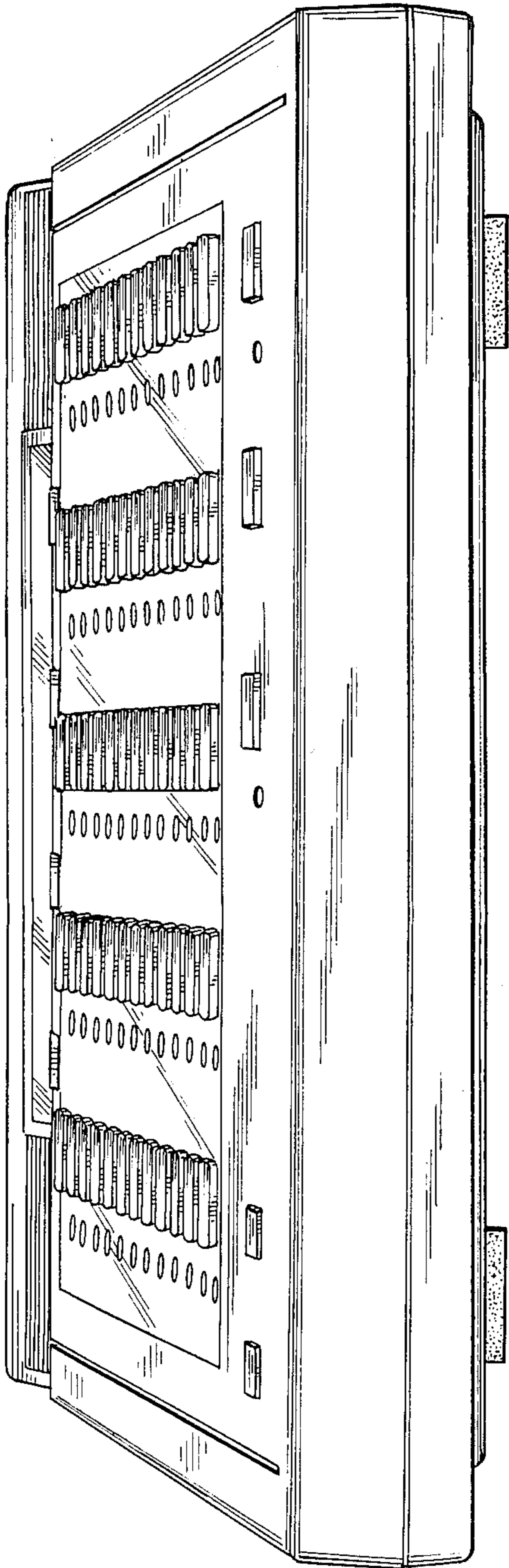

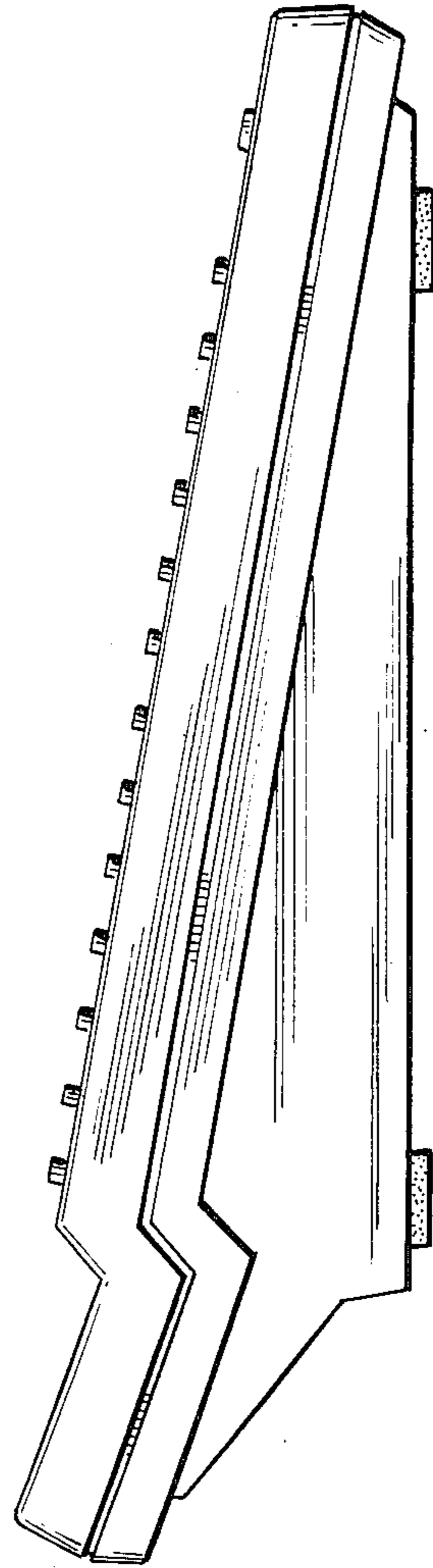

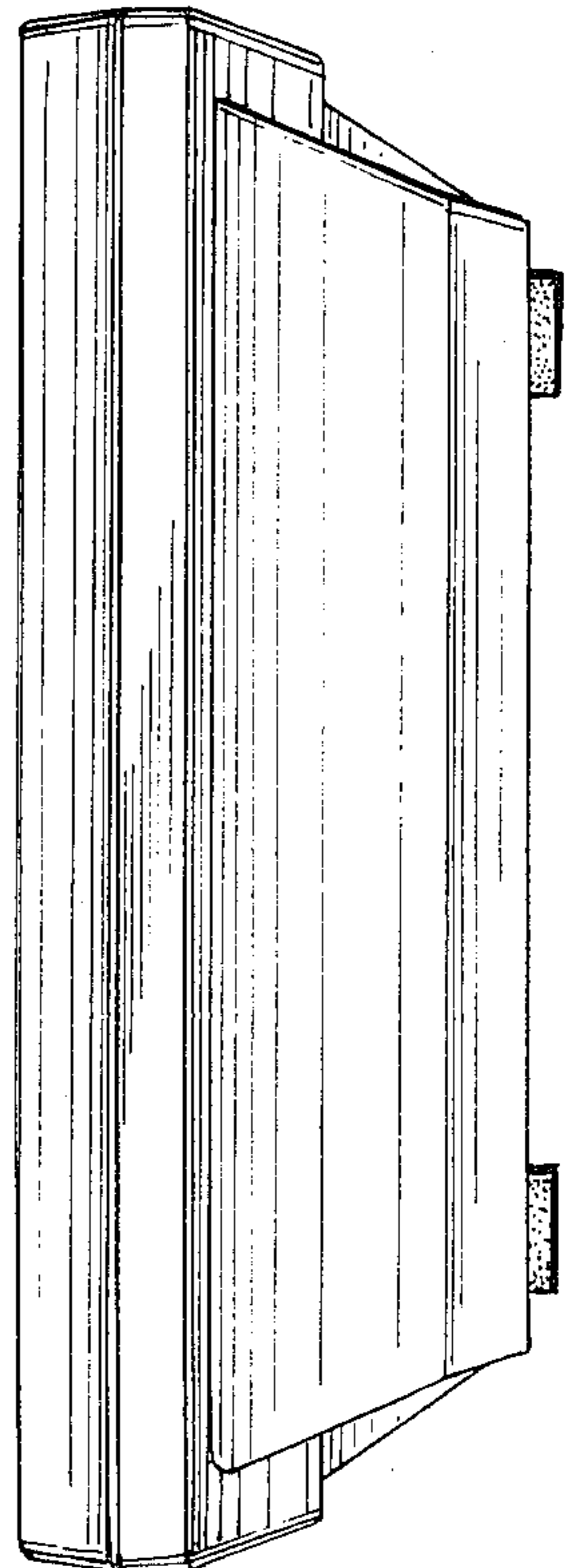

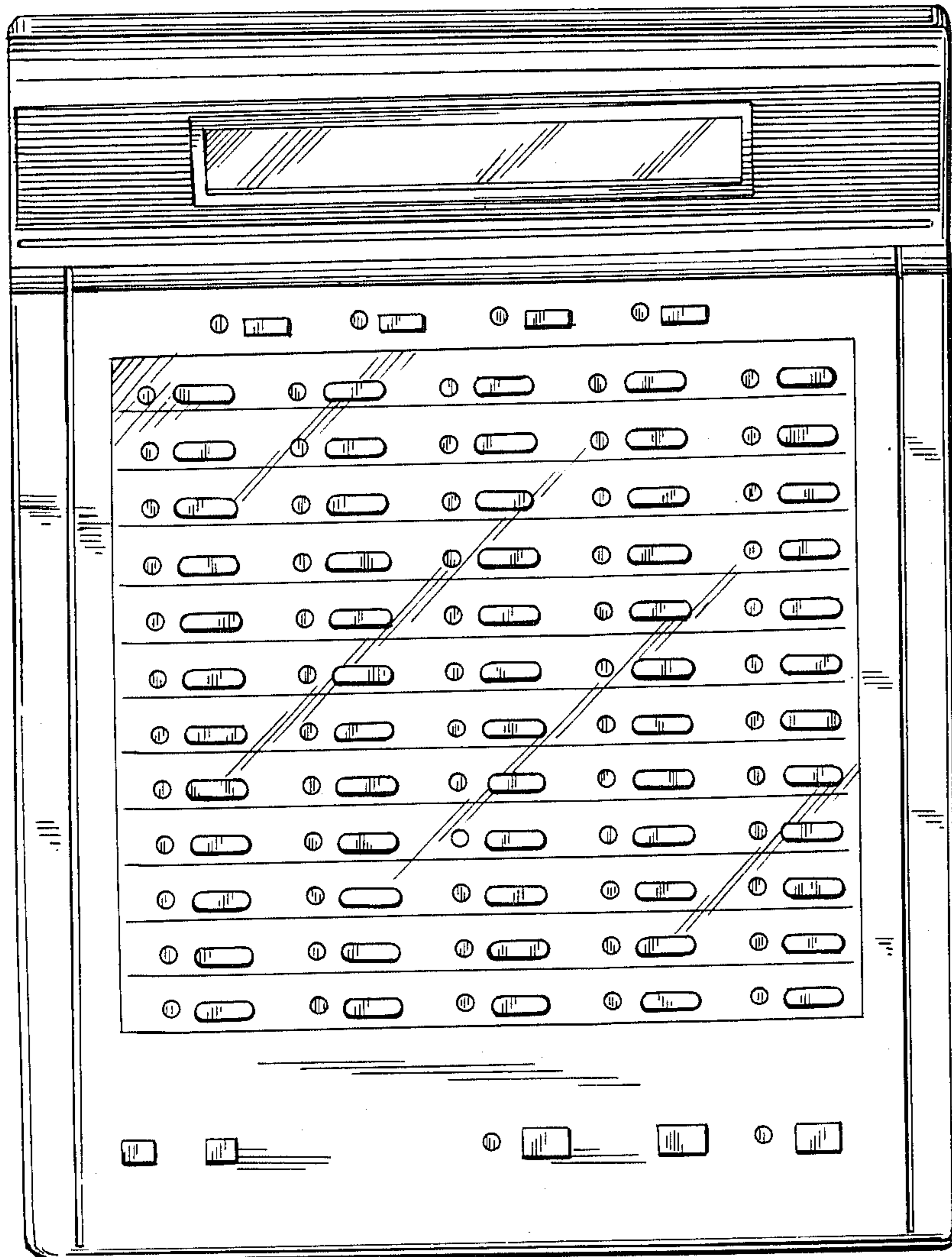

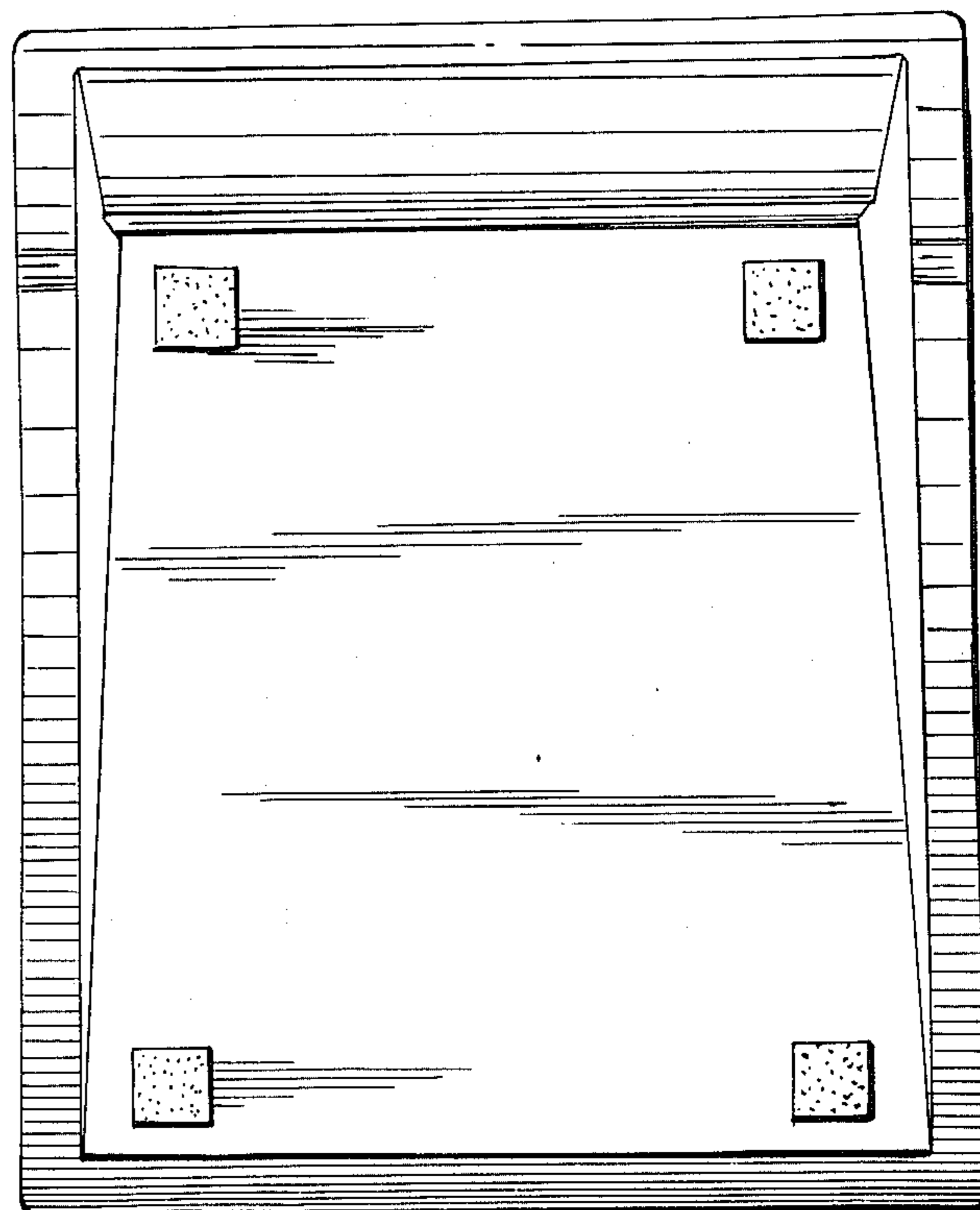

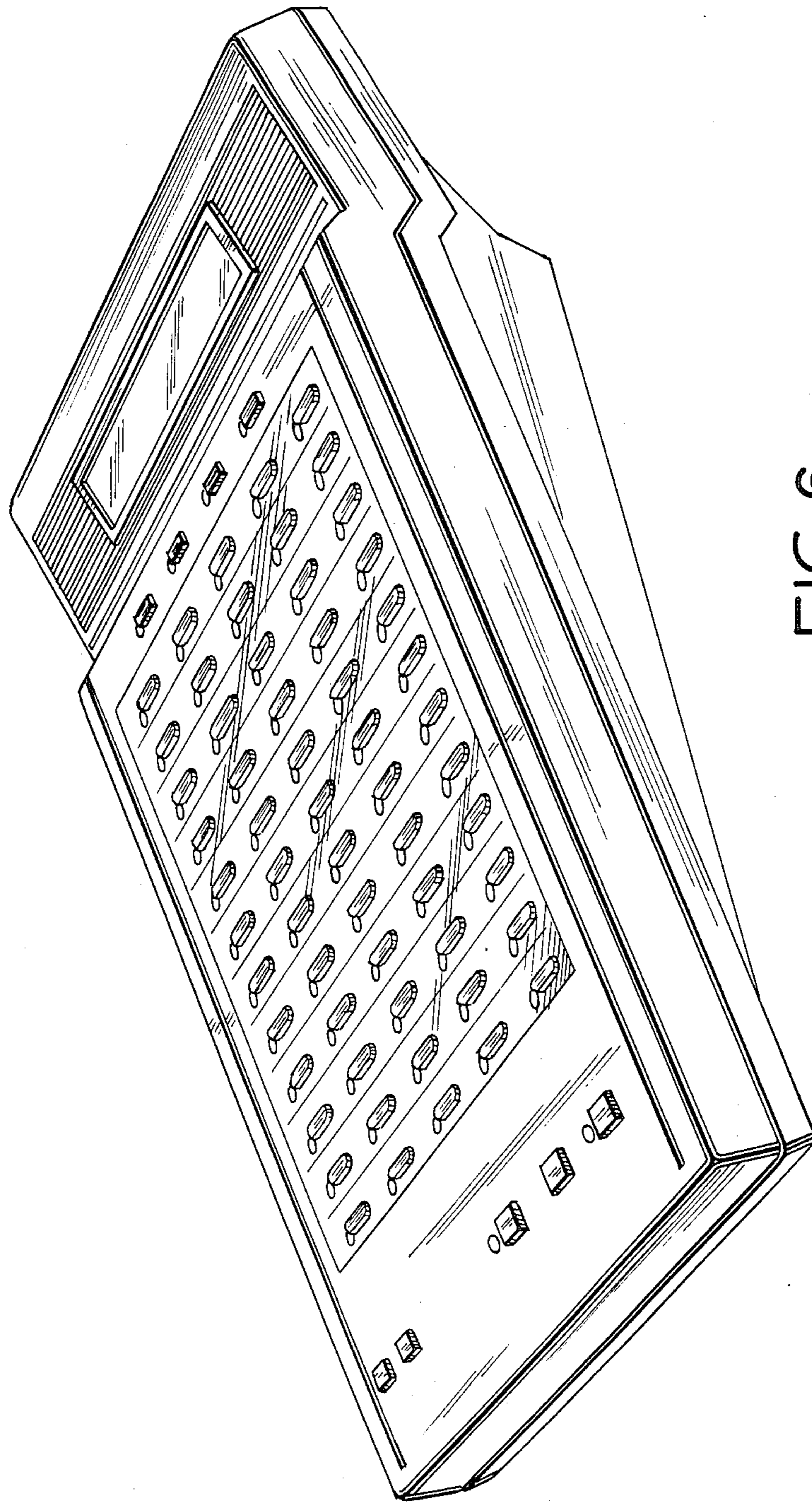
