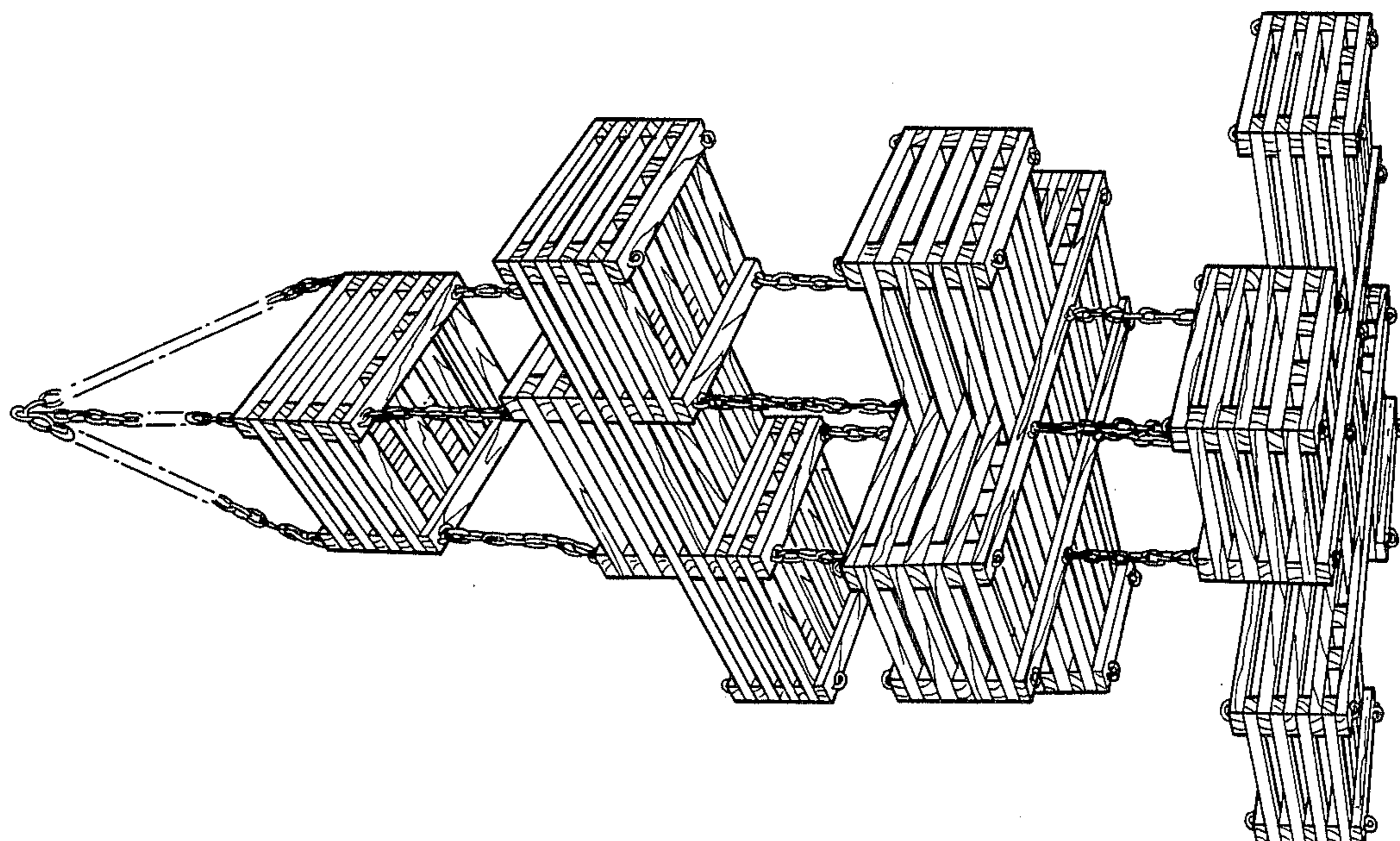

[57] **CLAIM**

The ornamental design for a hanging modular planter, as shown and described.

DESCRIPTION

FIG. 1 is a bottom perspective view of a hanging modular planter showing my new design, the portions of the chain link being omitted for convenience of illustration; FIG. 2 is a side elevational view of the top tier thereof, the opposite side being identical in appearance and the other tiers being omitted for convenience of illustration; FIG. 3 is a front elevational view of the top tier thereof, the rear being identical in appearance; FIG. 4 is a bottom plan view of the top tier thereof; FIG. 5 is a side elevational view of the second tier thereof, the opposite side being identical in appearance and the other tiers being omitted for convenience of illustration; FIG. 6 is a front elevational view of the second tier thereof, the rear being identical in appearance; FIG. 7 is a bottom plan view of the second tier thereof; FIG. 8 is a side elevational view of the third tier thereof, the opposite side being identical in appearance and the other tiers being omitted for convenience of illustration; FIG. 9 is a front elevational view of the third tier thereof, the rear being identical in appearance; FIG. 10 is a bottom plan view of the third tier thereof; FIG. 11 is a side elevational view of the bottom tier thereof, the opposite side being identical in appearance and the other tiers being omitted for convenience of illustration; FIG. 12 is a front elevational view of the bottom tier thereof, the rear being identical in appearance; and, FIG. 13 is a bottom plan view of the bottom tier thereof.



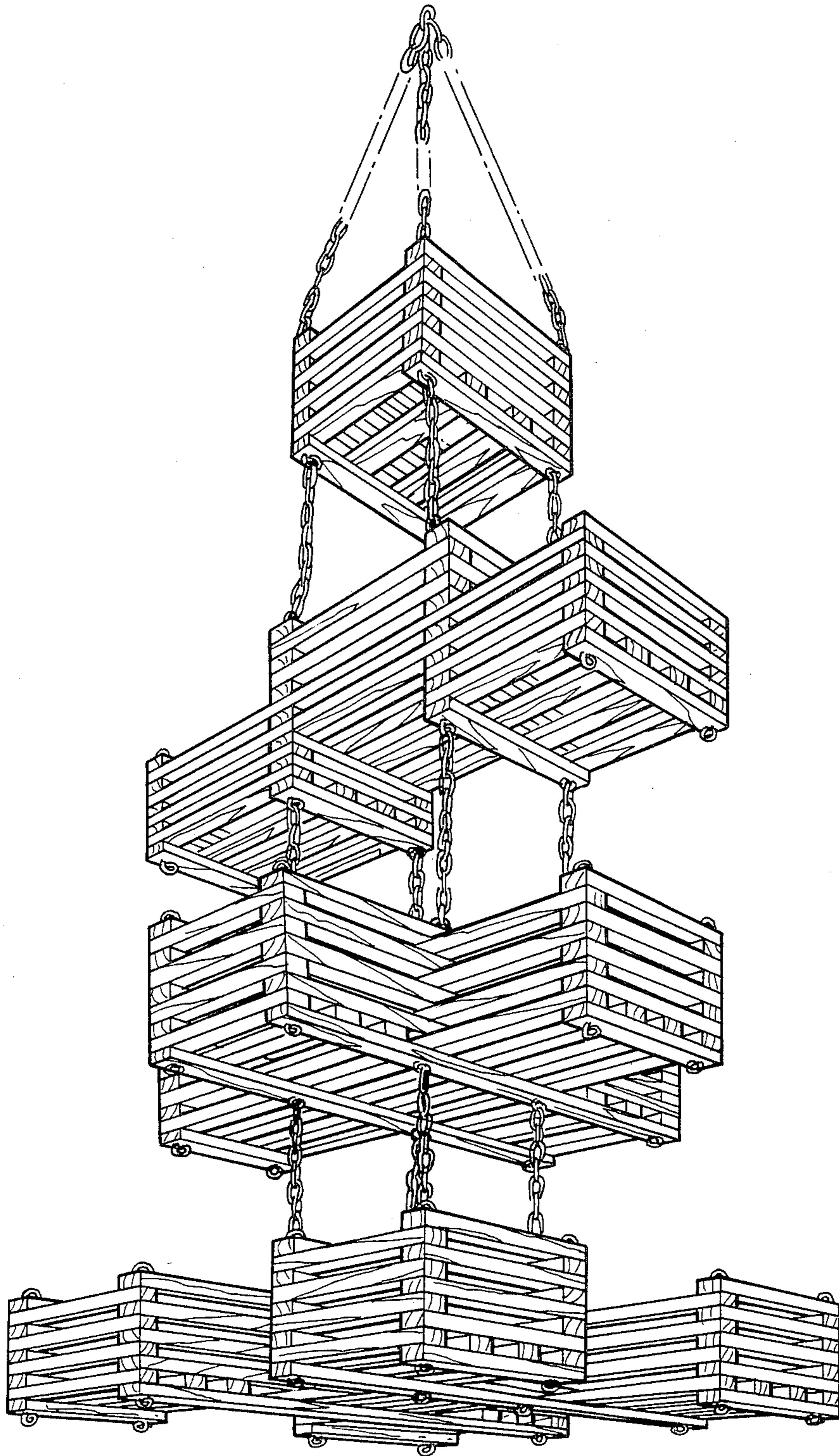

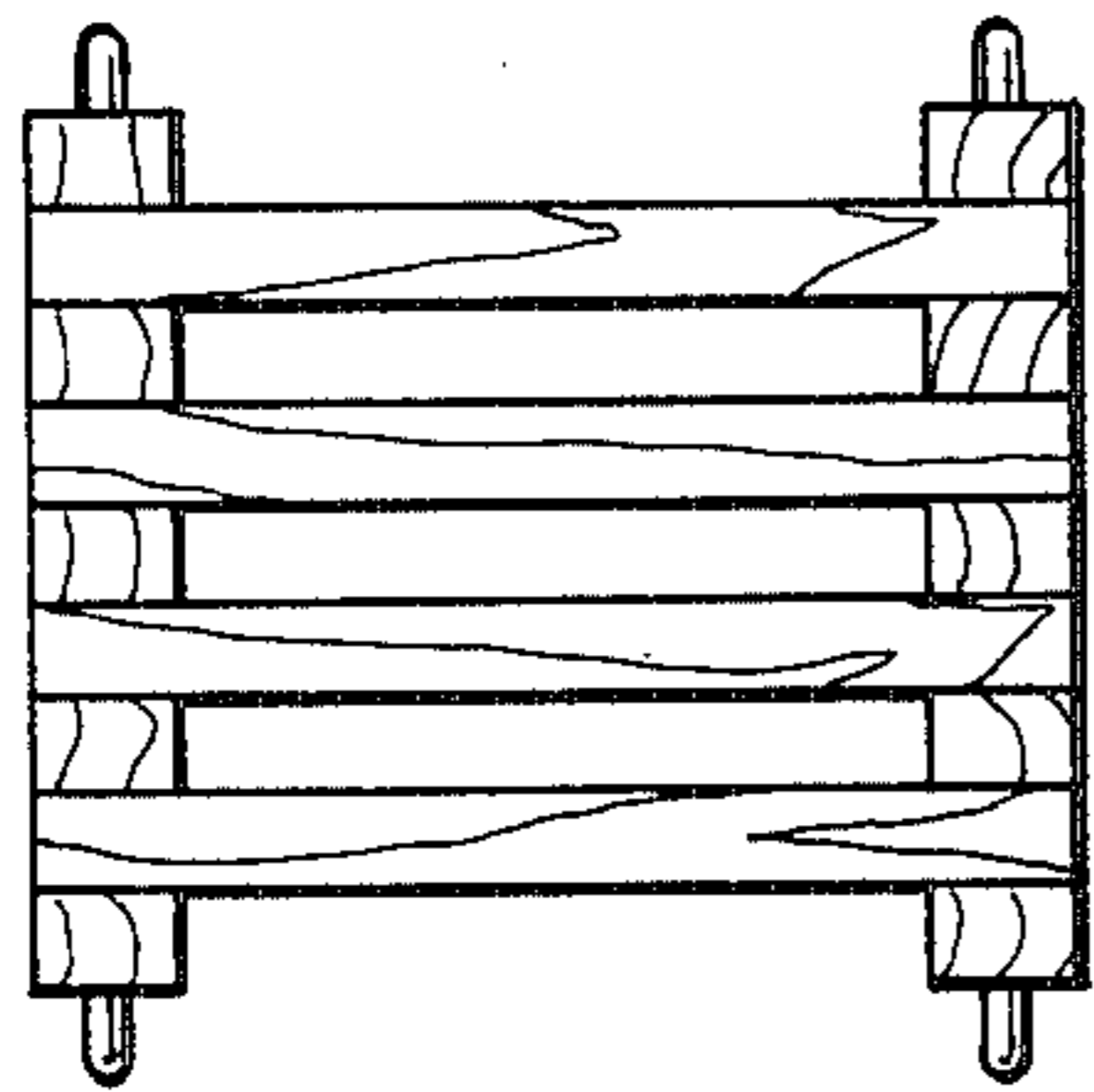

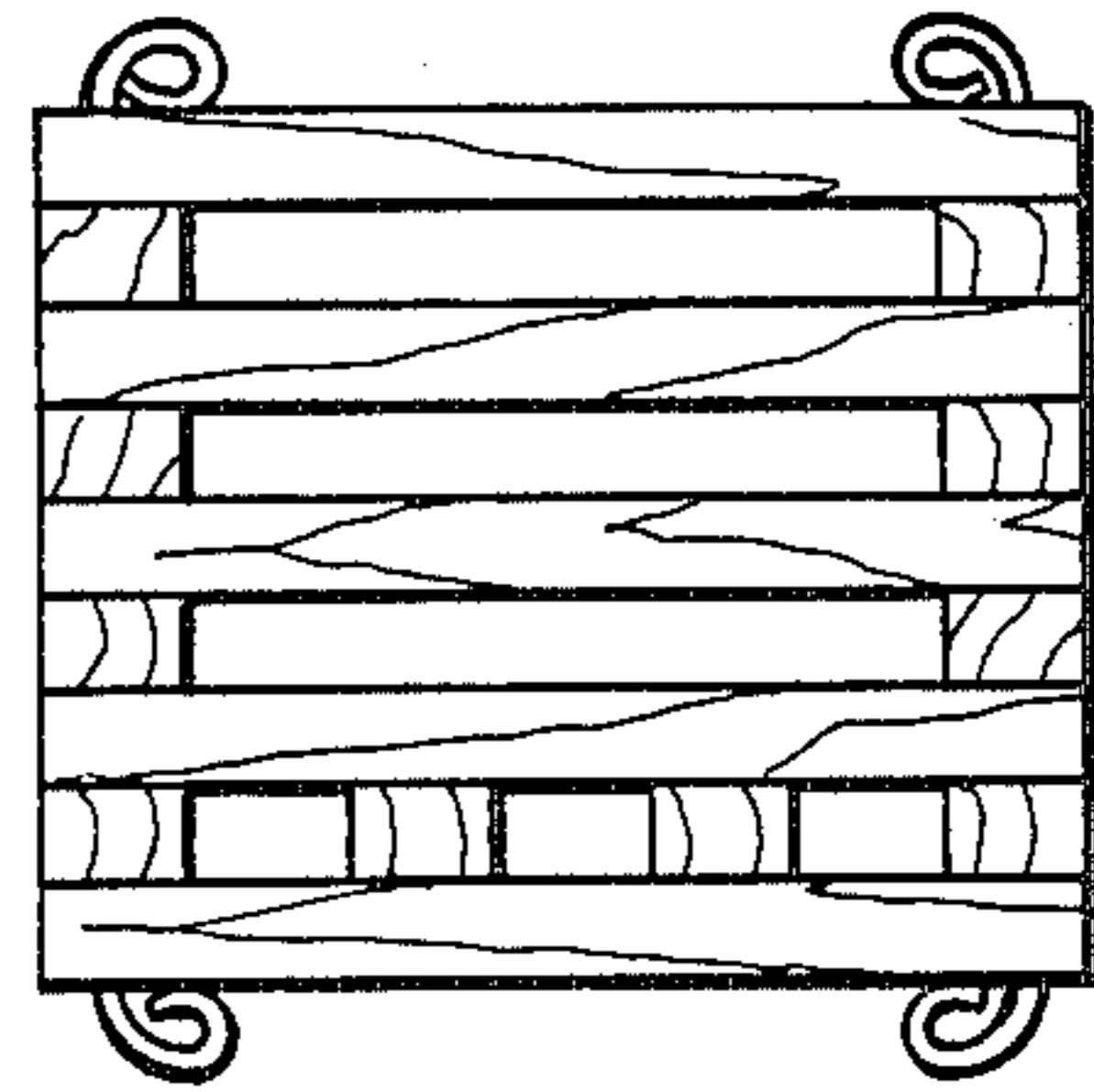

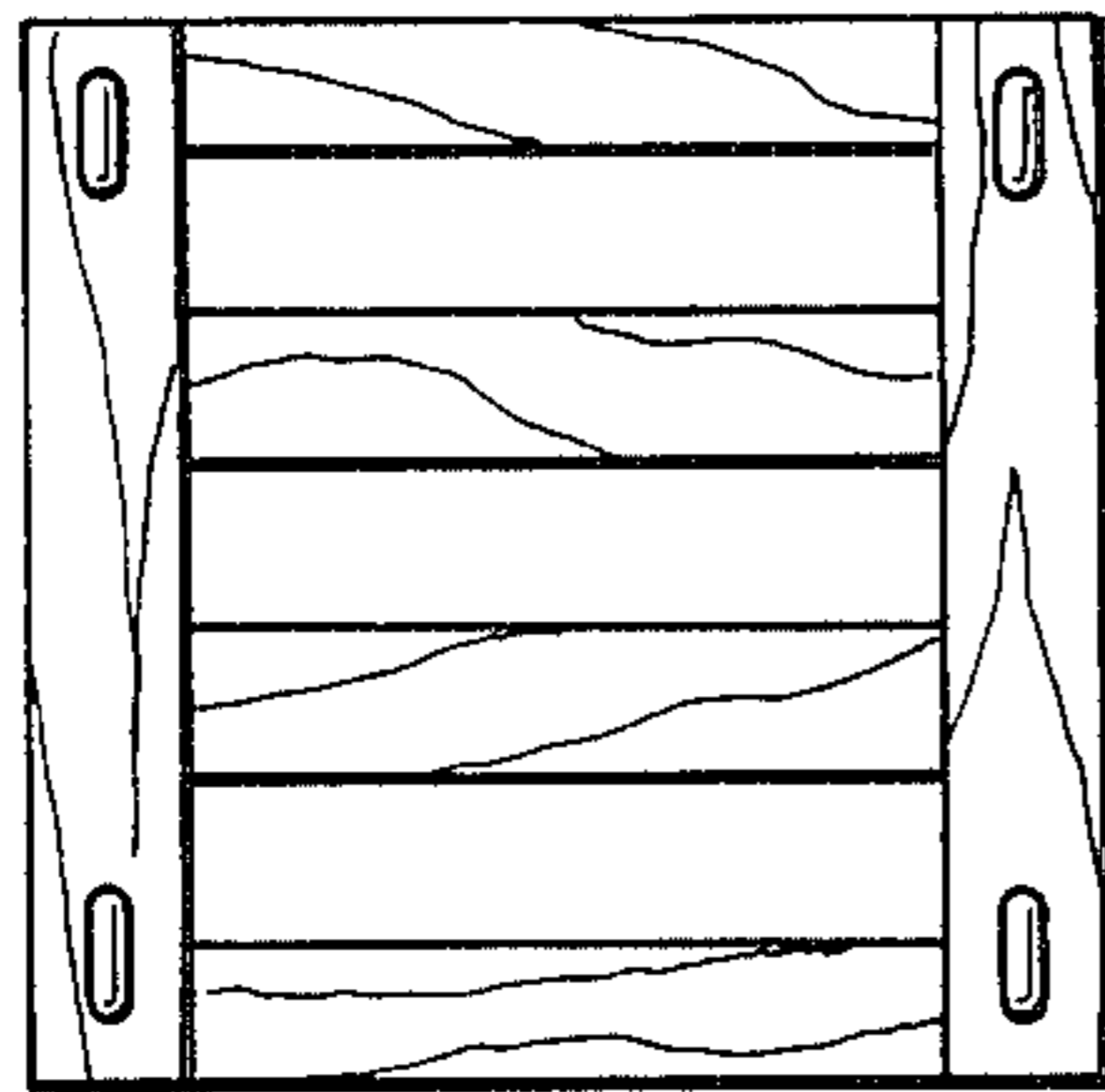

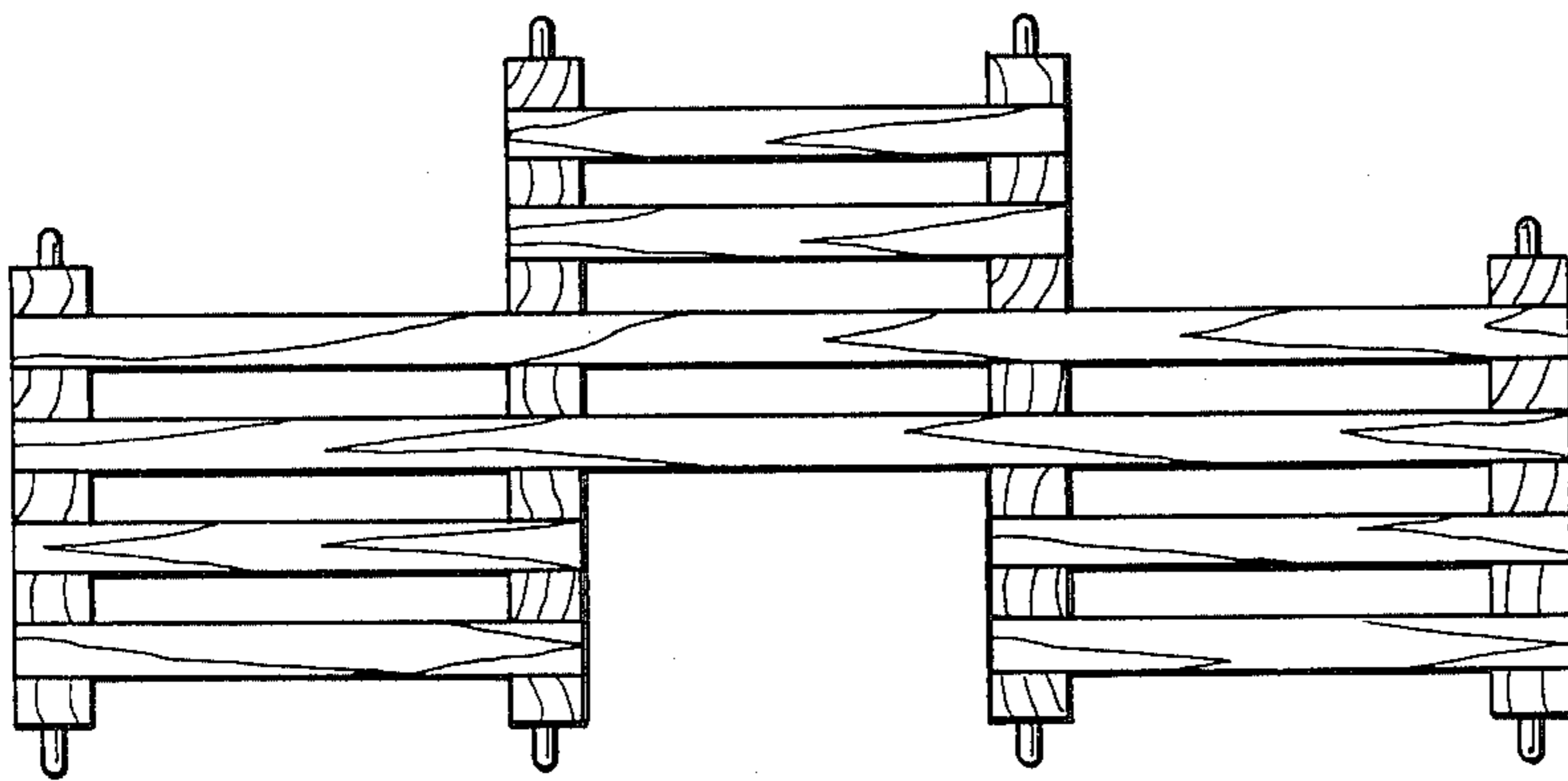

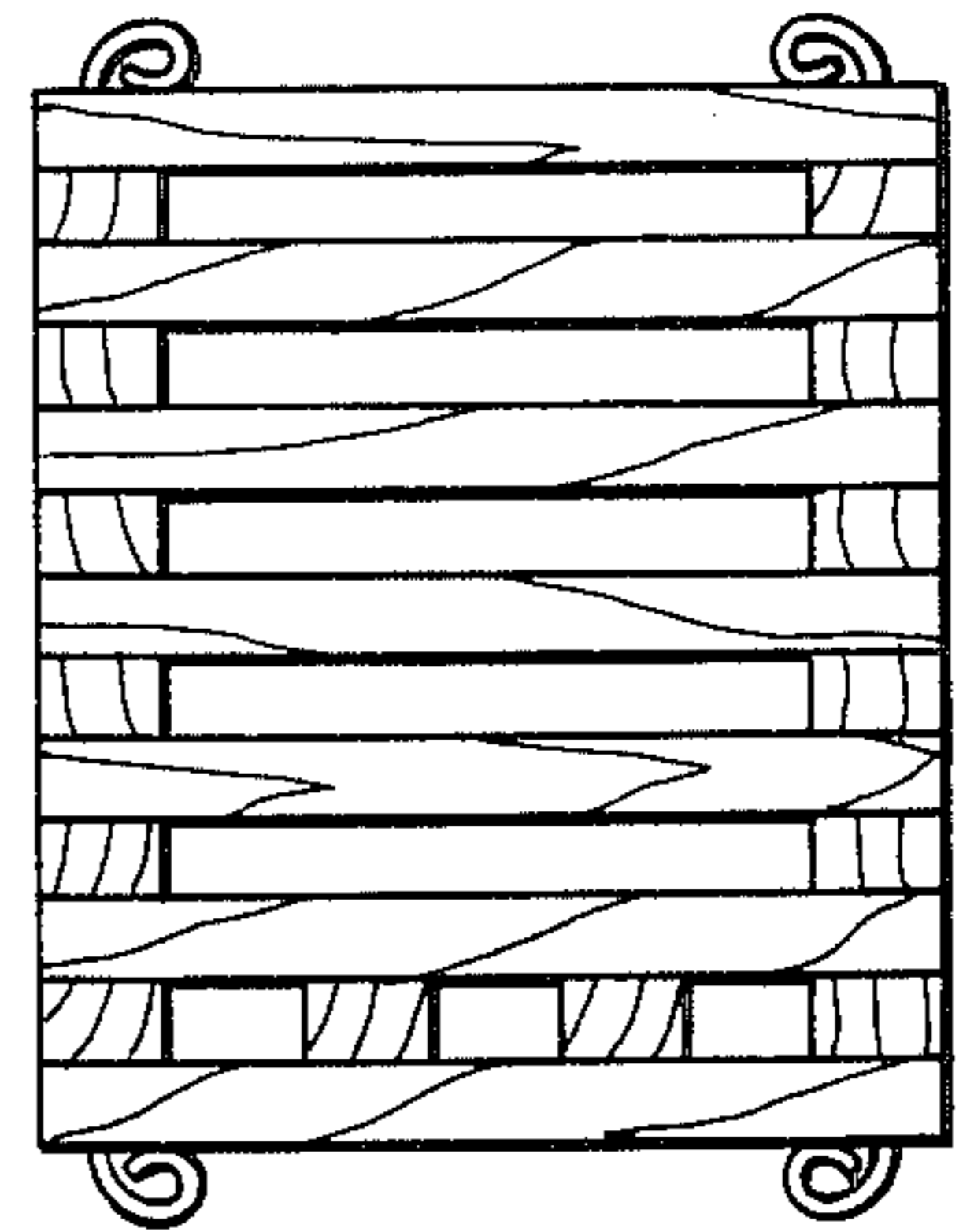

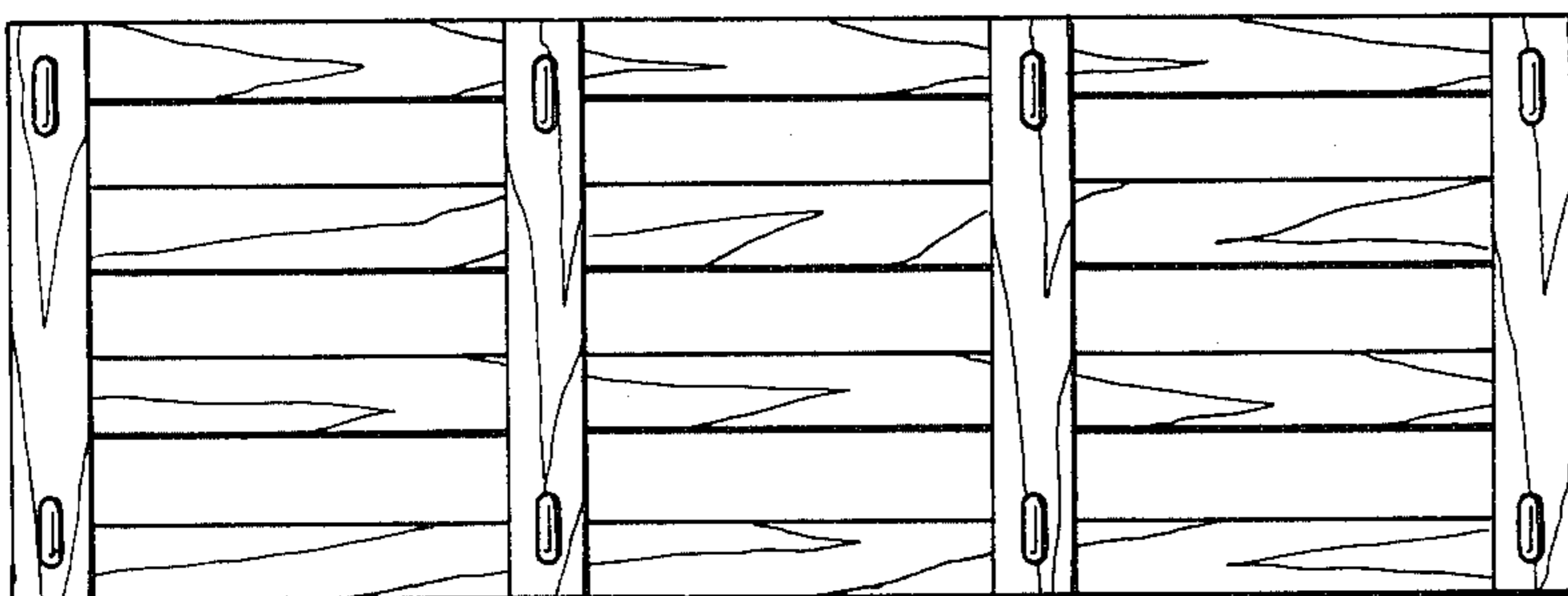

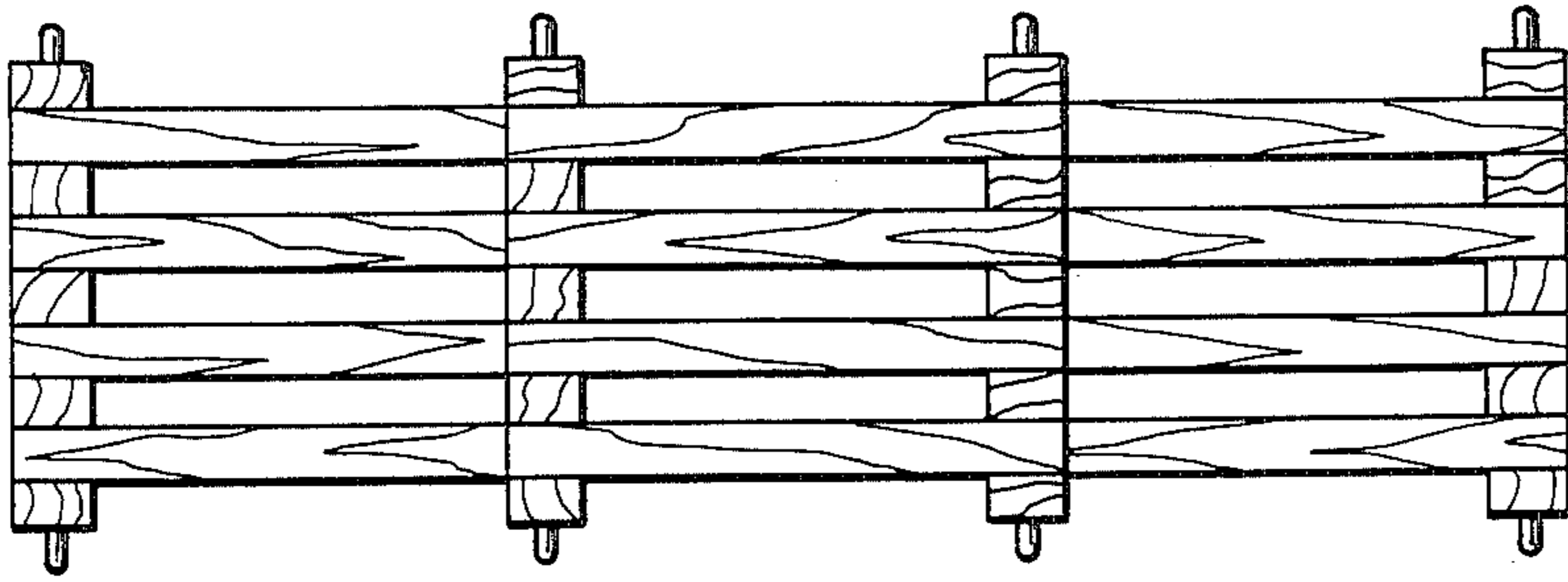

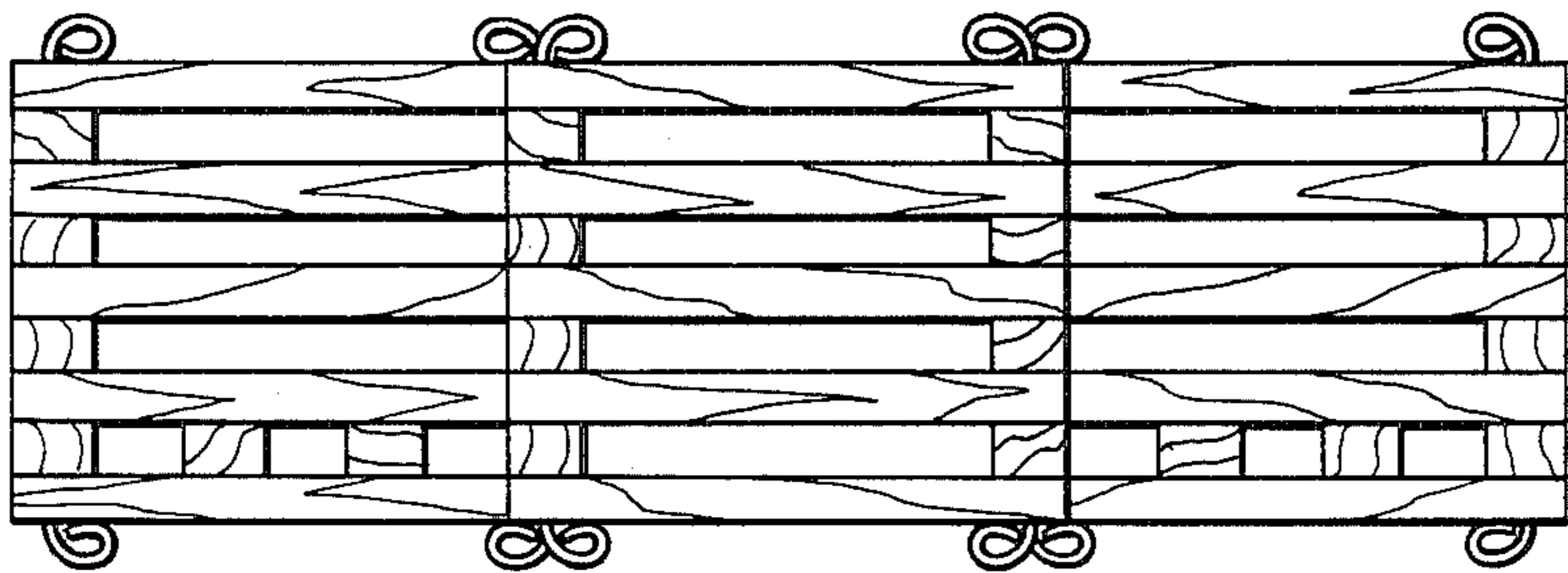

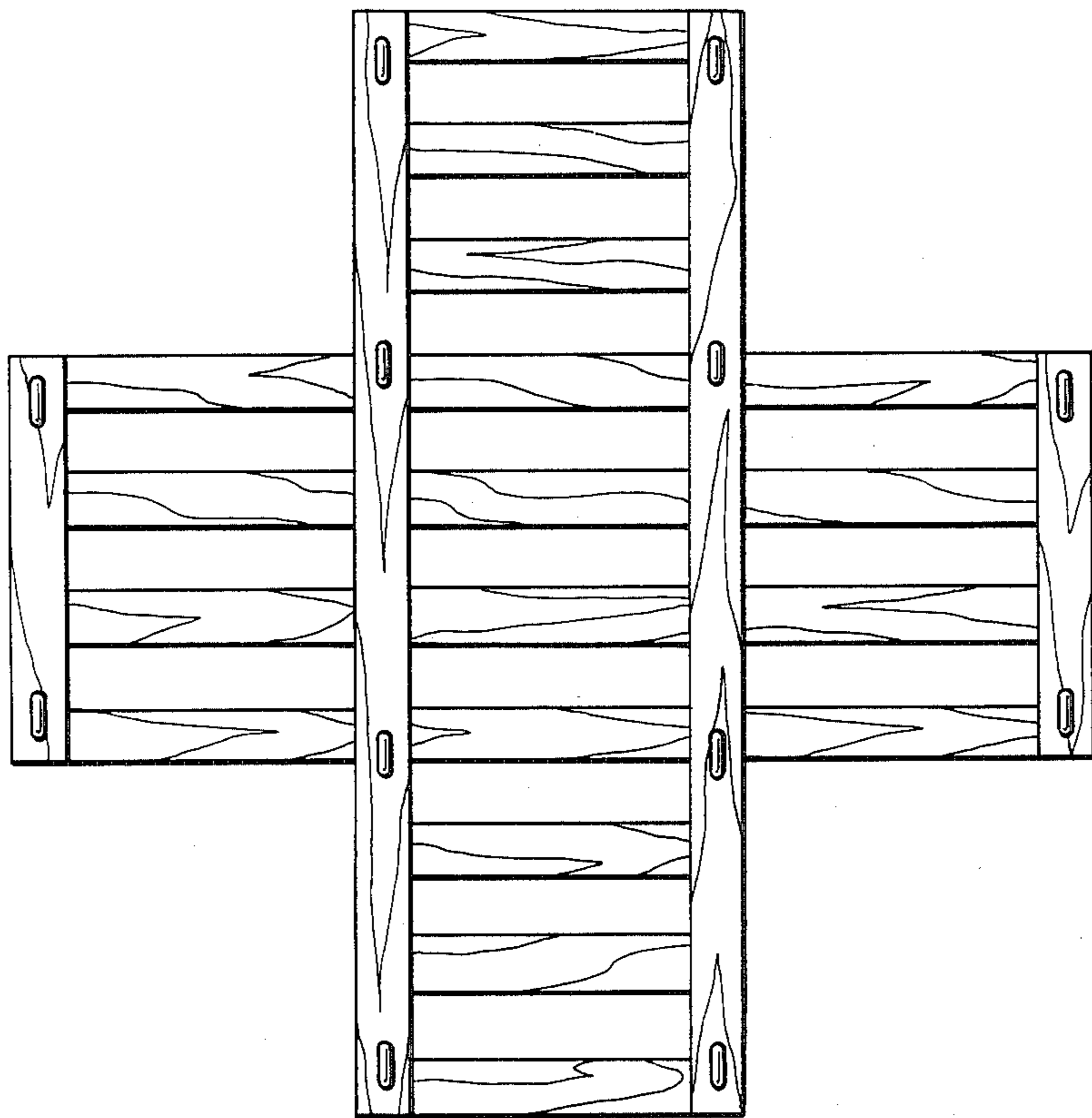

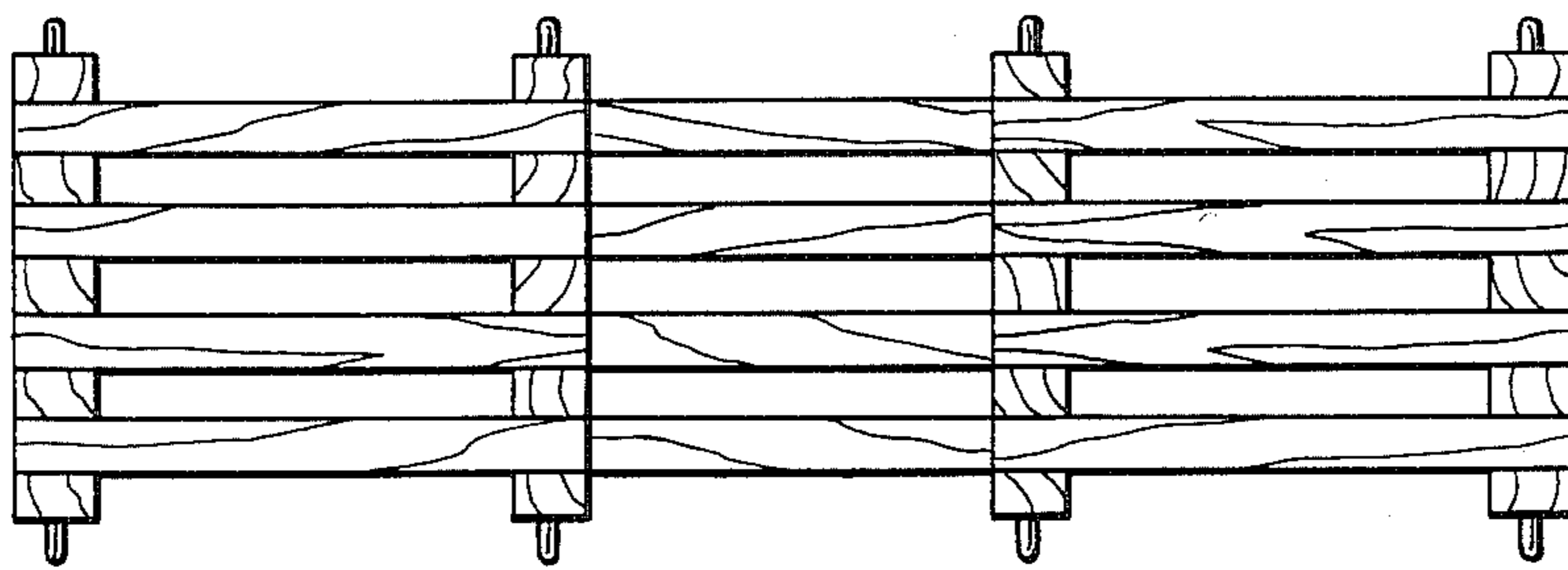

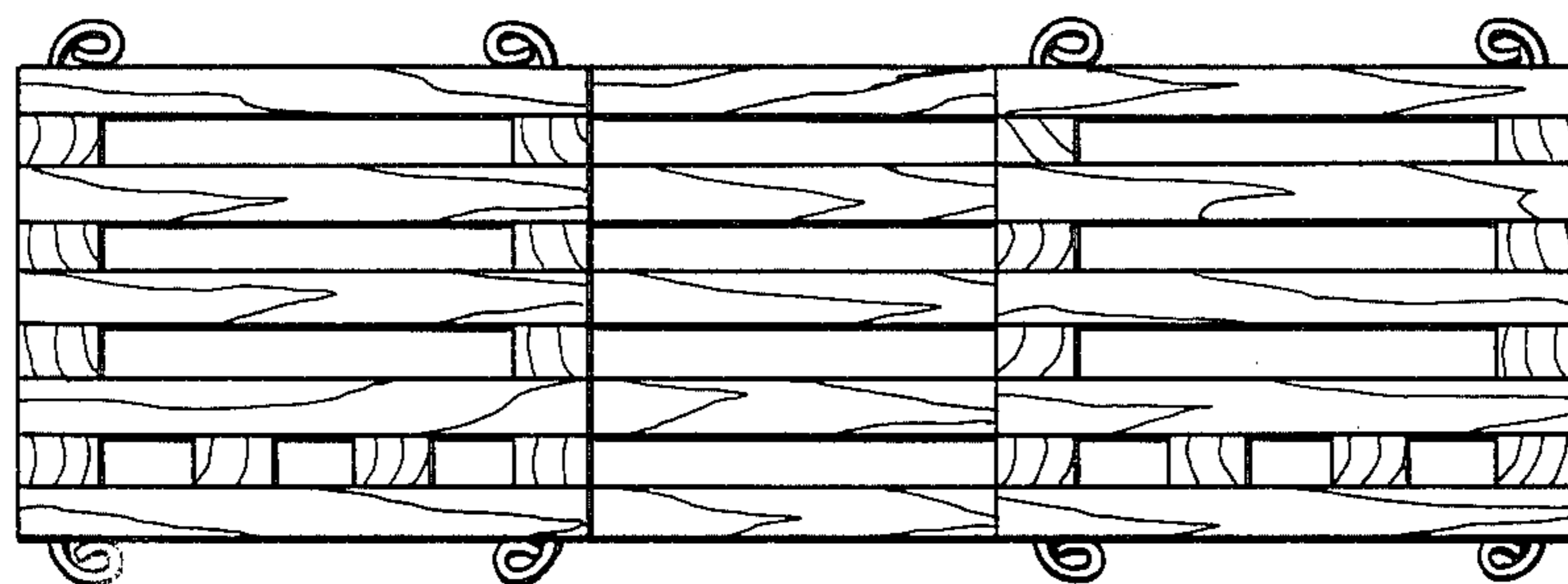

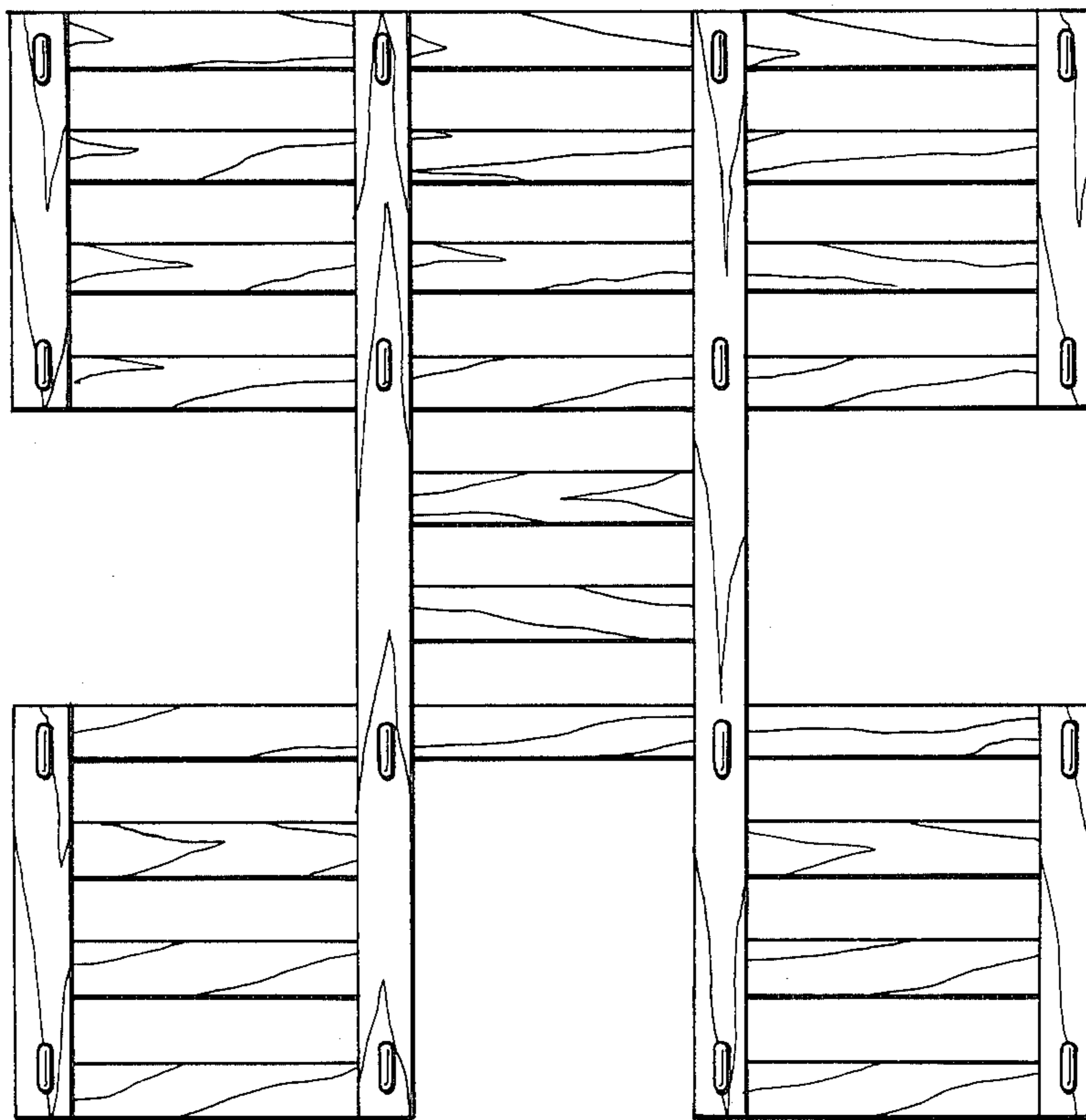
