[57] CLAIM

The ornamental design for a telephone attendant console, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a telephone attendant console showing our new design; FIG. 2 is a top plan view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a left side elevational view thereof; FIG. 7 is a perspective view thereof; FIG. 8 is a front elevational view with the display panel thereof in oblique raised position; FIG. 9 is a top plan view thereof with the display panel in raised position; and FIG. 10 is a right side elevational view with the display panel in raised position.

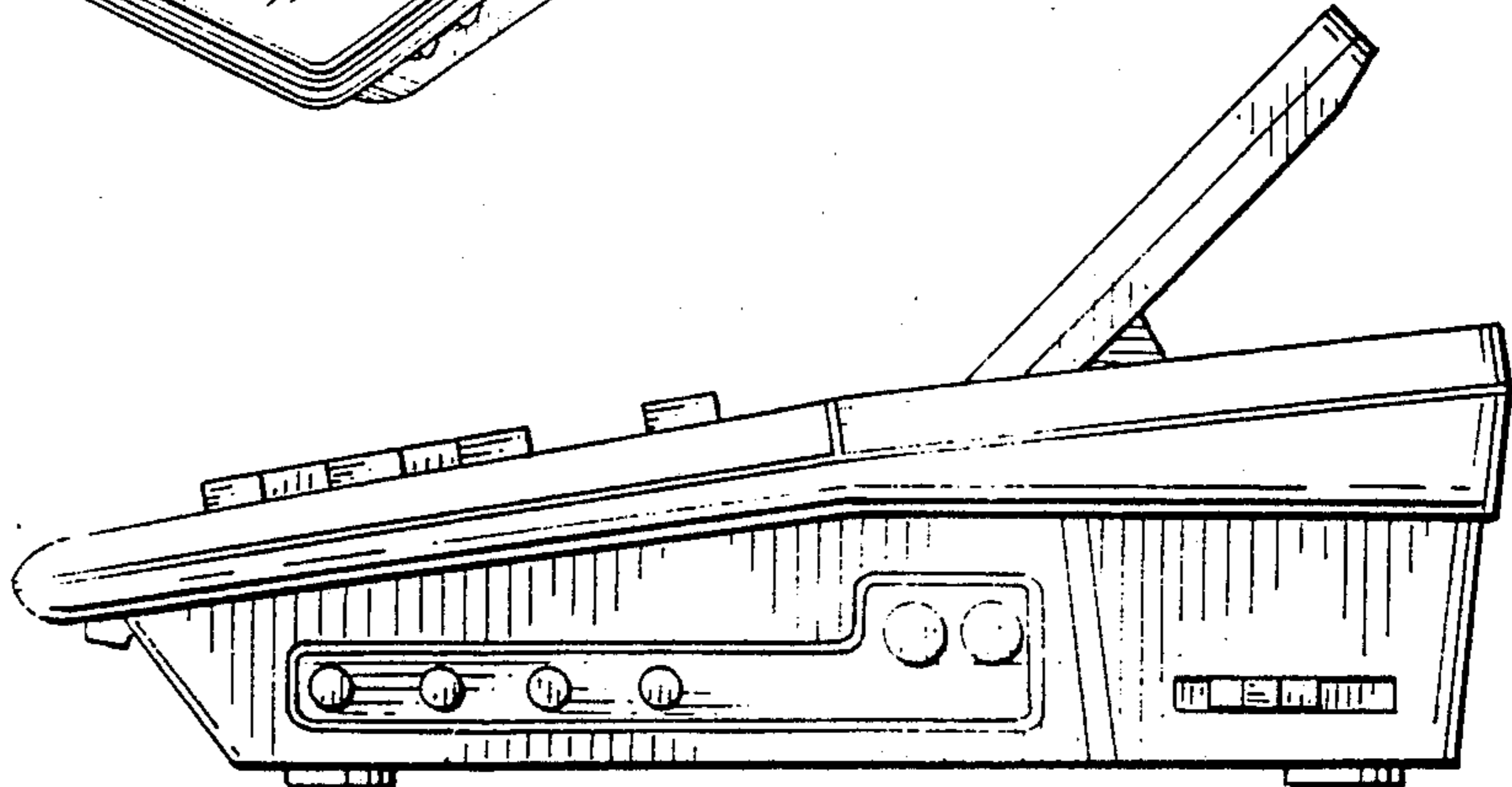
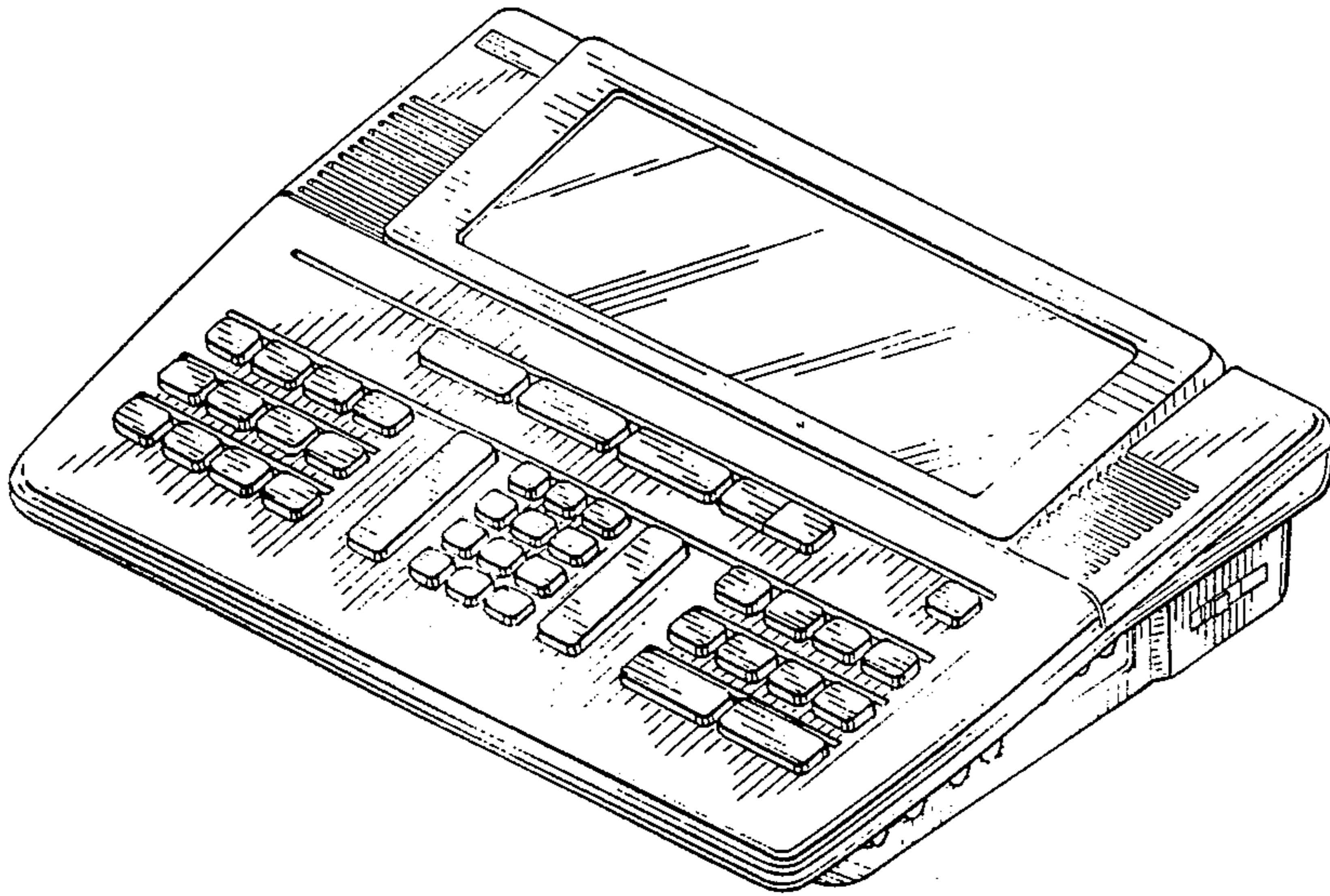

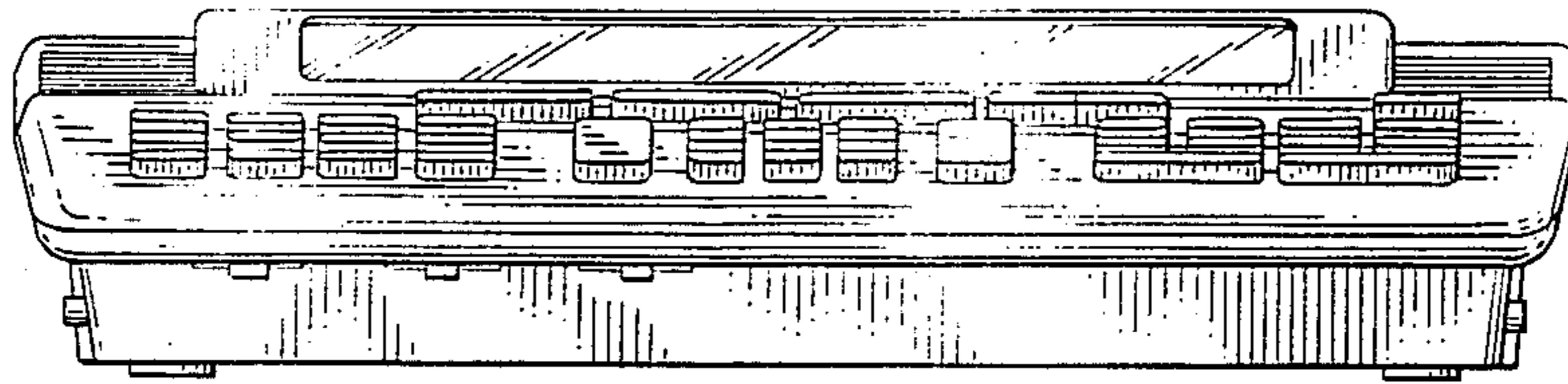

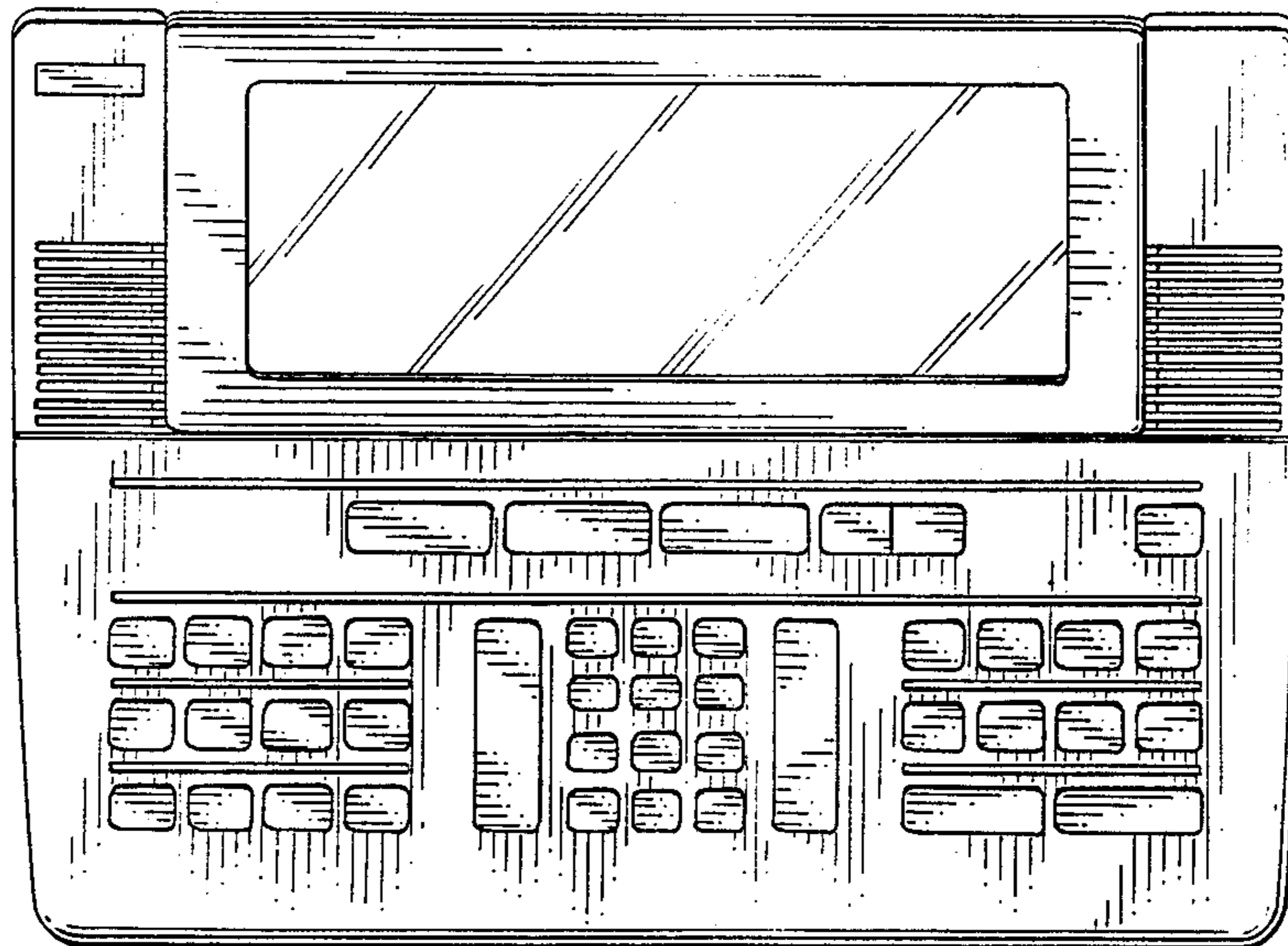

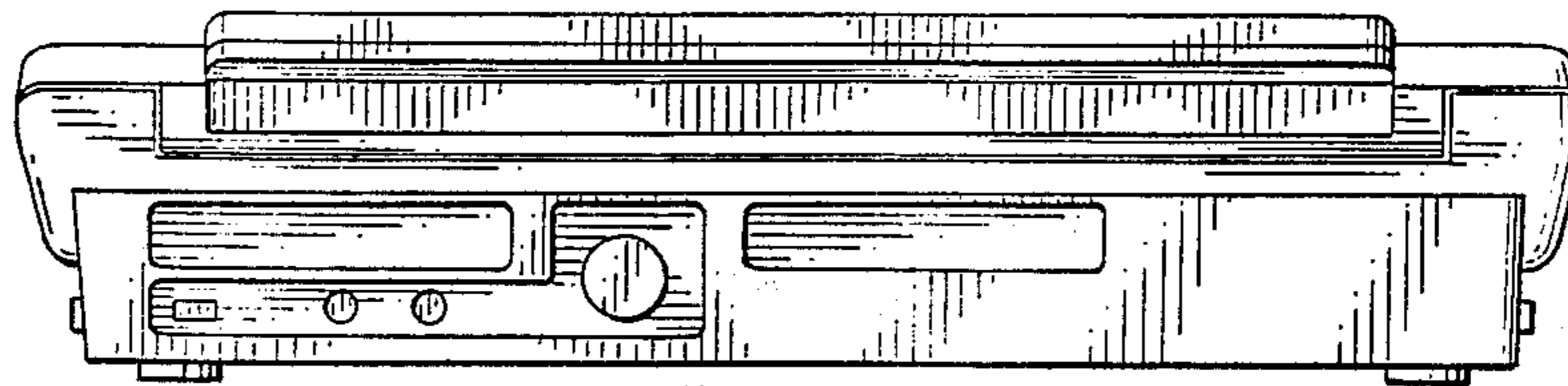

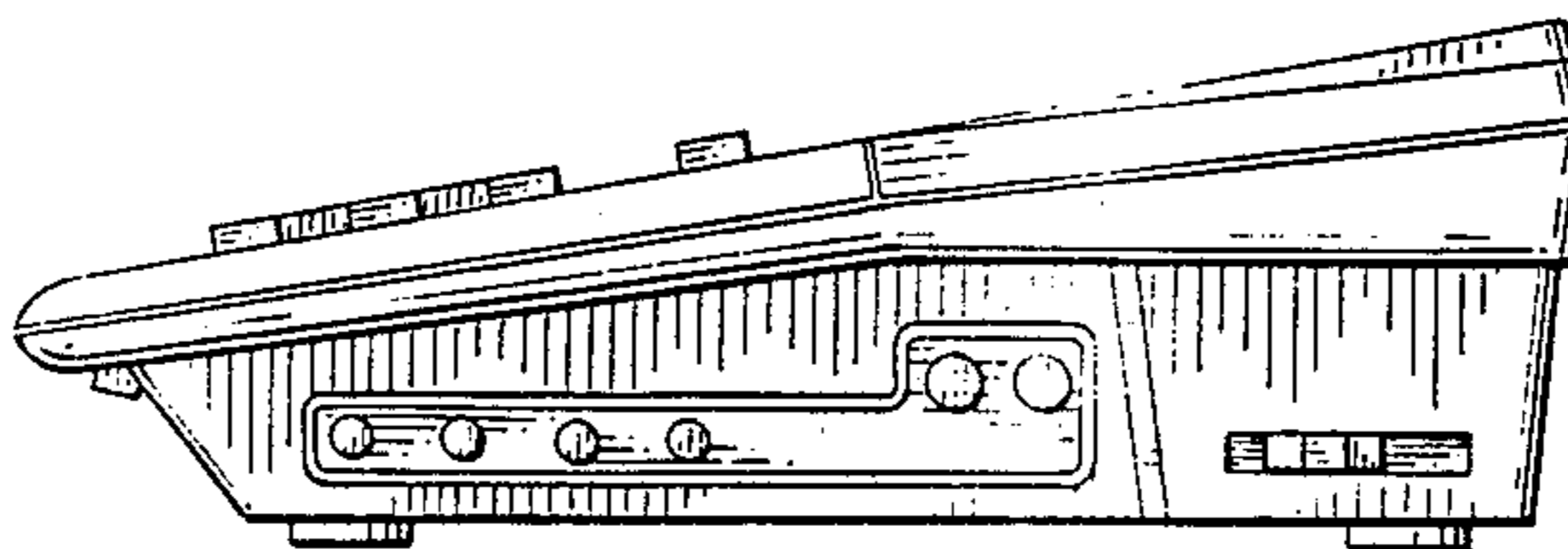

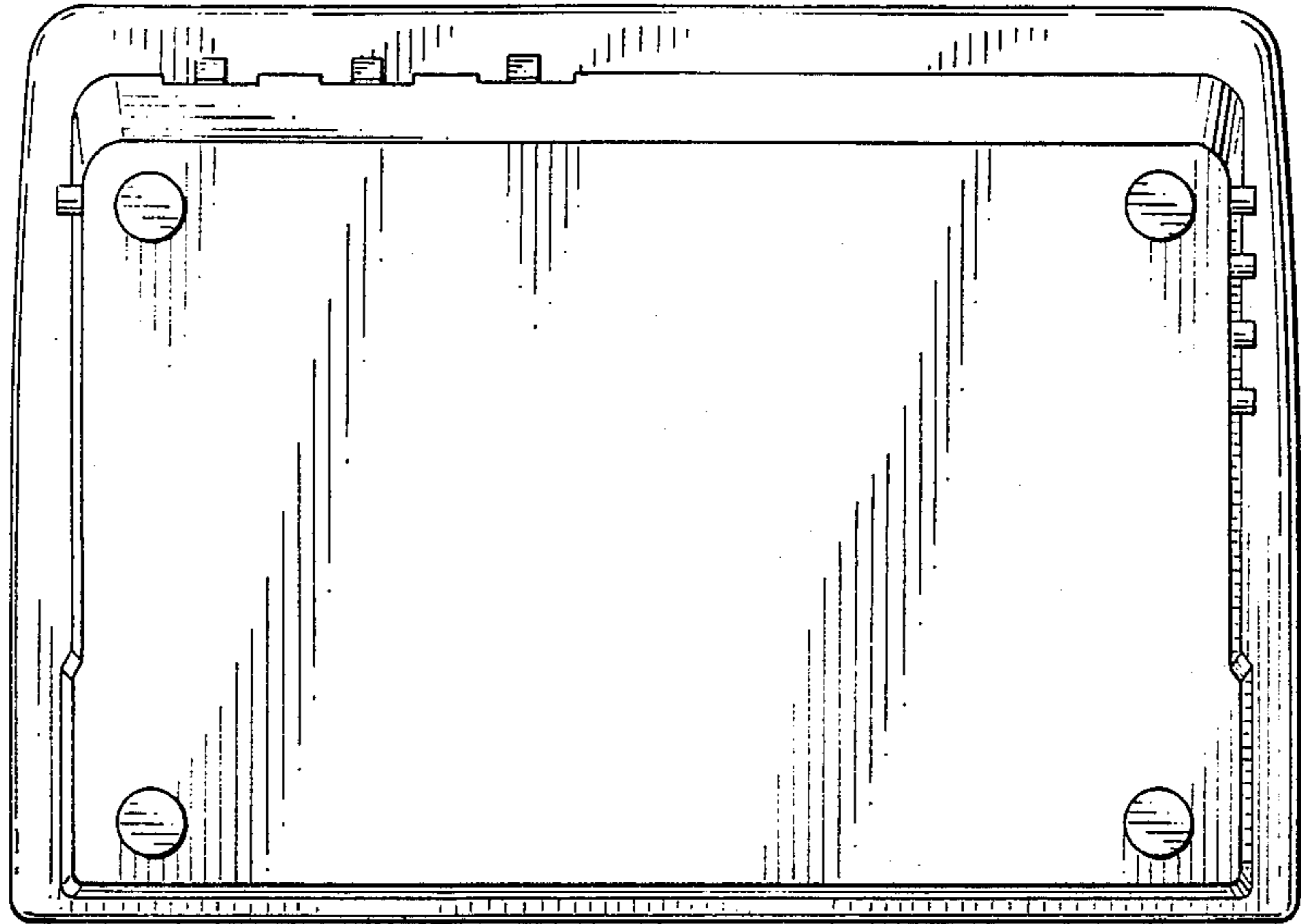

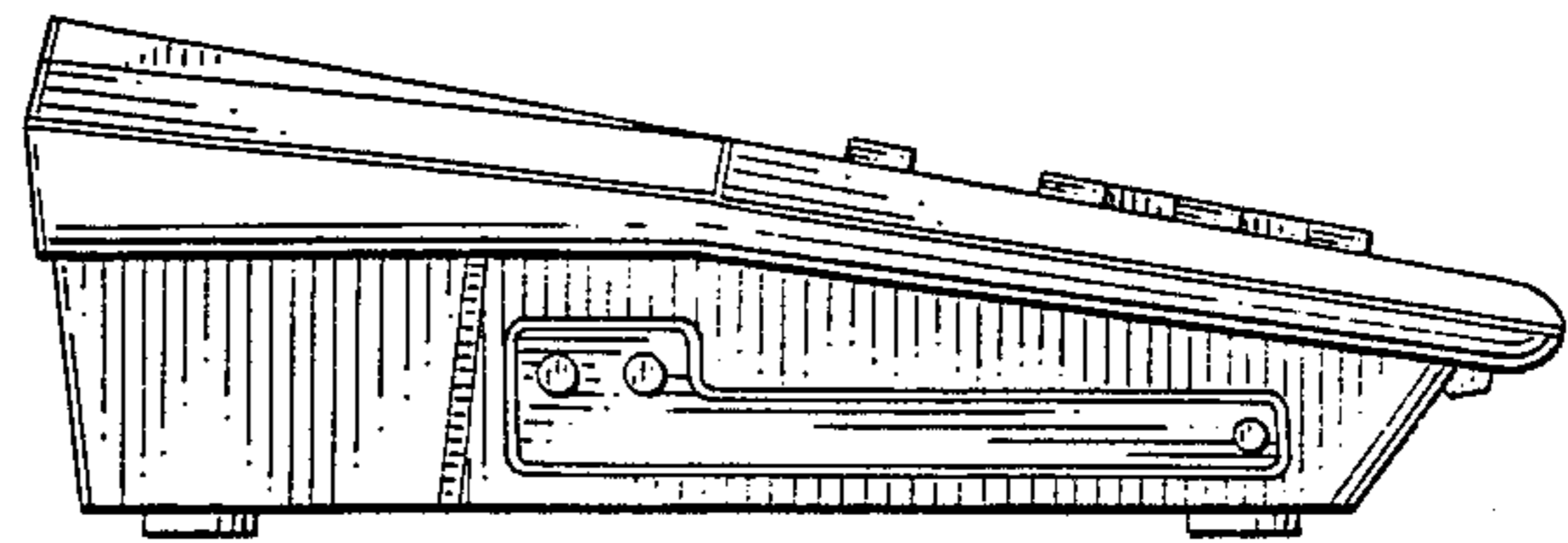

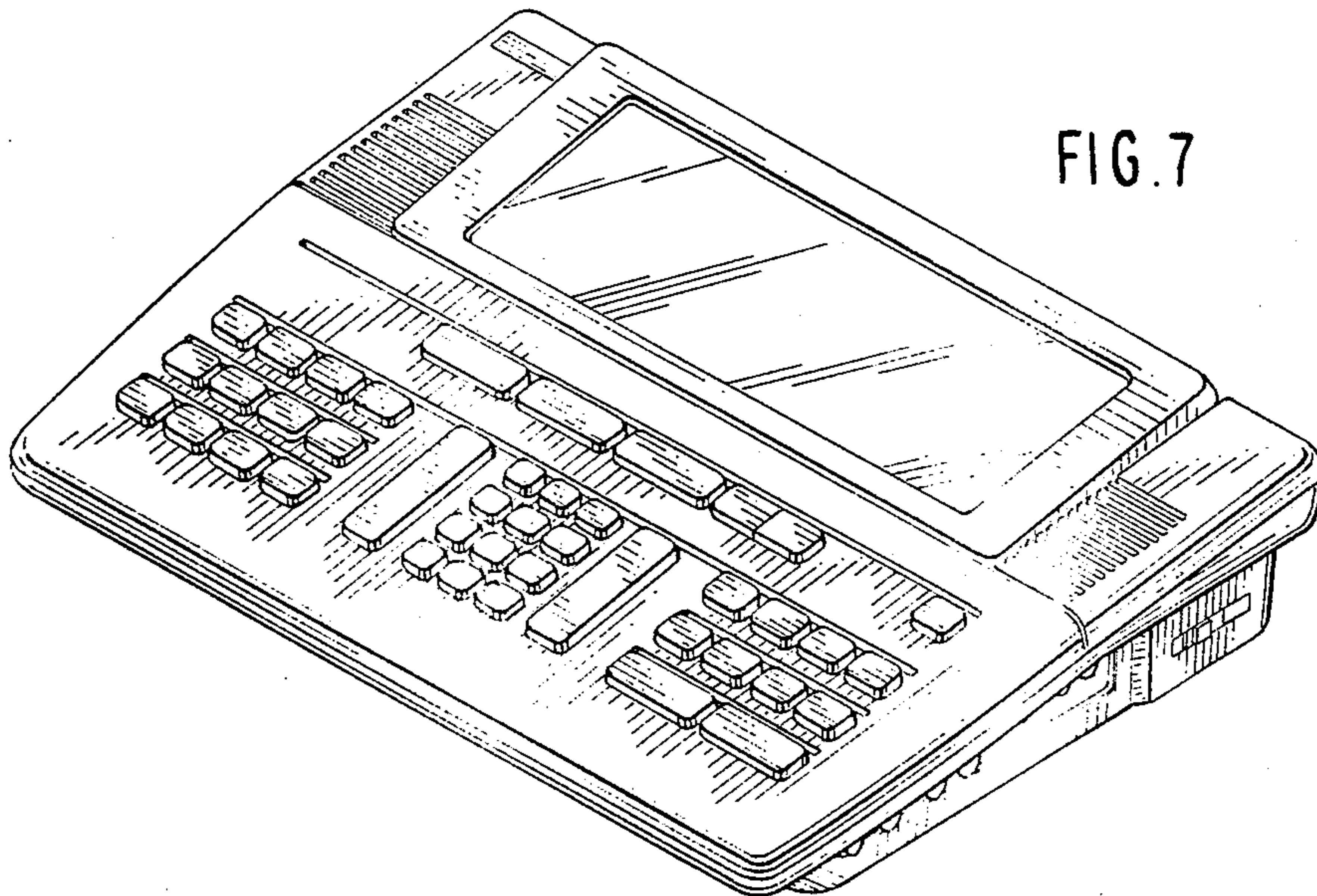

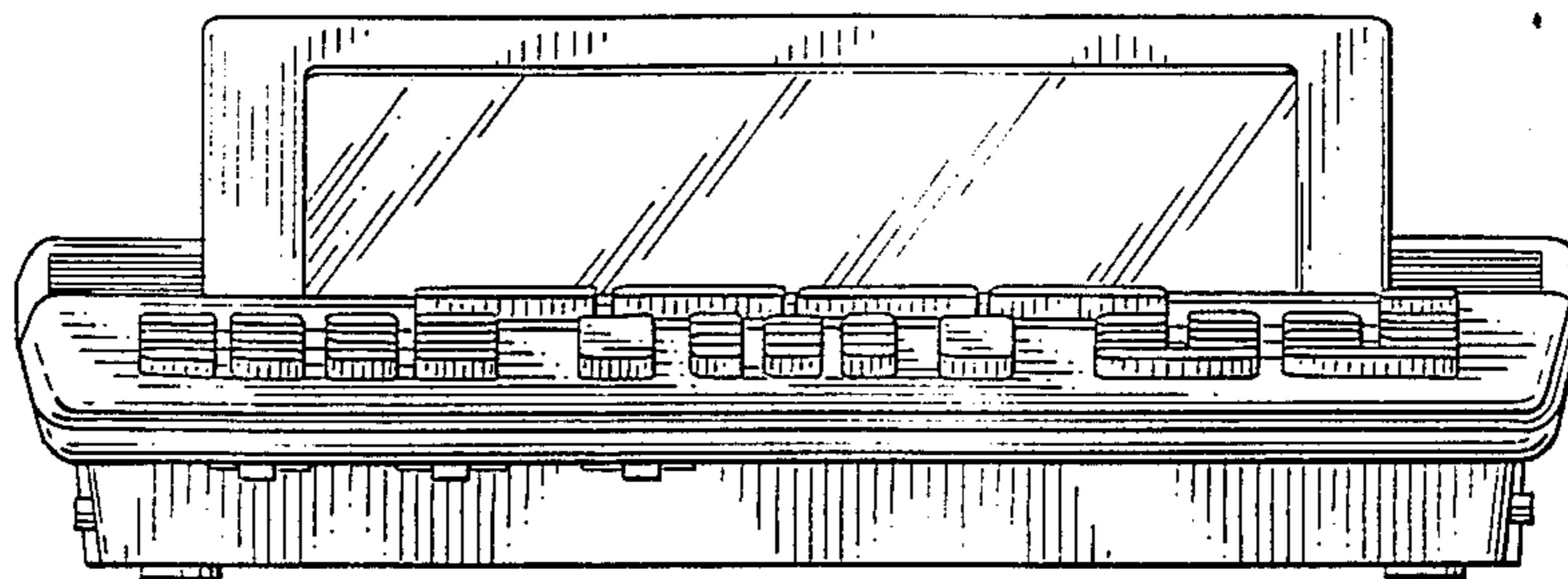

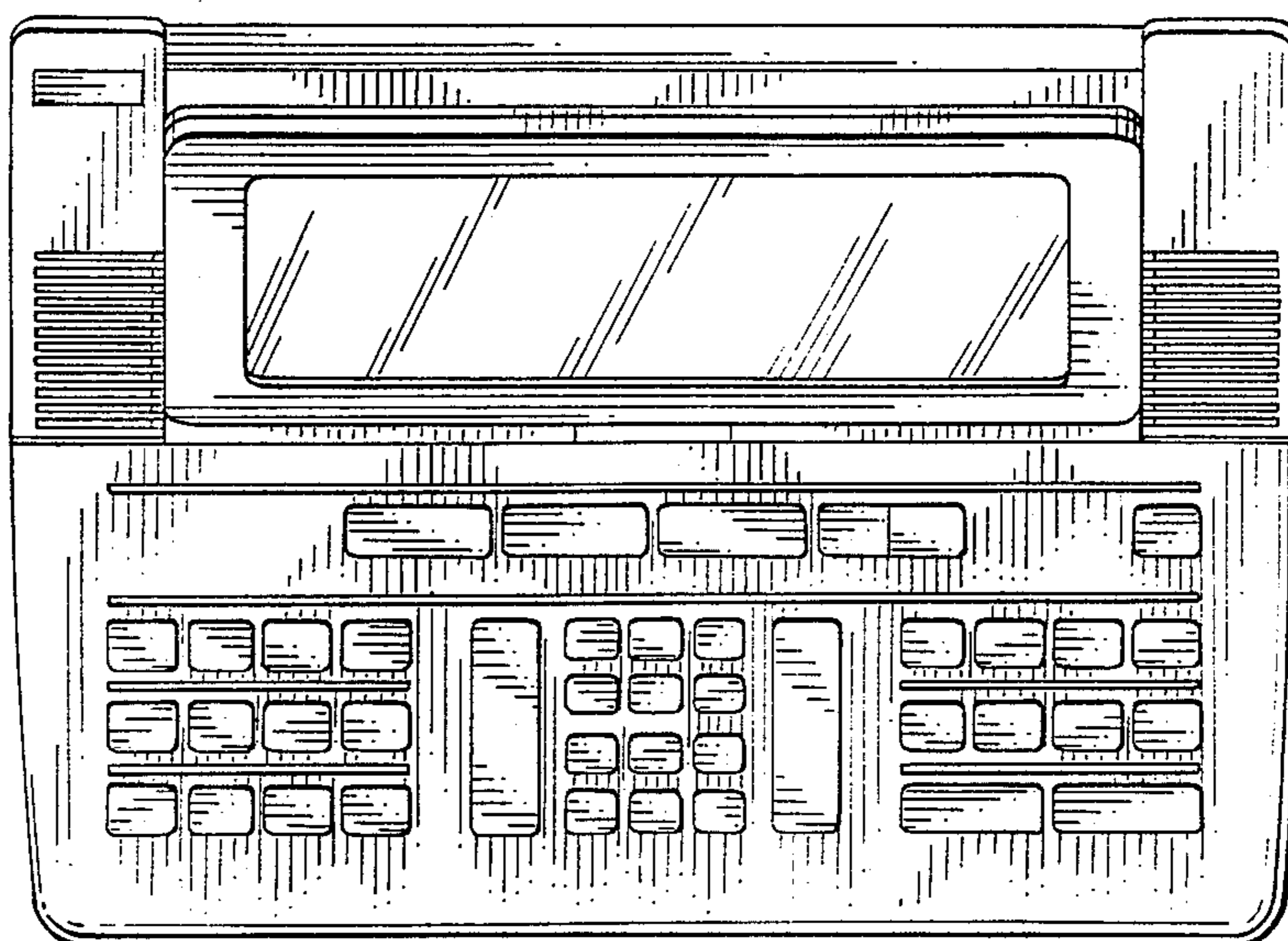
