[57] CLAIM

The ornamental design for a cage, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view taken from the top, front and left side of a cage showing my new design with the cage door shown in an open position;

FIG. 2 is a top plan view thereof showing the cage door in its closed position;

FIG. 3 is a bottom plan view of FIG. 2;

FIG. 4 is a right side elevational view of FIG. 2, the left side being a mirror image of the right side shown;

FIG. 5 is a front elevational view of FIG. 2;

FIG. 6 is a rear elevational view of FIG. 2;

FIG. 7 is a perspective view taken from the top, front and left side of a modified form of the cage shown in

FIG. 1 with the cage door shown in an open position;


FIG. 8 is a top plan view of FIG. 7 showing the cage door in its closed position;

FIG. 9 is a bottom plan view of FIG. 8;

FIG. 10 is a right side elevational view of FIG. 8, the left side being a mirror image of the right side shown;

FIG. 12 is a rear elevational view of FIG. 8.

























