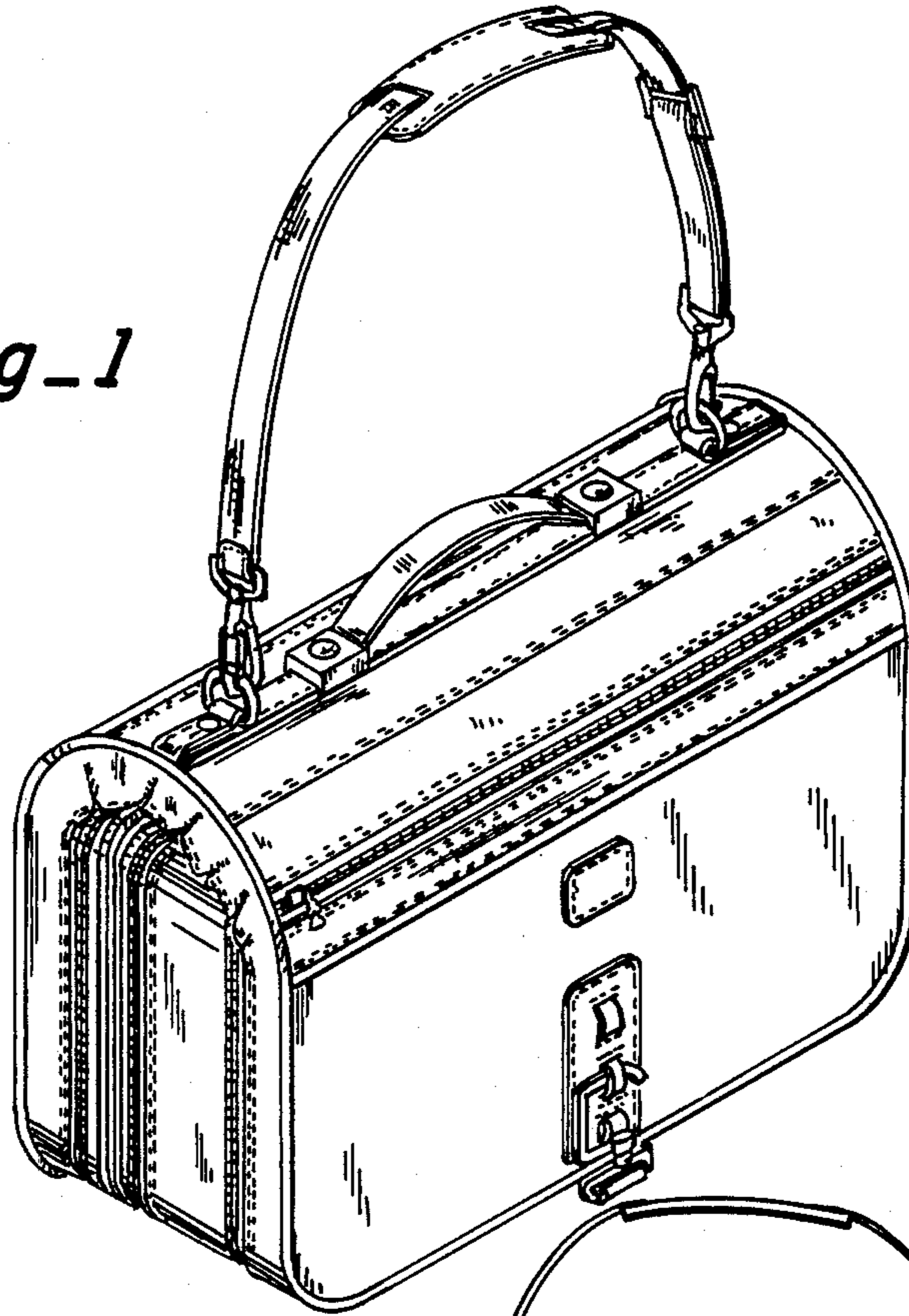
The ornamental design for a combined garment bag and luggage piece, as shown and described.

DESCRIPTION

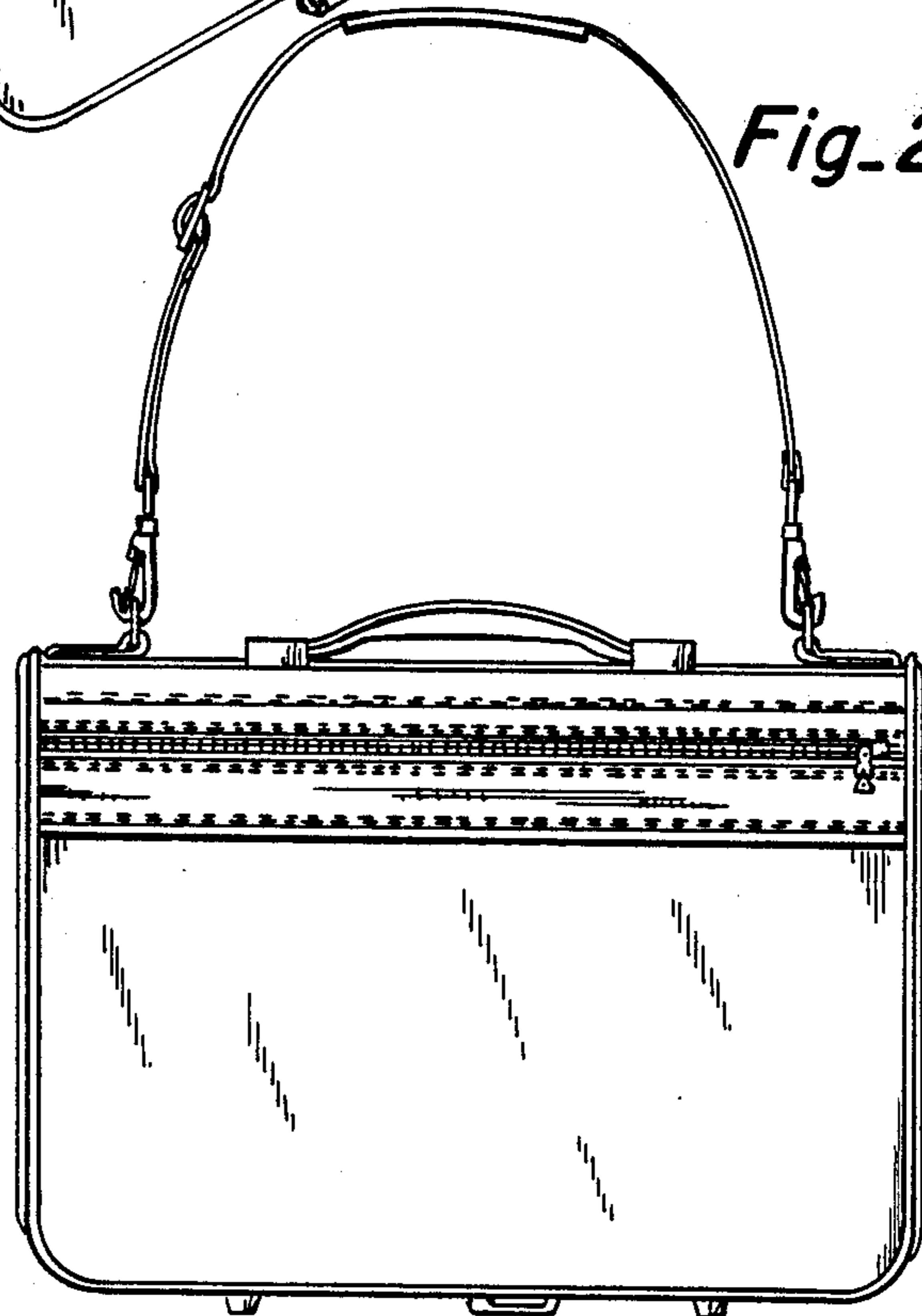
FIG. 1 is a perspective view of a combined garment bag and luggage piece embodying our new design. FIG. 2 is a rear side elevational view thereof. FIG. 3 is a left-end elevational view thereof. FIG. 4 is a front side elevational view thereof. FIG. 5 is a right-hand end elevational view thereof. FIG. 6 is a top plan view thereof. FIG. 7 is a bottom plan view thereof. FIG. 8 is a top front perspective view thereof illustrating the combined garment bag and luggage piece in an open configuration. FIG. 9 is a bottom rear perspective view thereof illustrating the combined garment bag and luggage piece in the open configuration. FIG. 10 is a perspective view of a combined garment bag and luggage piece showing a second embodiment of our design. FIG. 11 is a rear side elevational view thereof. FIG. 12 is a left-end elevational view thereof. FIG. 13 is a front side elevational view thereof. FIG. 14 is a right-hand end elevational view thereof. FIG. 15 is a top plan view thereof. FIG. 16 is a bottom plan view thereof. FIG. 17 is a top front perspective view illustrating the alternative design embodiment of the combined garment bag and luggage piece in an open configuration. FIG. 18 is a bottom rear perspective view illustrating the alternative design embodiment of the combined garment bag and luggage piece in the open configuration.



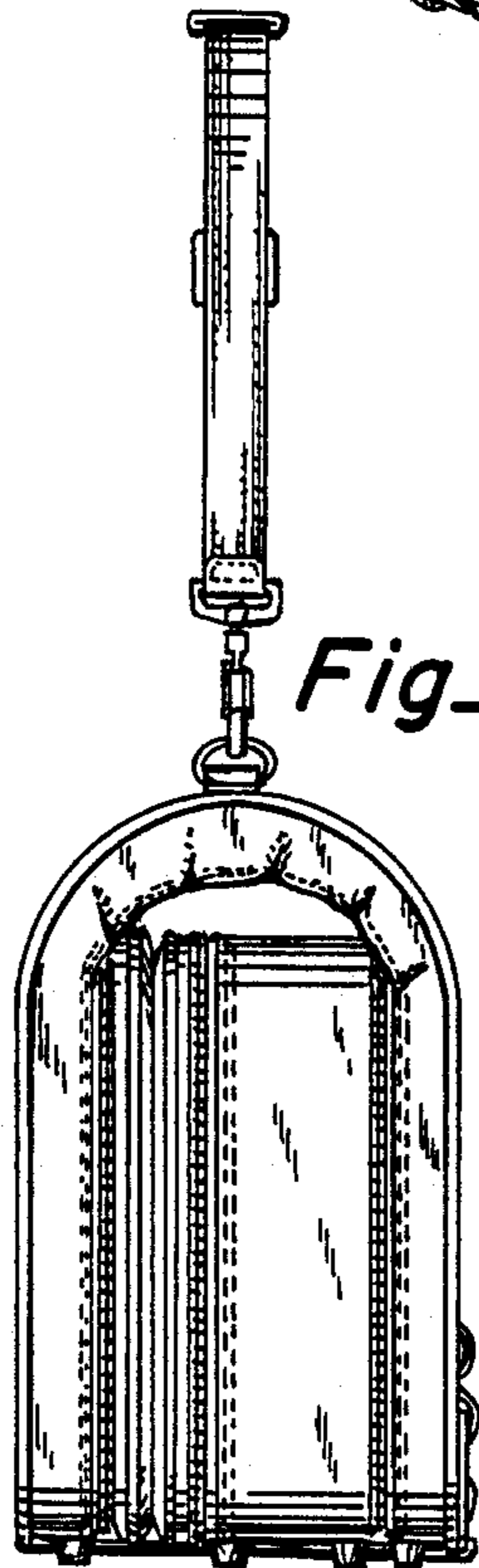

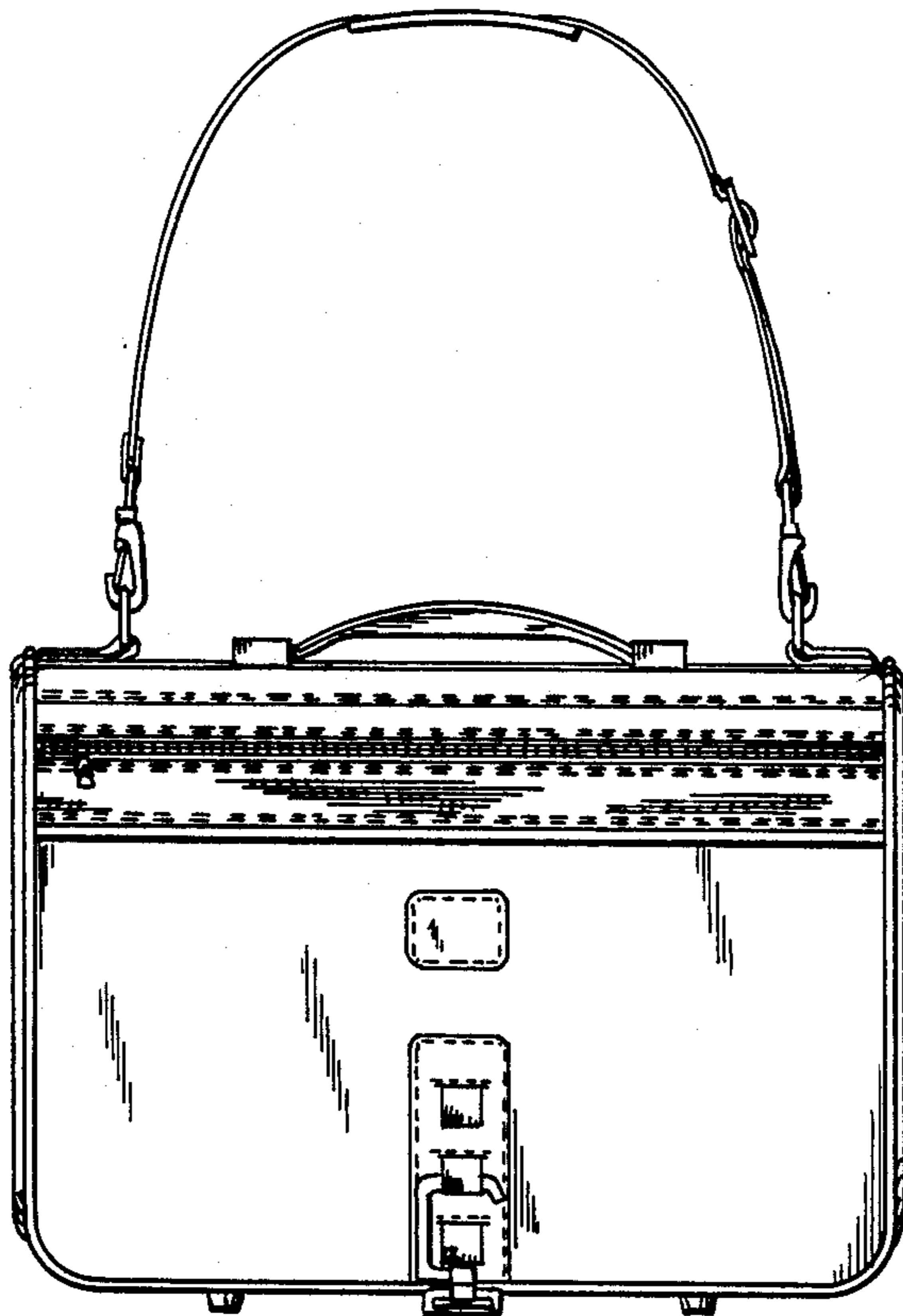

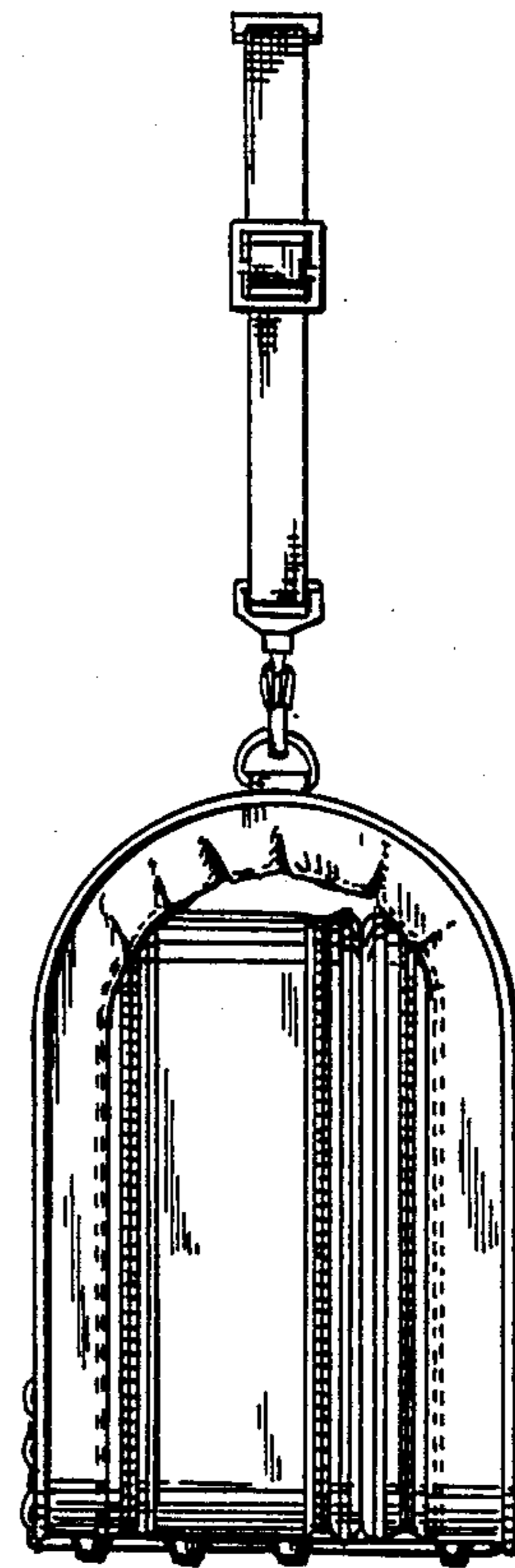

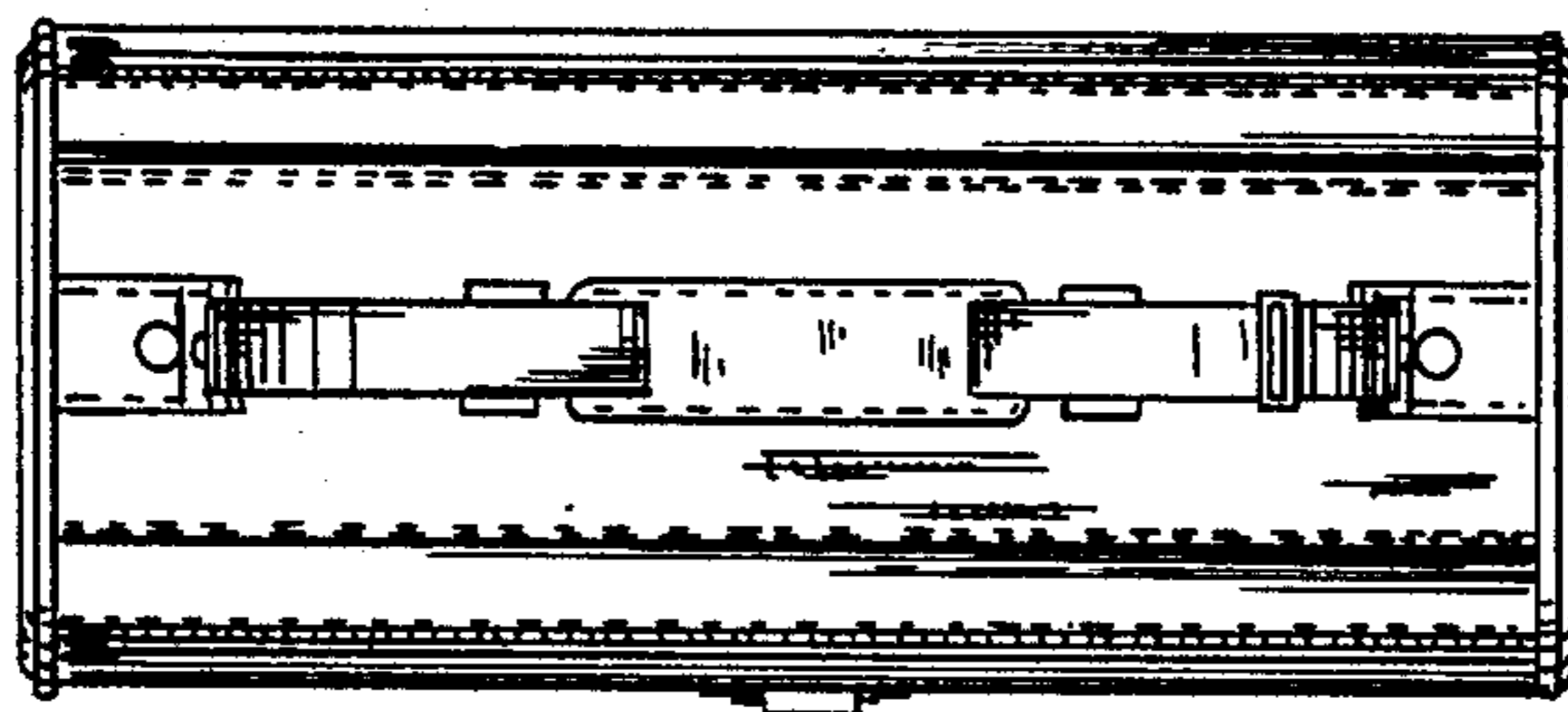




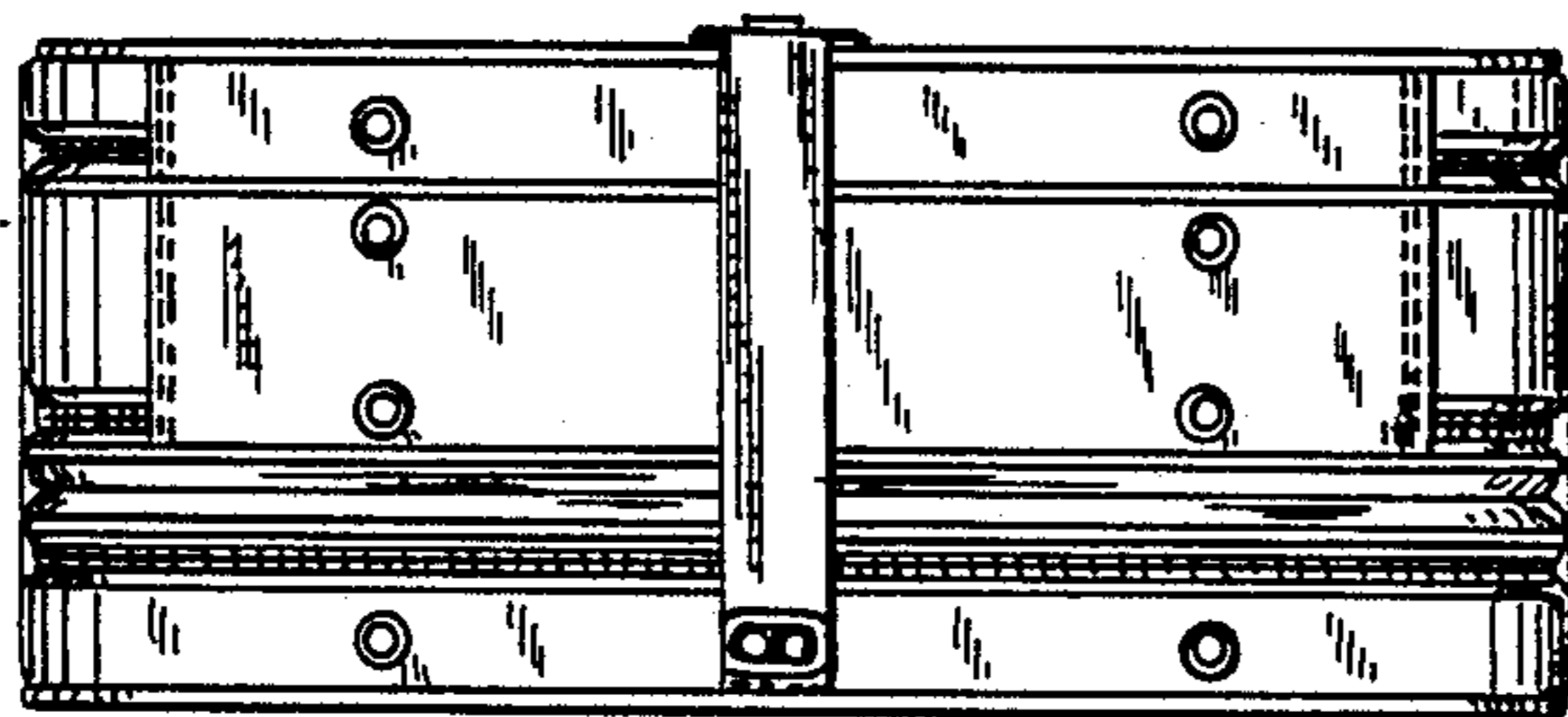

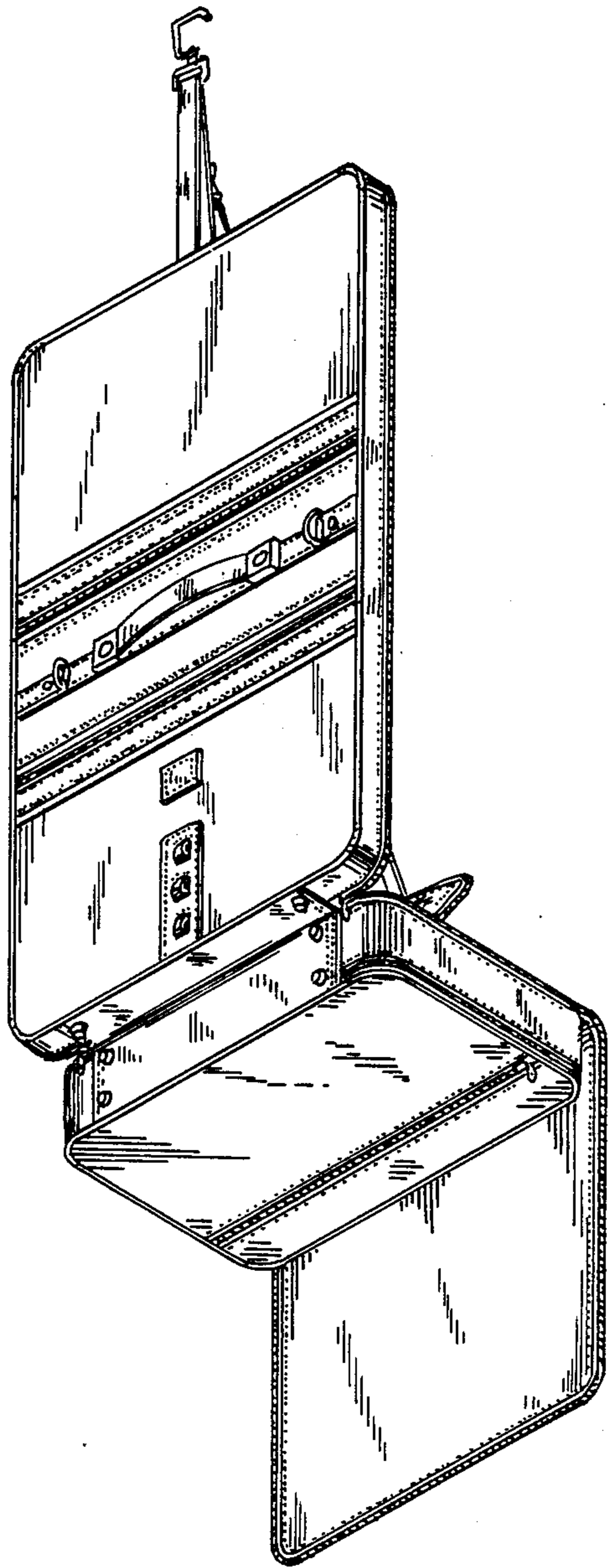
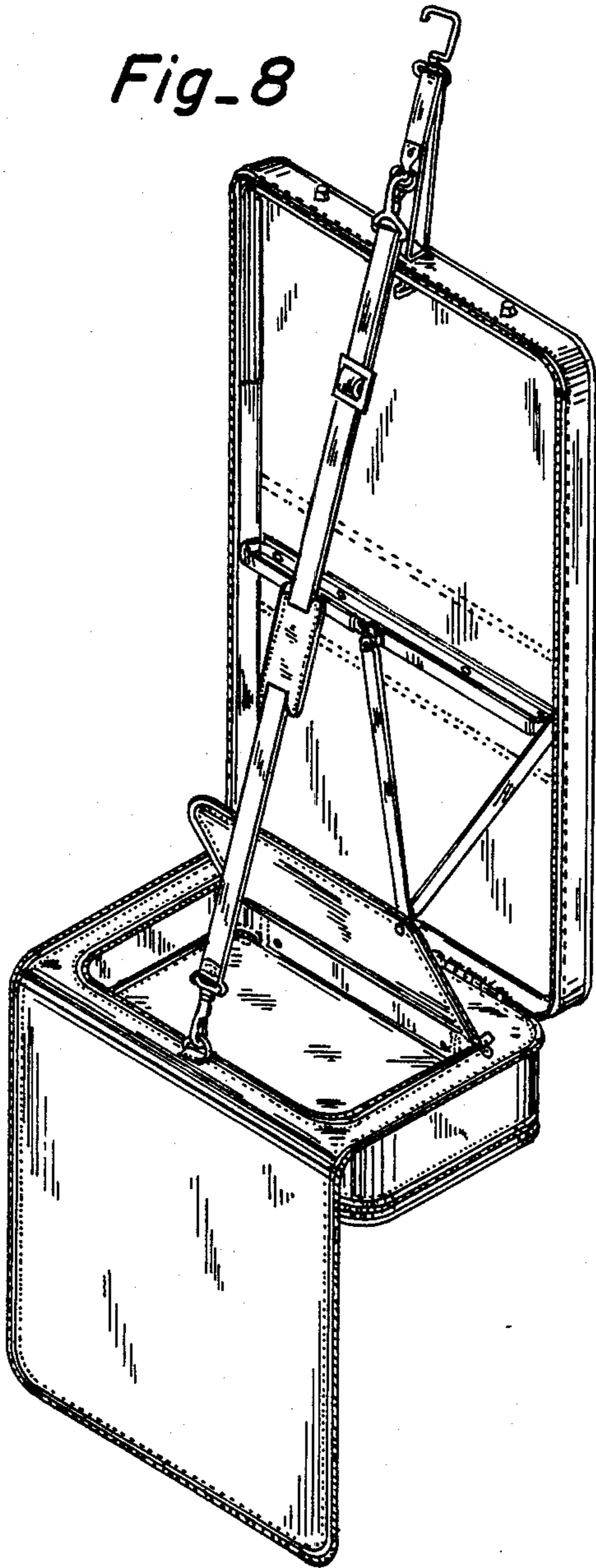
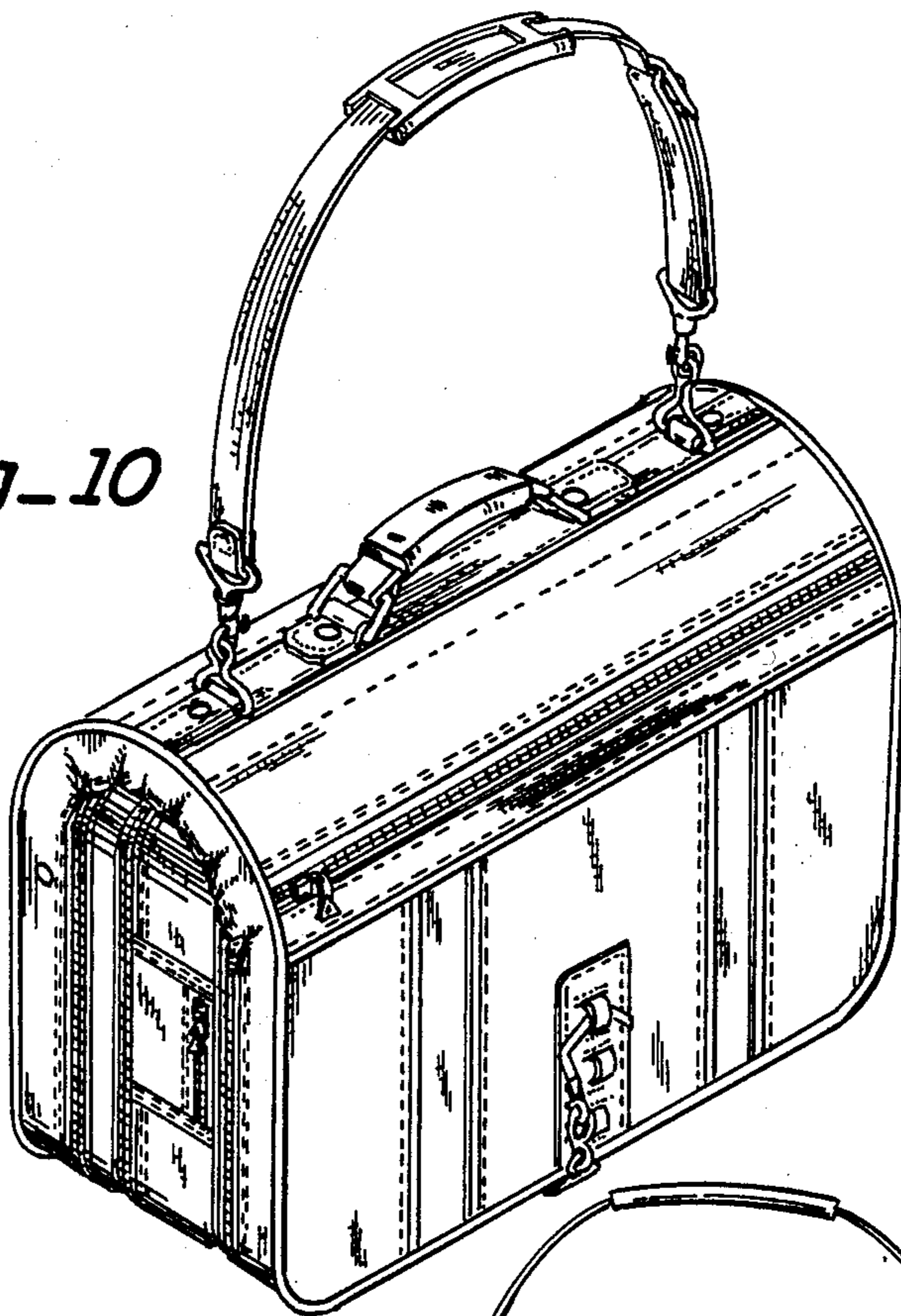
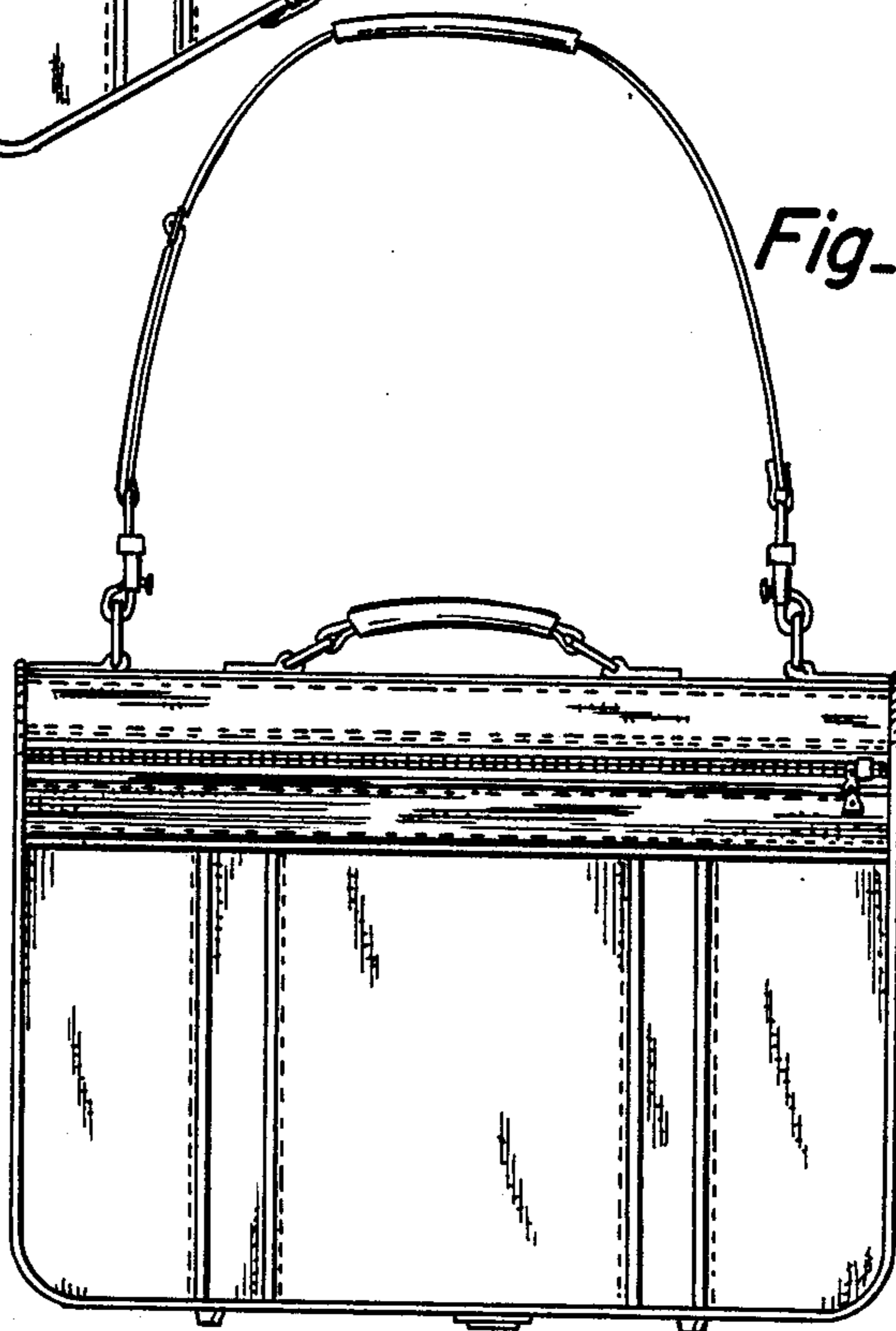

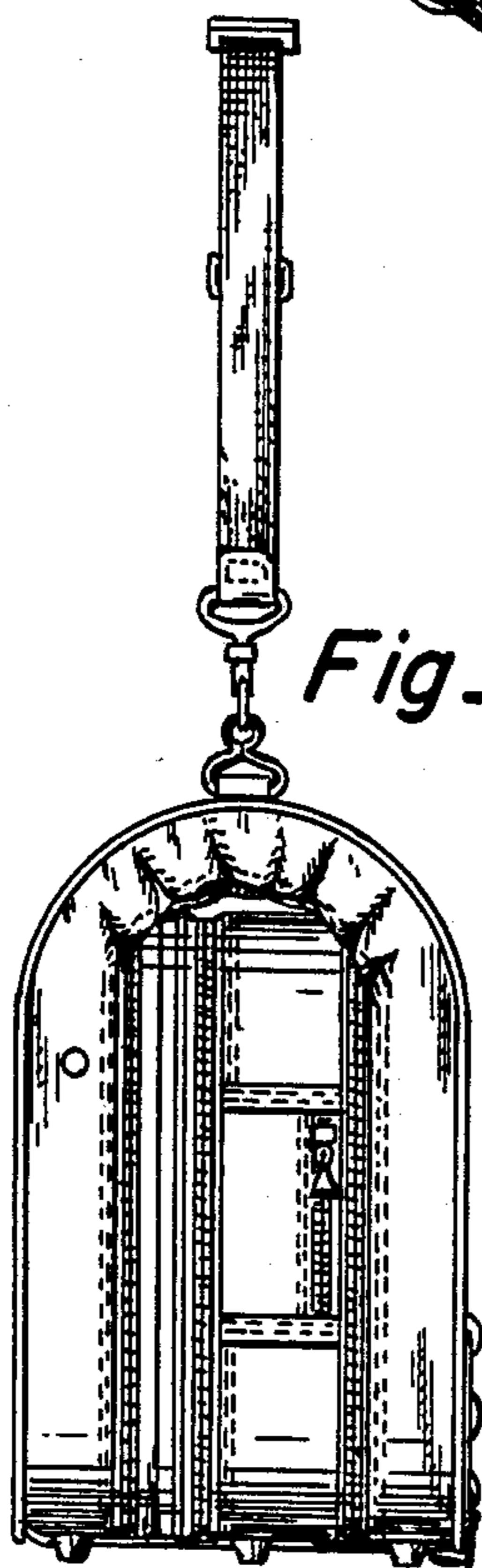

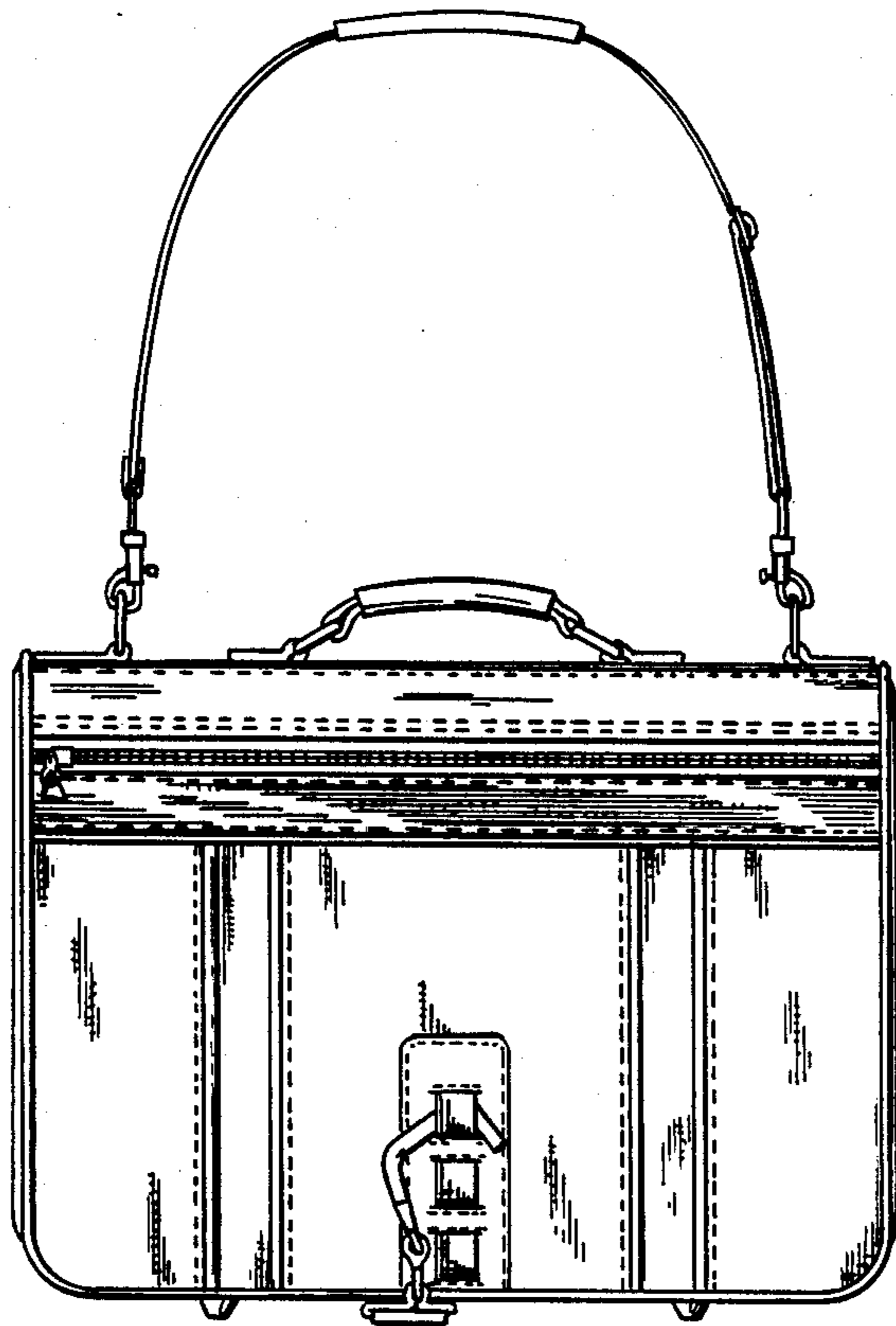

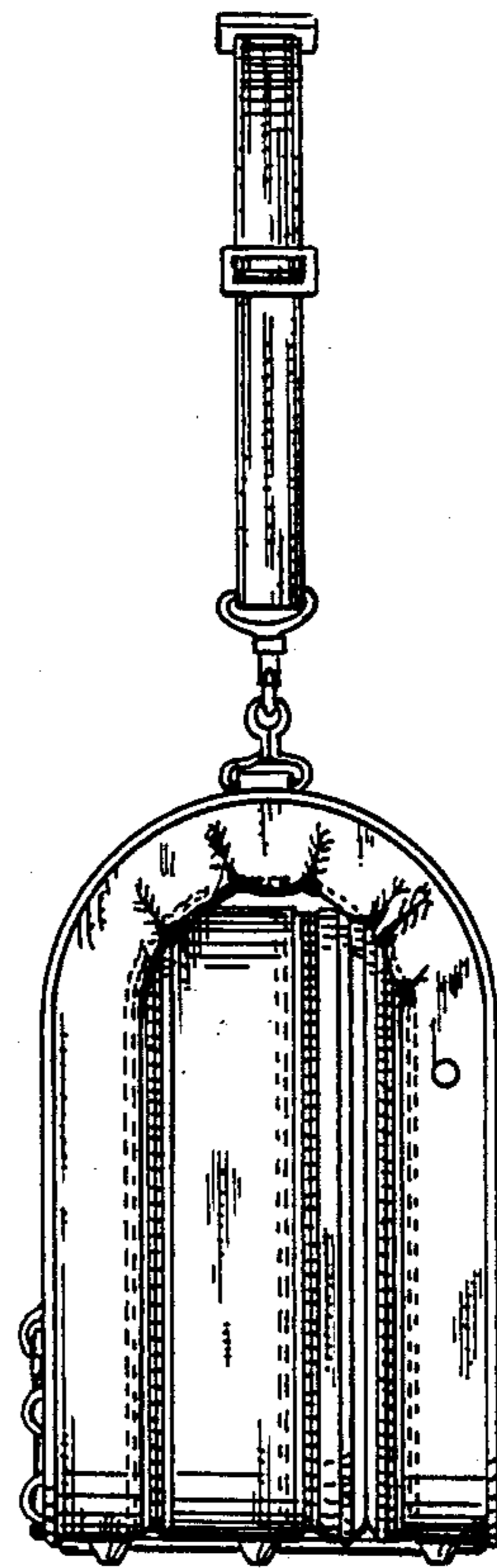

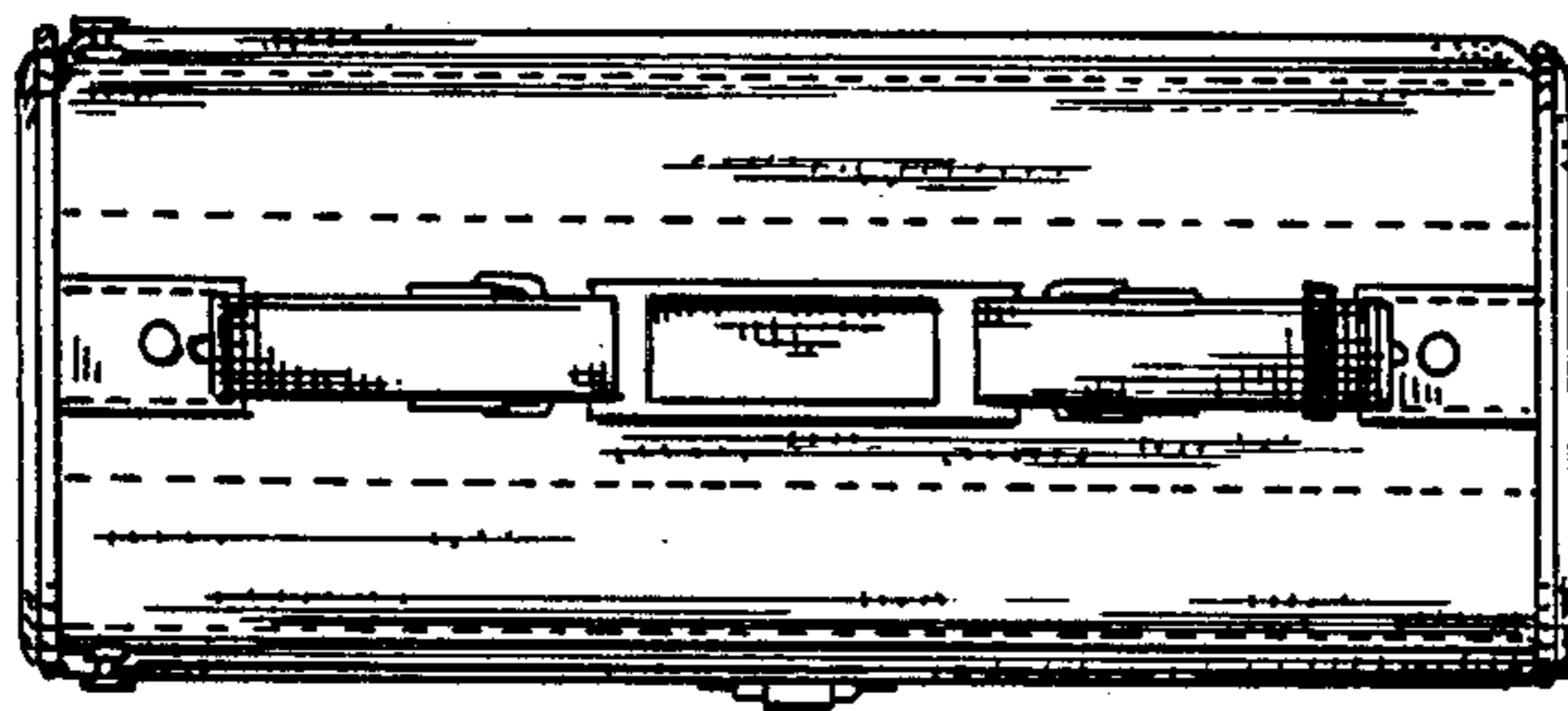




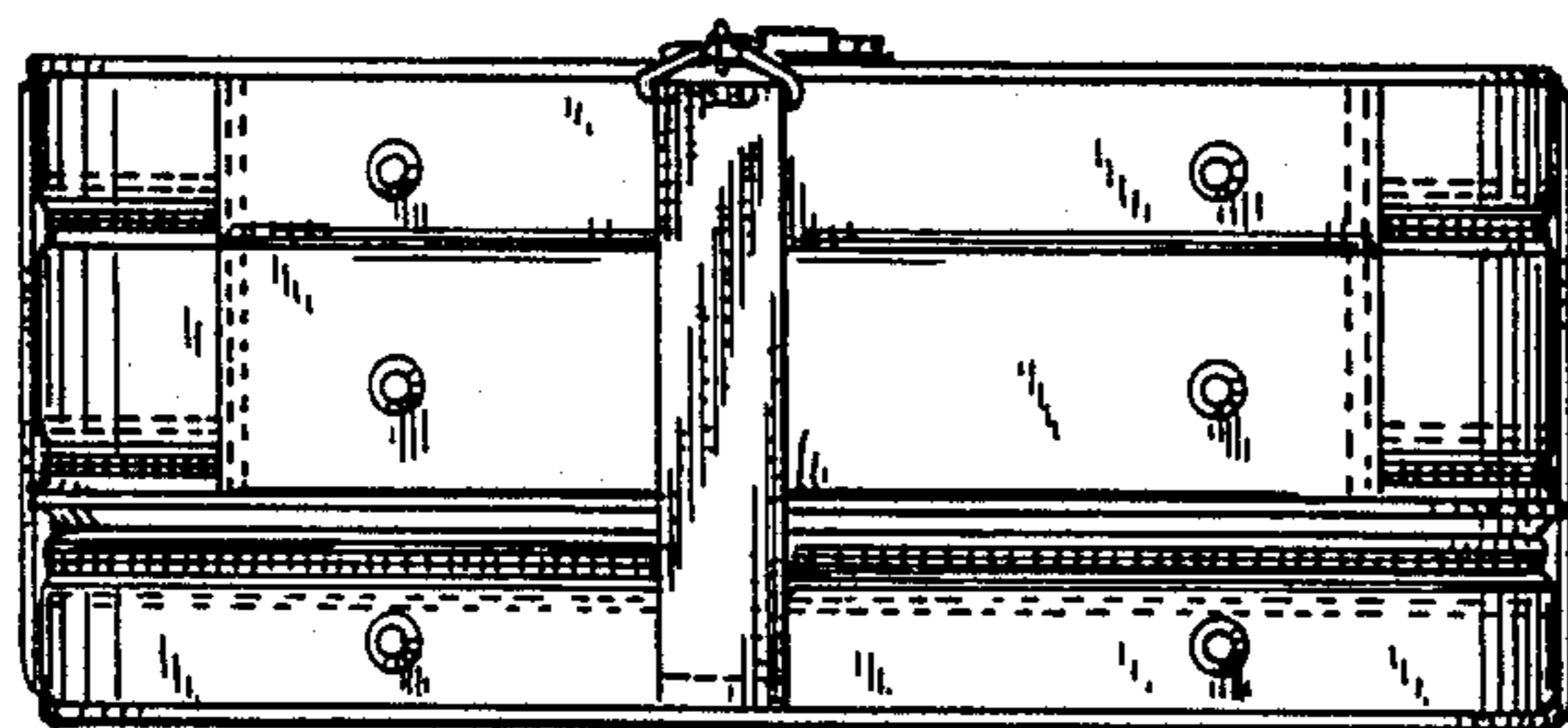

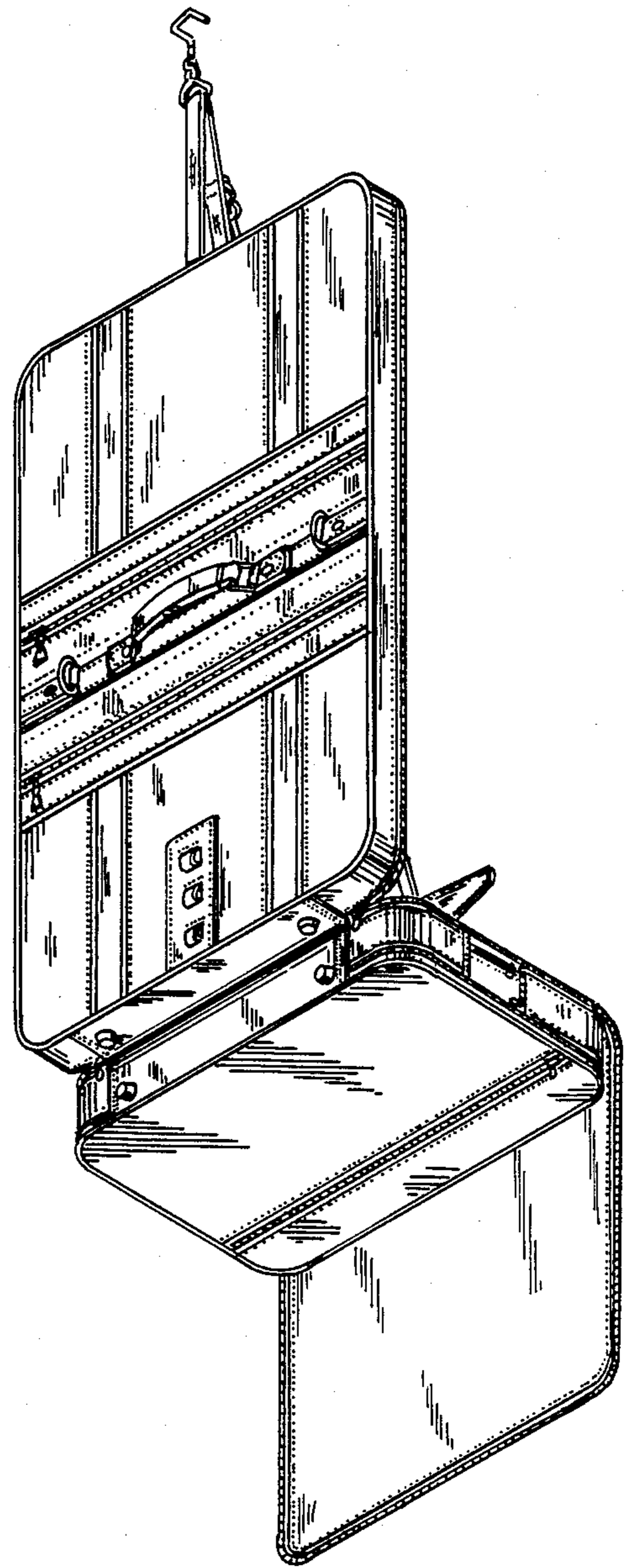
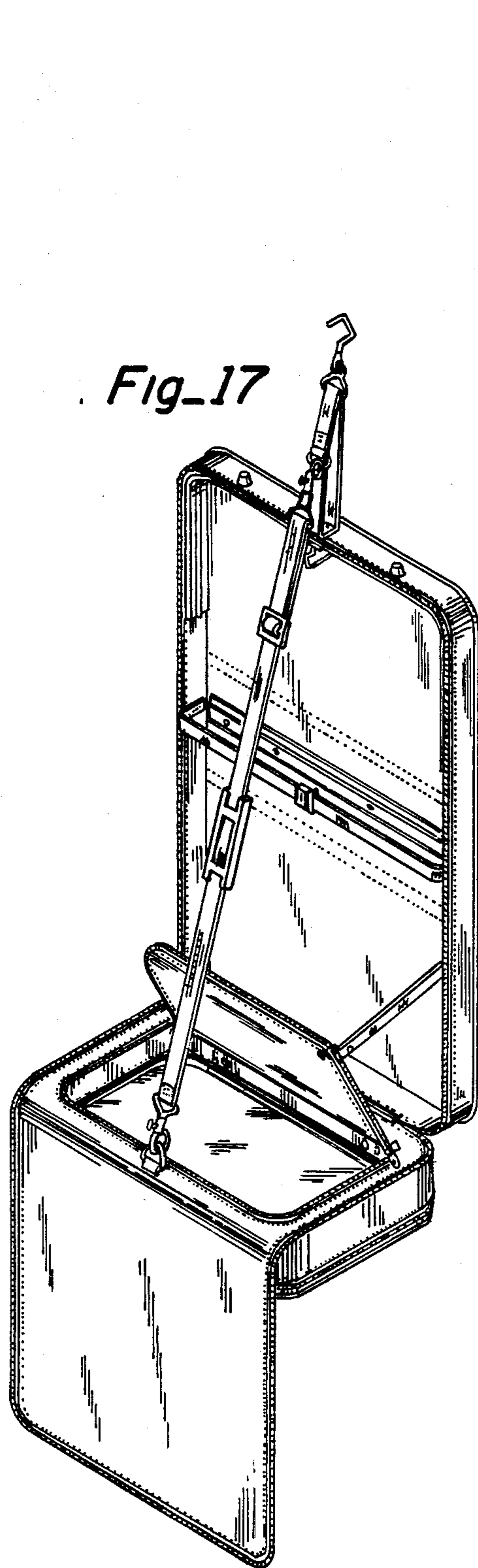
