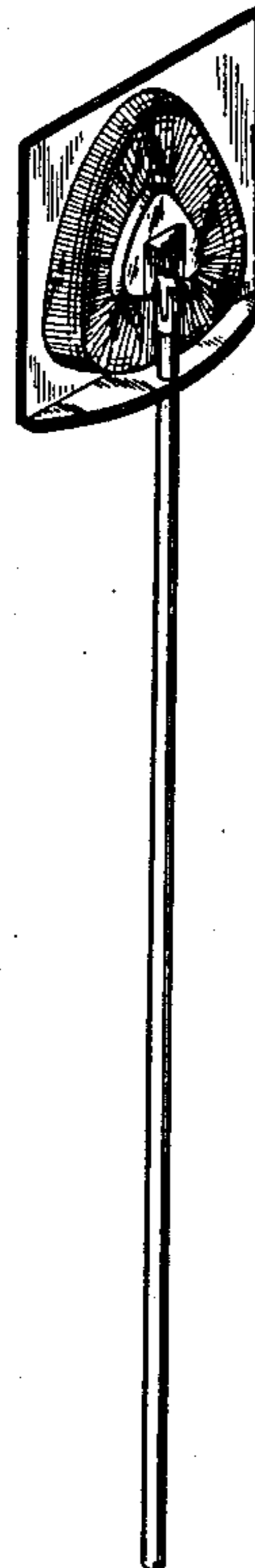
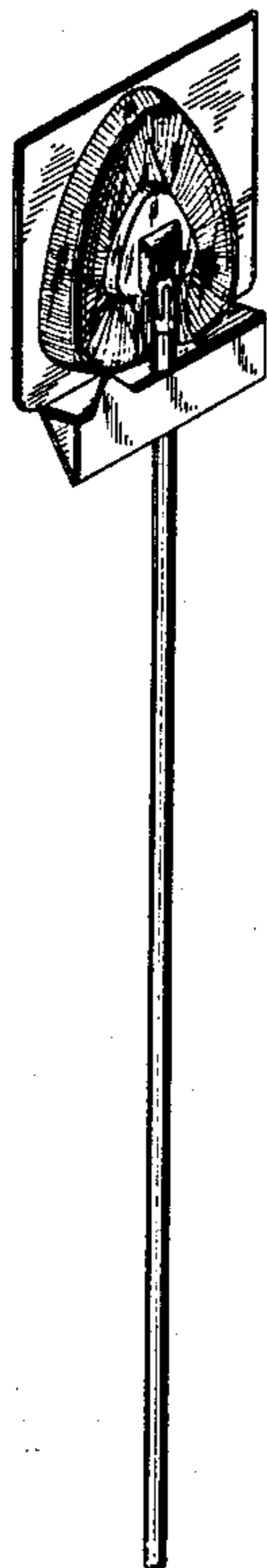

The ornamental design for a dust mop package, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a dust mop package showing my new design;  
 FIG. 2 is an enlarged front elevational view thereof, shown with the handle broken away for ease of illustration.  
 FIG. 3 is a right side elevational view thereof.  
 FIG. 4 is a rear elevational view thereof.  
 FIG. 5 is a top plan view thereof;  
 FIG. 6 is a bottom plan view thereof;  
 FIG. 7 is a perspective view of a second embodiment of FIG. 1;  
 FIG. 8 is an enlarged front elevational view thereof, shown with the handle broken away for ease of illustration.

 FIG. 12 is a bottom plan view thereof.



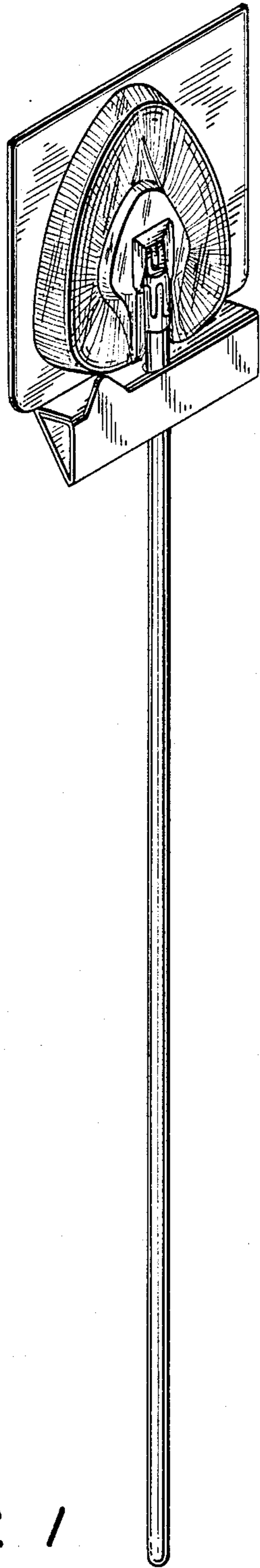

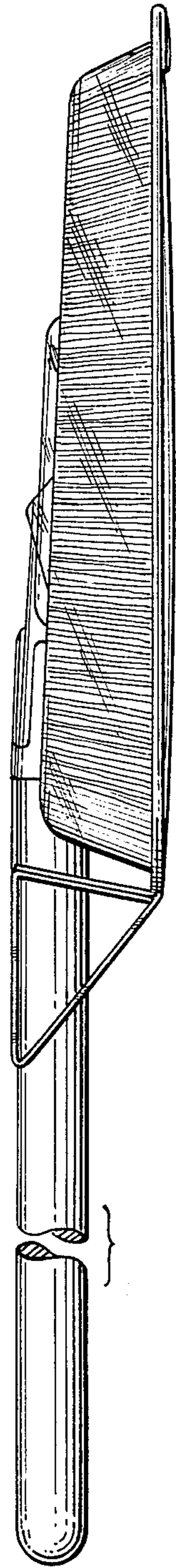

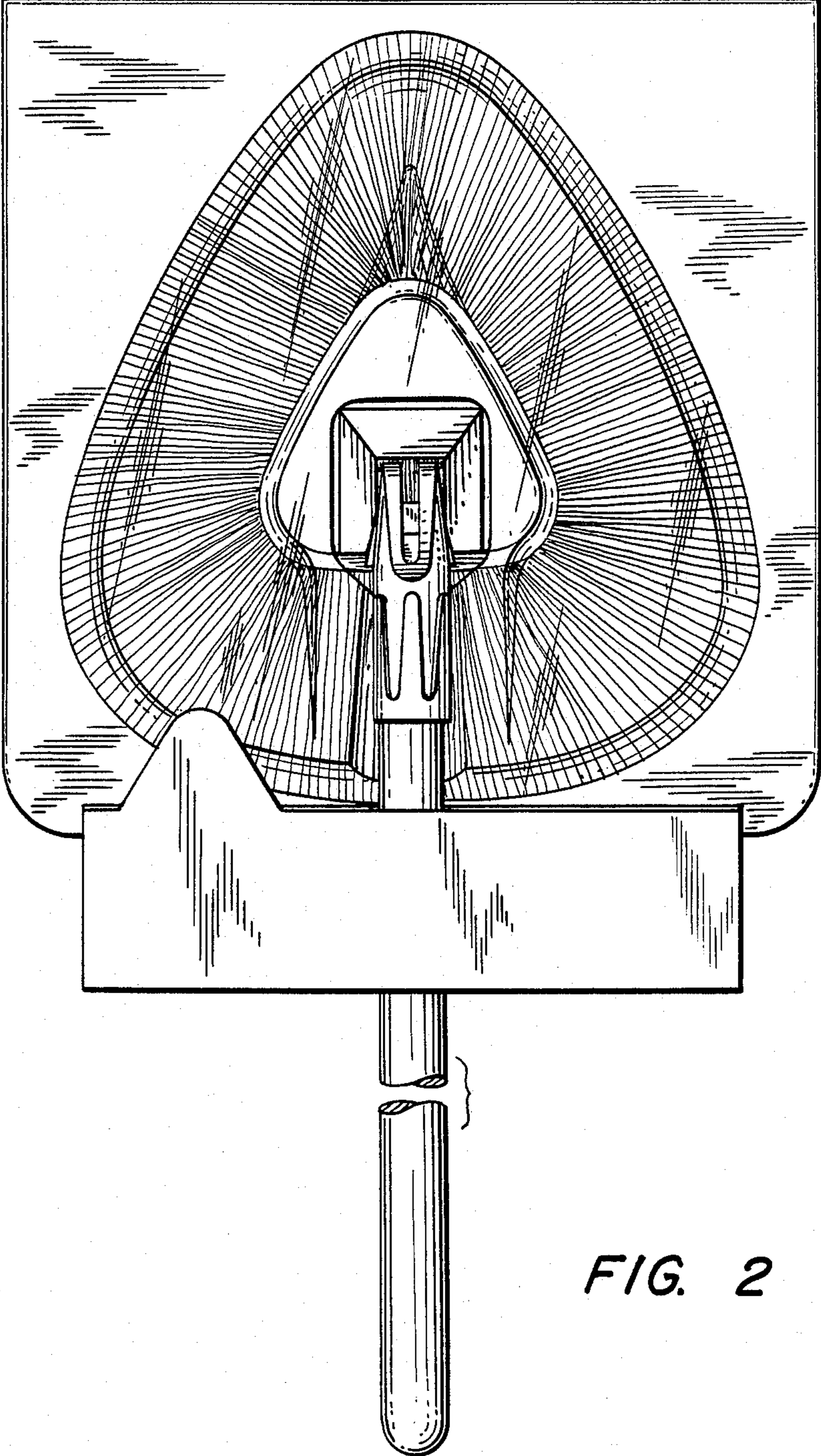

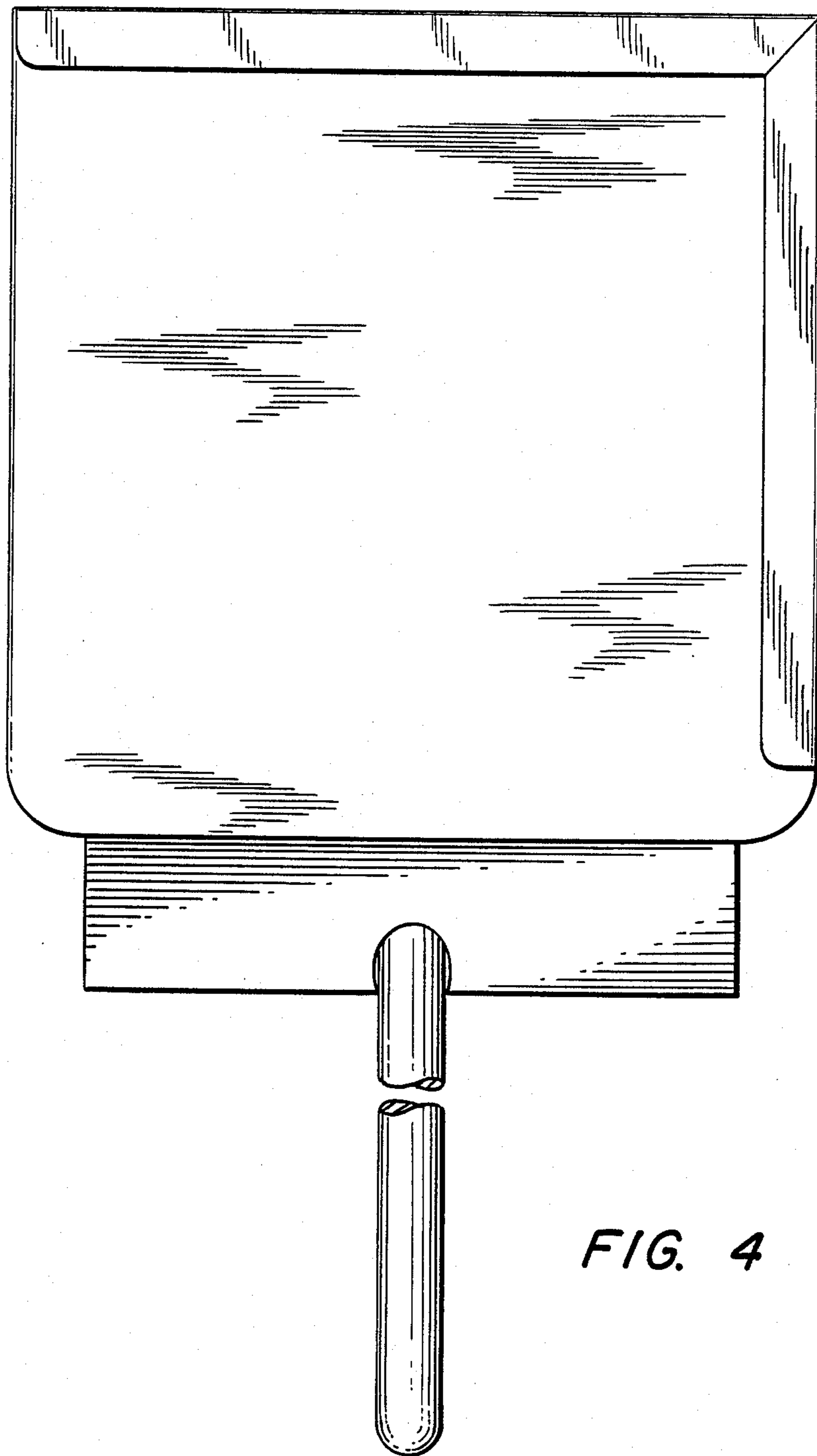

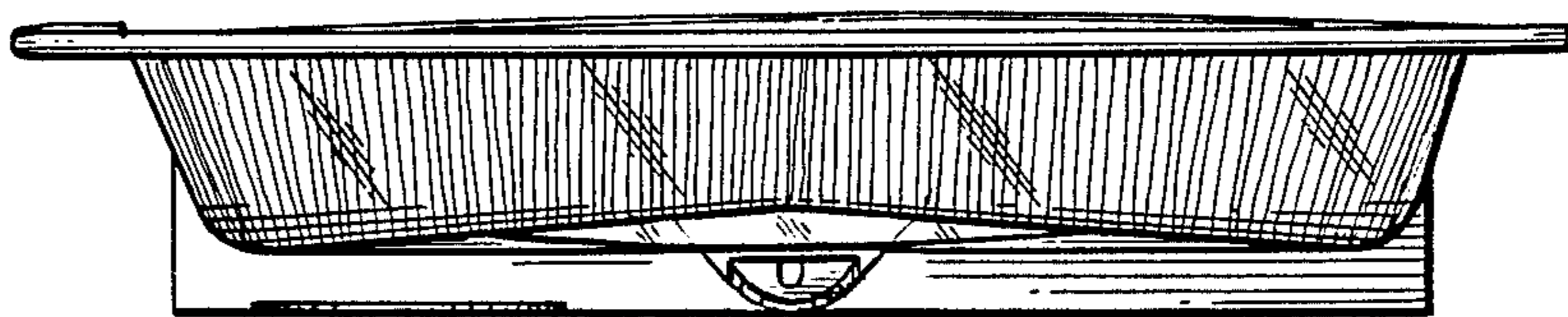

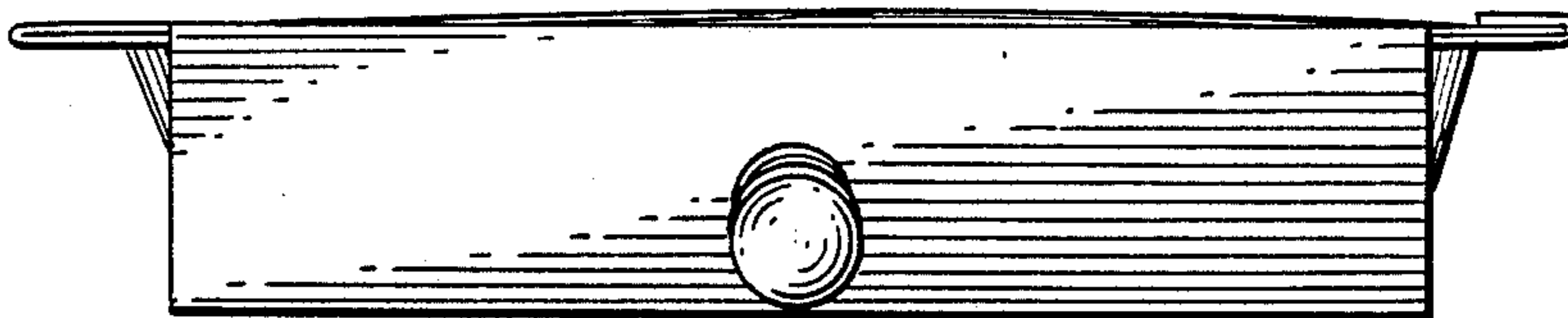

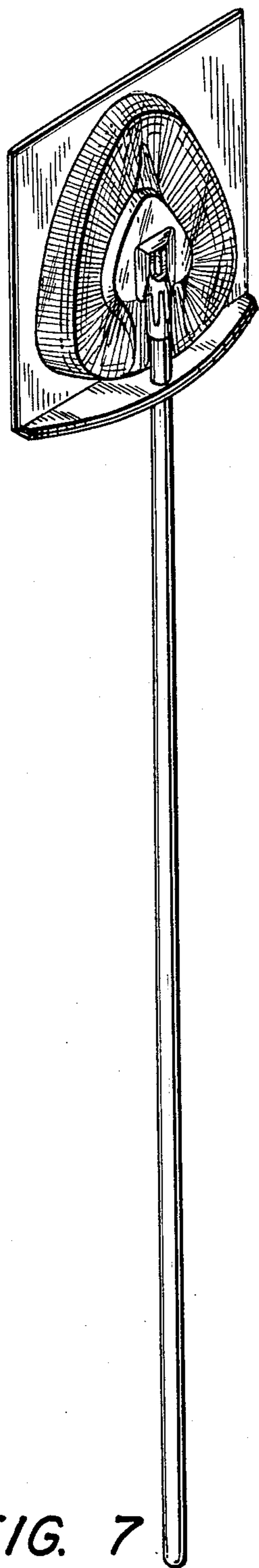

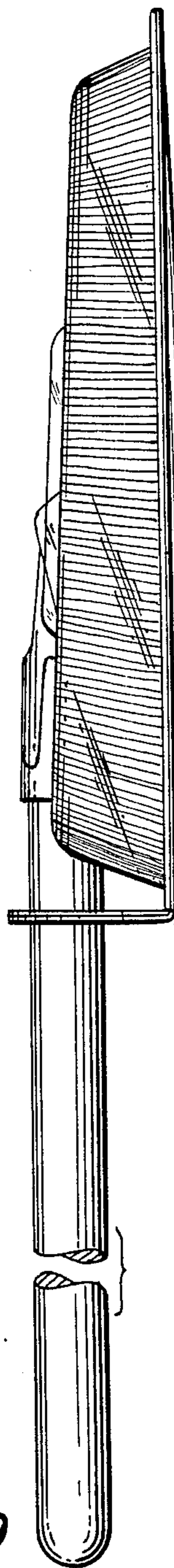

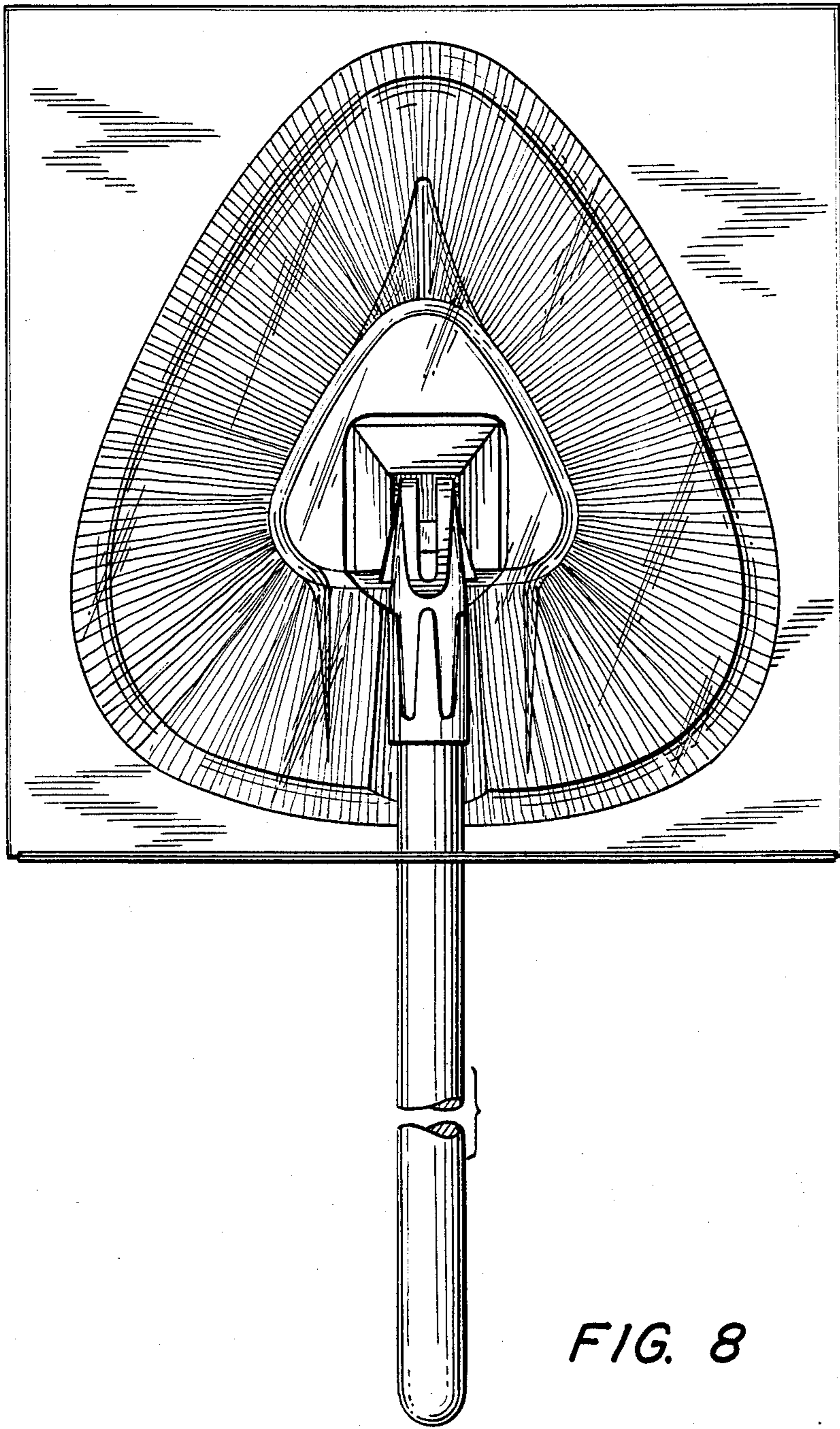

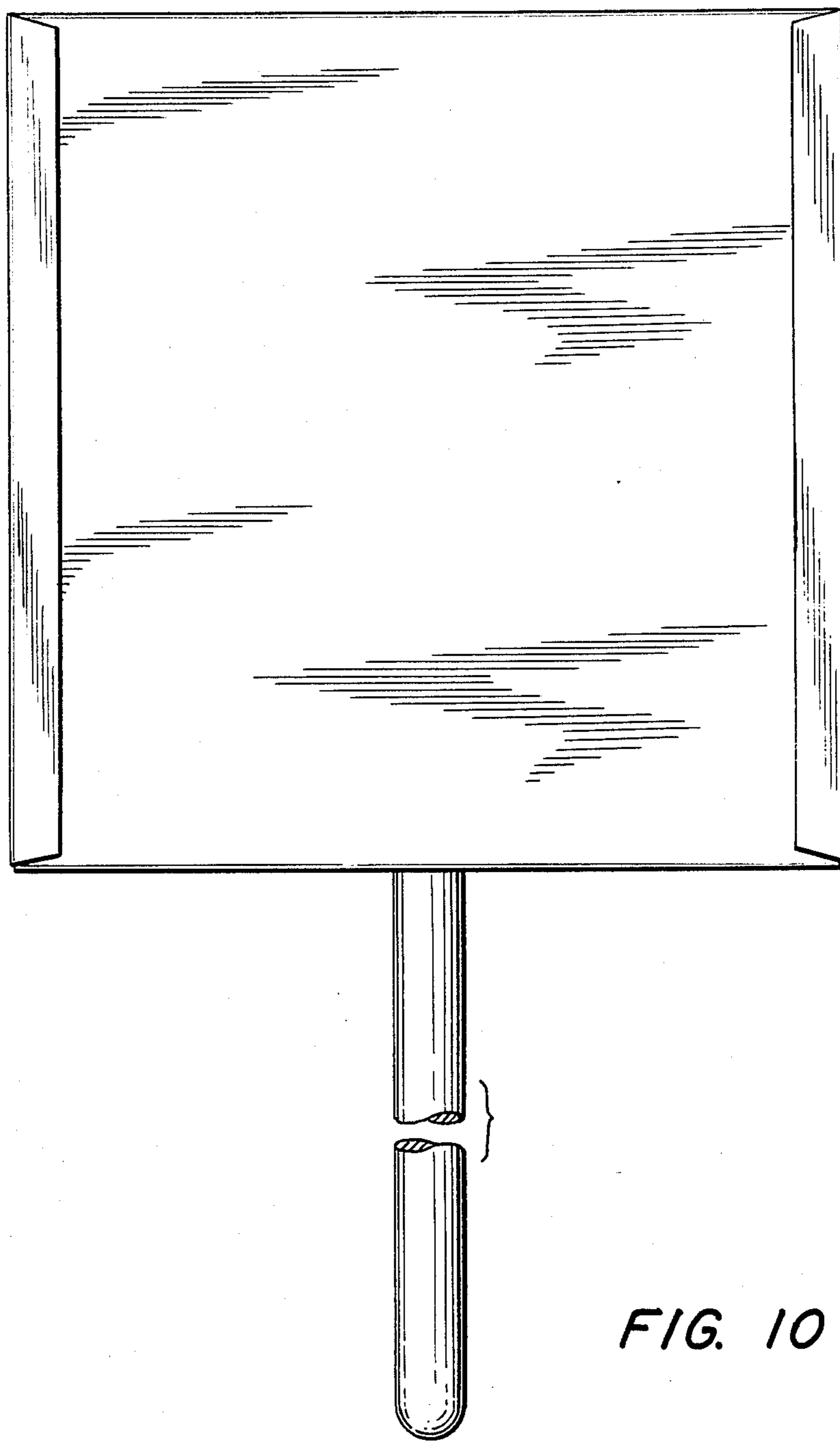
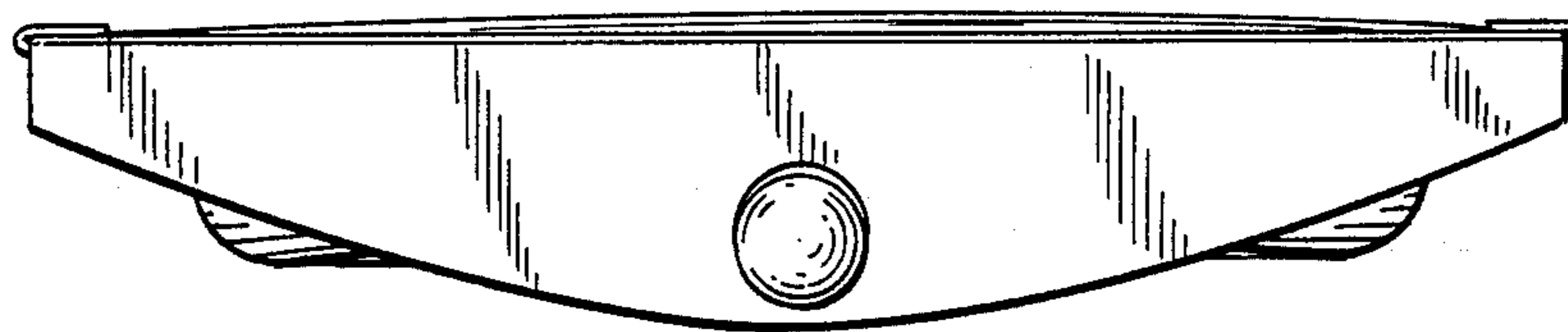
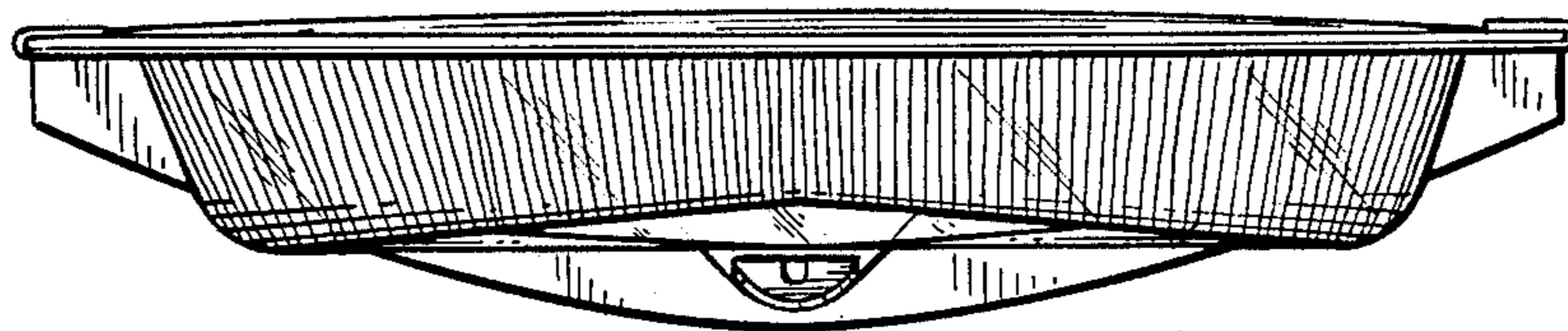
