[57] **CLAIM**

The ornamental design for wall mount, coin-operated, public telephone, as shown and described.

DESCRIPTION

FIG. 1 is a front and right side perspective view of a wall mount, coin-operated, public telephone showing our new design;

FIG. 2 is a perspective view like FIG. 1 with the handset removed from the console;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a right side elevational view thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a left side elevational view thereof;

FIG. 7 is a rear elevational view thereof; and

FIG. 8 is a bottom plan view thereof.

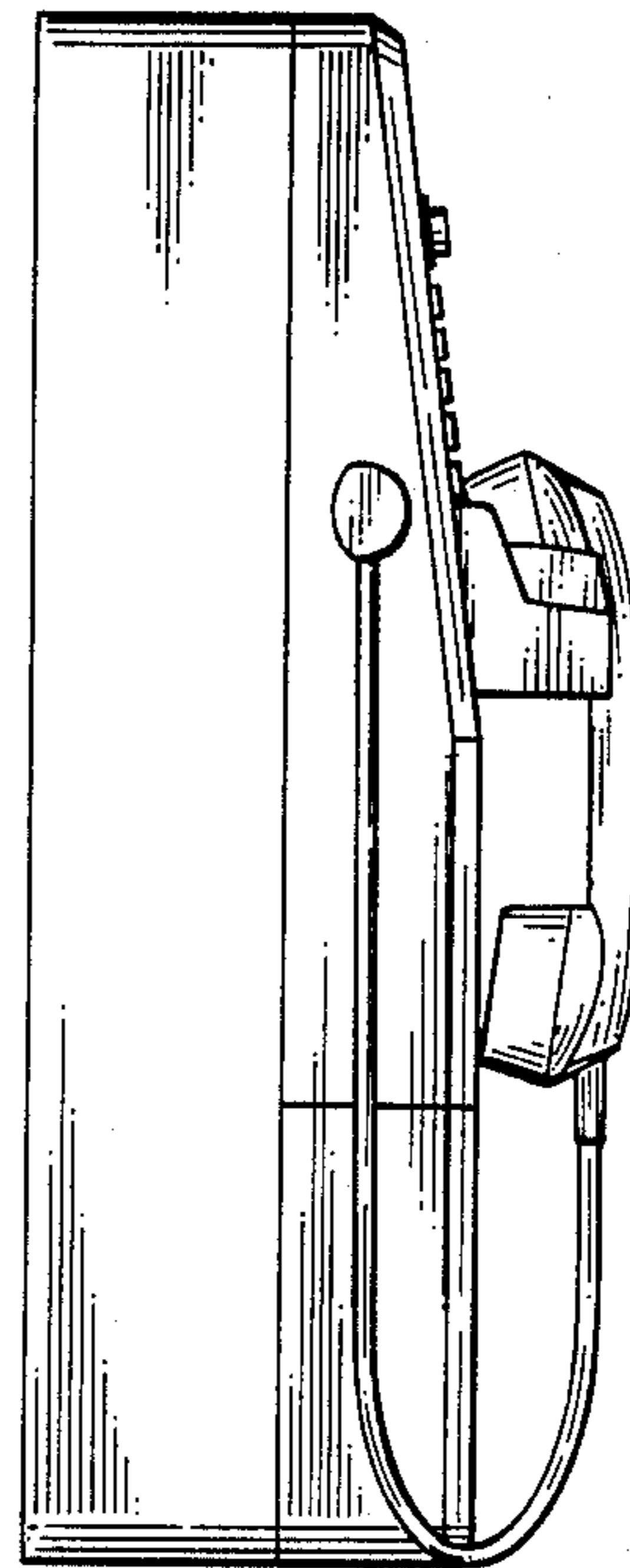
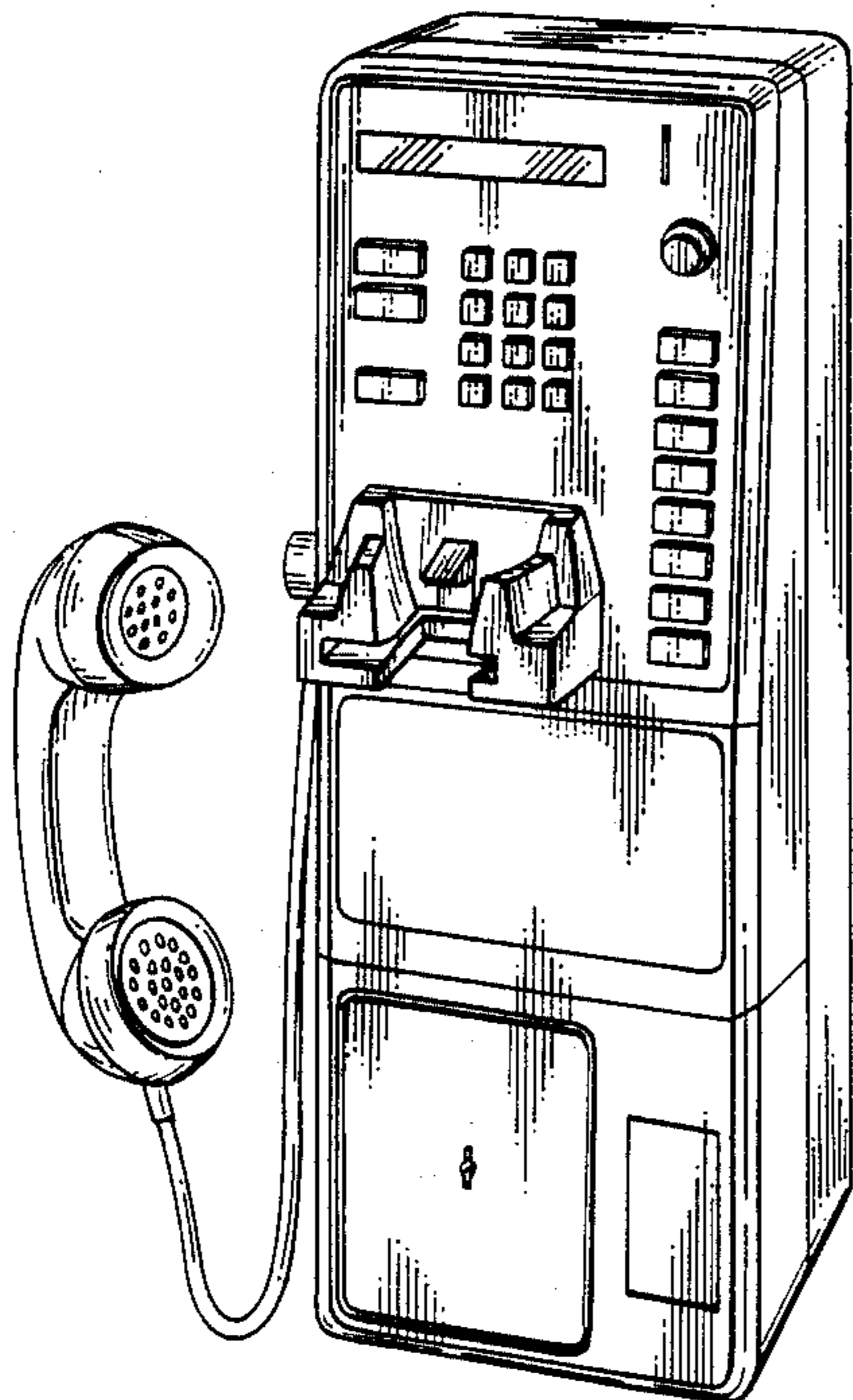

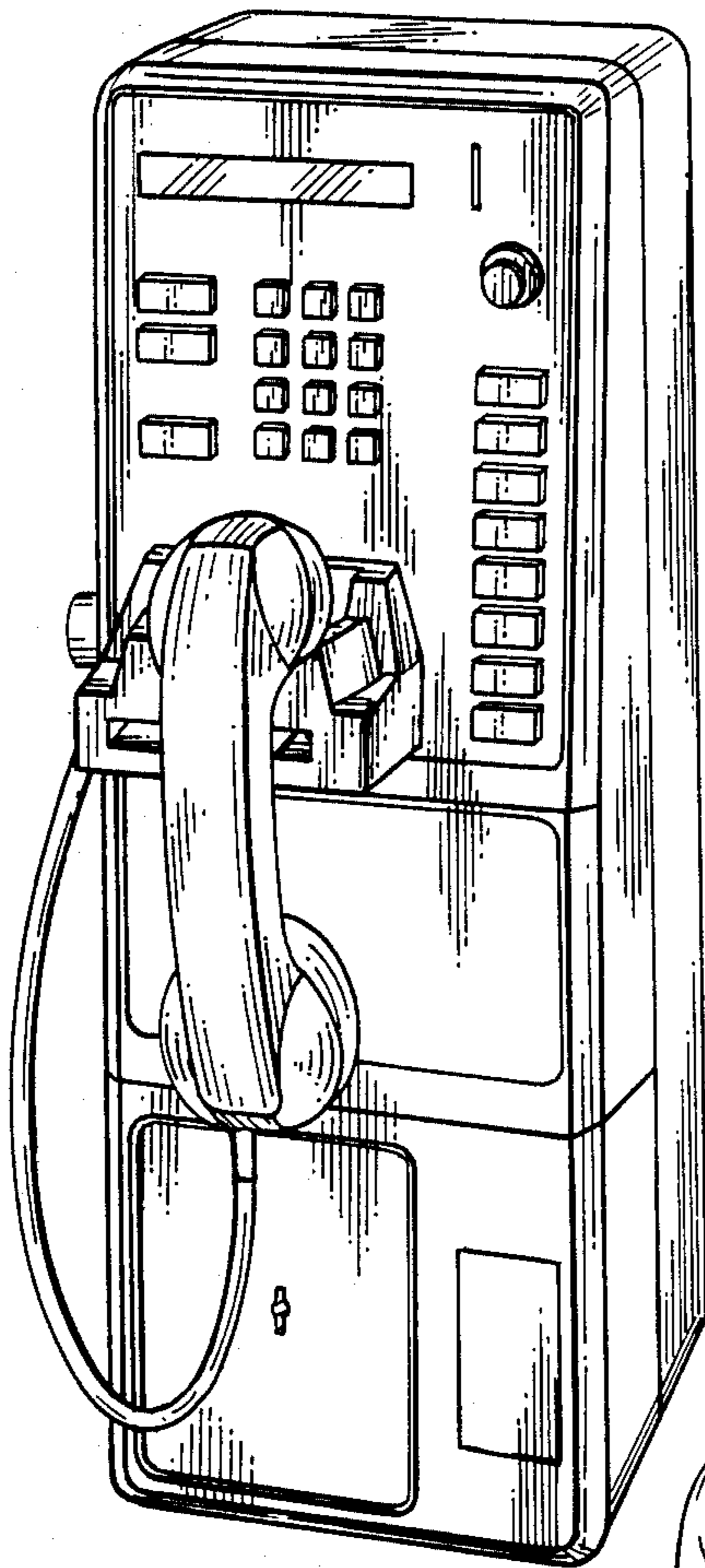

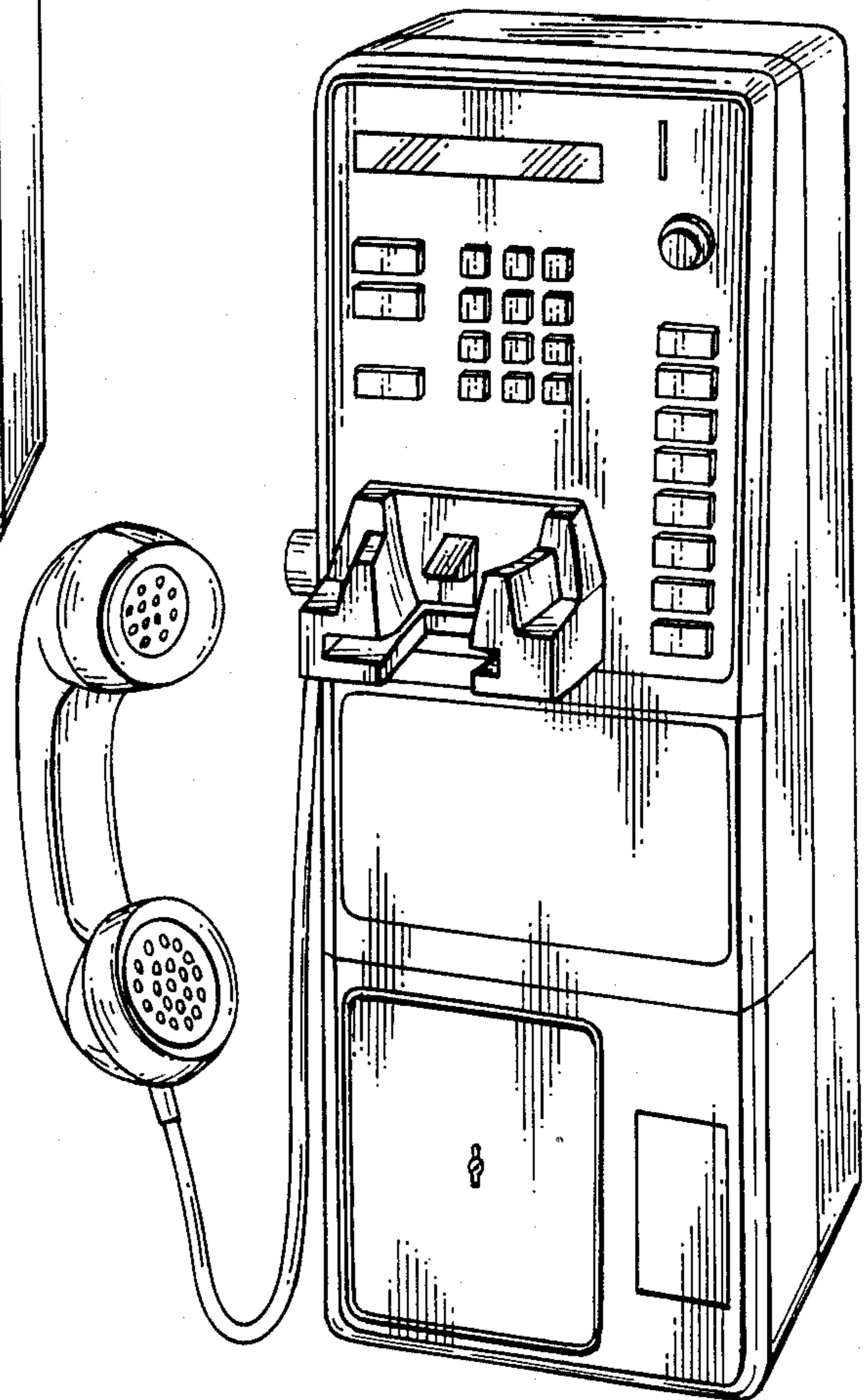

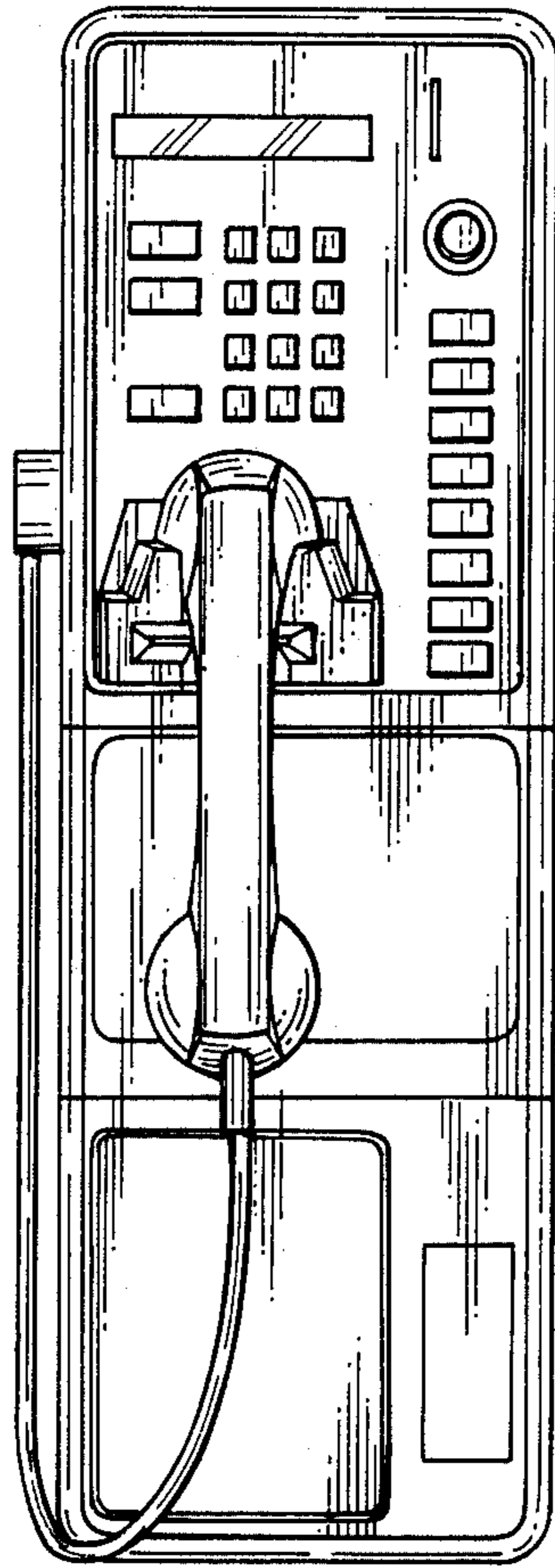

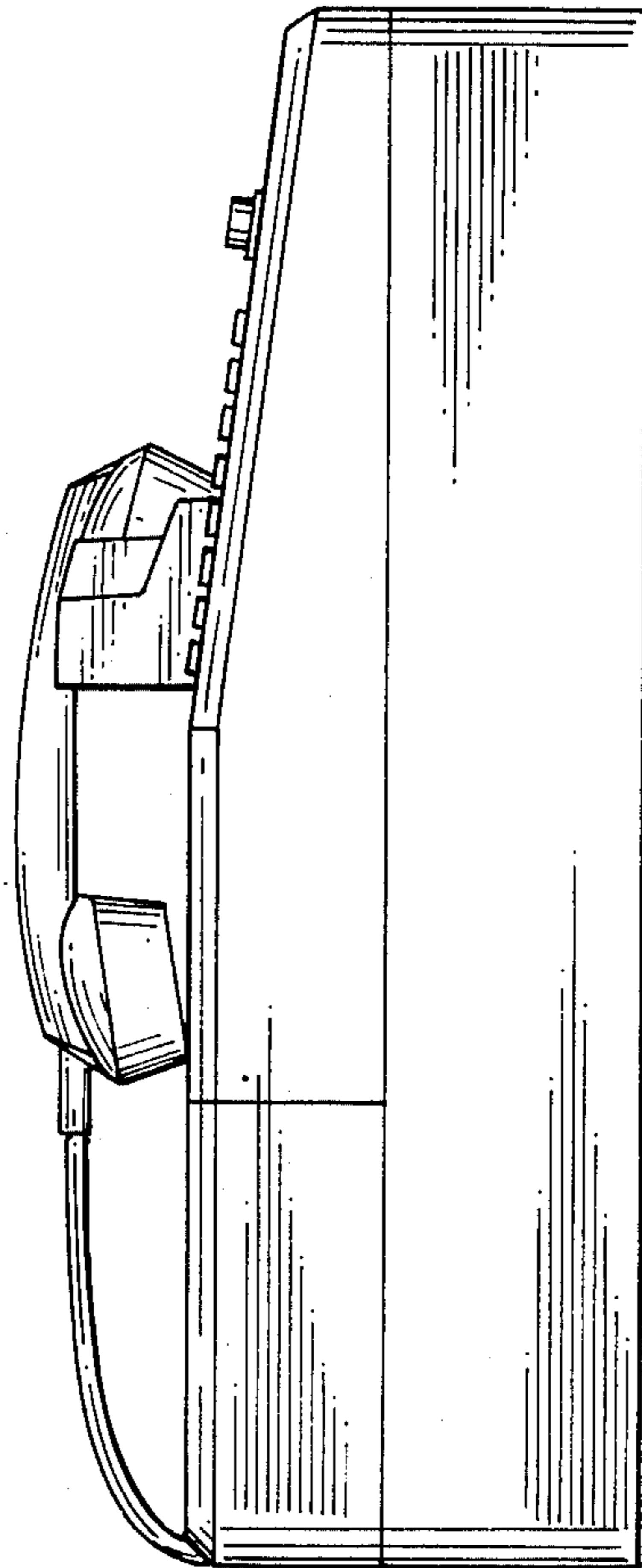

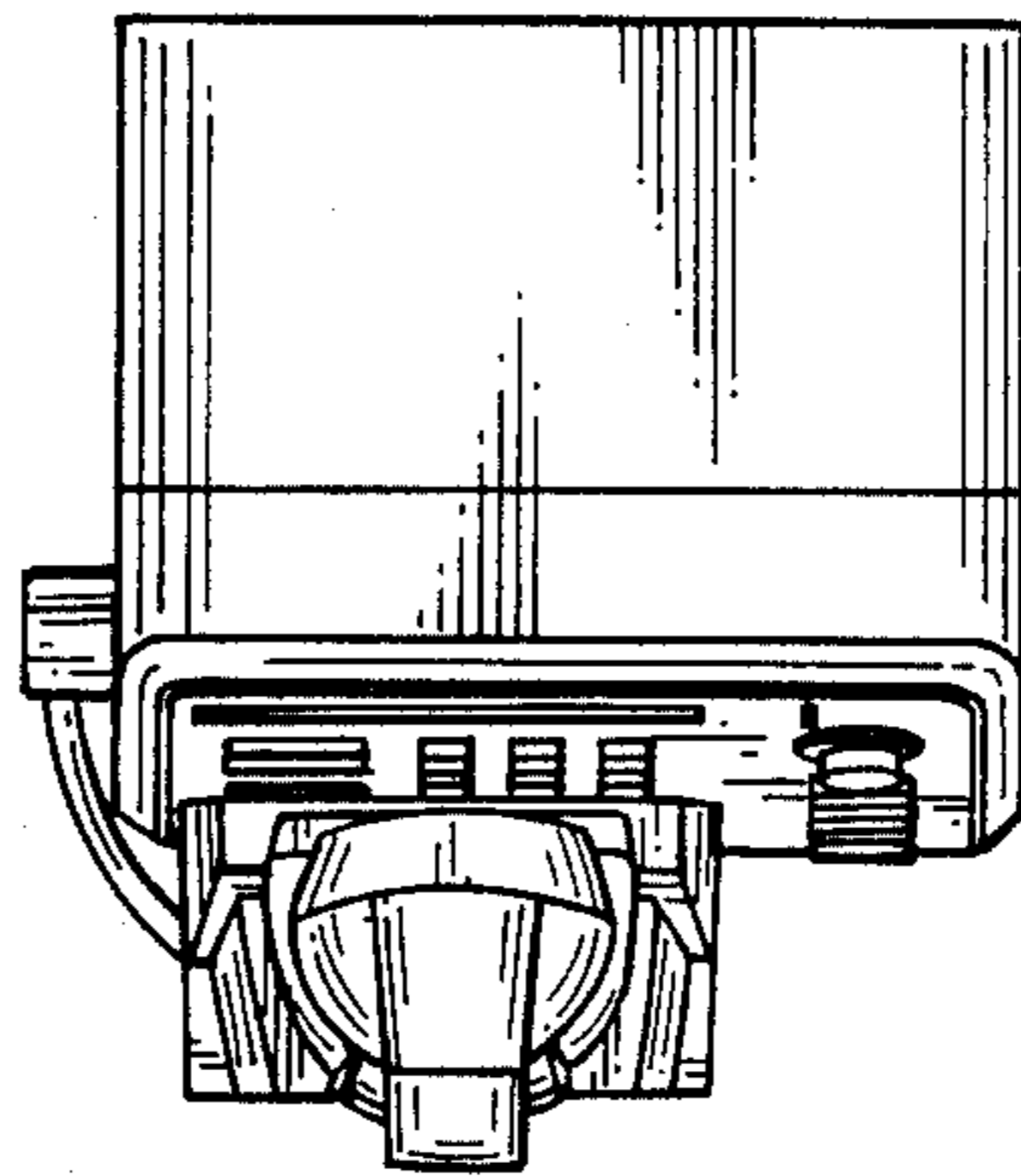

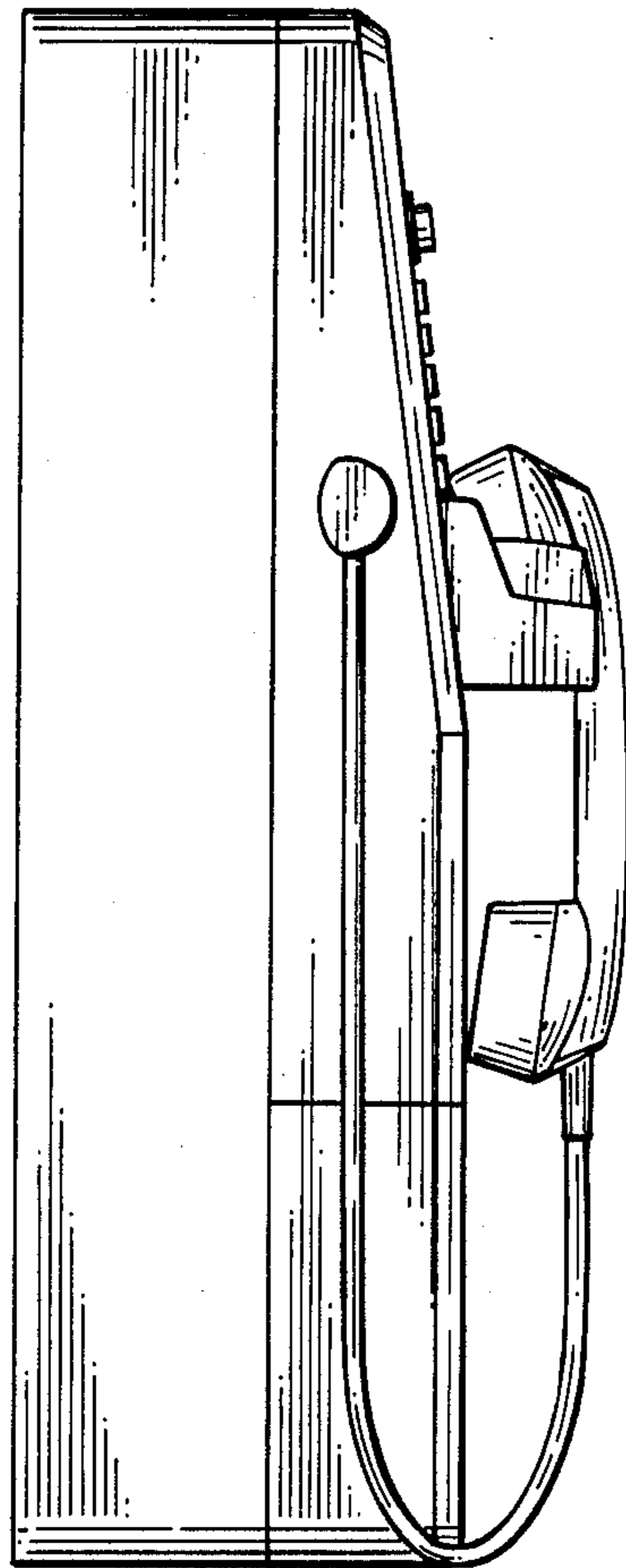

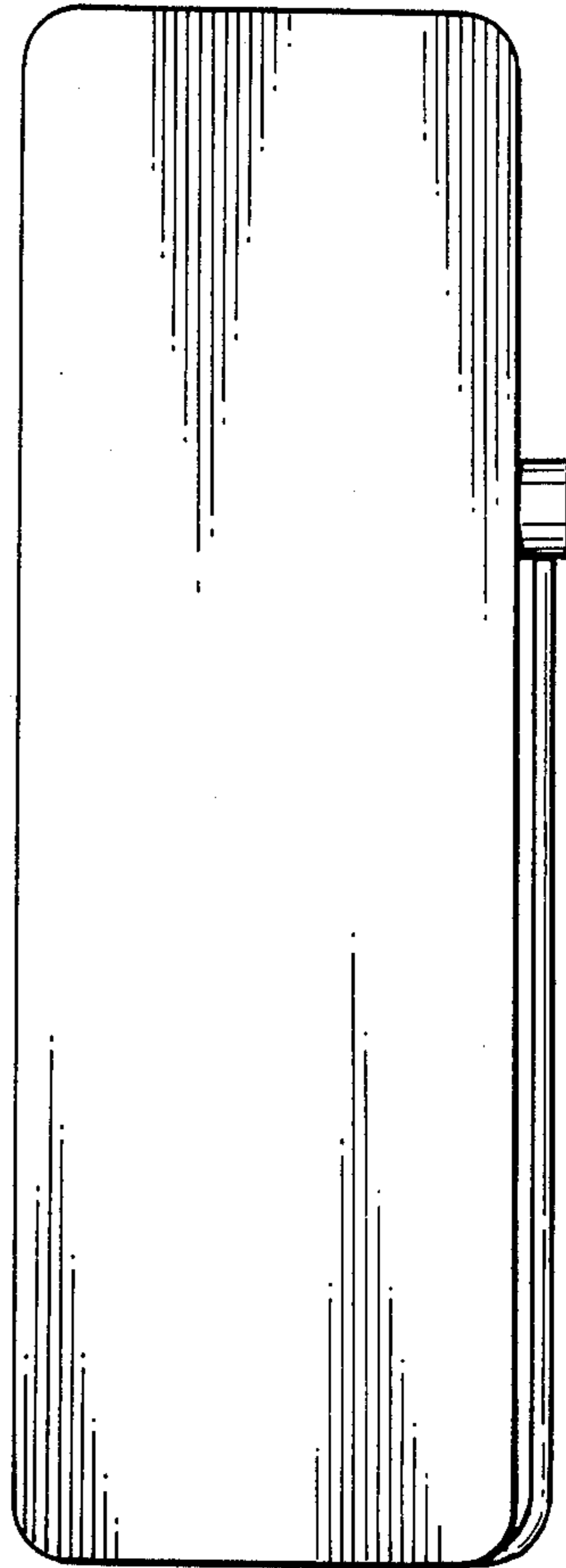
