 FIG. 7 is a sectional view taken on lines 7—7 of FIG. 1.

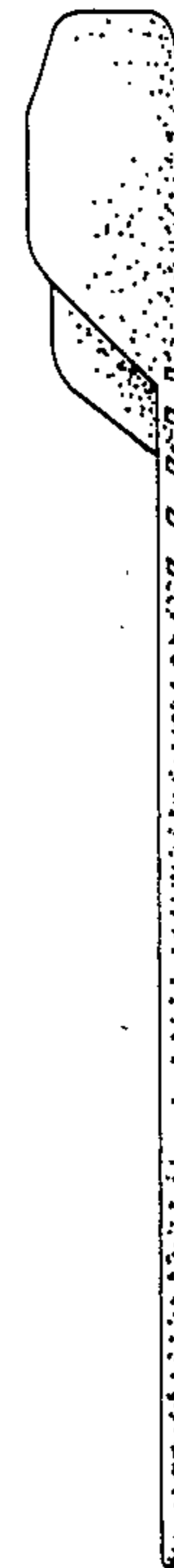
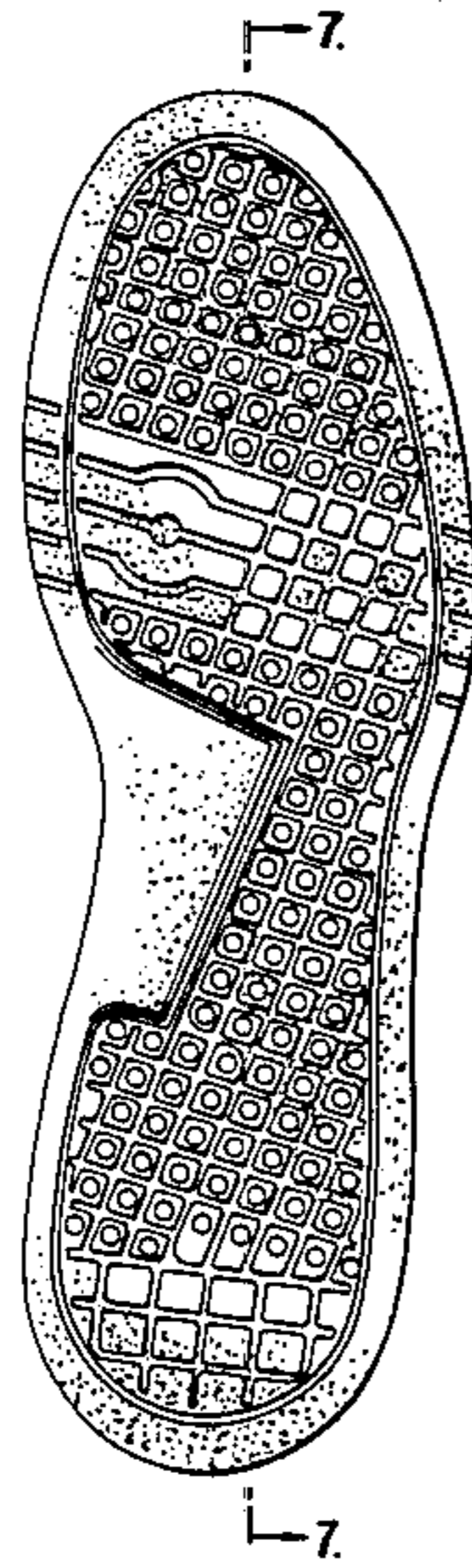

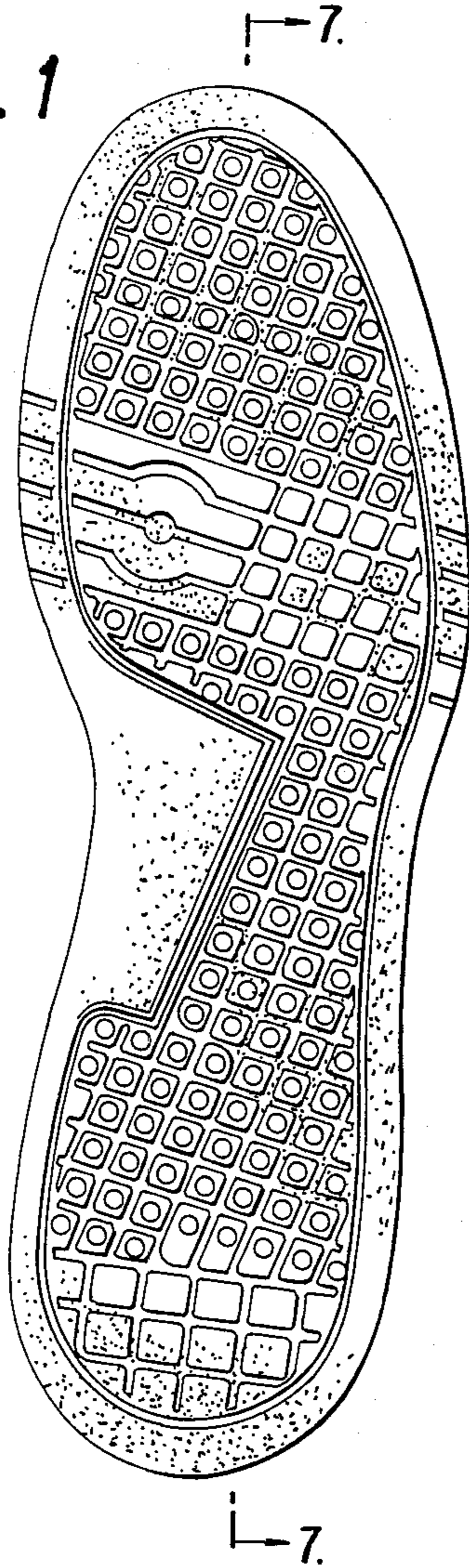

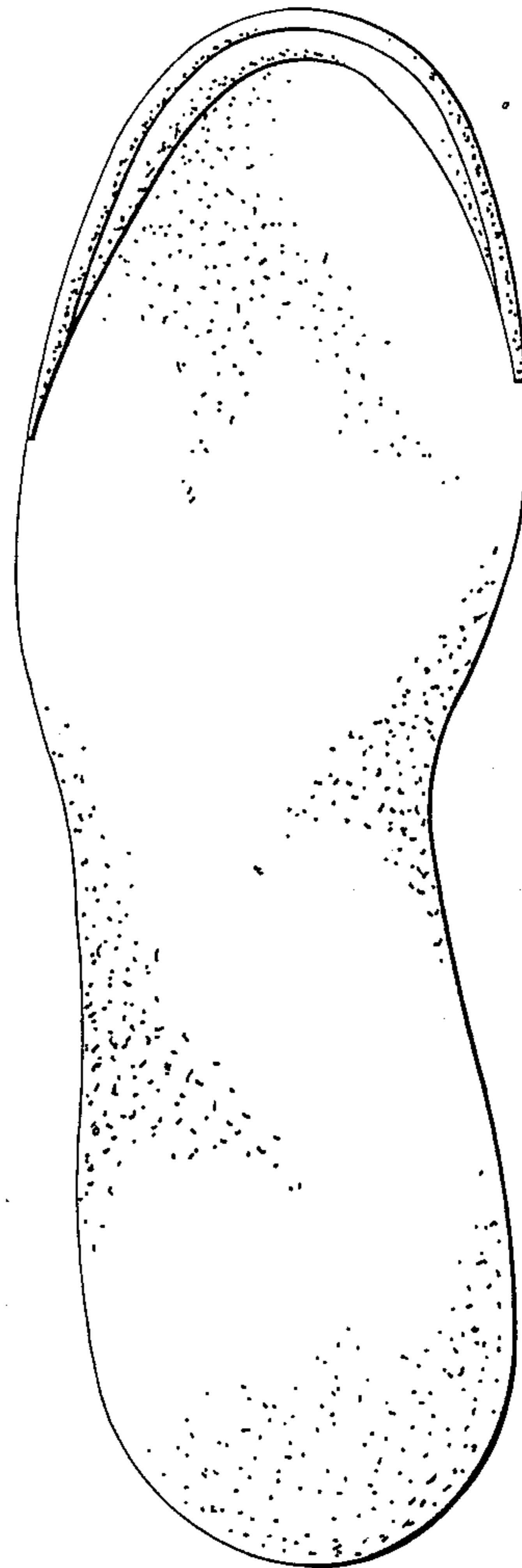

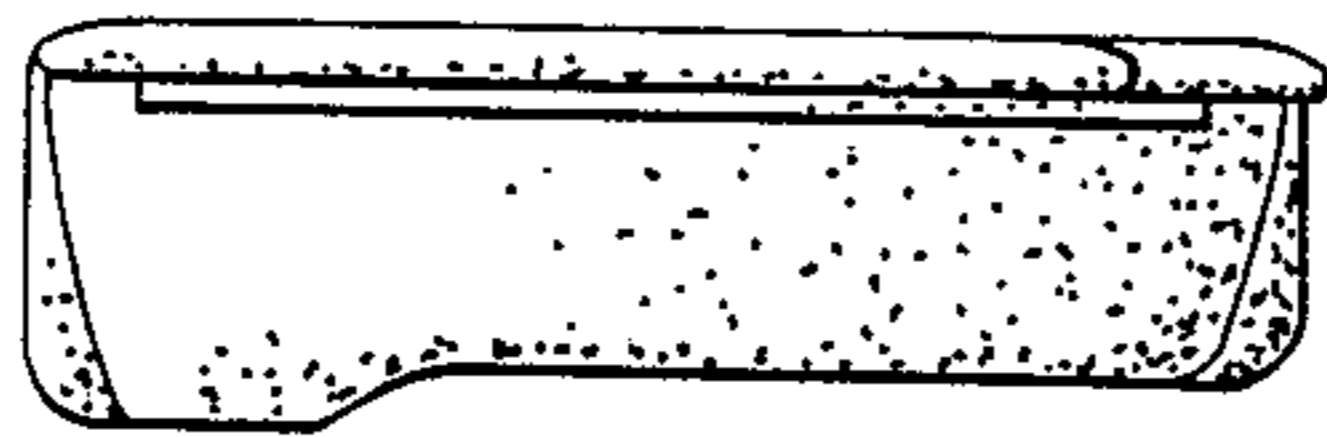

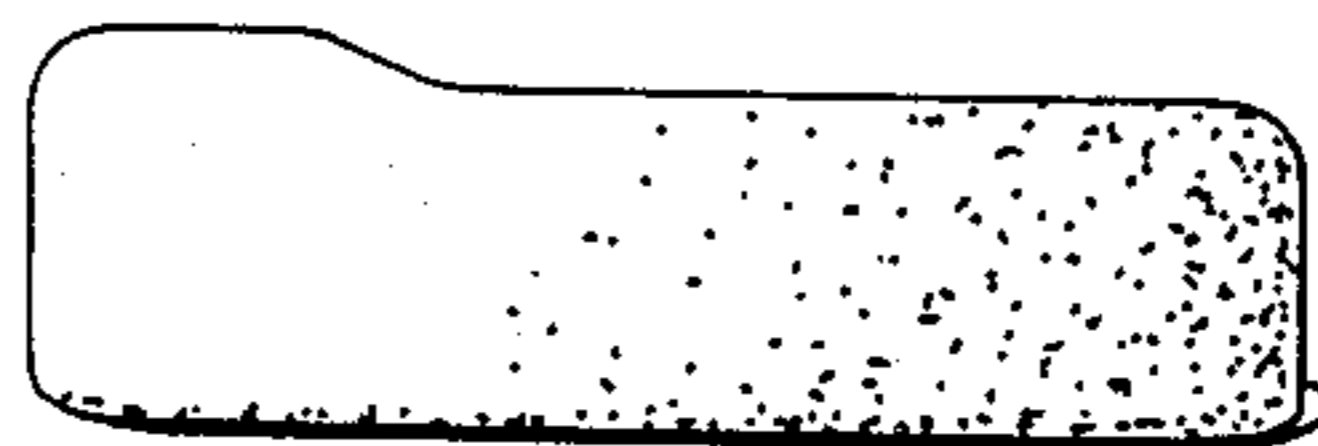

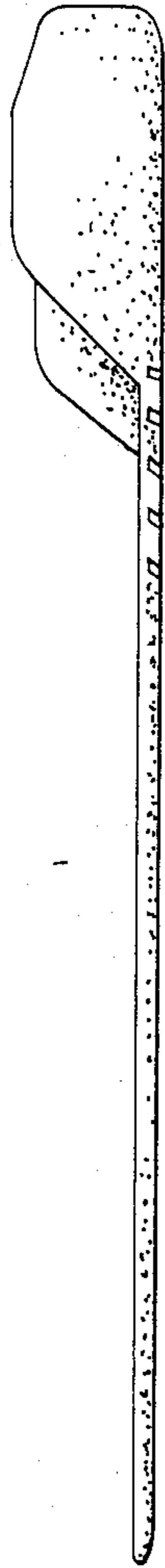

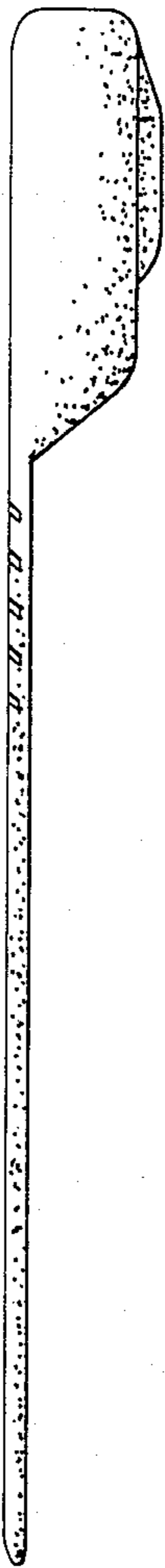

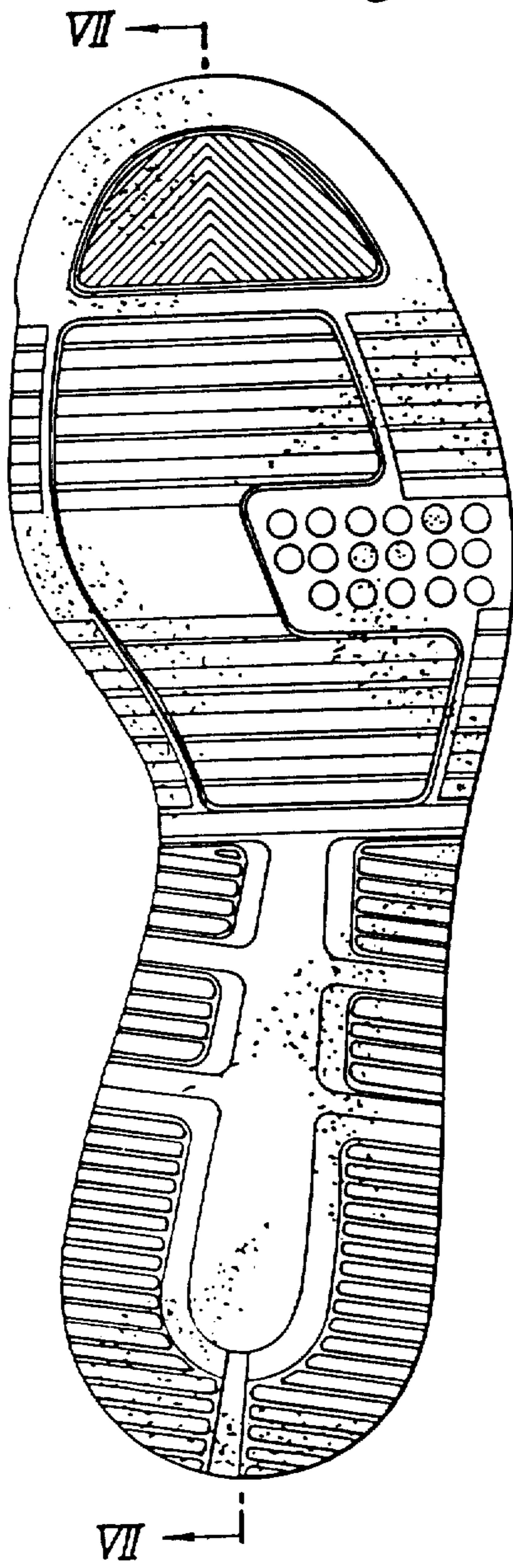

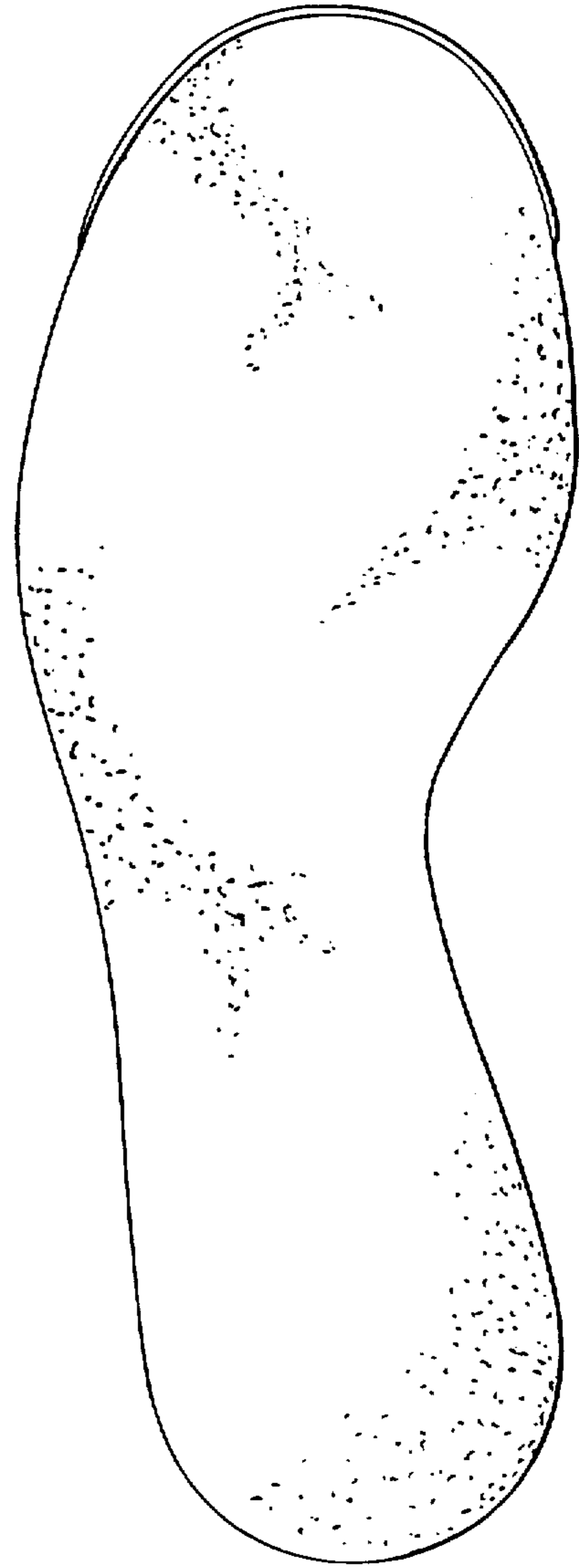

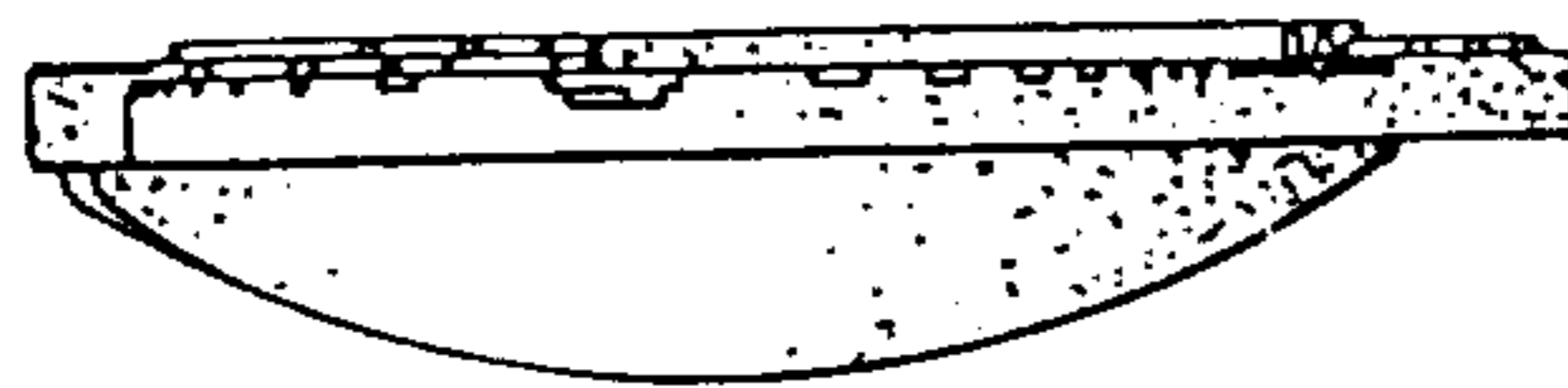

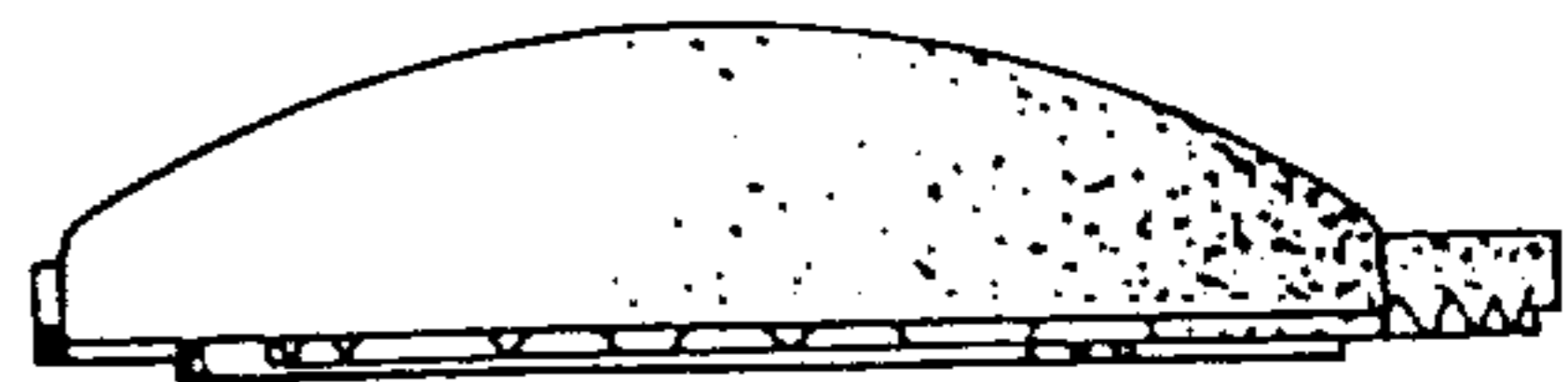

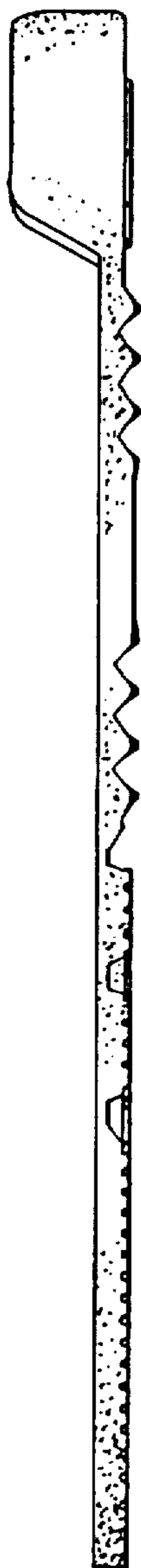

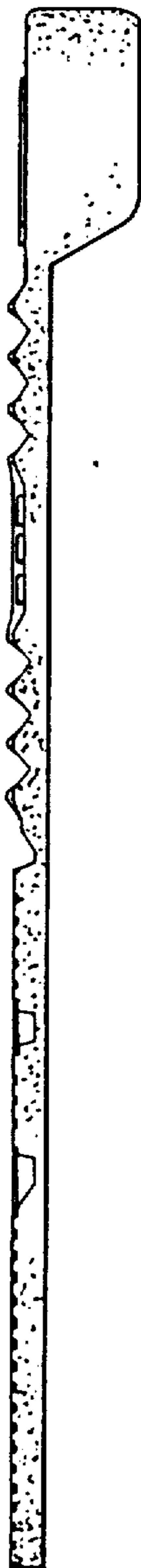
