DESCRIPTION

FIG. 10 is a bottom plan view thereof;

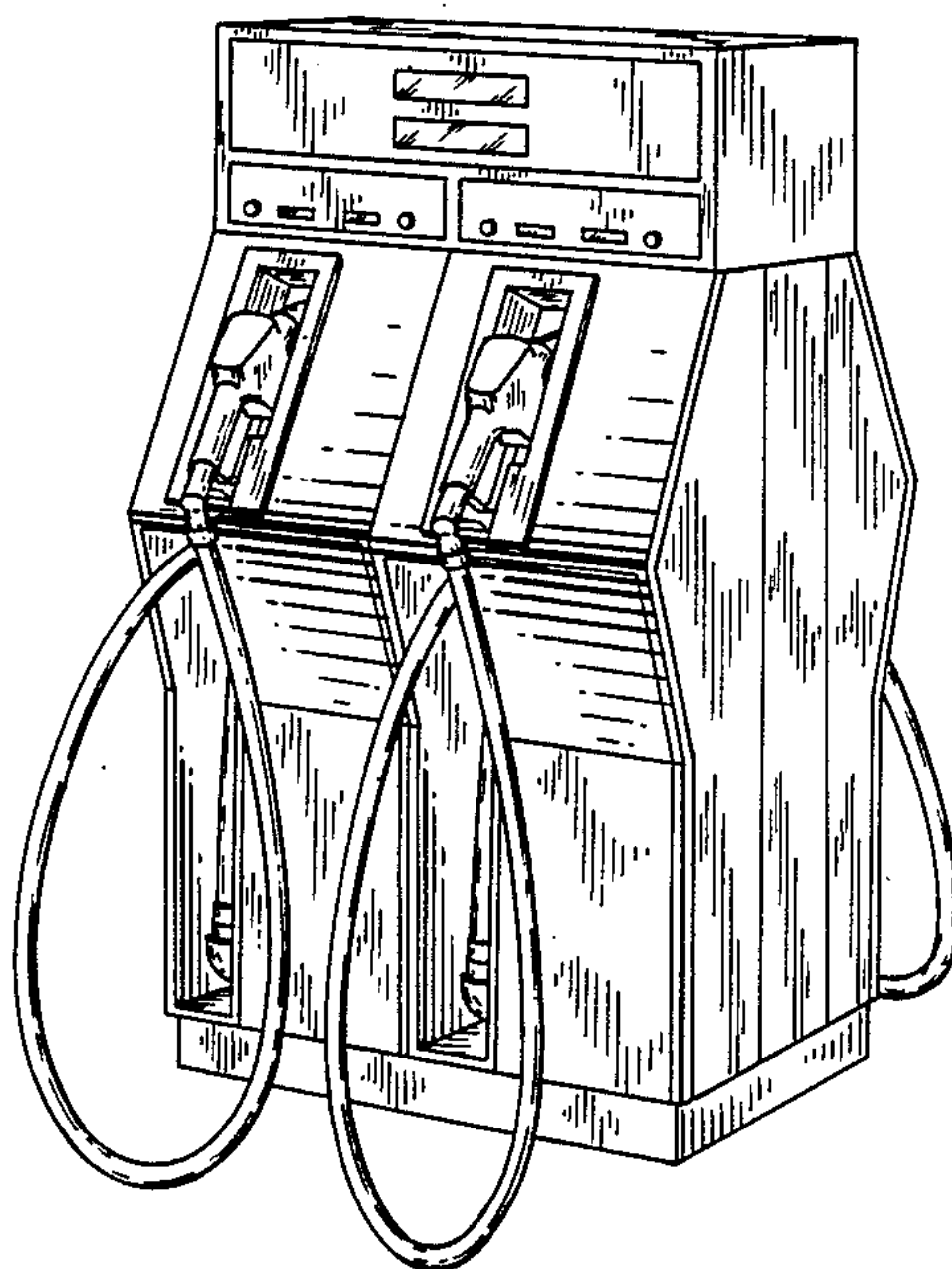
FIG. 11 is a perspective view of a third embodiment of a liquid fuel dispensing console showing my new design;

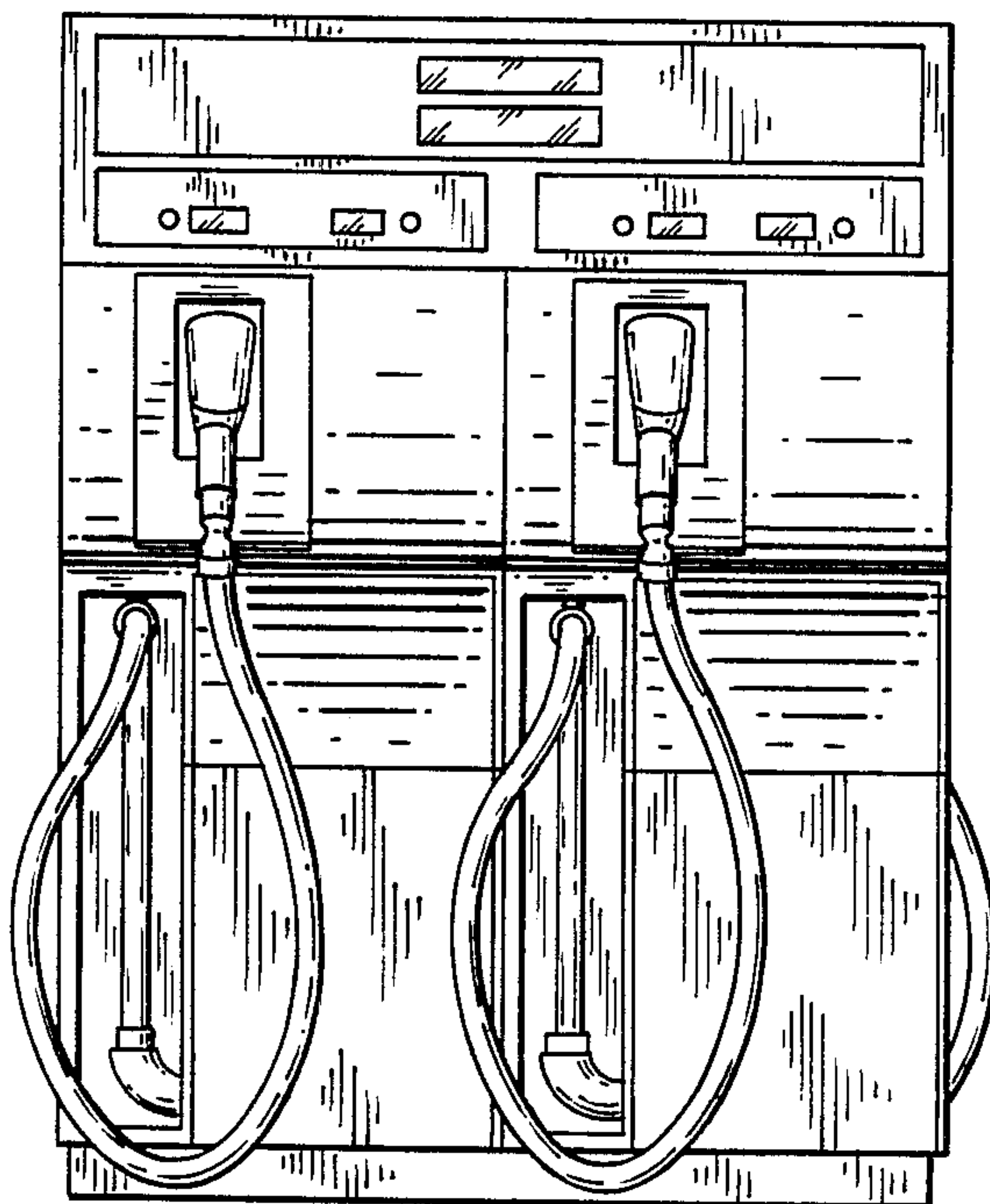
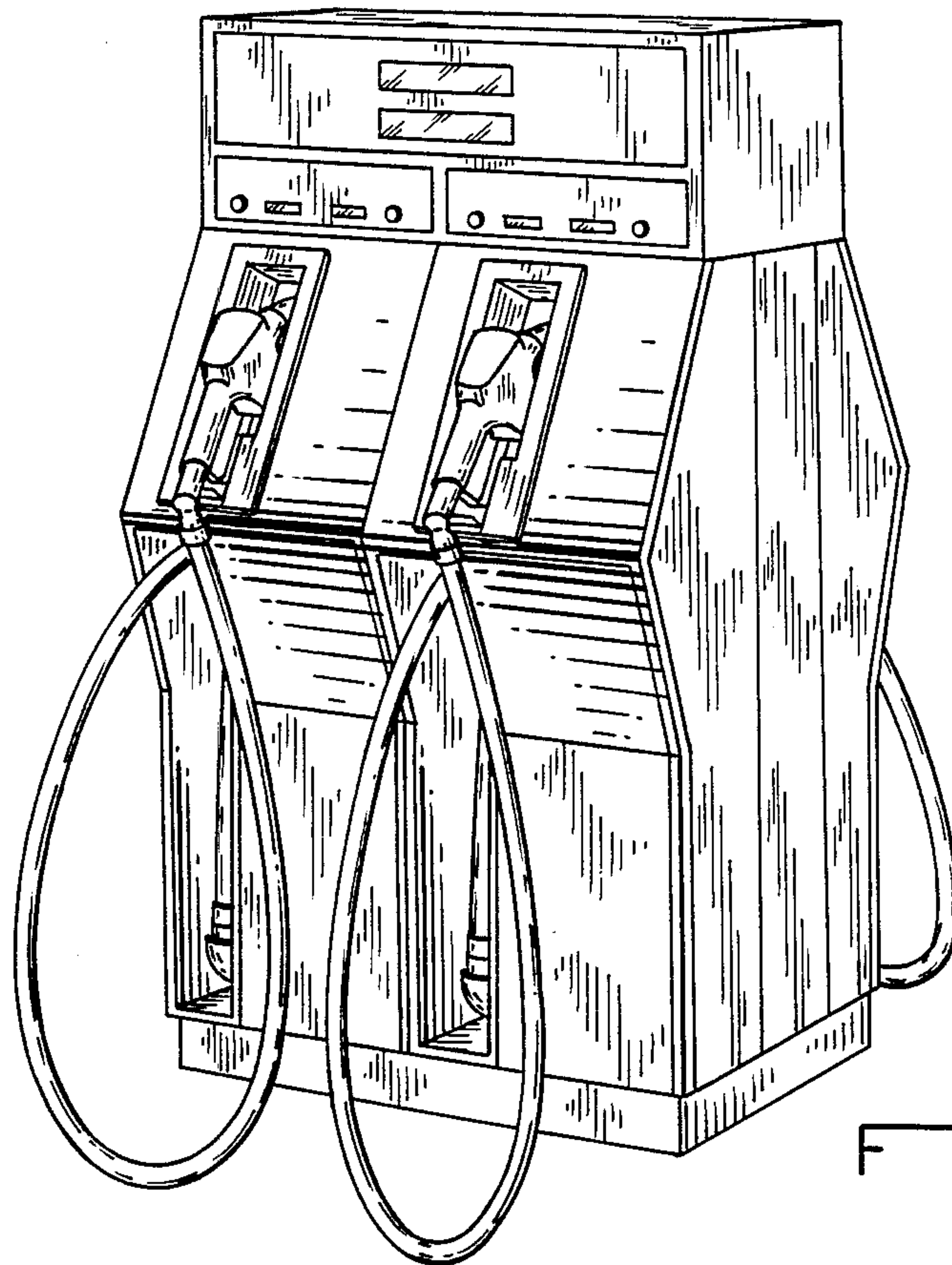
FIG. 12 is a front elevational view thereof, the rear being a mirror image of that shown;

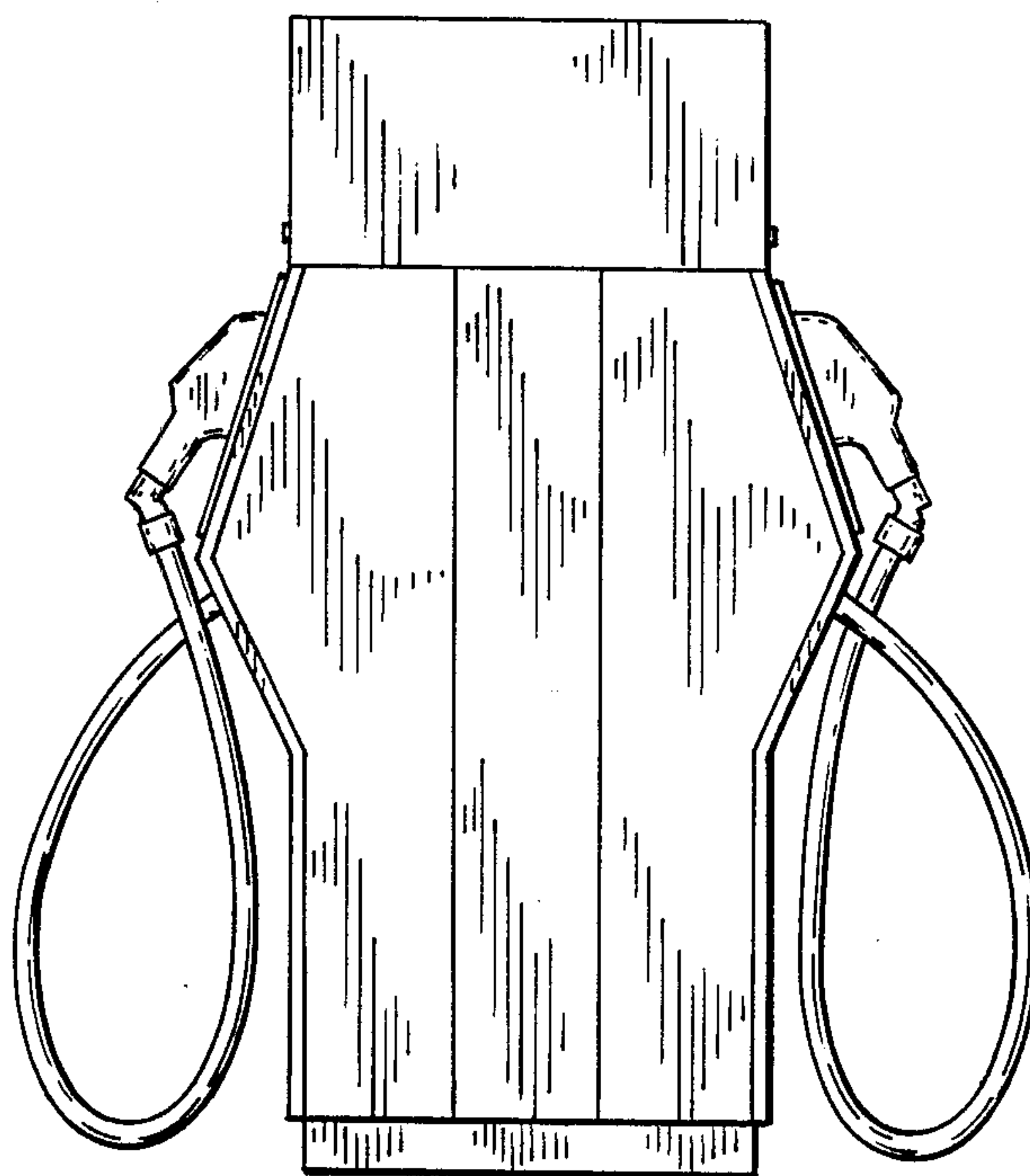
FIG. 13 is a side elevational view thereof, the side opposite being a mirror image of that shown;

FIG. 14 is a top plan view thereof; and

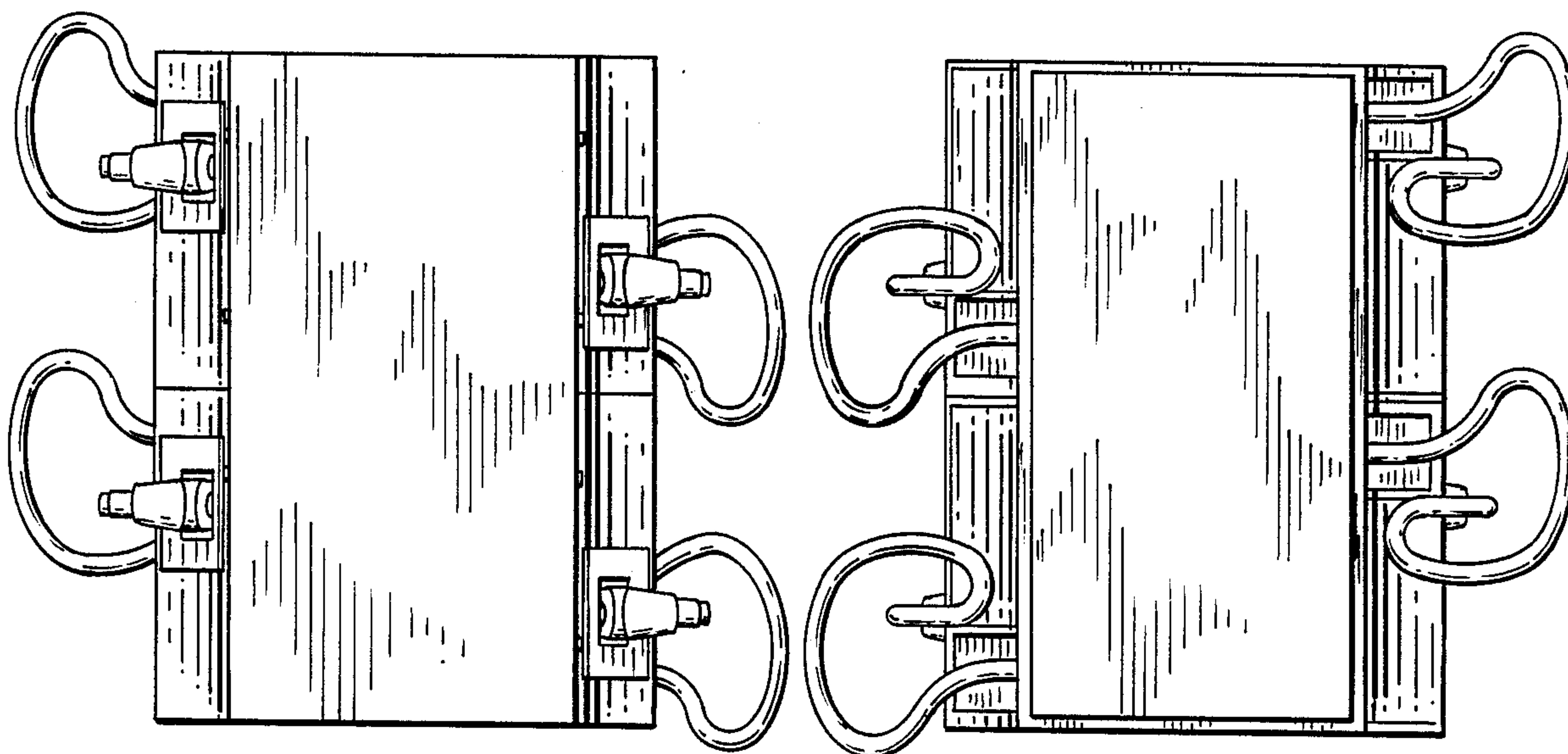
FIG. 15 is a bottom plan view thereof.







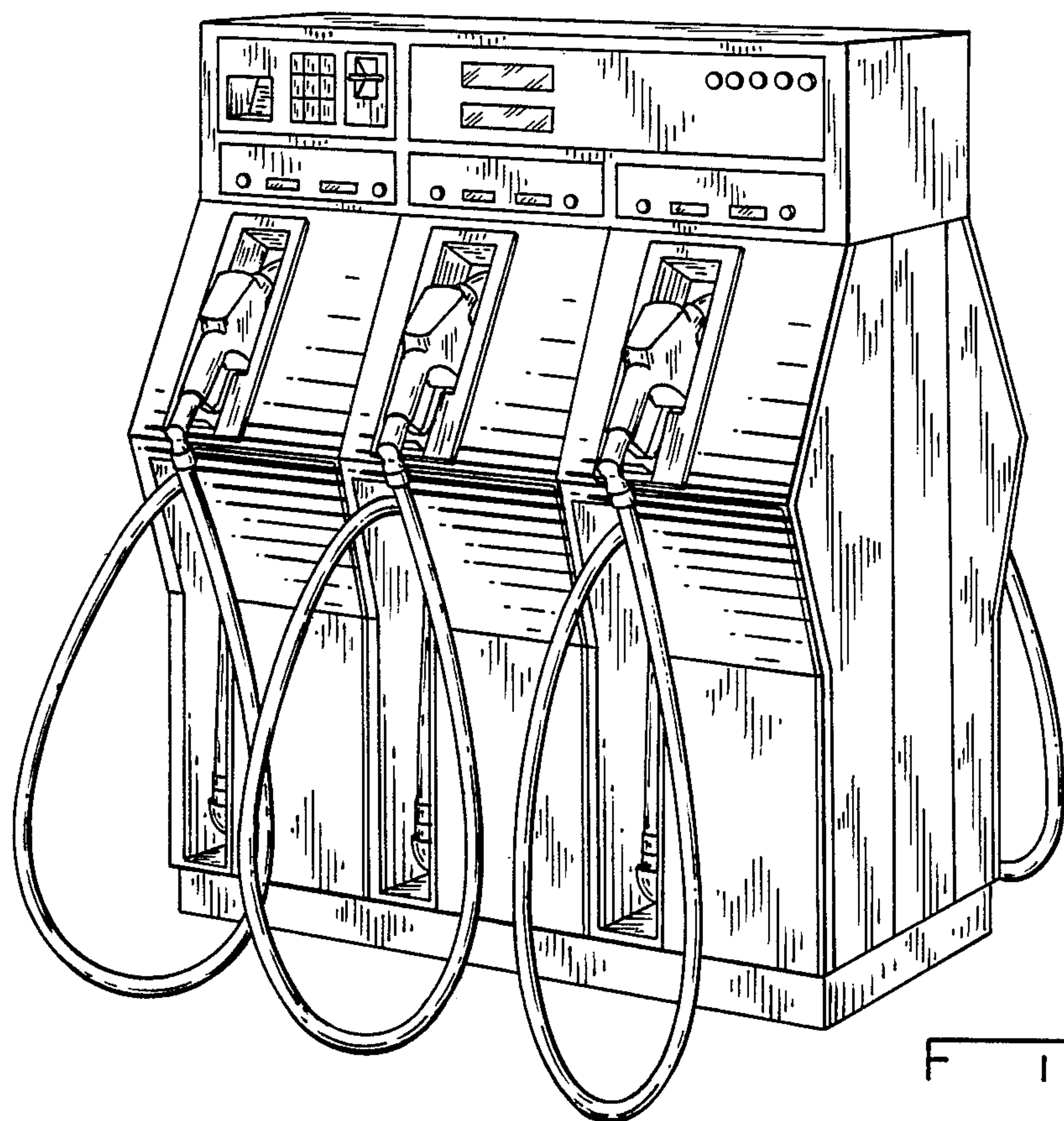

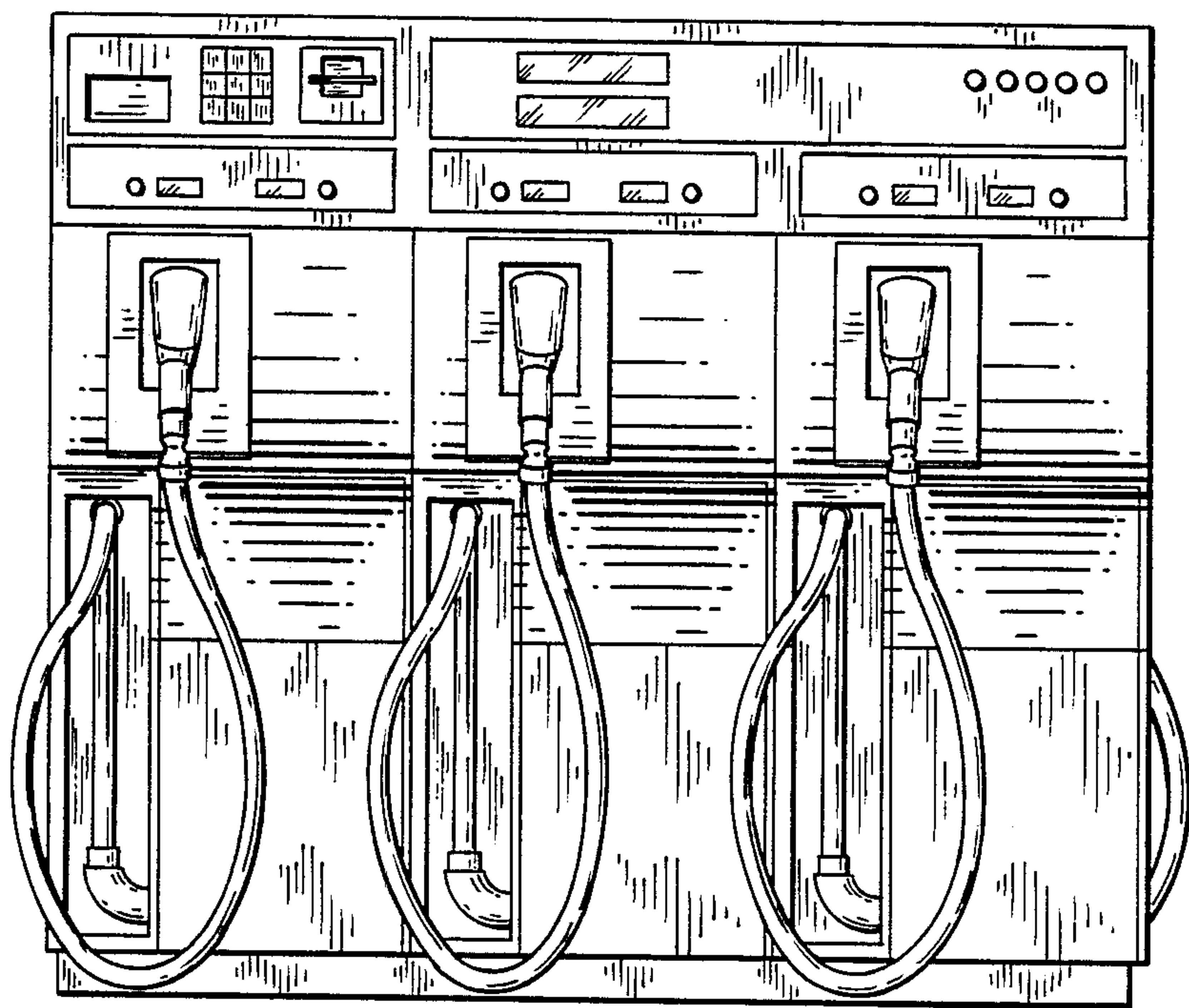

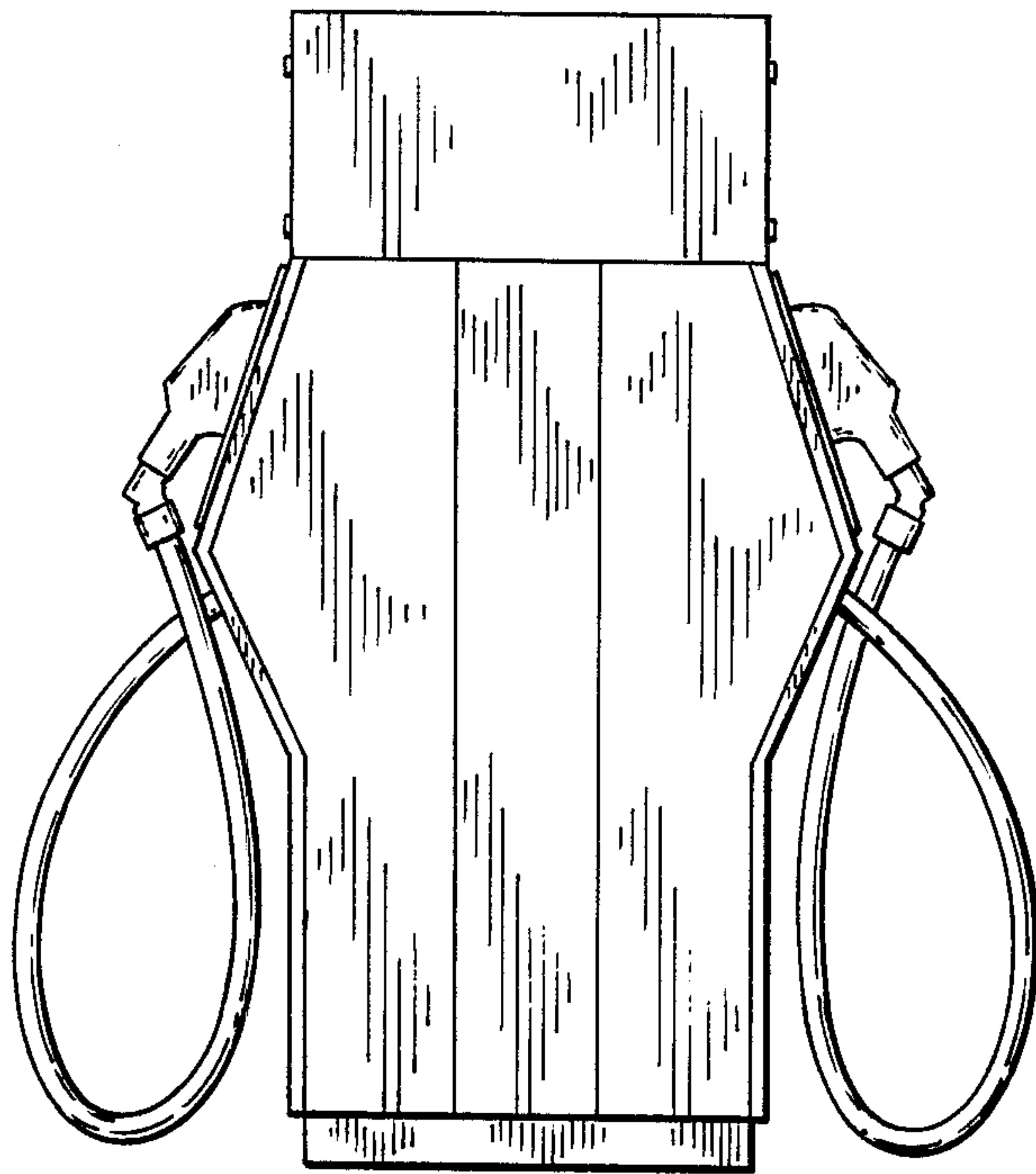




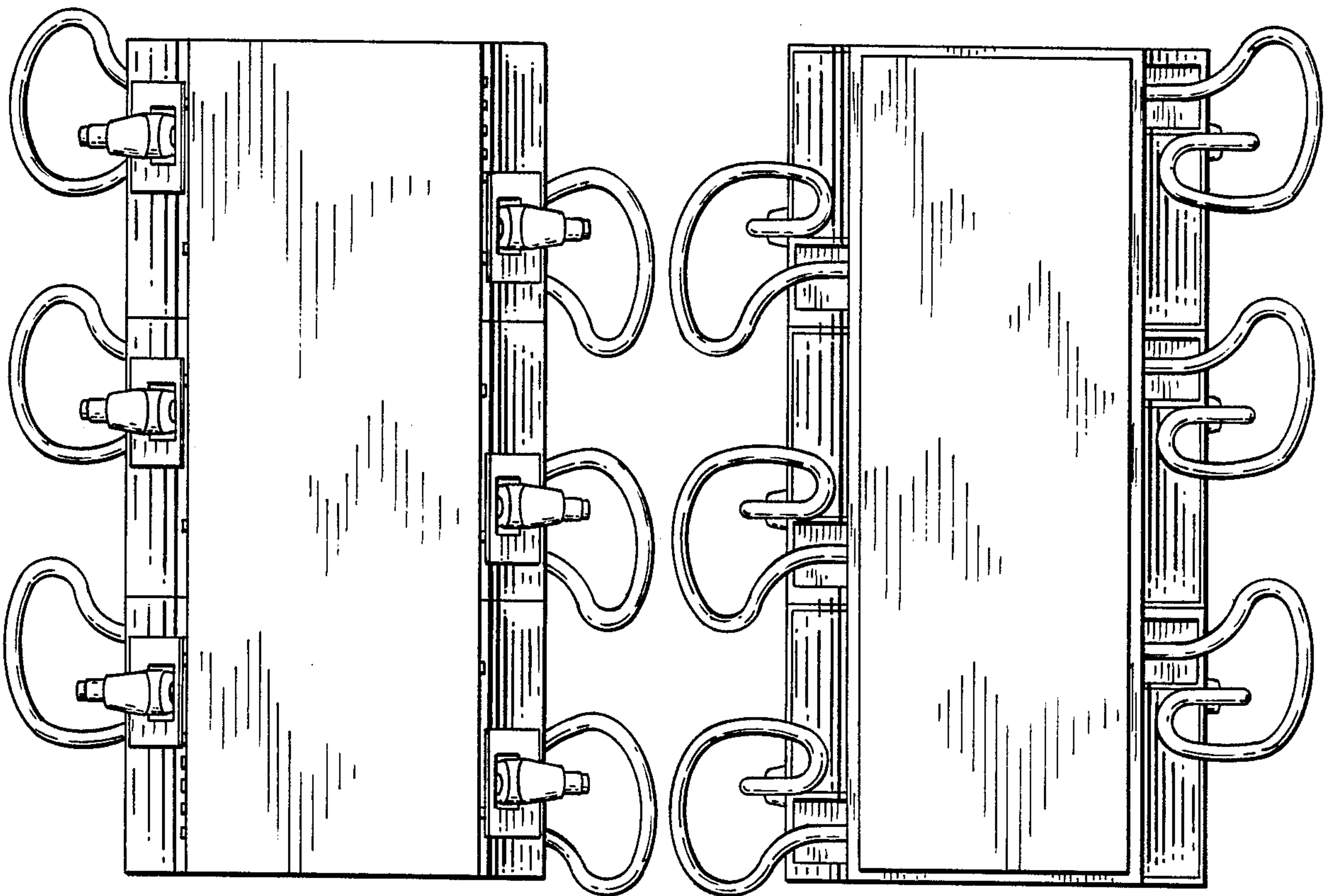

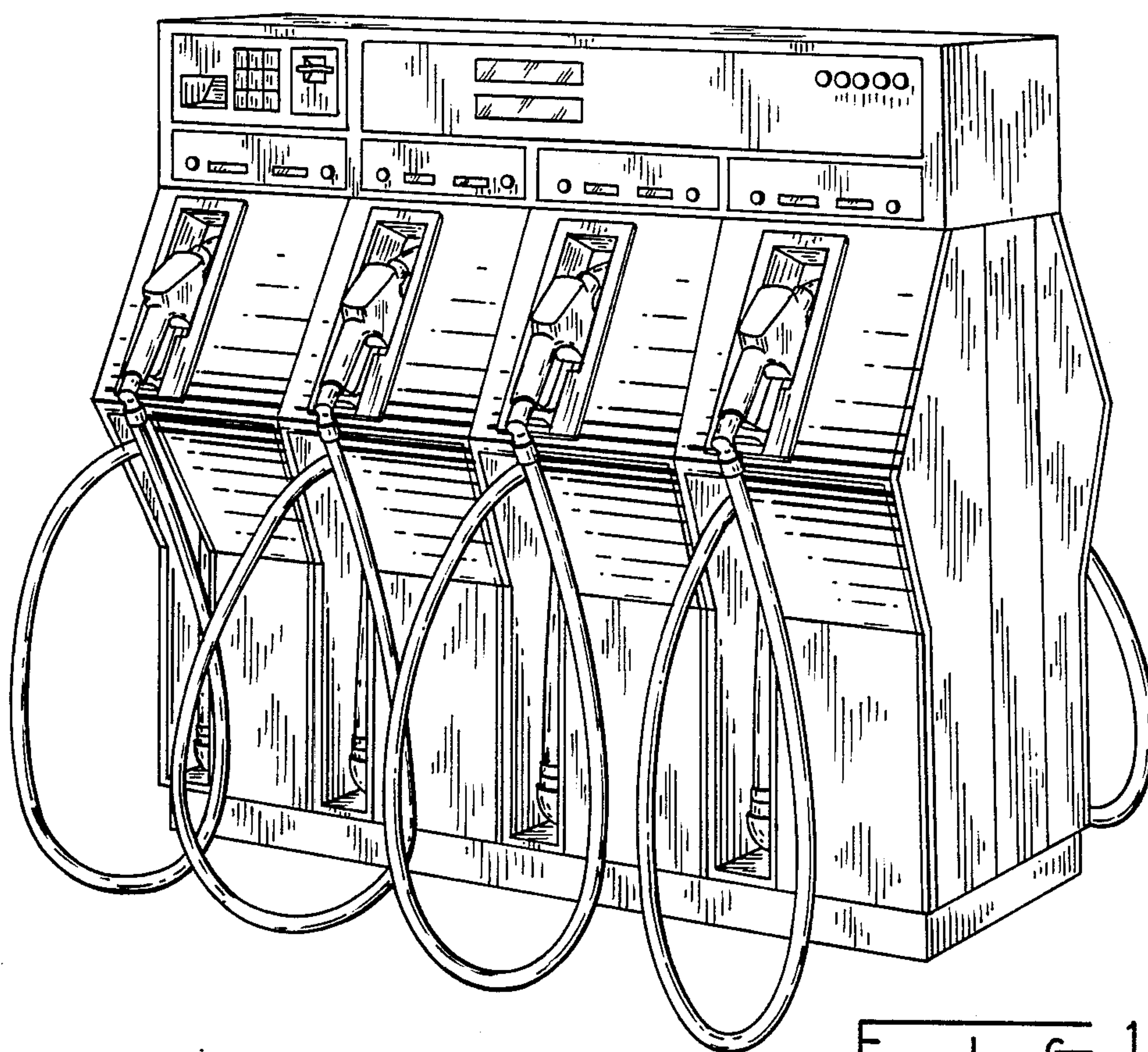

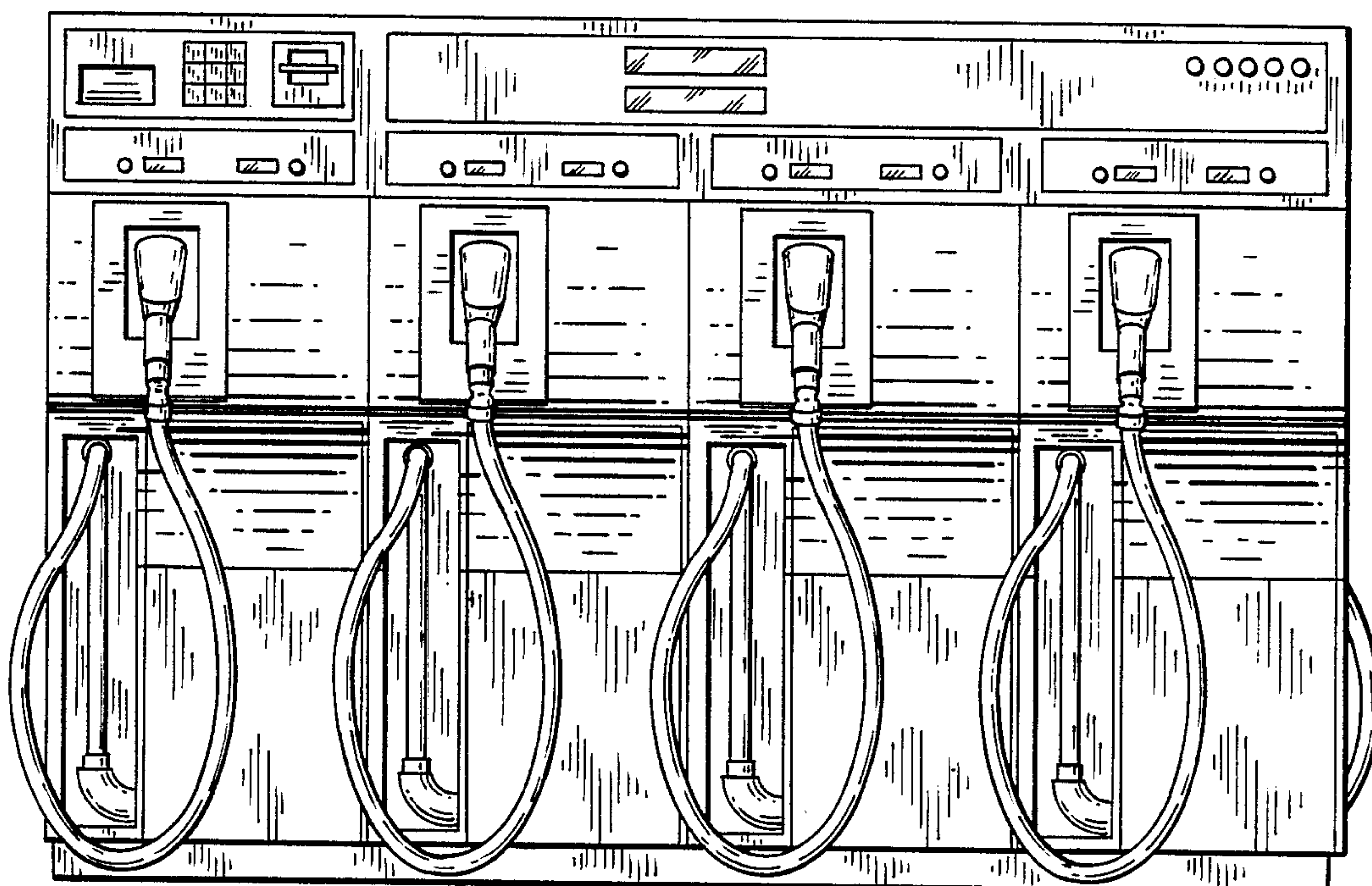
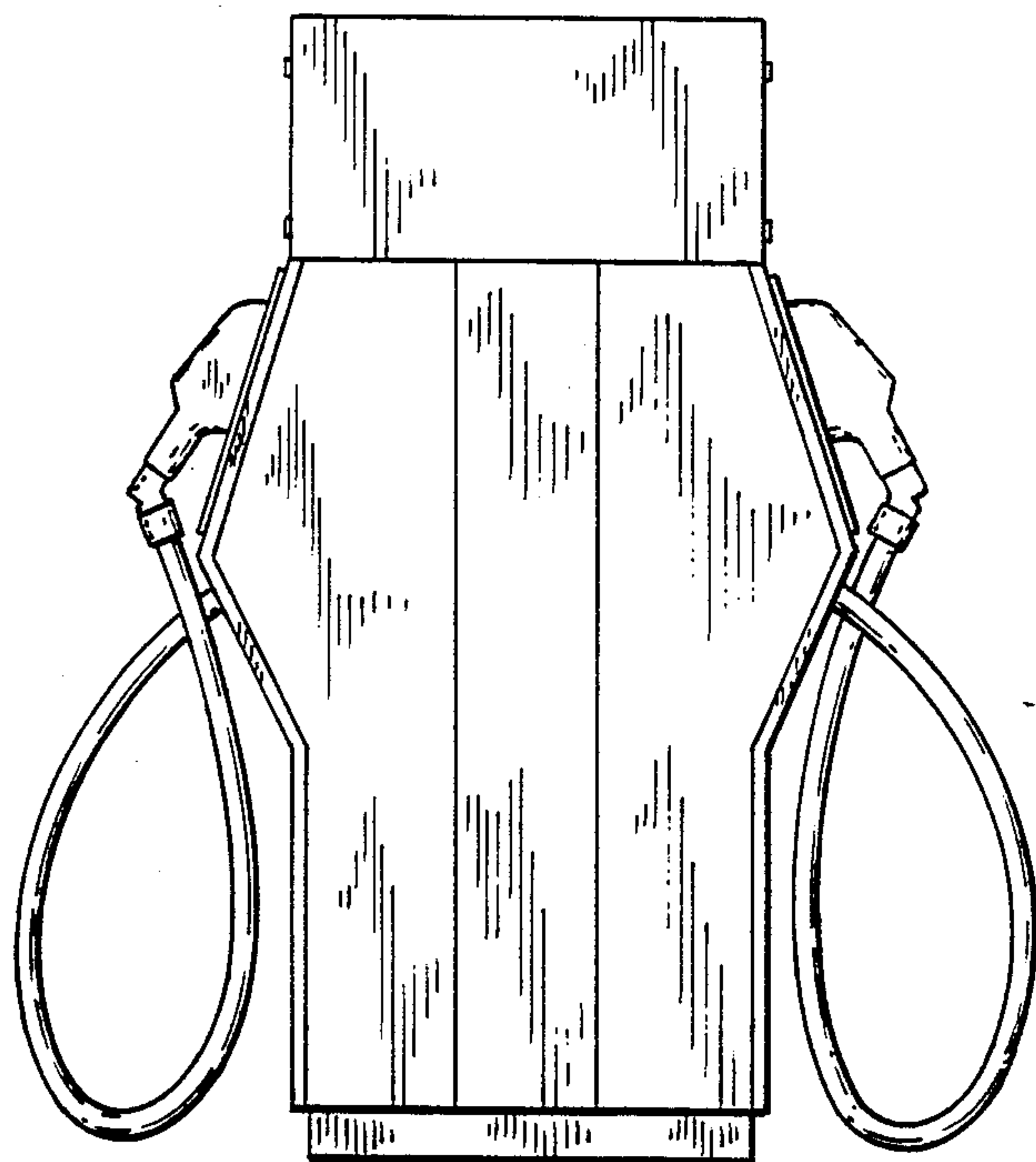
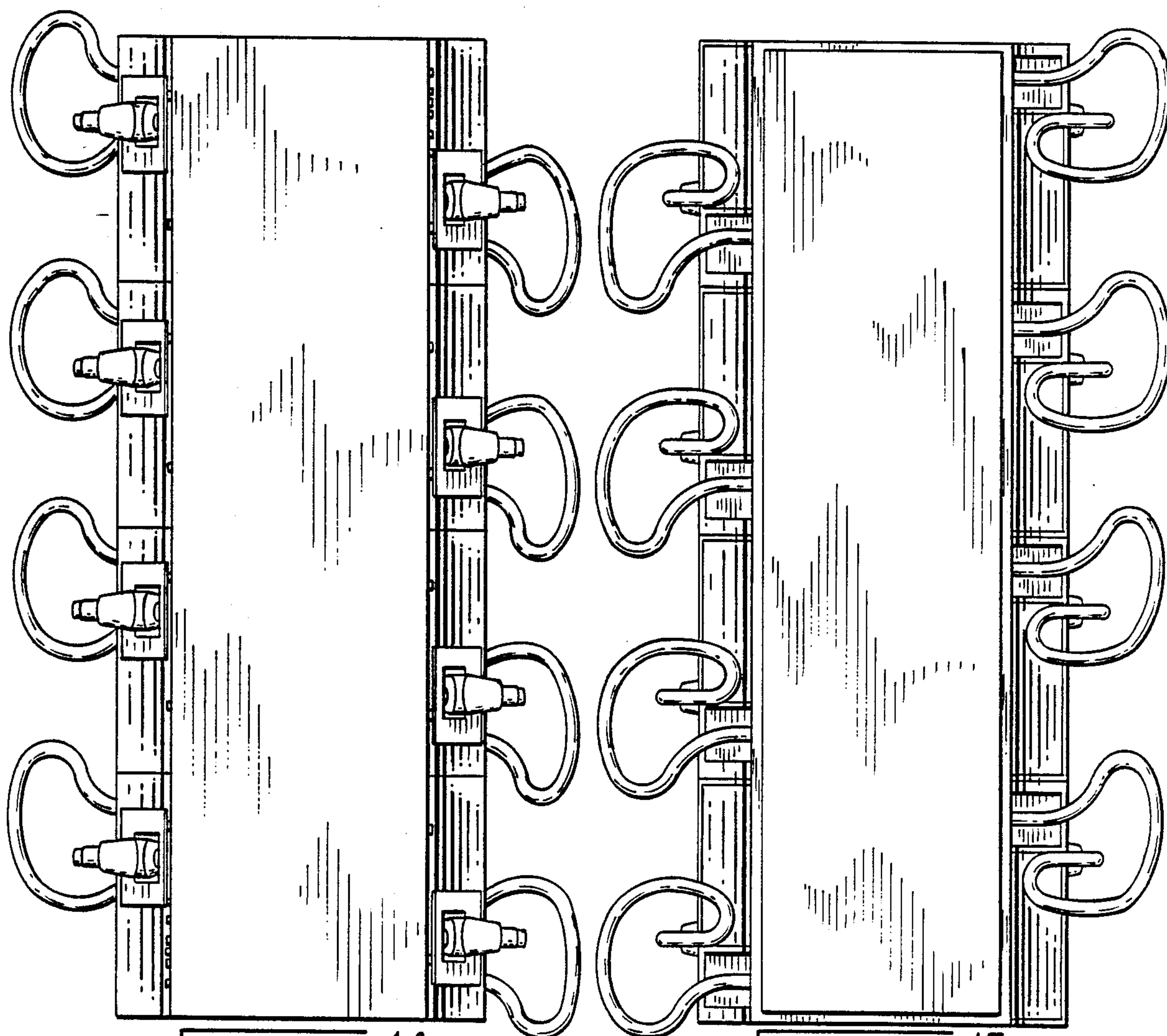
