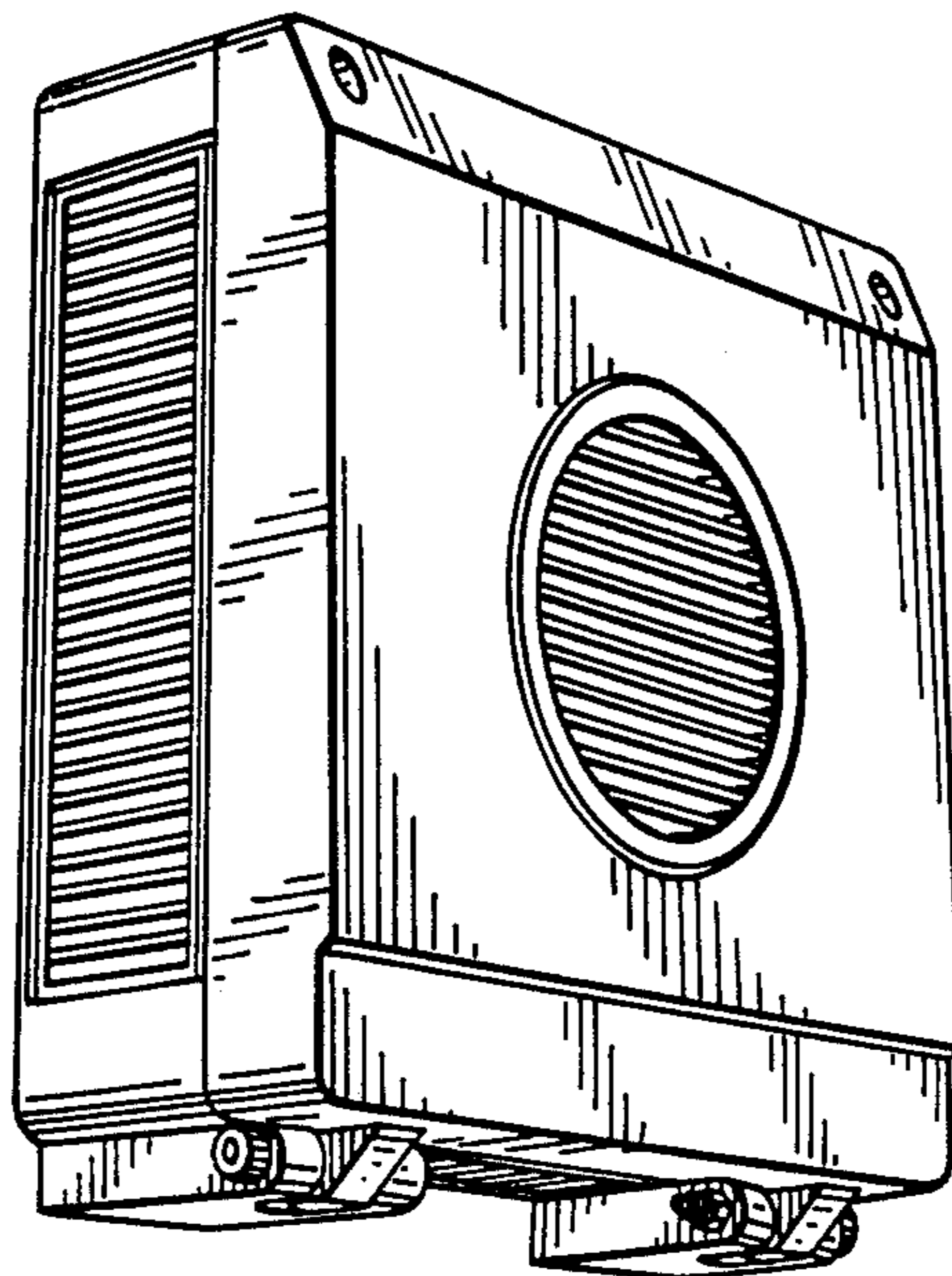

The ornamental design for a housing for brake mechanism for an industrial machine, as shown.

DESCRIPTION

FIG. 1 is a rear elevation view of a housing for brake mechanism for an industrial machine showing my new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a side elevation view thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is an opposite side elevation view thereof;
FIG. 6 is a bottom, front perspective view thereof;
FIG. 7 is a perspective view of the front and one side thereof taken from below; and
FIG. 8 is a perspective view of the front and opposite side thereof taken from above.



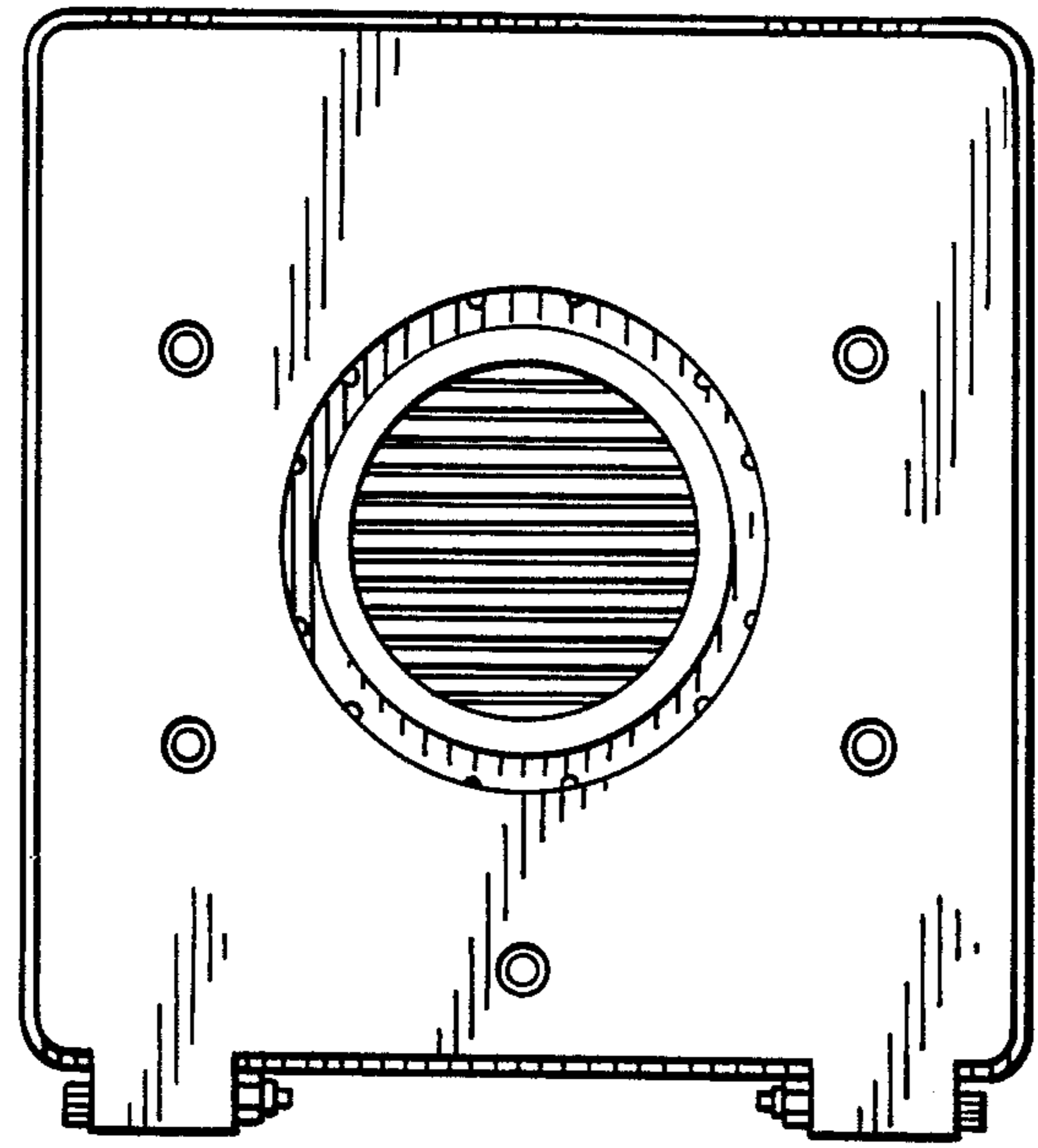

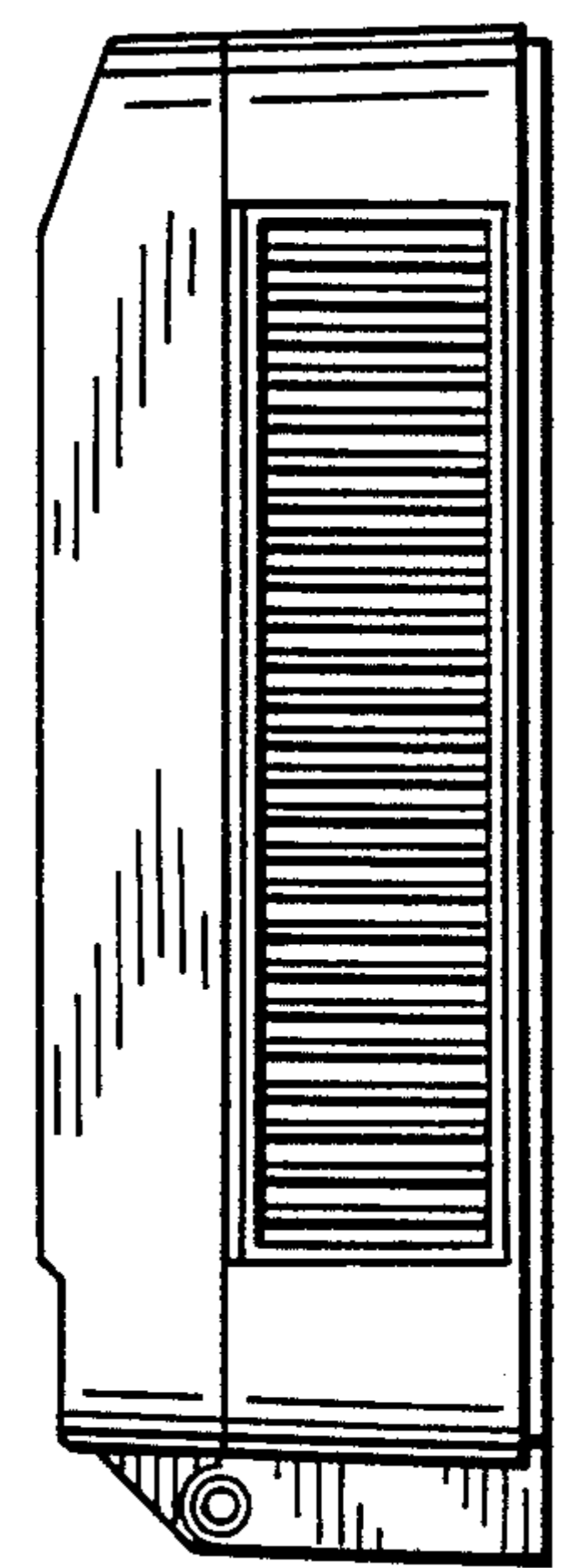

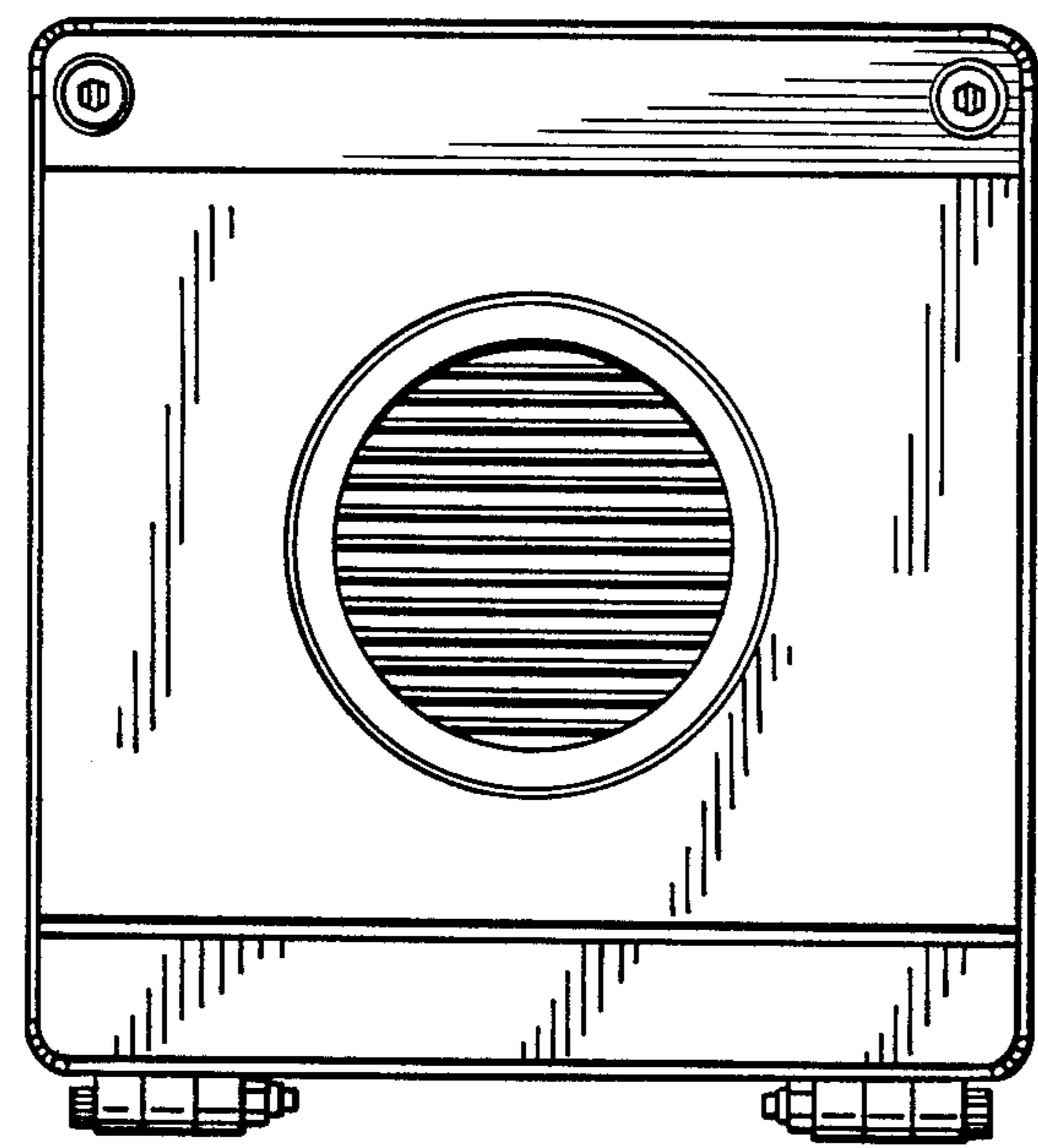

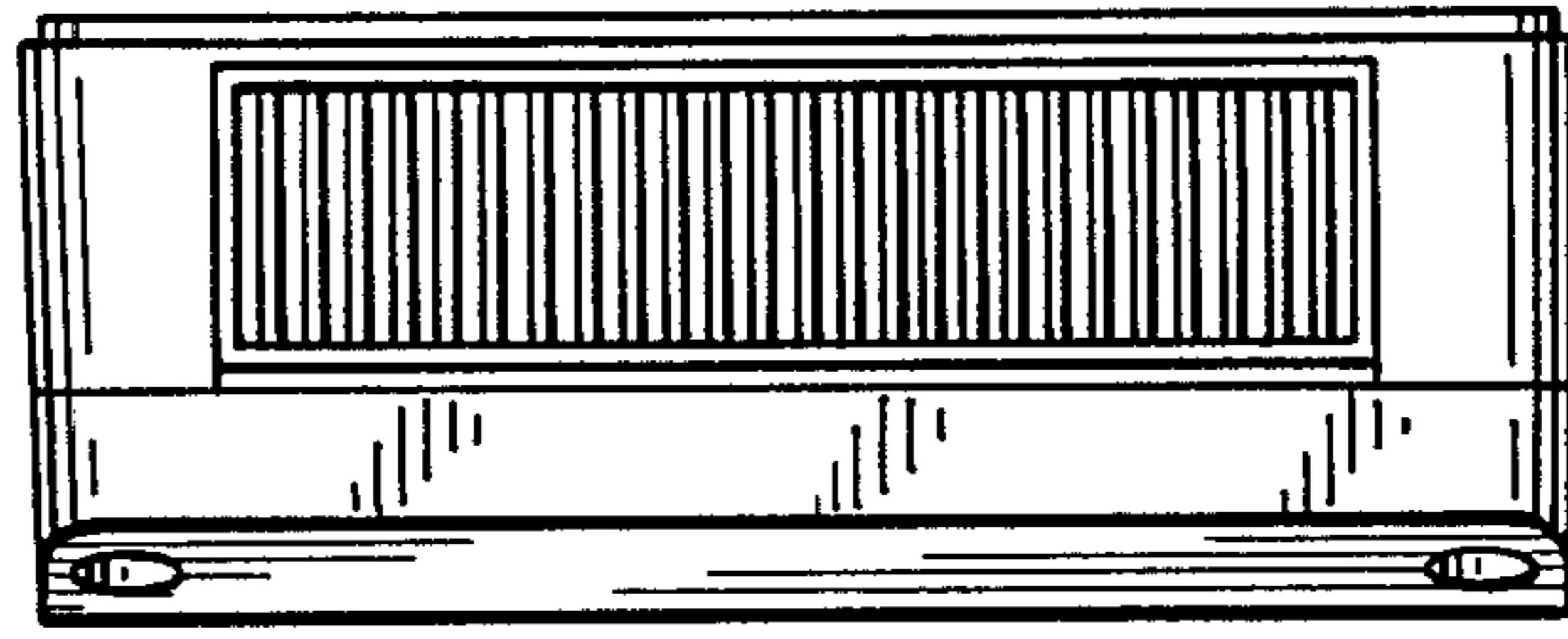

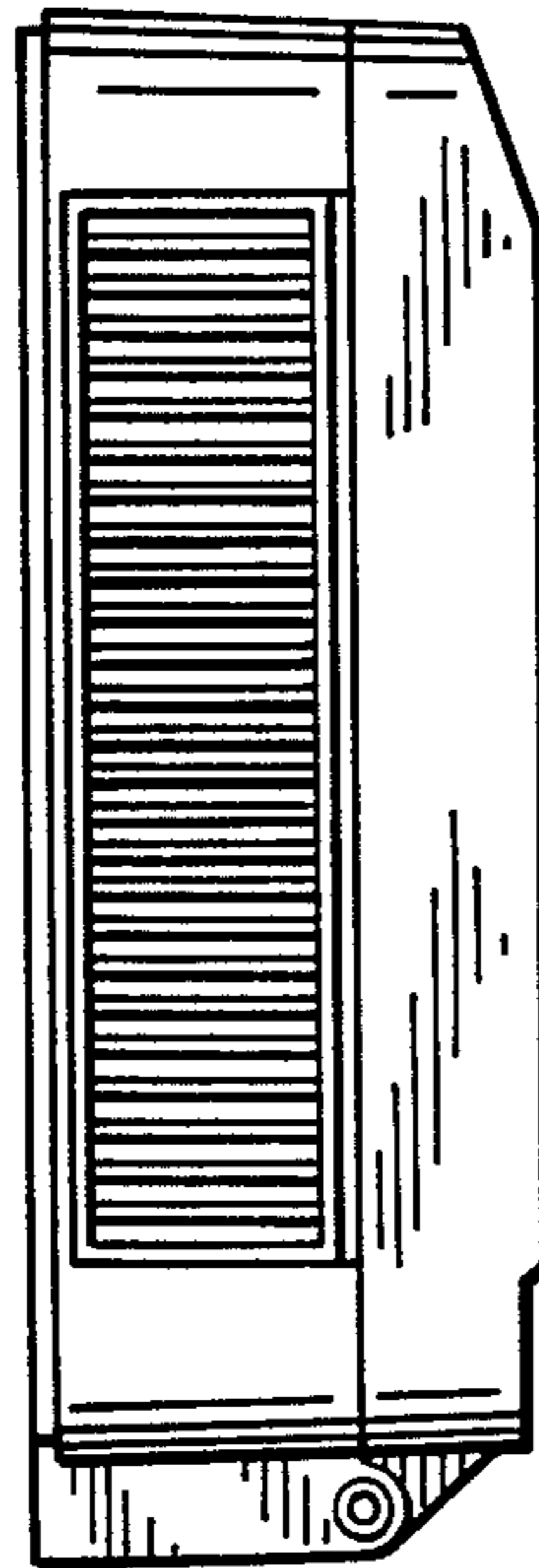

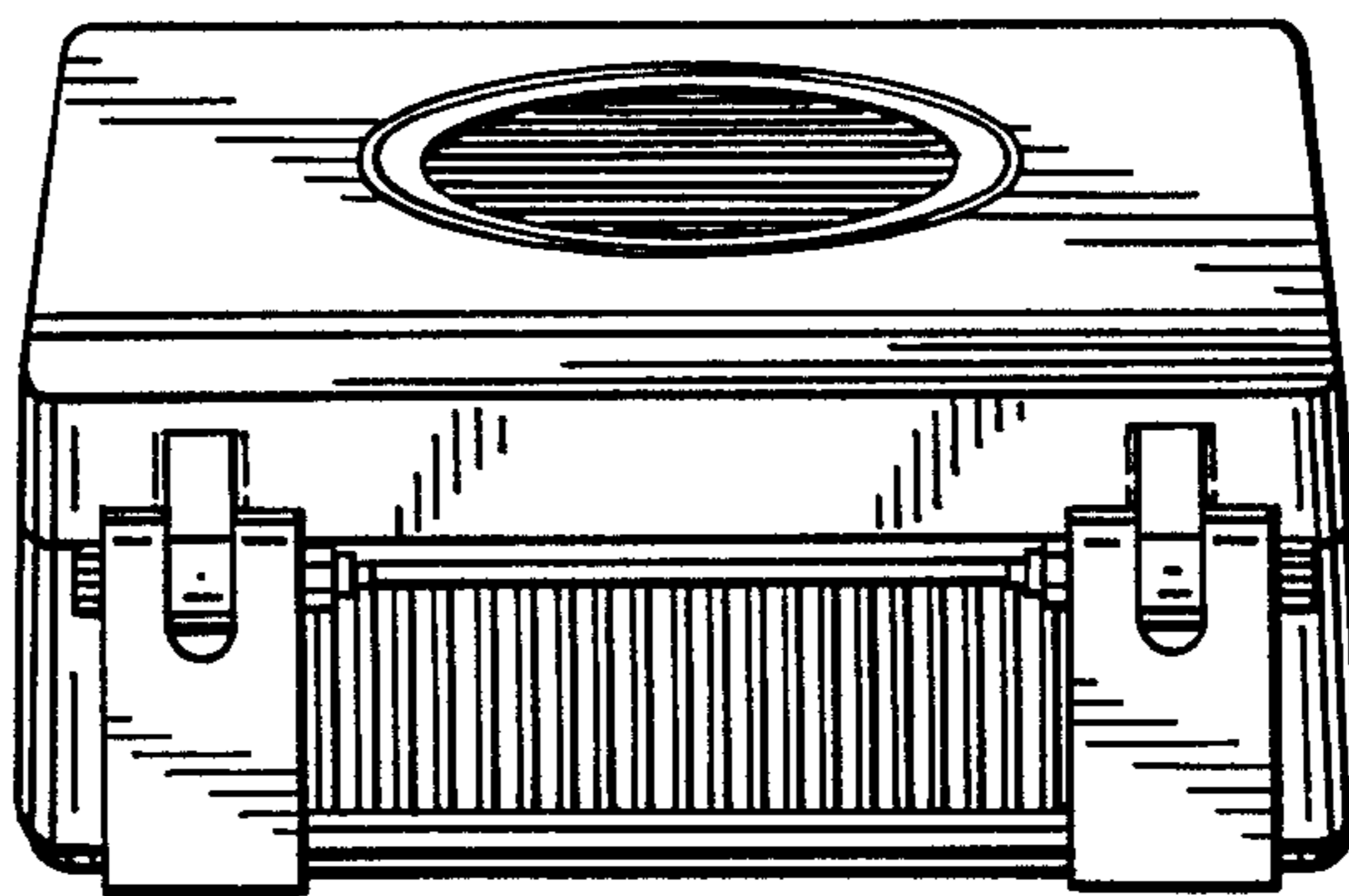

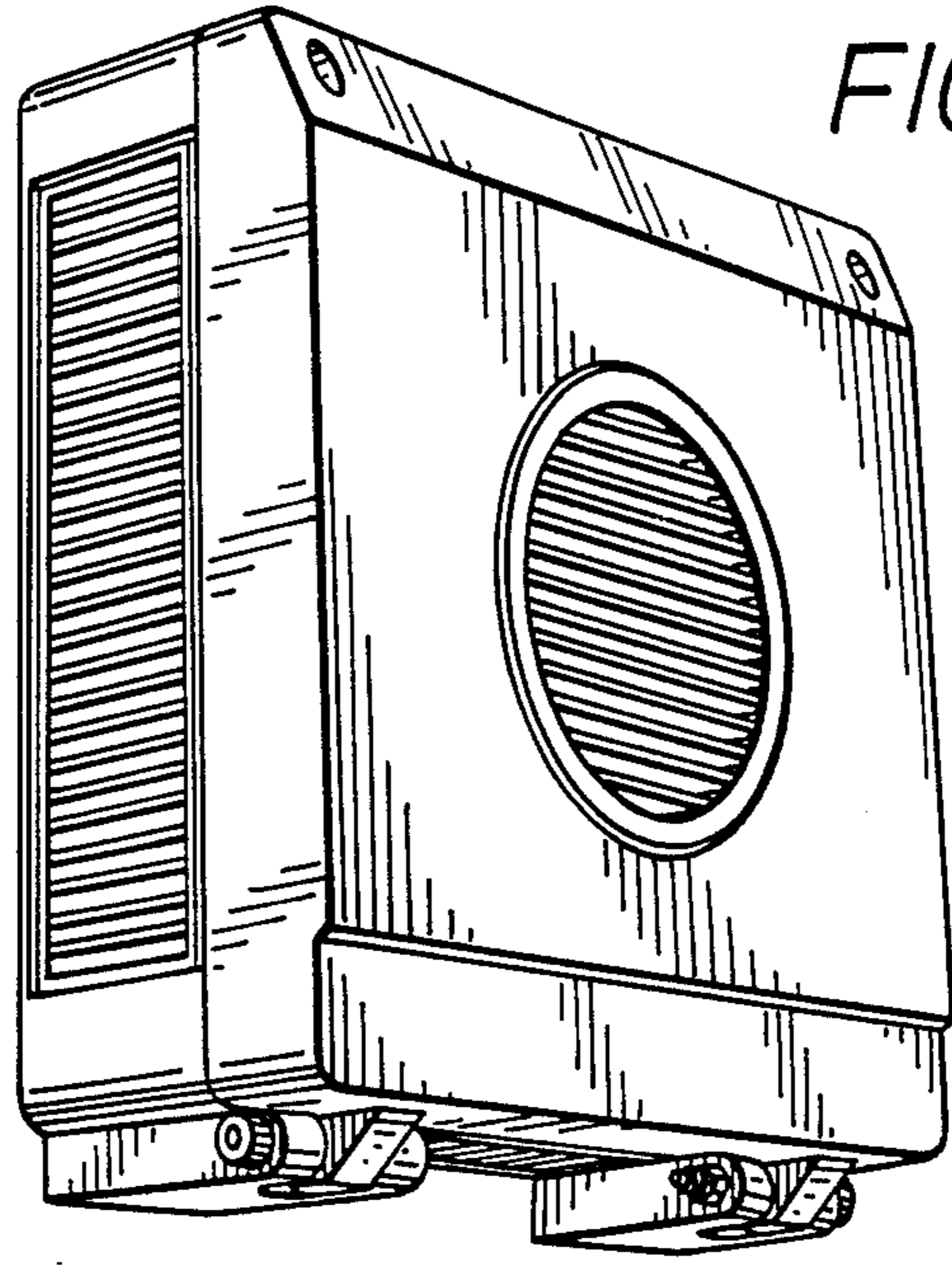

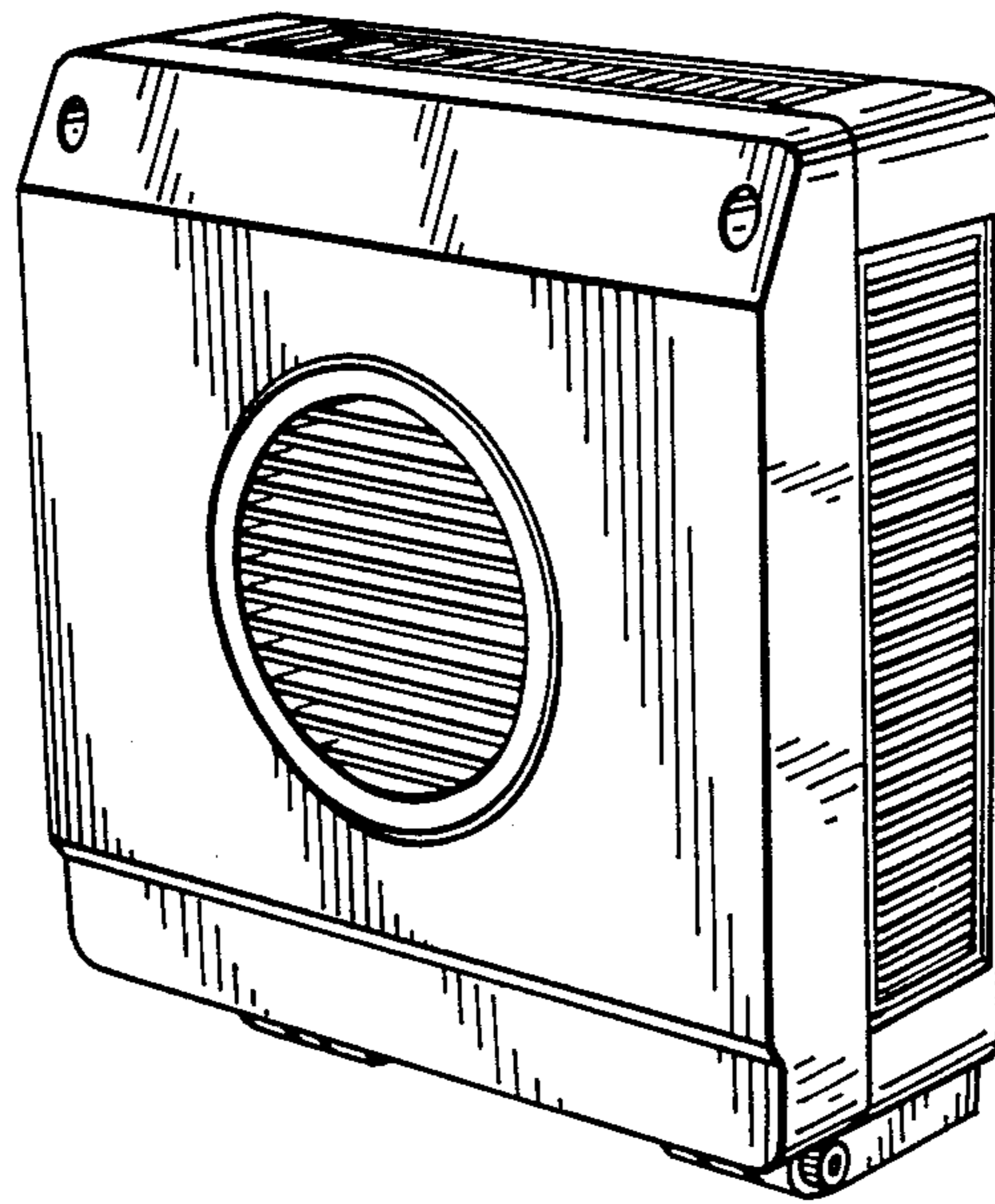
