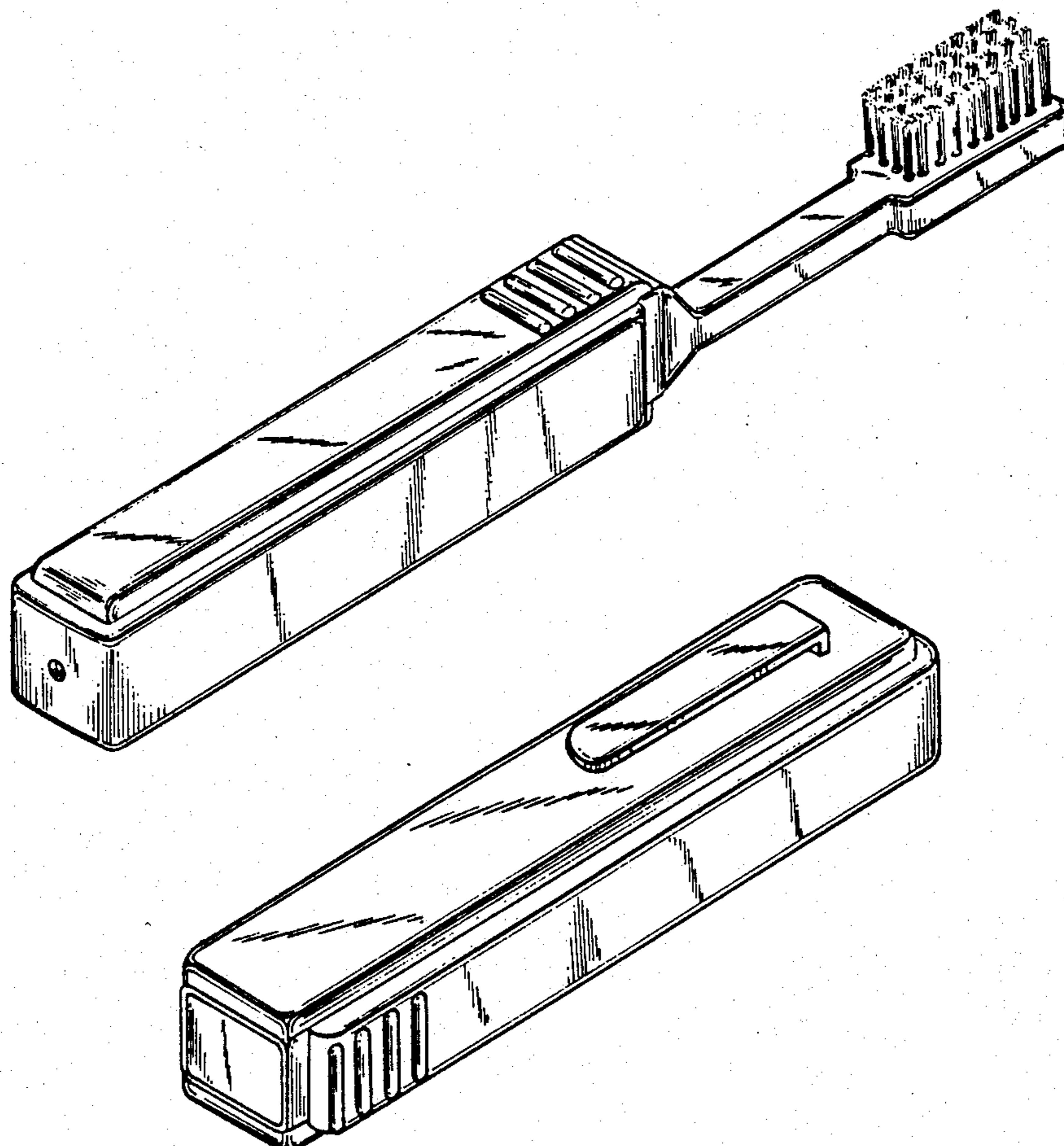

[57] CLAIM

The ornamental design for a combined toothbrush and container therefor, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a combined toothbrush and container therefor embodying my new design; FIG. 2 is a front side elevational view thereof; FIG. 3 is a rear side elevational view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a left end elevational view thereof; FIG. 7 is a right end elevational view thereof; FIG. 8 is a perspective view thereof, the container type handle shown in partially open condition; FIG. 9 is a perspective view thereof, shown with the toothbrush enclosed in the container portion; FIG. 10 is a front side elevational view thereof; FIG. 11 is a rear side elevational view thereof; FIG. 12 is a top plan view thereof; FIG. 13 is a bottom plan view thereof; FIG. 14 is a left end elevational view thereof; and FIG. 15 is a right end elevational view thereof.



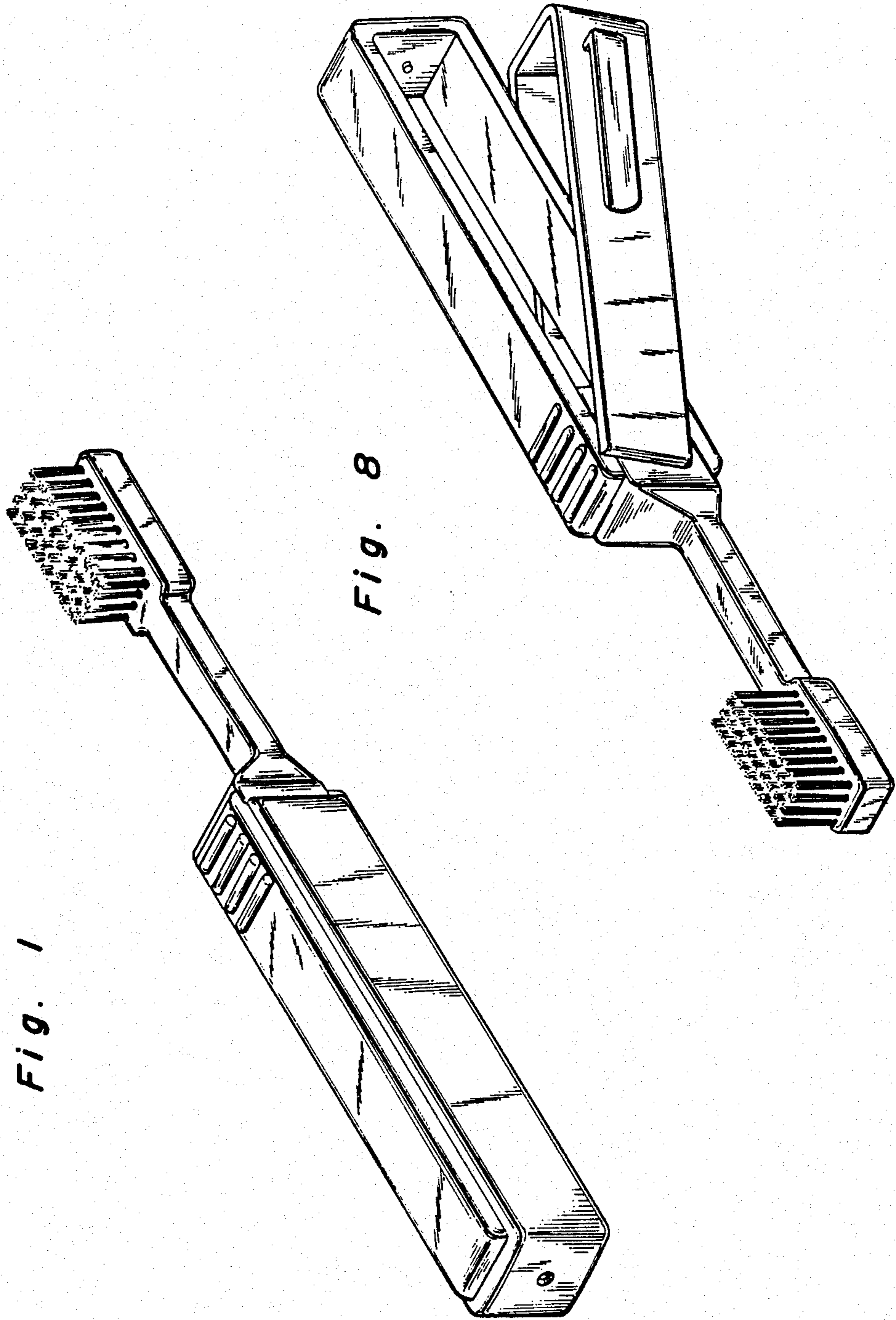

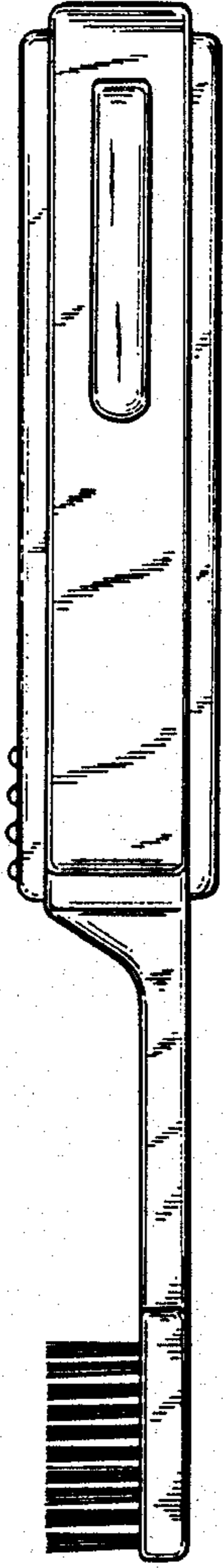

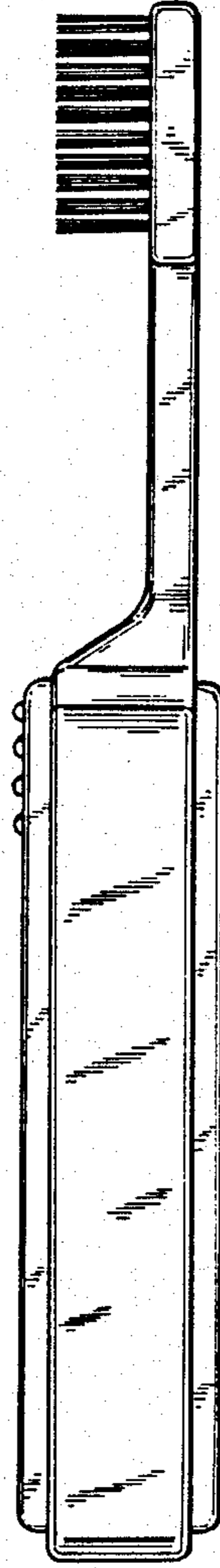

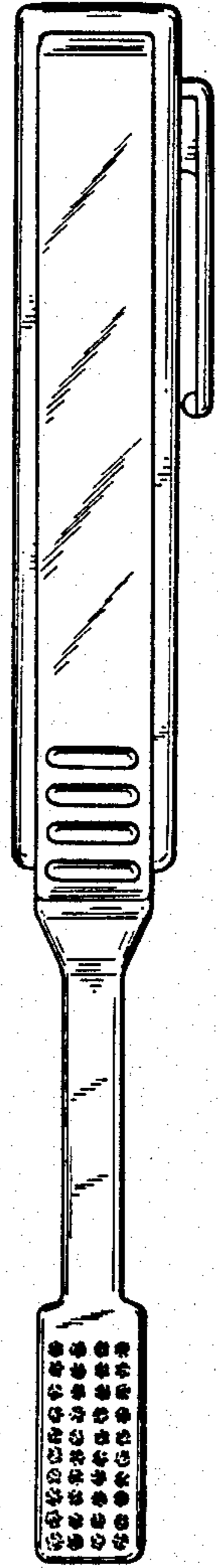

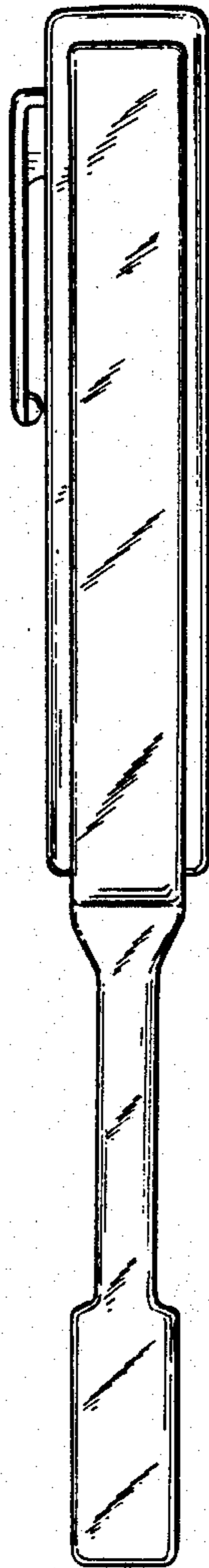

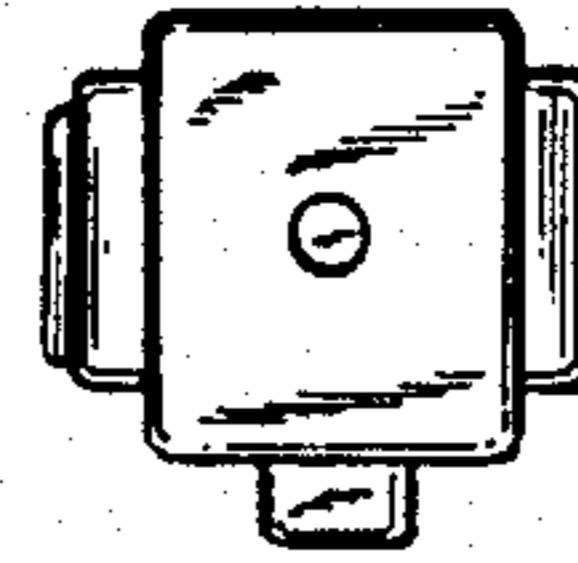

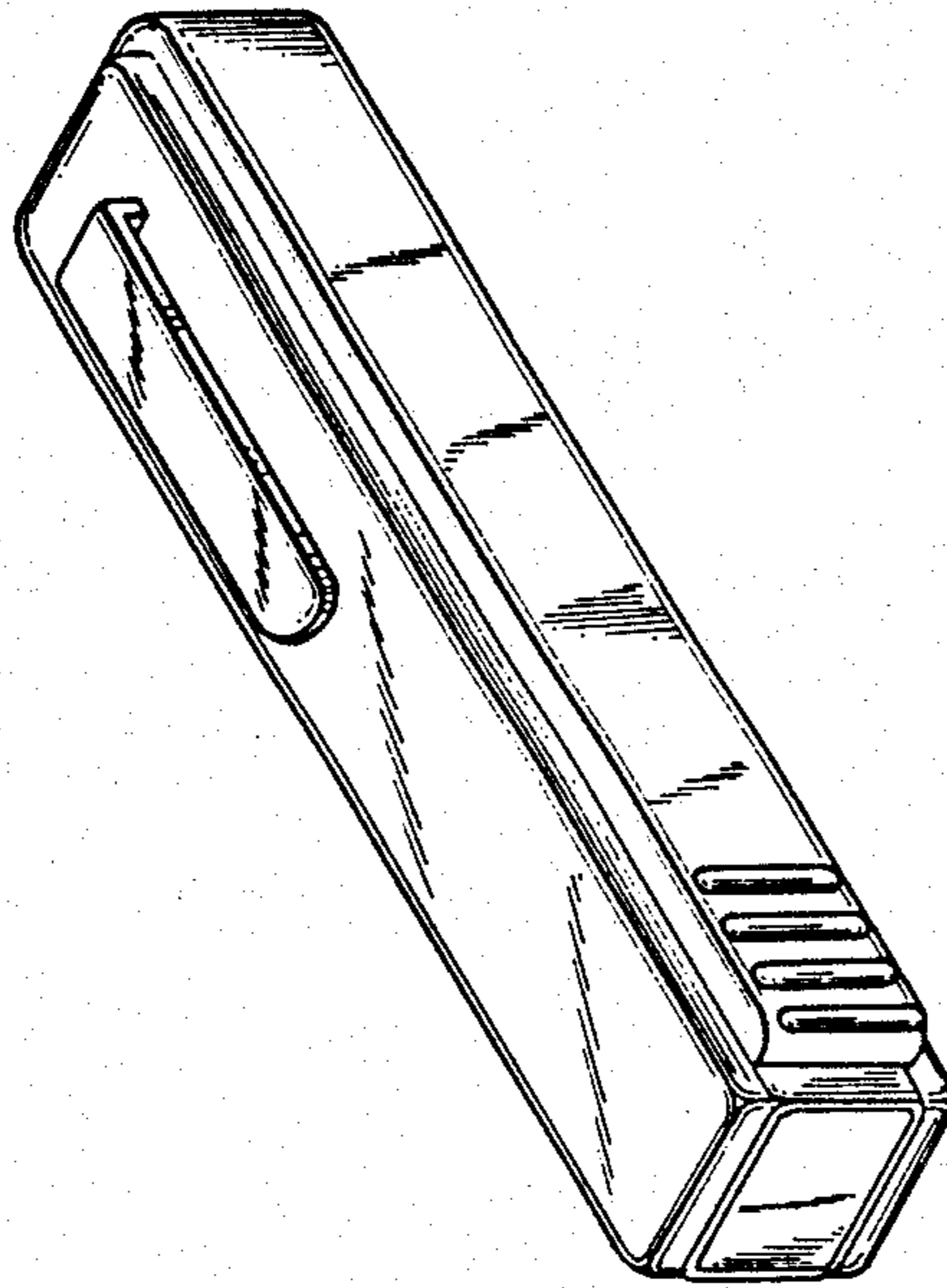

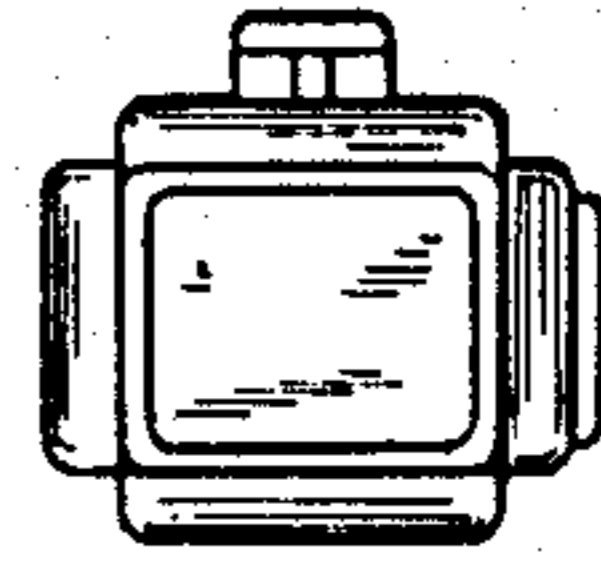

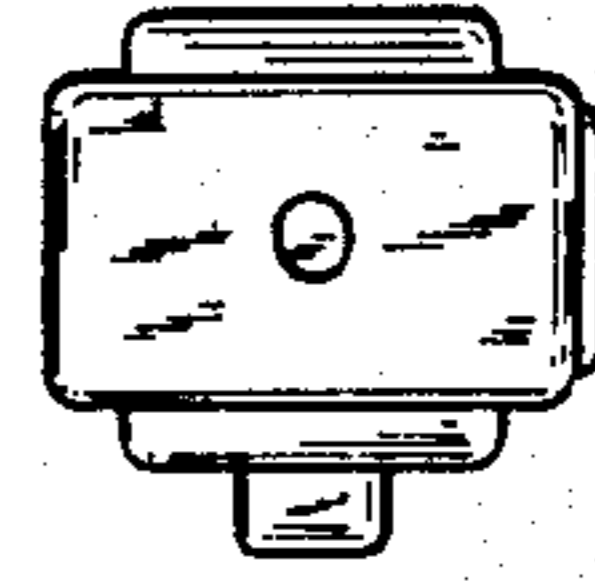

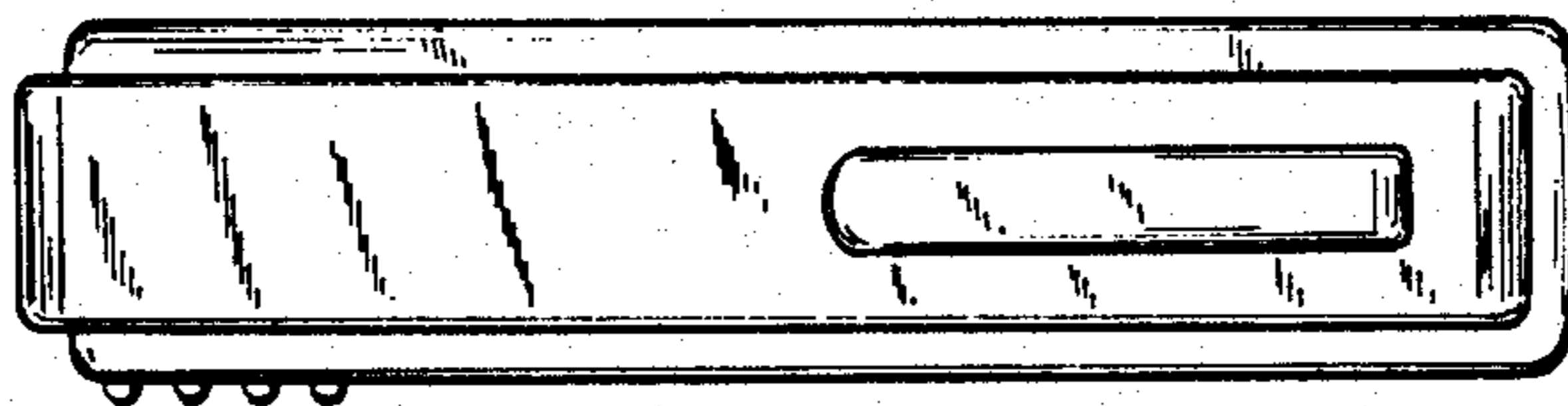

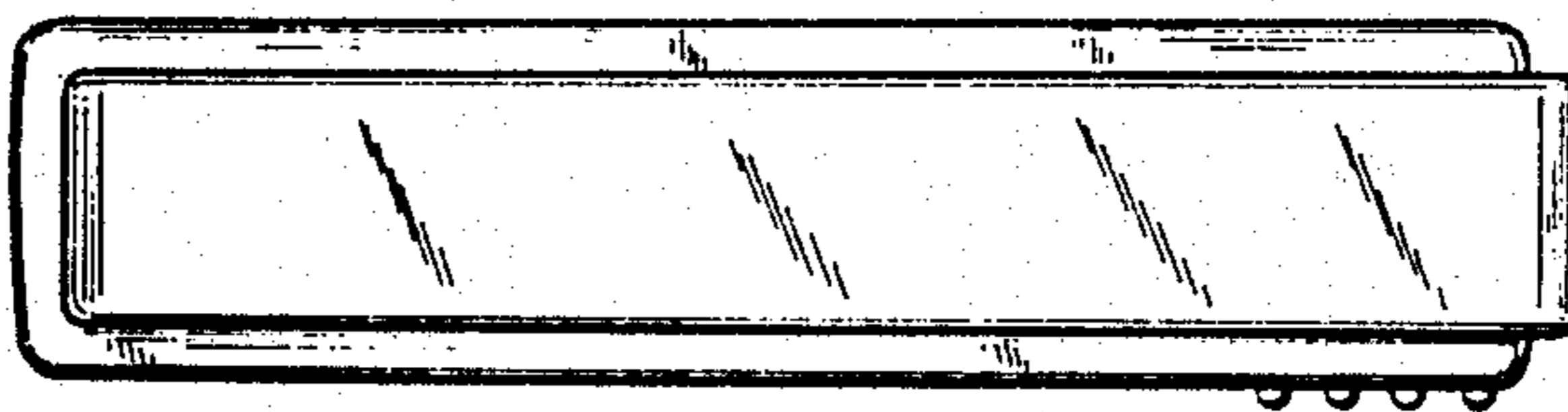

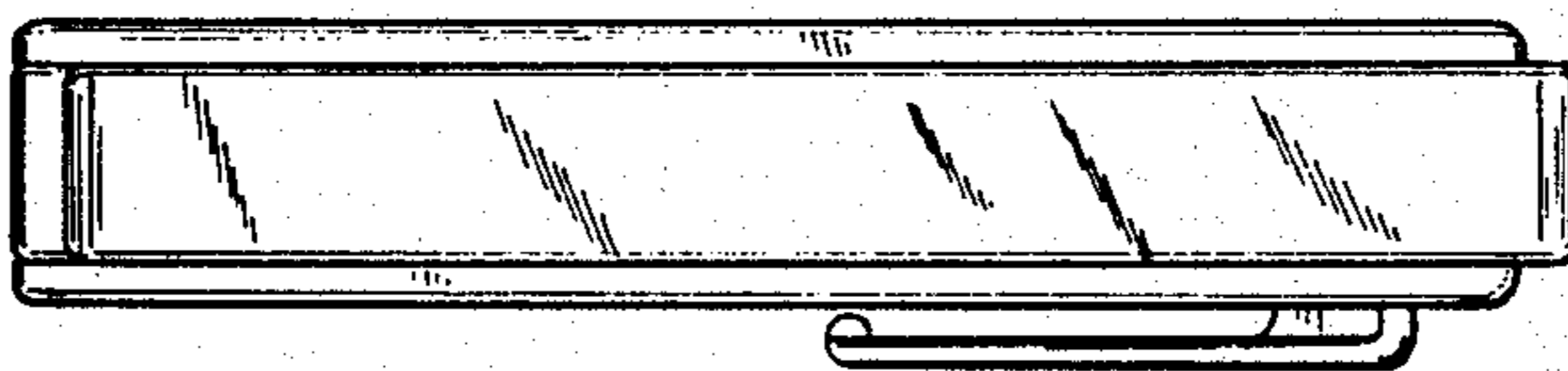
