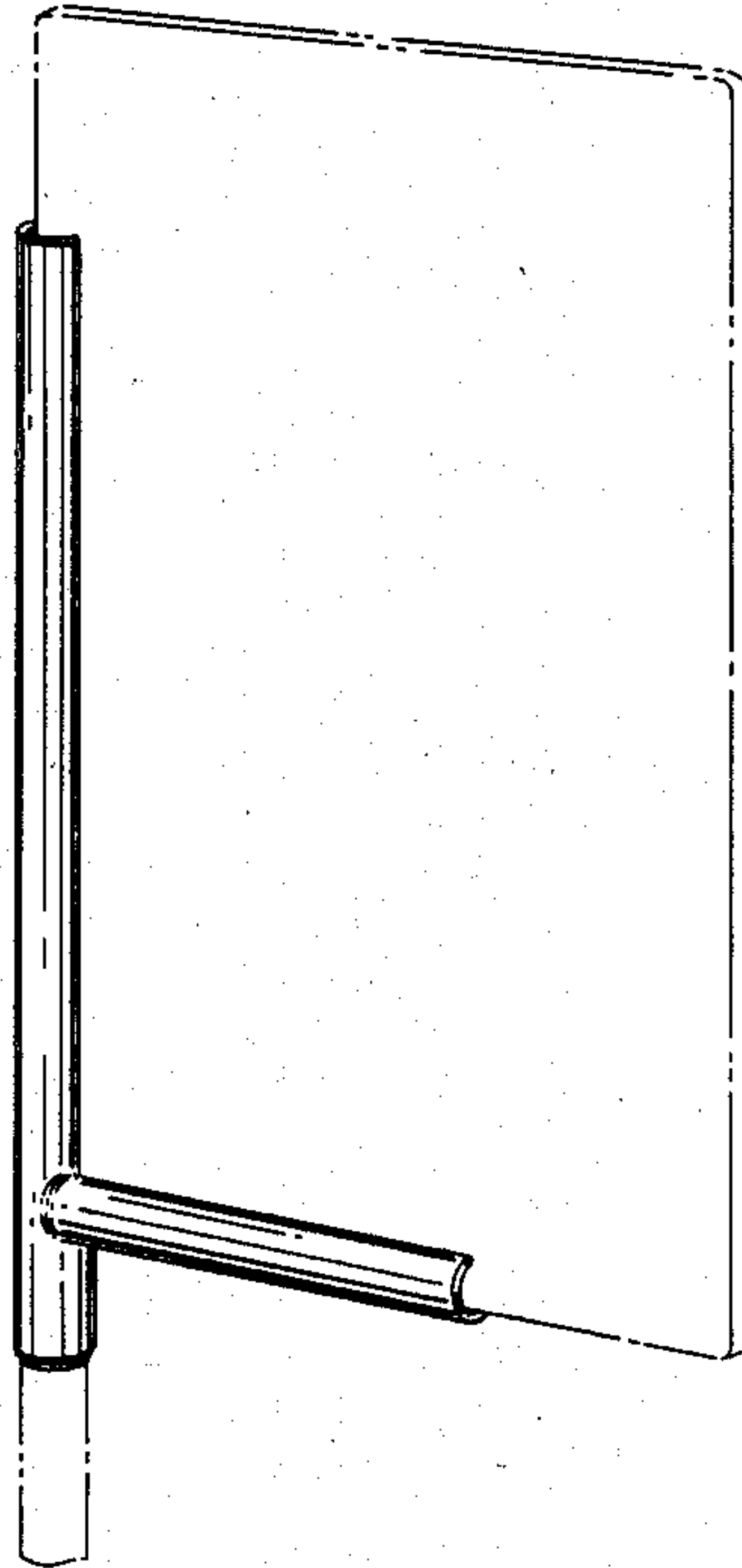

DESCRIPTION

FIG. 1 is a front perspective view of a bracket for a poster showing my new design;  
FIG. 2 is a front perspective view thereof with a poster shown in broken lines for illustrative purposes only;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a rear elevational view thereof.  
The stand is shown in broken lines for illustrative purposes only.



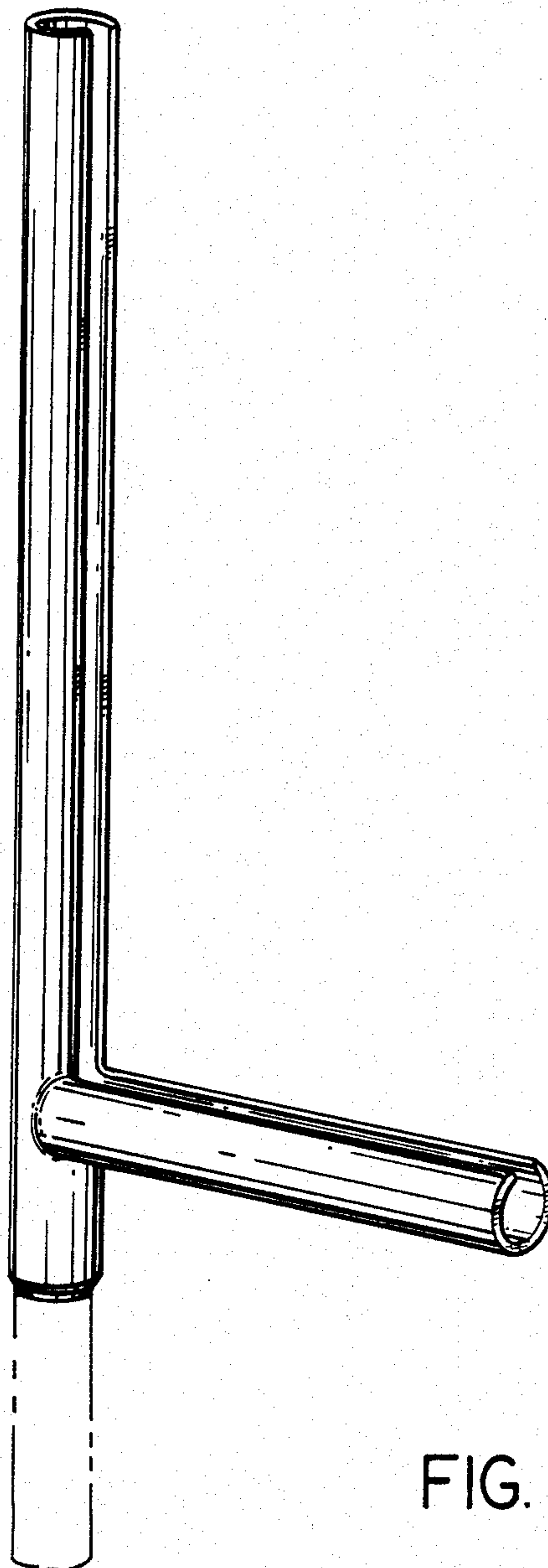

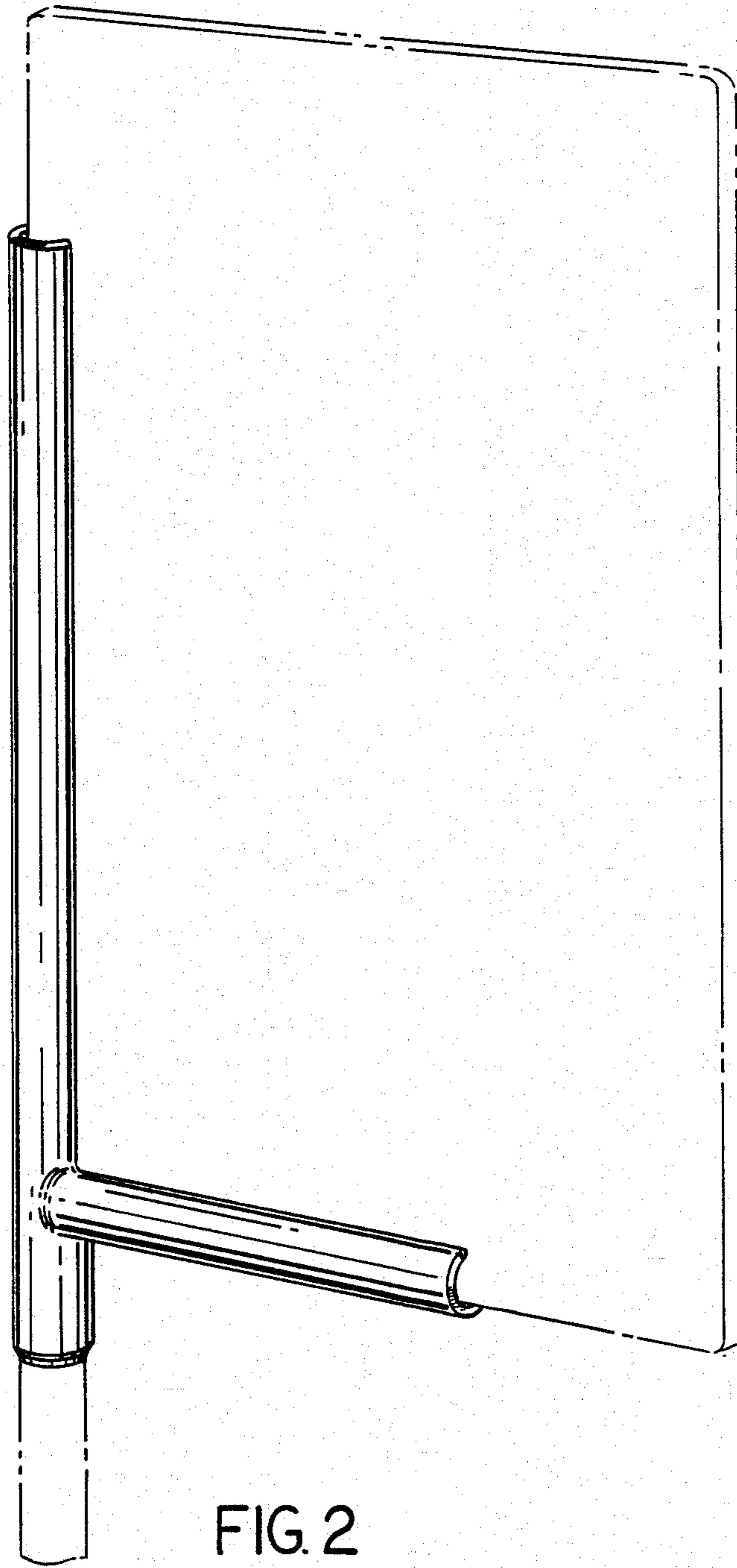

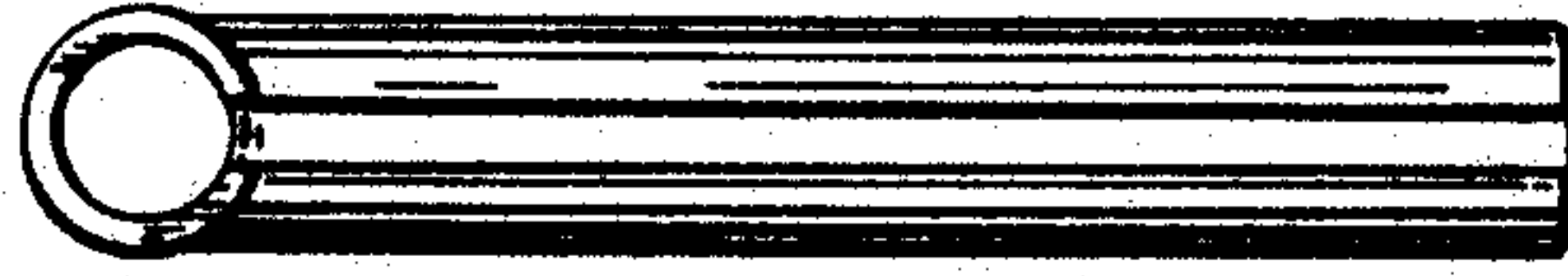

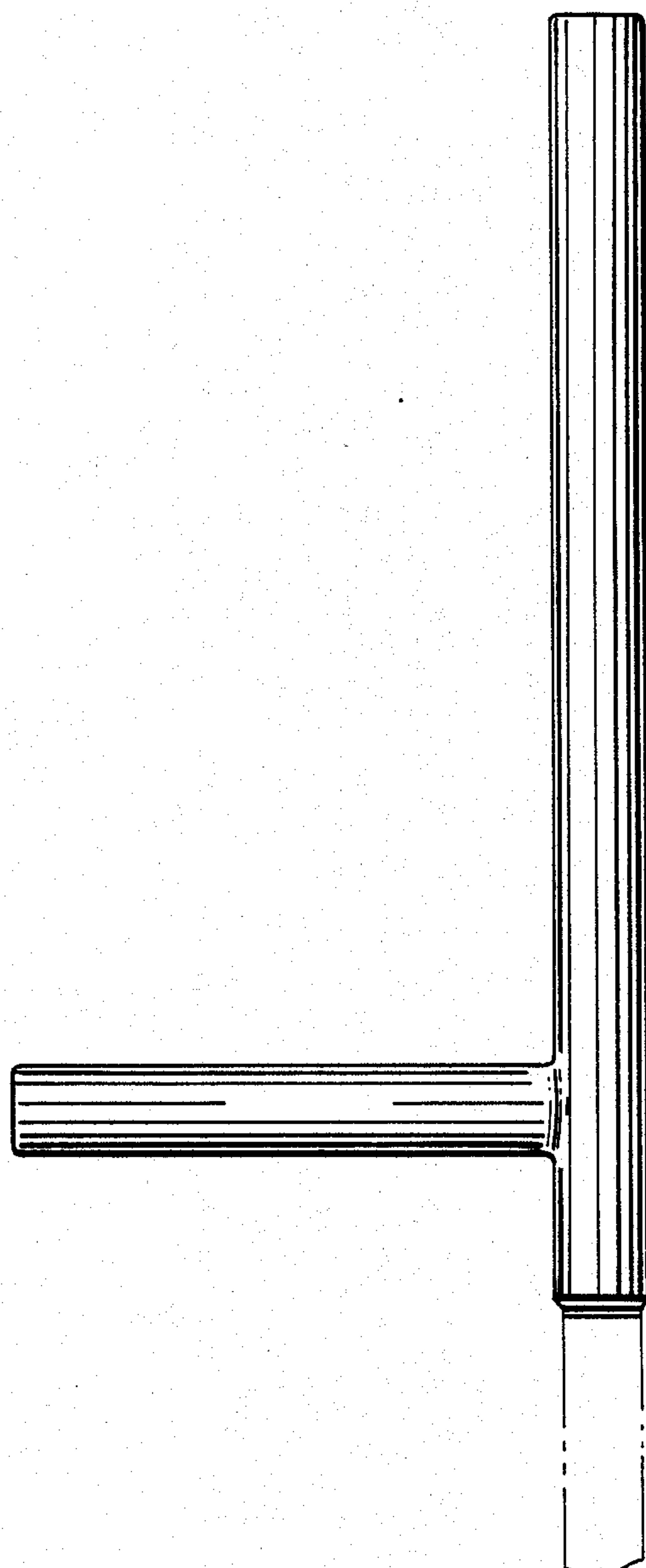
