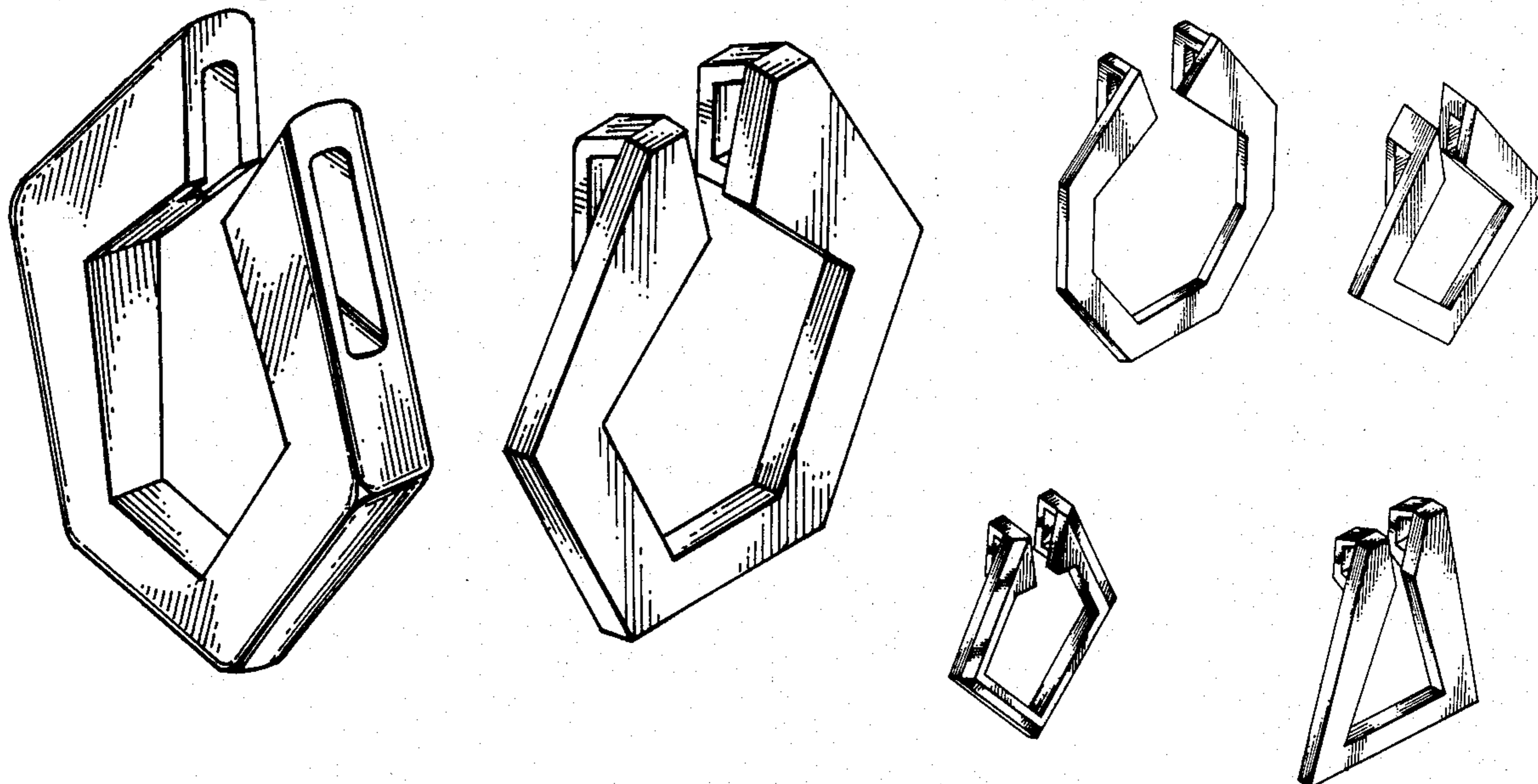
CLAIM

The ornamental design for a necklace pendant circlet, substantially as shown and described.

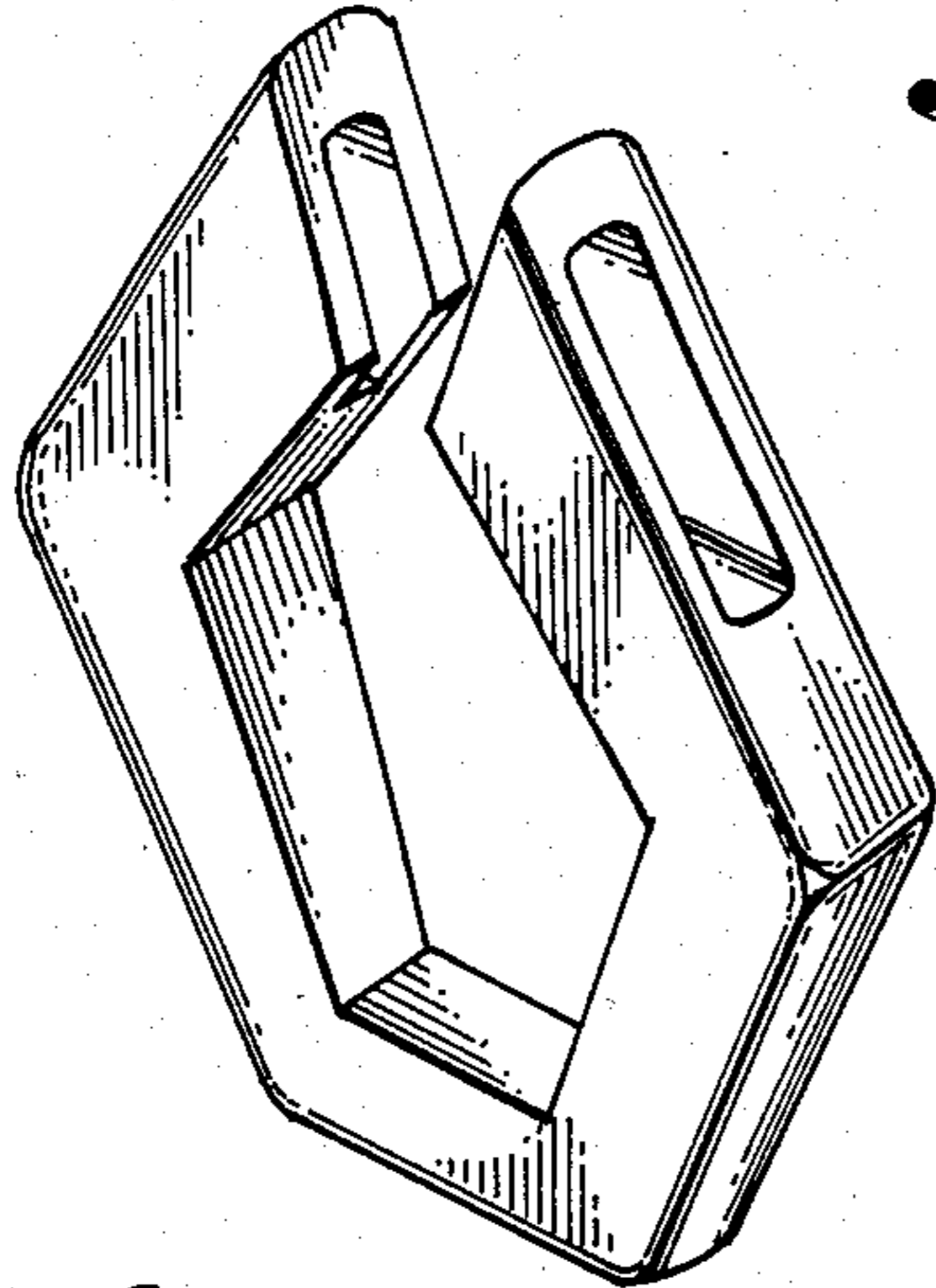
DESCRIPTION

FIG. 4 is a bottom plan view thereof;

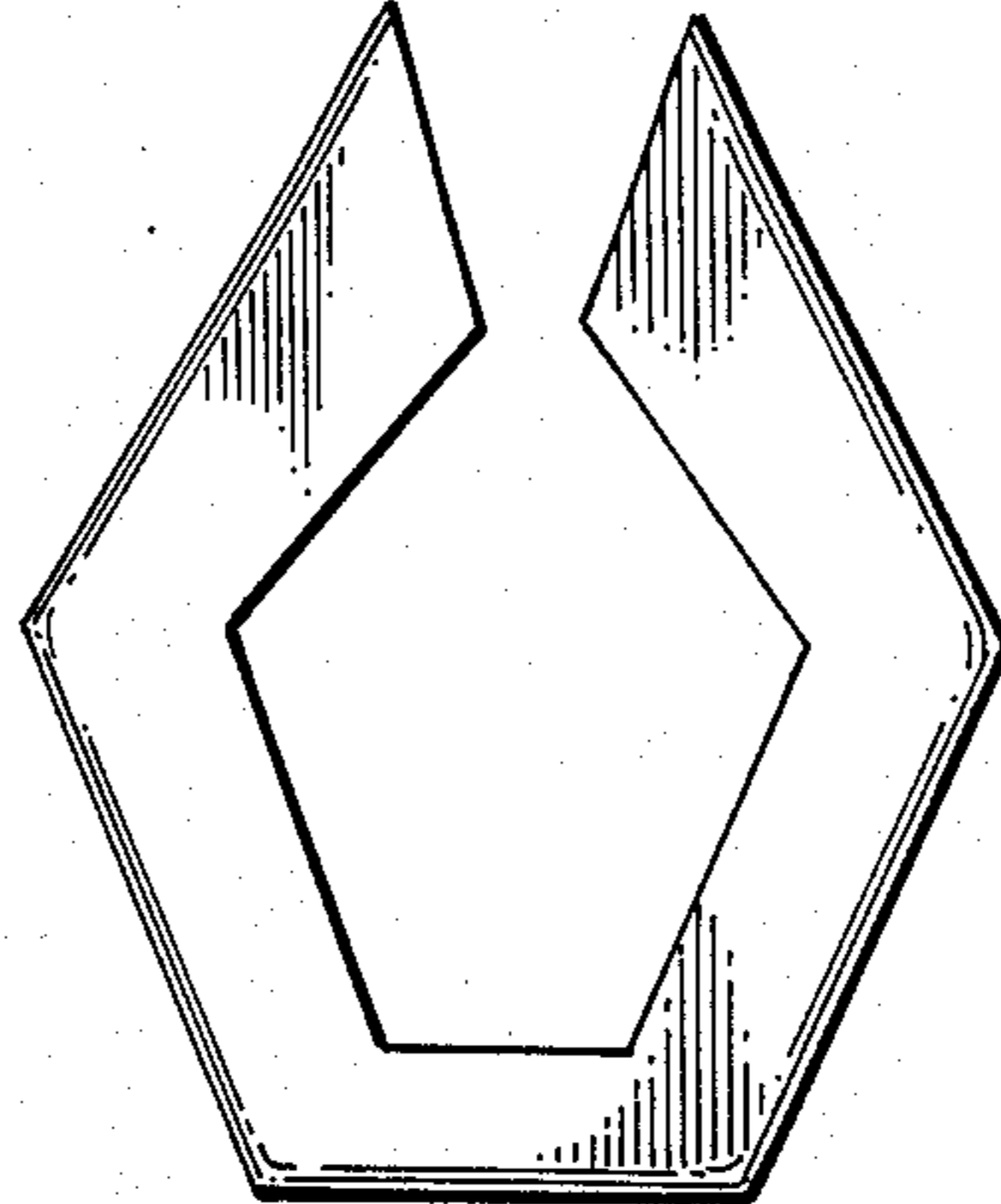
FIG. 5 is a top perspective view thereof;

FIG. 35 is a top perspective view of FIG. 30.



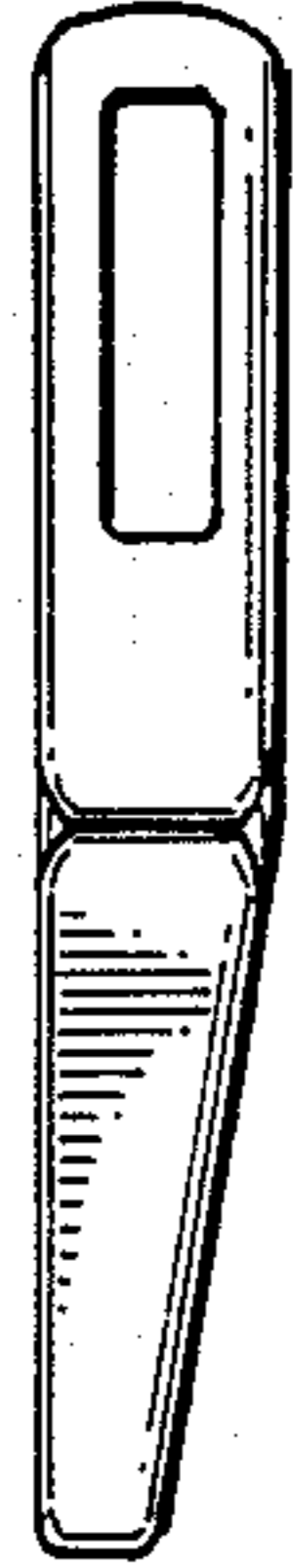

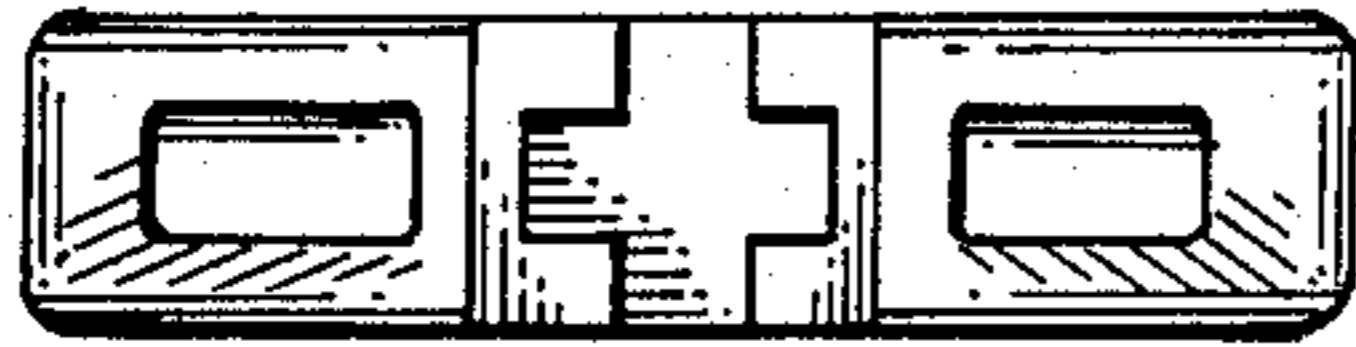

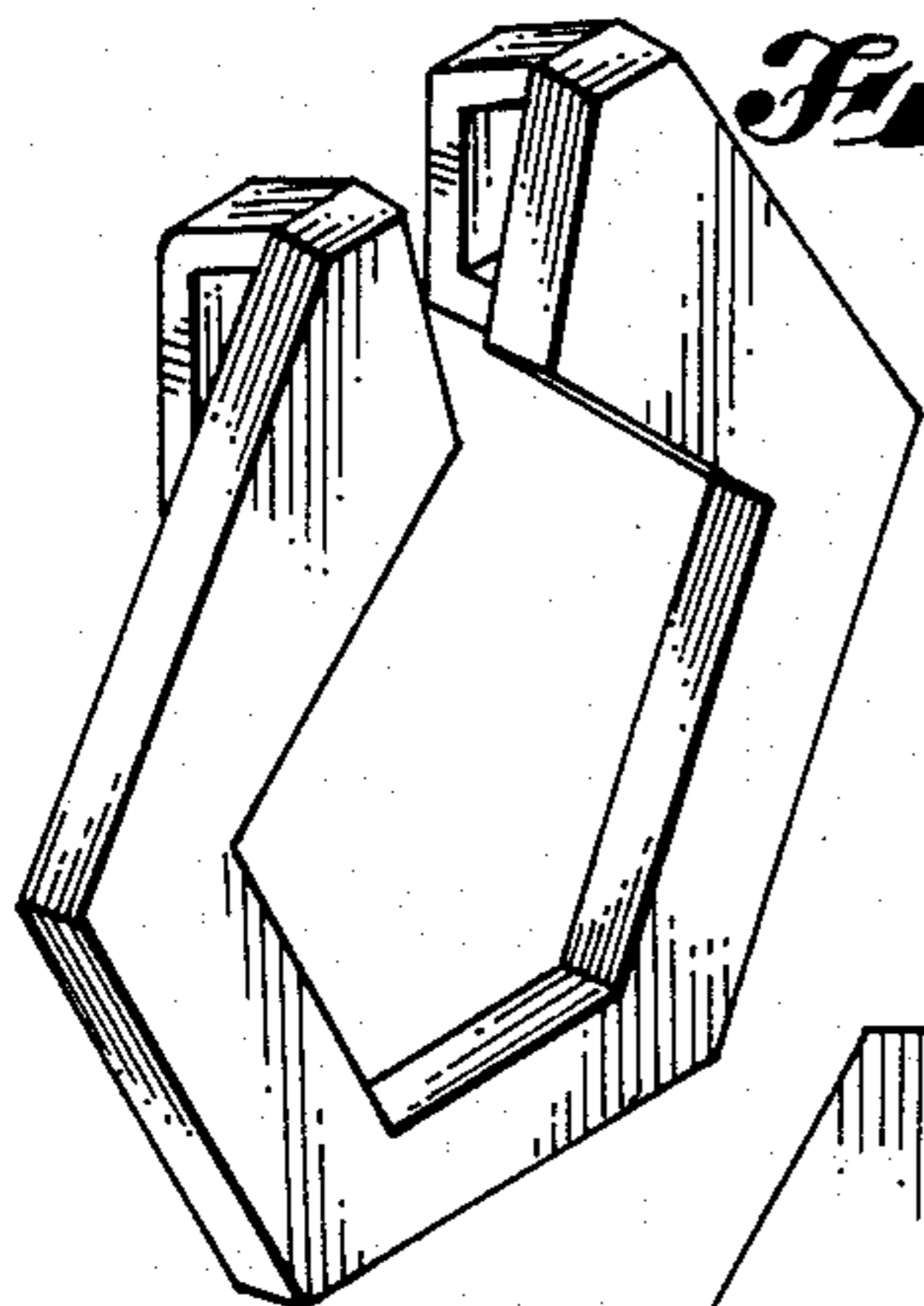

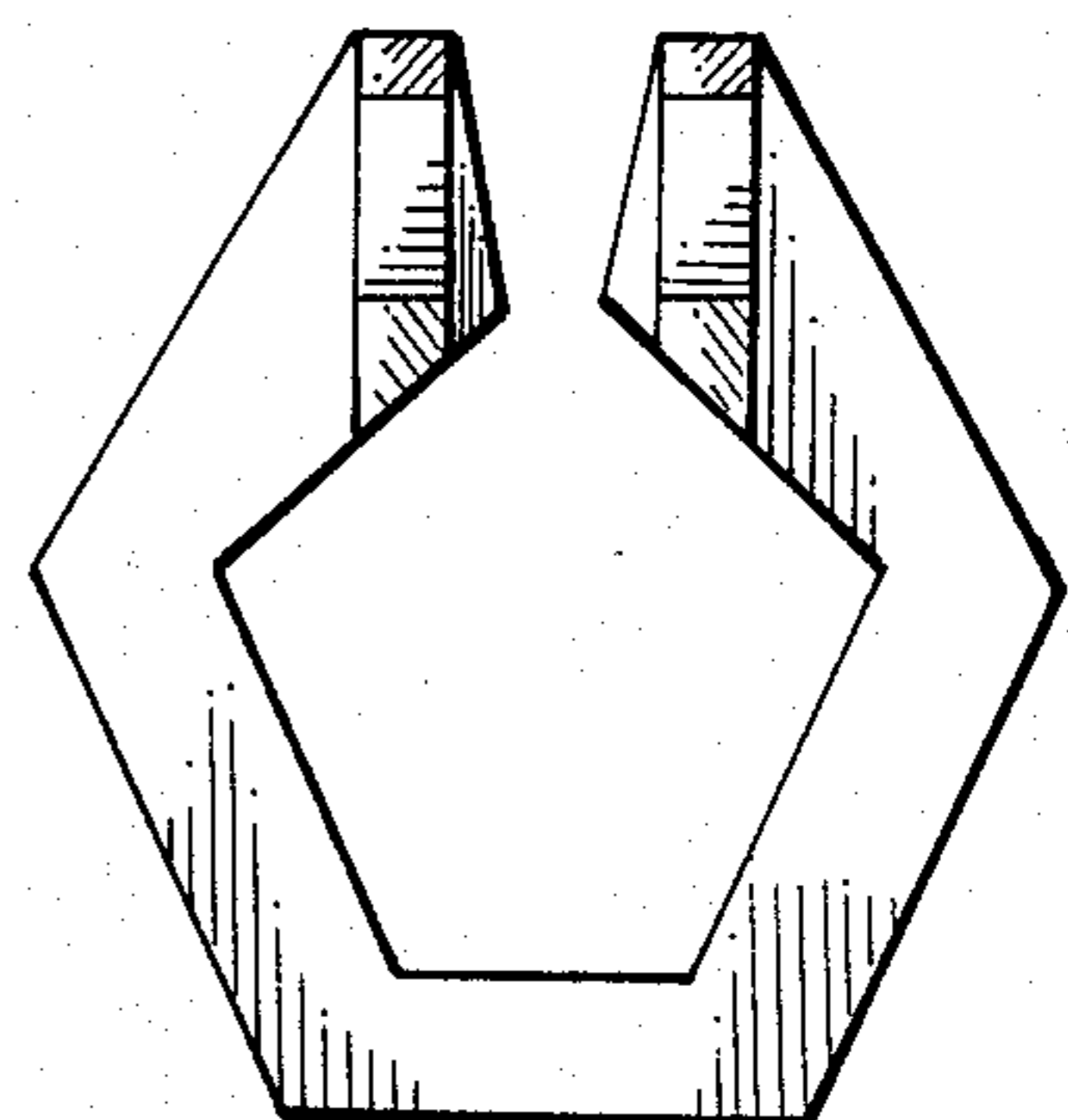
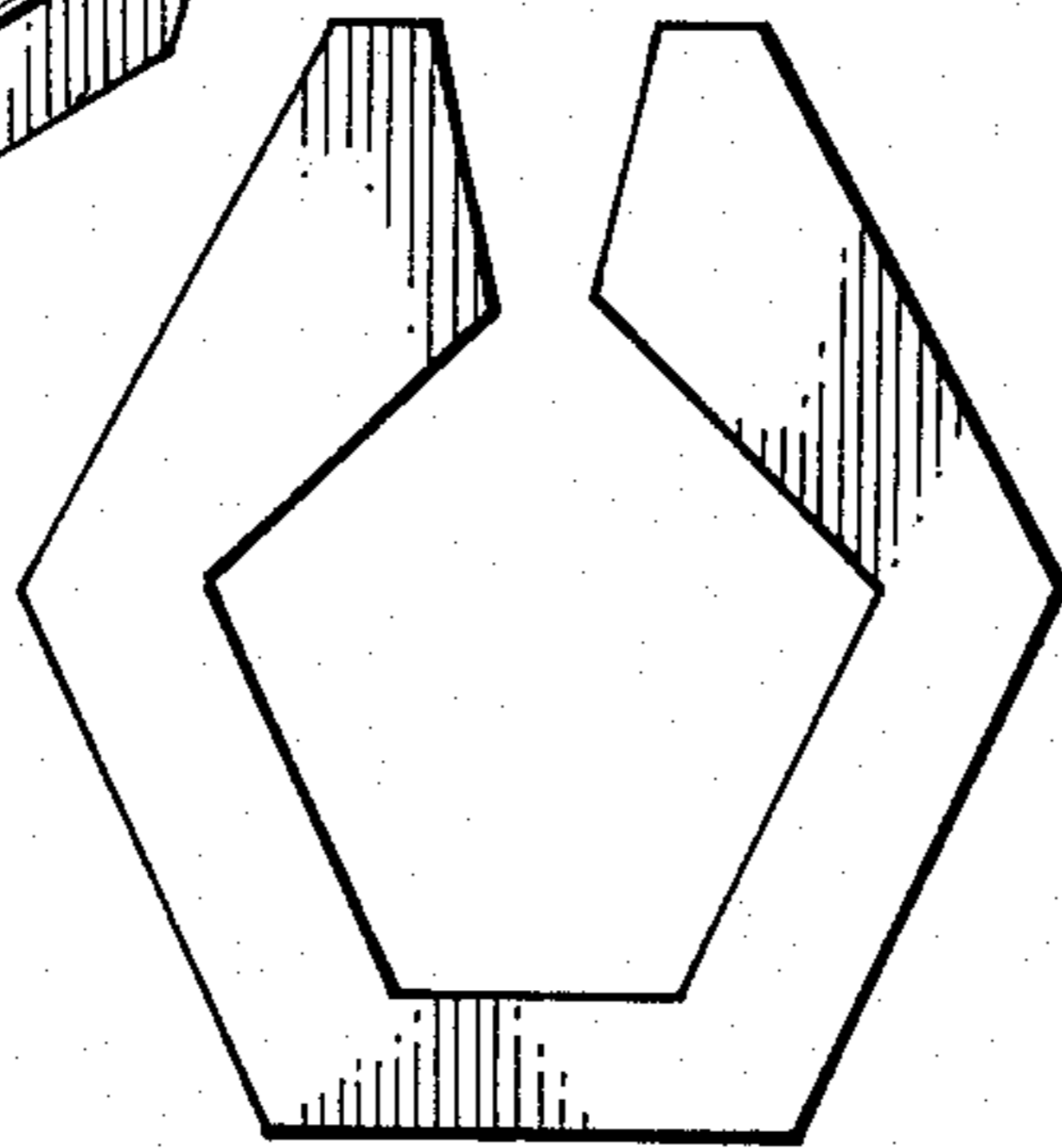

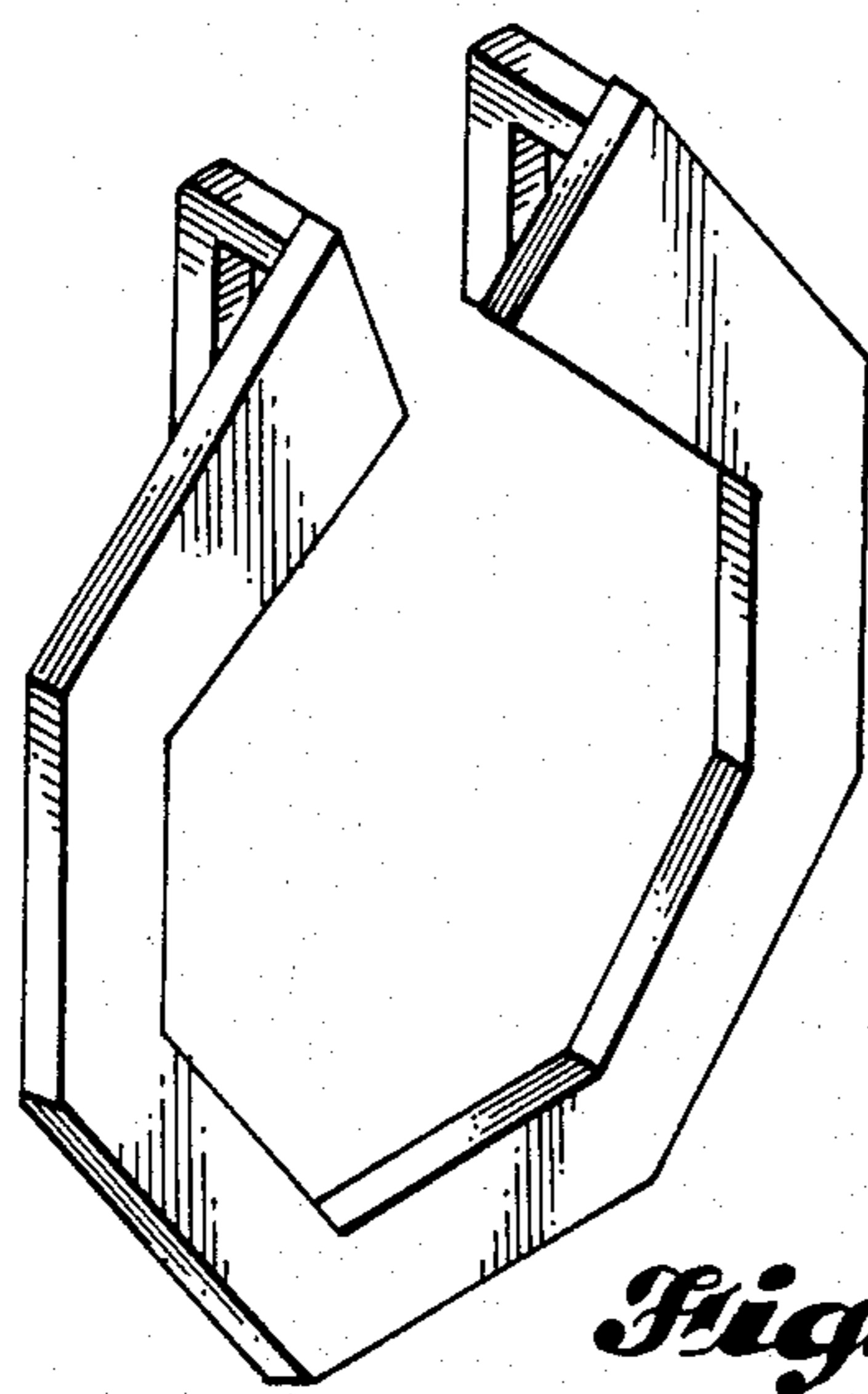

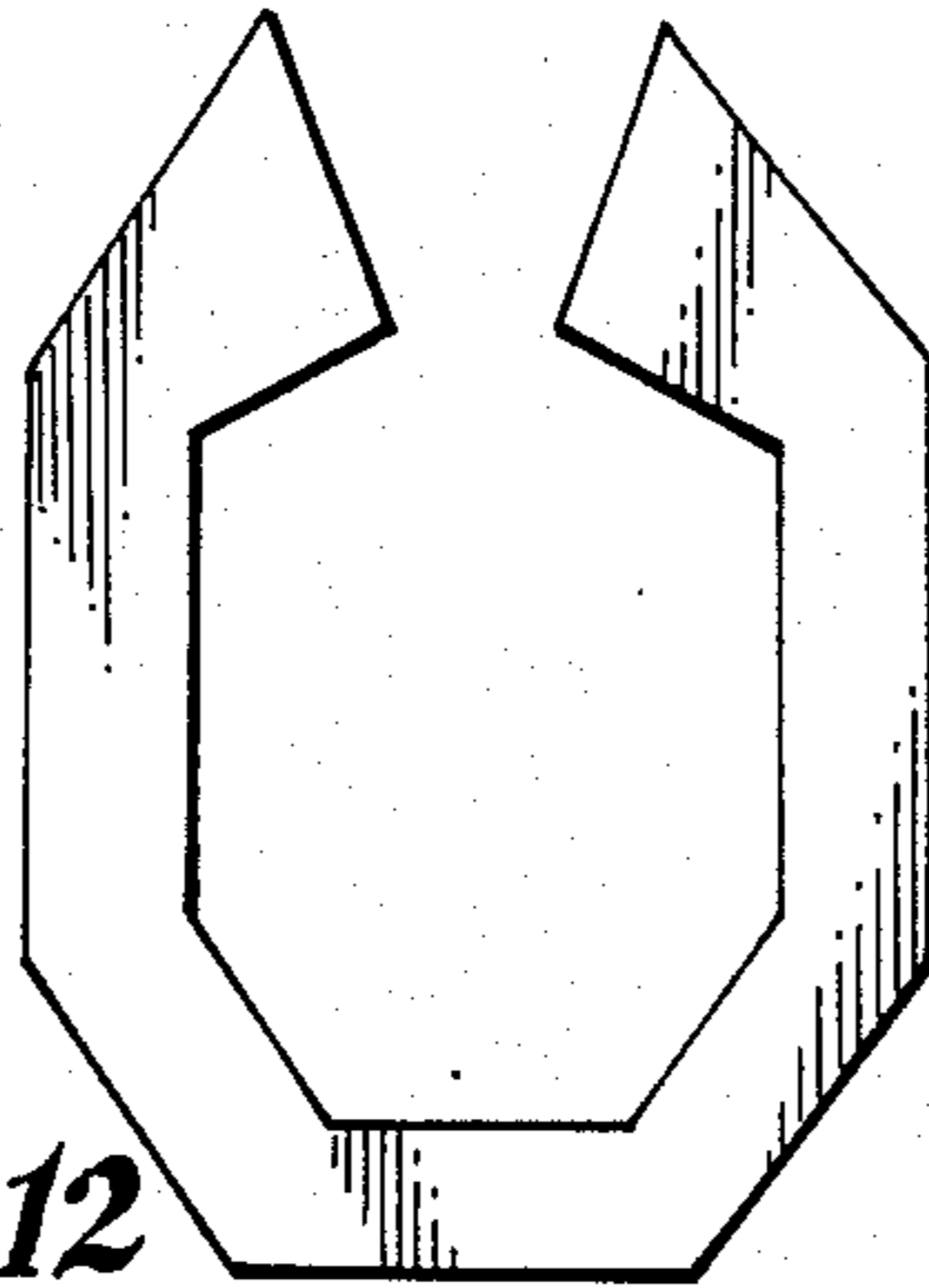

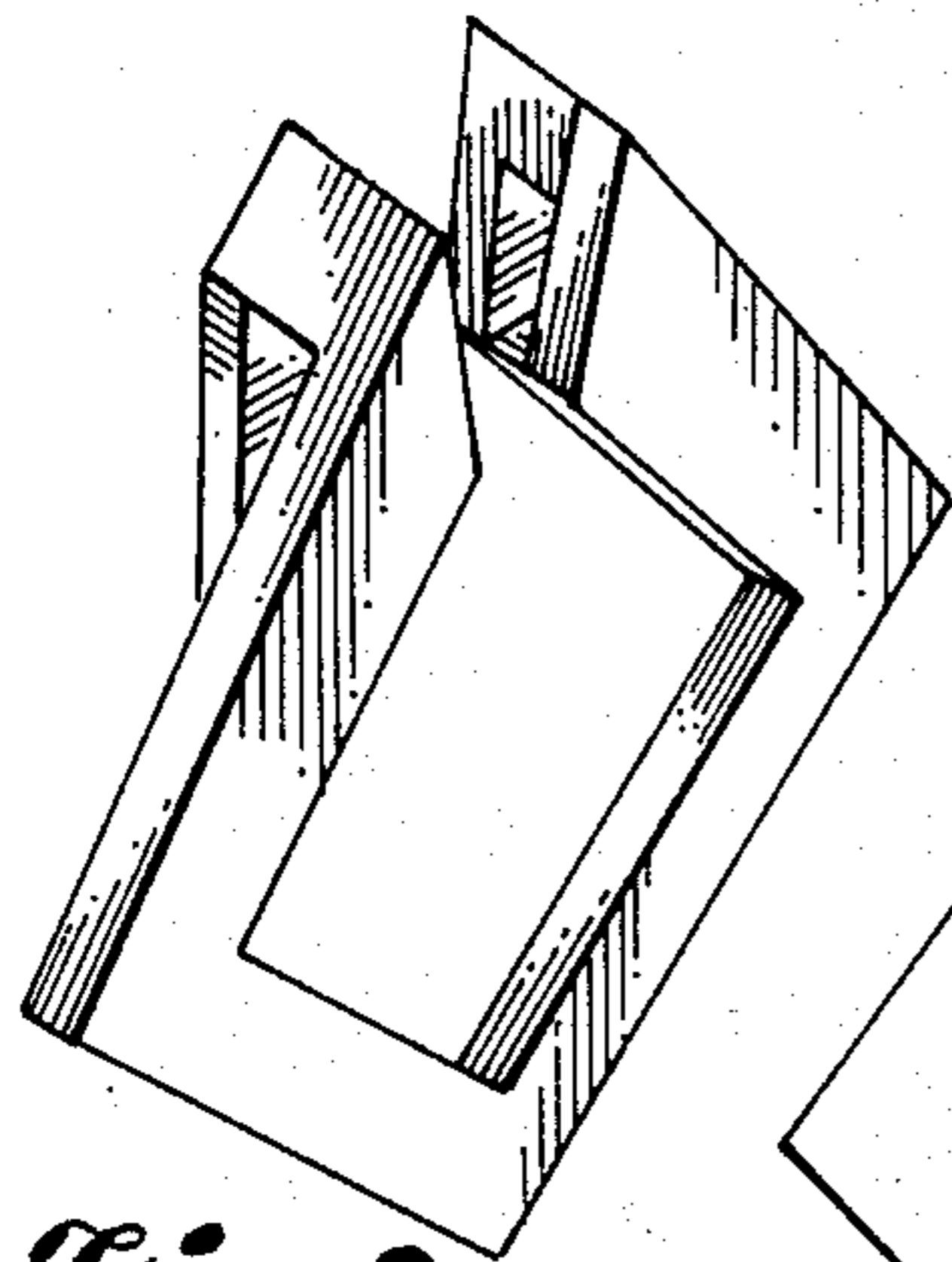

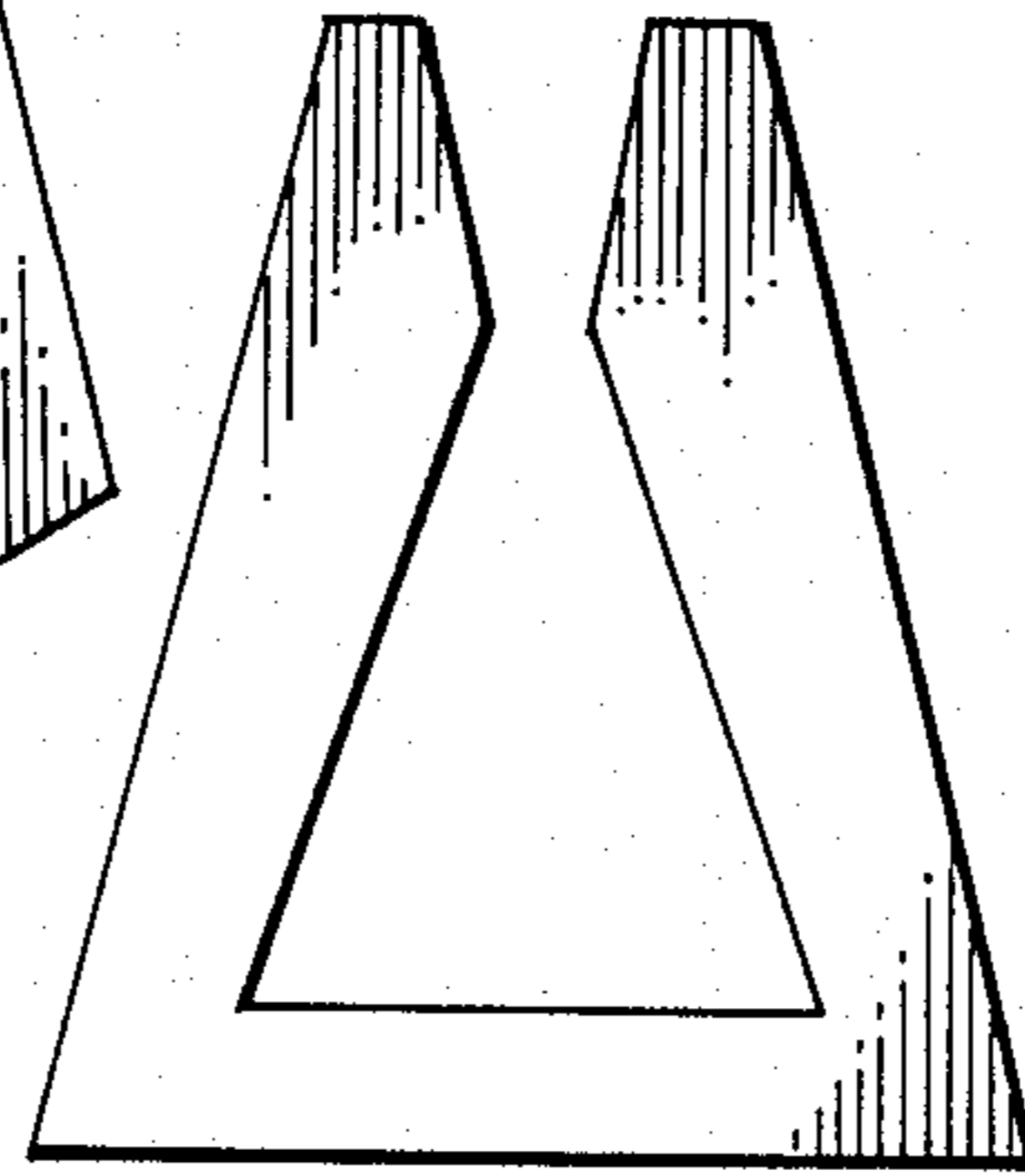

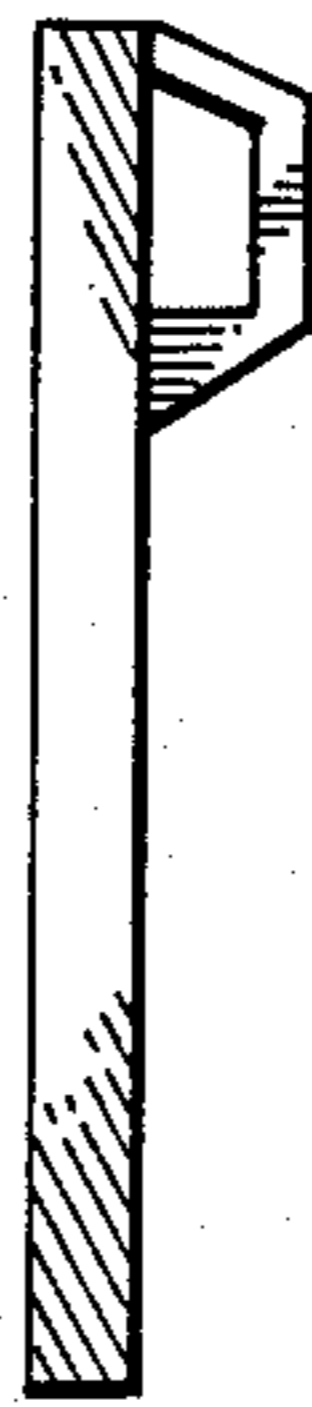
