The ornamental design for a combined hearing aid bat-

tery carrier, tester and key ring, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a combined hearing aid battery carrier, tester and key ring showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is an end elevational view thereof;

FIG. 5 is an elevational view of the opposite end thereof;

FIG. 6 is a side elevational view thereof;

FIG. 7 is an elevational view of the opposite side thereof;

FIG. 8 is a front elevational view thereof in an open condition;

FIG. 9 is a rear elevational view in an opened condition;

FIG. 10 is a right end side elevational view thereof in an open condition;

FIG. 11 is a left end elevational view thereof;

FIG. 12 is a side elevational view in an opened condition; and

FIG. 13 is the opposite side elevational view thereof.

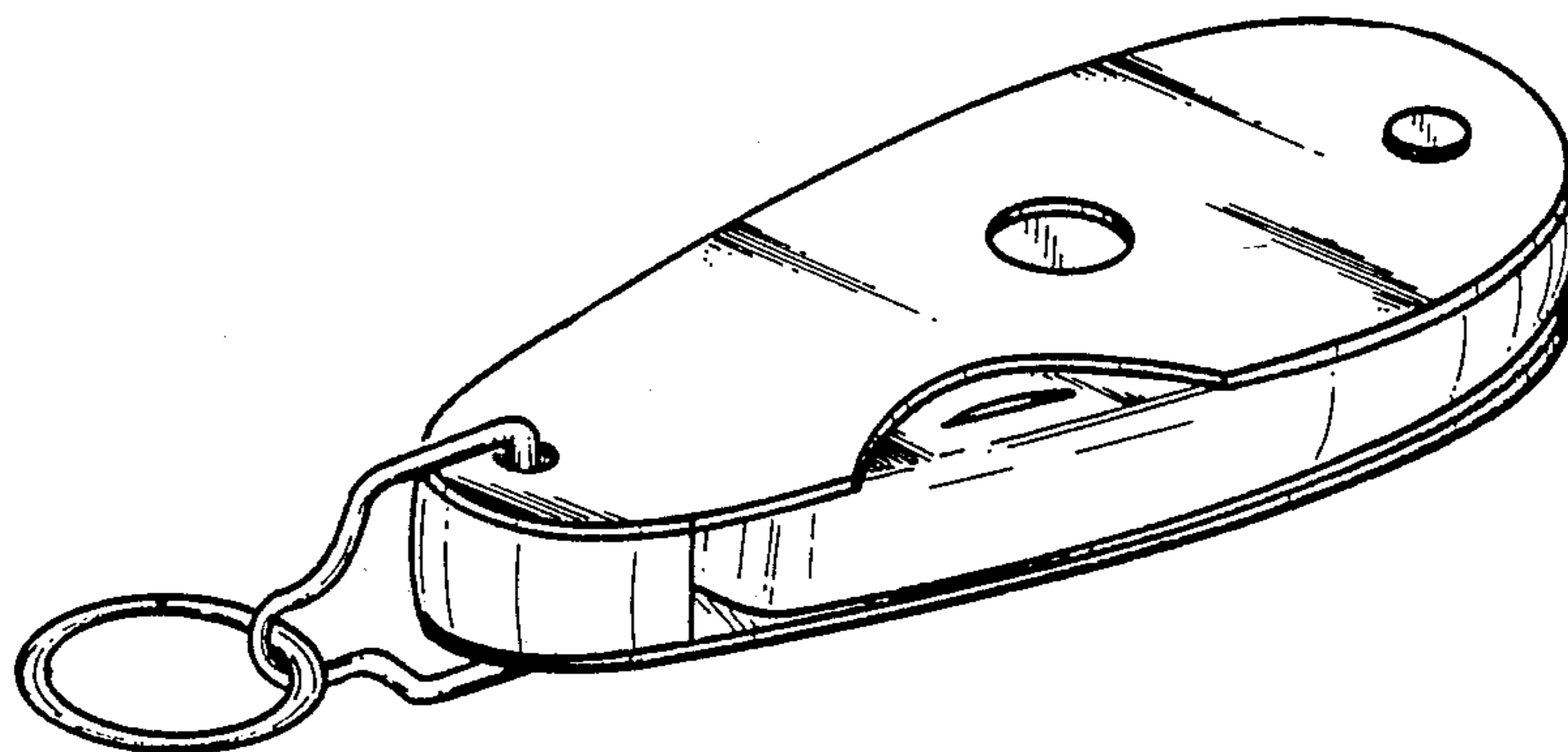

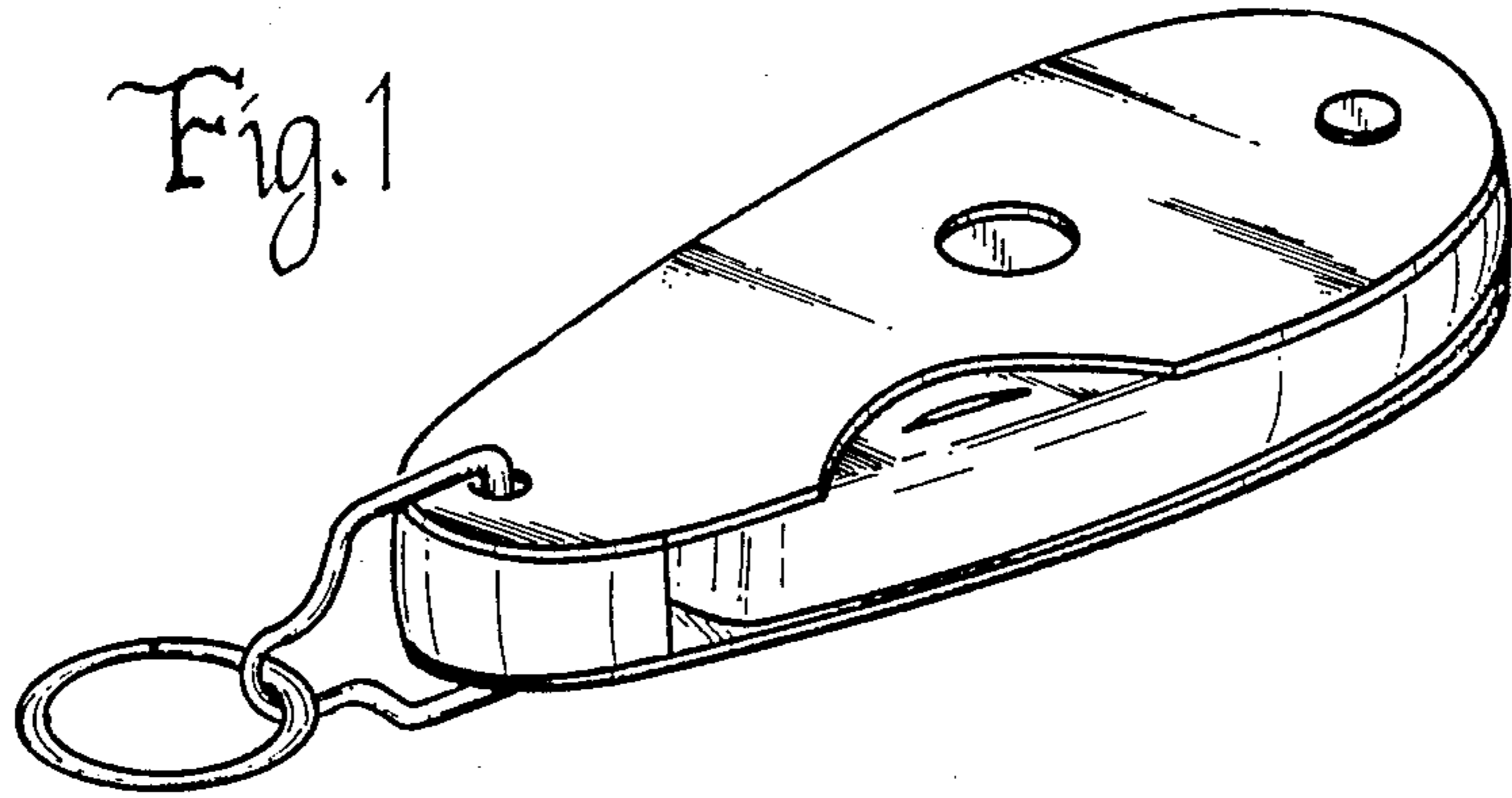

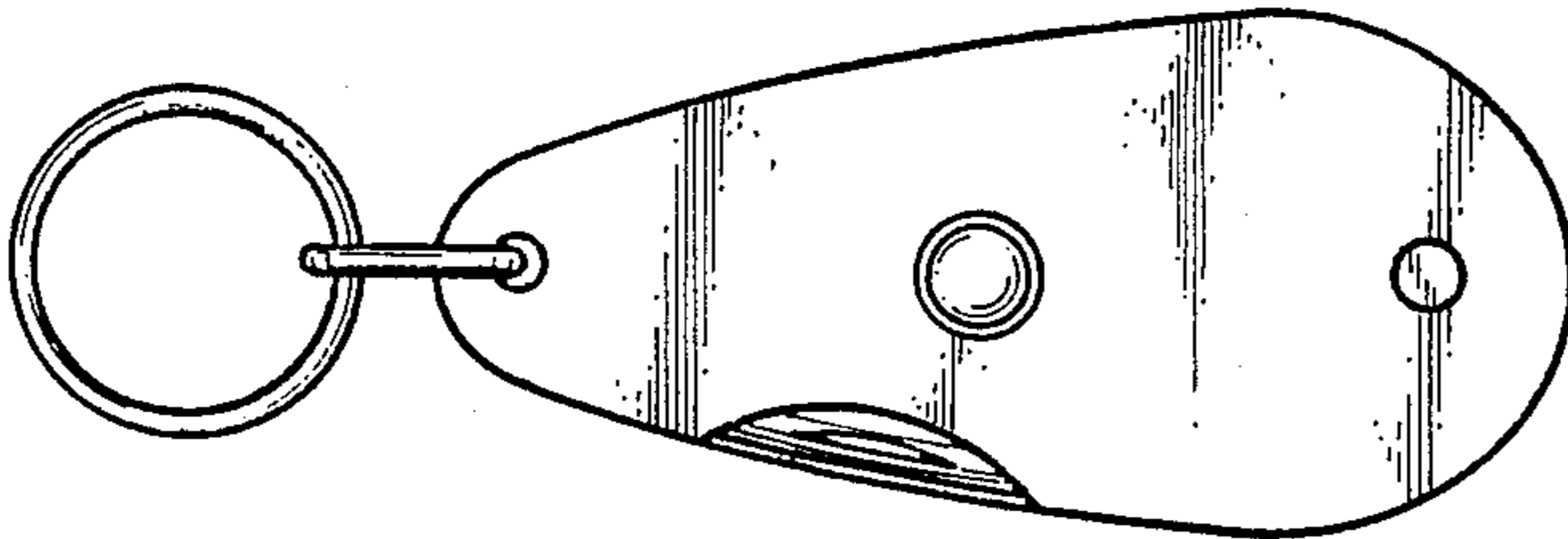

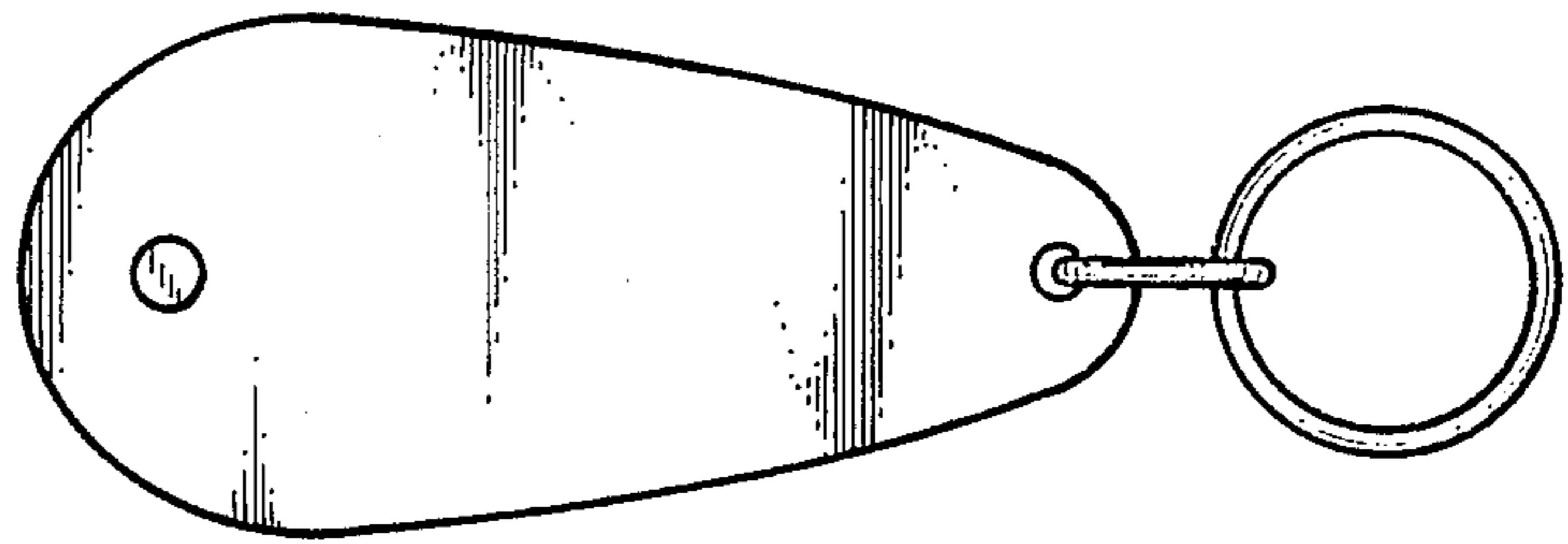

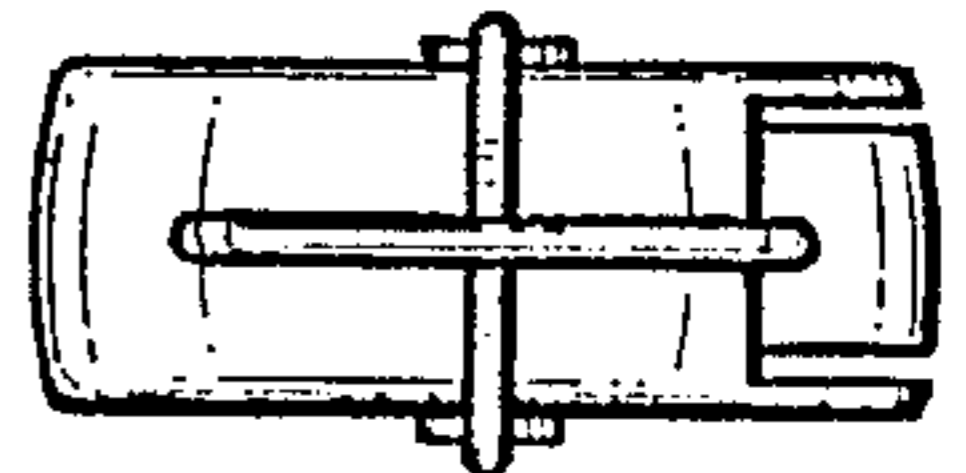

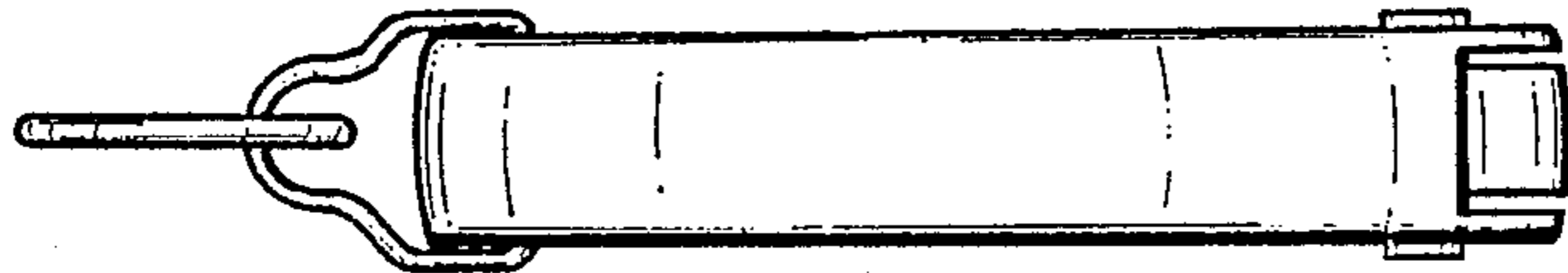

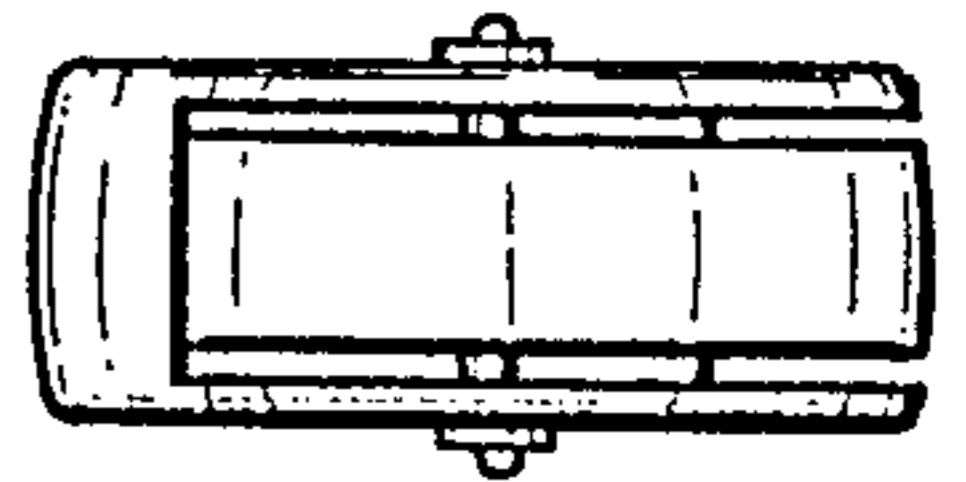

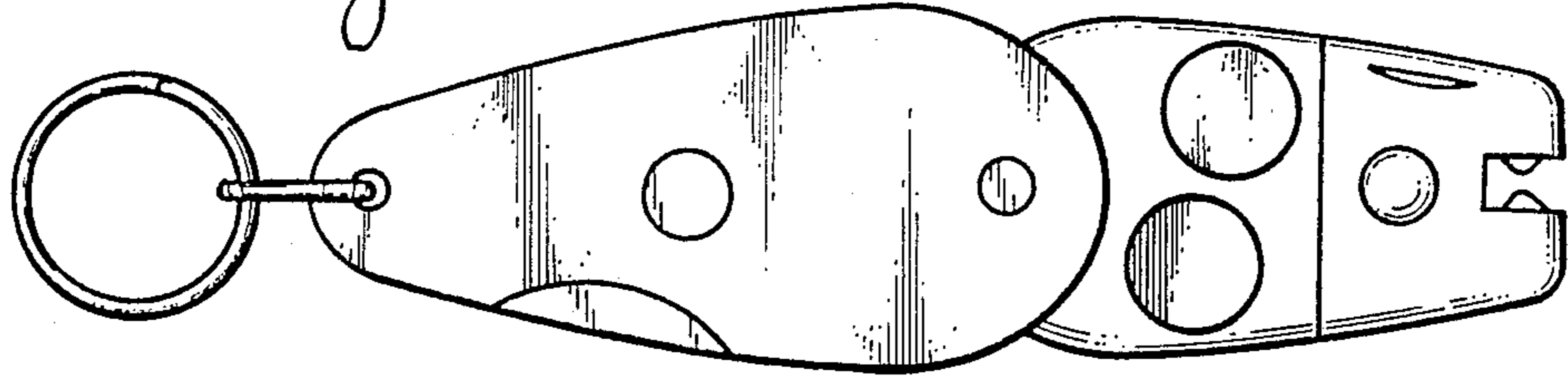

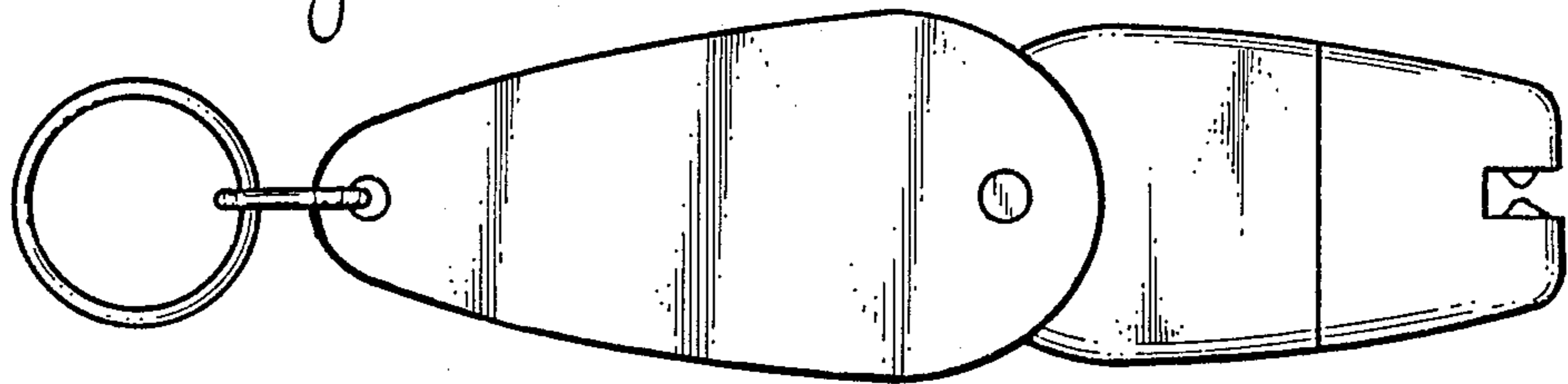

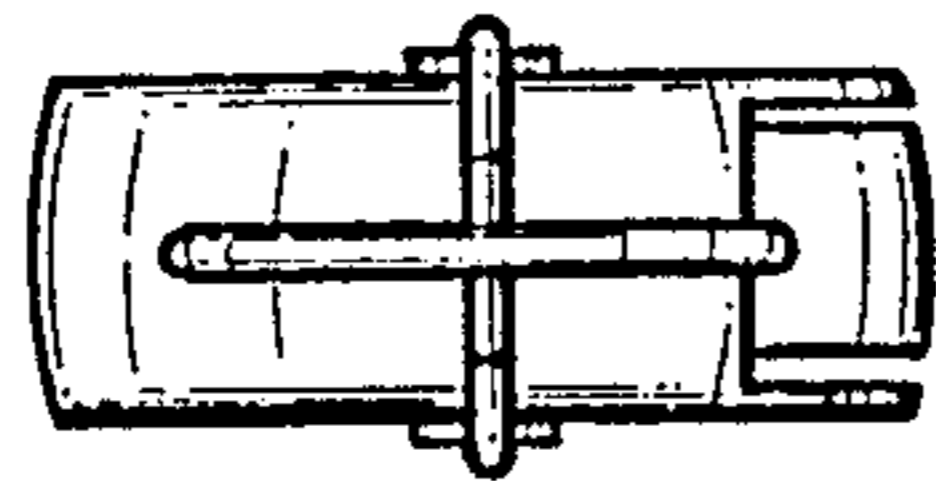

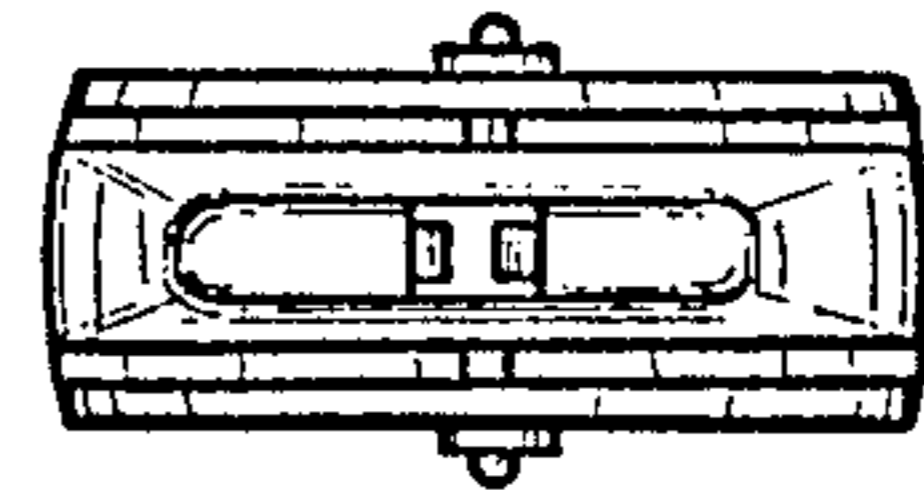

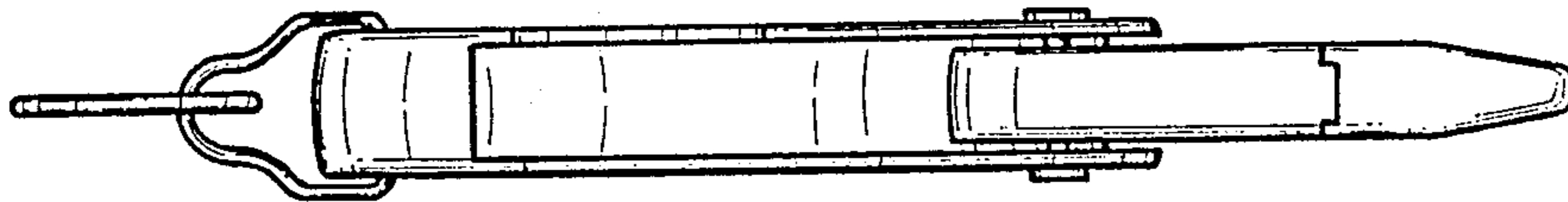
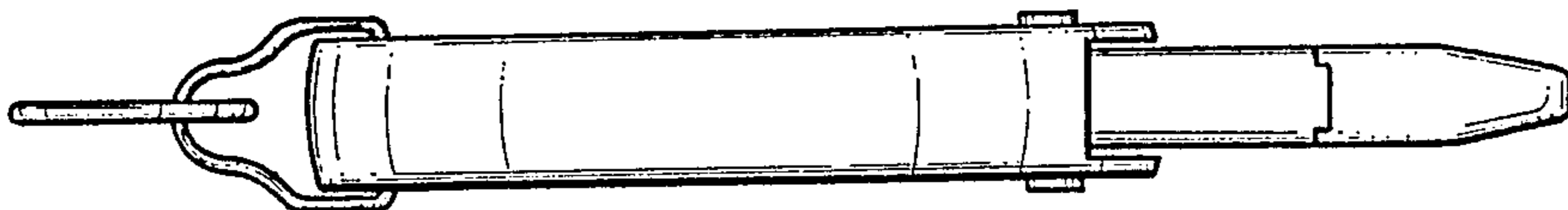
