FIG. 1 is a front elevational view of a beverage can showing our new design with a lip indentation recess; FIG. 2 is a side elevational view of FIG. 1; FIG. 3 is a rear elevational view thereof; FIG. 4 is a top plan view of FIG. 2; FIG. 5 is a bottom plan view thereof; FIG. 6 is a front elevational view of a beverage can showing a second embodiment of our new design wherein the lip indentation recess is modified; FIG. 7 is a side elevational view of modified form FIG. 6; FIG. 8 is a rear elevational view thereof; FIG. 9 is a top plan view of FIG. 7; FIG. 10 is a bottom plan view thereof; FIG. 11 is a front elevational view of a beverage can showing a third embodiment of our new design wherein the lip indentation recess is modified; FIG. 12 is a side elevational view of modified form FIG. 11; FIG. 13 is a rear elevational view thereof; FIG. 14 is a top plan view of FIG. 12; FIG. 15 is a bottom plan view thereof; FIG. 16 is a front elevational view of a beverage can showing a fourth embodiment of our new design wherein the lip indentation recess is modified; FIG. 17 is a side elevational view of modified form FIG. 16; FIG. 18 is a rear elevational view thereof; FIG. 19 is a top plan view of FIG. 17; and FIG. 20 is a bottom plan view thereof.

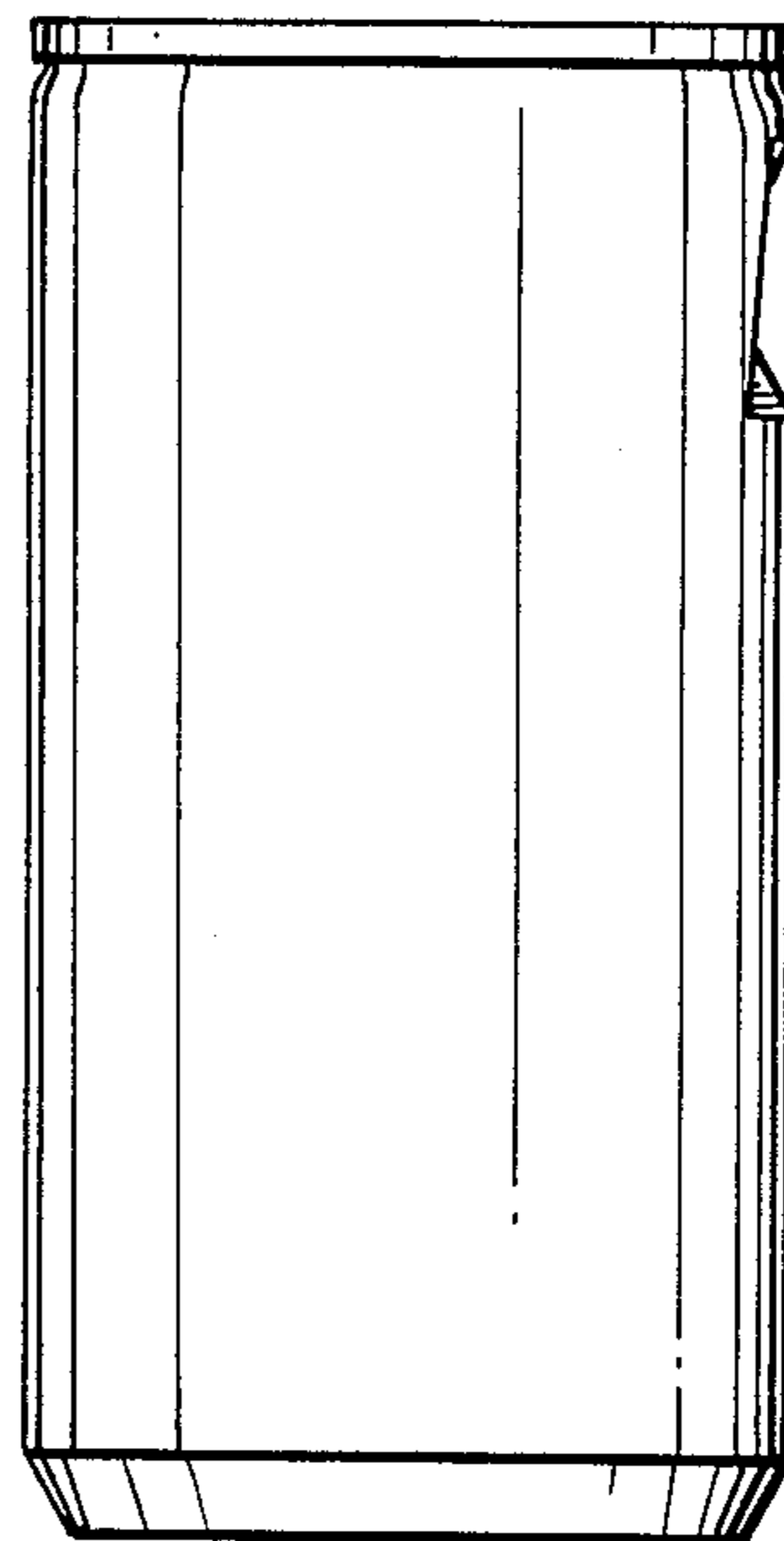
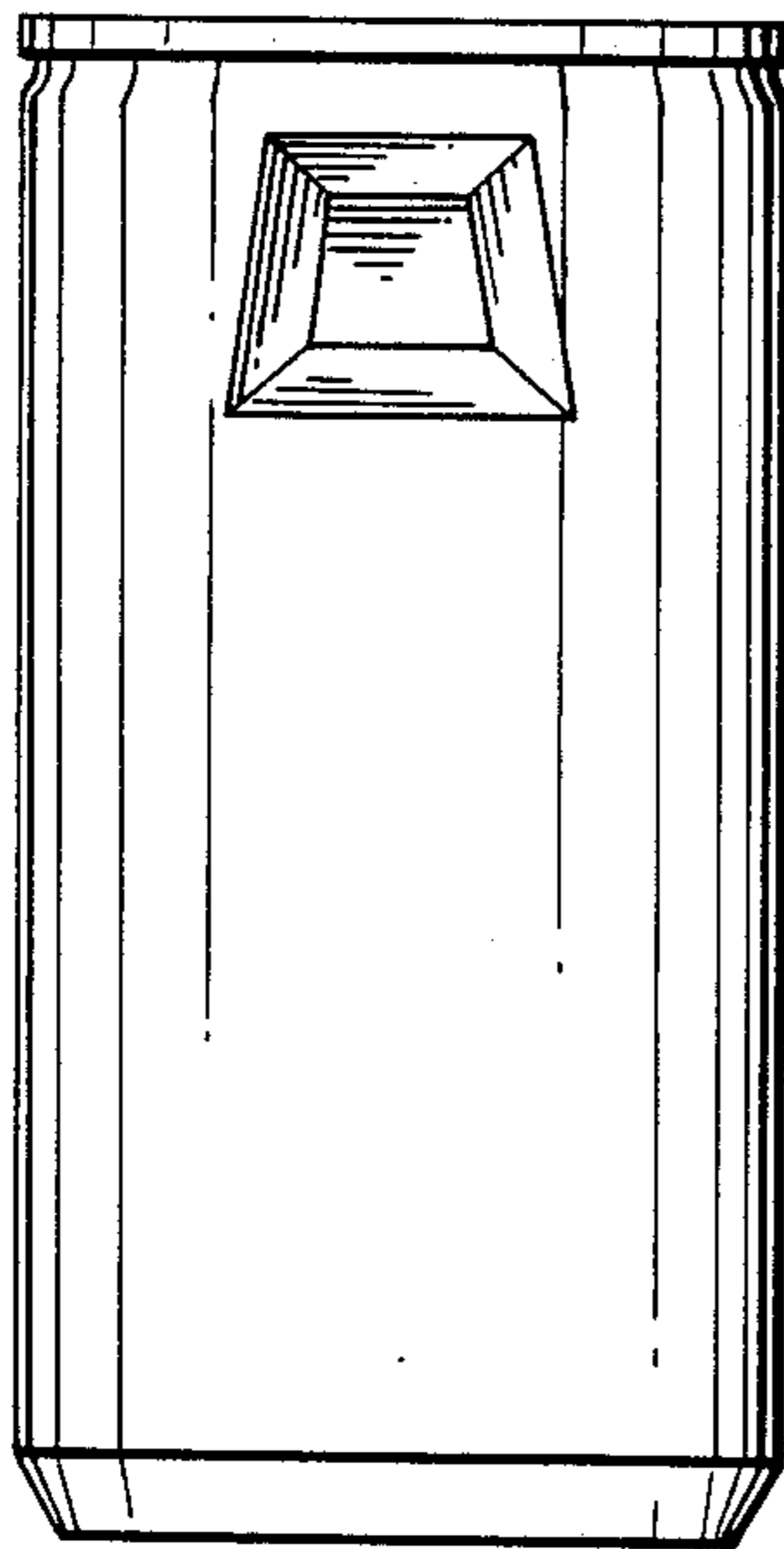

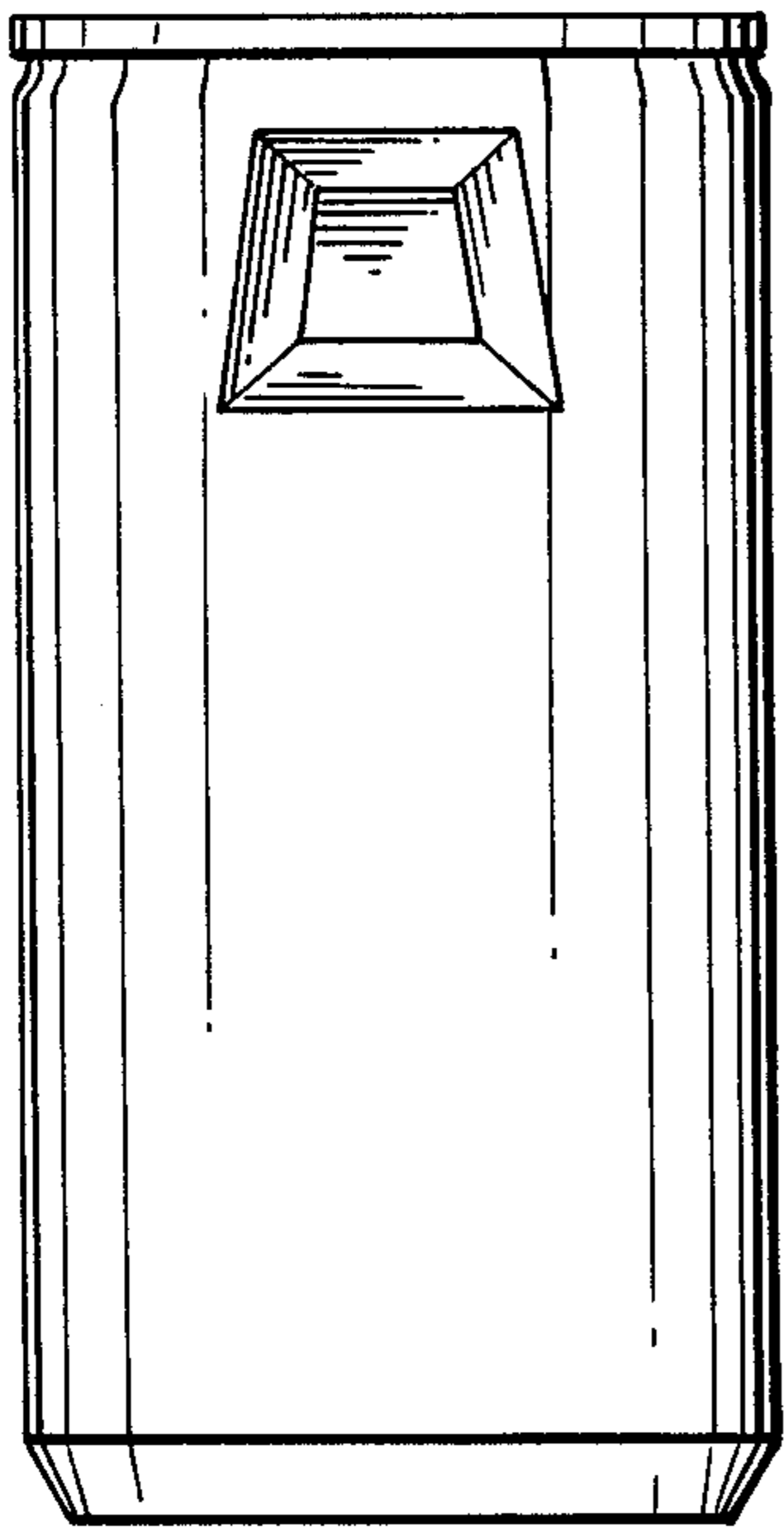

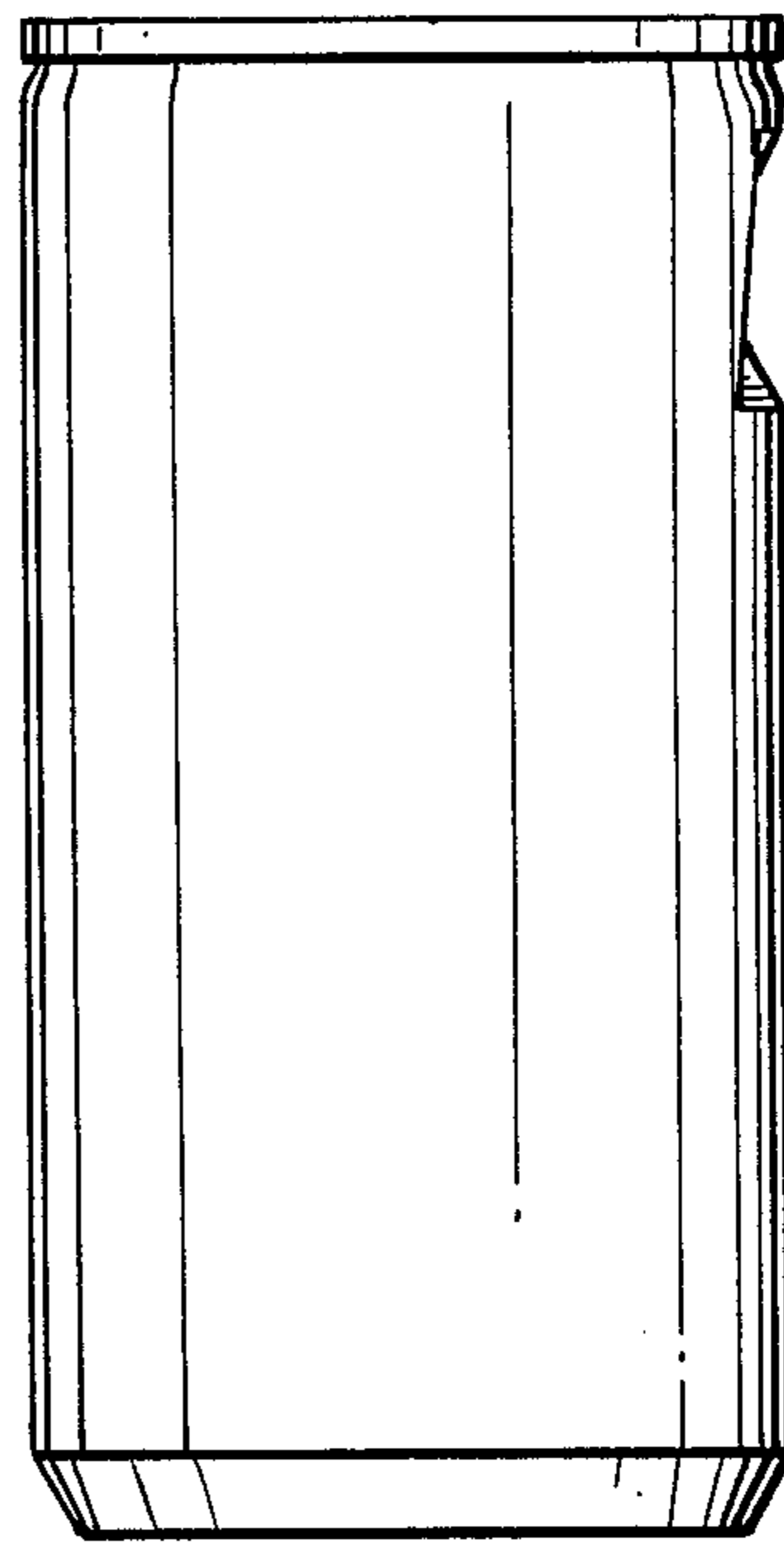

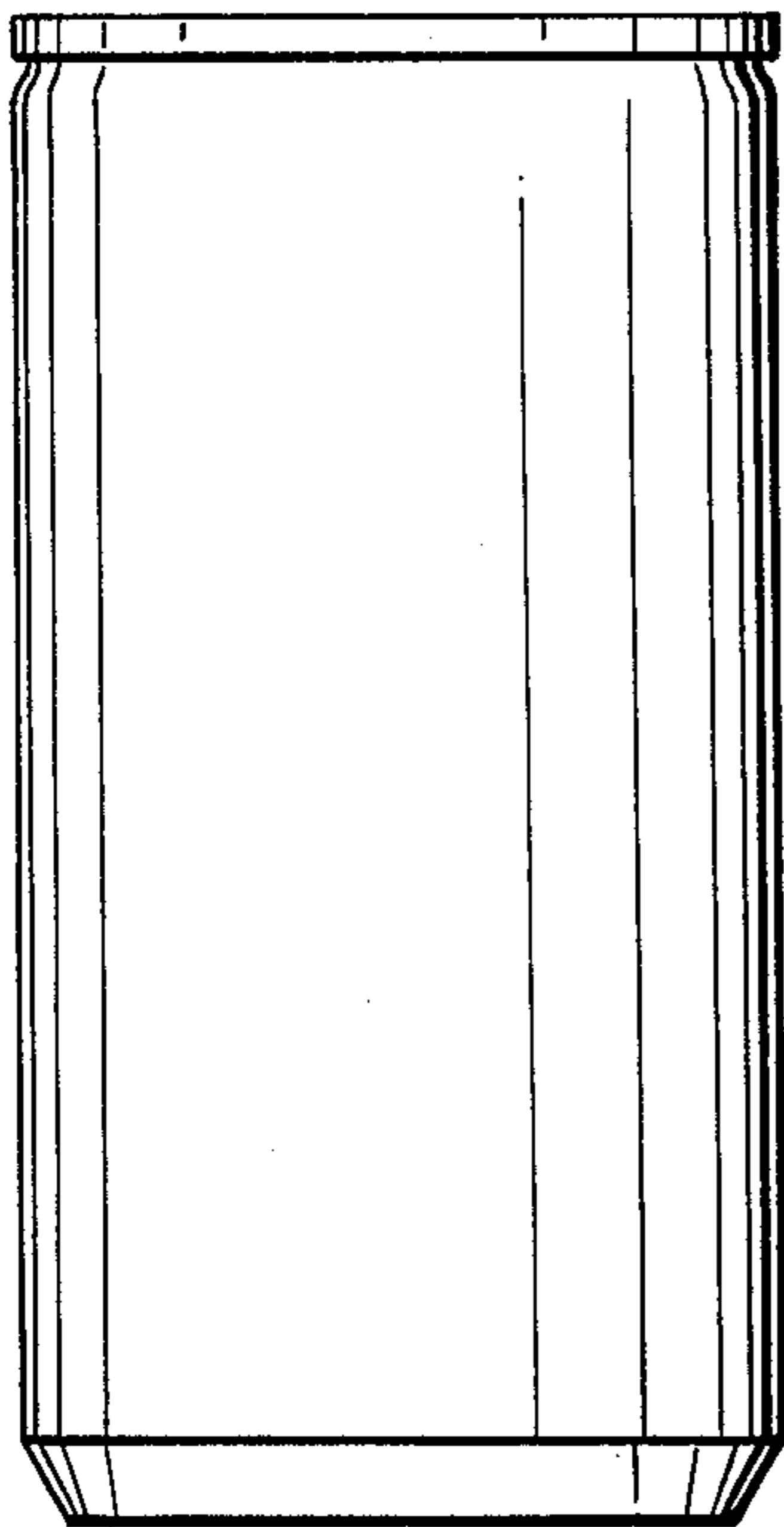

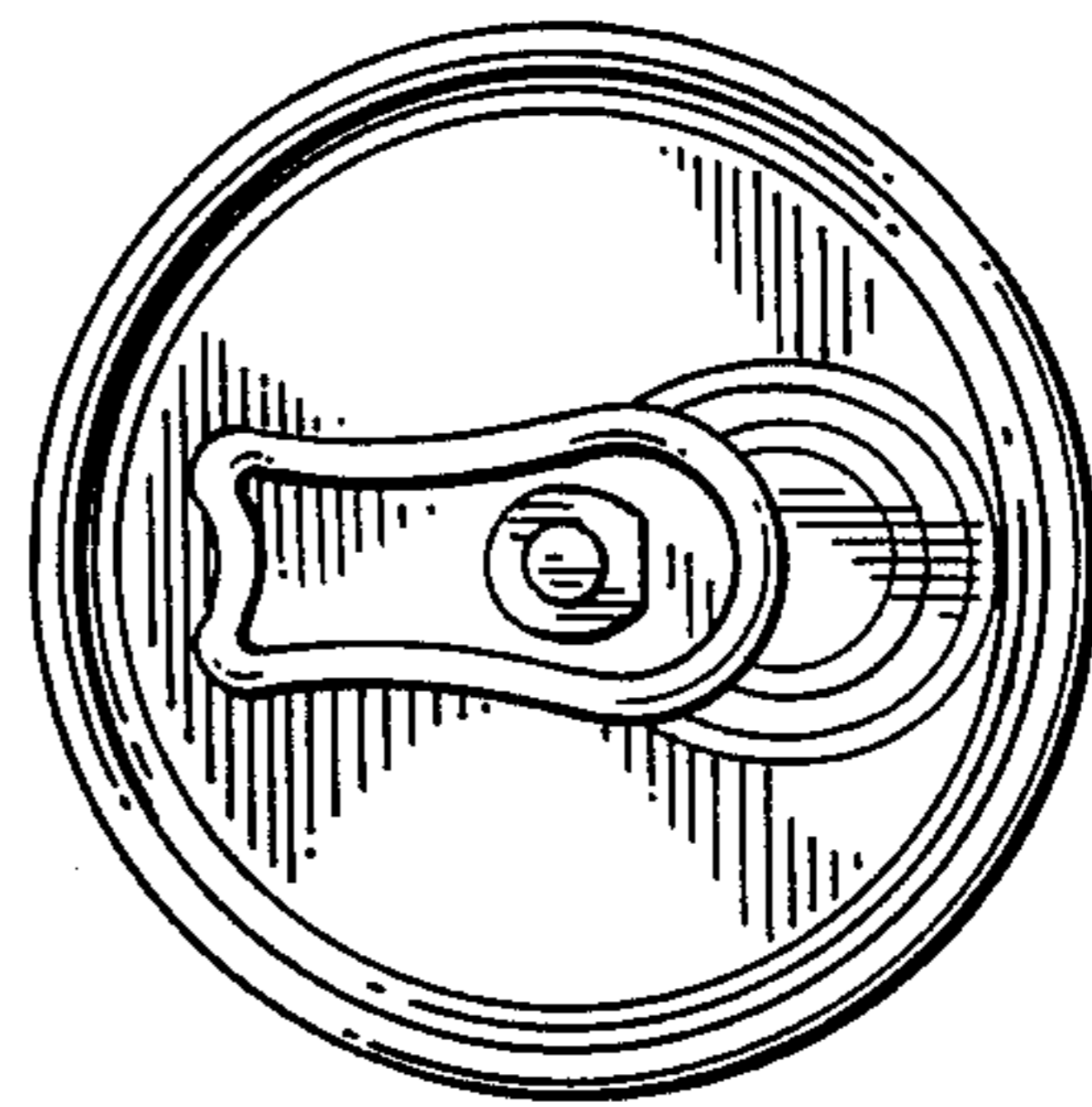

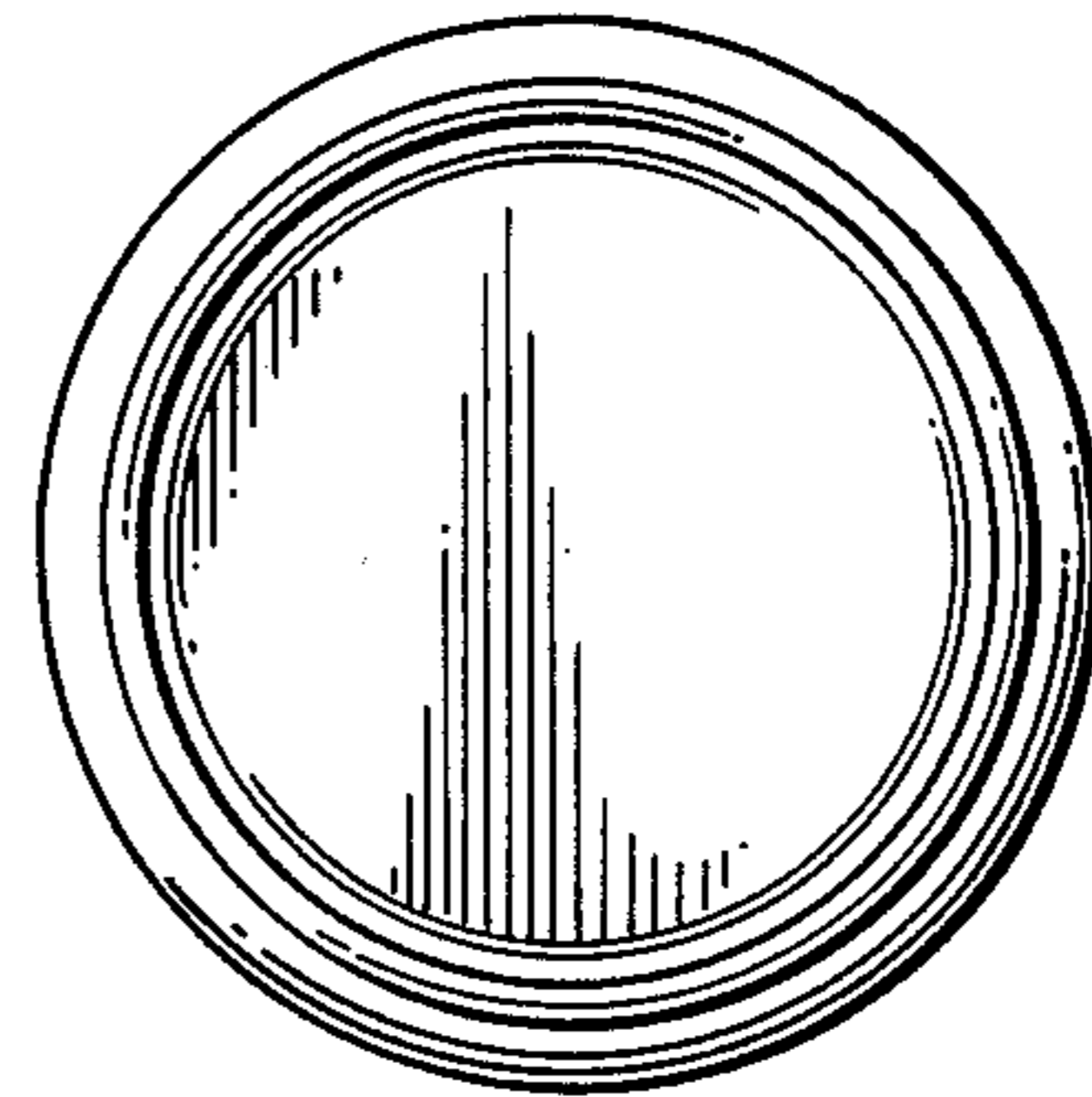

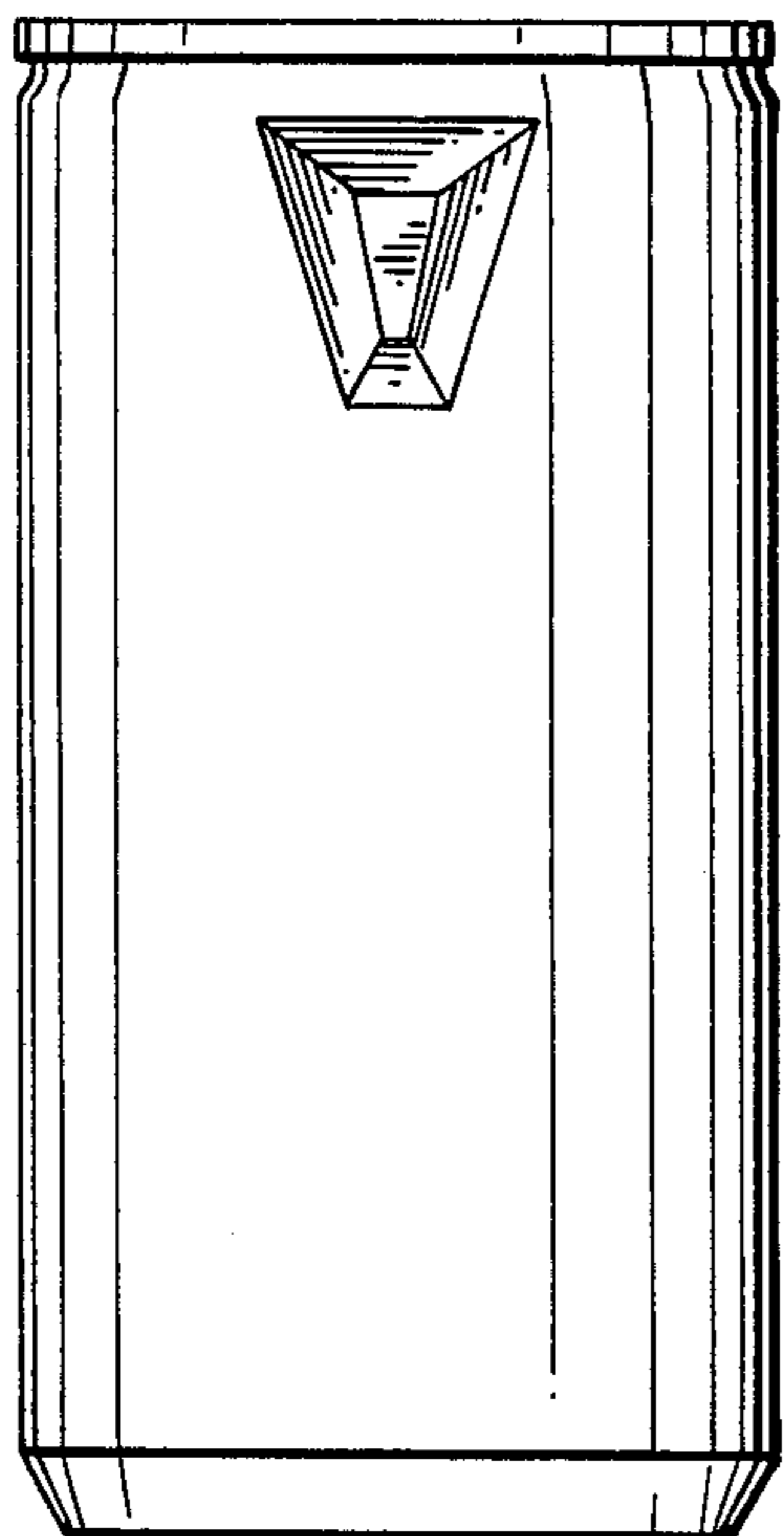

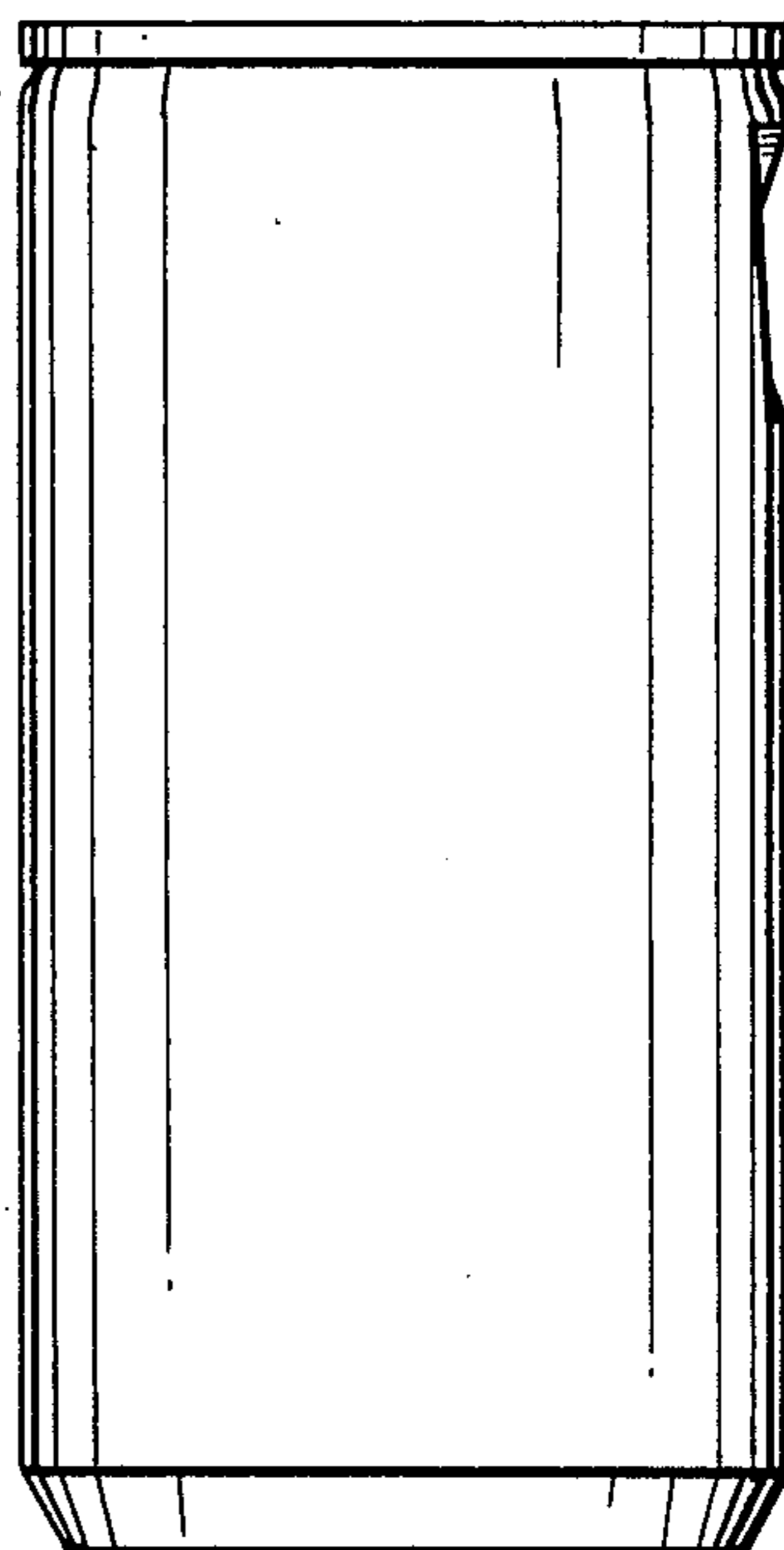

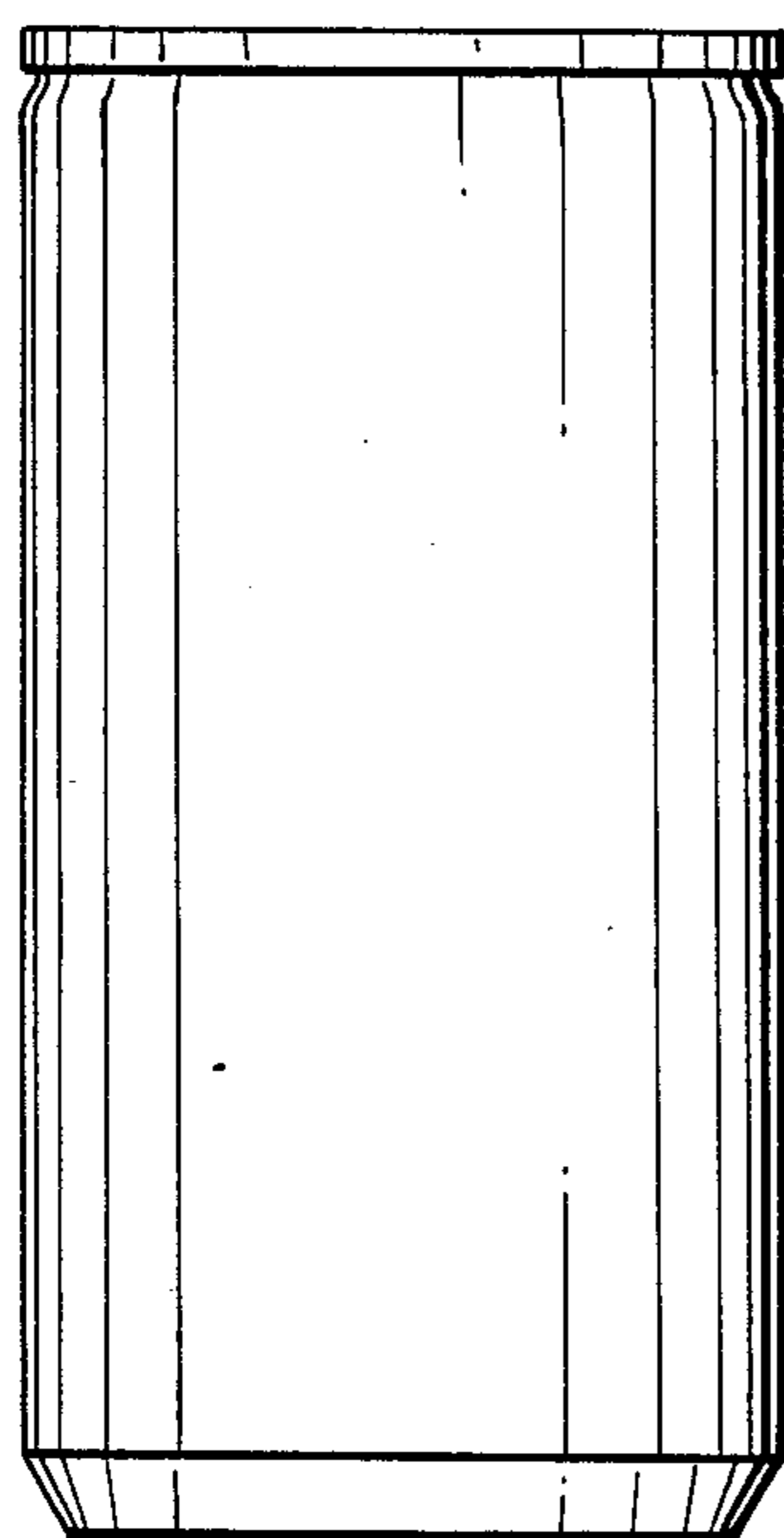

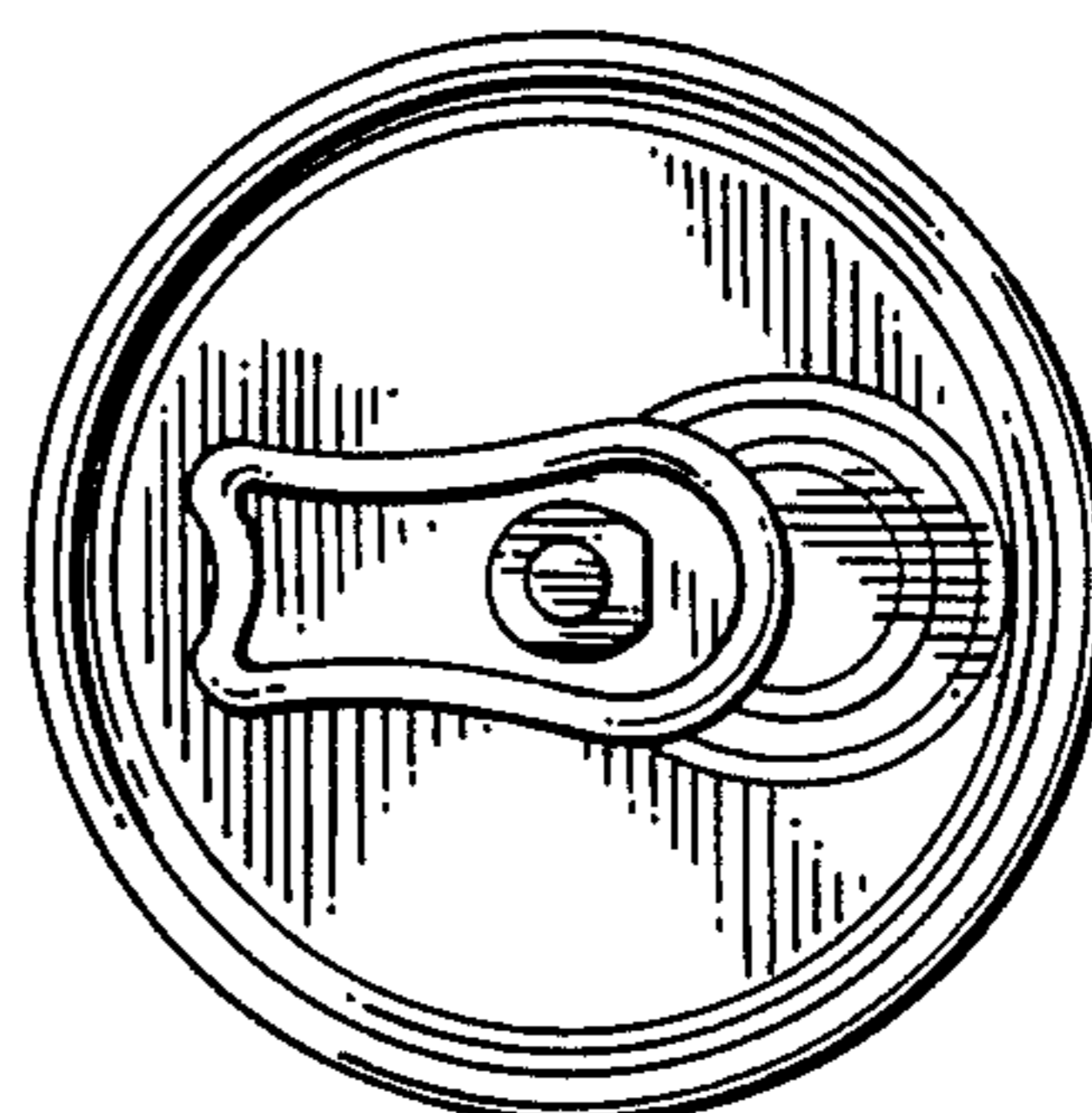

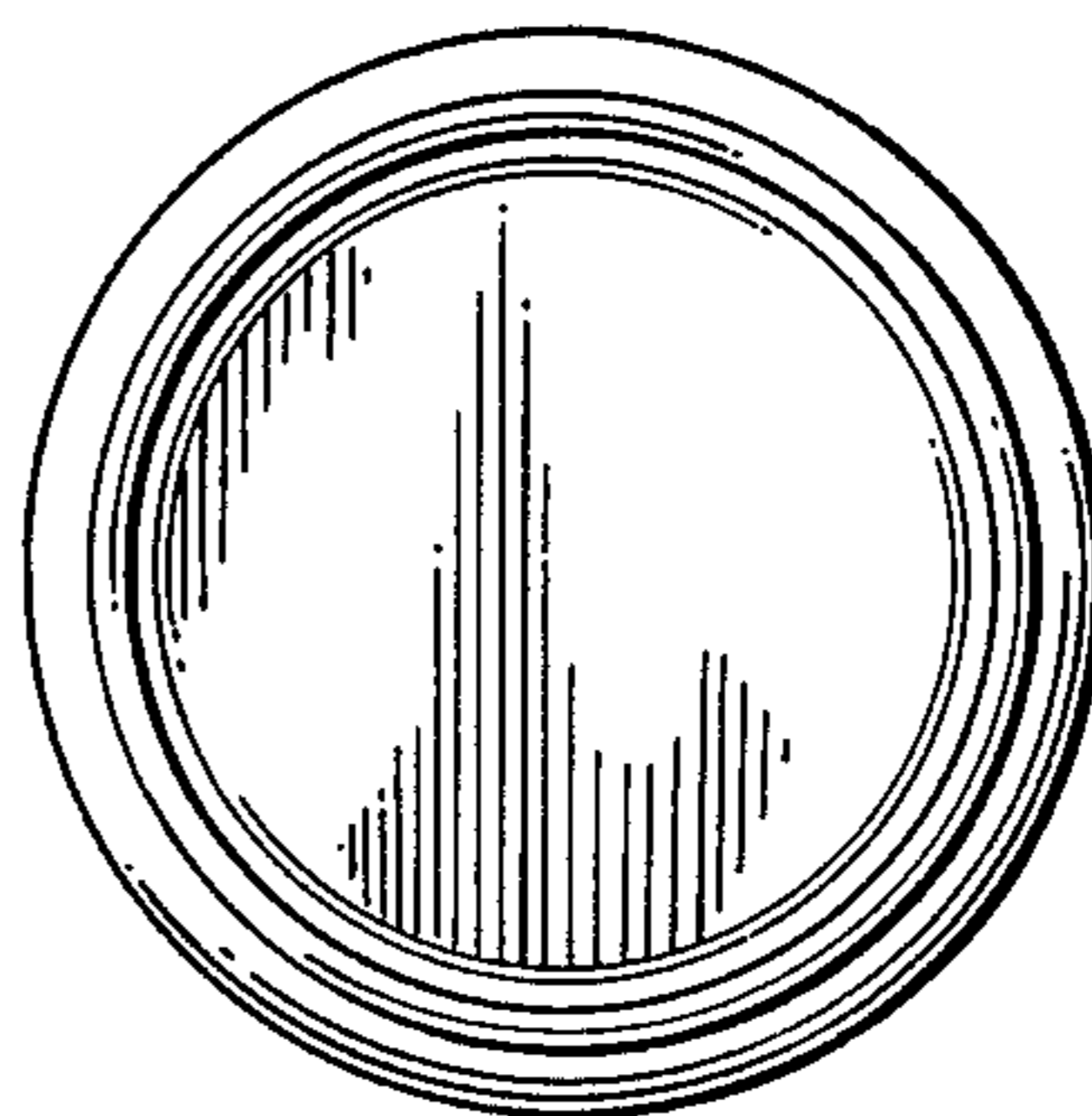

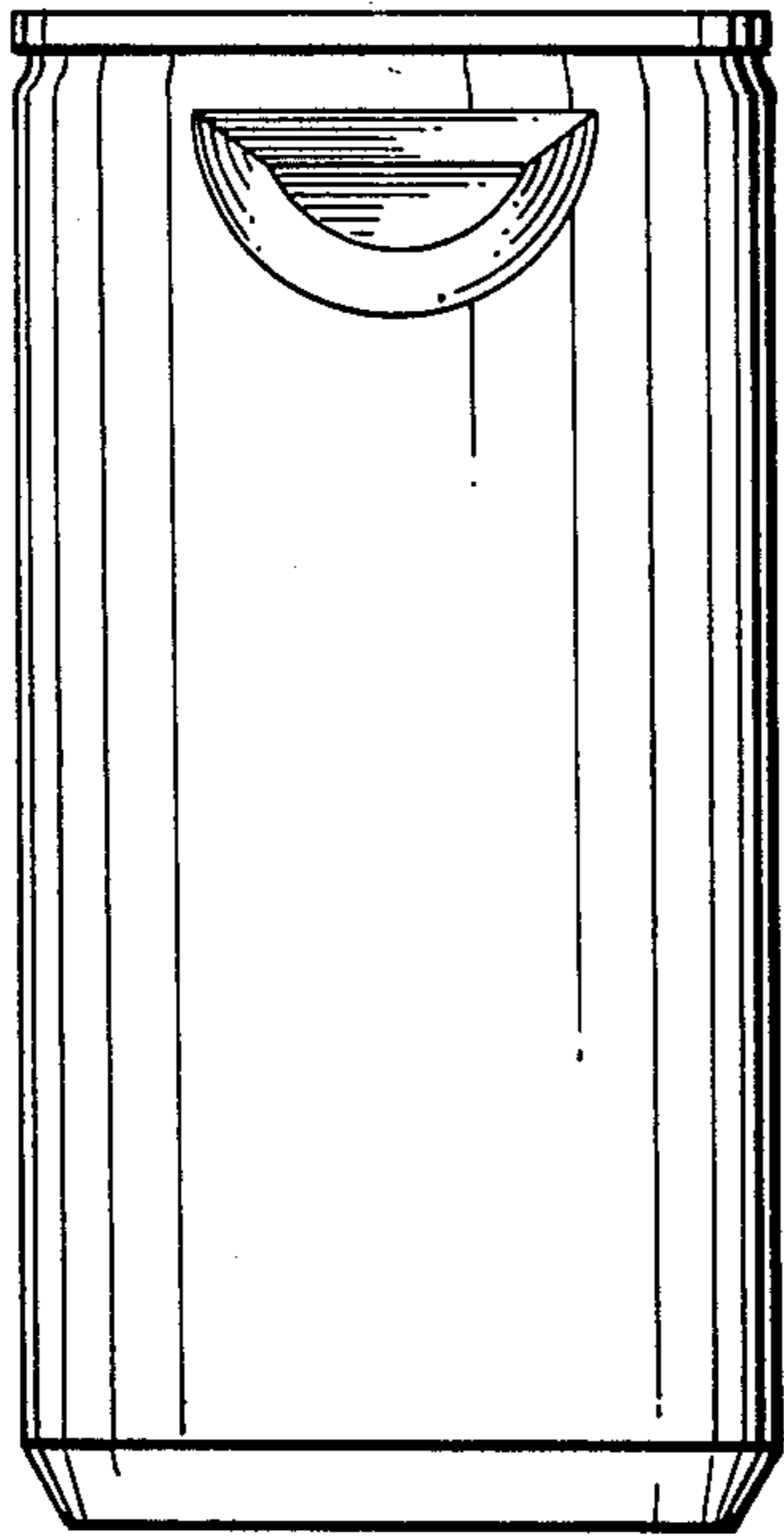

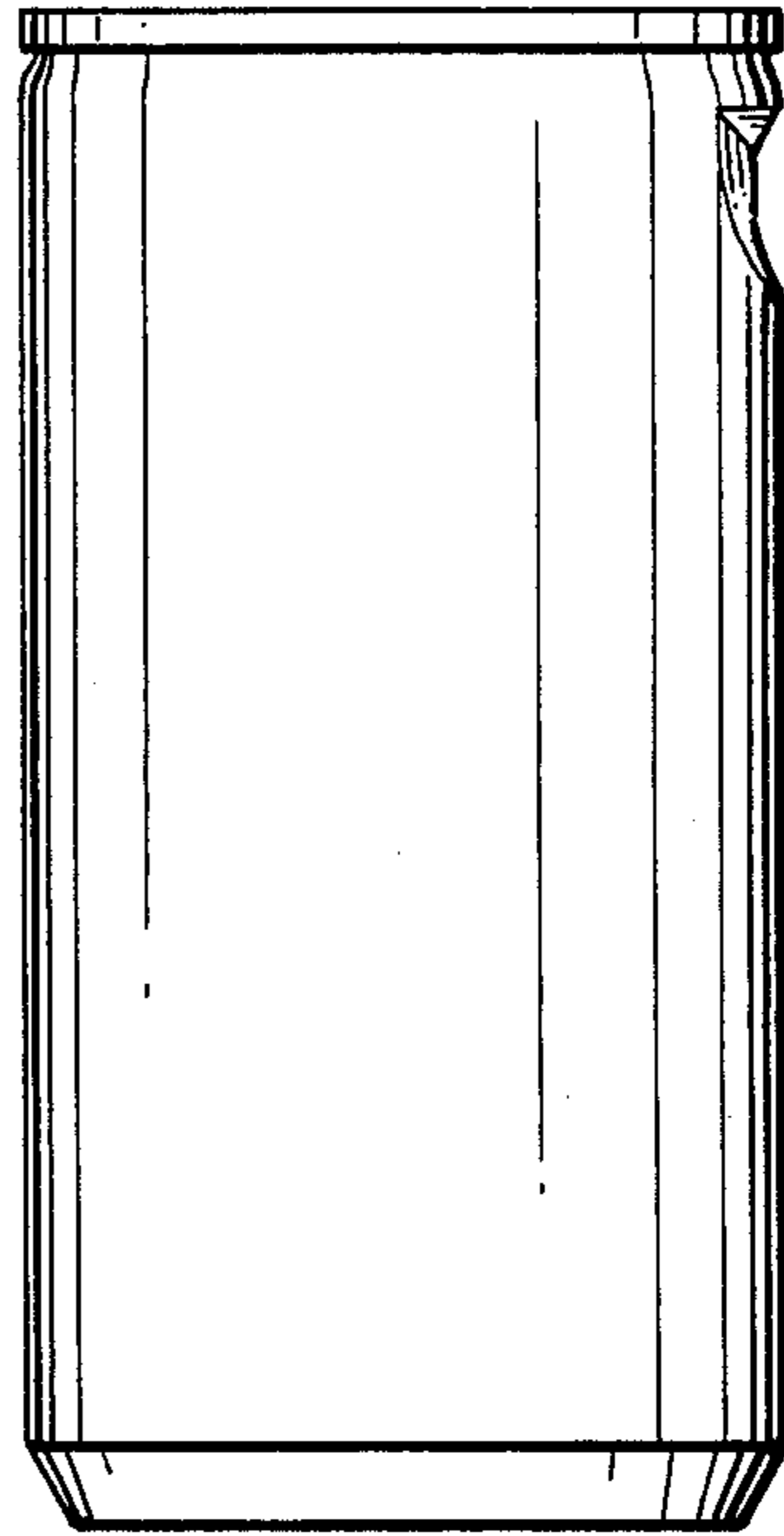

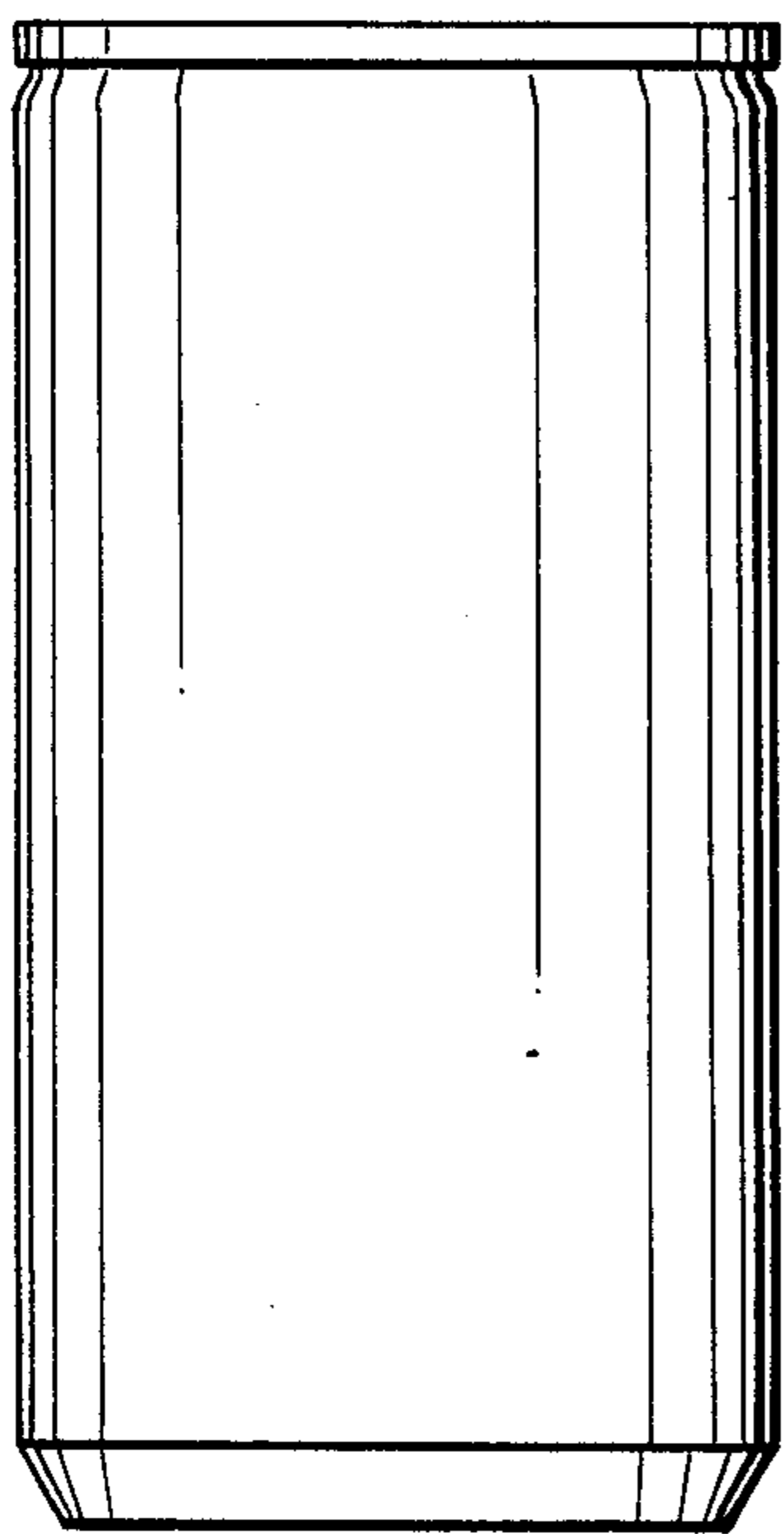

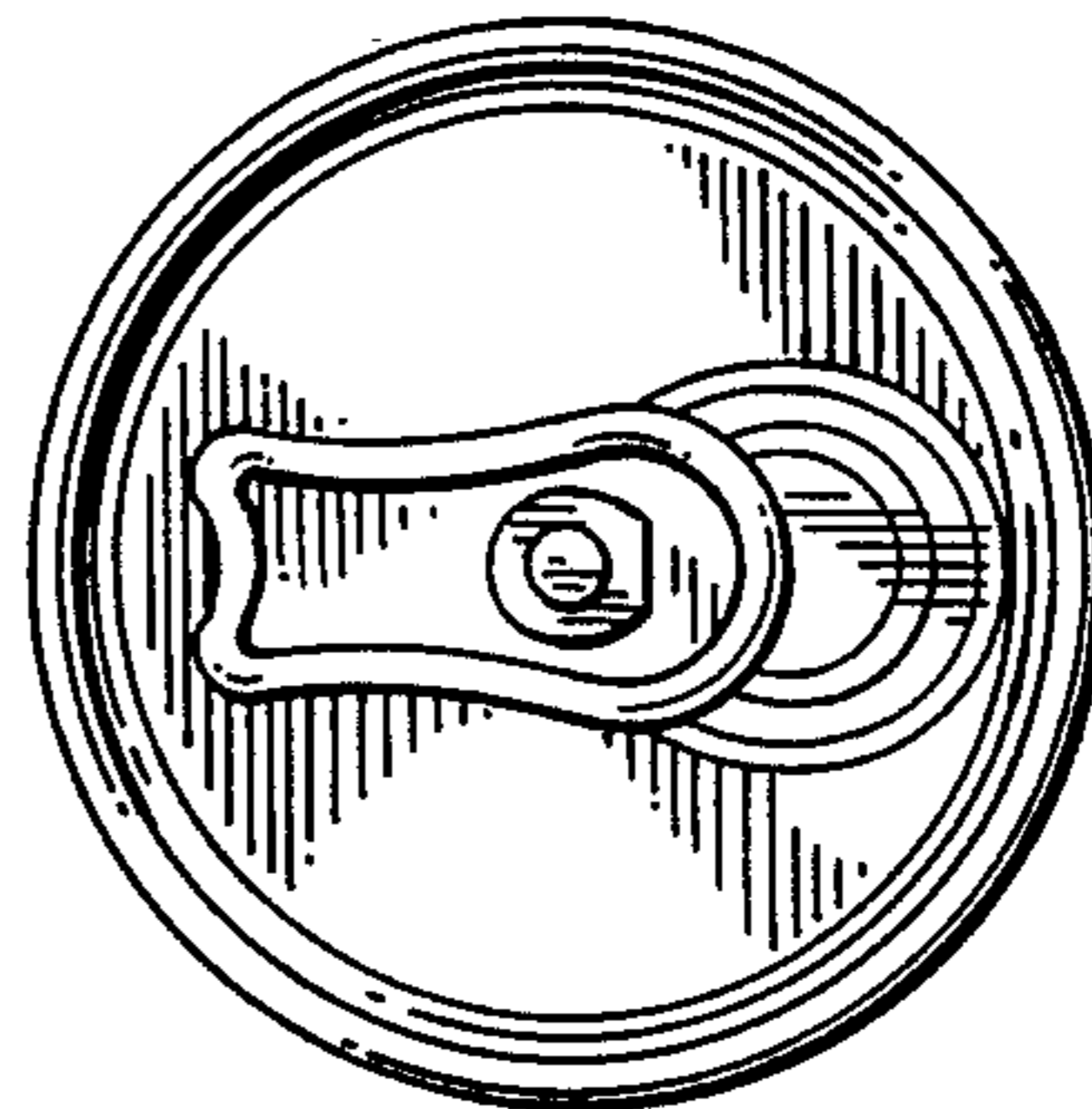

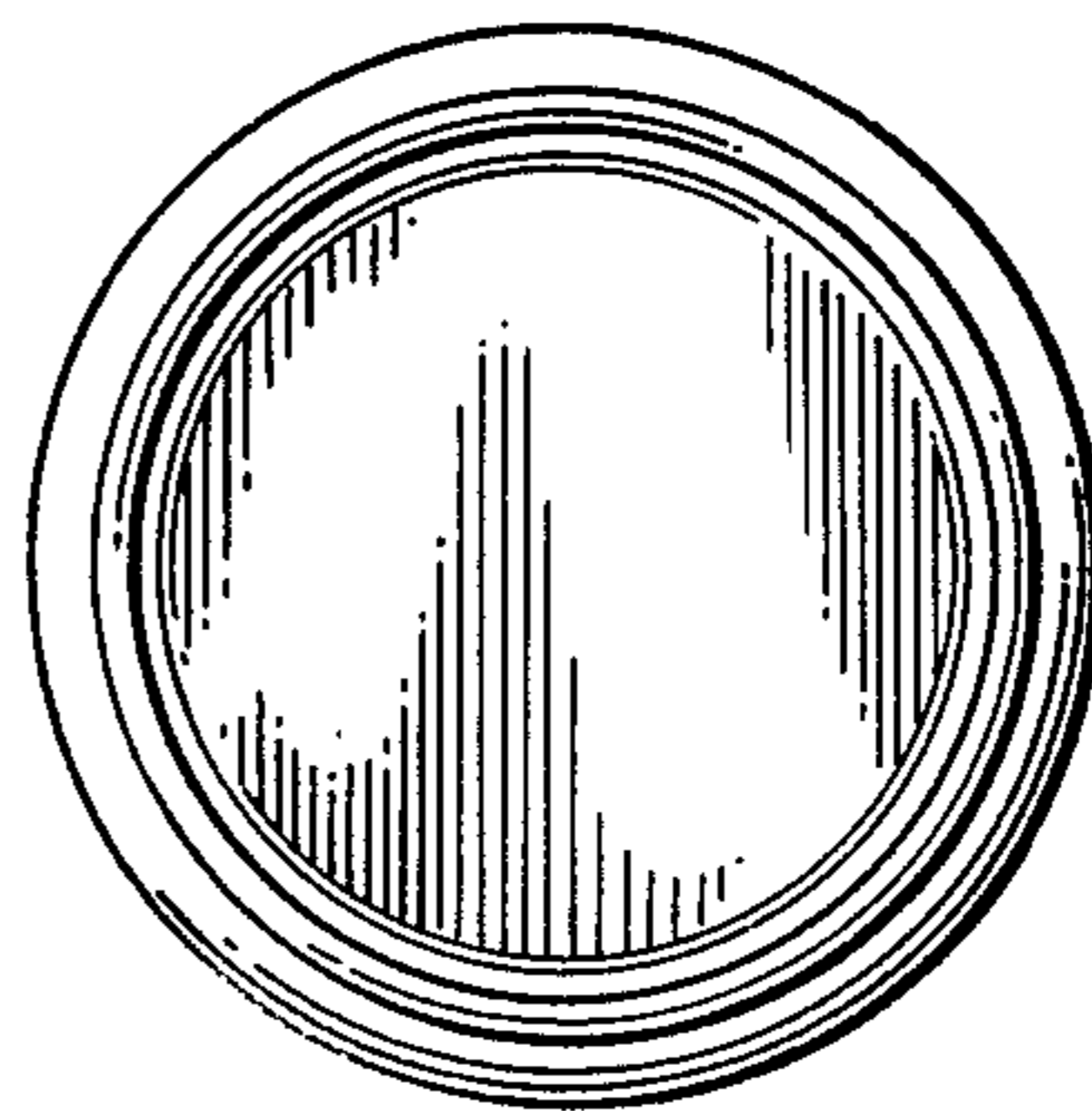

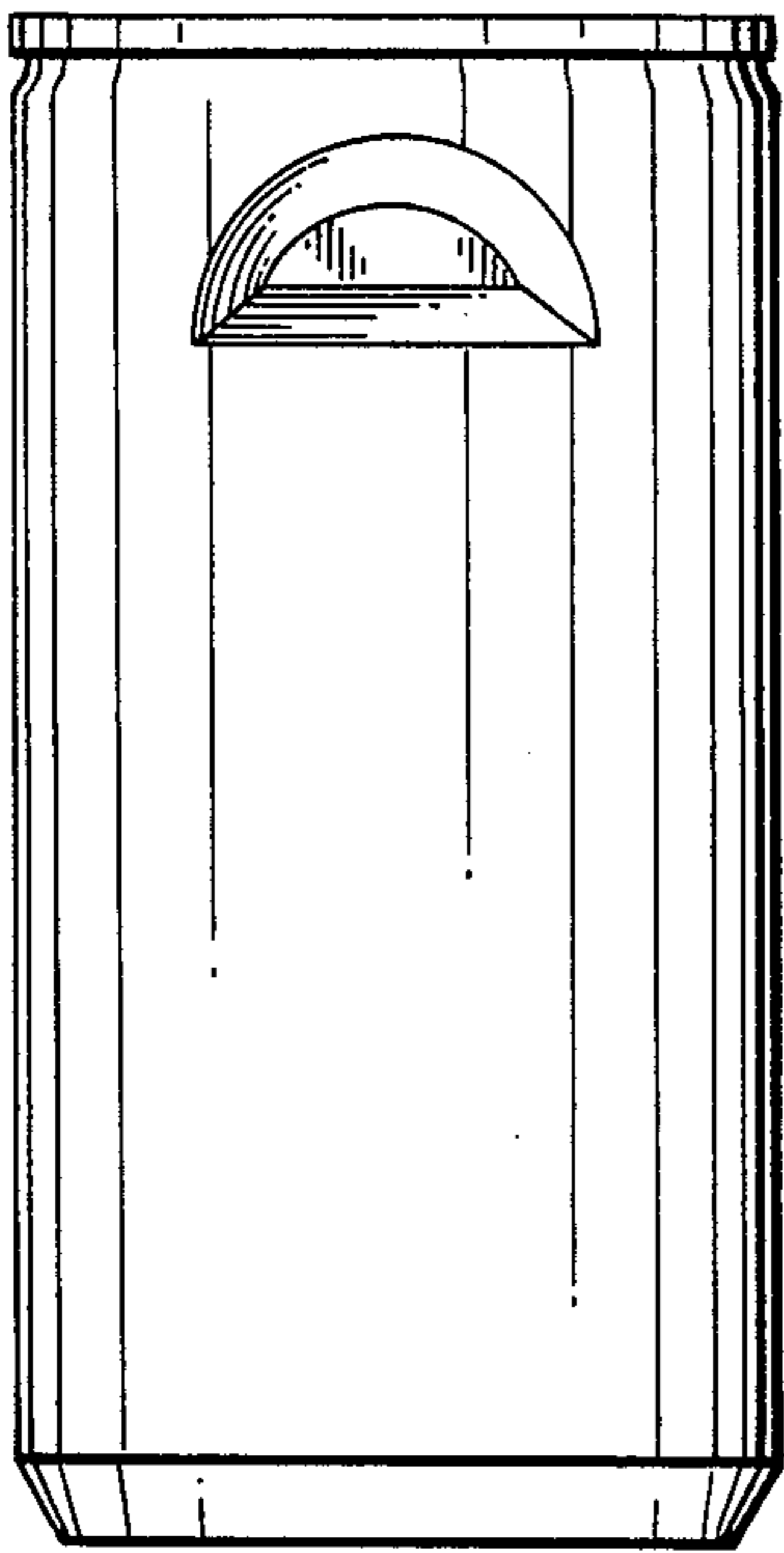

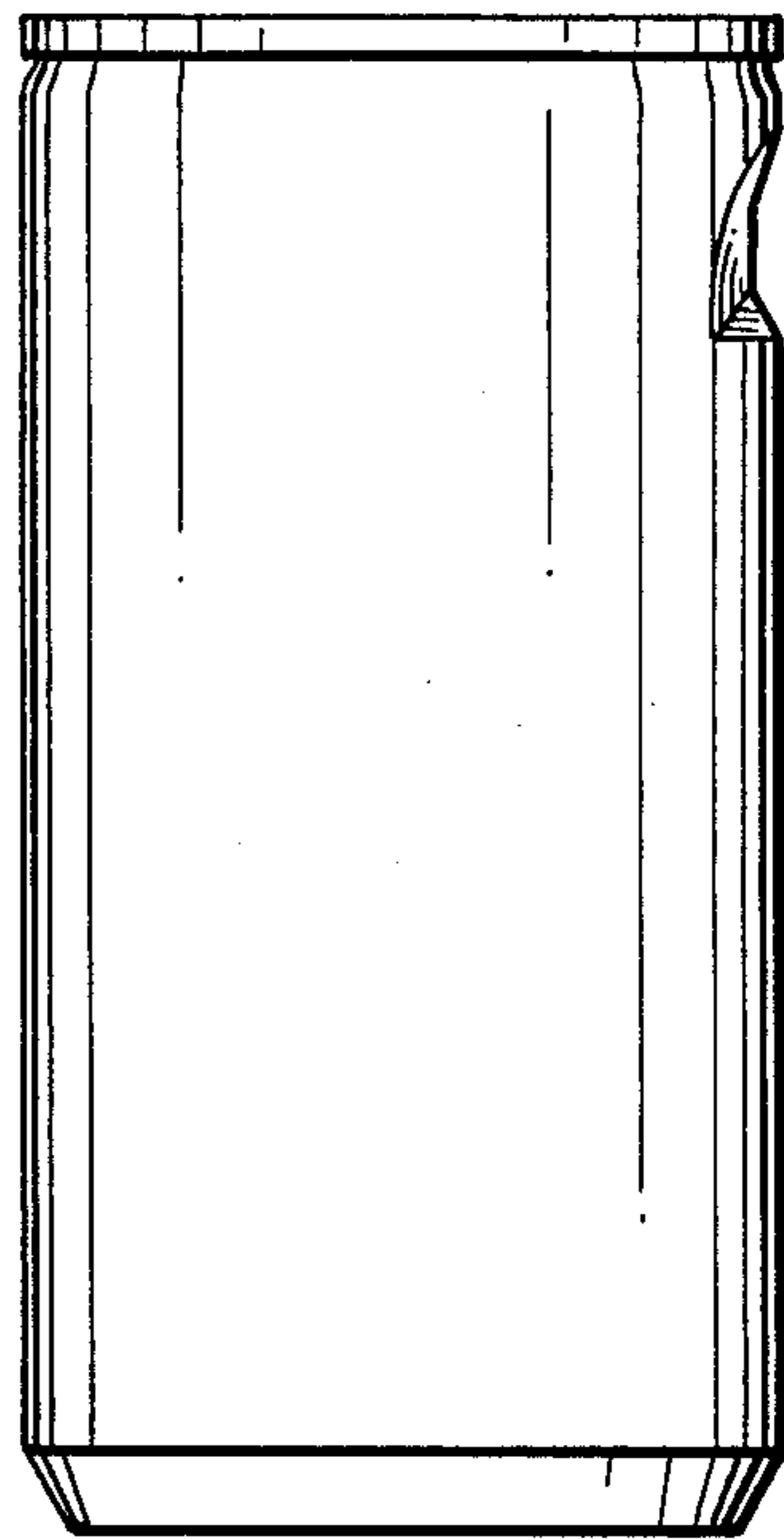

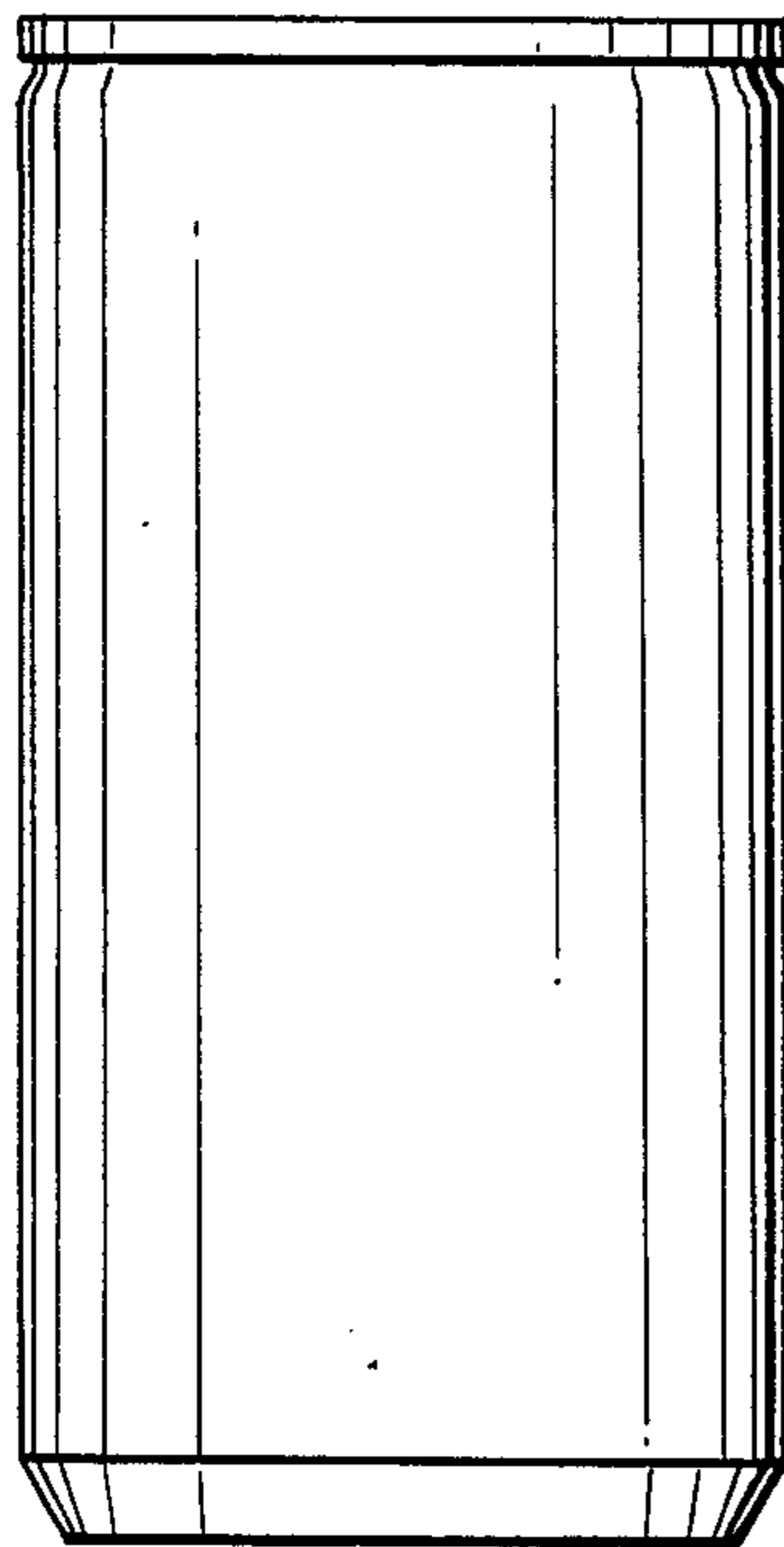

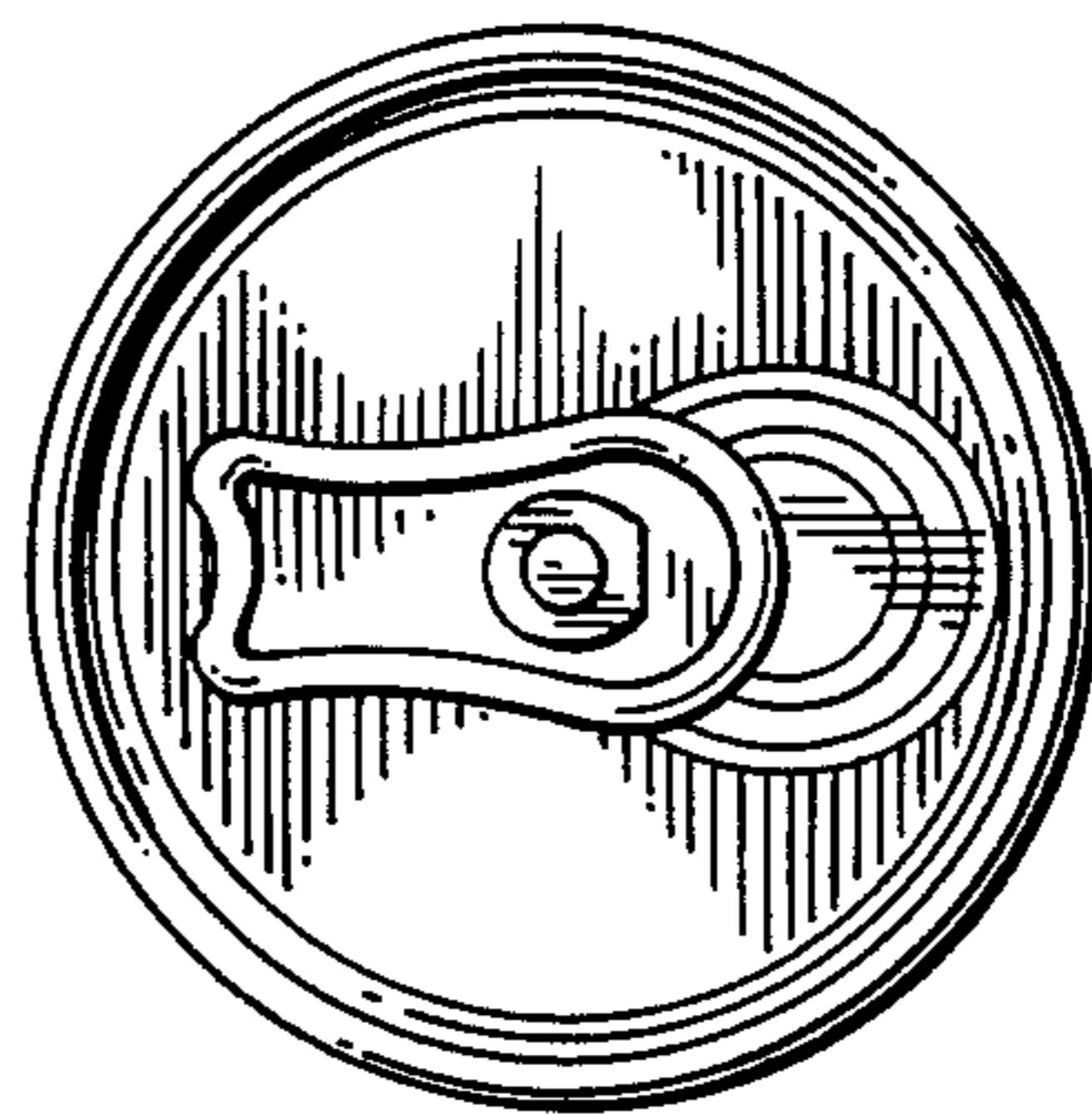

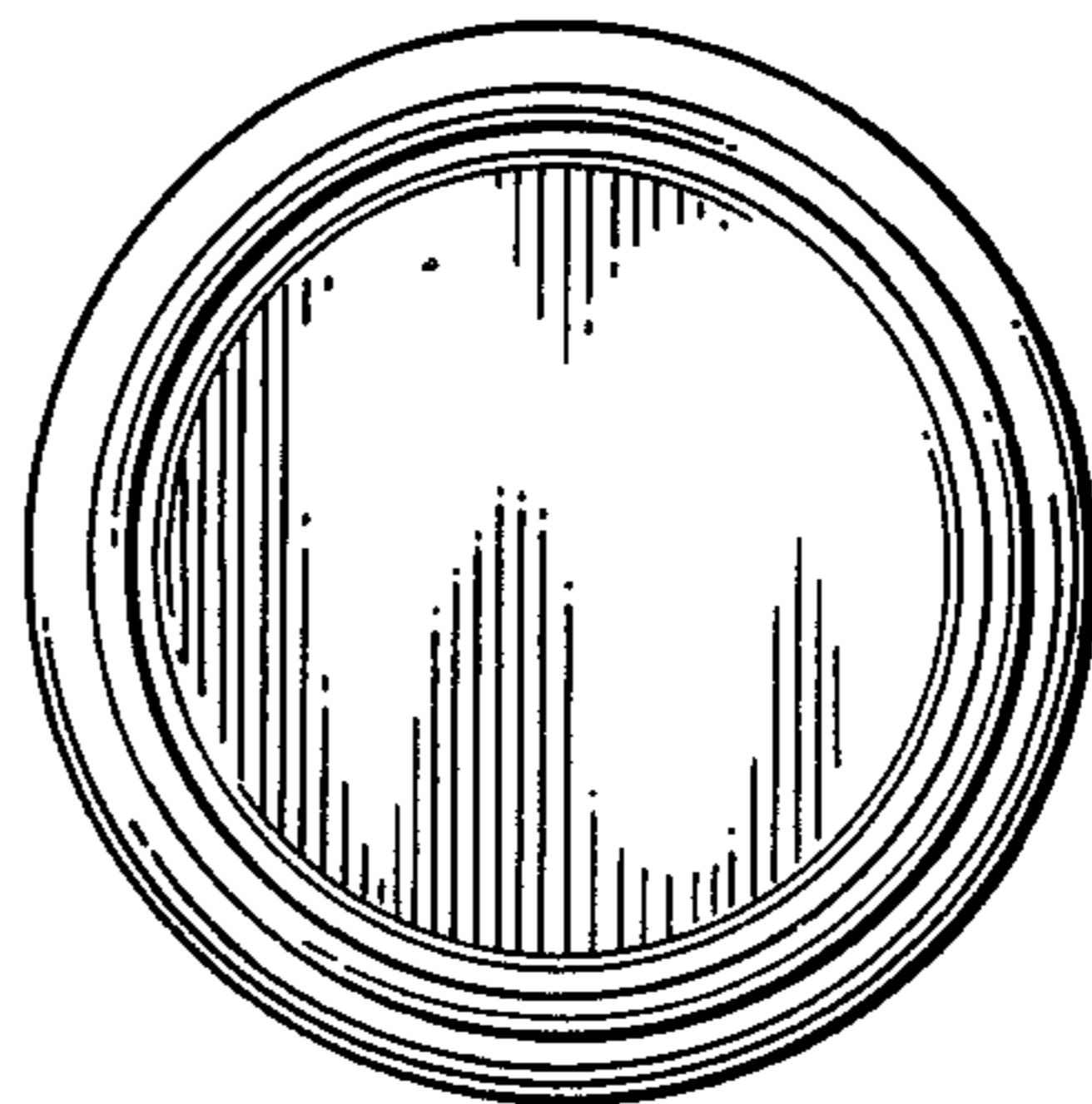
