DESCRIPTION

FIG. 1 is a front elevation of a bottle showing my new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a left side elevation thereof; and,
FIG. 5 is a right side elevation thereof.
The rear elevation not shown is a mirror image of the front elevation shown in FIG. 1.

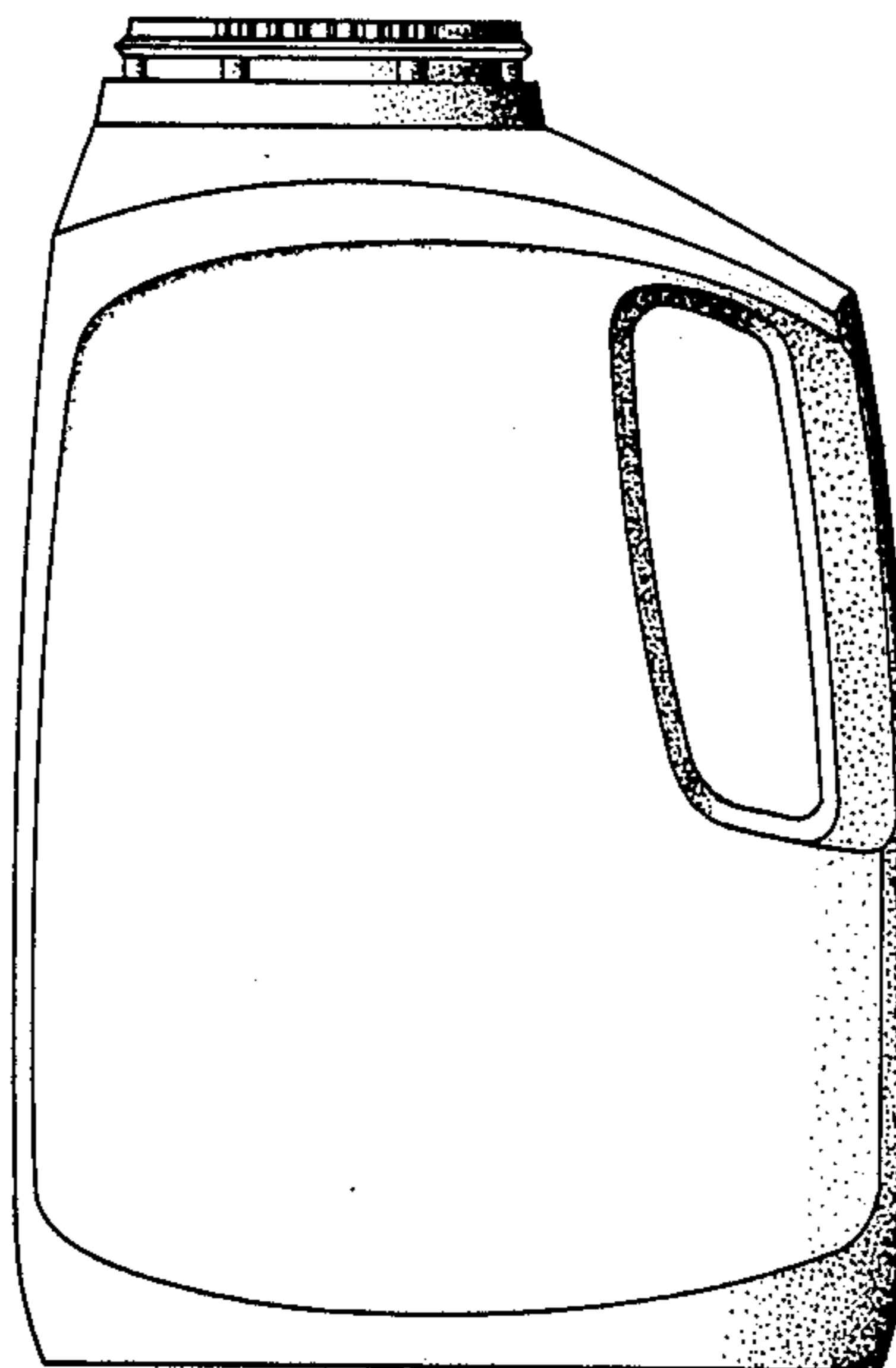

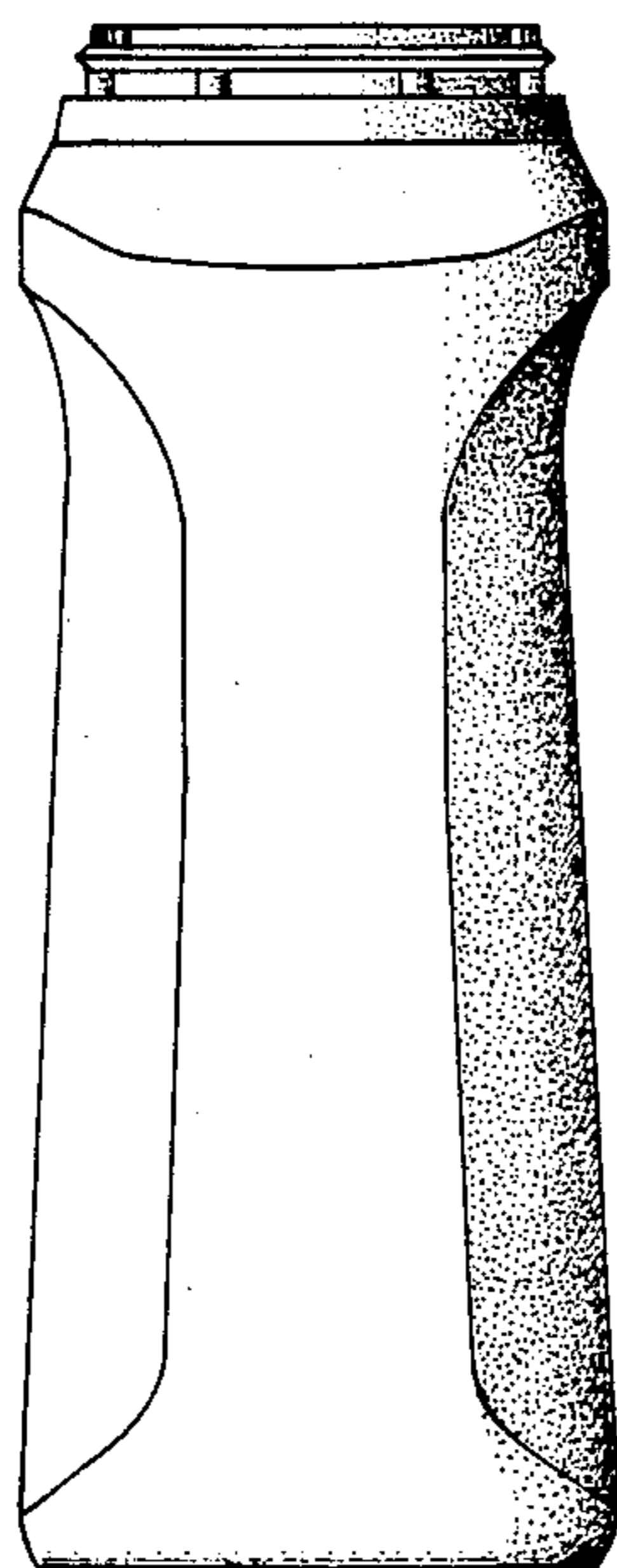

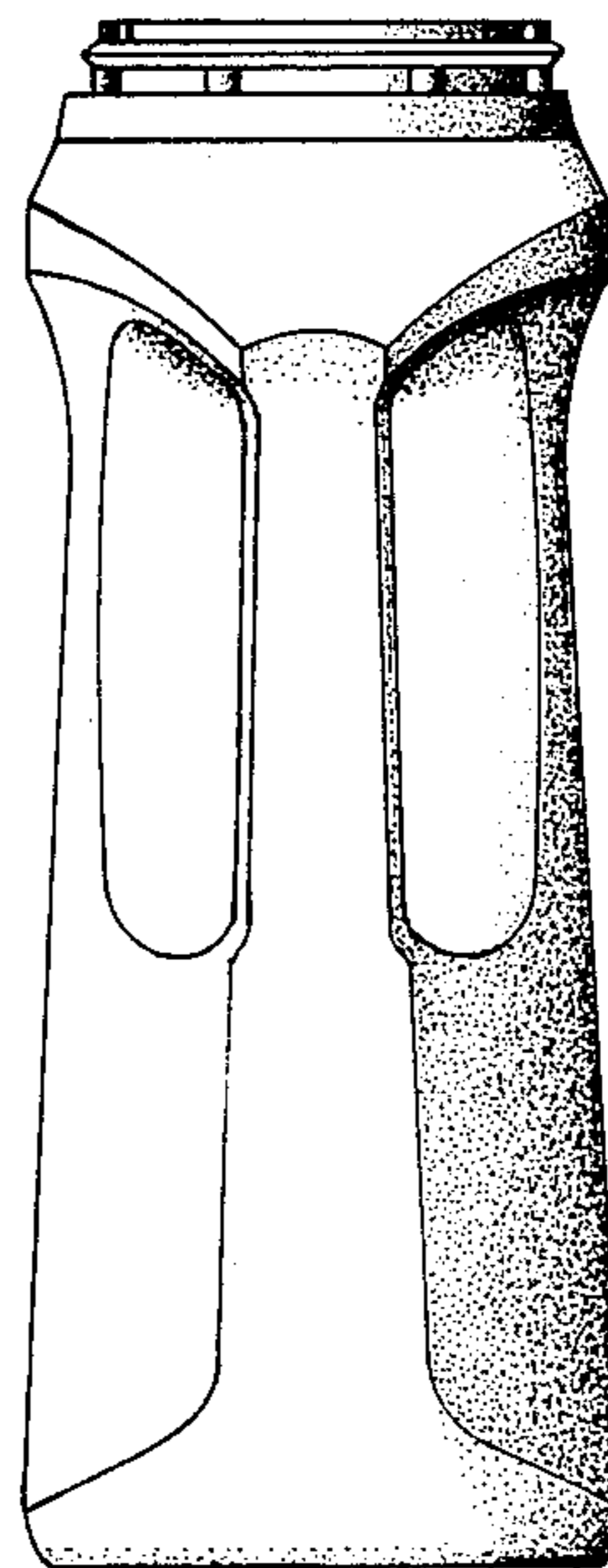

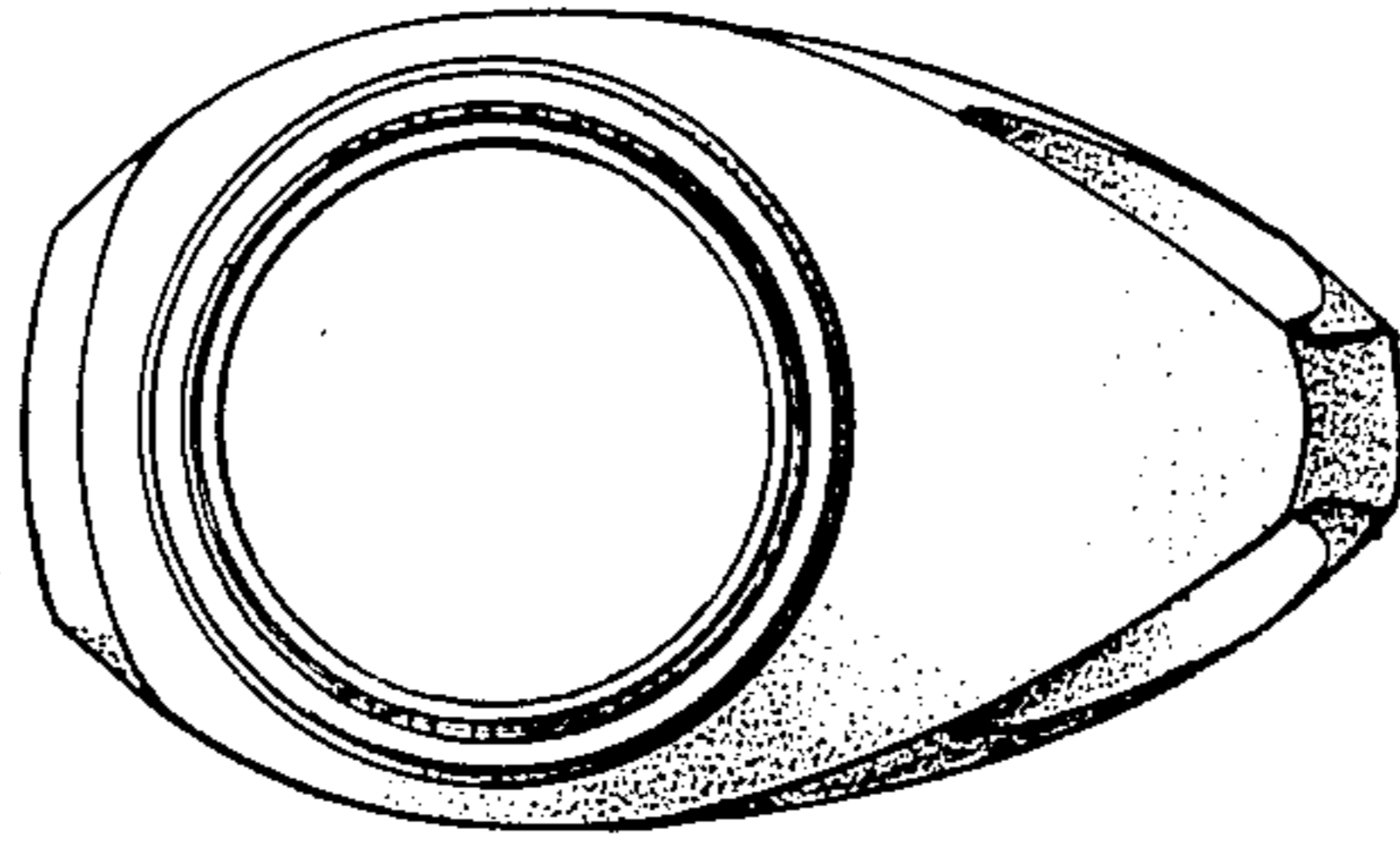

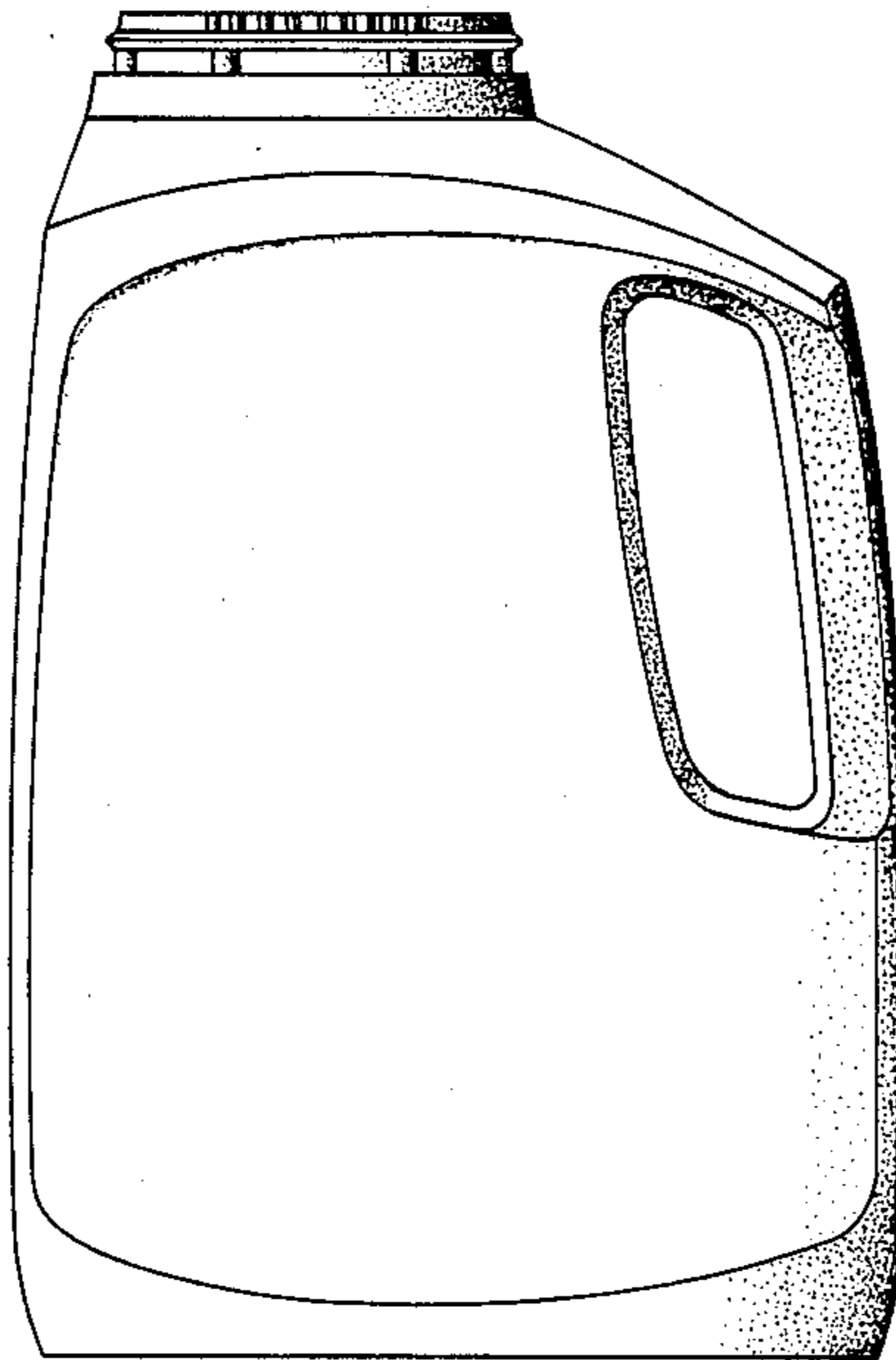
