[57] CLAIM

The ornamental design for a pressure dome for coupling the blood pressure of a patient to a transducer that generates an electrical signal corresponding to pressure, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a pressure dome for coupling the blood pressure of a patient to a transducer that generates an electrical signal corresponding to pressure, showing my new design;

FIG. 2 is a top plan view of FIGS. 1 and 3;

FIG. 3 is a perspective view of a second embodiment of FIG. 1;

FIG. 4 is a bottom plan view of FIG. 3;

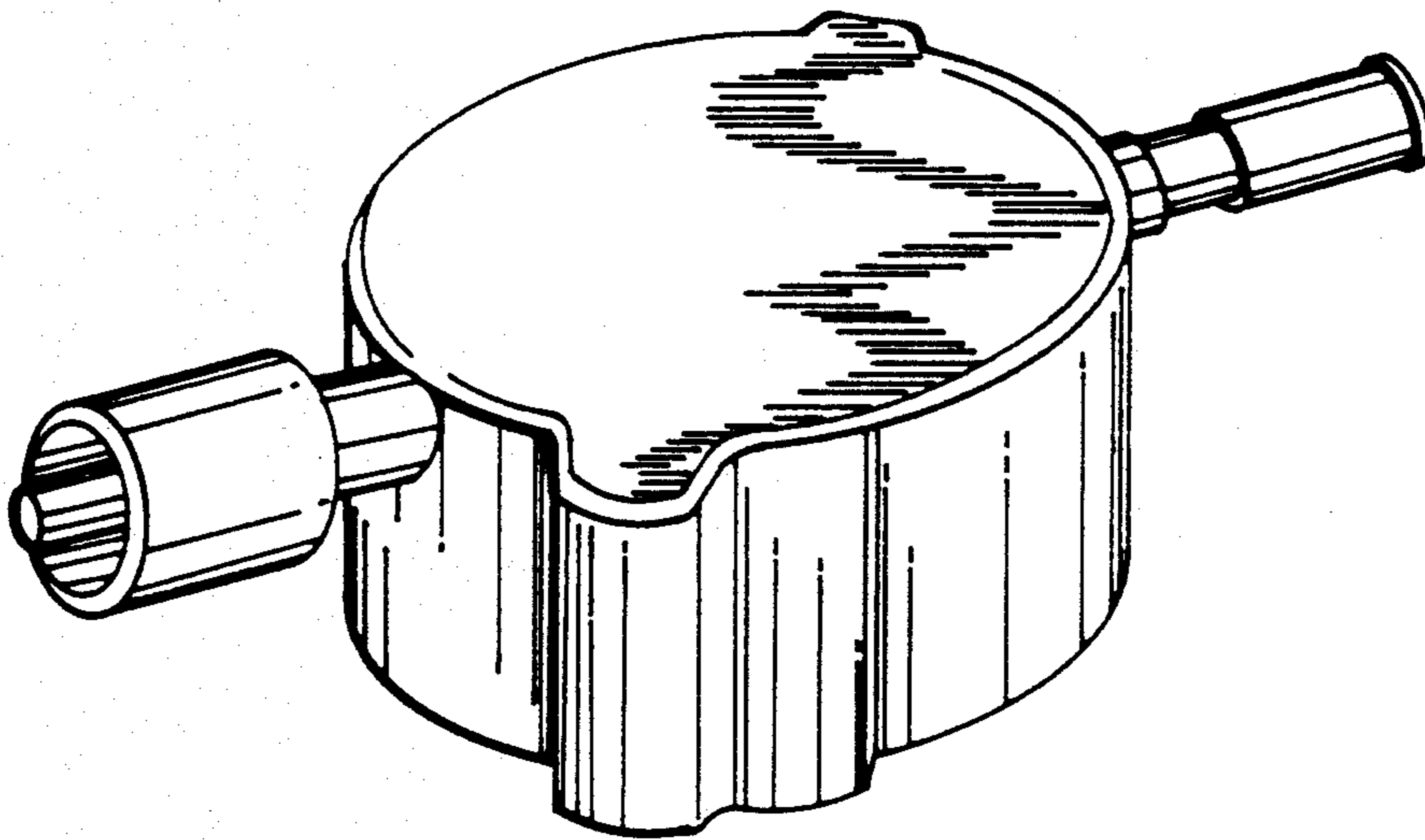
FIG. 5 is a bottom plan view of FIG. 1;

FIG. 9 is a back elevational view of FIG. 3.



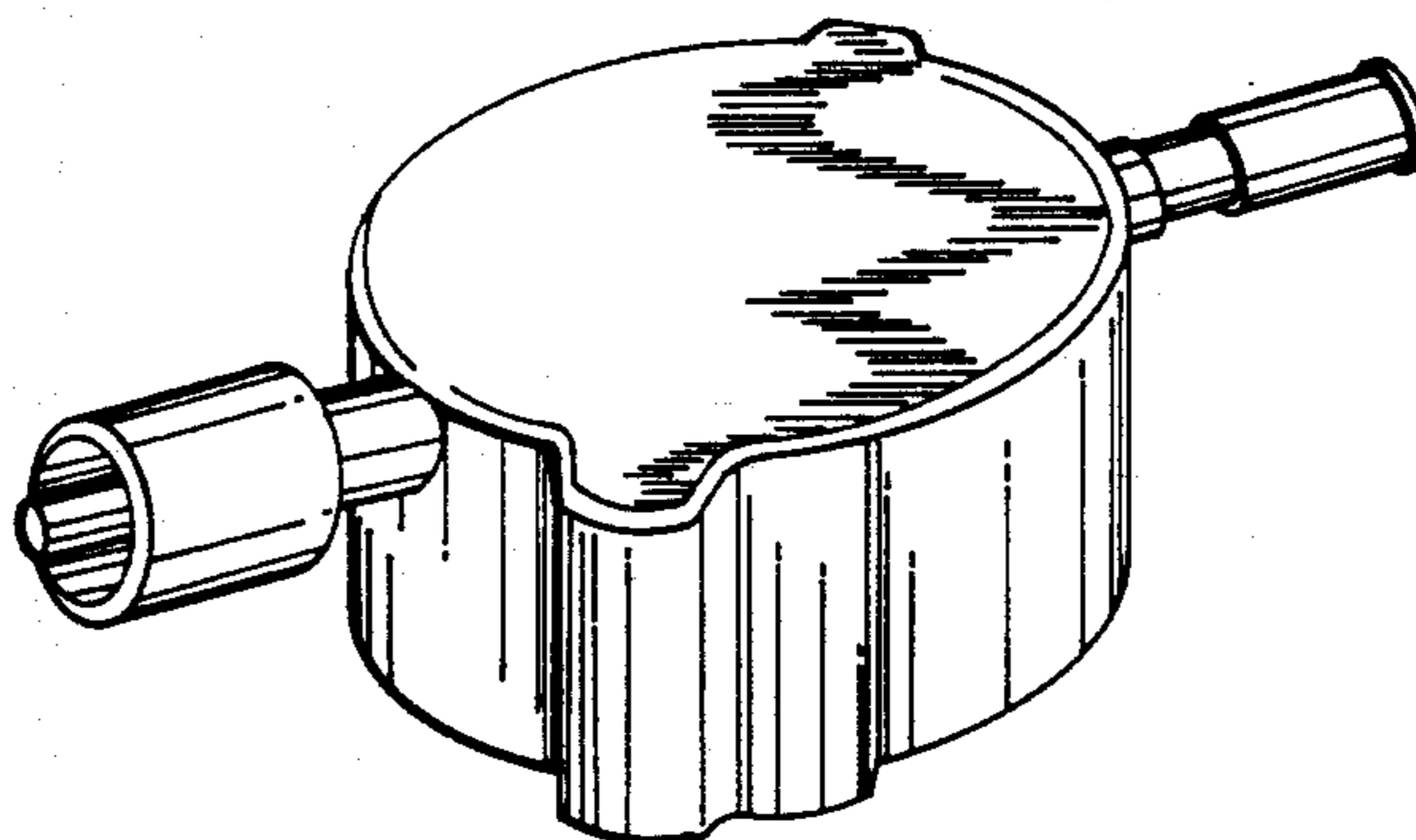

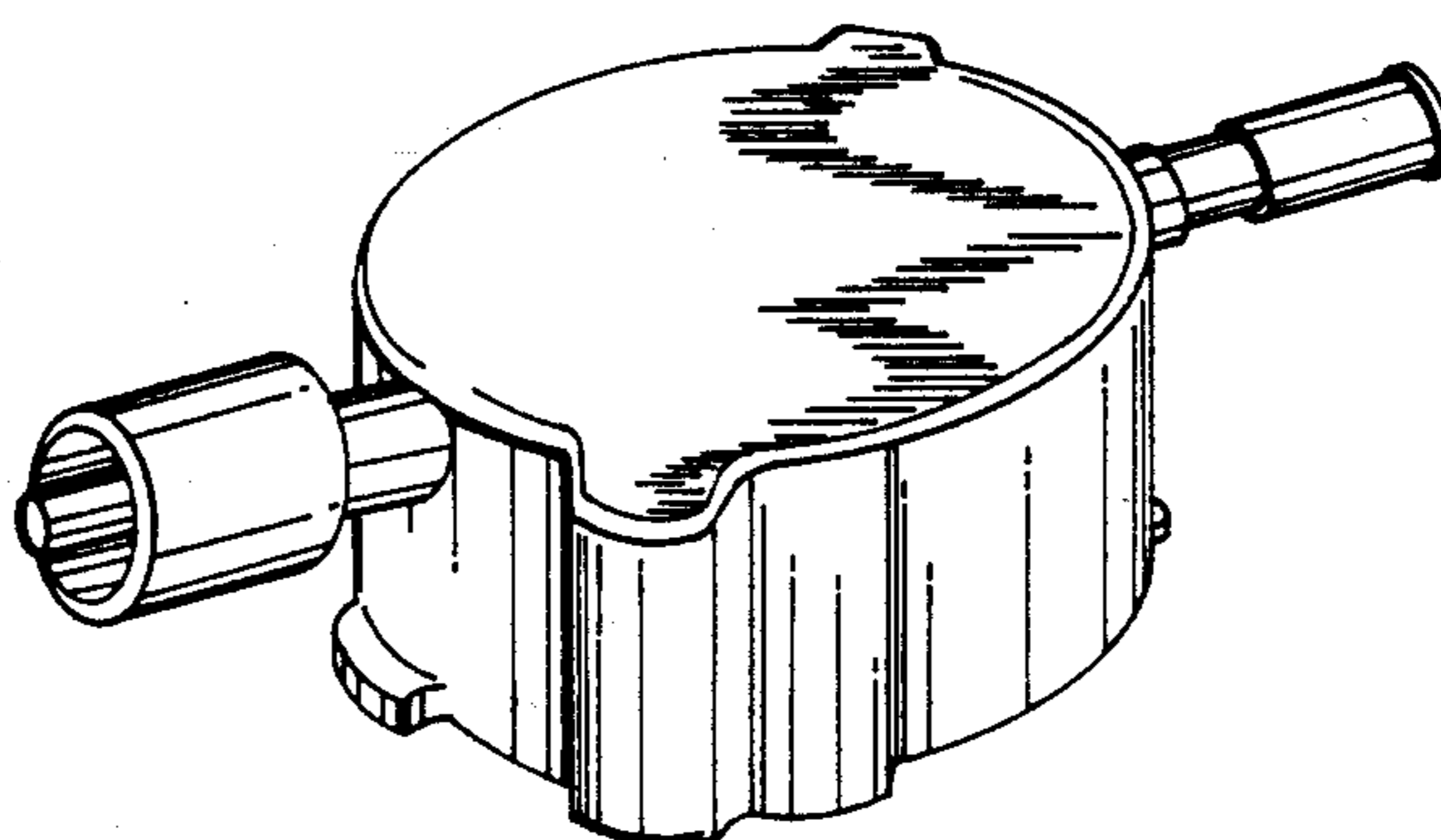

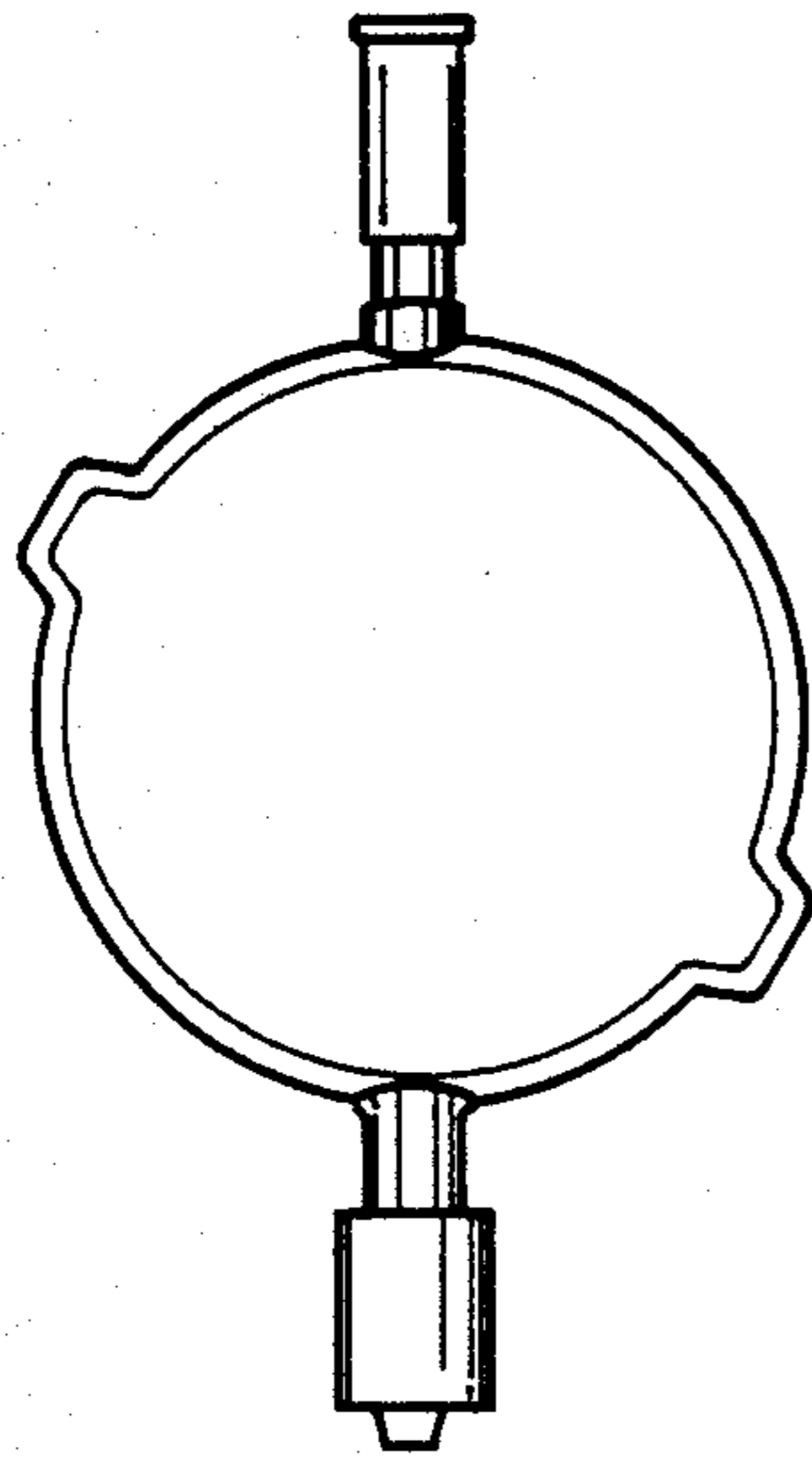

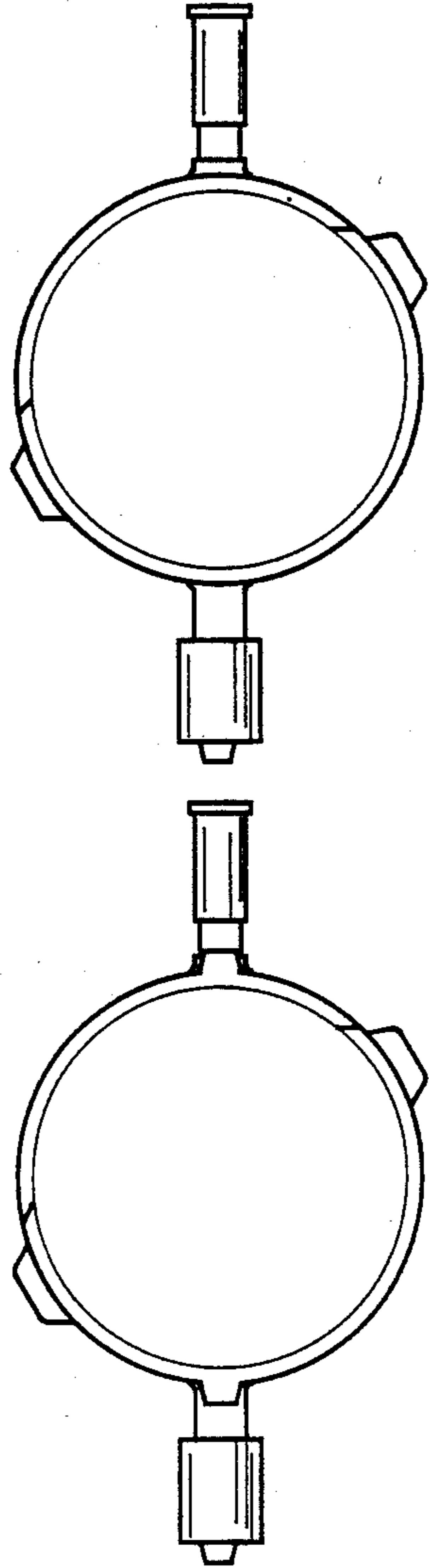

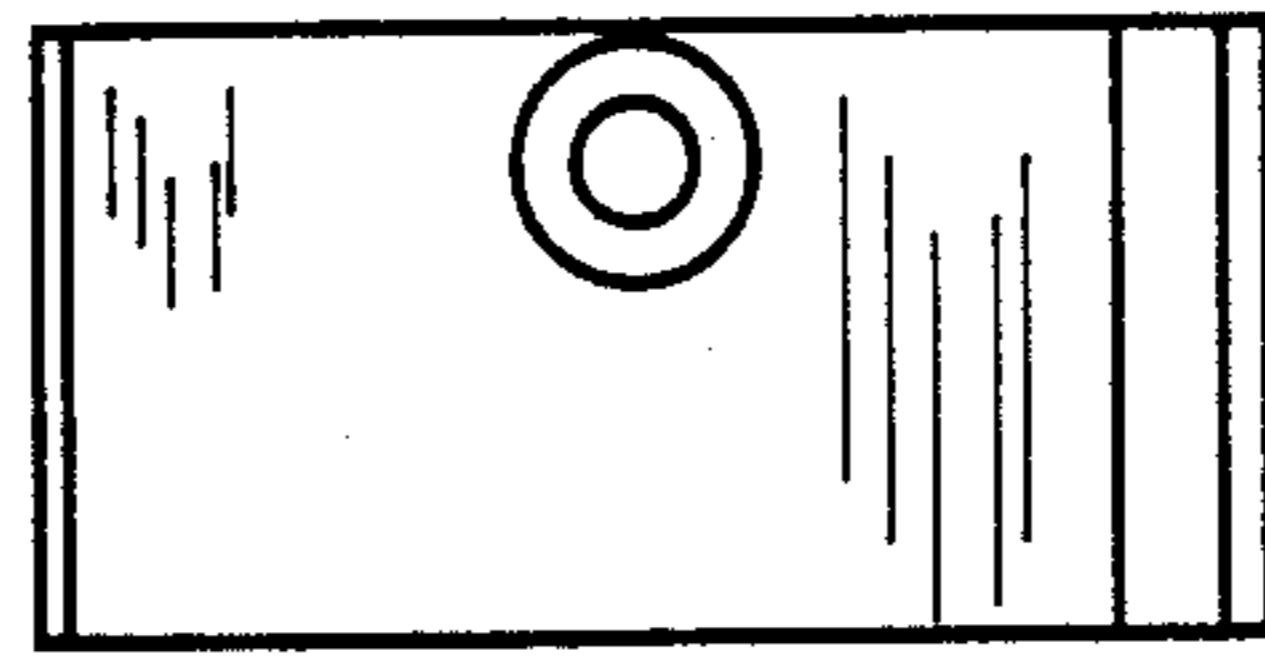

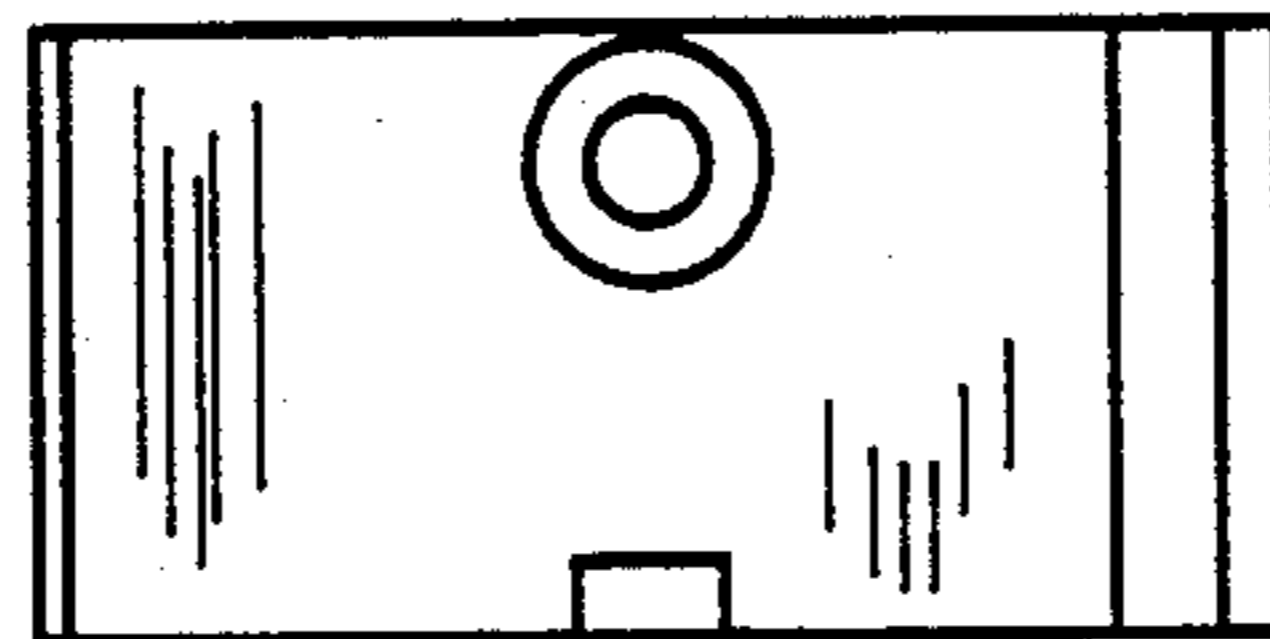

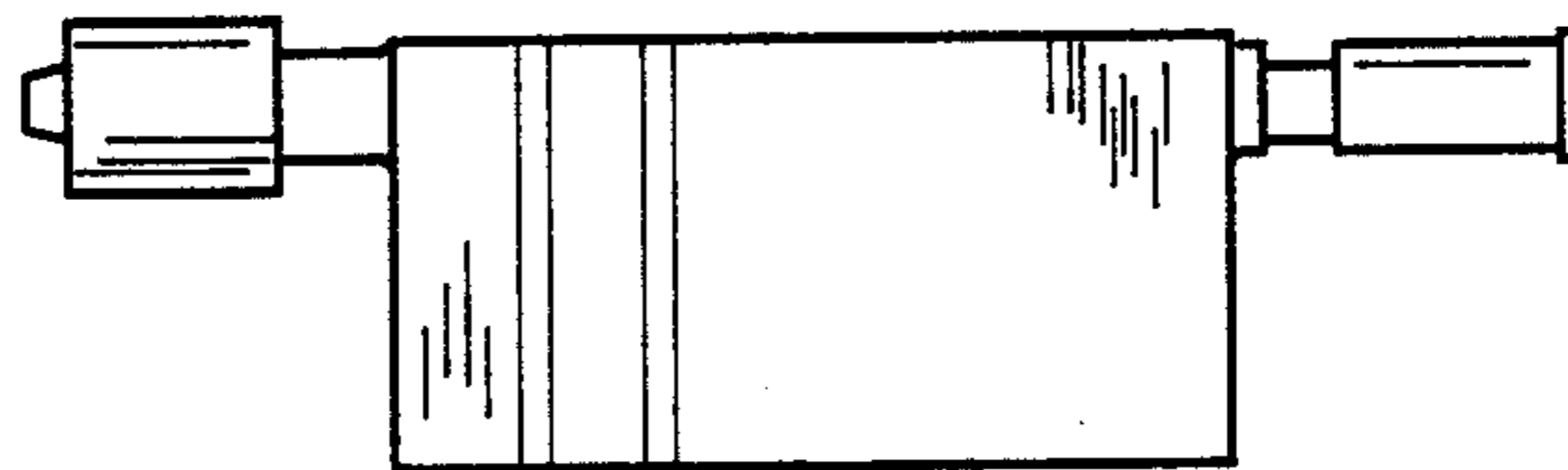

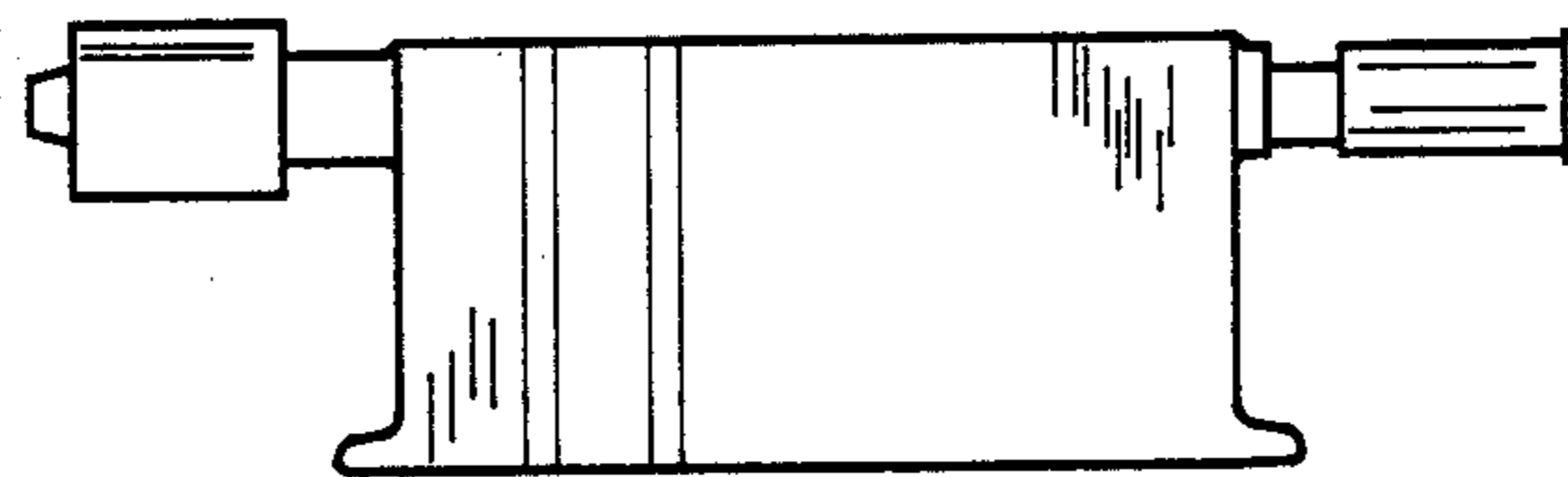
