[57] **CLAIM**

The ornamental design for a light fixture, as shown and described.

DESCRIPTION

FIG. 1 is an elevational view of a light fixture showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a bottom plan view thereof;

FIG. 4 is a cross-sectional view thereof as taken along line 4-4 of FIG. 1;

FIG. 5 is a cross-sectional view thereof as taken along line 5-5 of FIG. 2;

FIG. 6 is an elevational view of a second embodiment of my new design;

FIG. 7 is a top plan view thereof;

FIG. 8 is a bottom plan view thereof;

FIG. 9 is a cross-sectional view thereof as taken along line 9-9 of FIG. 6;

FIG. 10 is a cross-sectional view thereof as taken along line 10-10 of FIG. 6.

The chain is shown in broken lines for illustrative purpose only.

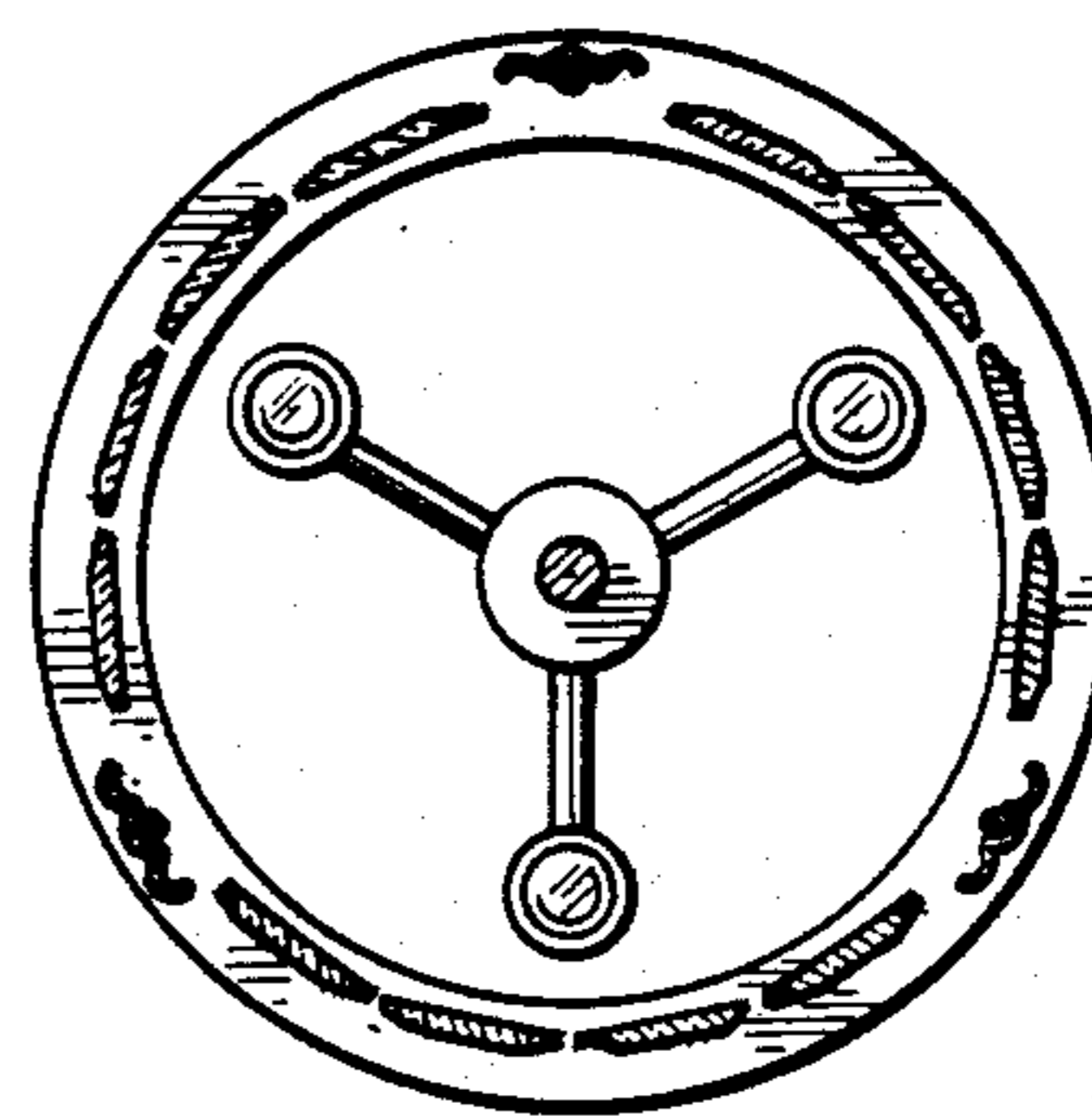
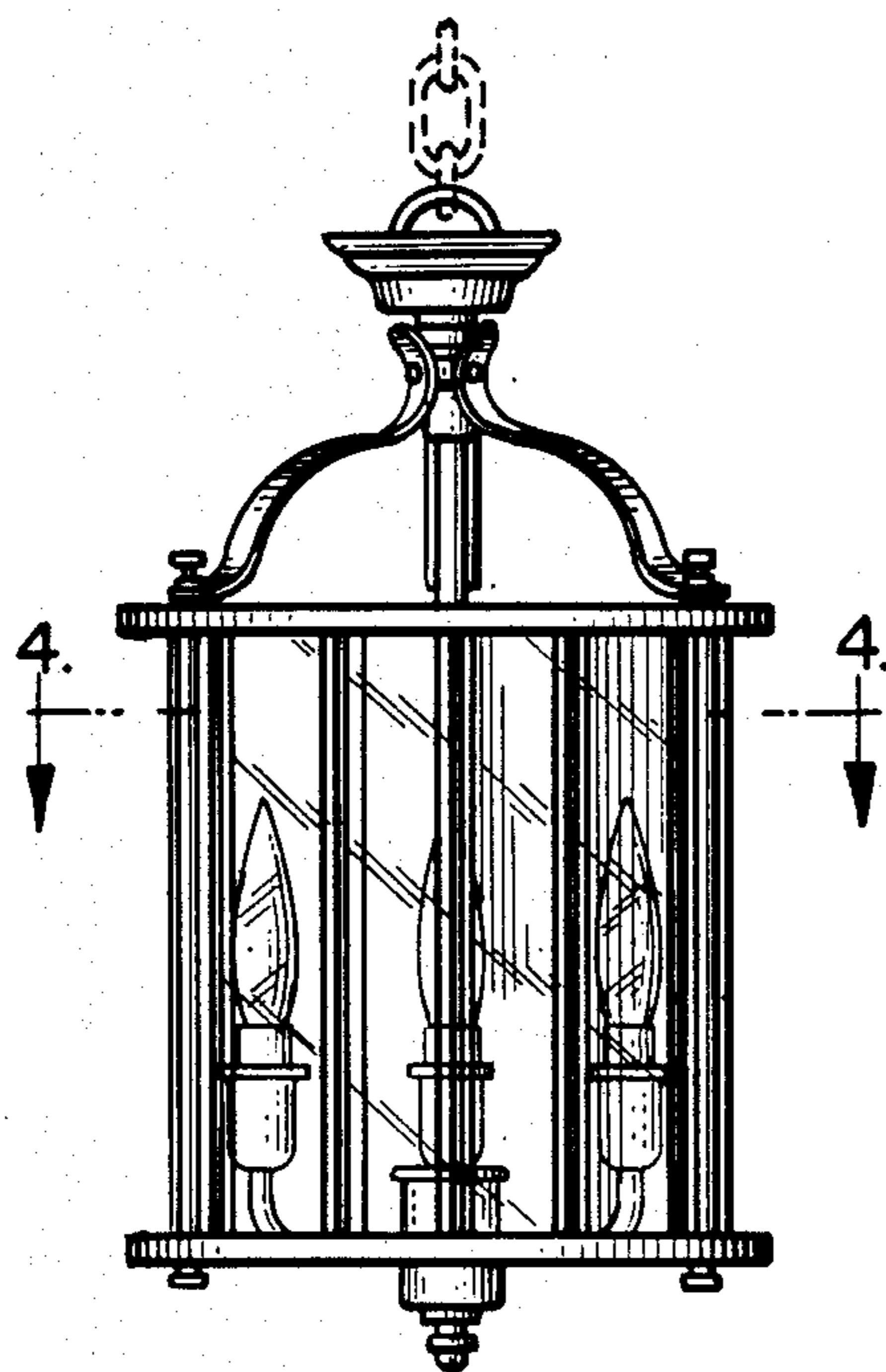

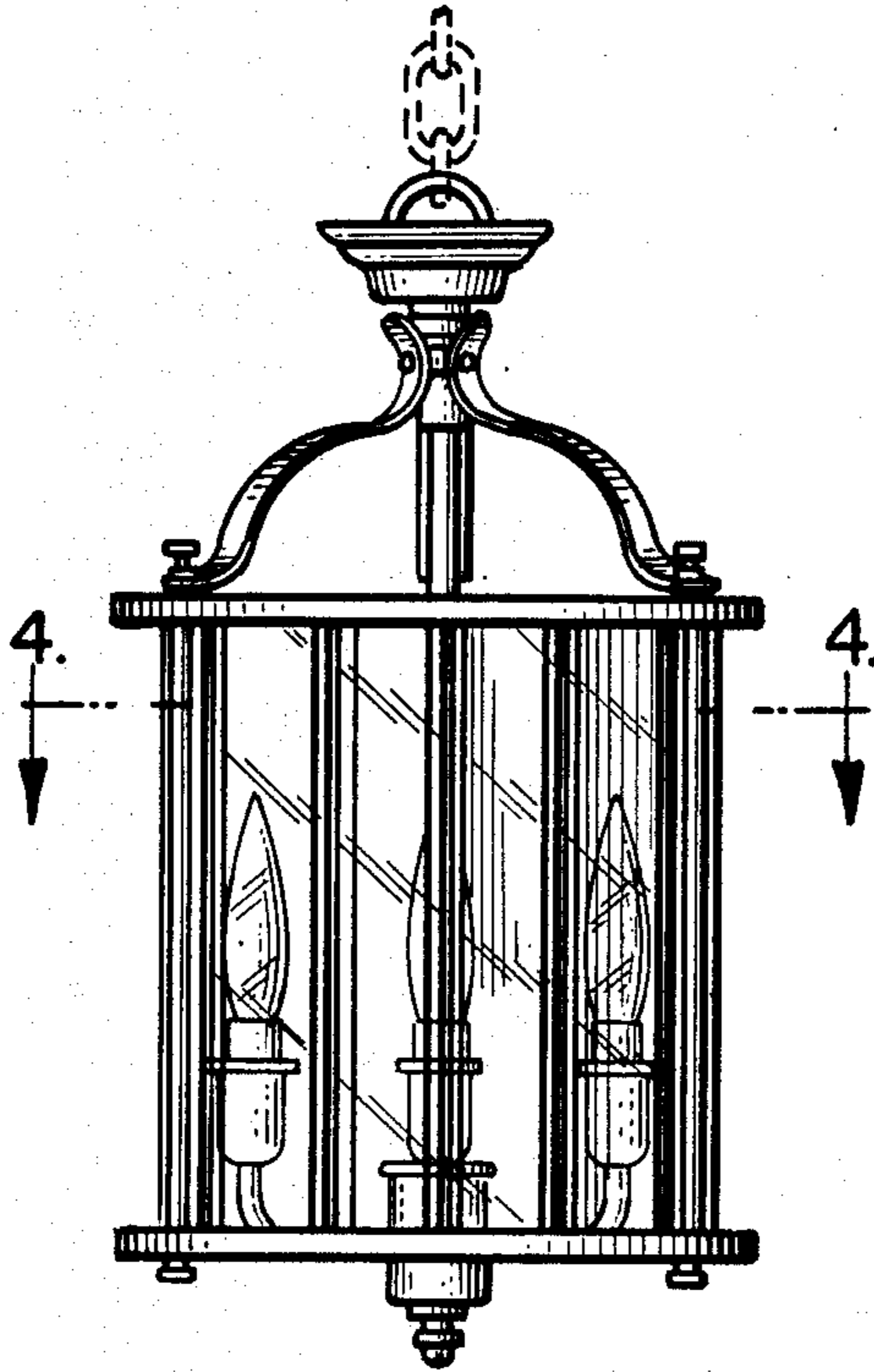

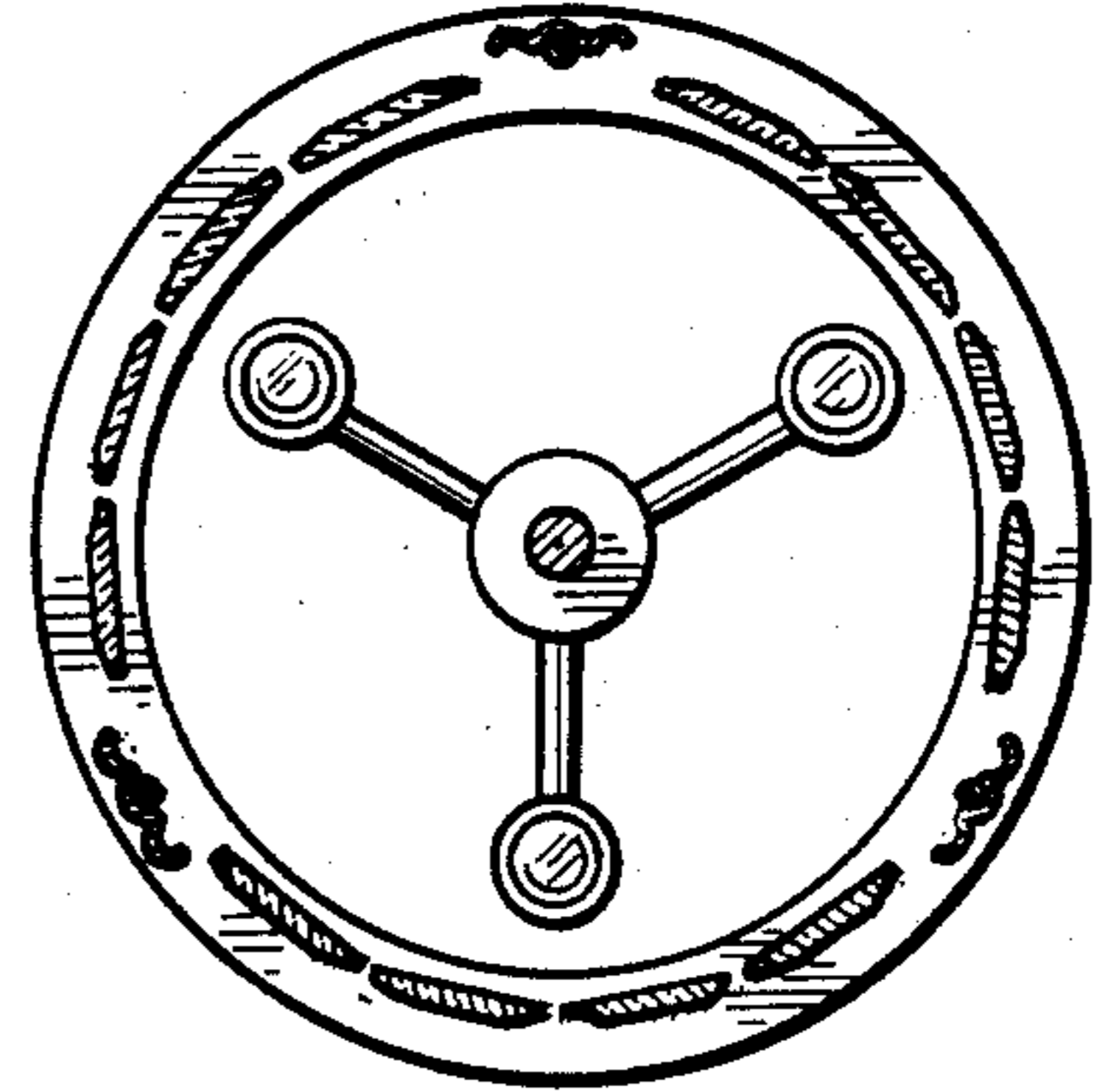

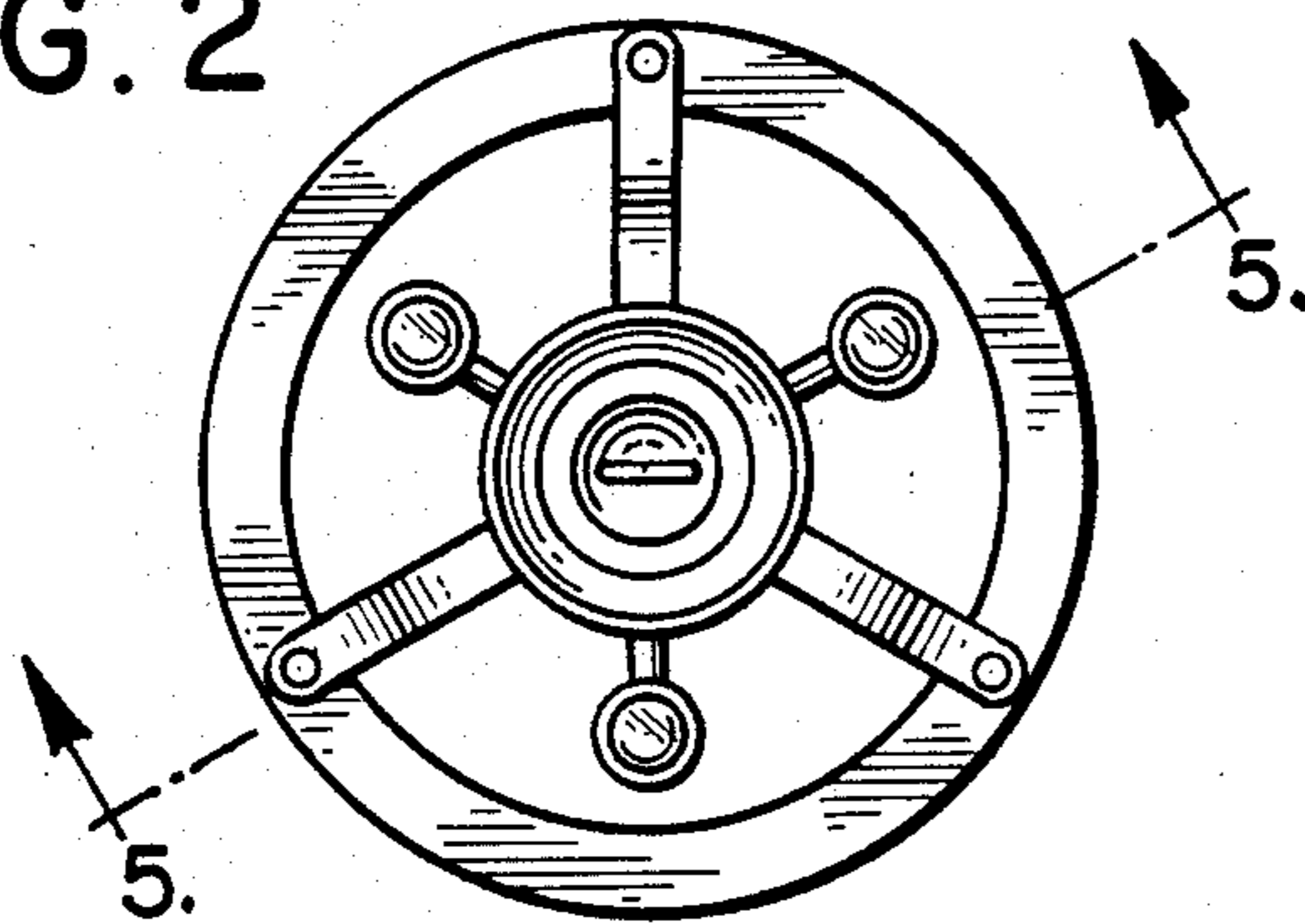

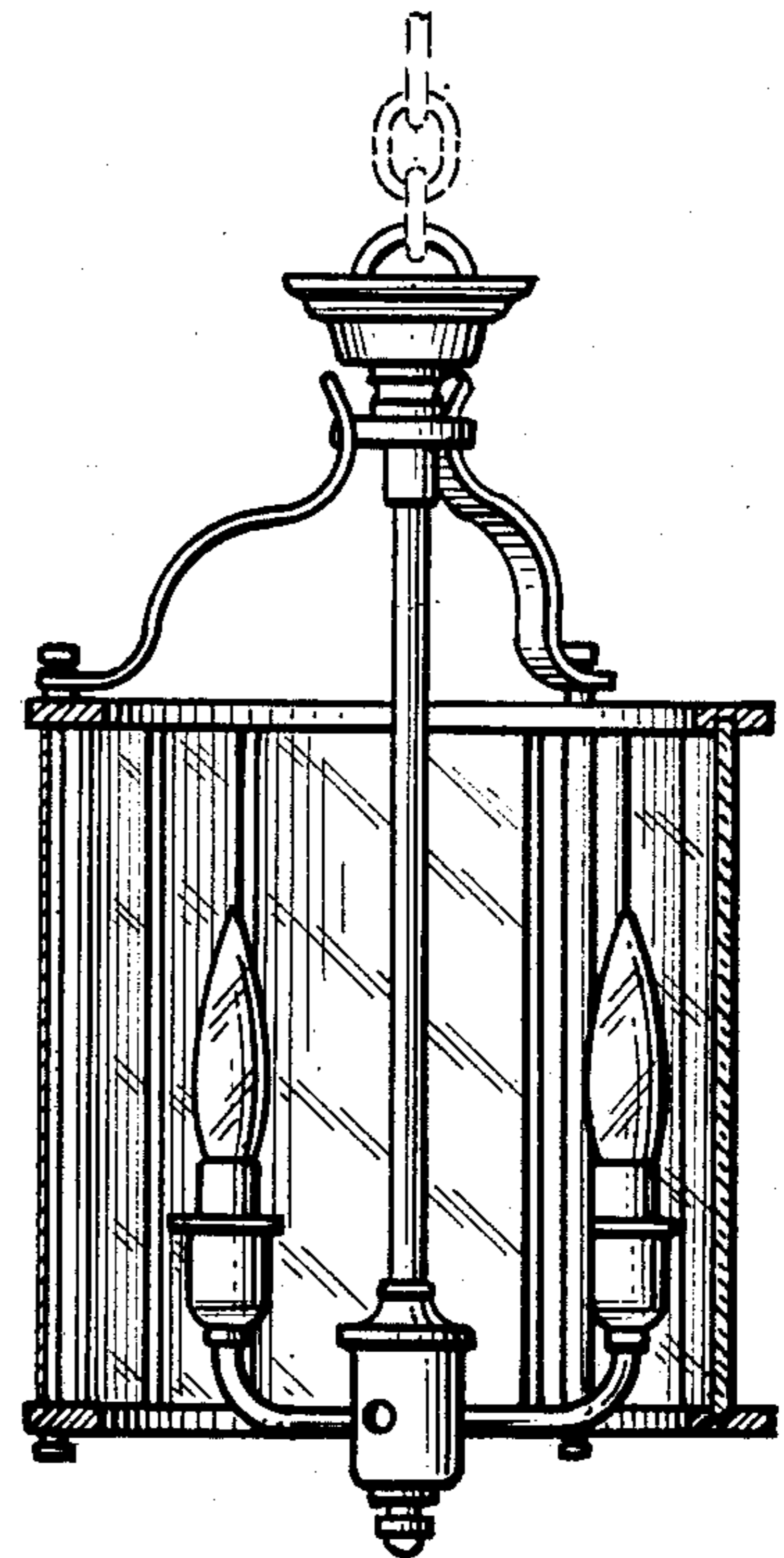

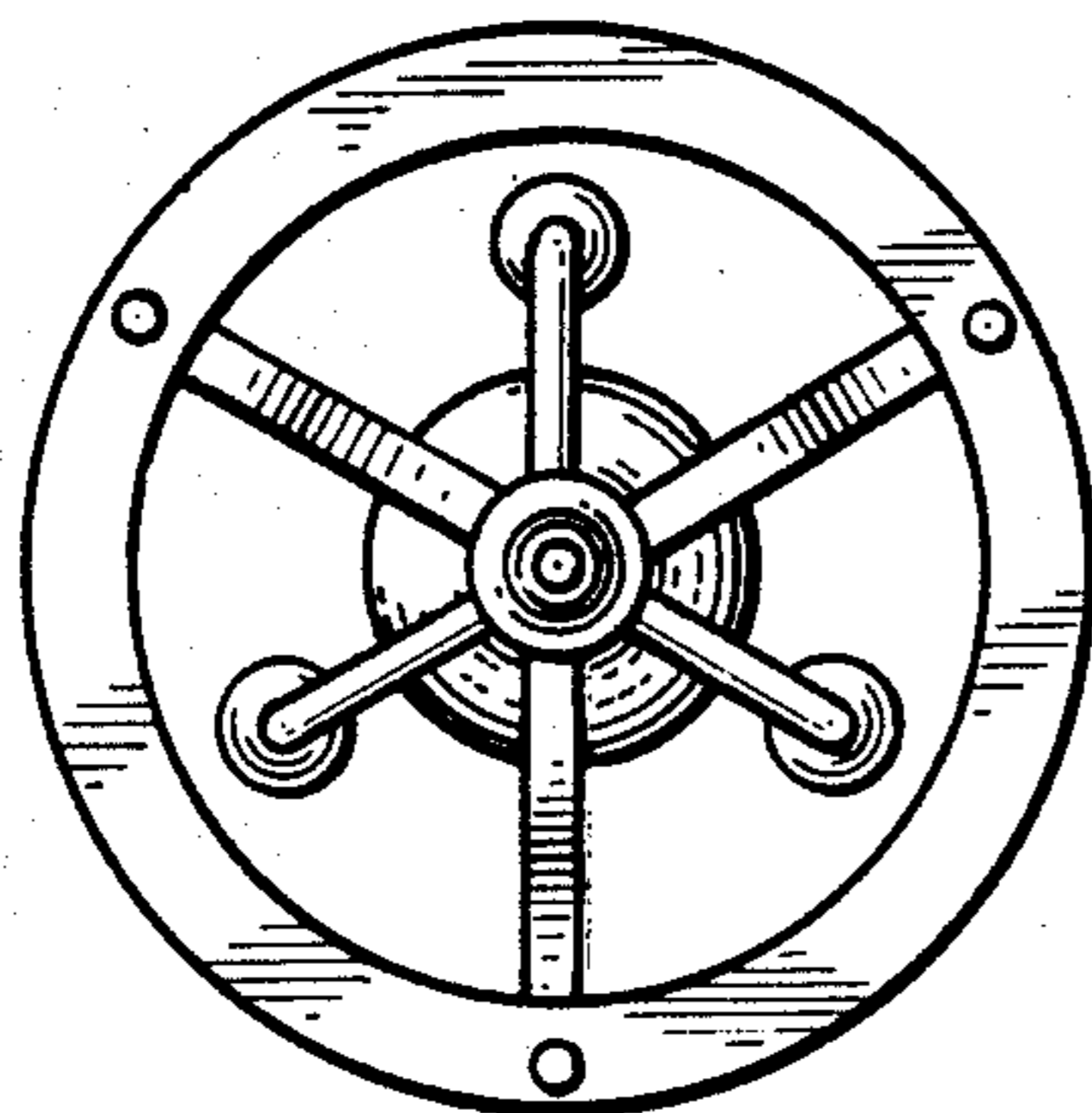

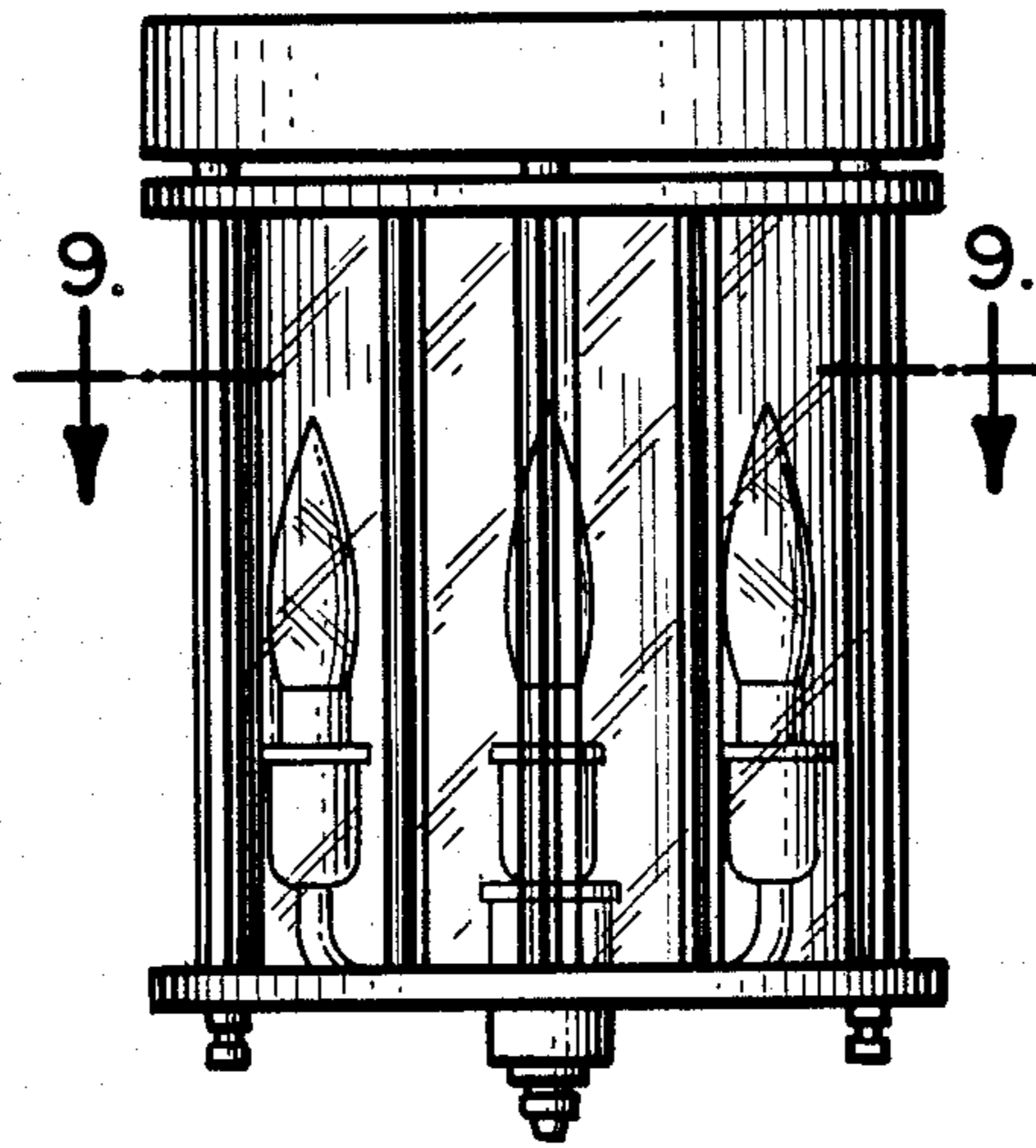

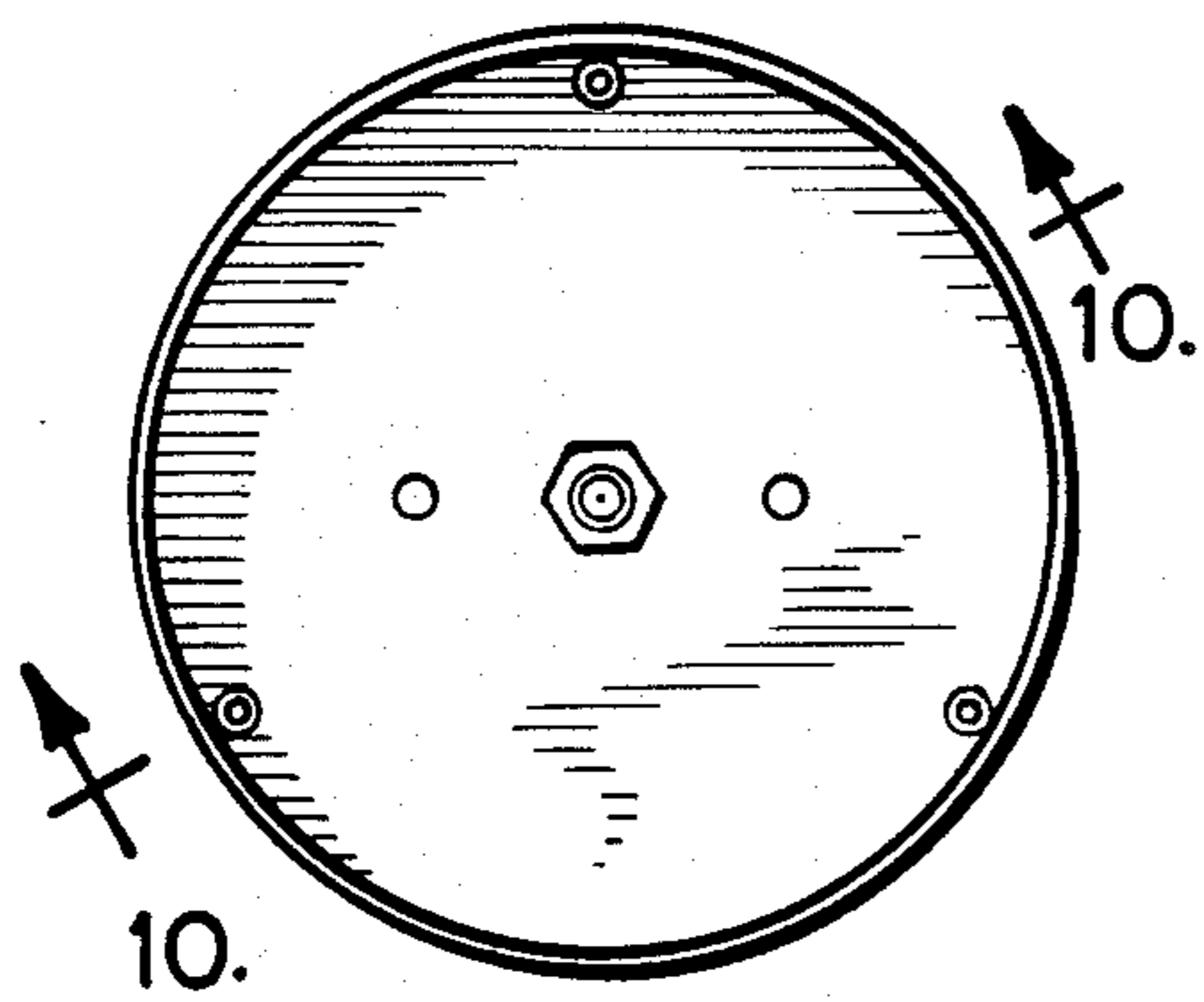

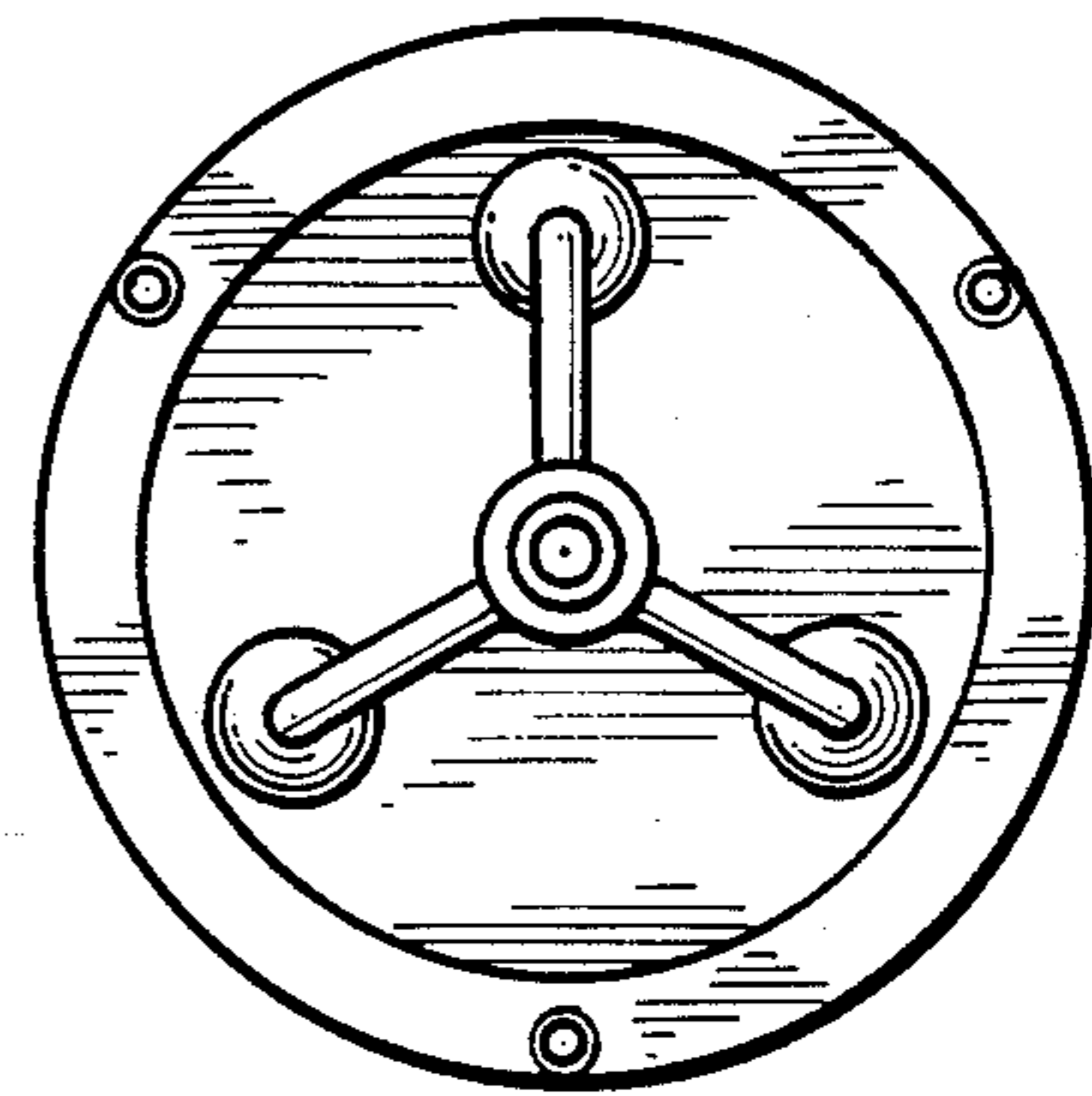

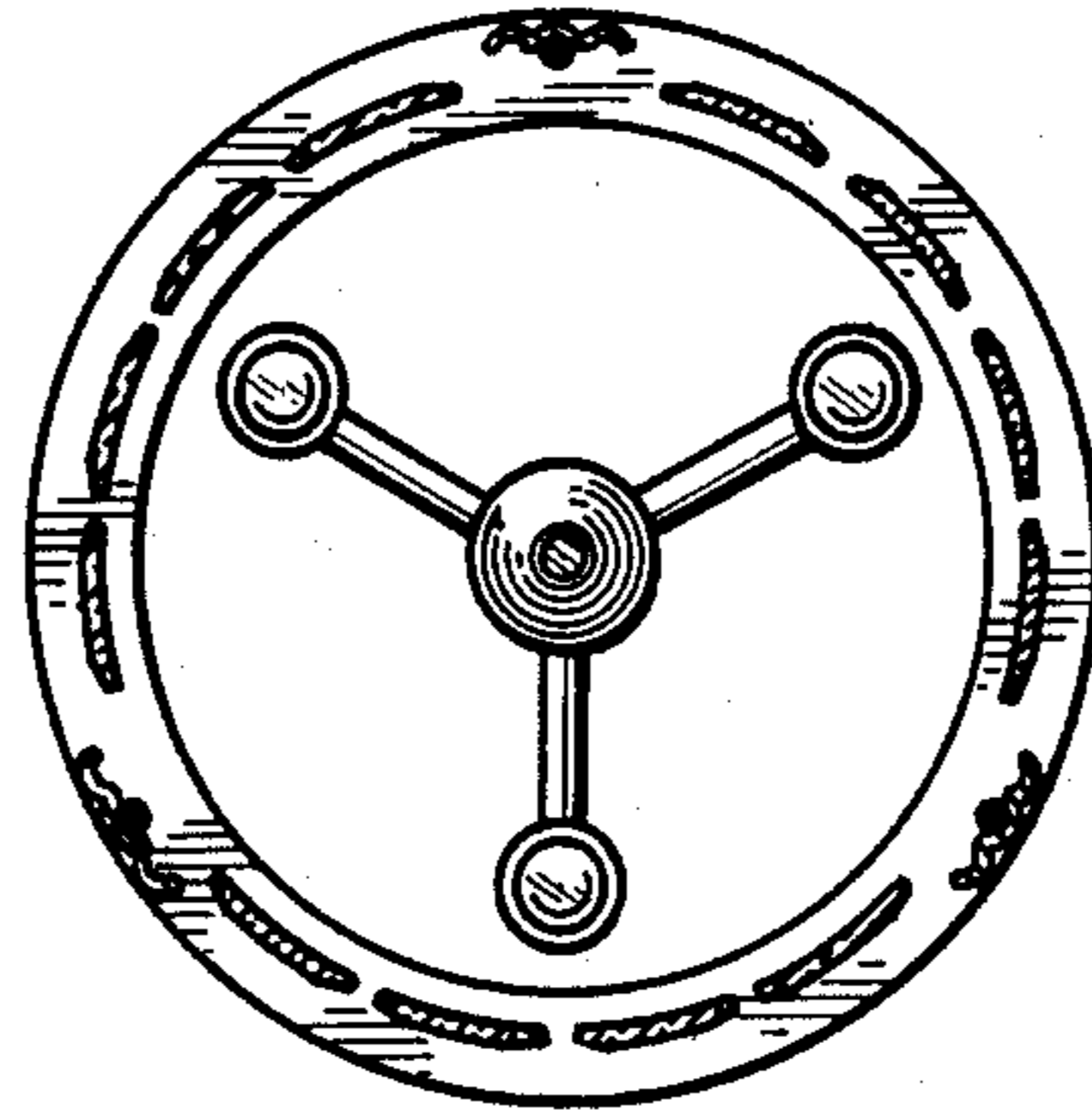
