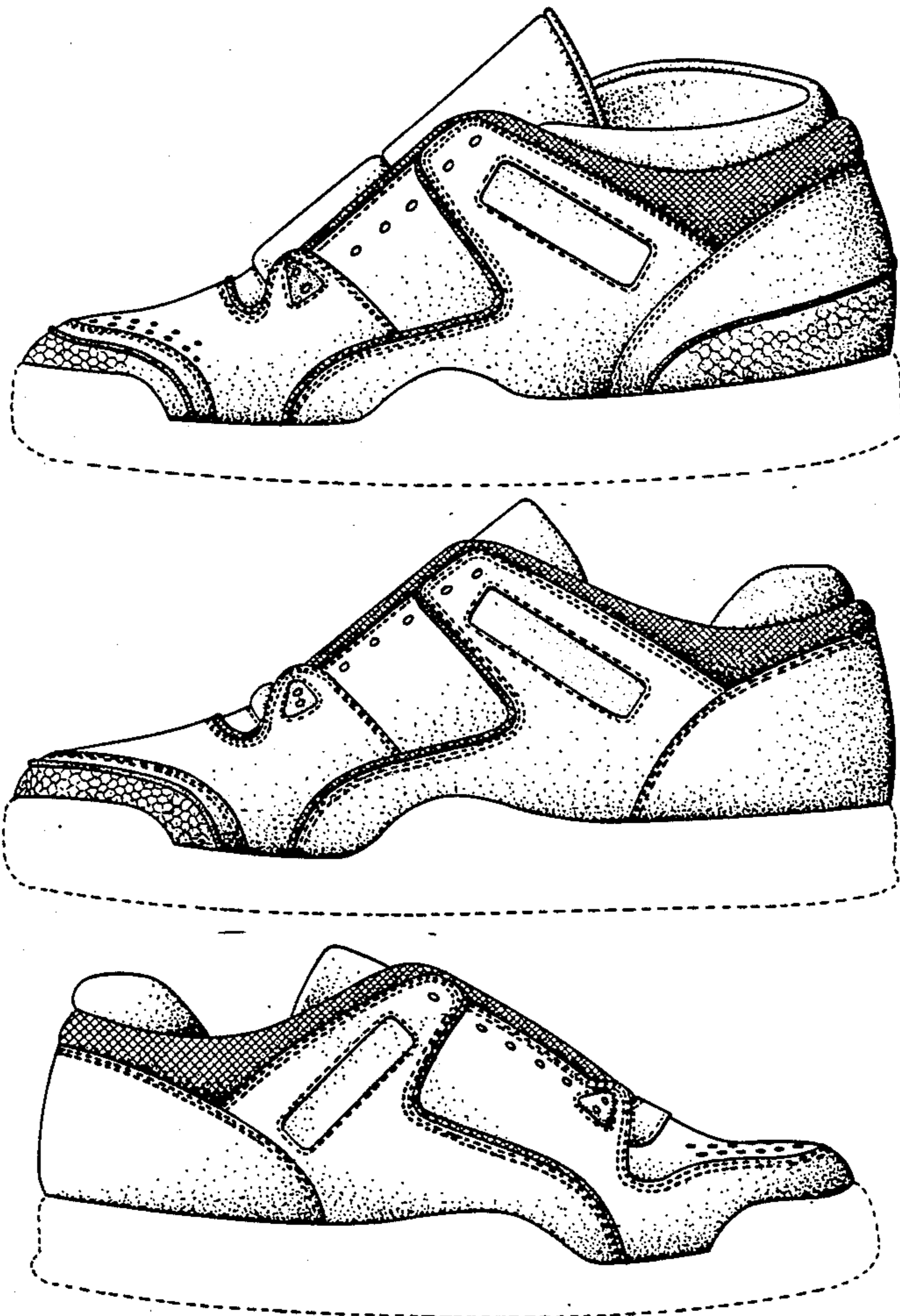

DESCRIPTION

FIG. 1 is a left side elevational view of a shoe upper showing our new design;

 FIG. 5 is a rear elevational view thereof;
 FIG. 6 is a left side elevational view of a shoe upper showing an alternate embodiment of our new design;

 FIG. 8 is a top plan view thereof;
 FIG. 9 is a front elevational view thereof;
 FIG. 10 is a rear elevational view thereof;
 FIG. 11 is a left side elevational view of yet another alternative embodiment of a shoe upper showing our new design;
 FIG. 12 is a right side elevational view thereof;
 FIG. 13 is a top plan view thereof;
 FIG. 14 is a front elevational view thereof; and
 FIG. 15 is a rear elevational view thereof;
 The broken line showing of a shoe sole in FIGS. 1-15 and the area within are environmental only and form no part of the claimed design.



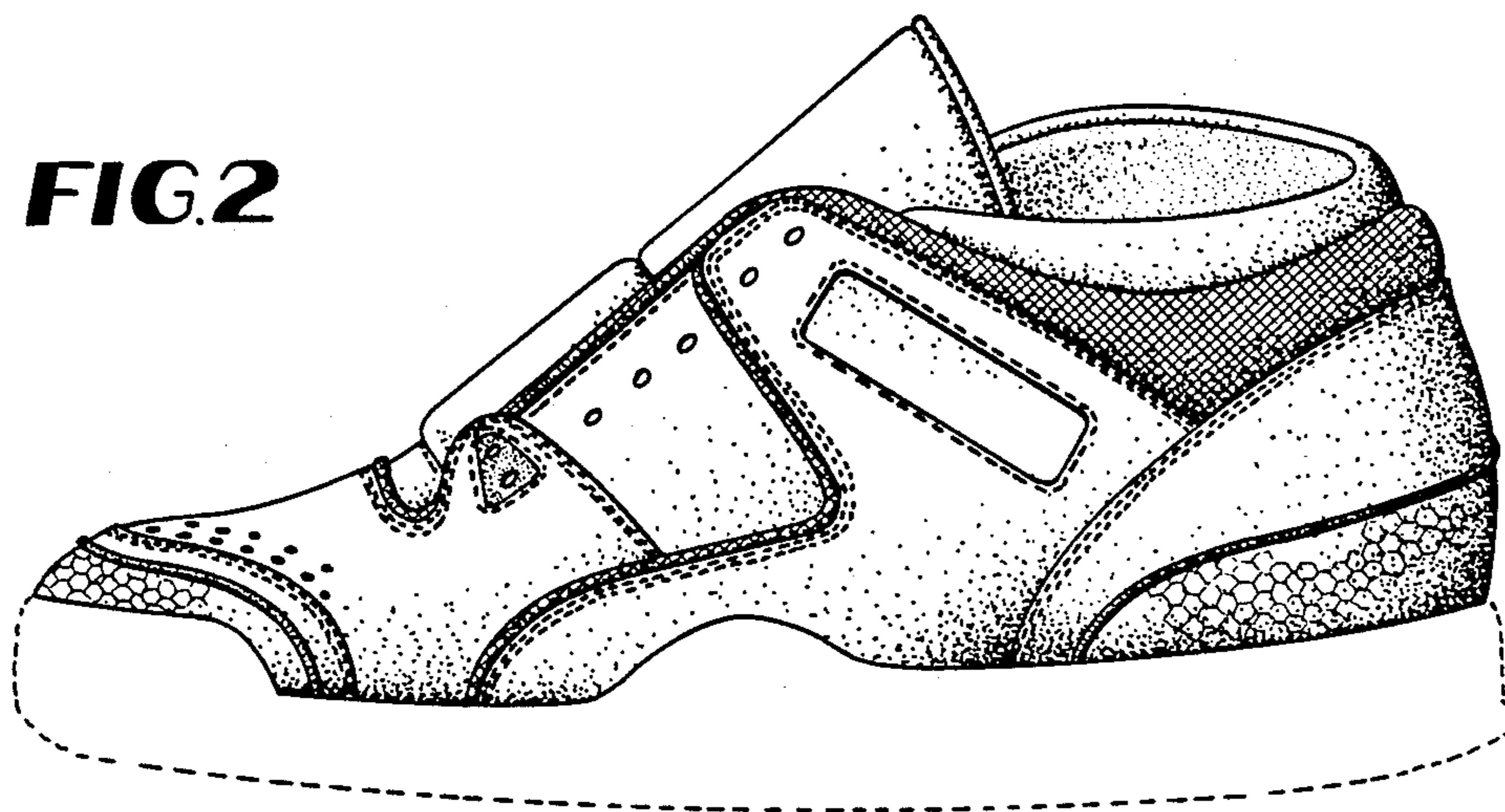
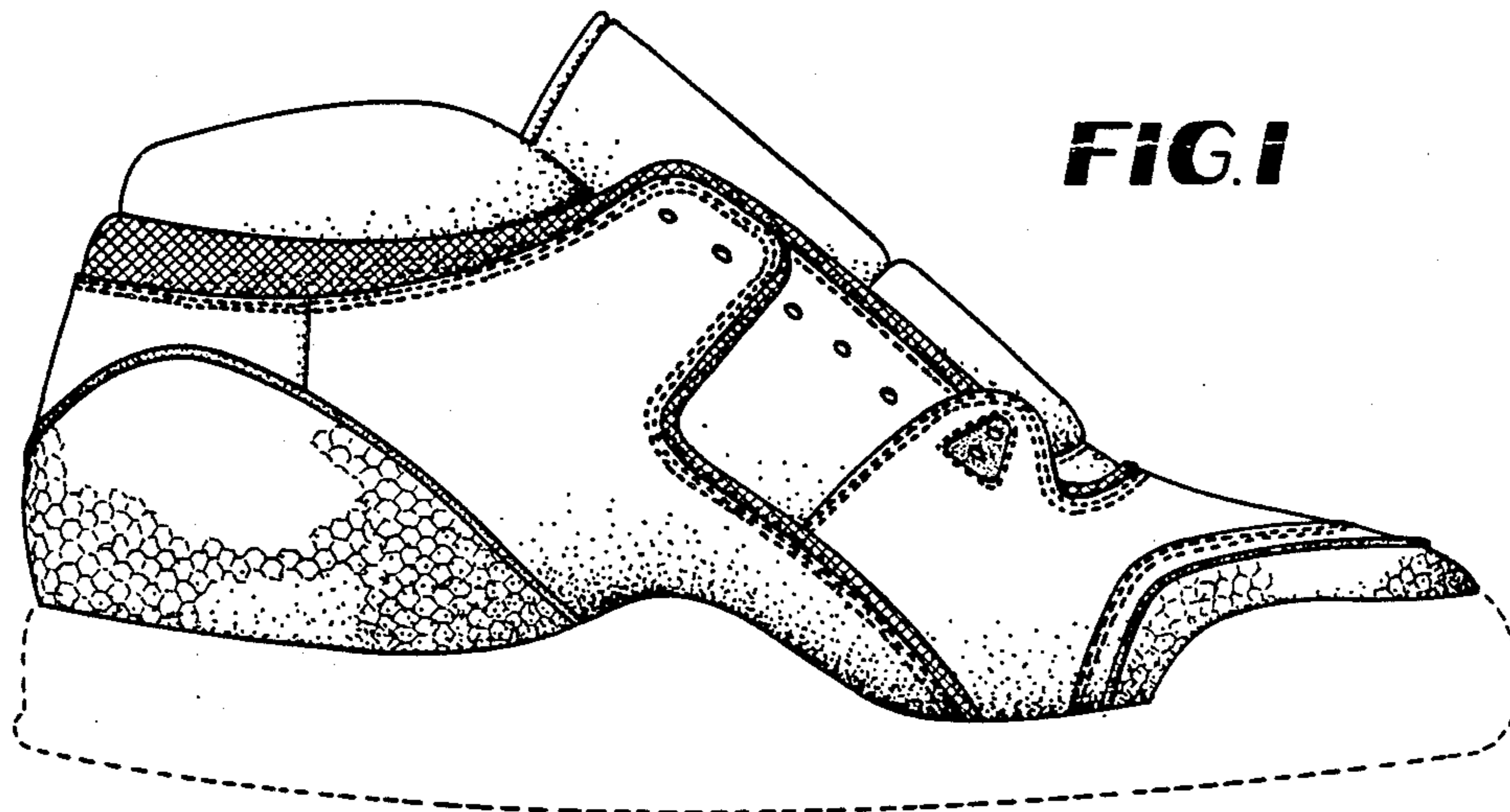

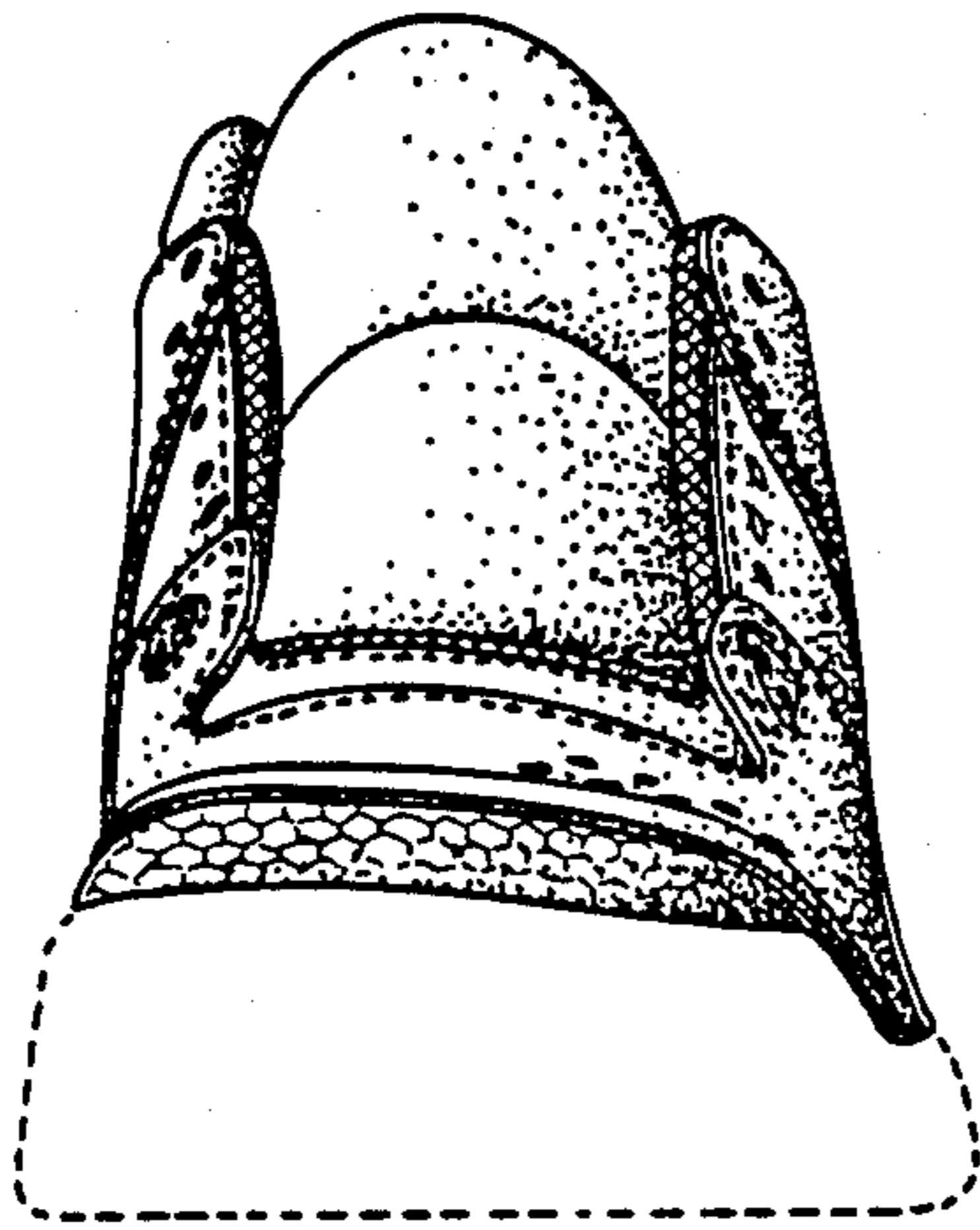
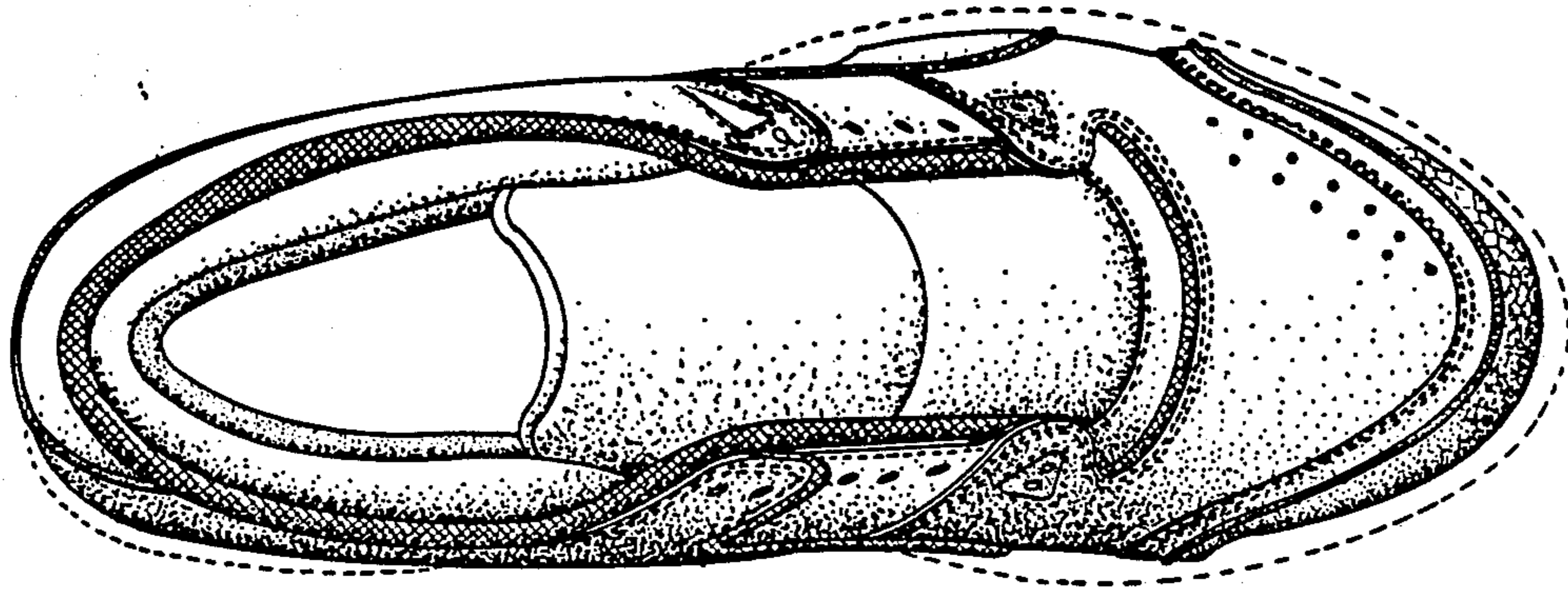

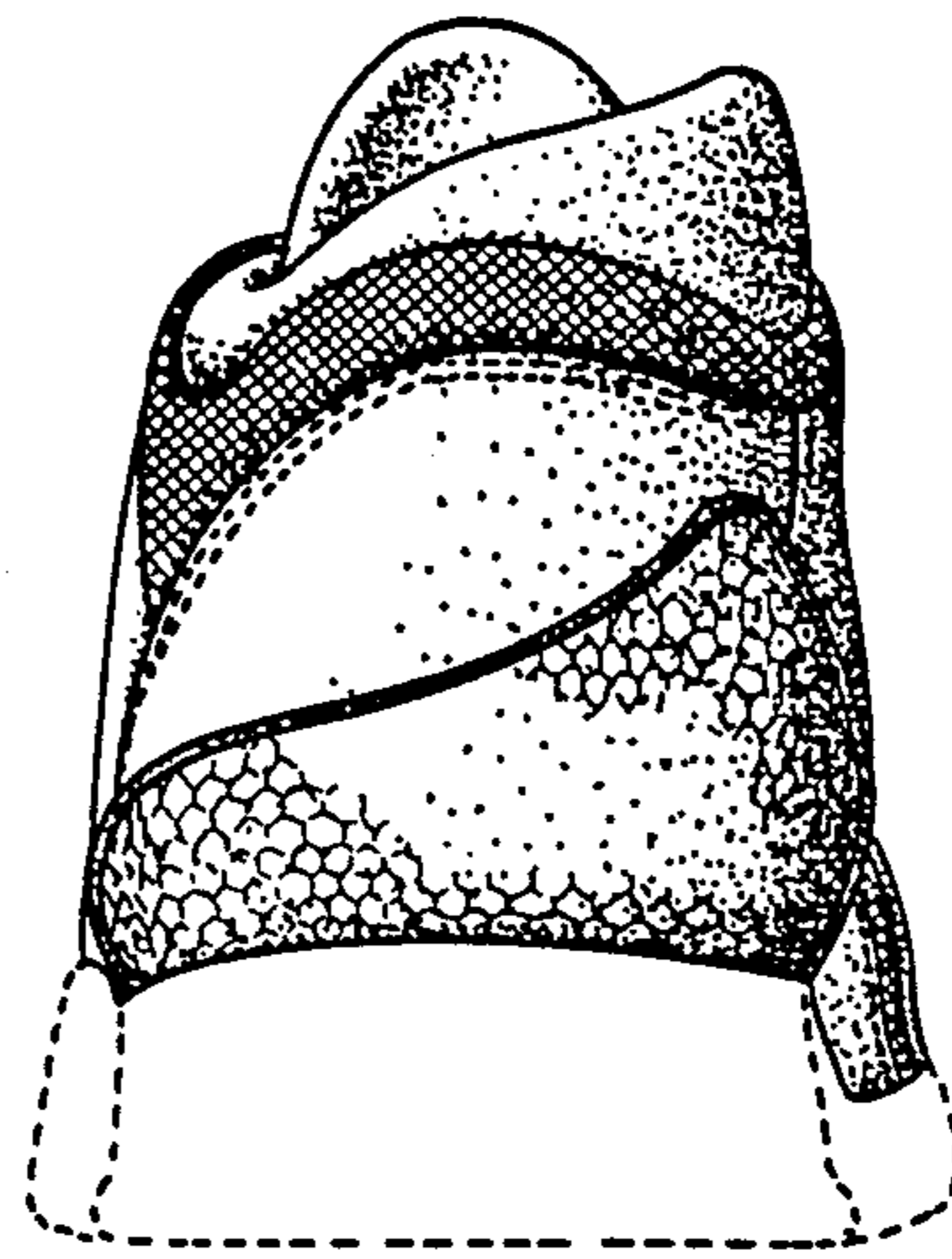

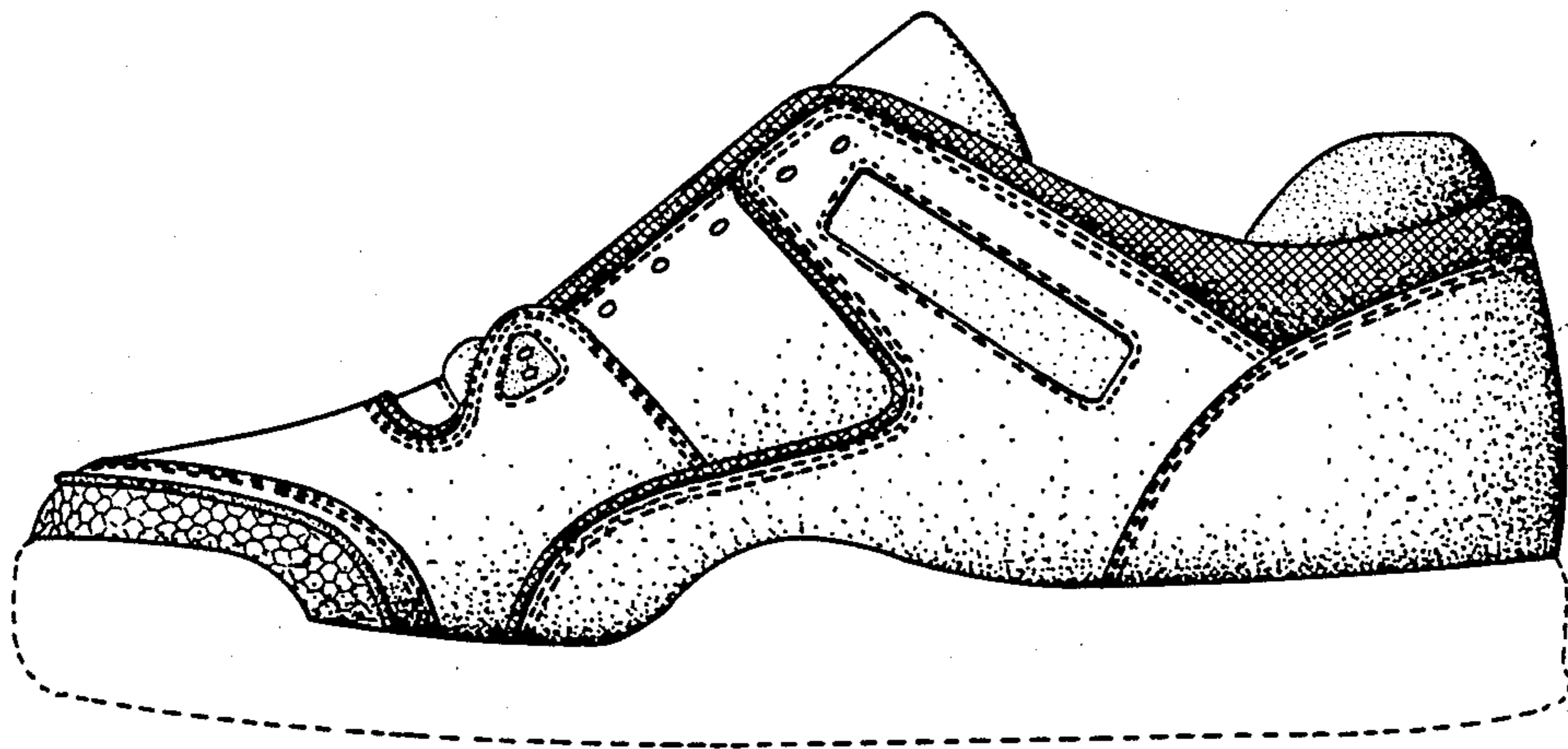
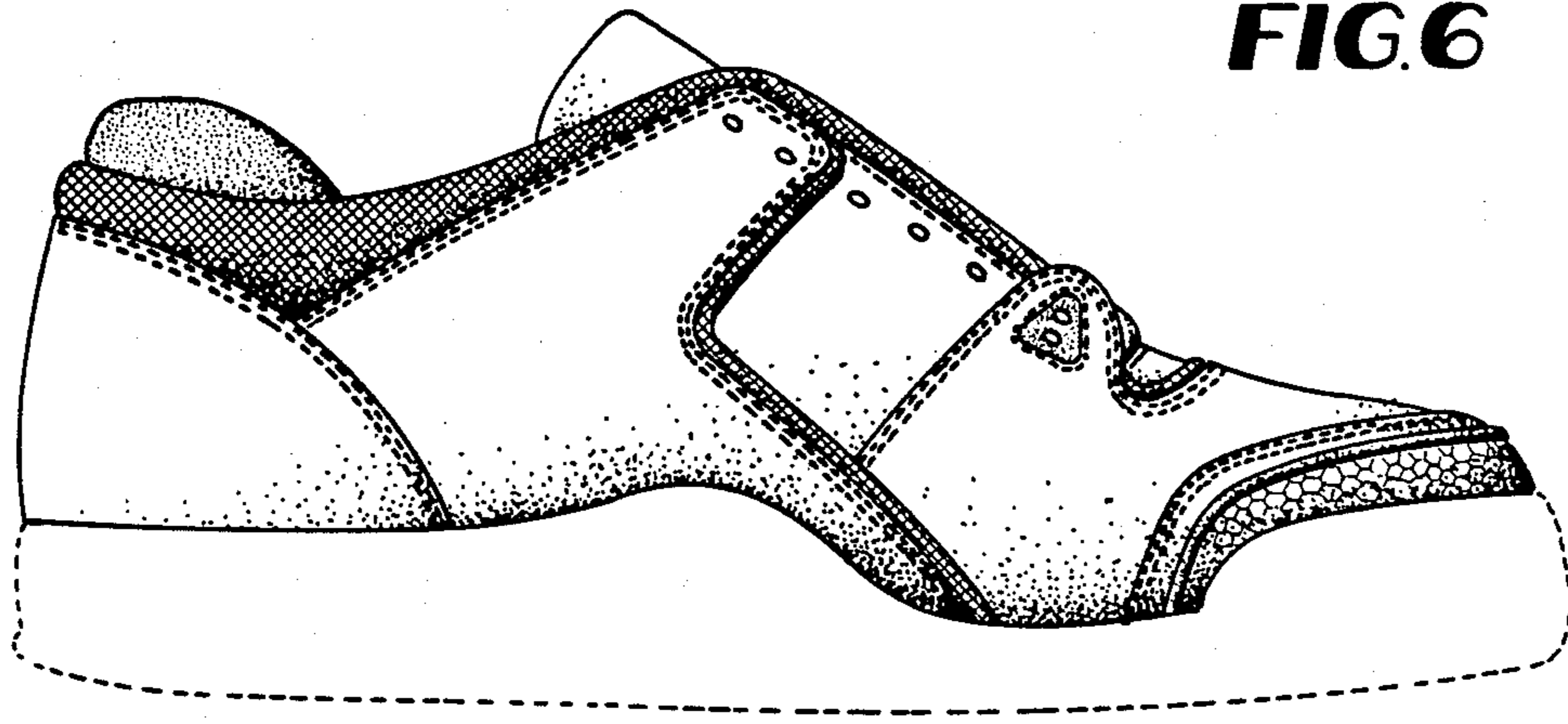

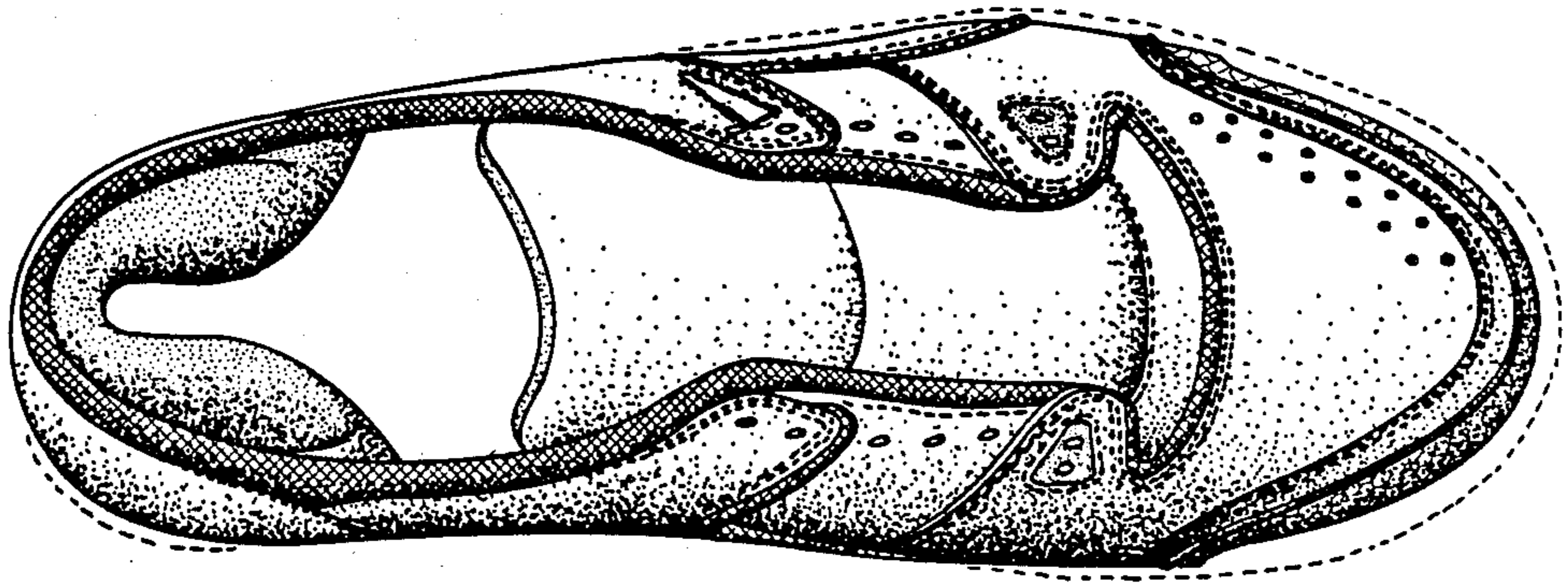

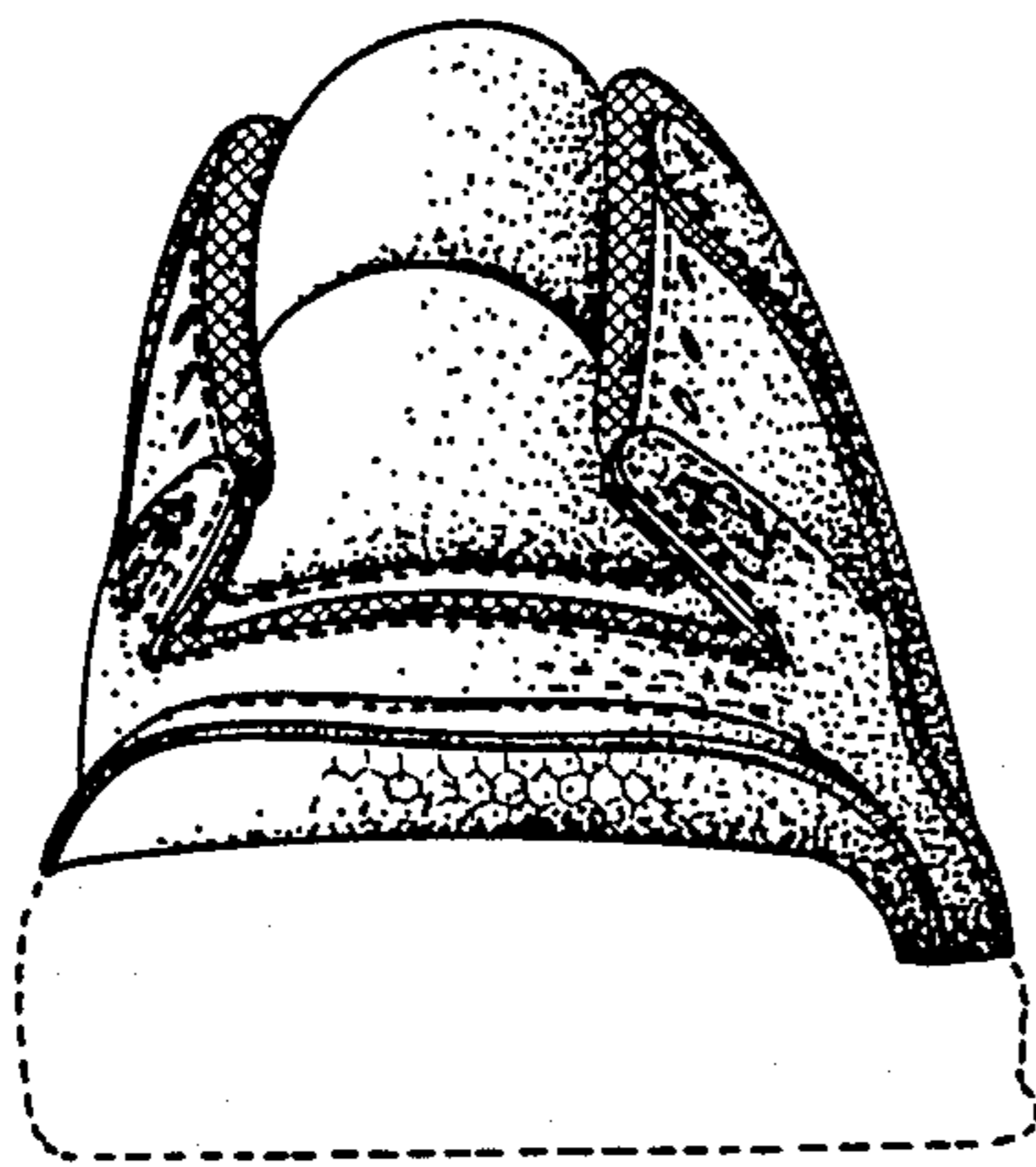

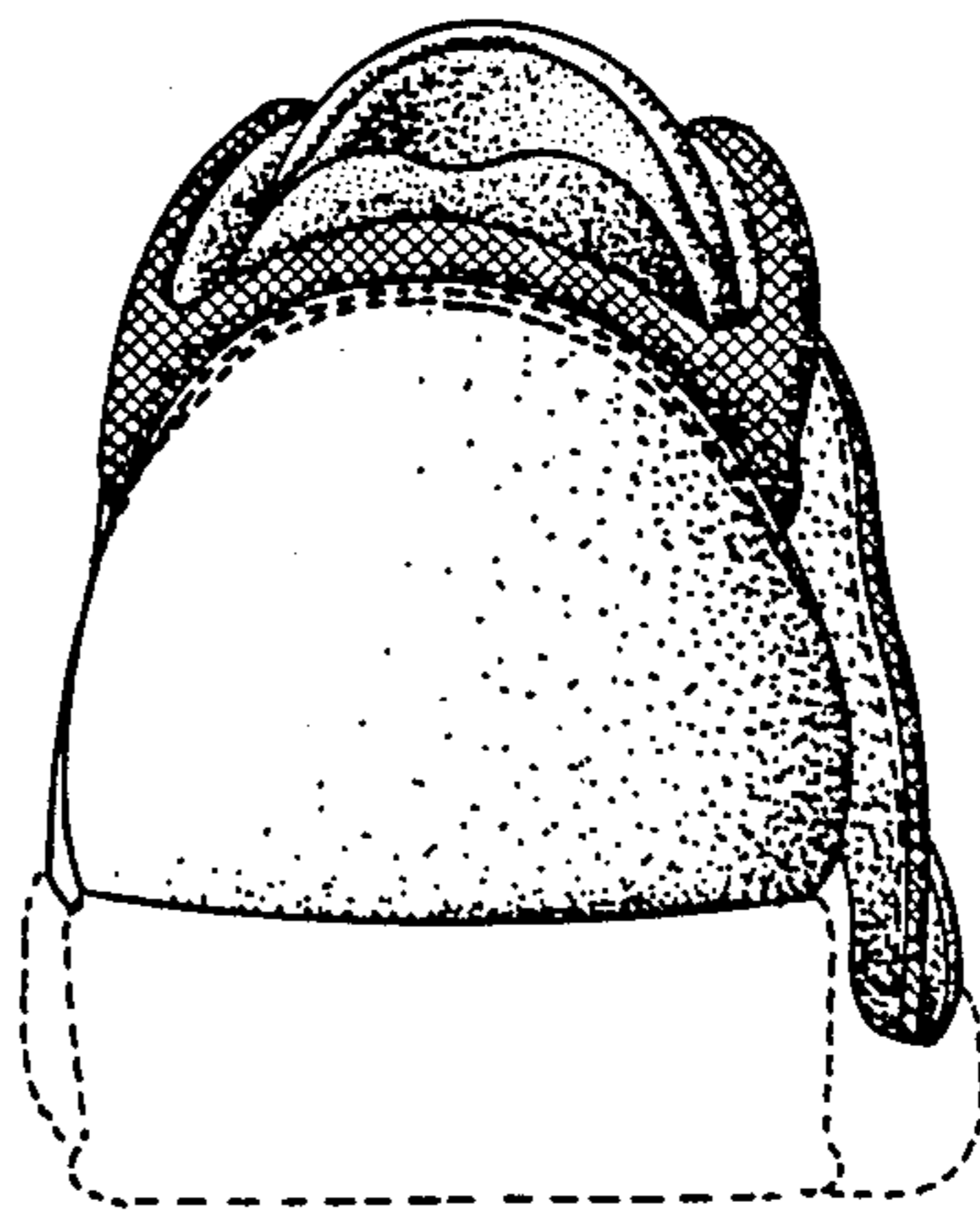

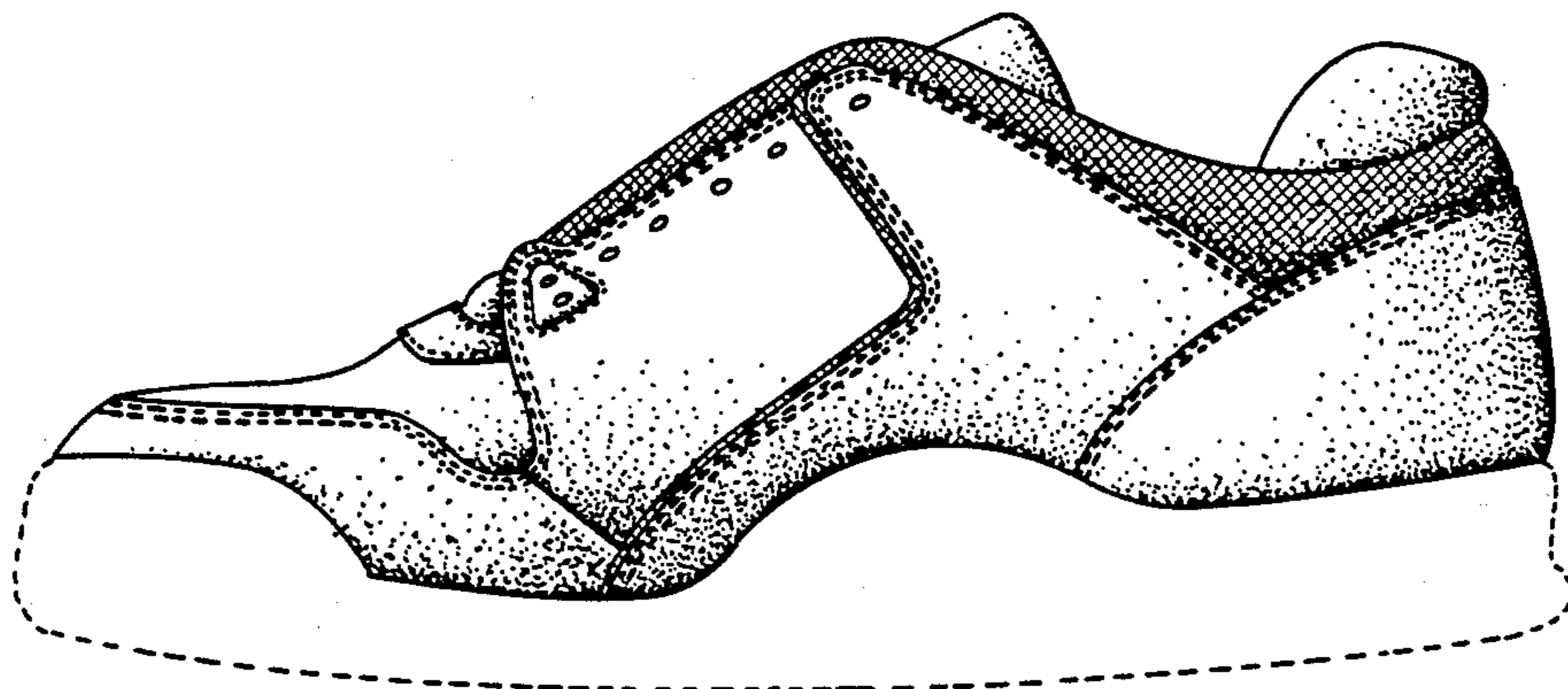
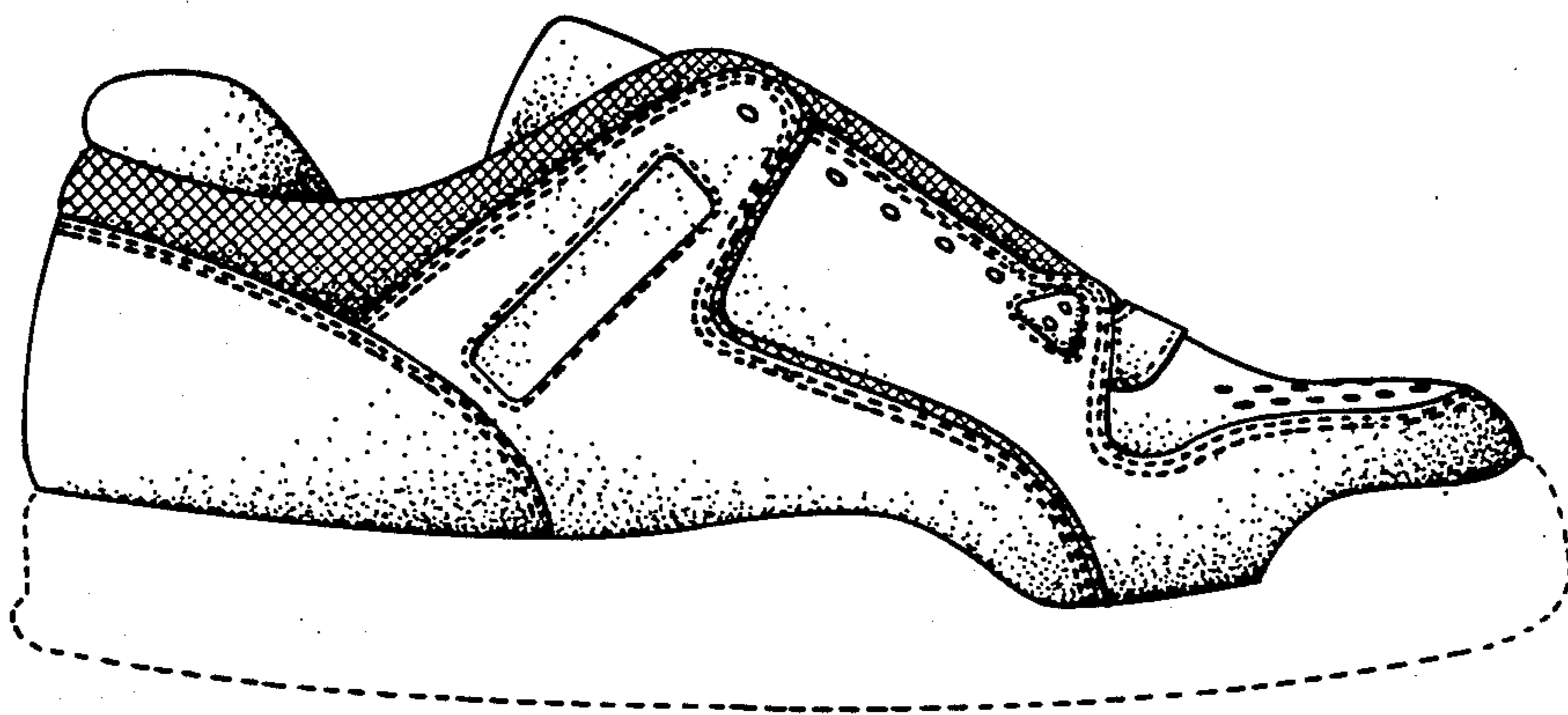

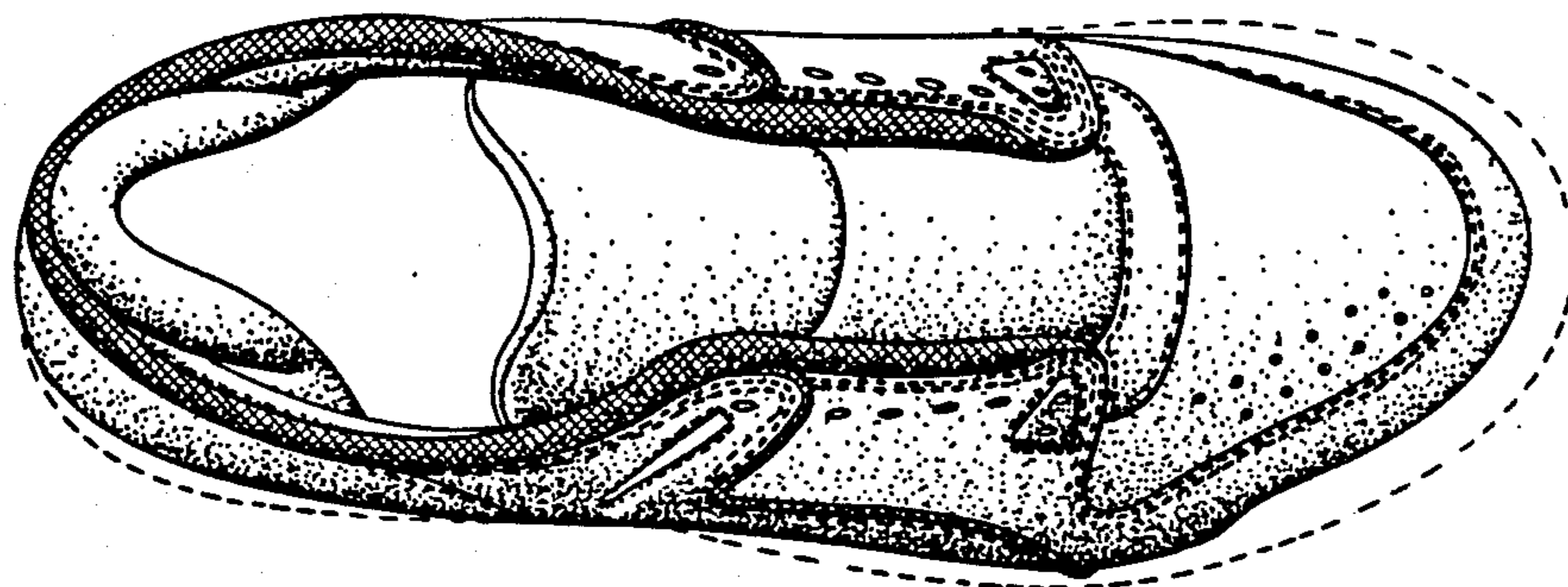

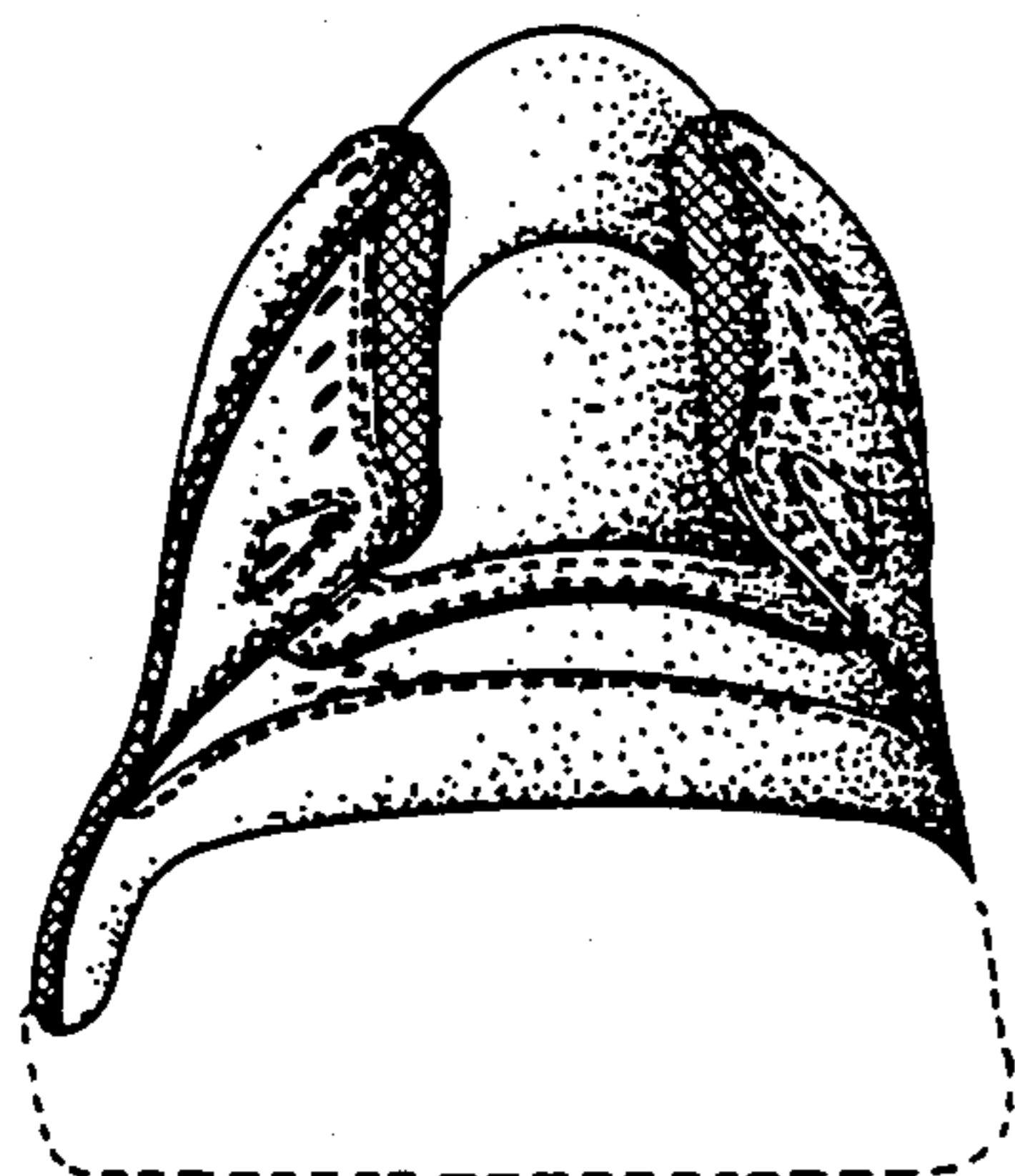

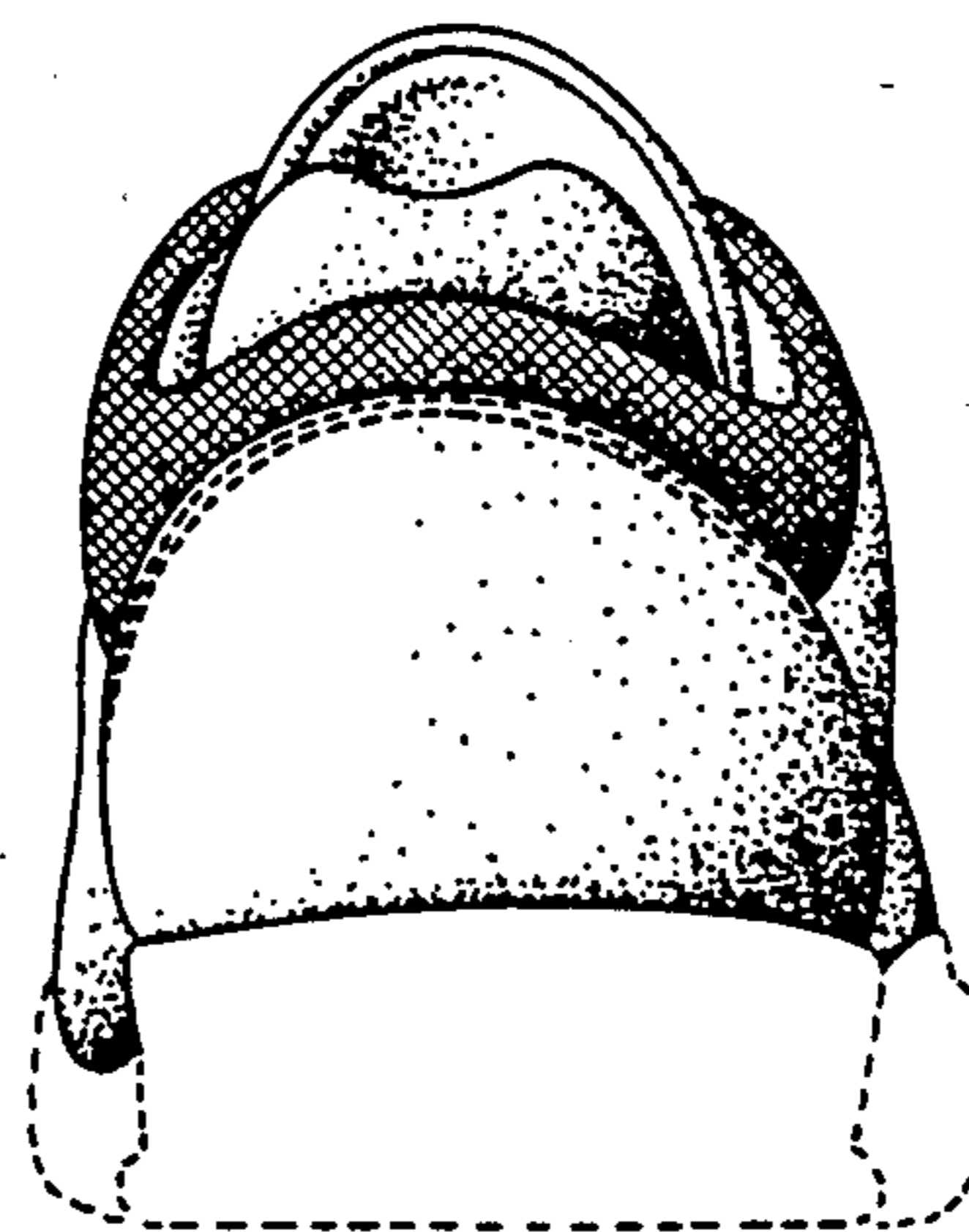
