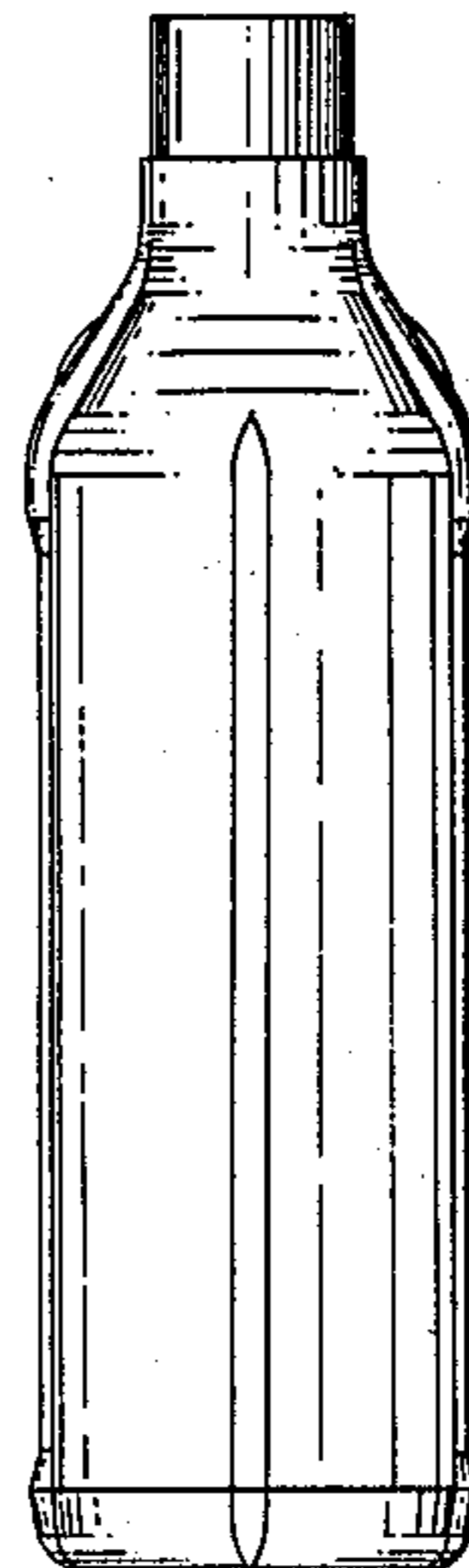
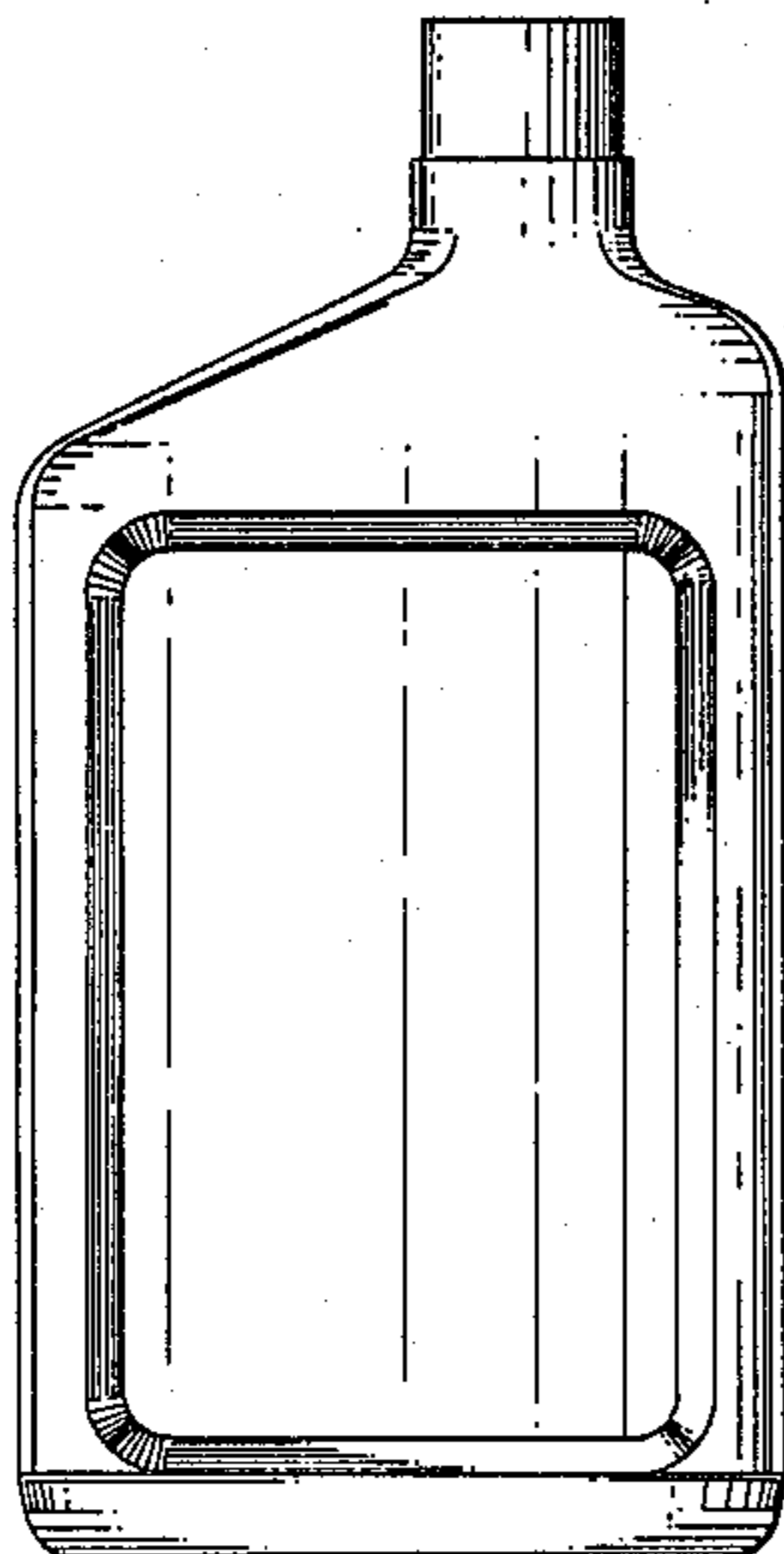

The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation of a bottle showing our new design, the rear elevation being a mirror image thereof; FIG. 2 is a left side elevation thereof; FIG. 3 is a right side elevation thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a front elevation of a second embodiment of the bottle, the rear elevation being a mirror image thereof; FIG. 7 is a right side elevation thereof; FIG. 8 is a left side elevation thereof; FIG. 9 is a top plan view thereof; and FIG. 10 is a bottom plan view thereof.



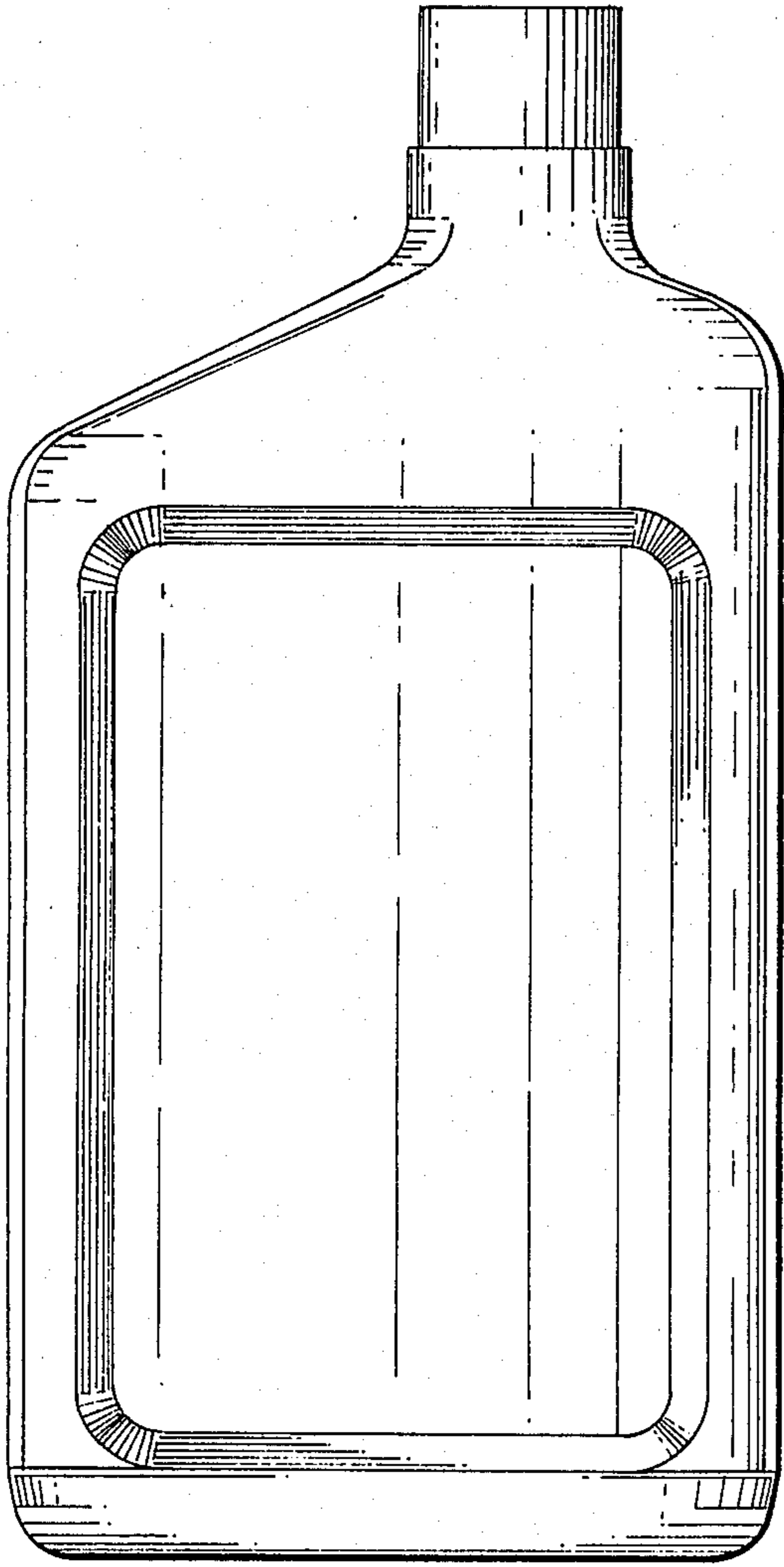

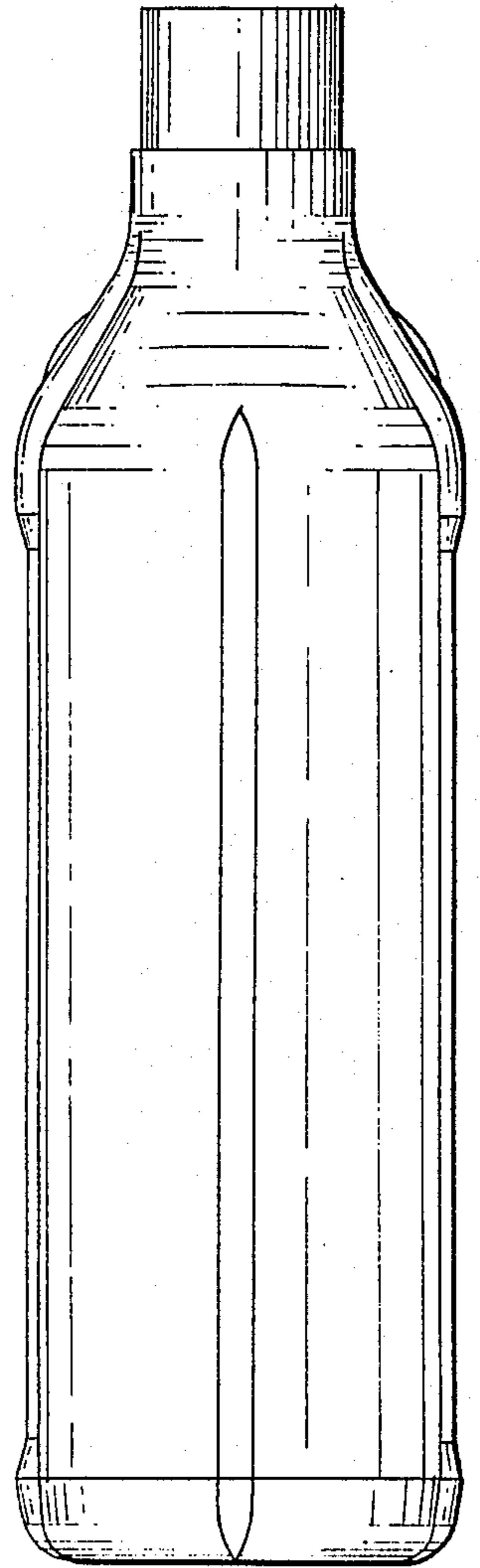

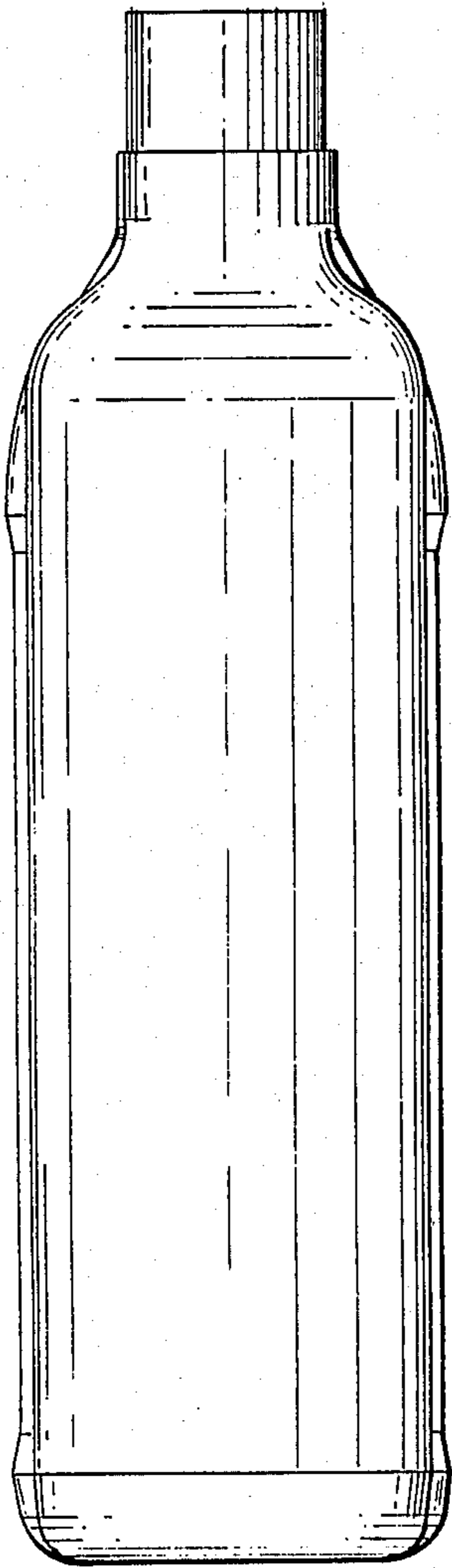

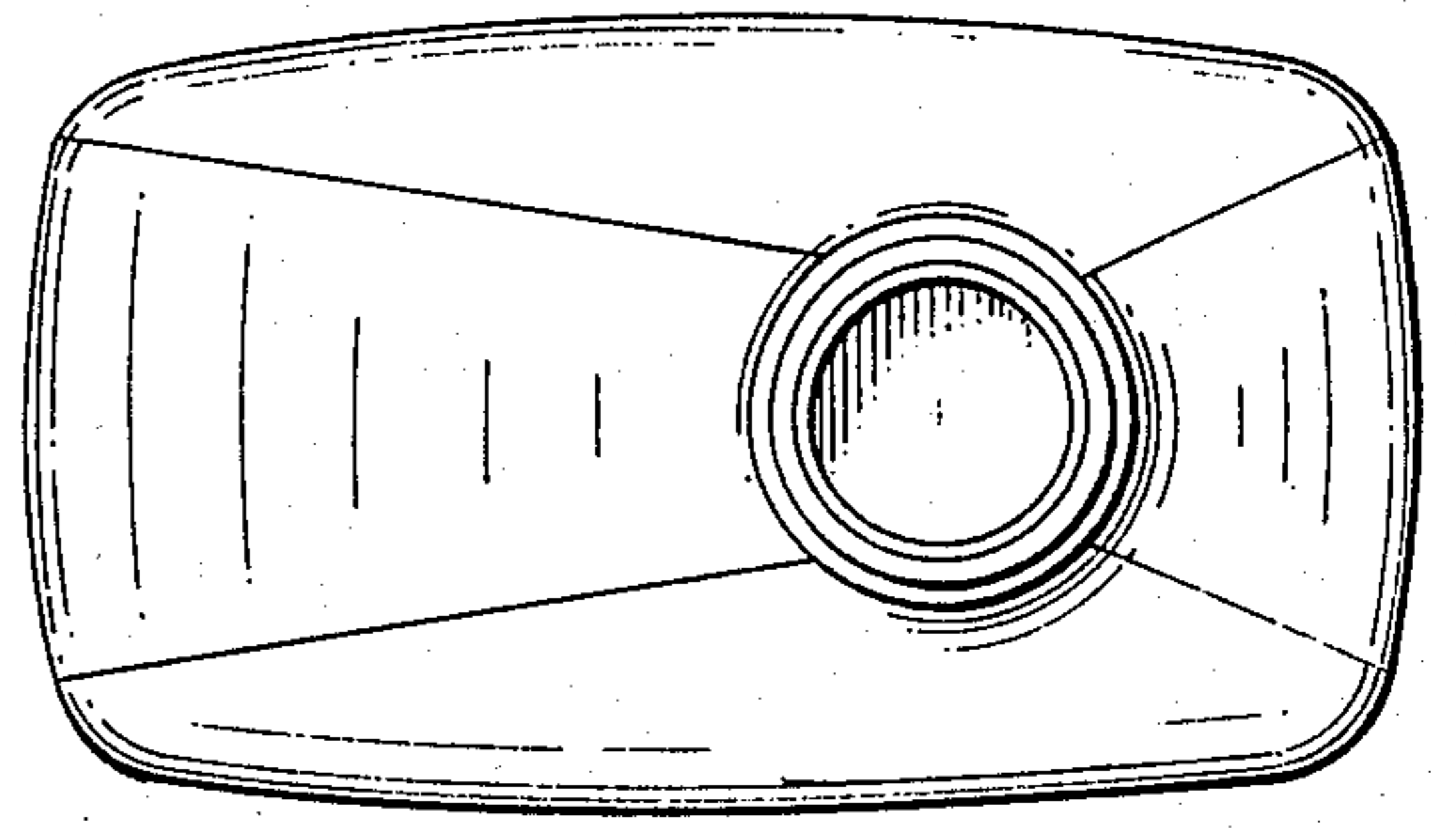

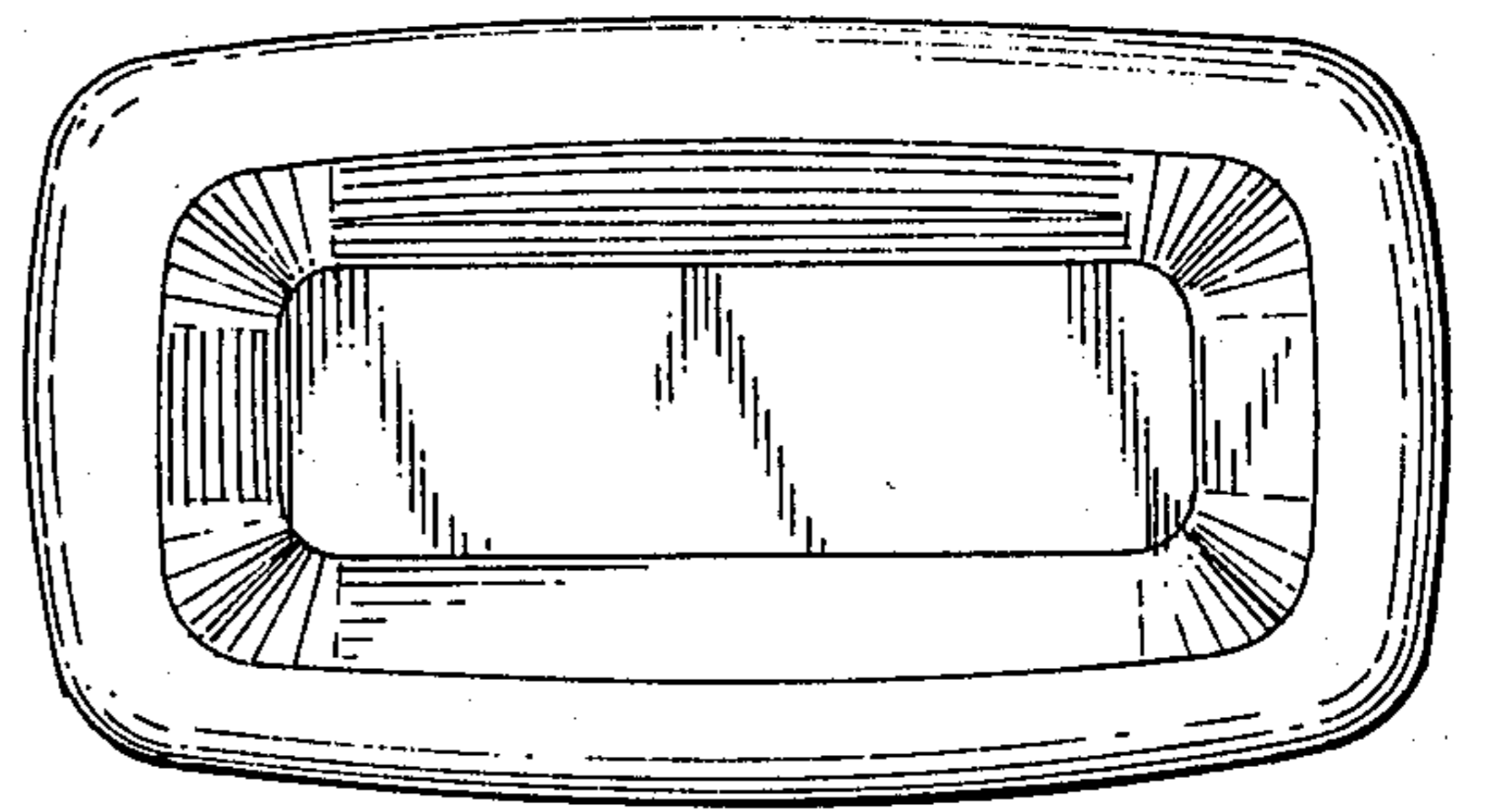

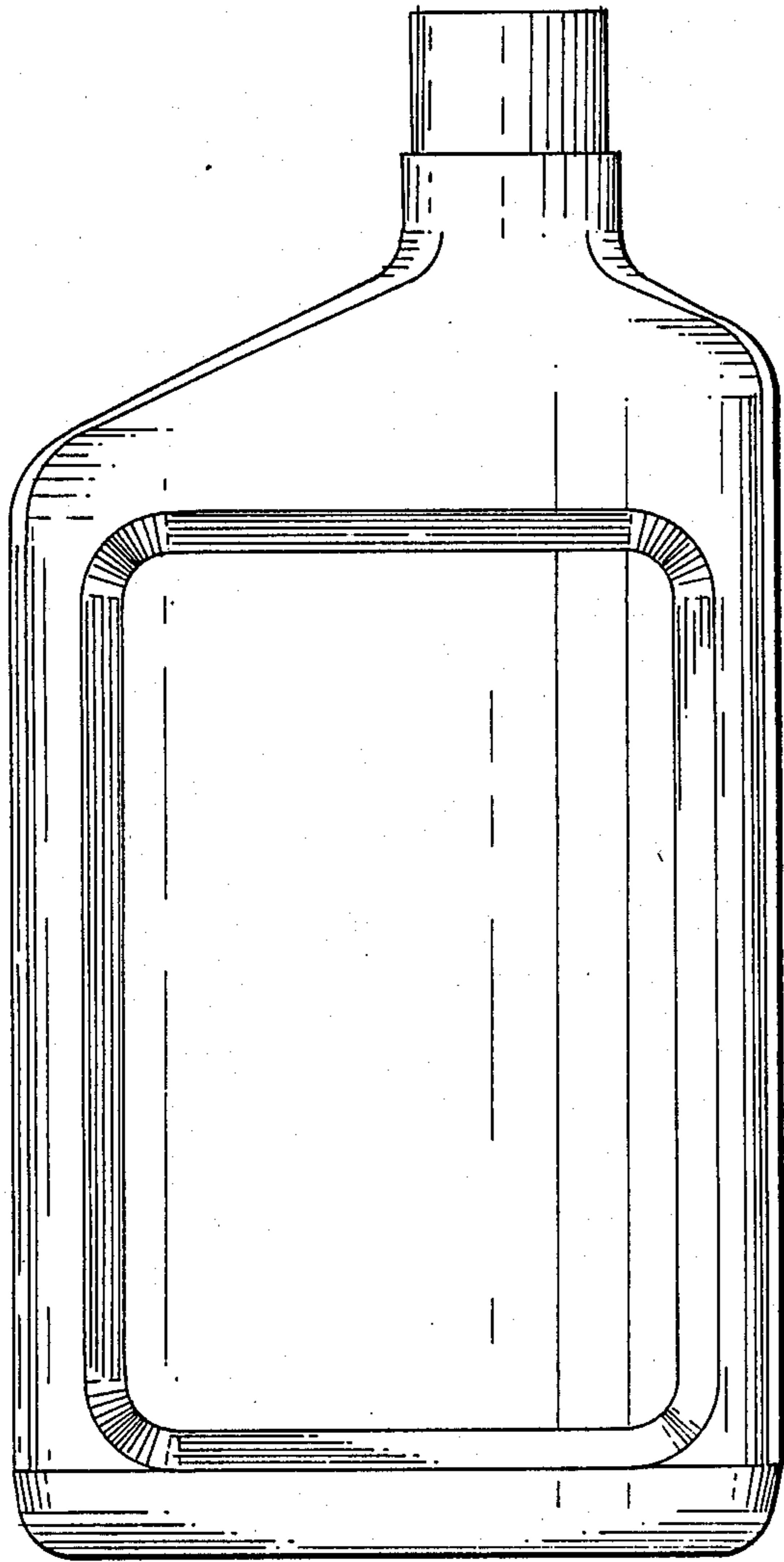

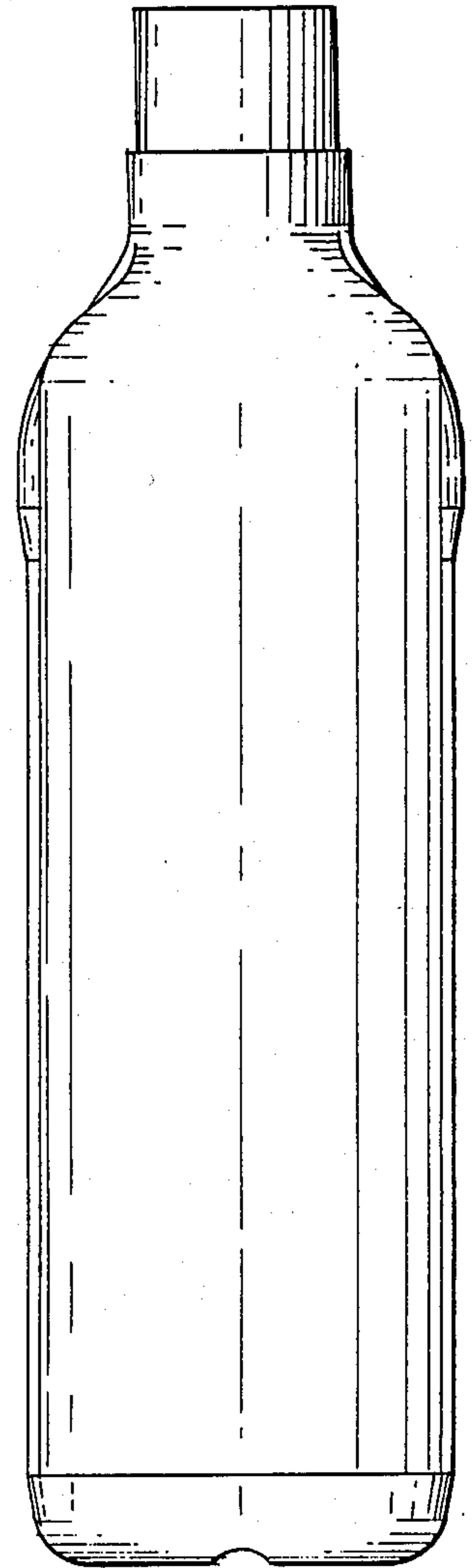

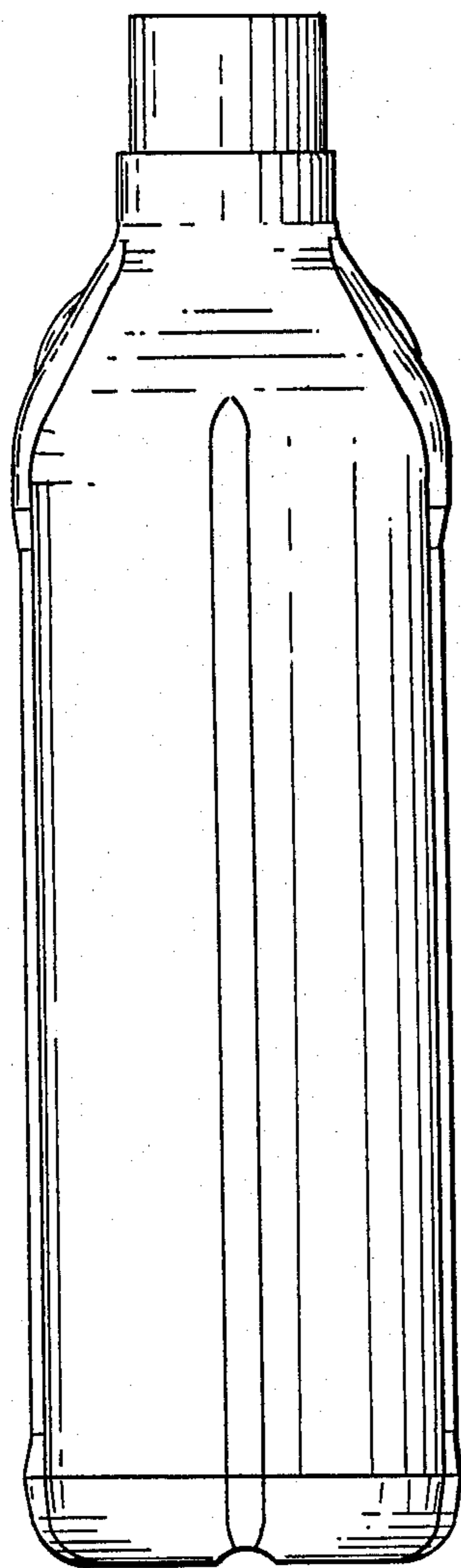

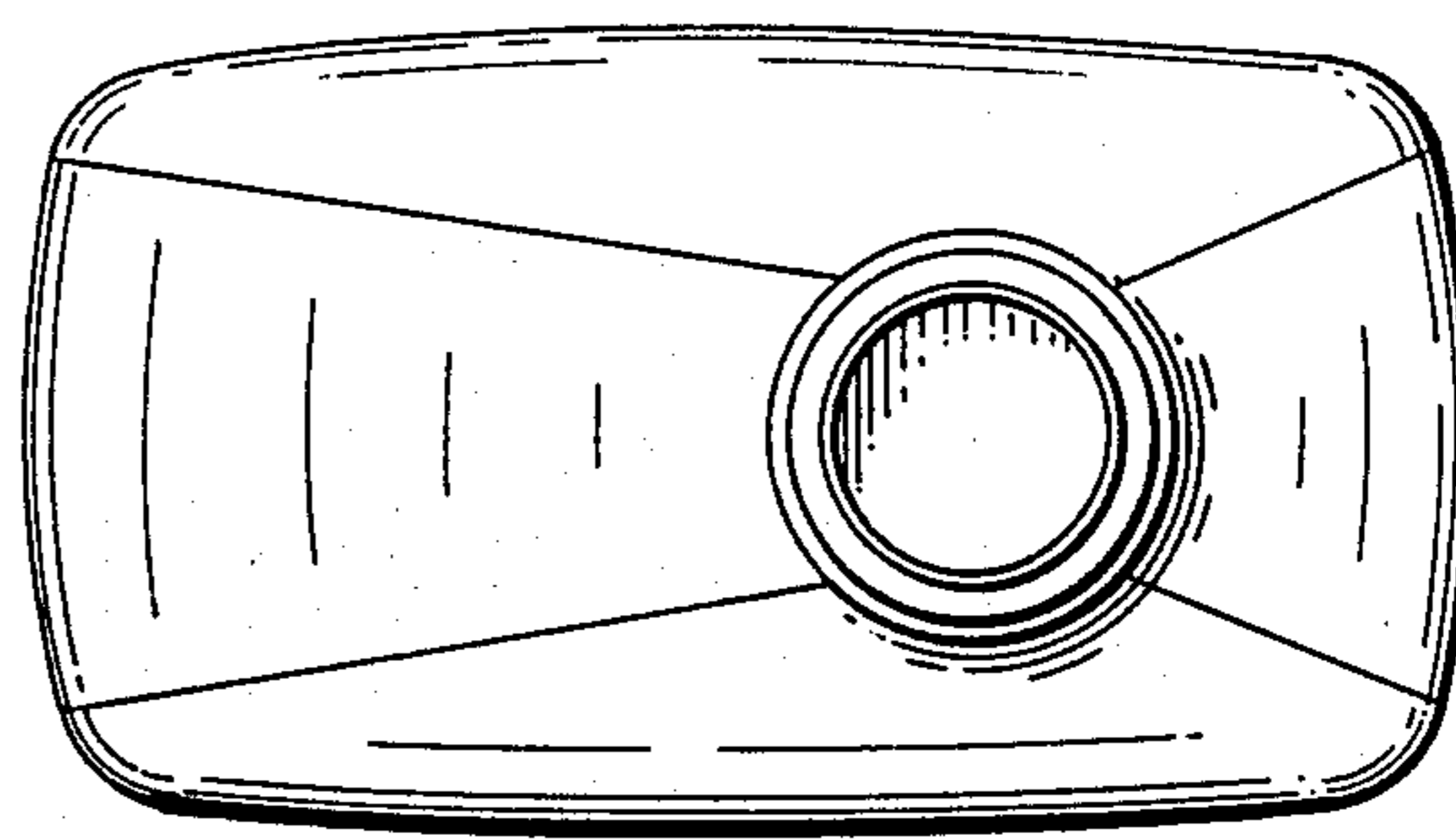

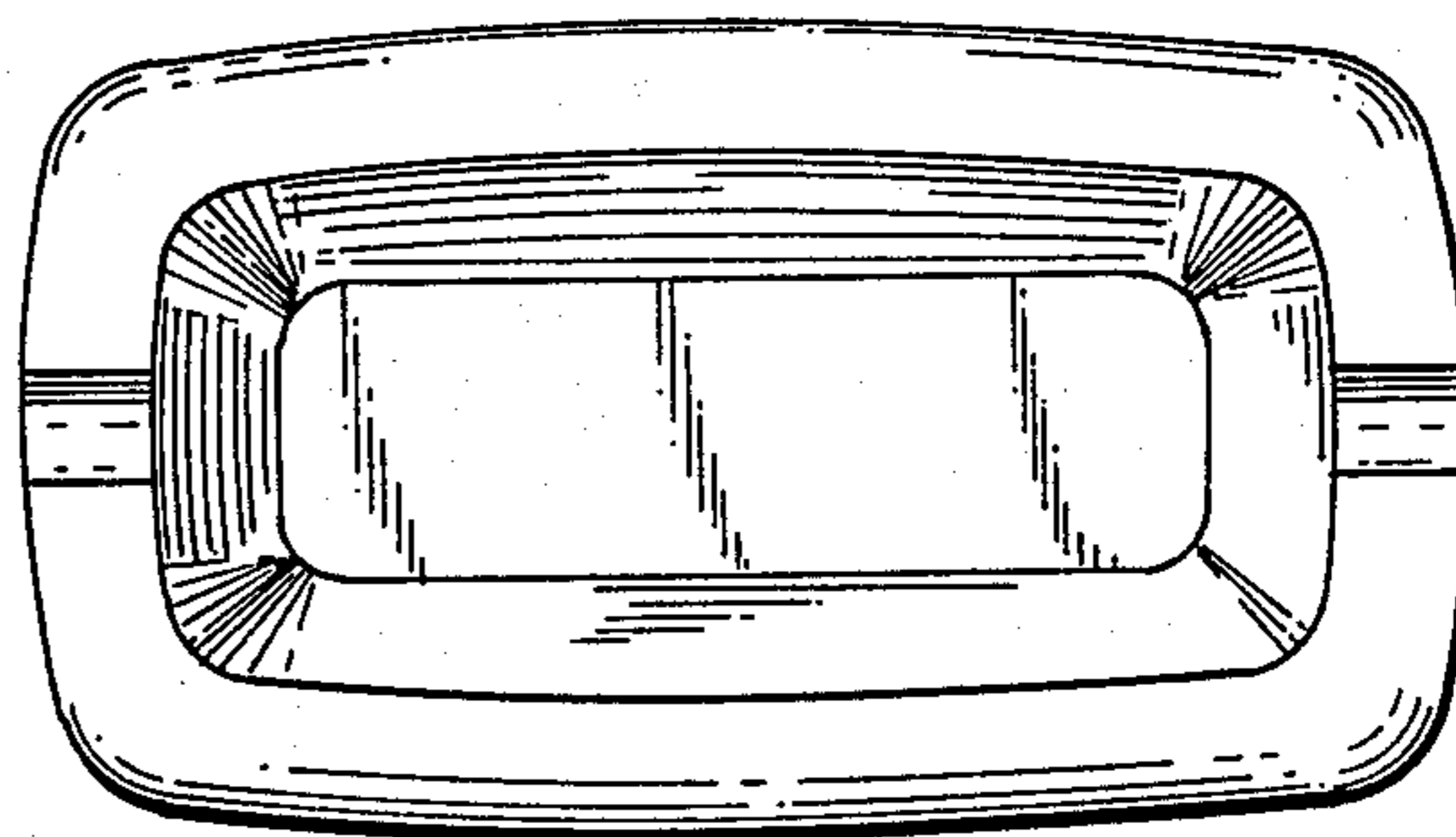
