The ornamental design for a cosmetic case, as shown and described.

DESCRIPTION

FIG. 1 is a perspective top and front view of a cosmetic case showing my new design;

FIG. 15 is a top plan view thereof;

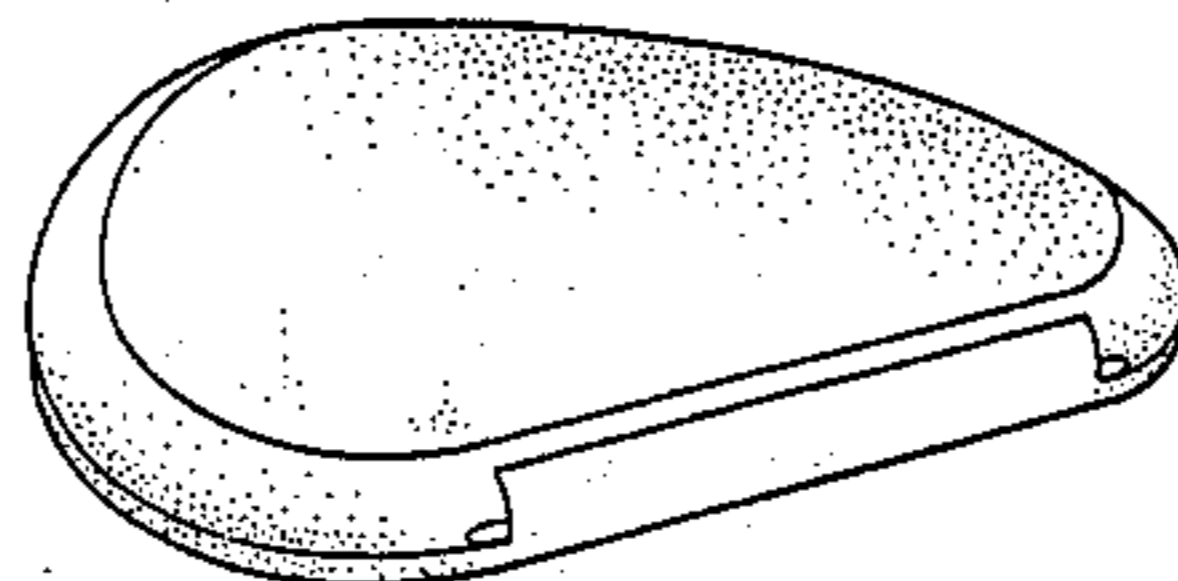
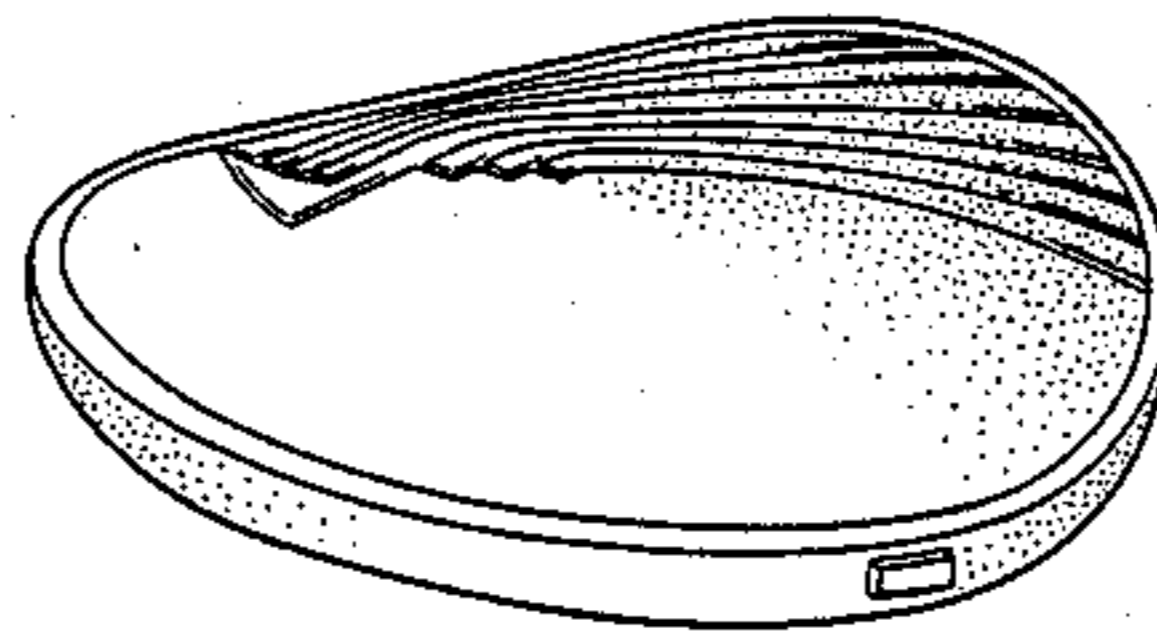
FIG. 16 is rear elevational view thereof;

FIG. 20 is an enlarged detail view of the design within the inset of FIG. 19.



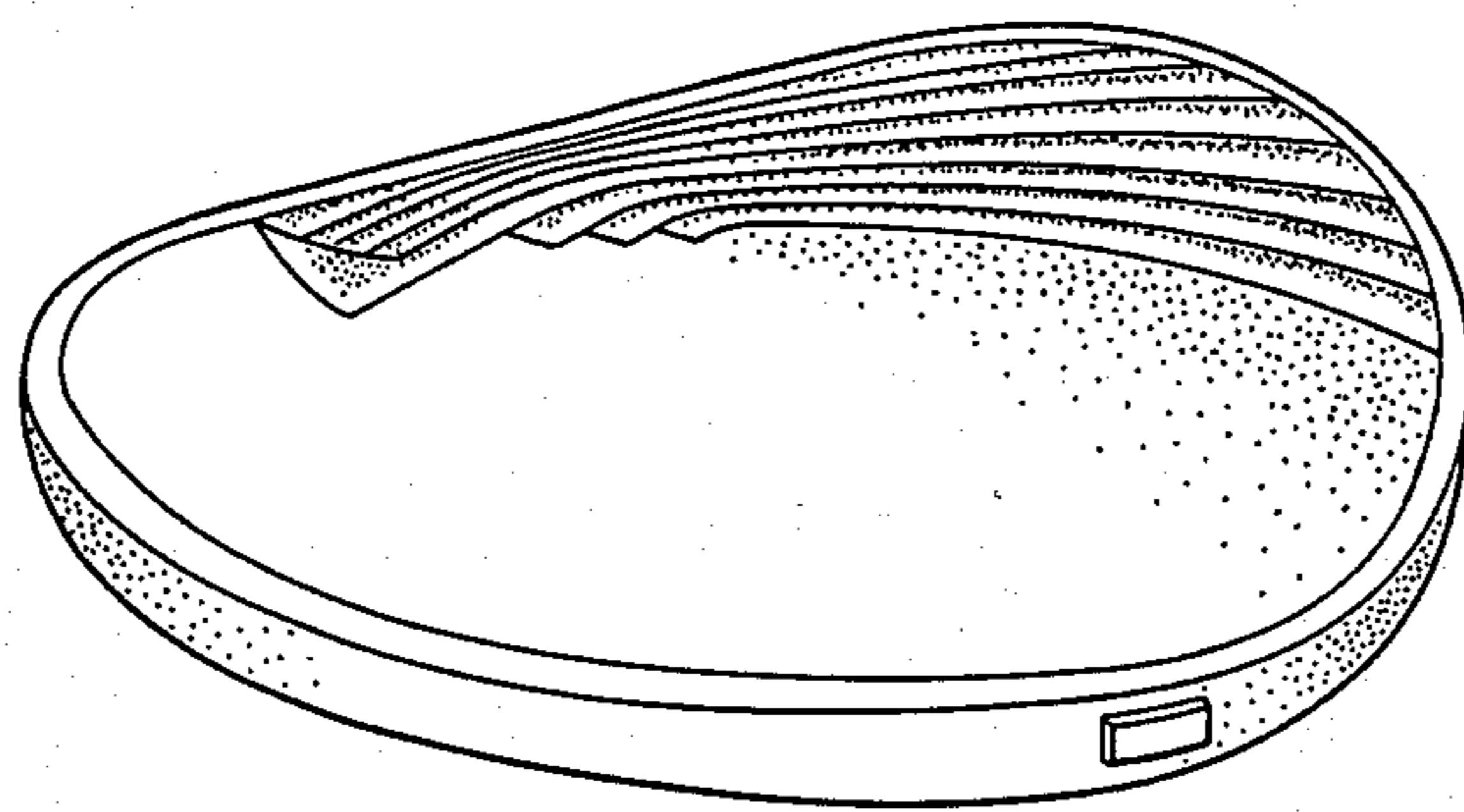

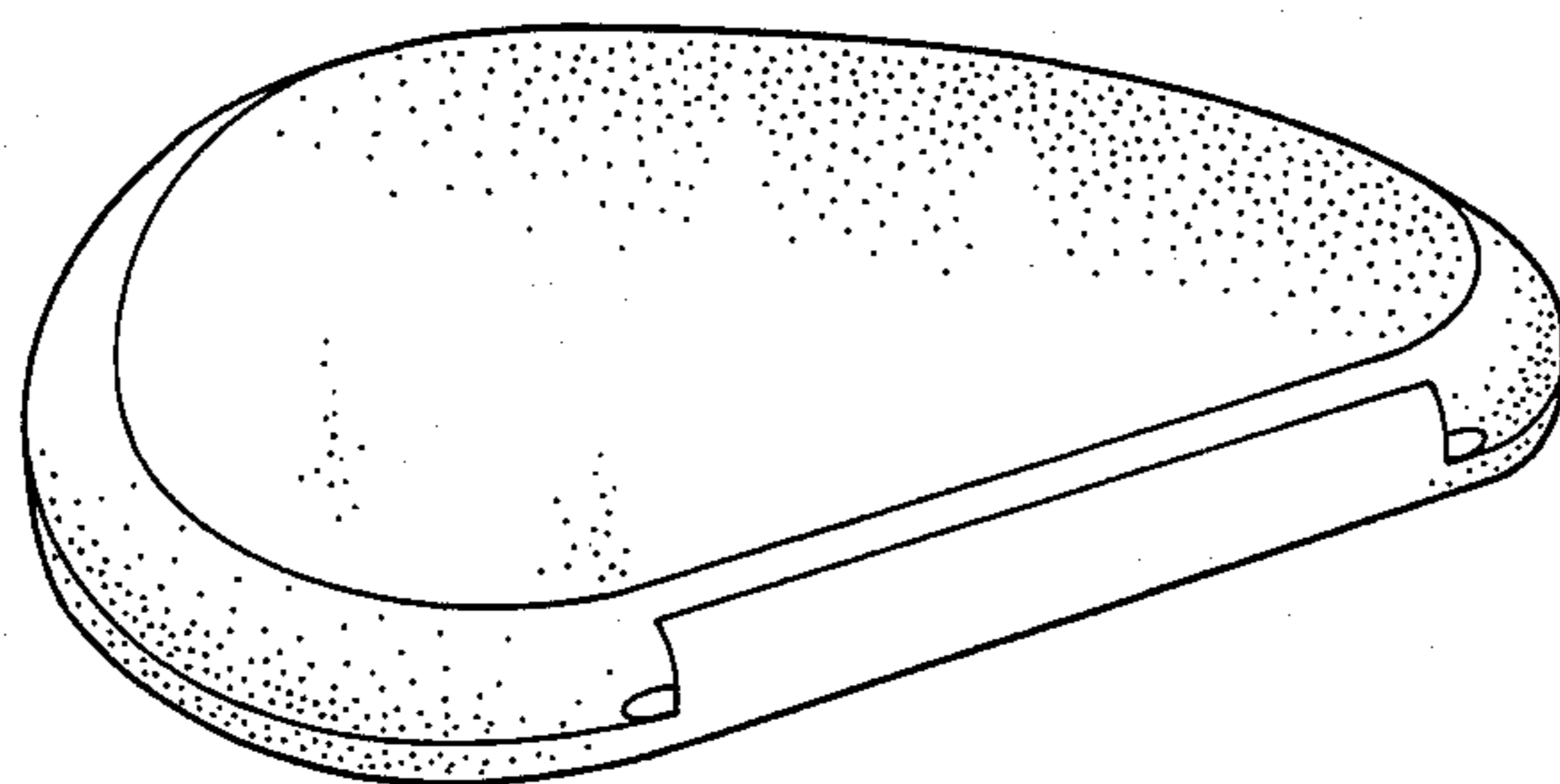

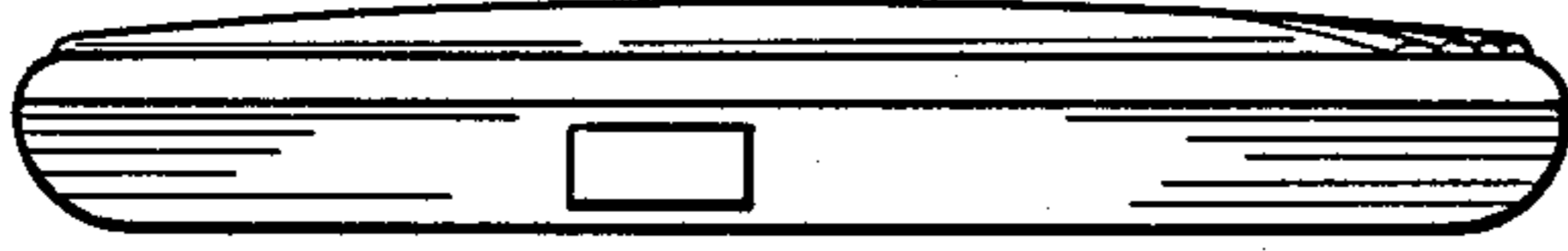

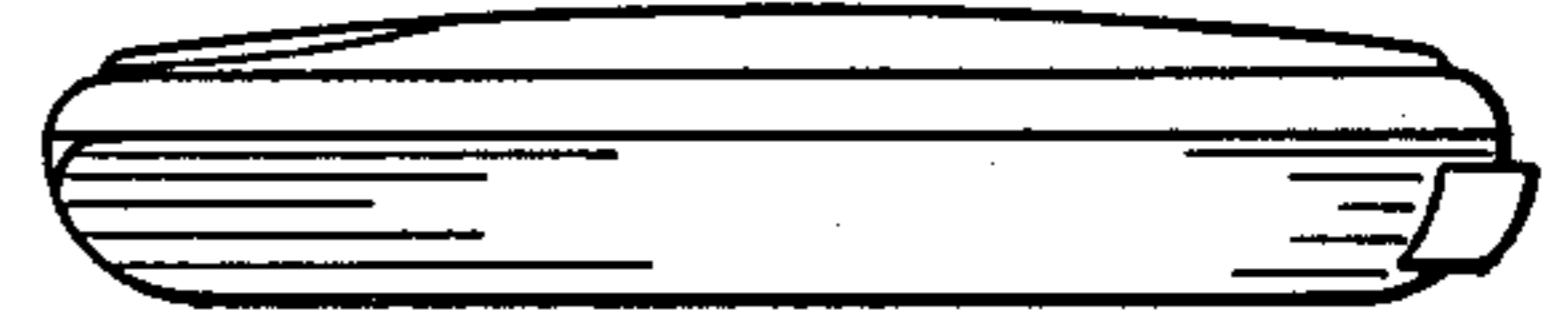

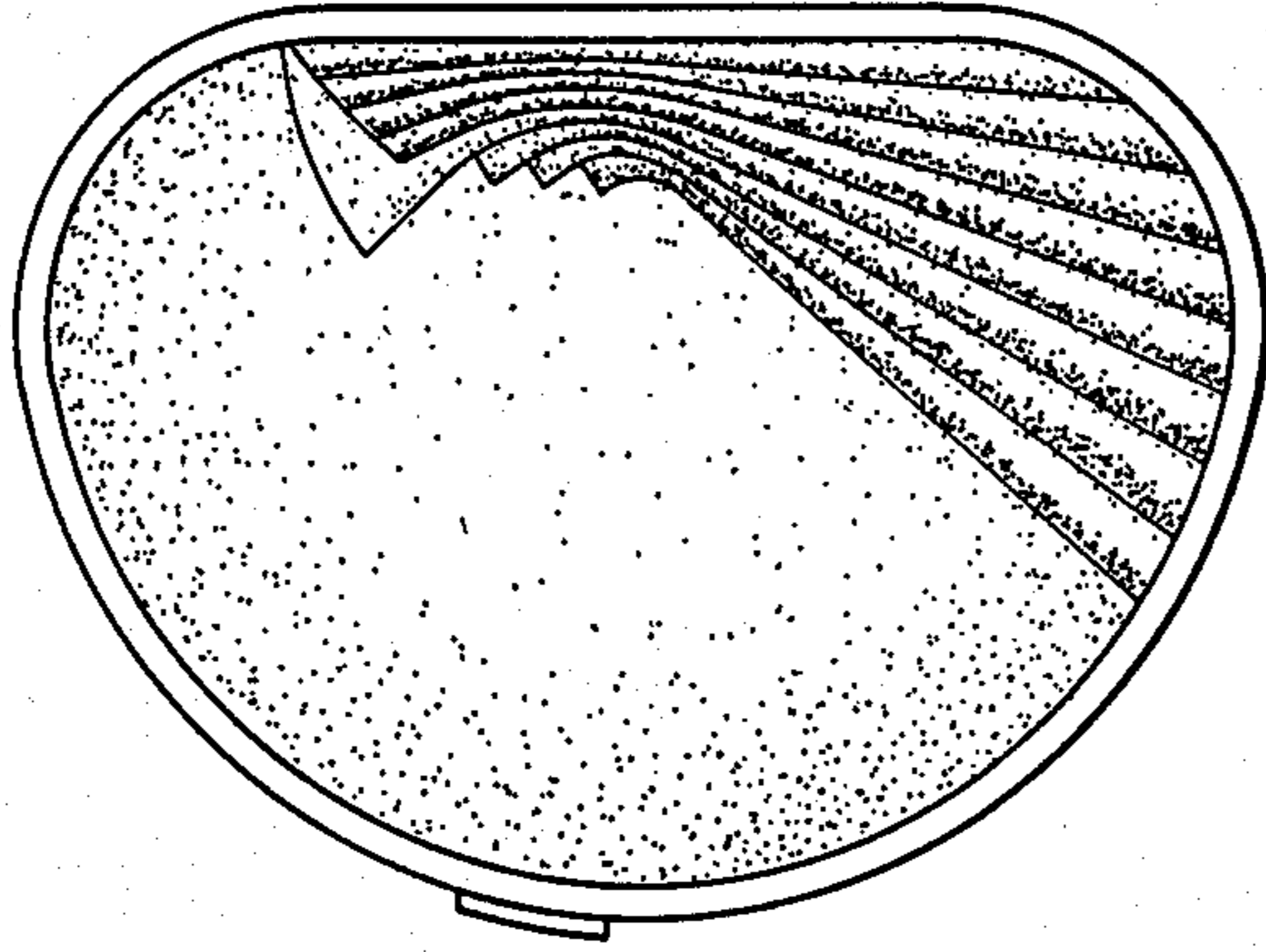

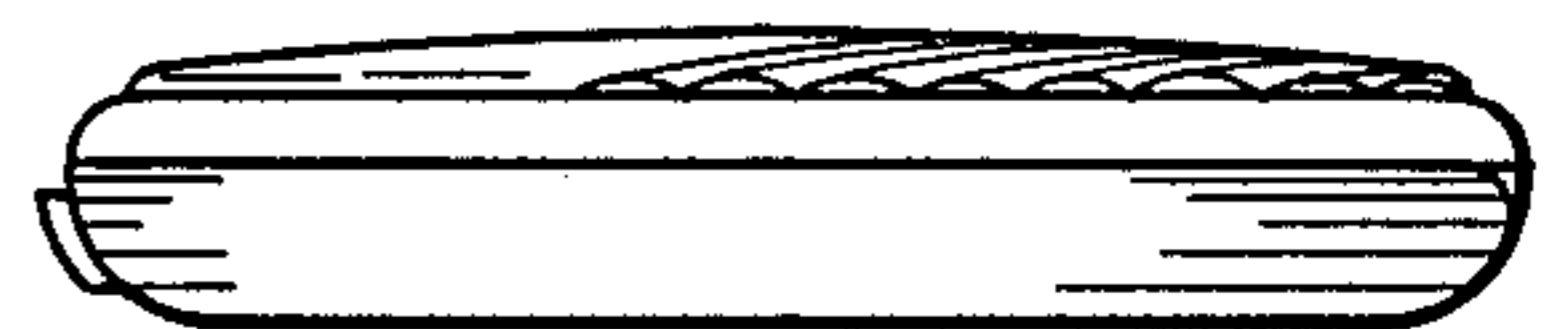

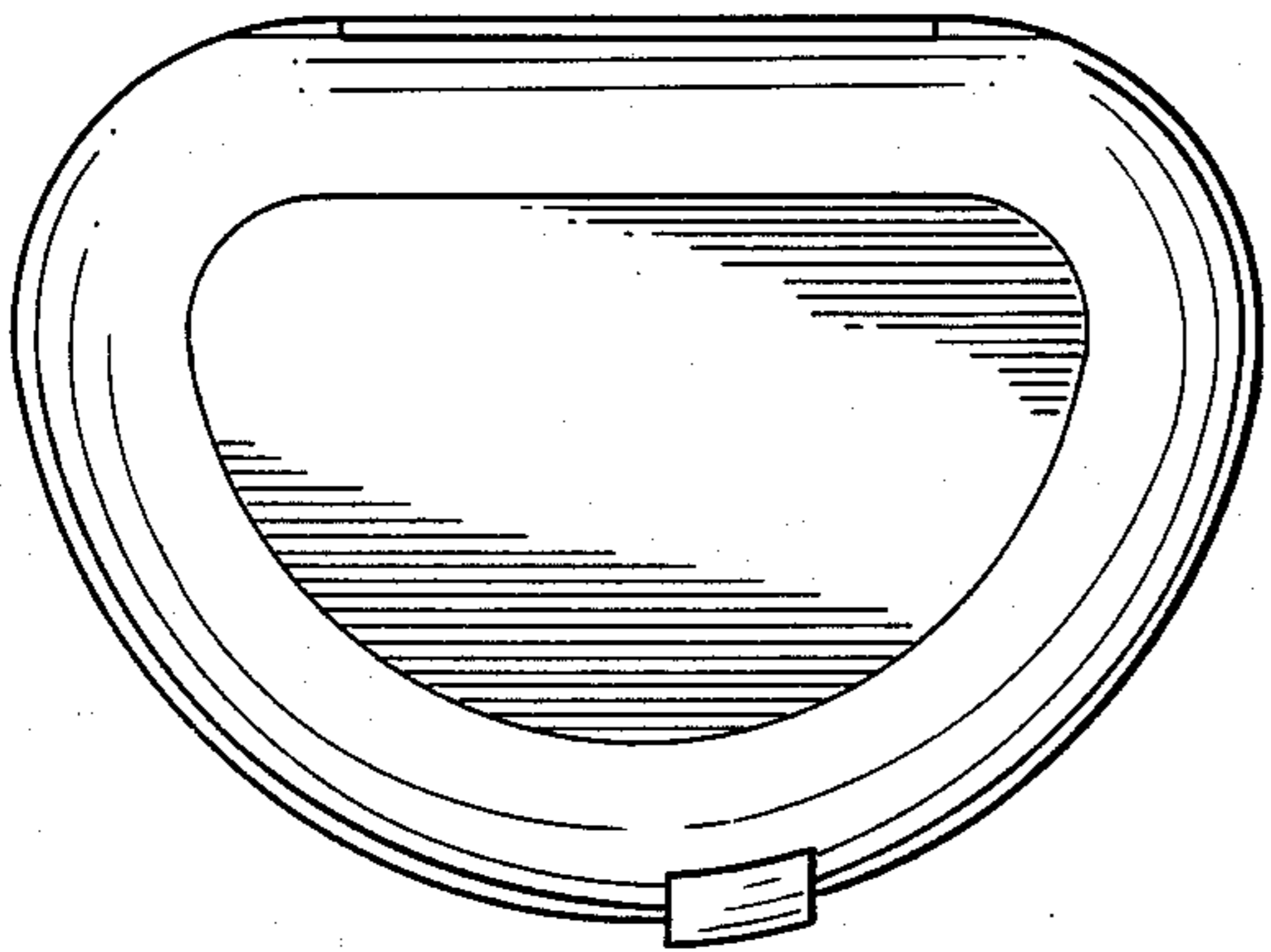

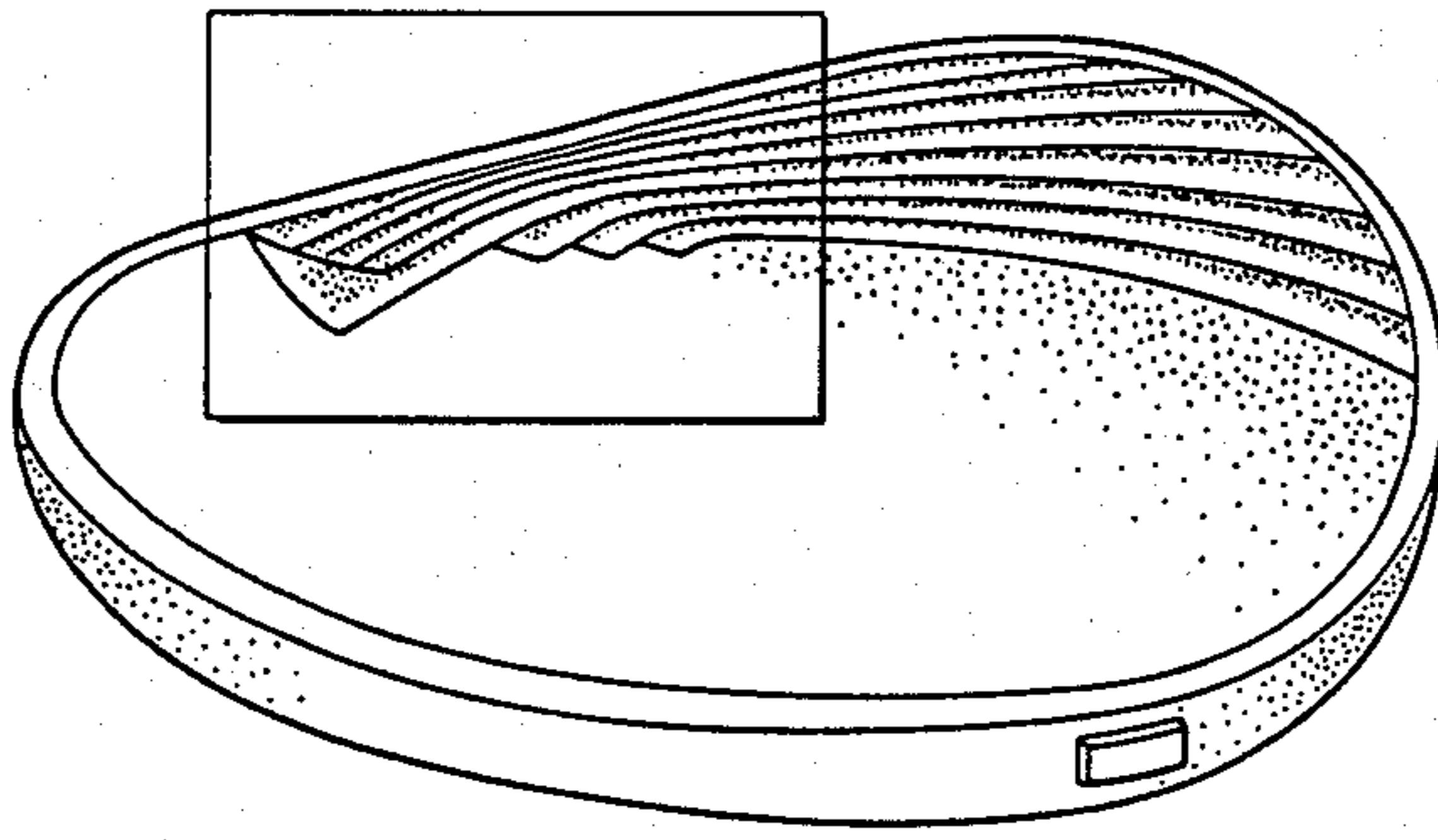

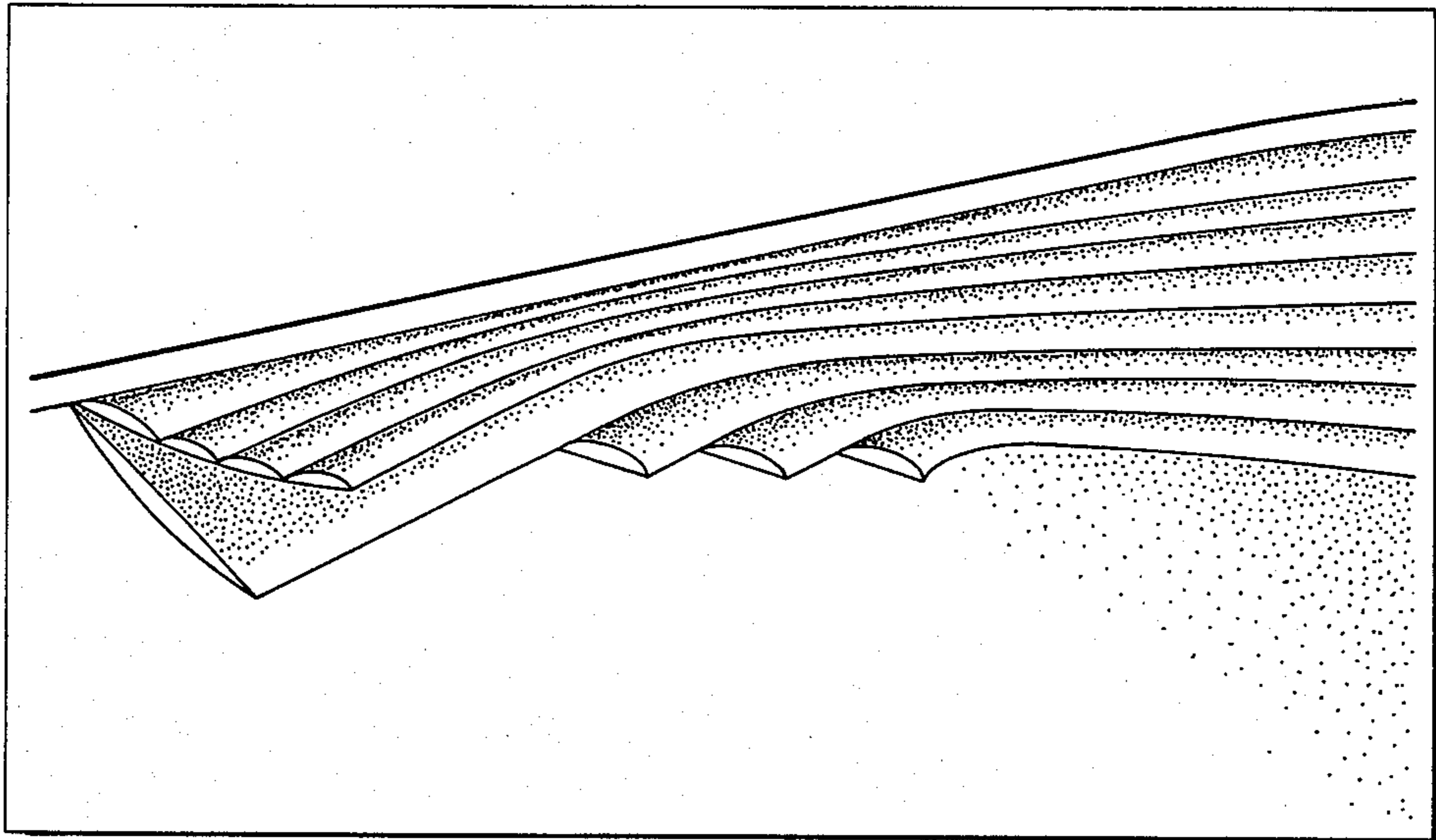

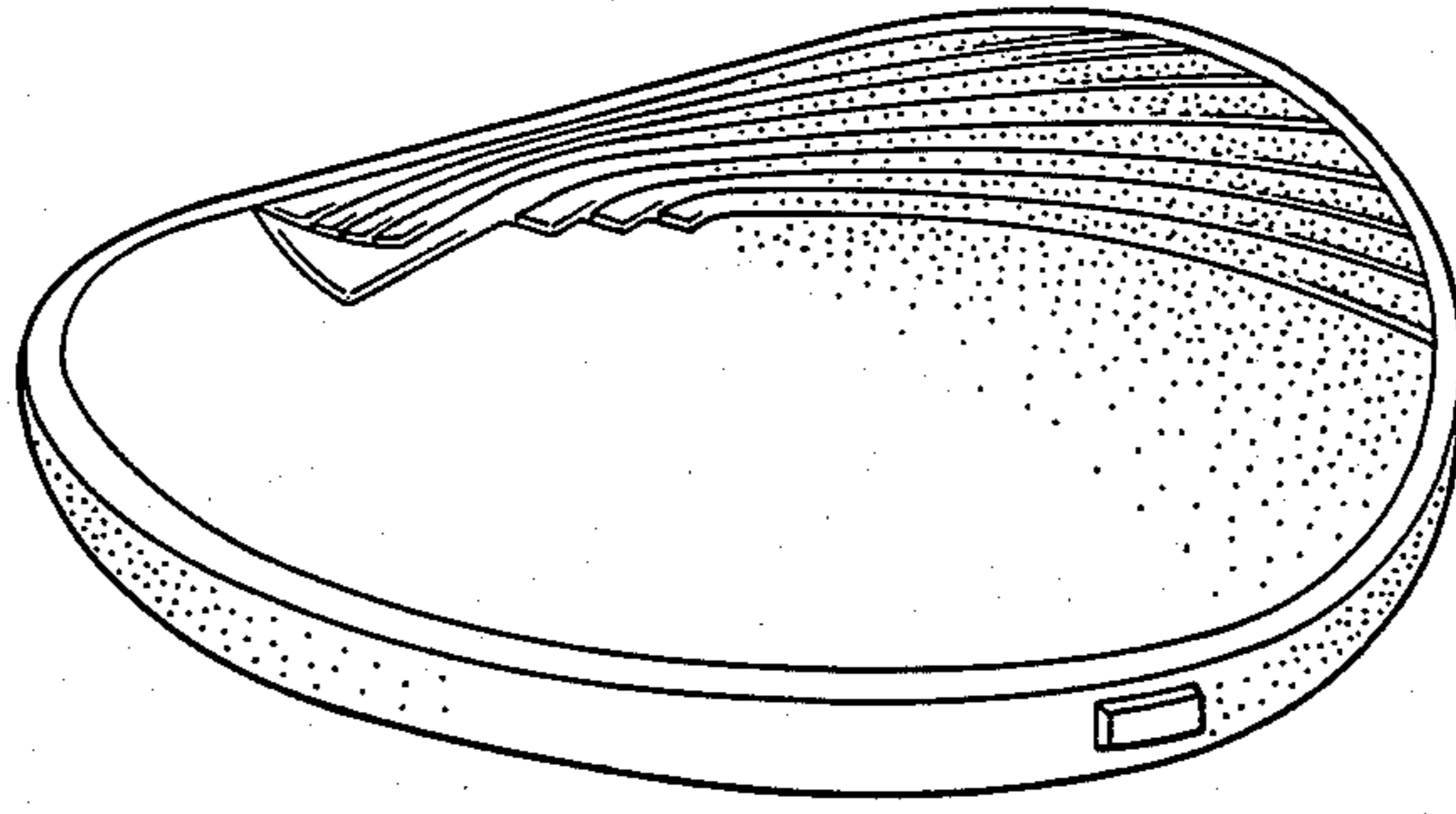

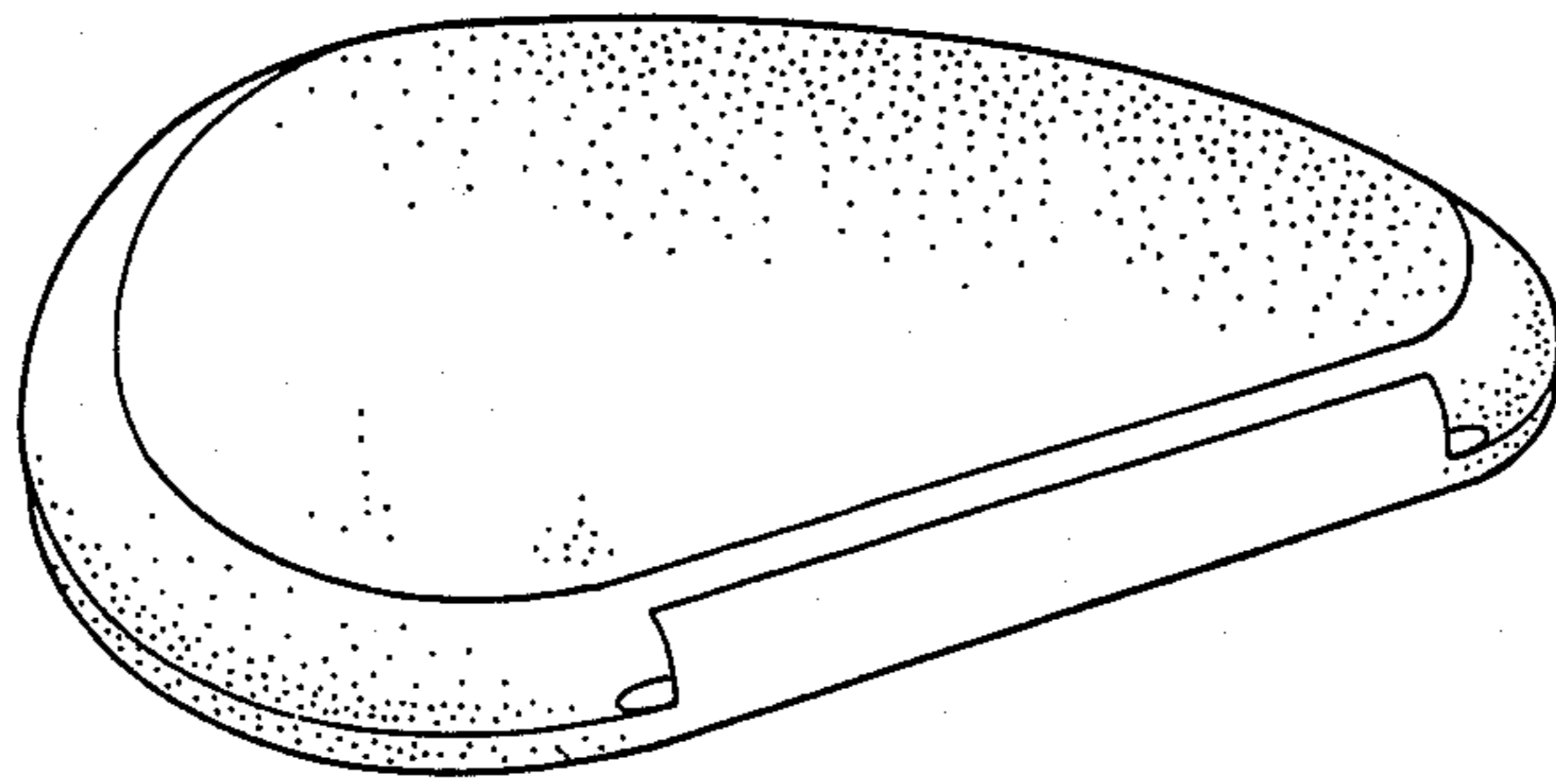

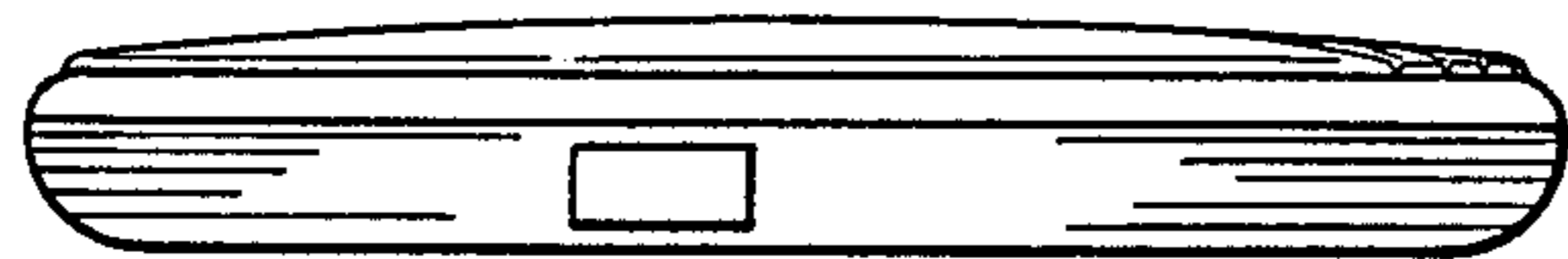

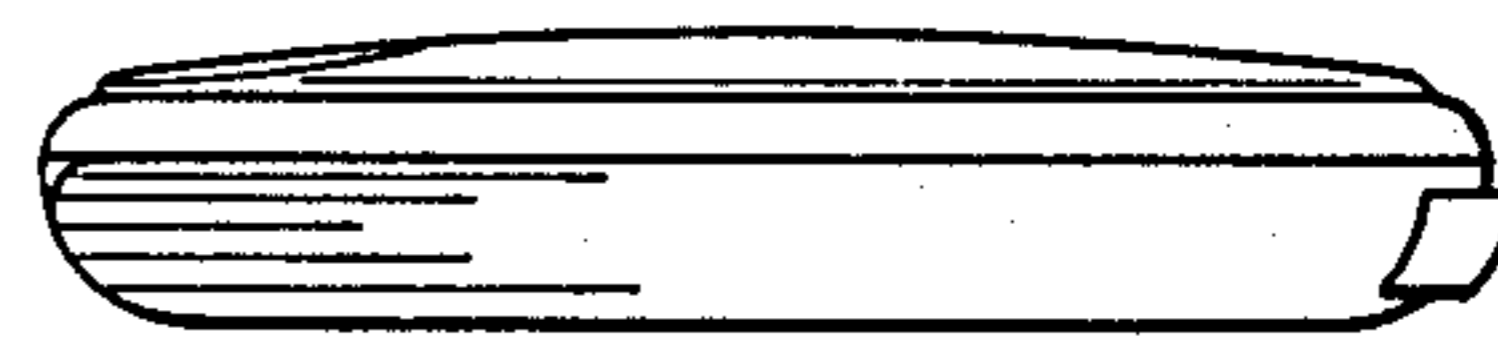

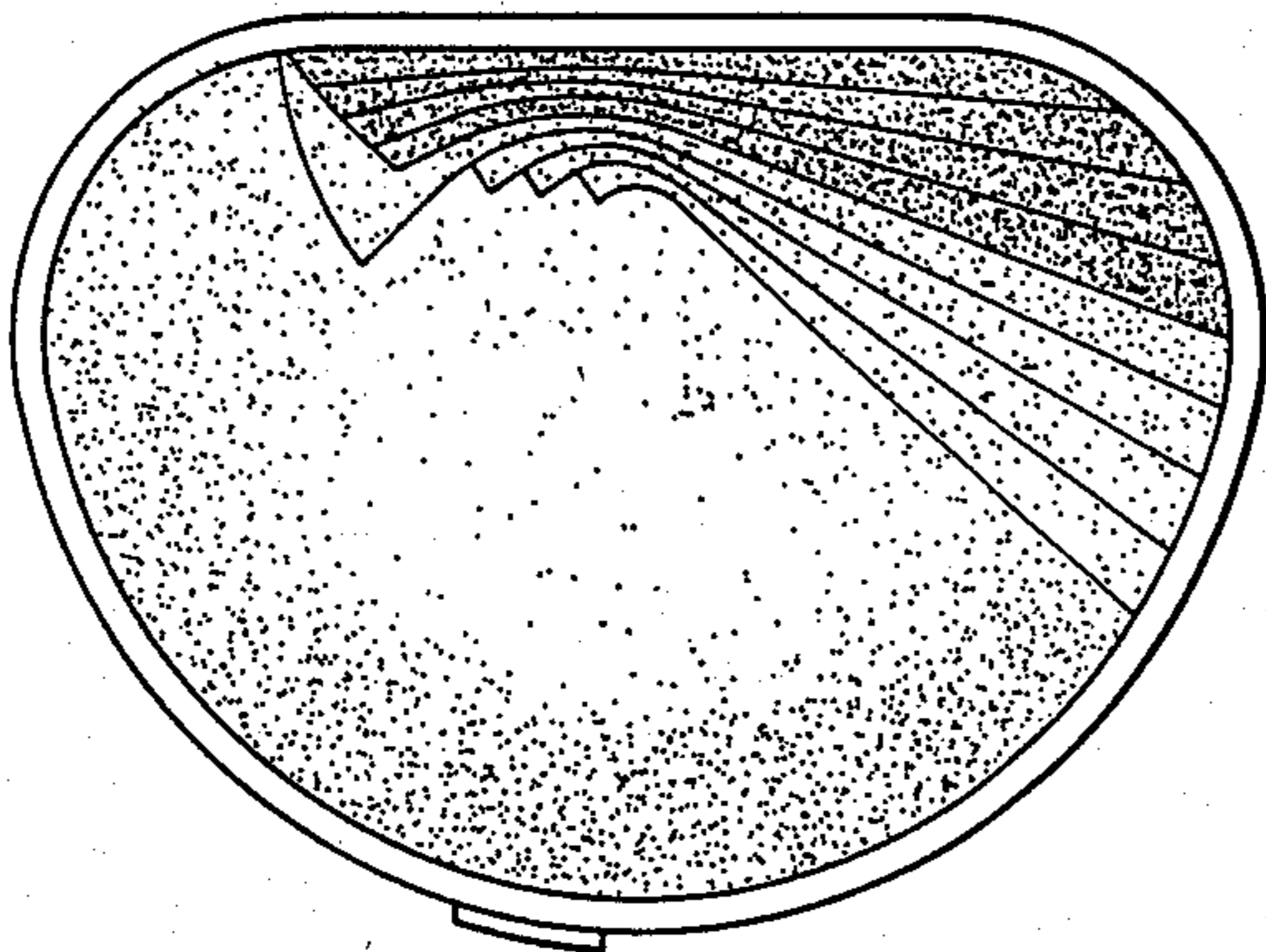

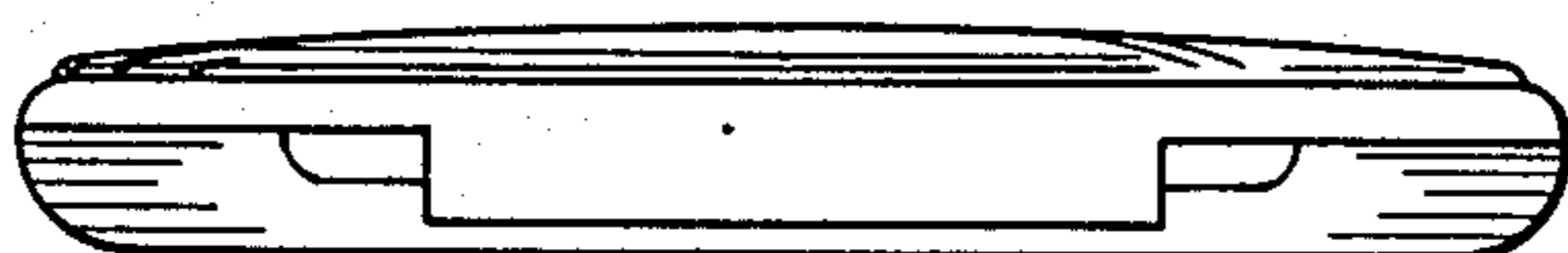

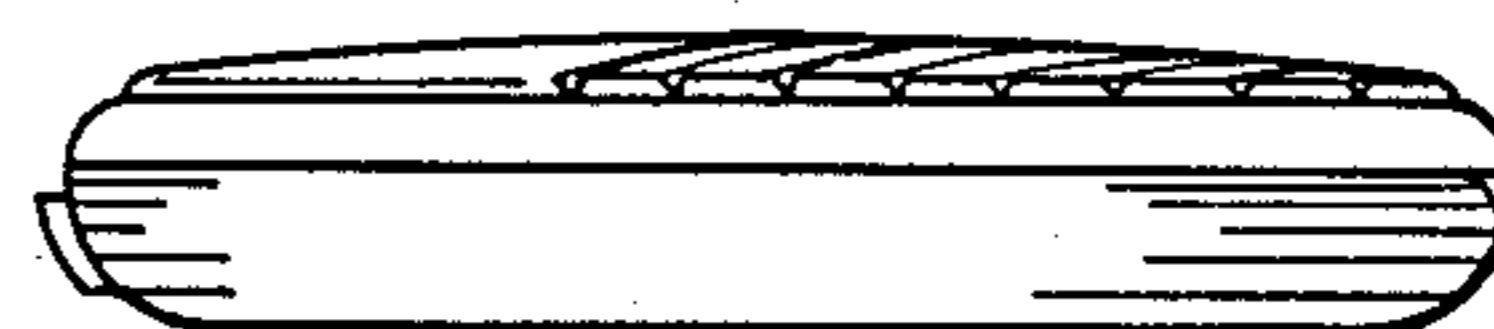

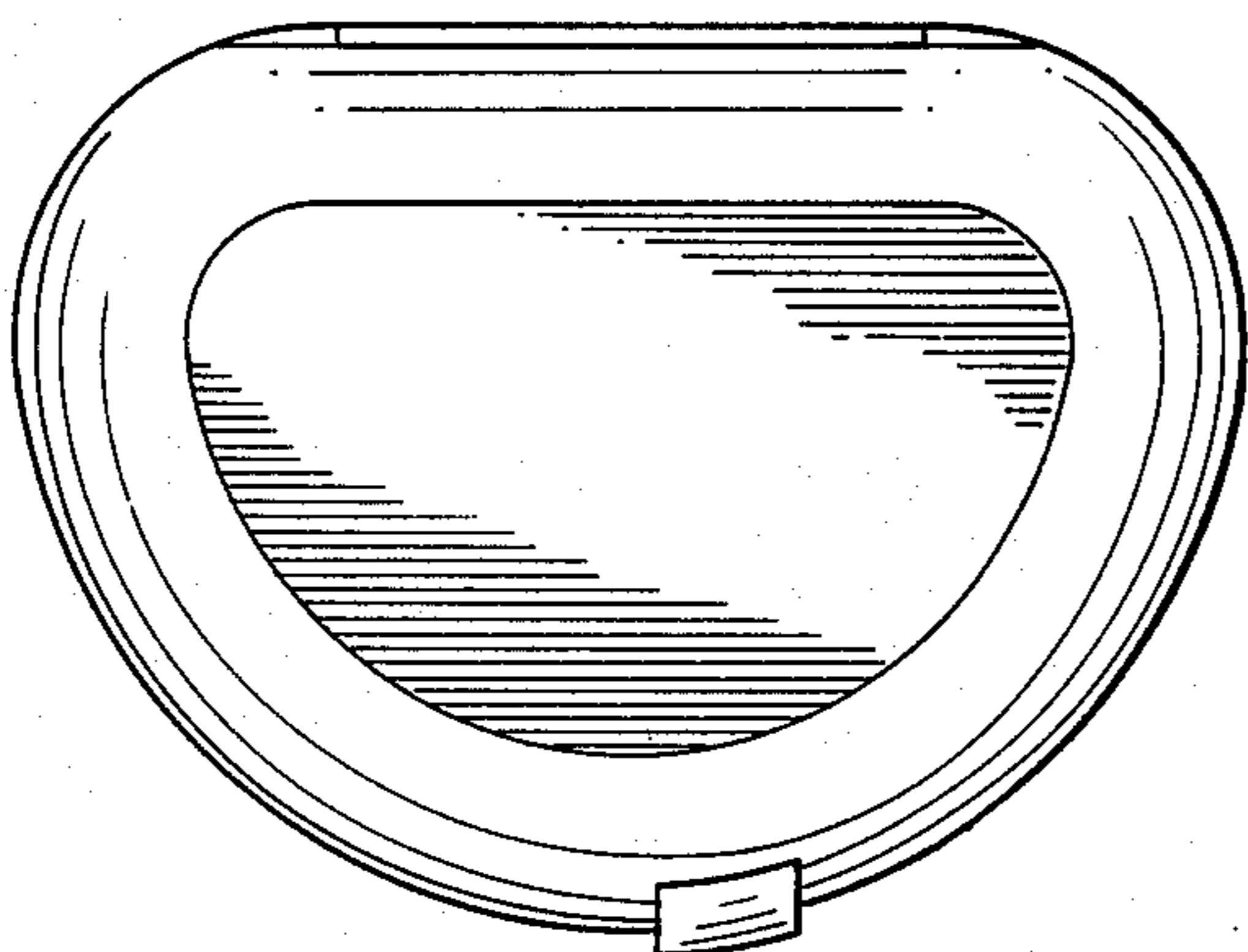

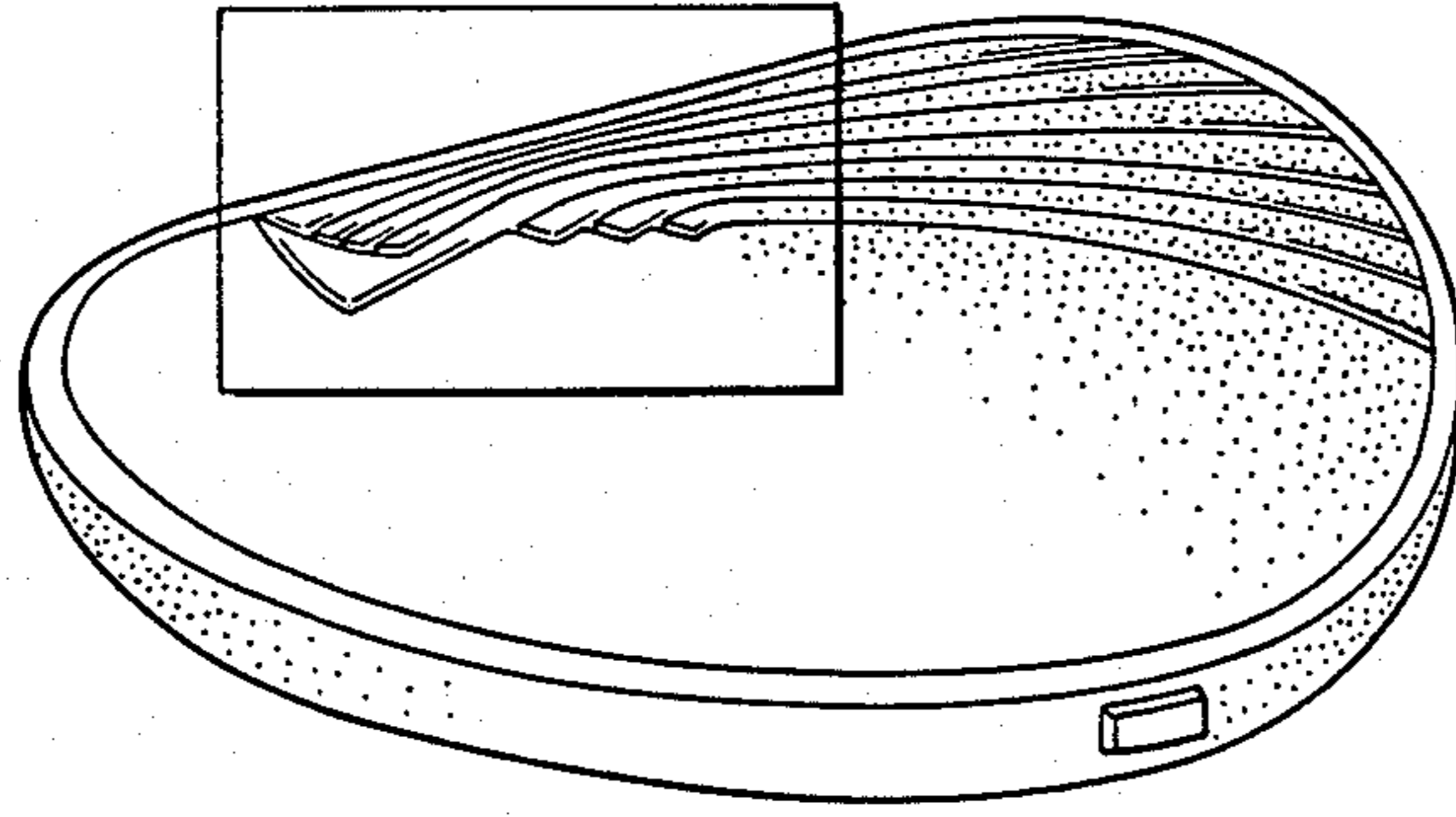

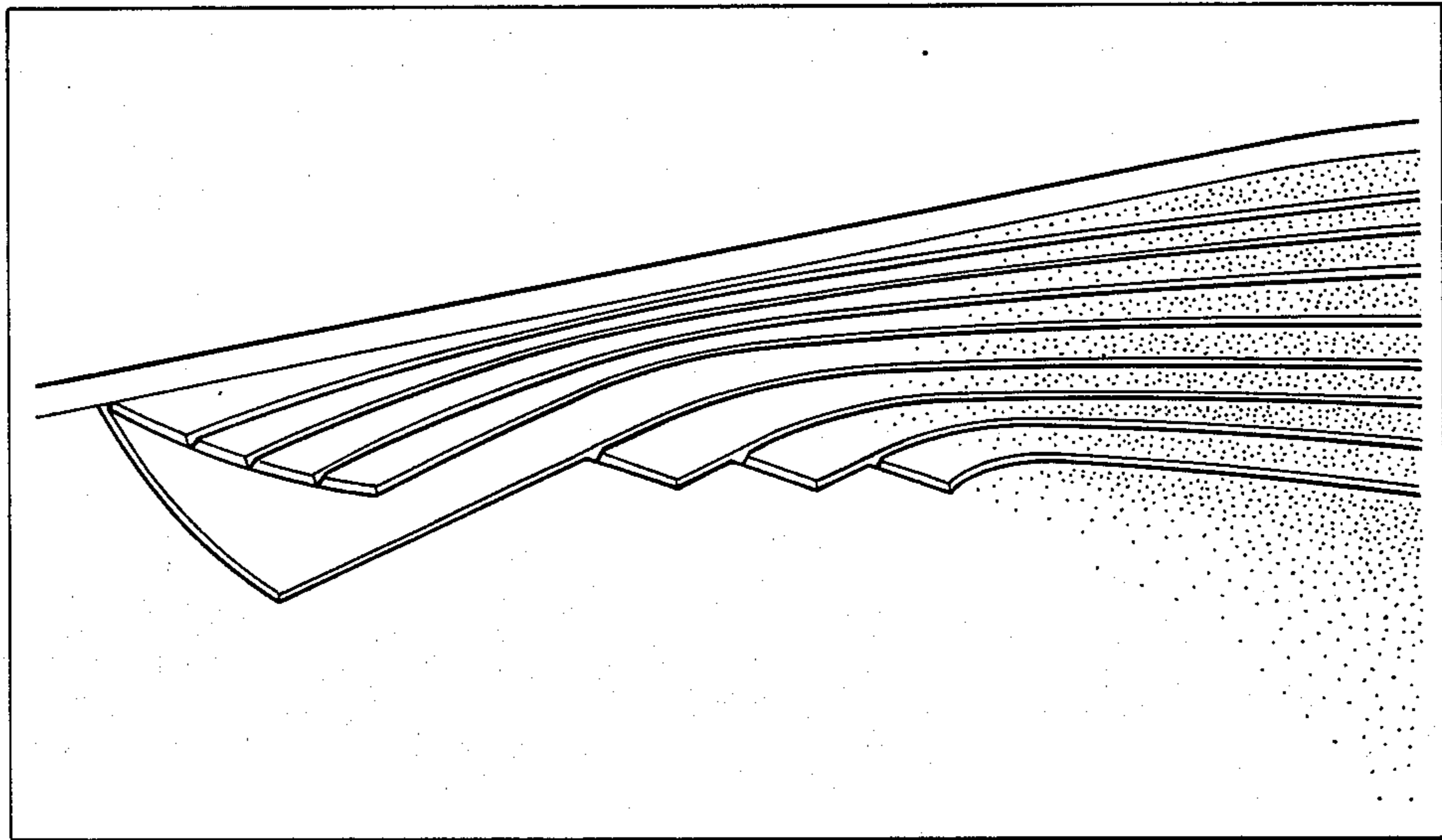
