The ornamental design for a fluid collection receptacle, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a fluid collection receptacle showing my new design;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is a front elevational view thereof;
 FIG. 4 is a rear elevational view thereof;
 FIG. 5 is a side elevational view thereof, the opposite side elevational view being a mirror image of that shown; and
 FIG. 6 is a bottom plan view thereof.

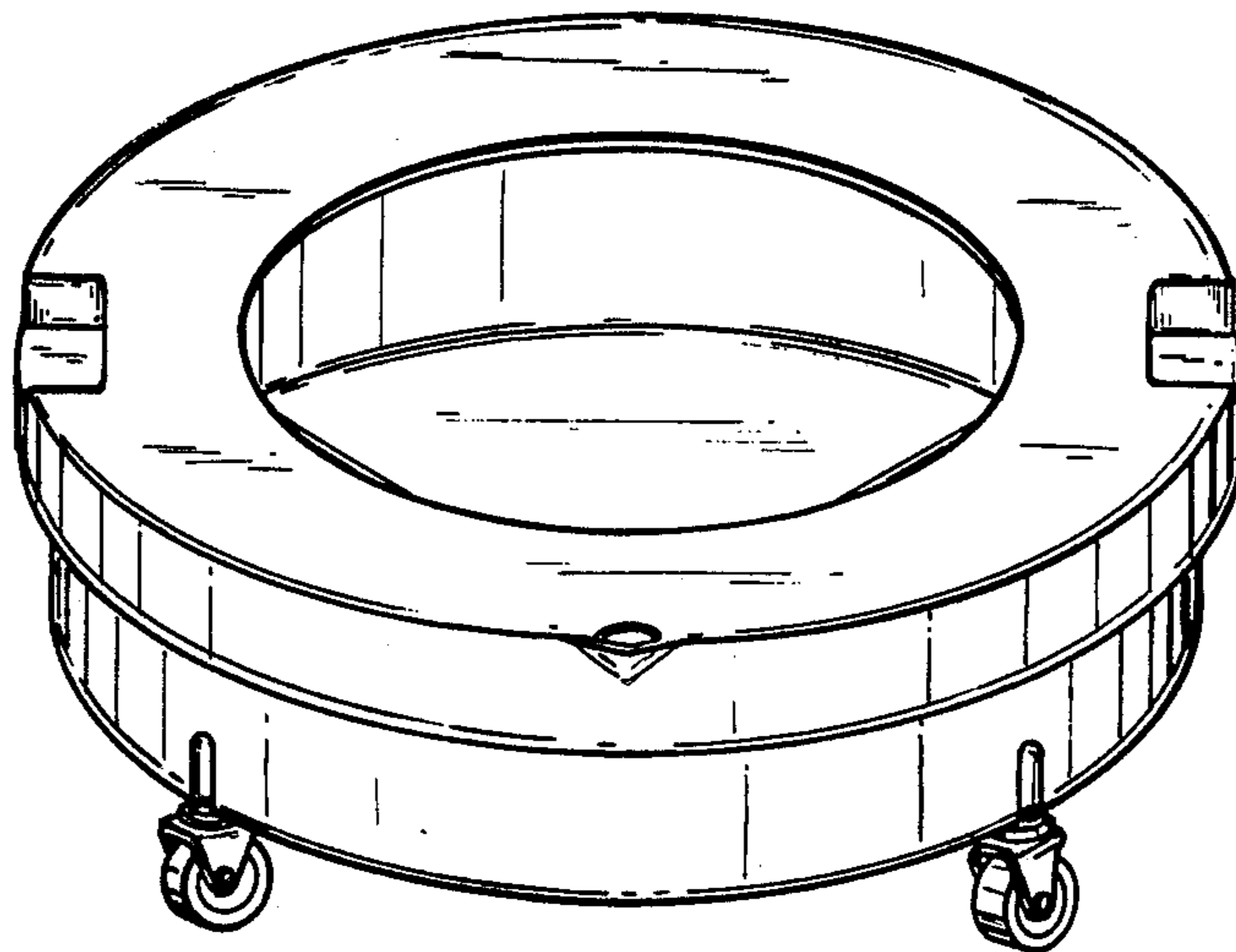

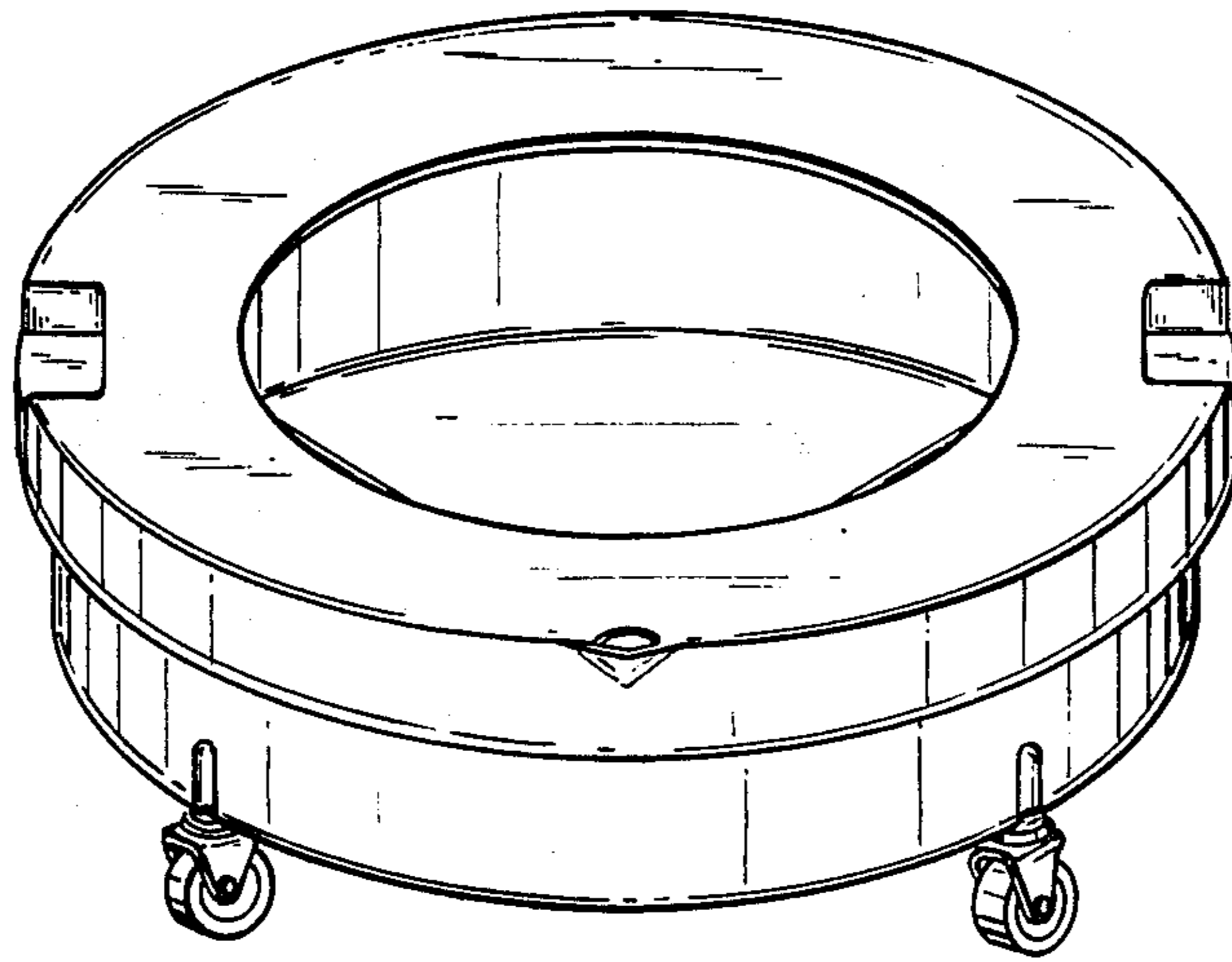

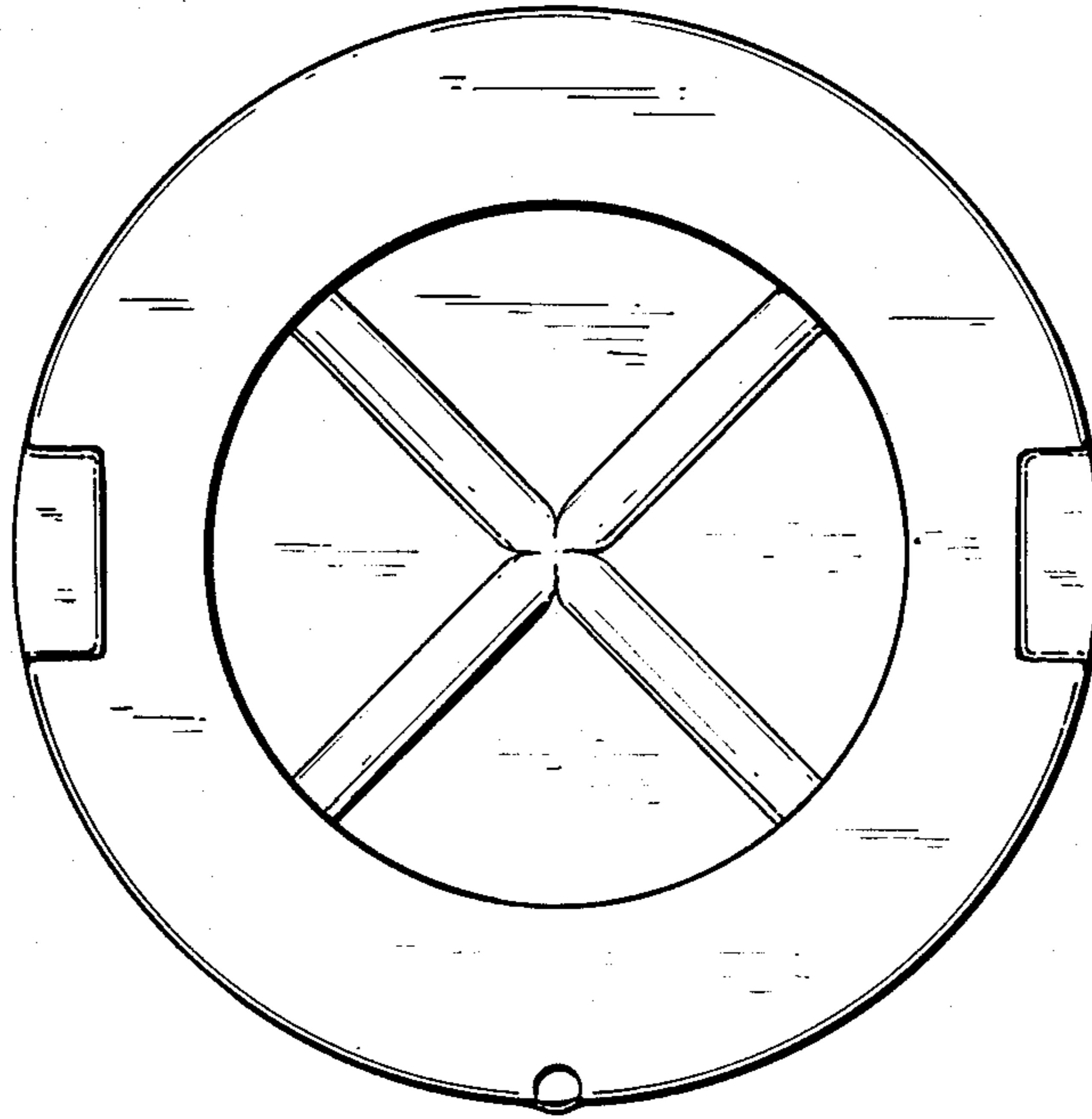
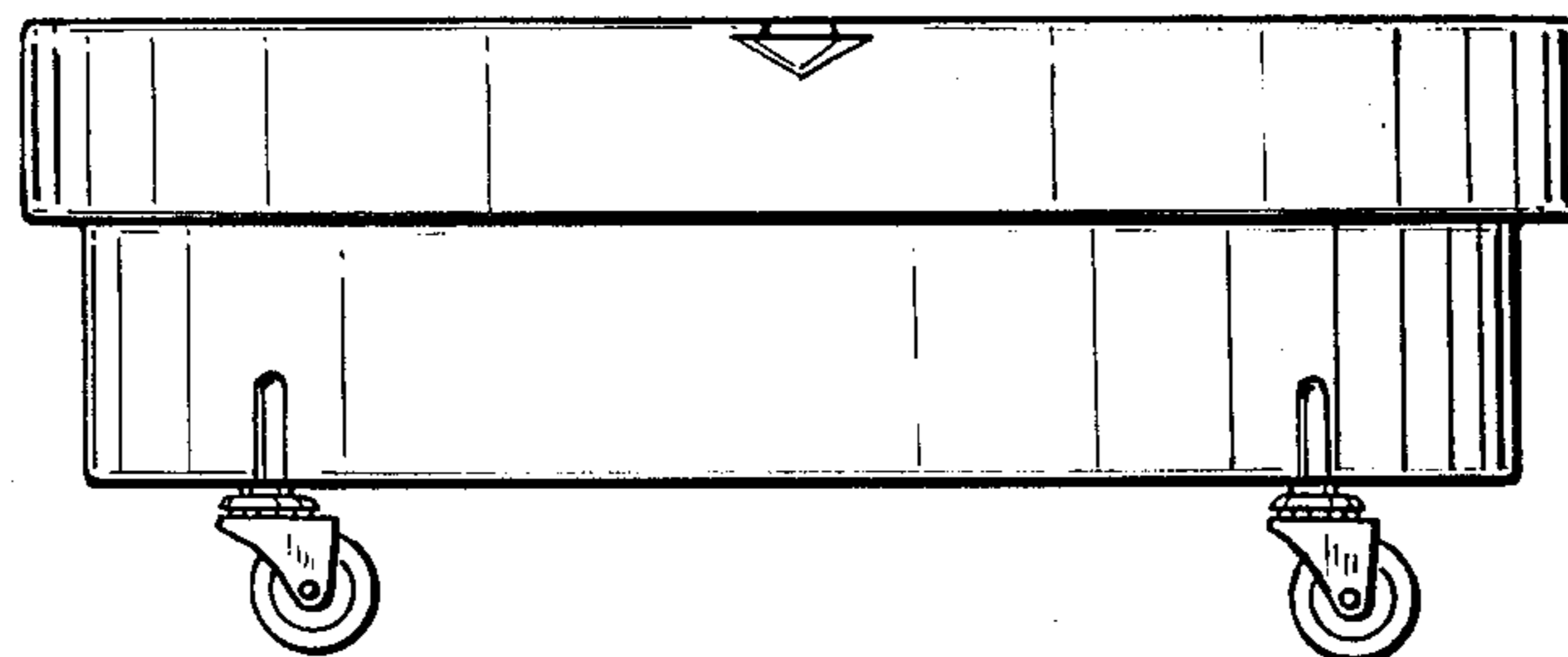

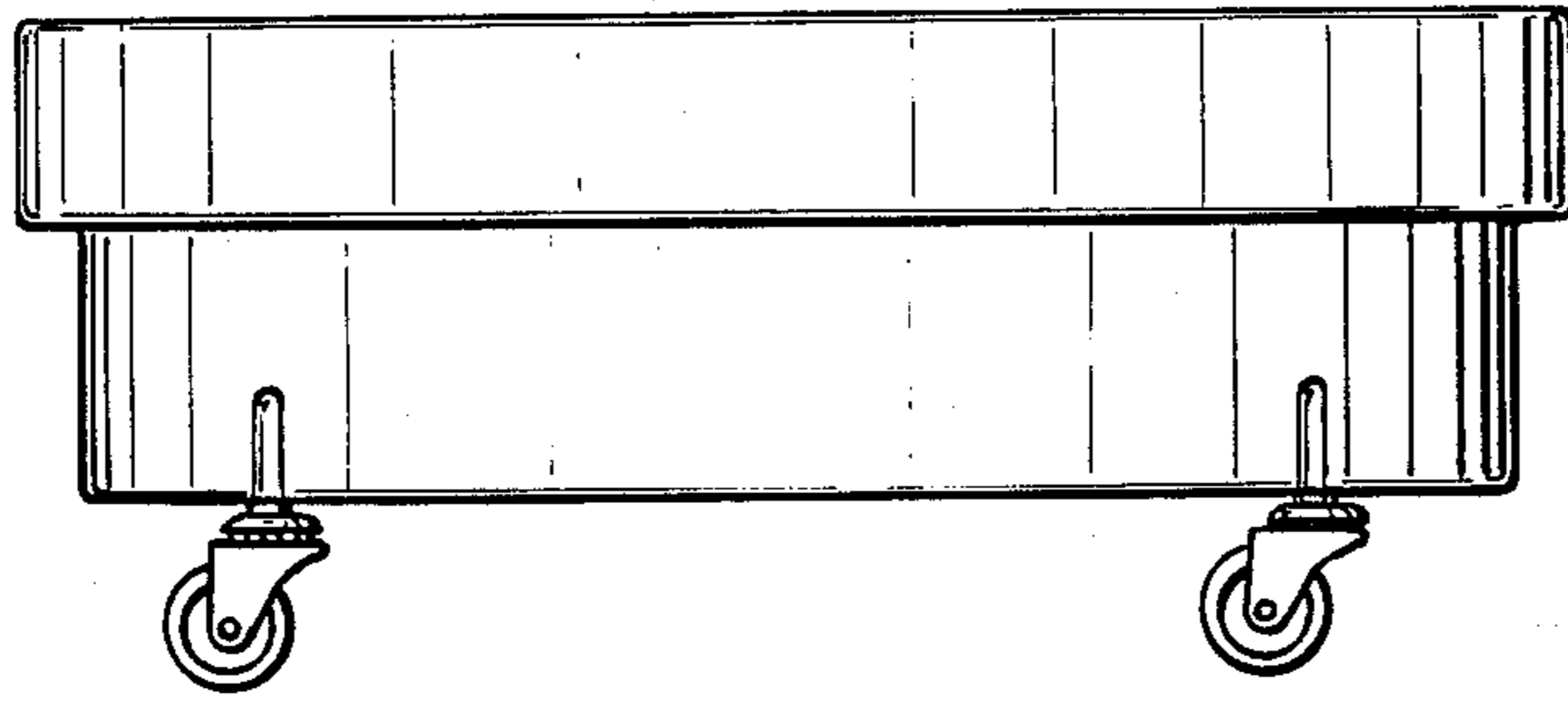

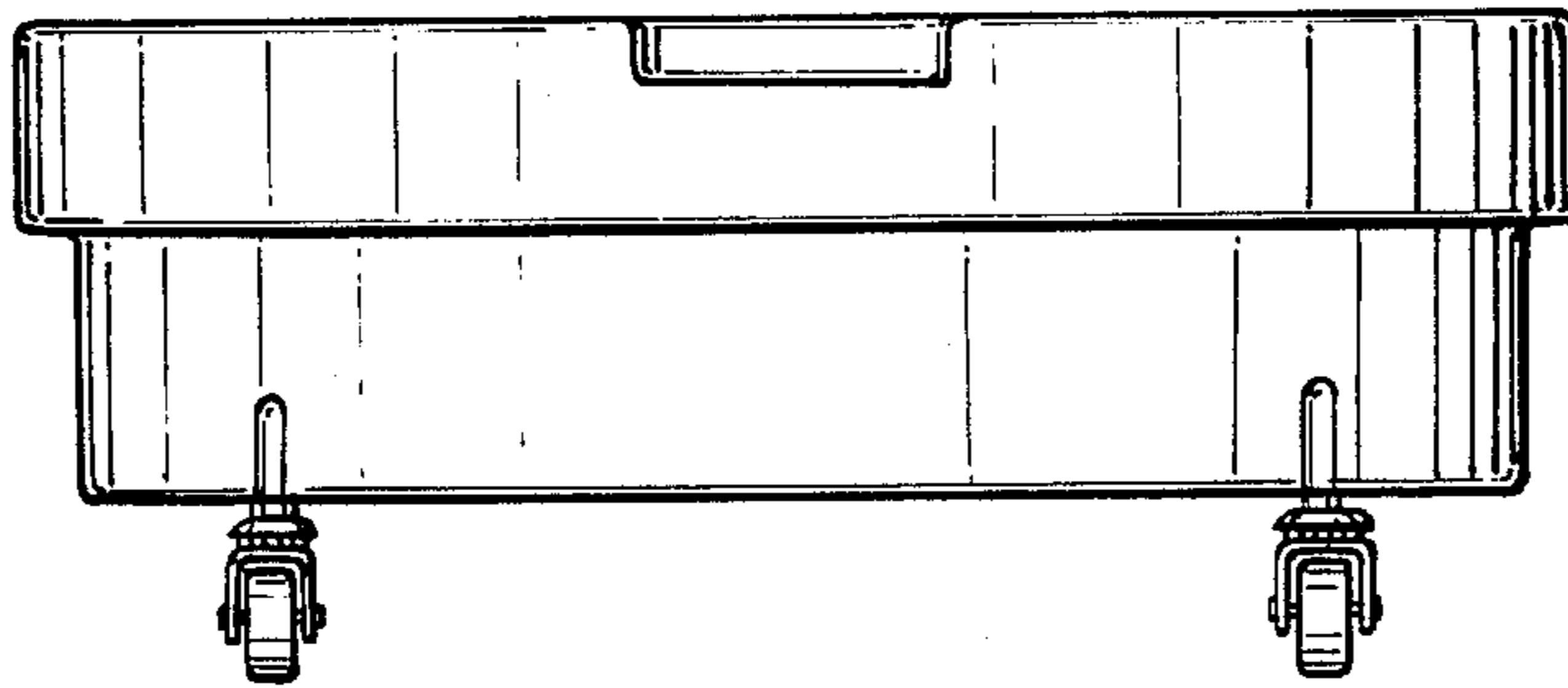

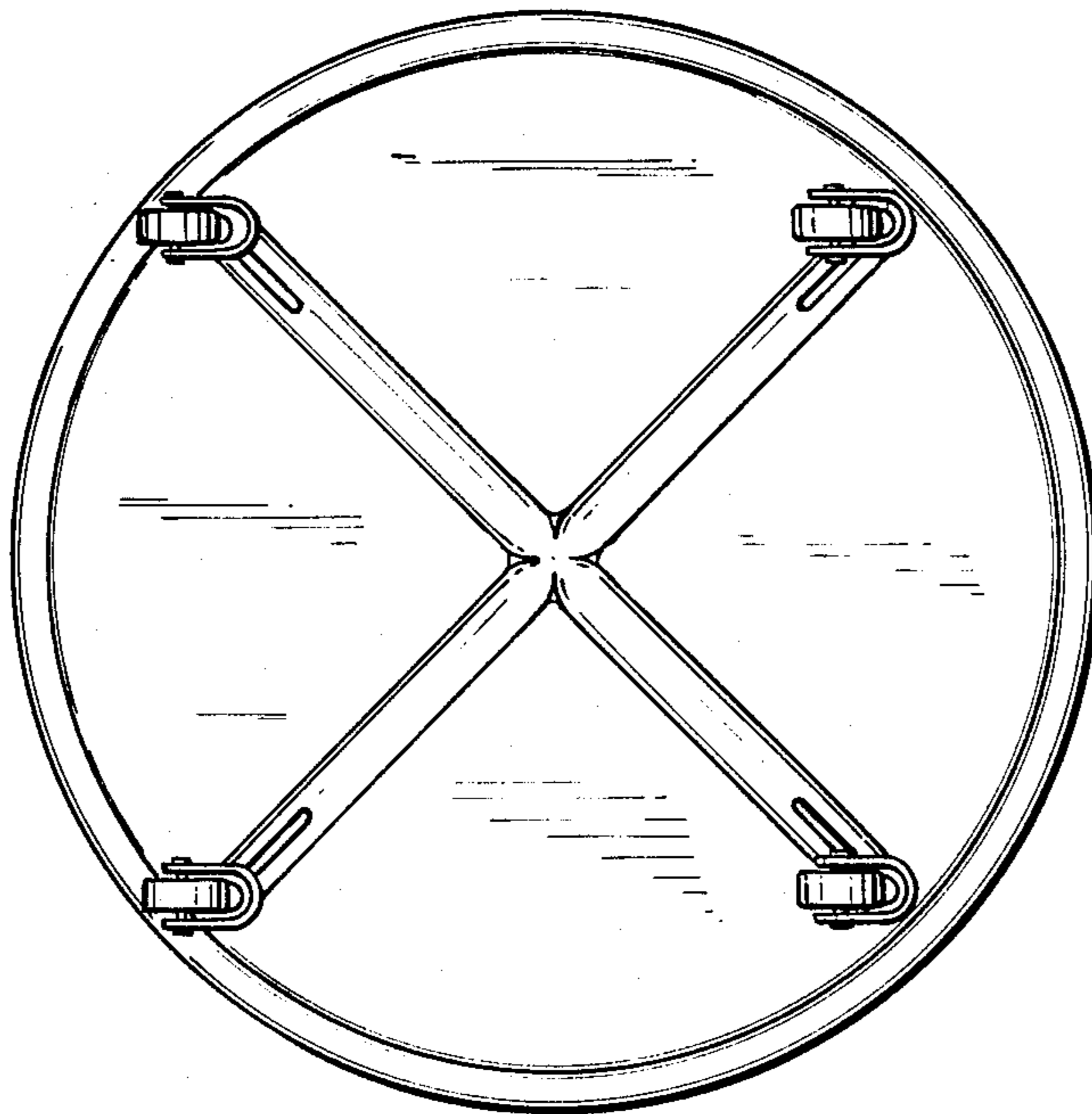
