The ornamental design for an electrophoresis sequencing apparatus, as shown.

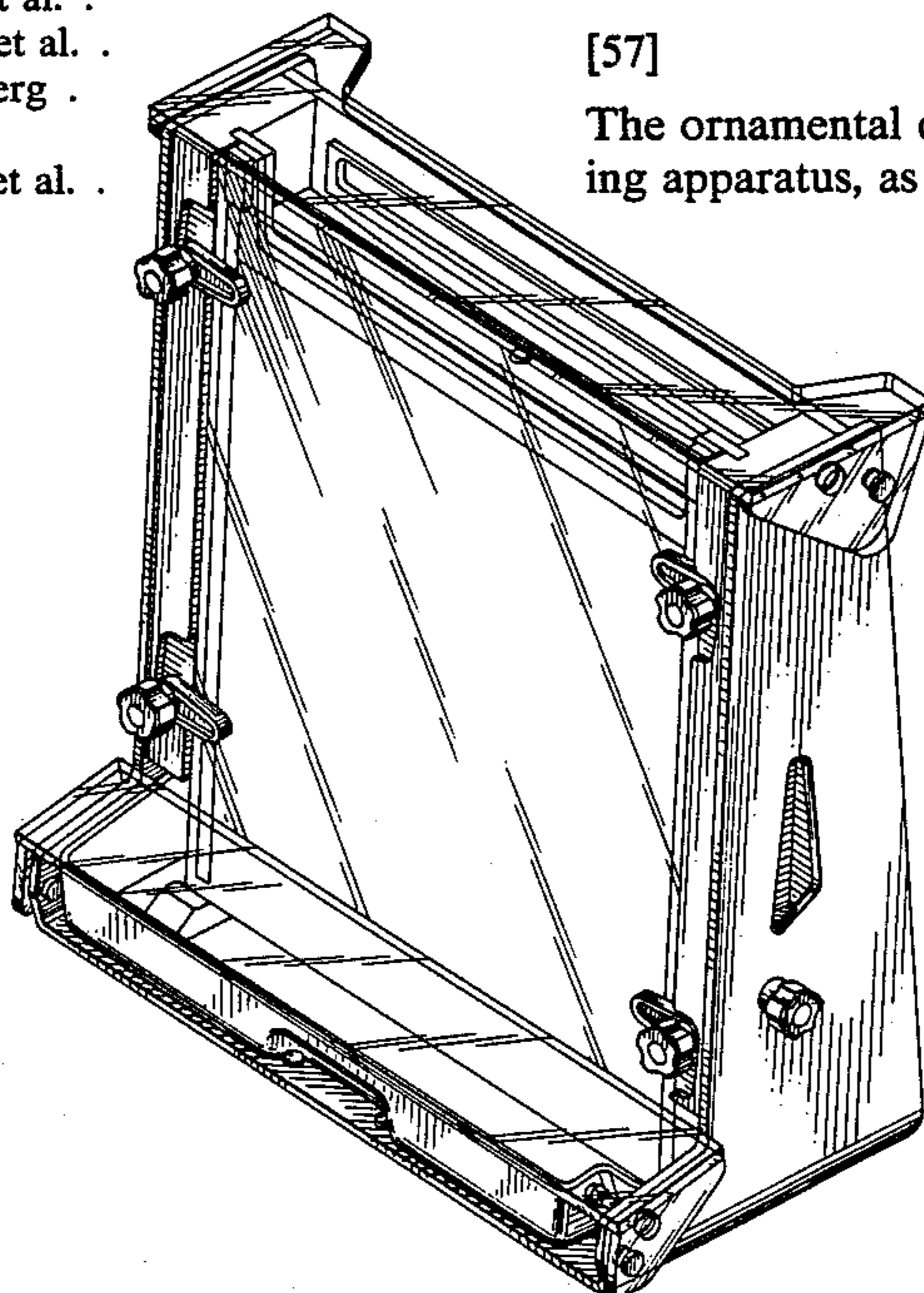

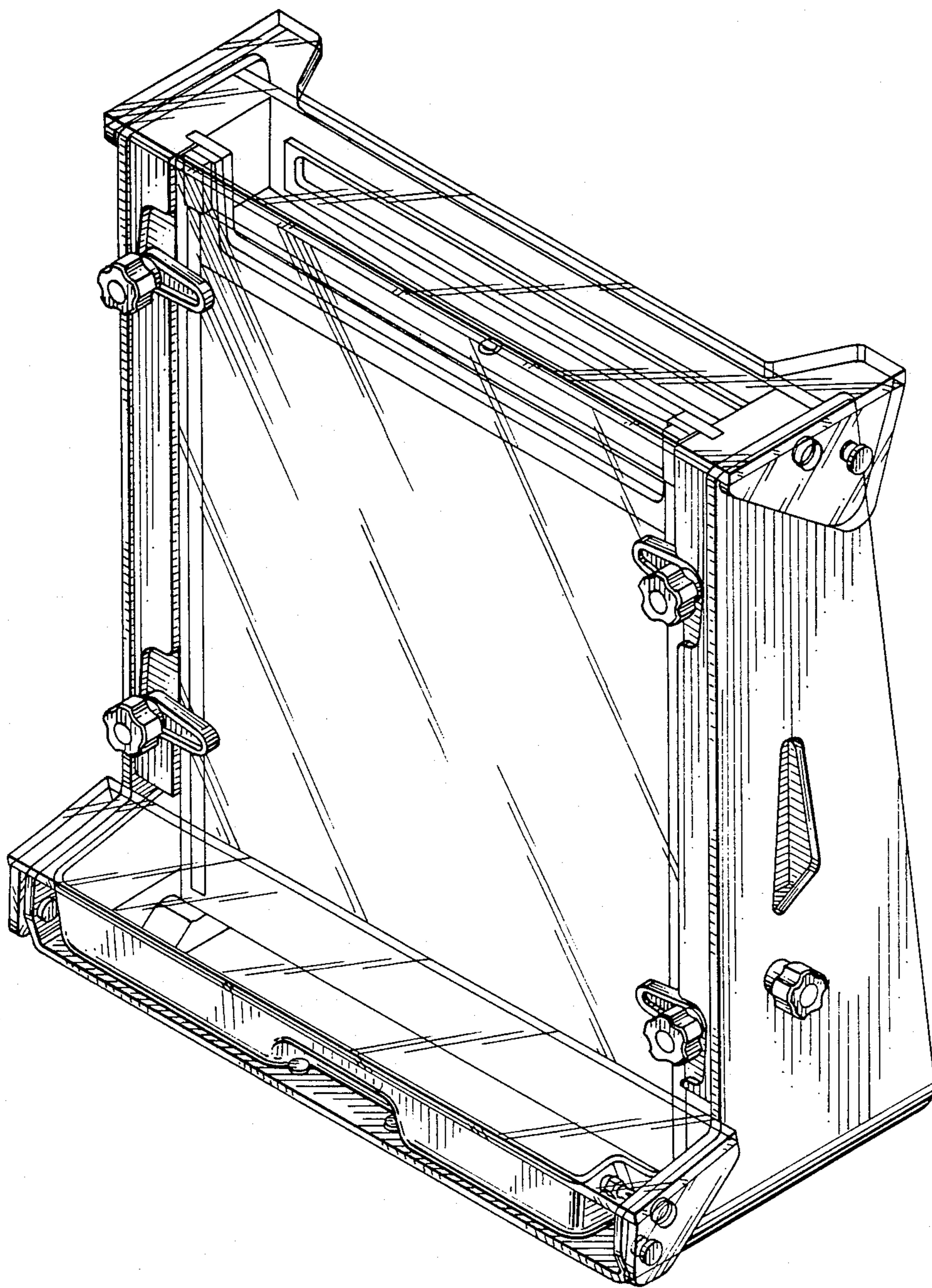

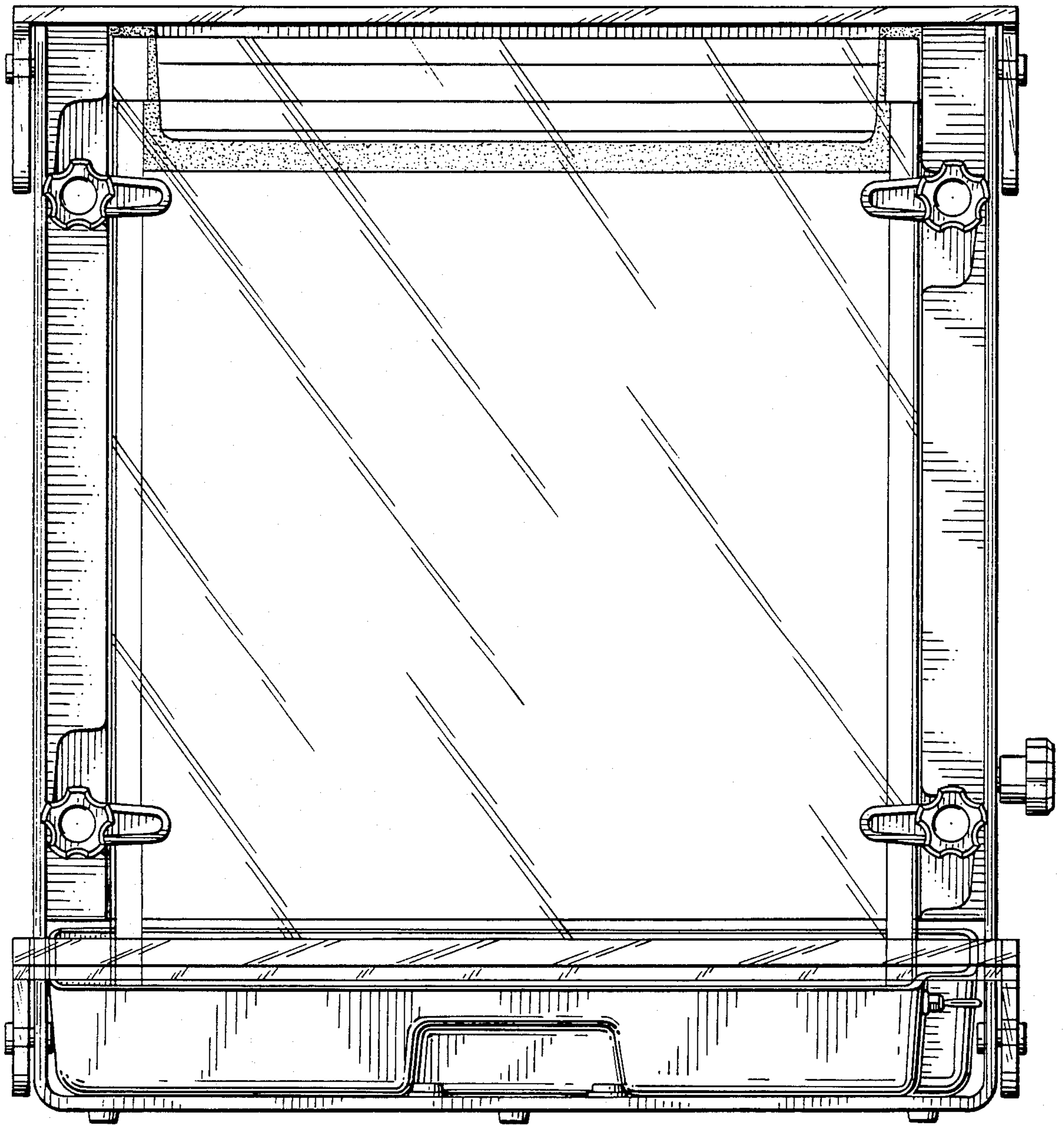

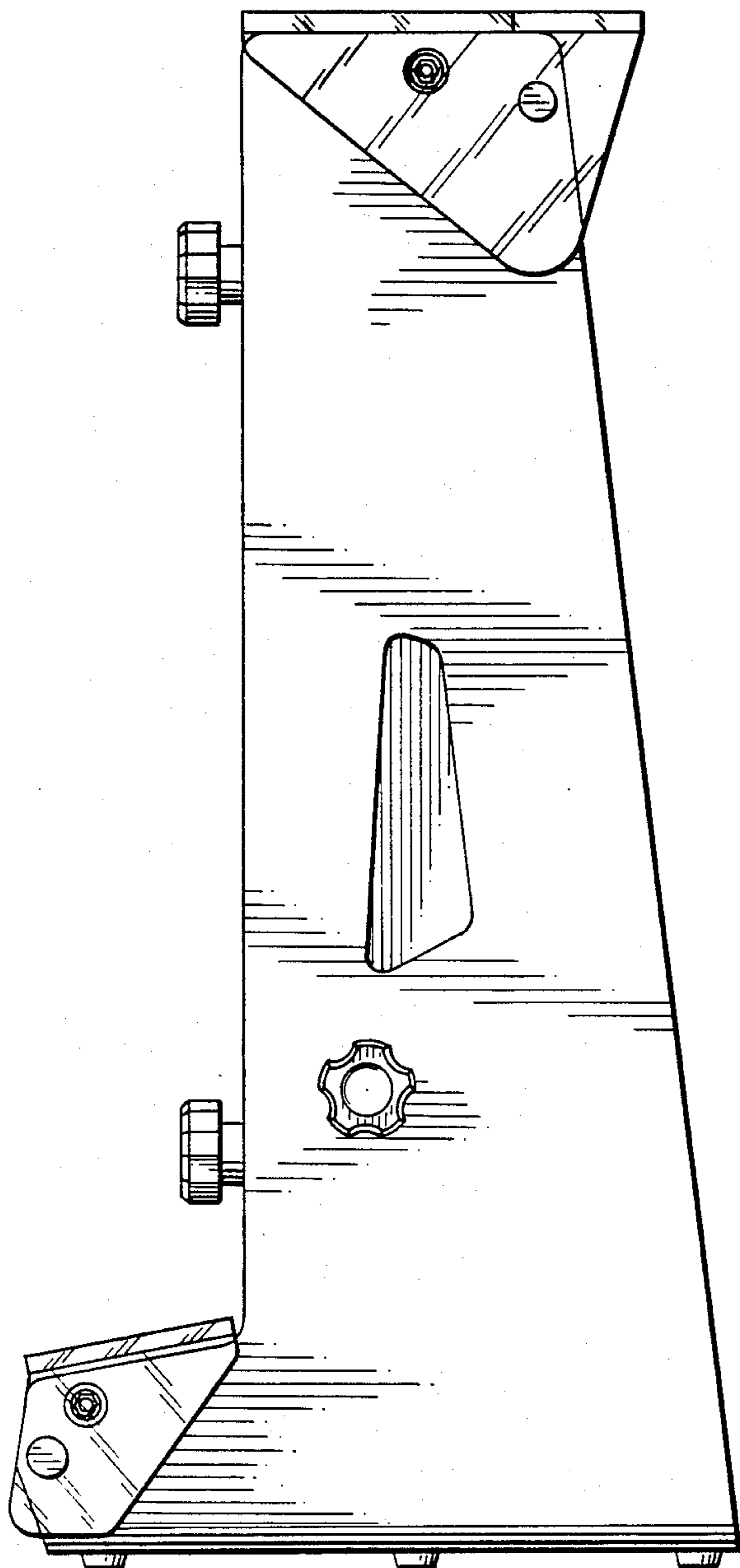

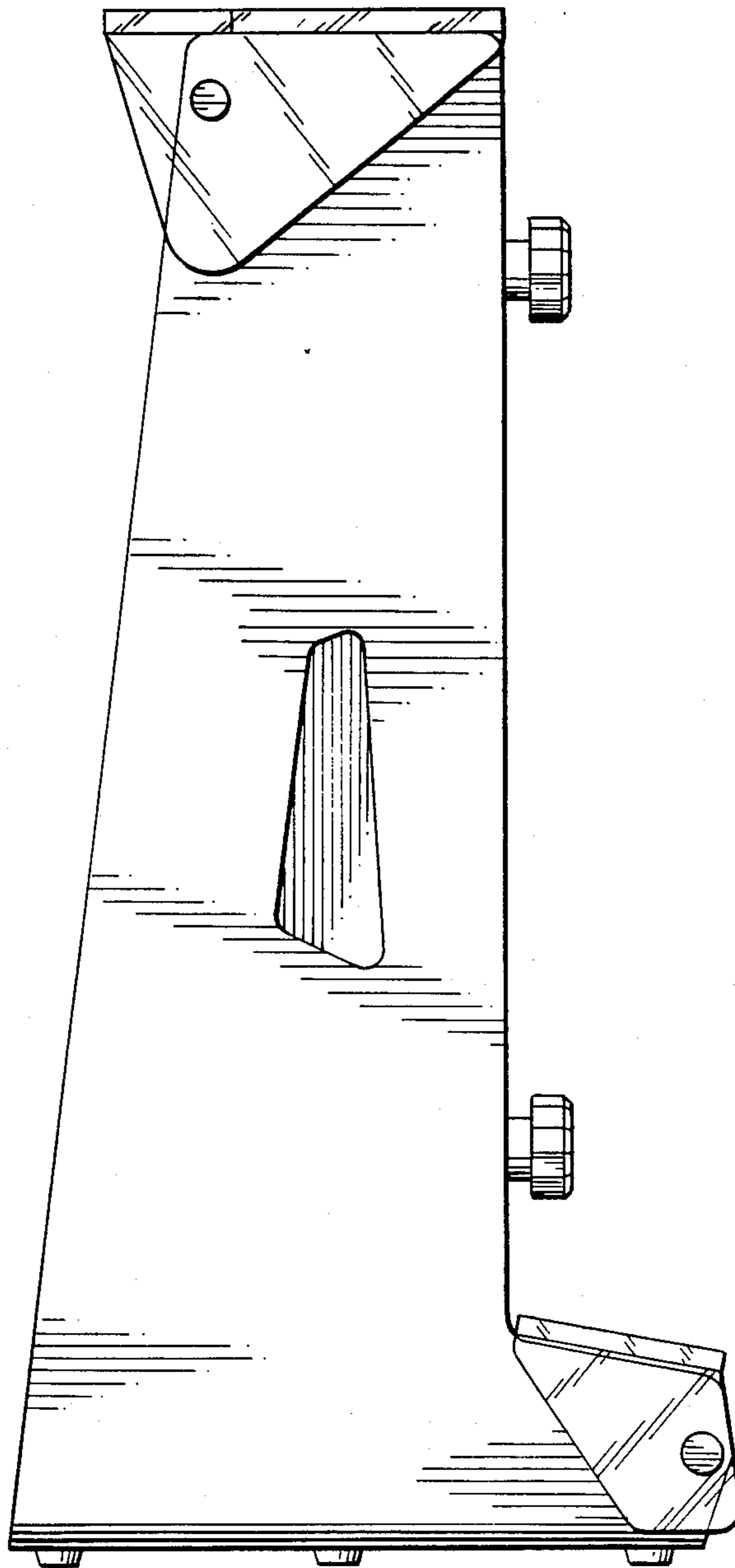

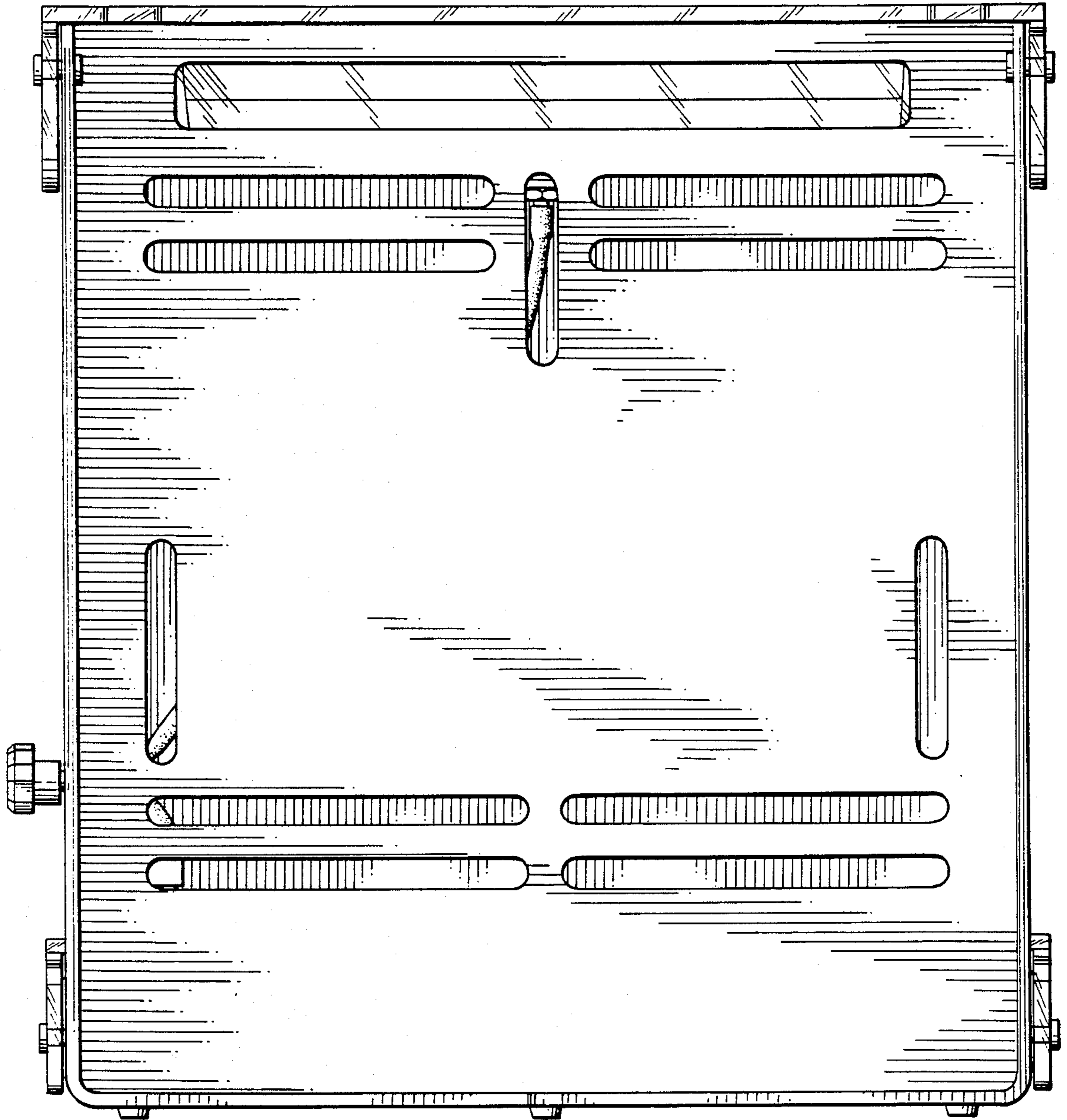

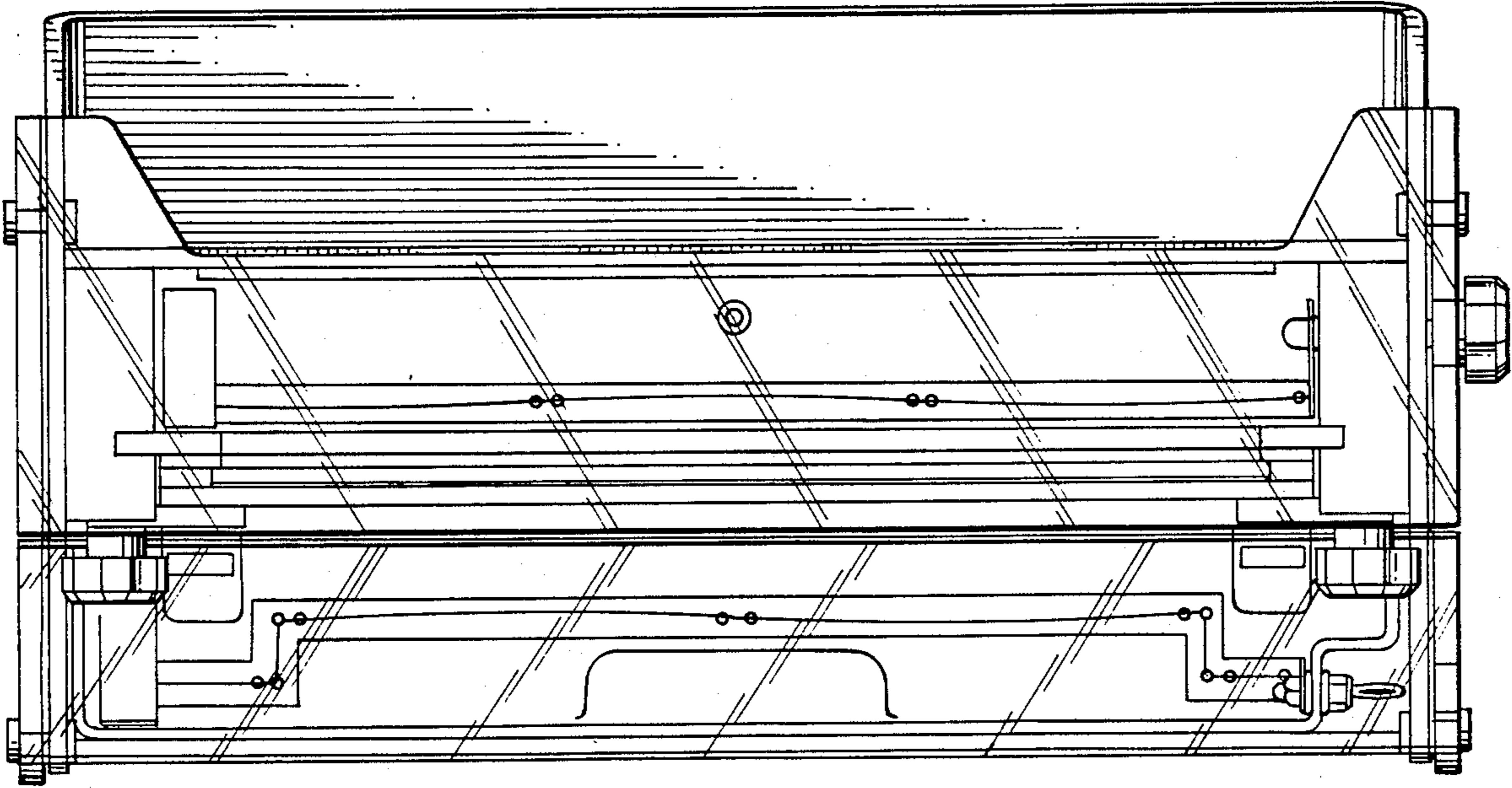
