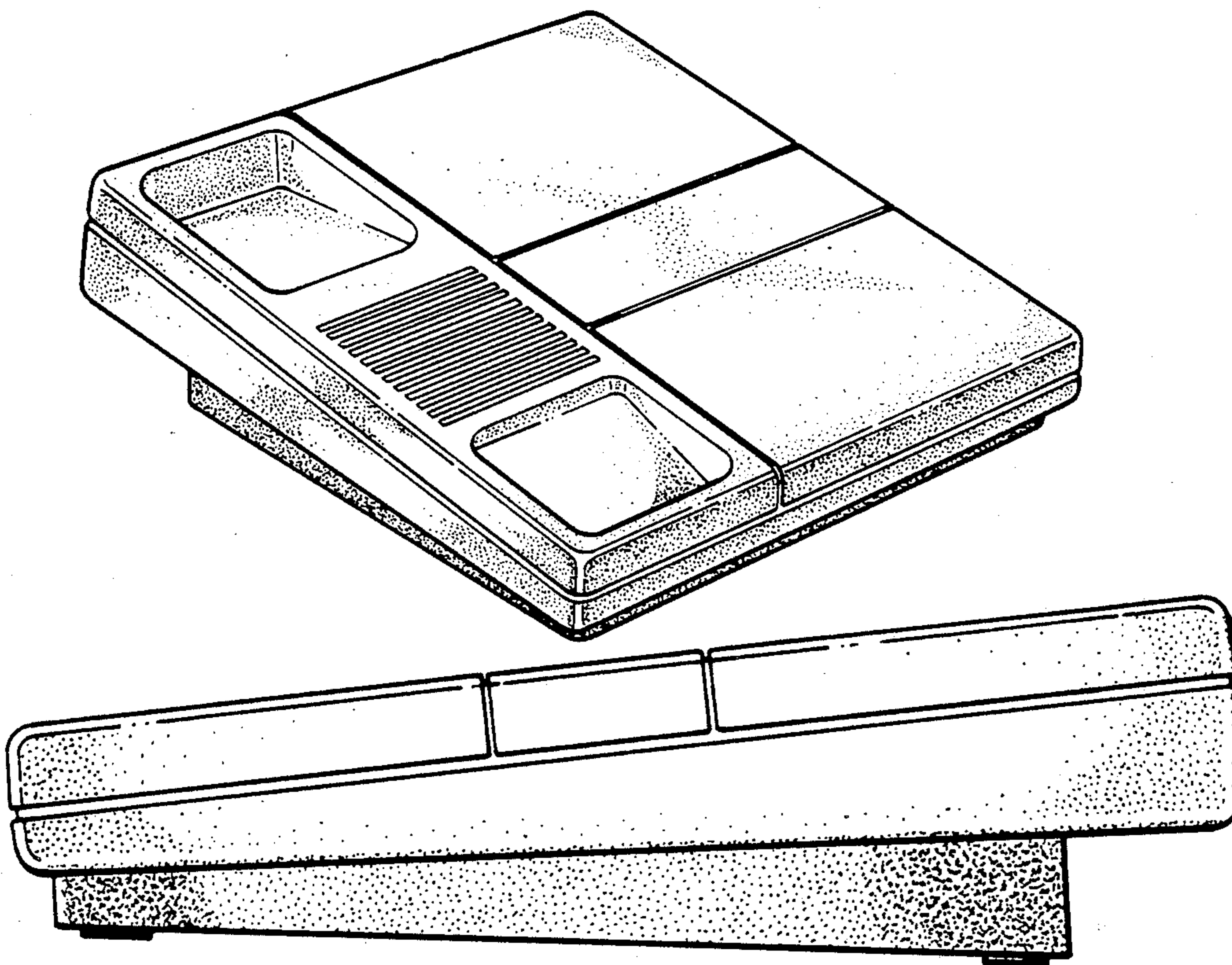

DESCRIPTION

FIG. 1 is a top, front and left side perspective view of a telephone stand showing our new design; FIG. 2 is a top plan view thereof; FIG. 3 is a front elevational view; FIG. 4 is a right side elevational view; FIG. 5 is a rear elevational view thereof; FIG. 6 is a left side elevational view; and FIG. 7 is a bottom plan view.



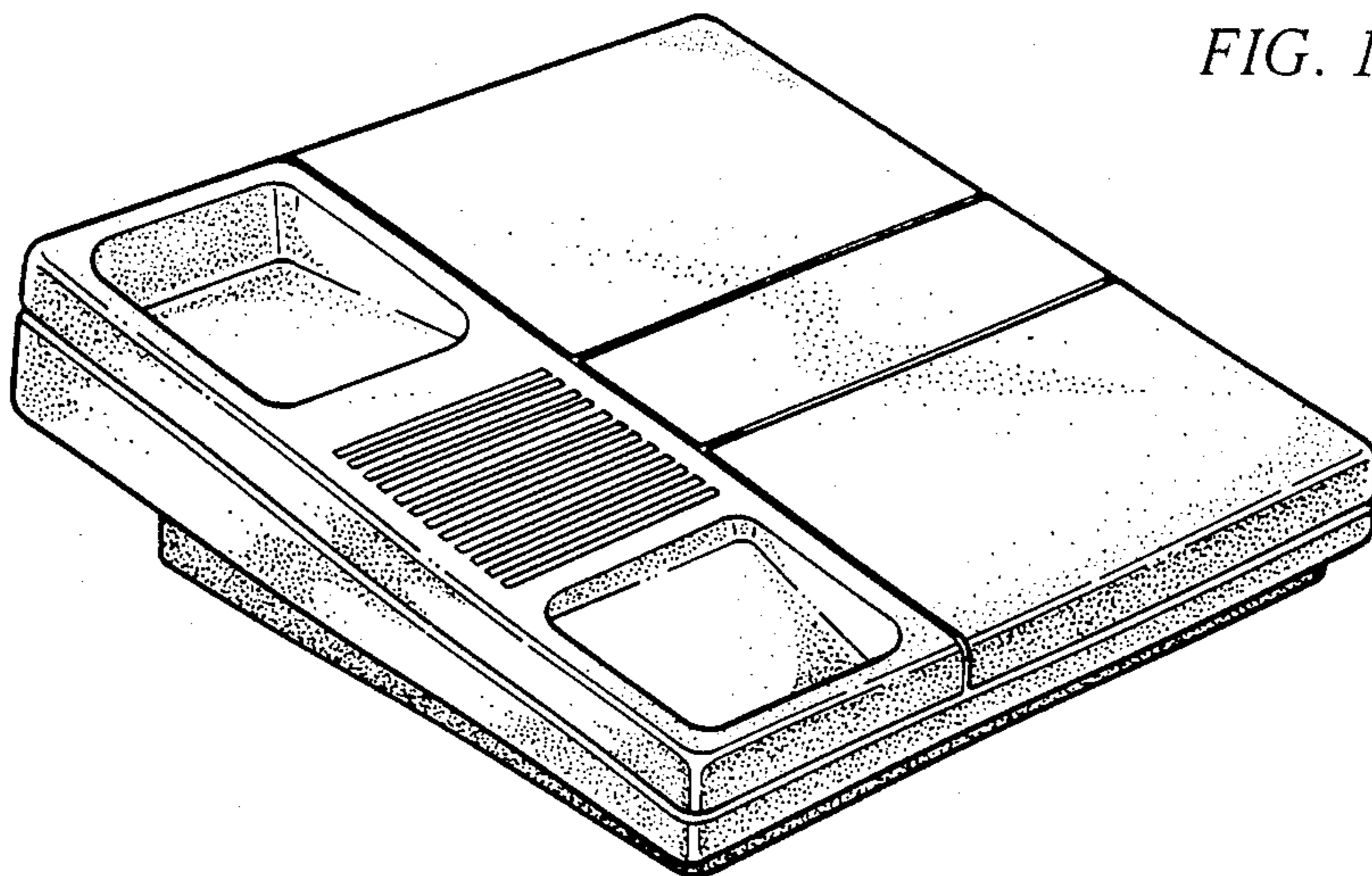

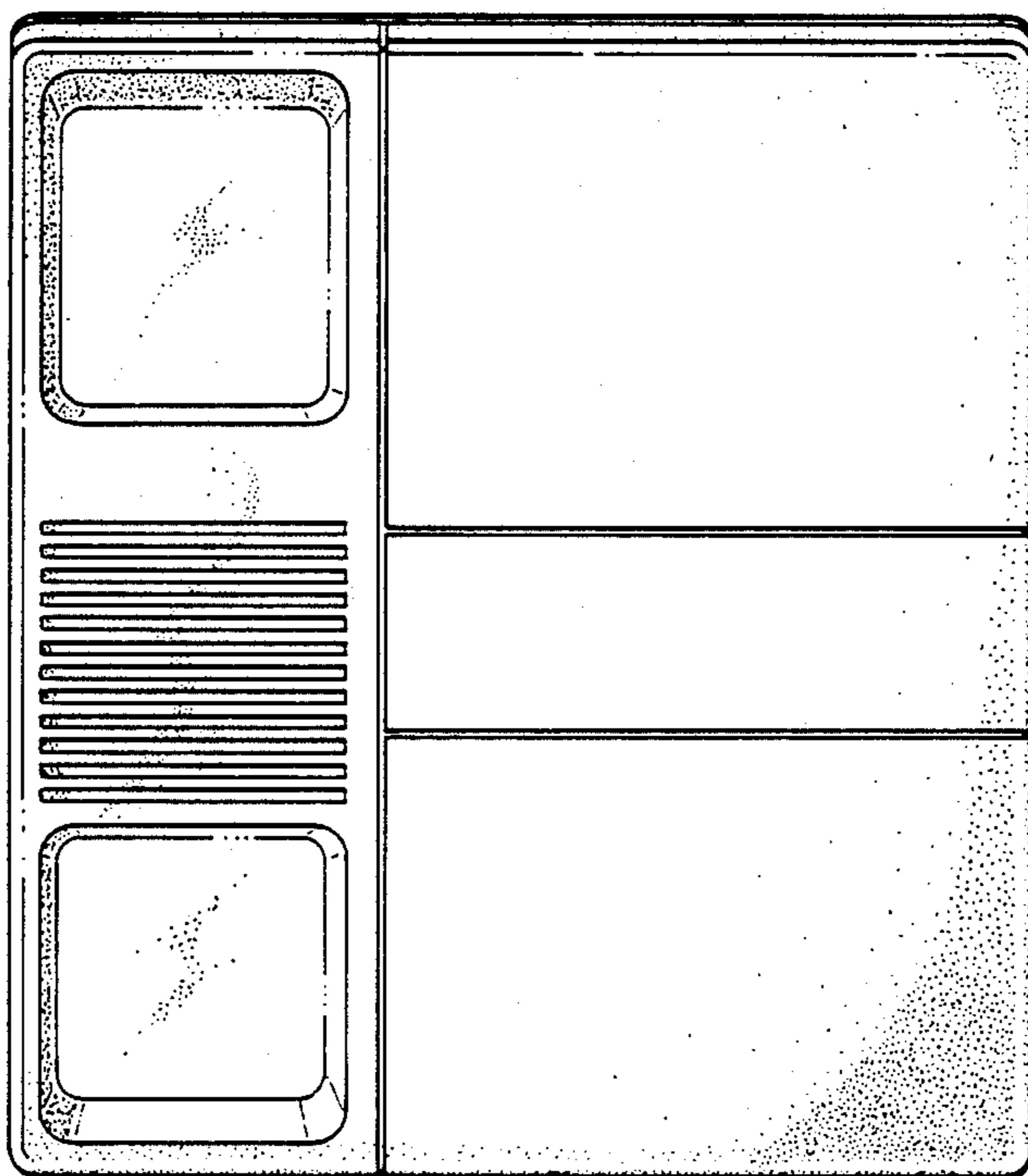

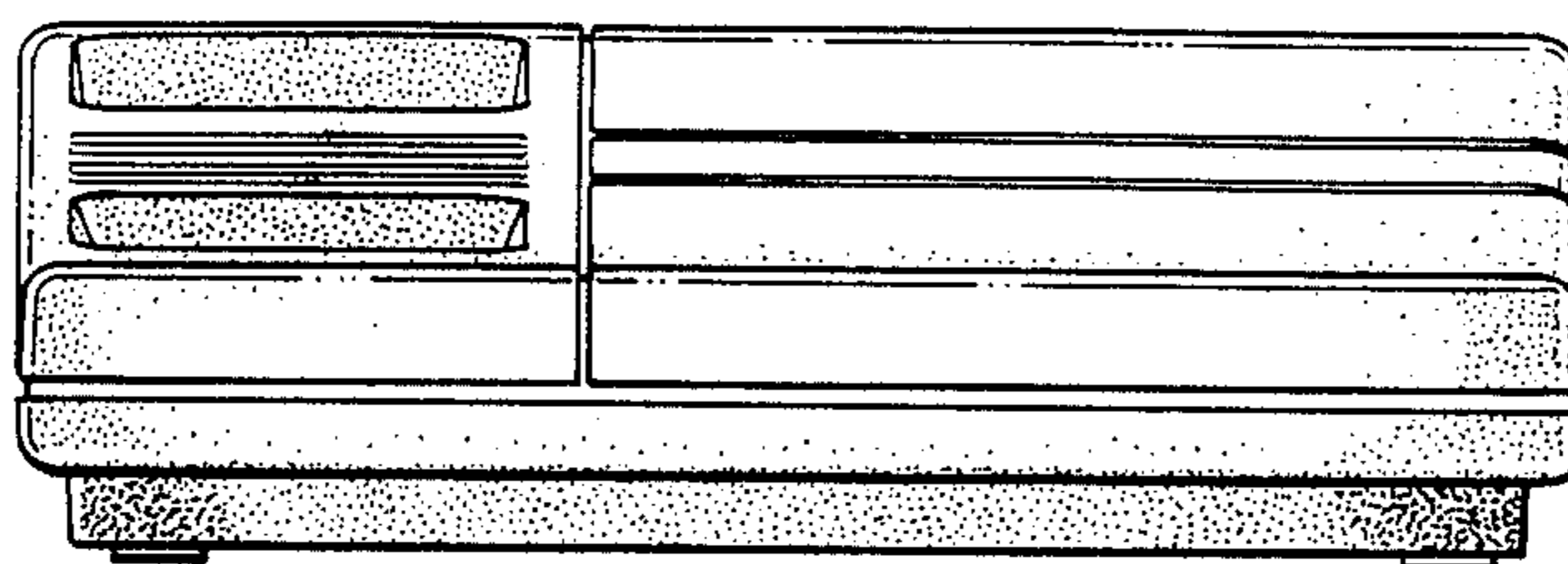

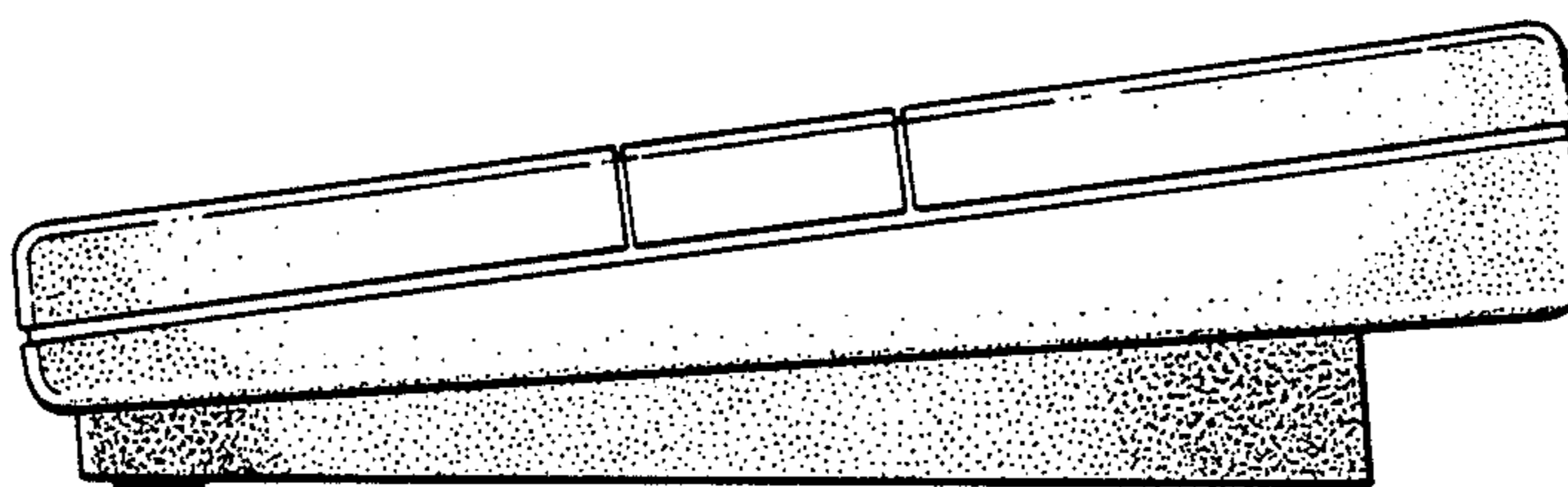

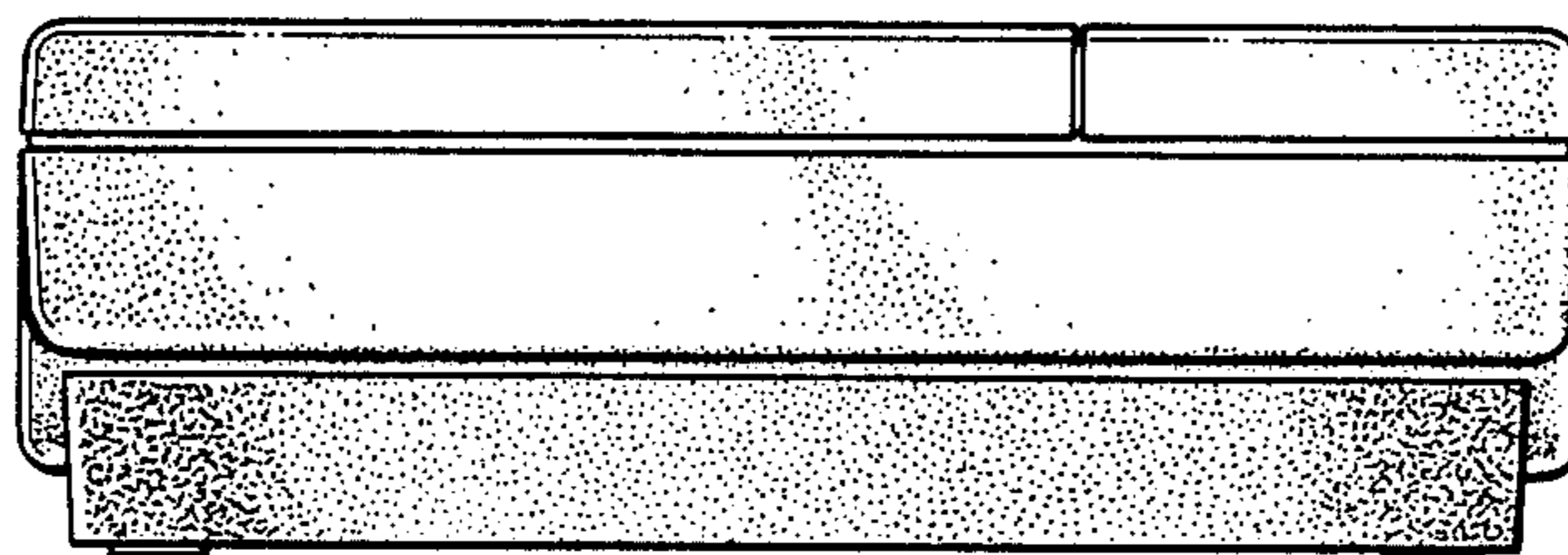

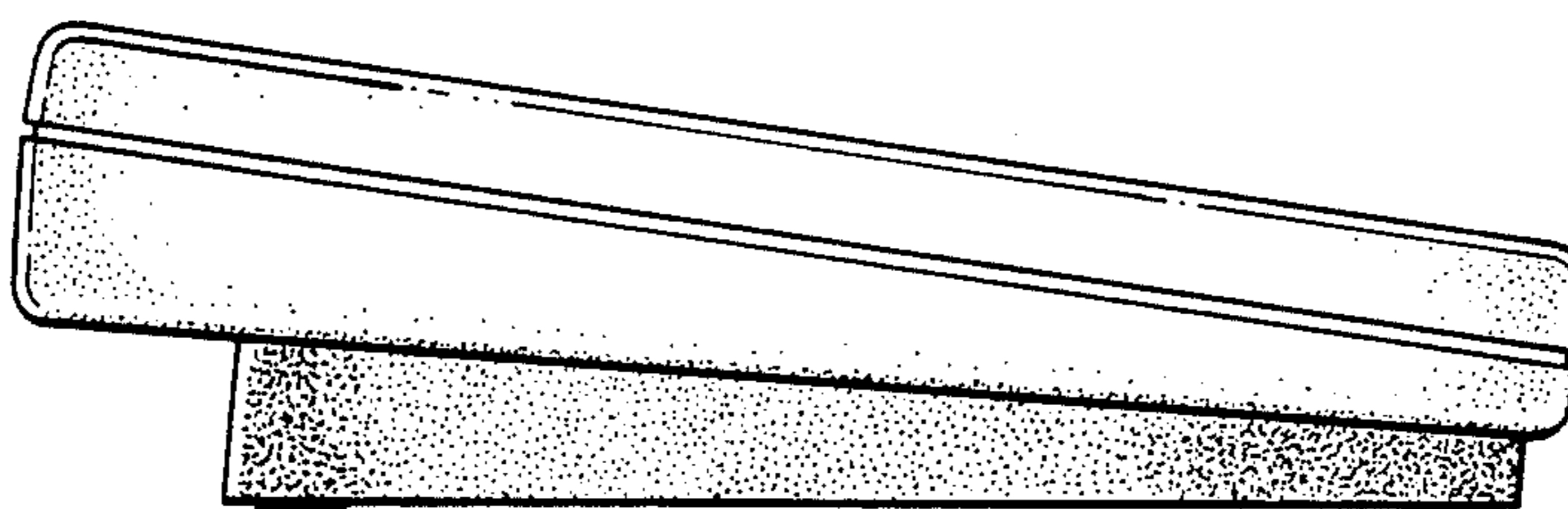

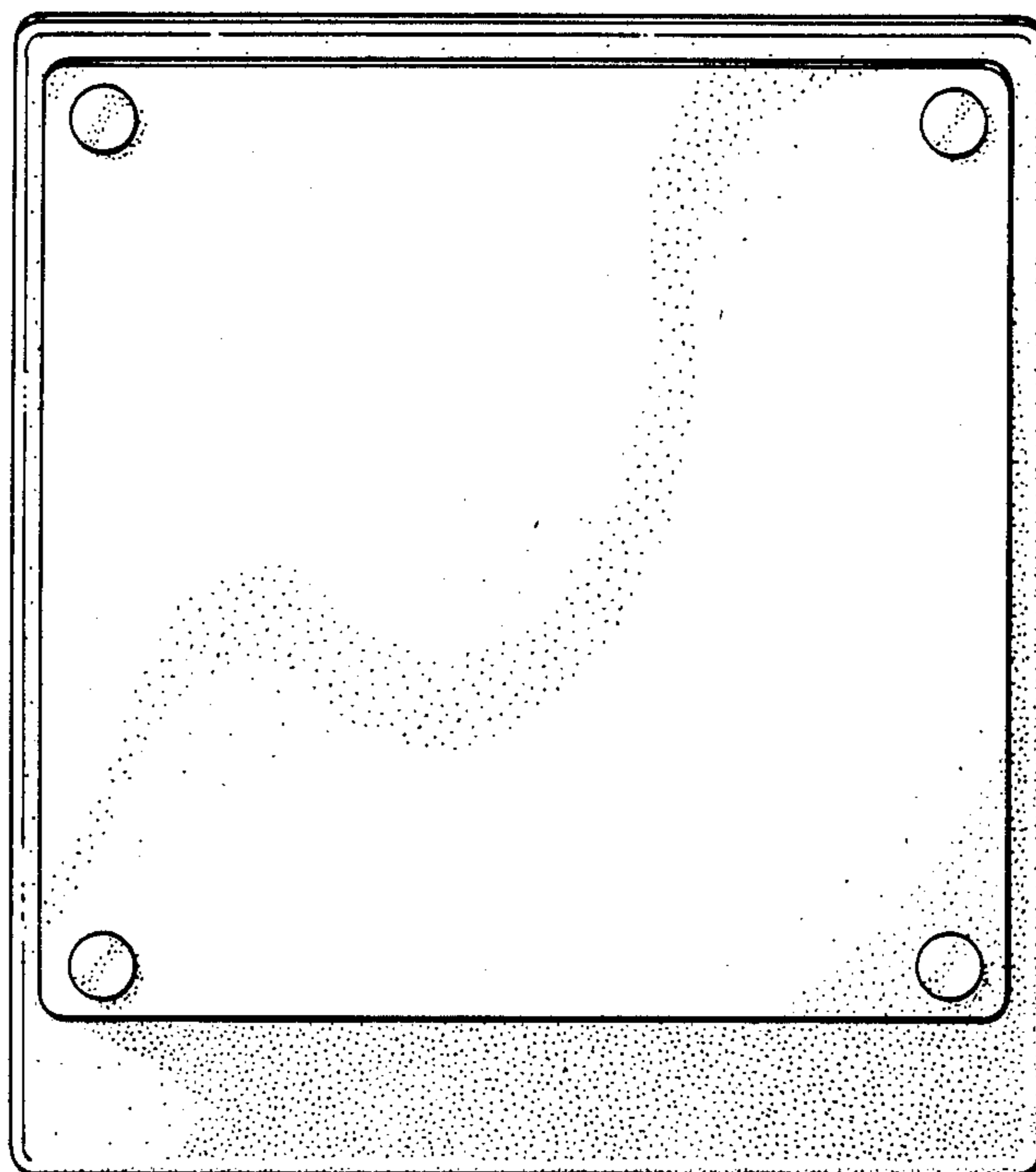
